Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 8 October 2019. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.




Public Safety - Out in Public Locally (Daytime)




General Satisfaction with Police Services


Satisfaction - Dealing with Public Order Problems


Public Order Incidents - August 2019


Public Order : Disturbance - August 2019


Public Order : Noise - August 2019


Public Order : Vandalism - August 2019

Public Order : Offensive Behaviour - August 2019



















Total Person Offences - Victim Categories - SOUTH





Total Person Offences - SOUTH





Total Person Offences - Victim Categories - NORTH










Total Uniform Police Patrol Hours - August 2019


Uniform Police - Patrol Hours




Family Violence Incidents - August 2019



Family Violence RAST - Excludes Other and Argument Categories





Family Violence - Action at Scene (Excludes 'Other' and 'Argument' categories)





Family Violence : Weapons Present - August 2019





Family Violence Orders : Police Issued - August 2019






Family Violence - PFVO Breaches - August 2019














Traffic Related Information Reports - August 2019


Total Search Returns - August 2019


CIB: Total Offenders - August 2019

CIB: Total Crime Offenders - August 2019






Drug Detector Dogs - Deployments - August 2019


Drug Detector Dogs - Drug Detections - August 2019


Explosive Detector Dog - Deployments - August 2019


Explosive Detector Dog - Detections - August 2019

DIS Warrants Executed - August 2019








Major Traffic Operations - August 2019




Speeding Offenders - August 2019


Excessive Speed Offenders - 15-29km/h - August 2019


Excessive Speed Offenders - 30km/h + - August 2019


High Risk Offenders - August 2019


Seatbelt Compliance Offenders - August 2019


Mobile Phone Offenders - August 2019


Vehicle Defect Notices - August 2019


Random Breath Tests (ALCOHOL) - August 2019

Oral Fluid Tests (Drugs) - August 2019








Dangerous and Reckless Driving Offenders - August 2019

Disqualified and Unlicensed Driving Offenders - August 2019






Unregistered Vehicle Offenders - August 2019


Vehicle Complaints made to RDS - August 2019




Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - August 2019

ANPR: Total Vehicles Captured - August 2019






Road Crashes: Fatalities YTD - August 2019


Fatal Crashes - August 2019





On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)




Southern District Rural Policing



Northern District Rural Policing







Sea Inspections (Vessel & Non-Vessel) - August 2019








Search and Rescue Operations - August 2019
