Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 11 June 2021. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

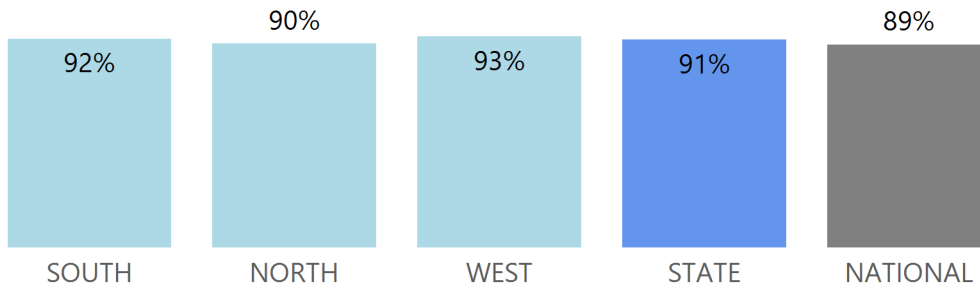

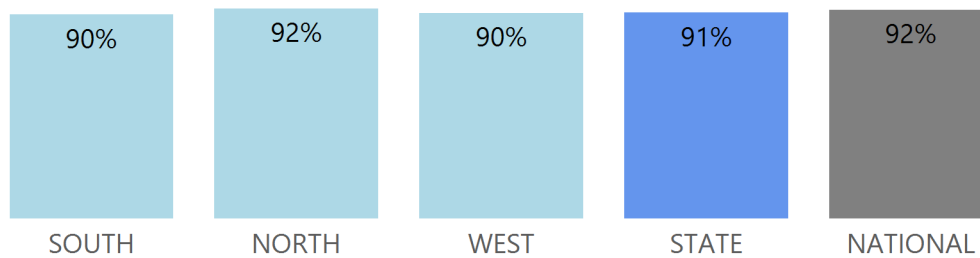

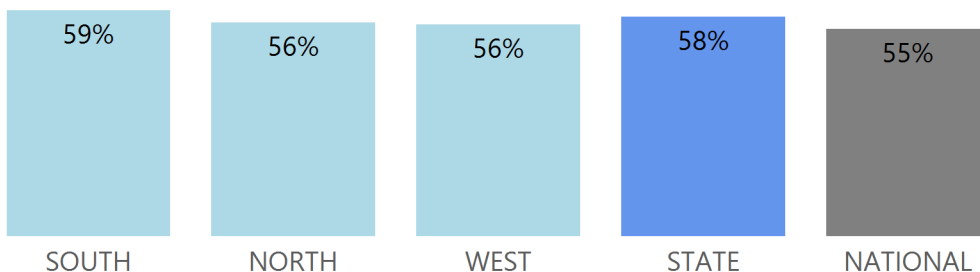
Public Safety - Out in Public Locally (Daytime)

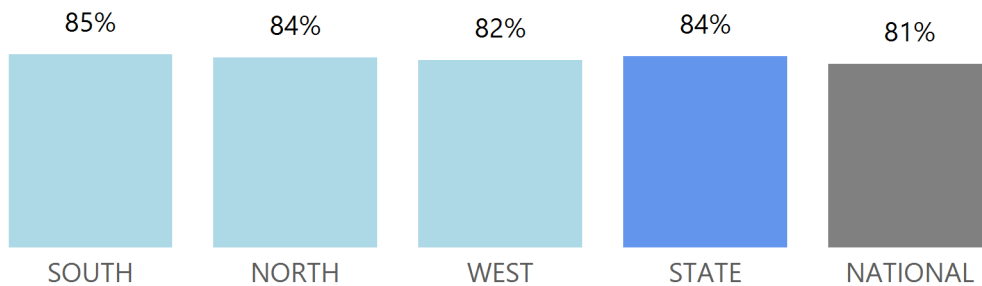

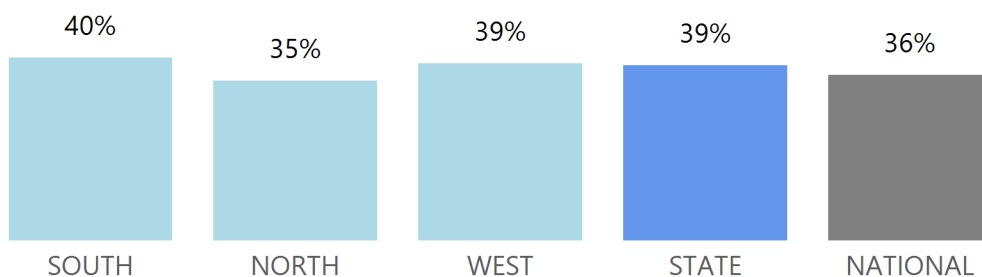
General Satisfaction with Police Services

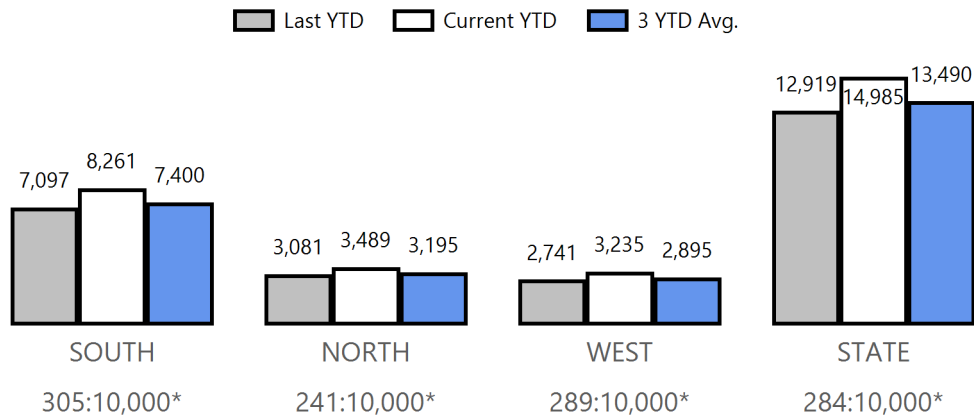
Satisfaction - Dealing with Public Order Problems

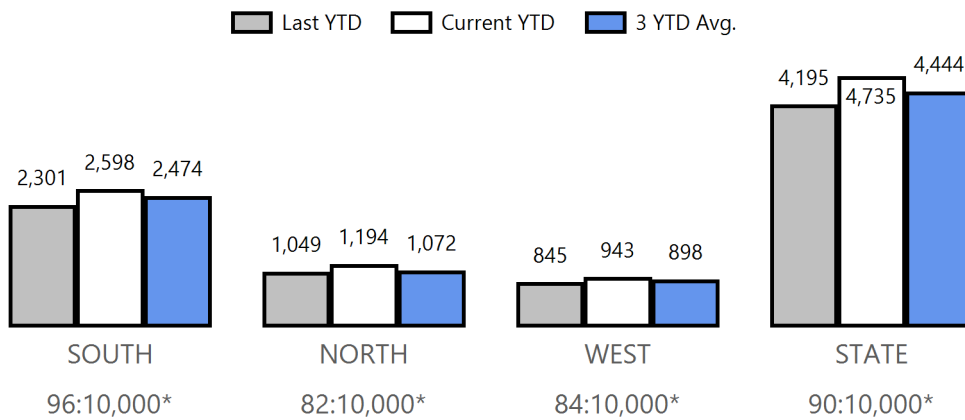
Public Order Incidents - April 2021

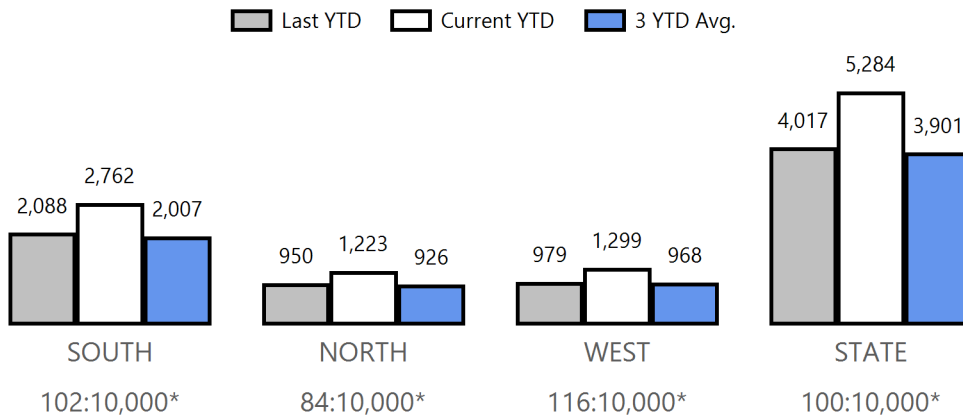
Public Order : Disturbance - April 2021

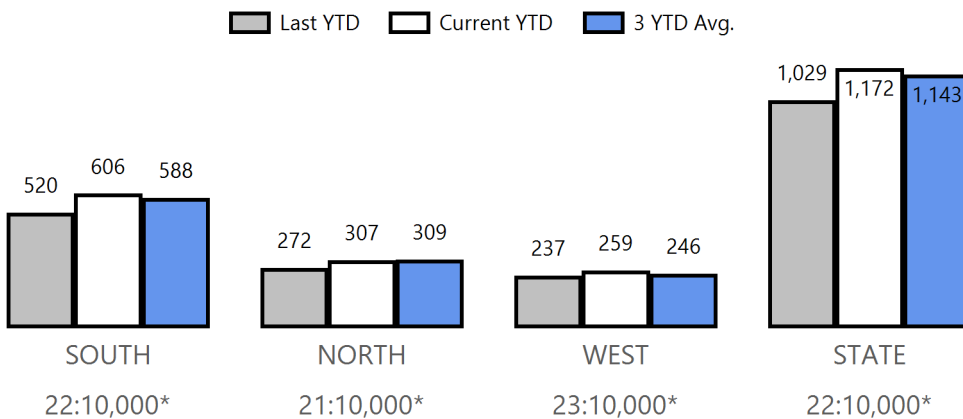
Public Order : Noise - April 2021

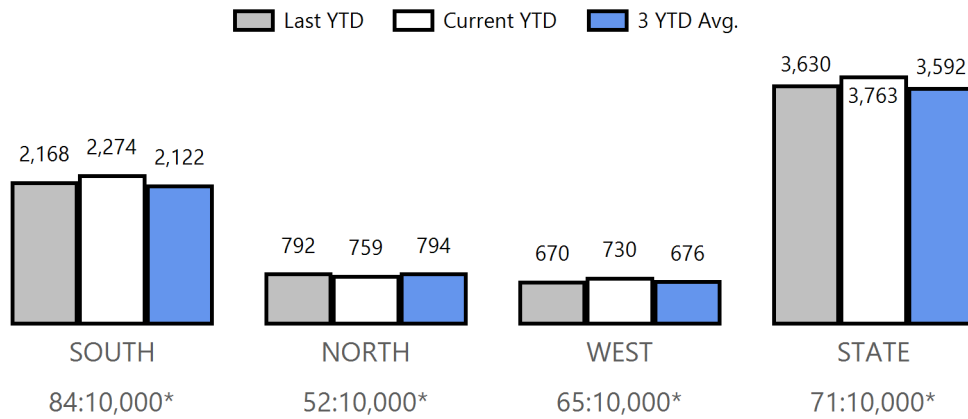
Public Order : Vandalism - April 2021

Public Order : Offensive Behaviour - April 2021

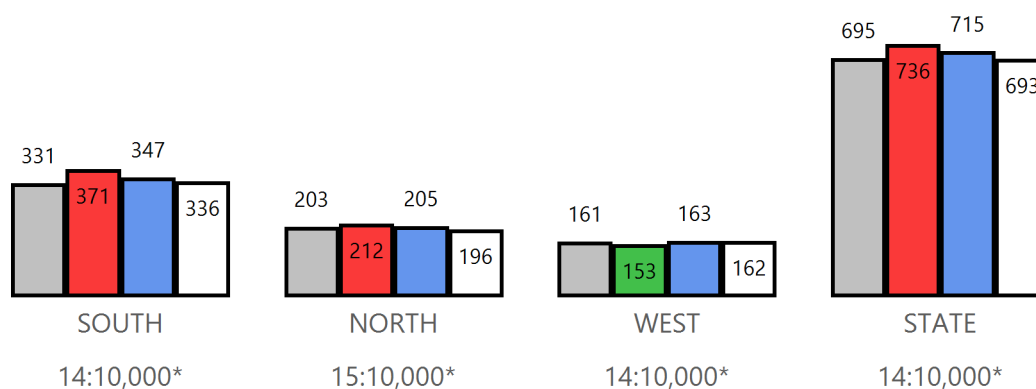

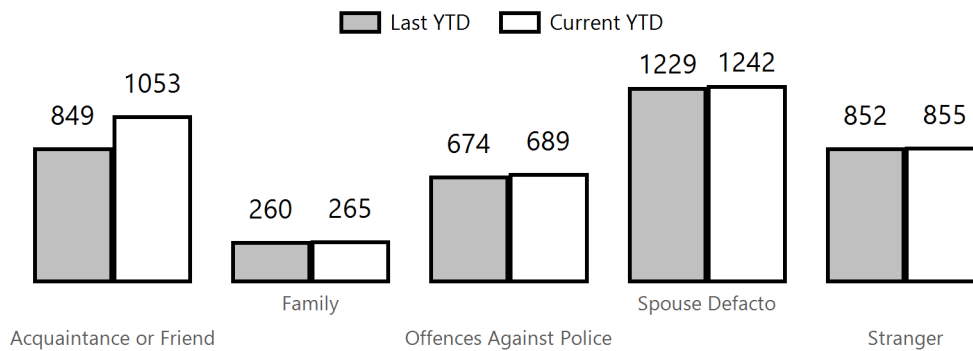

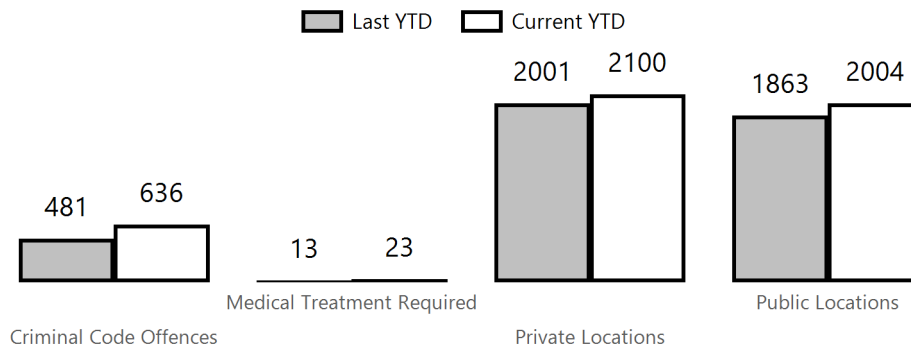

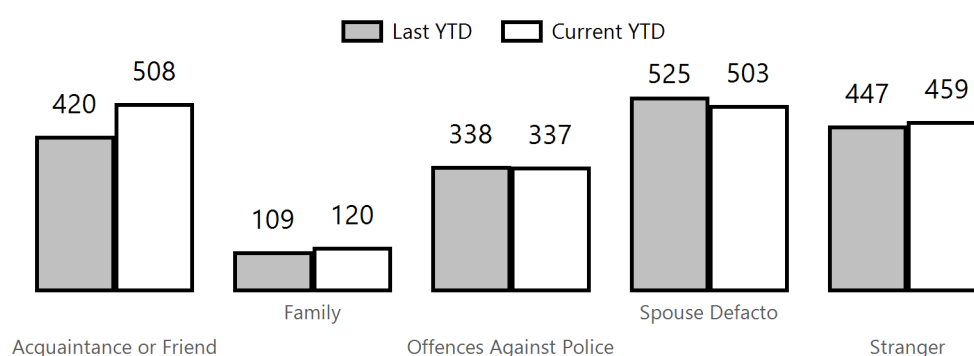

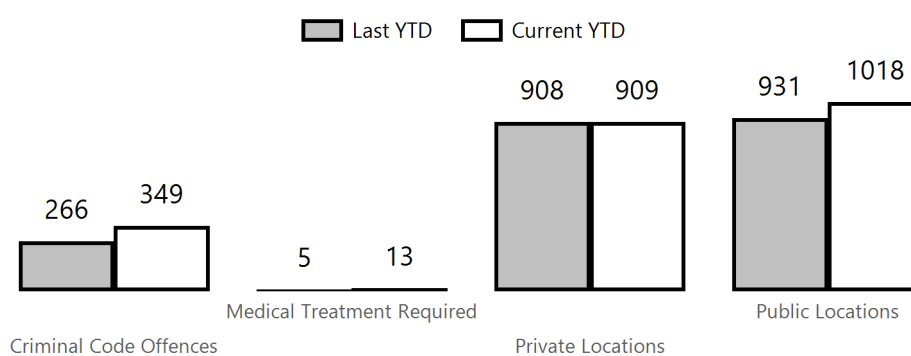

Total Person Offences - Victim Categories - SOUTH



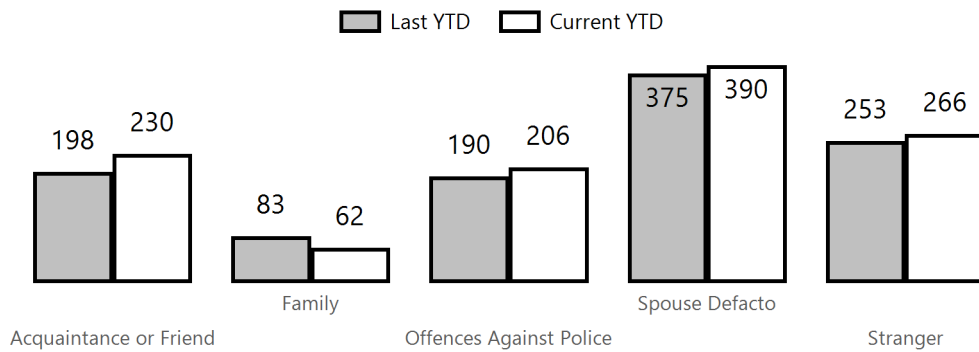

Total Person Offences - SOUTH



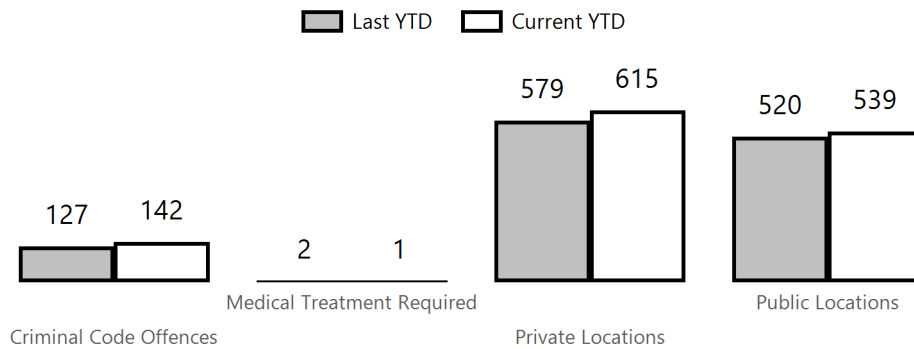

Total Person Offences - Victim Categories - NORTH



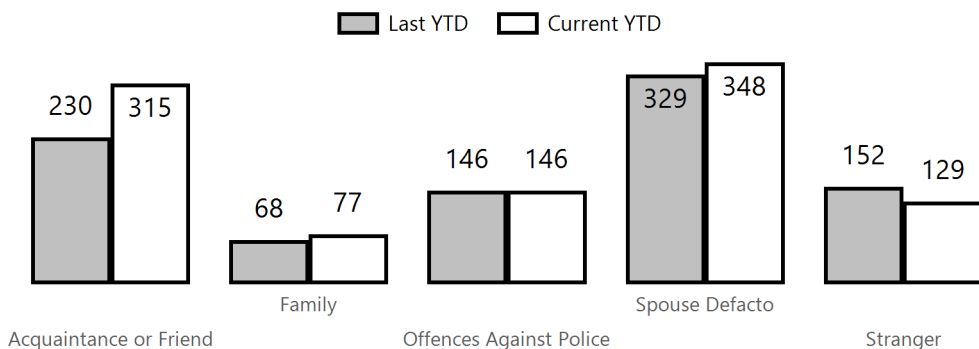

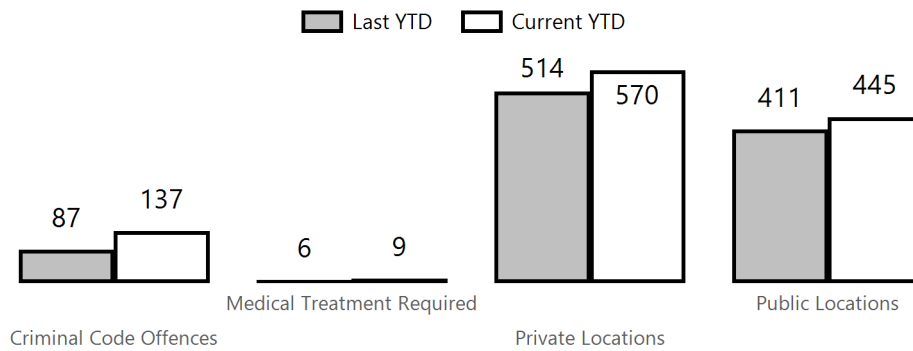

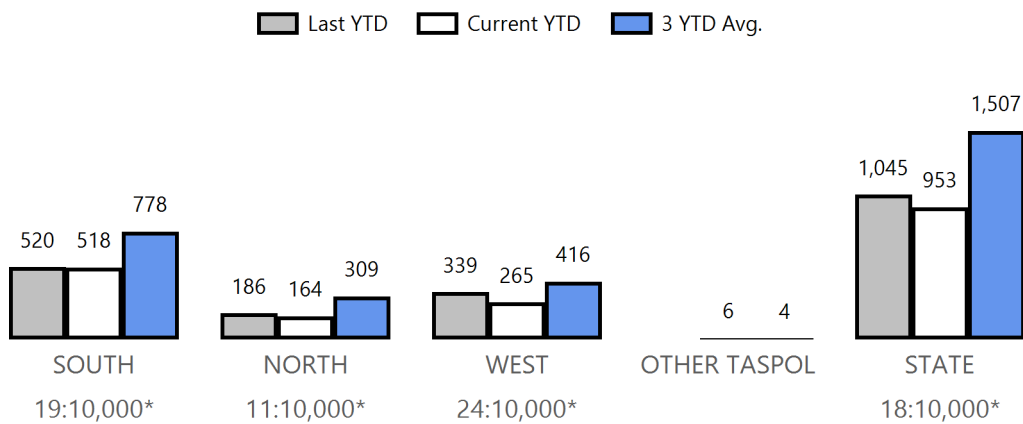

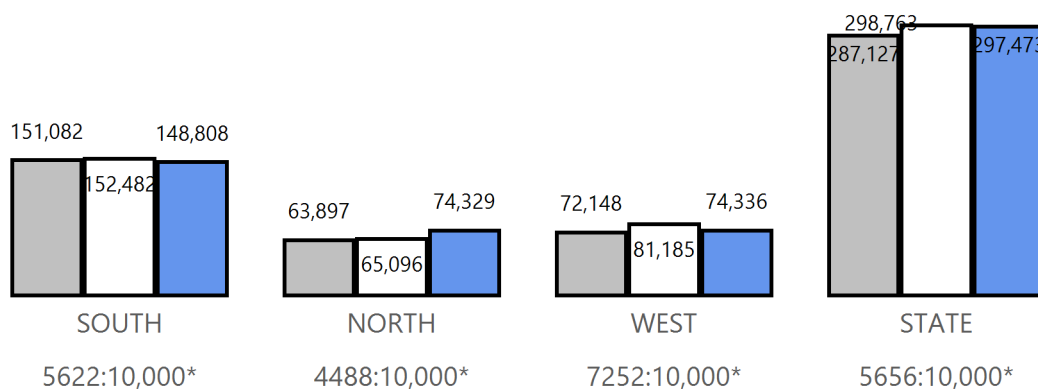

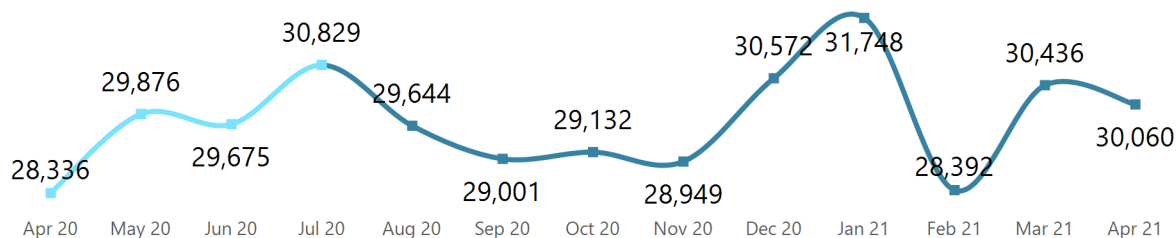
Total Uniform Police Patrol Hours - April 2021

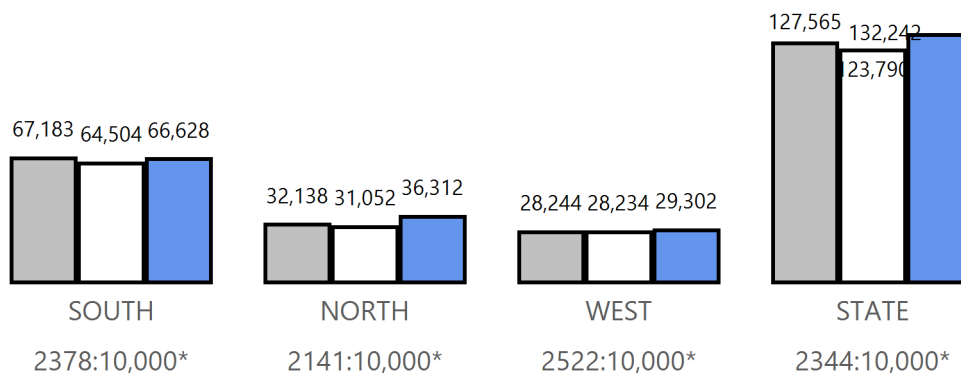
Uniform Police - Patrol Hours

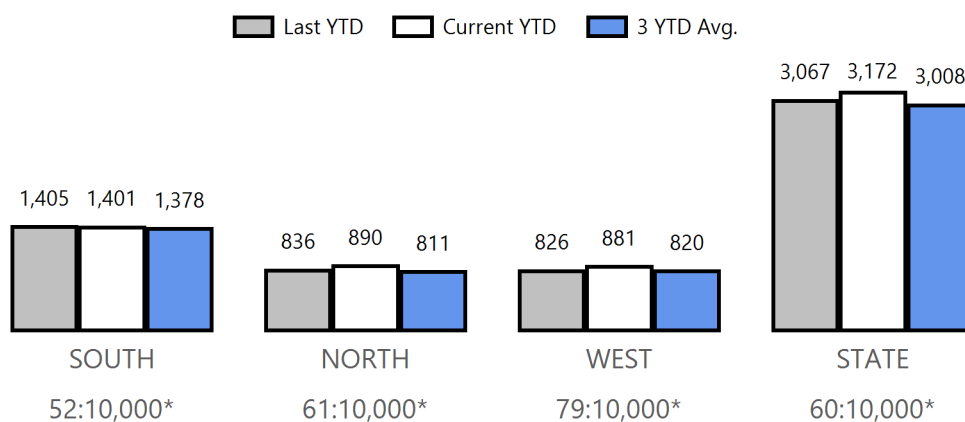

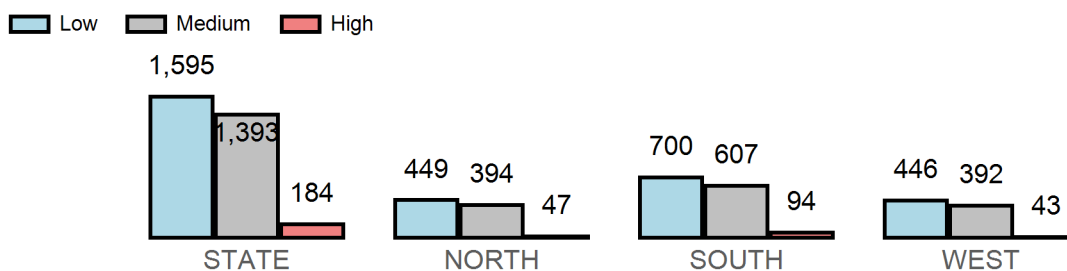
Family Violence Incidents - April 2021

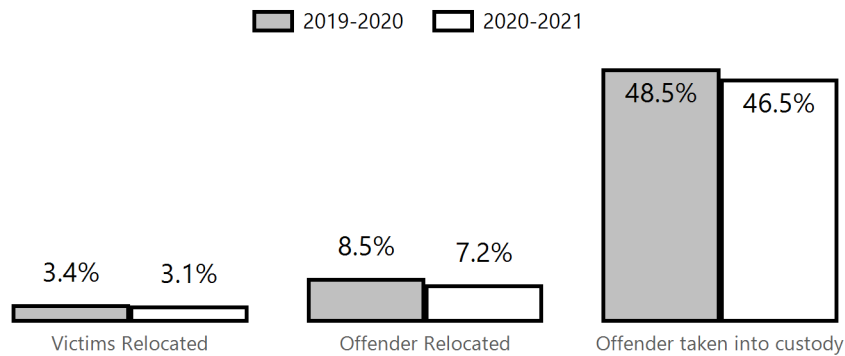

Family Violence RAST - Excludes Other and Argument Categories



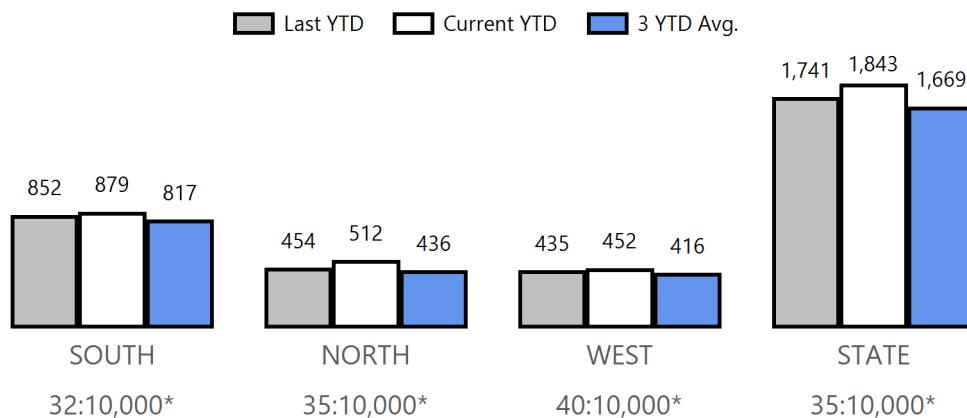

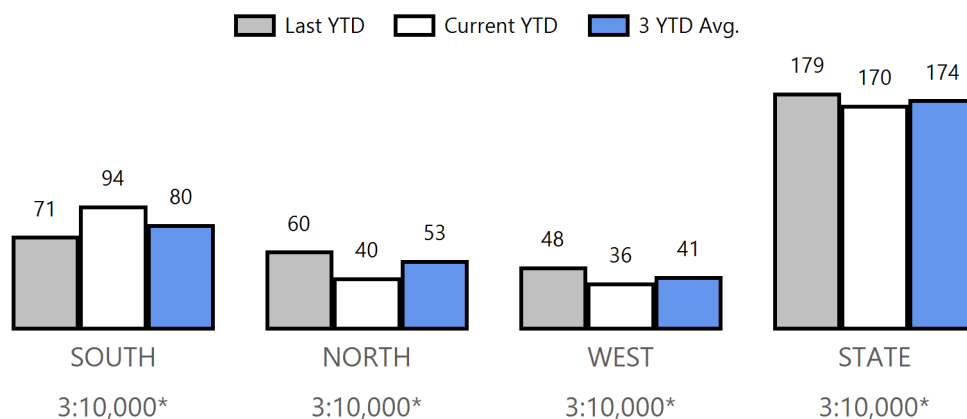
Family Violence : Juveniles Affected - April 2021

Family Violence : Weapons Present - April 2021



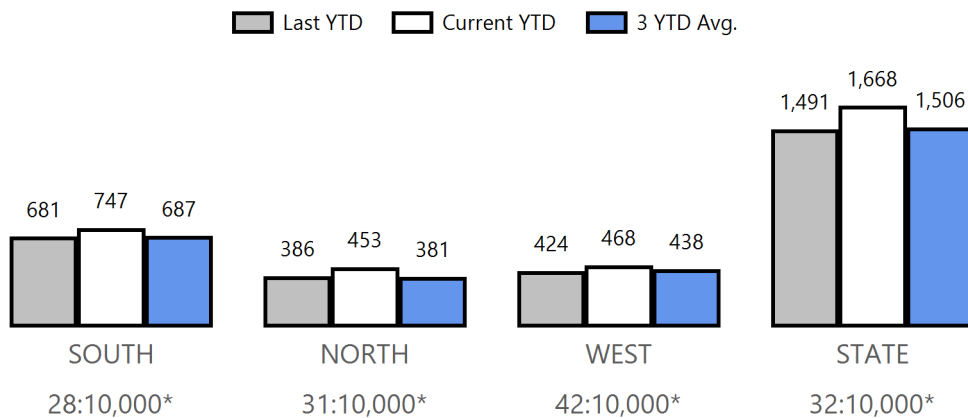

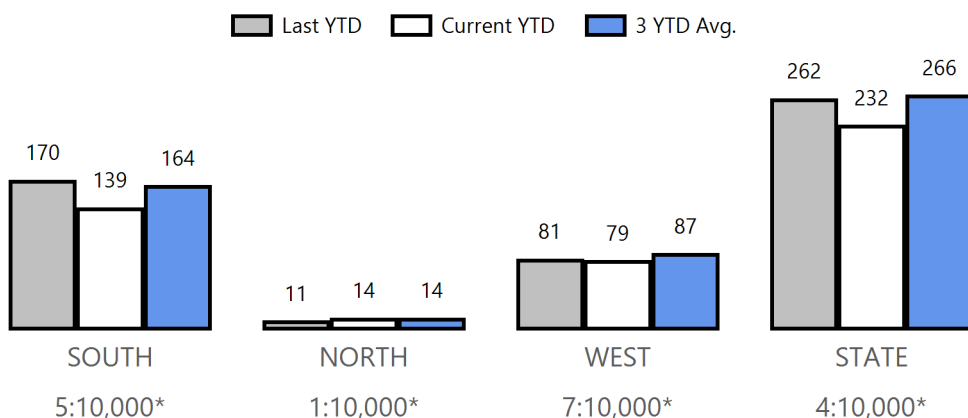
Family Violence Orders : Police Issued - April 2021

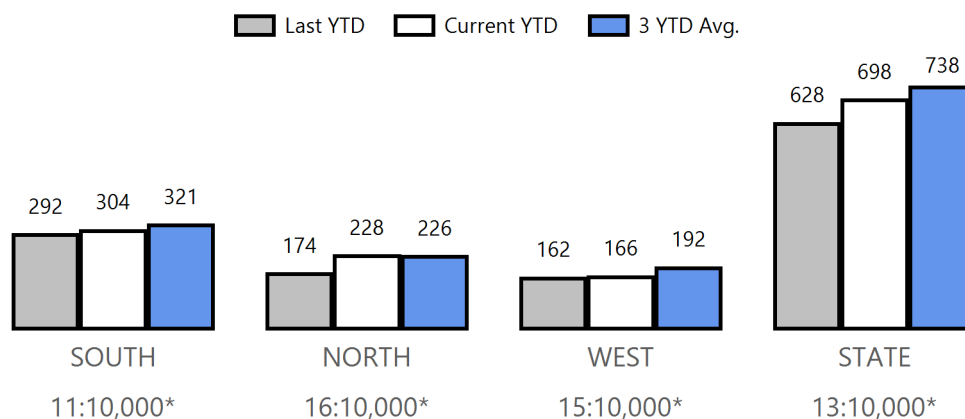
Family Violence Orders : Court Application - April 2021

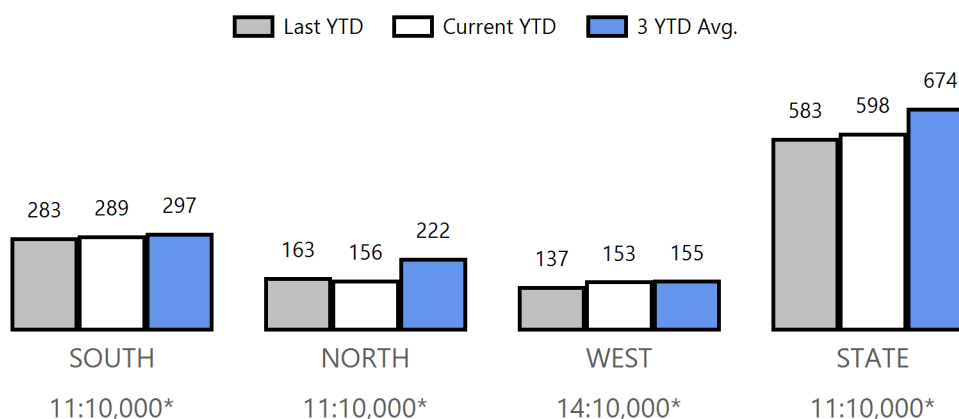
Family Violence - PFVO Breaches - April 2021

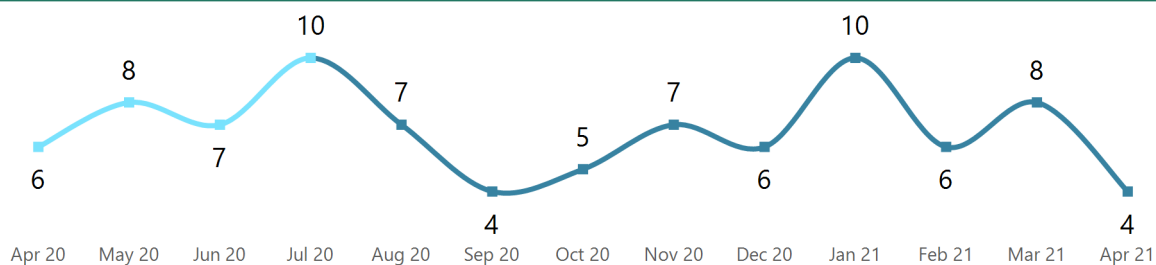

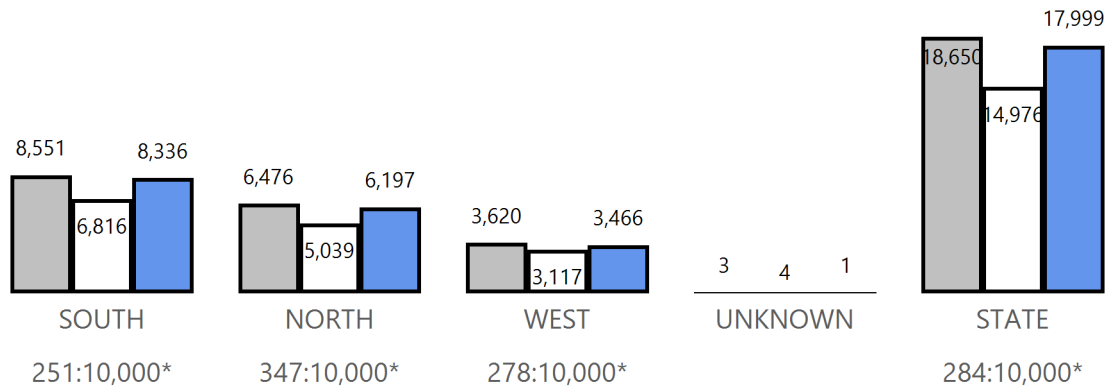

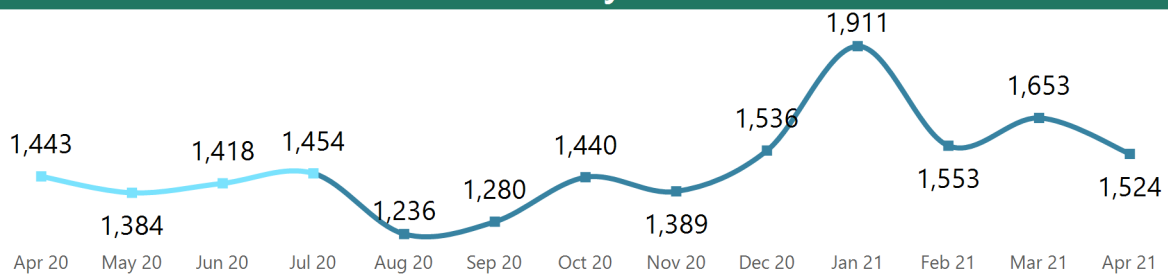

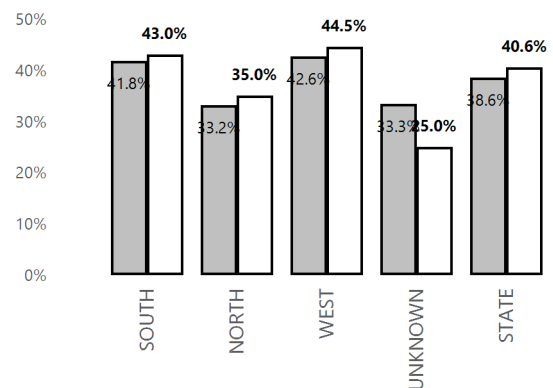

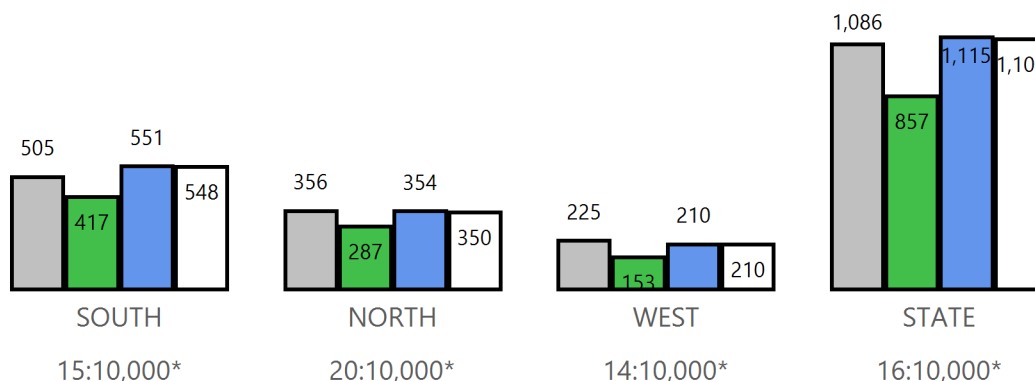

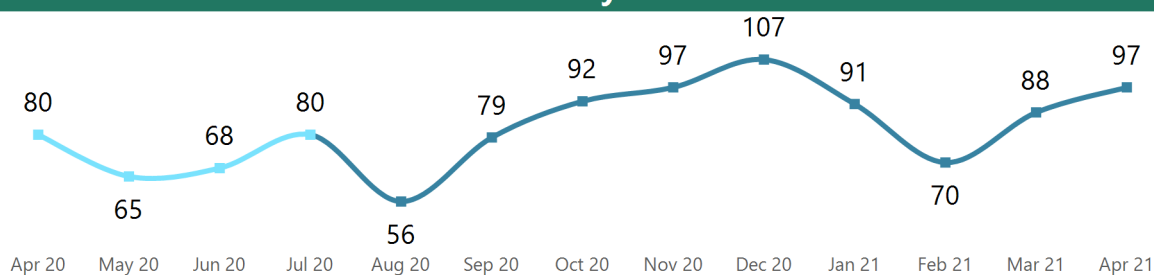

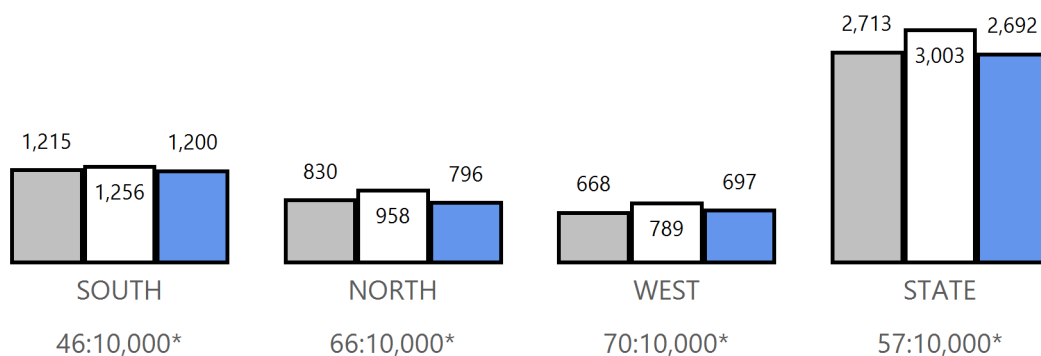

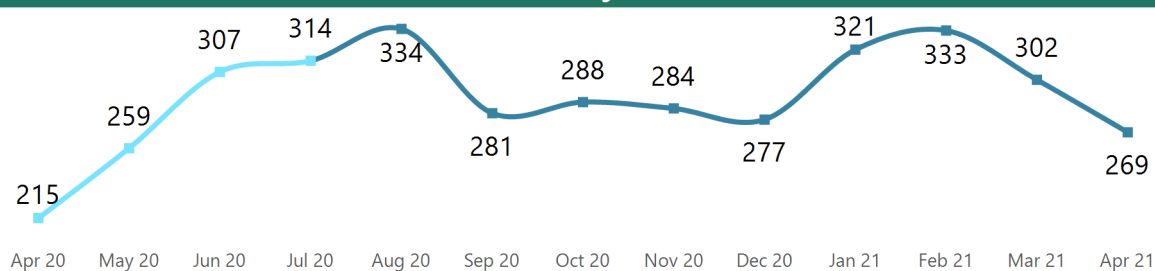

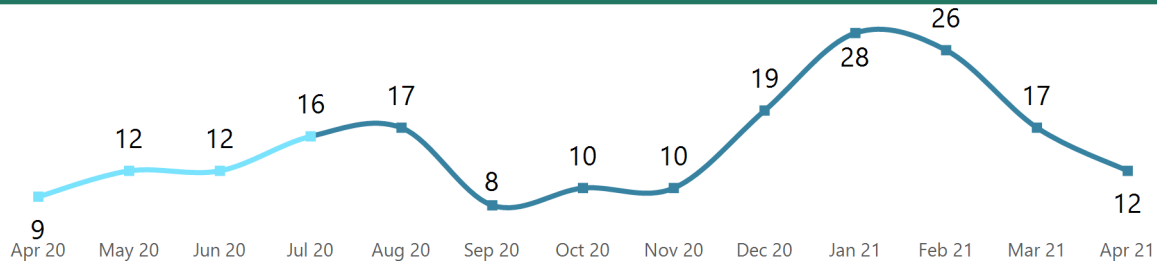
SMV : Fire Damaged - April 2021

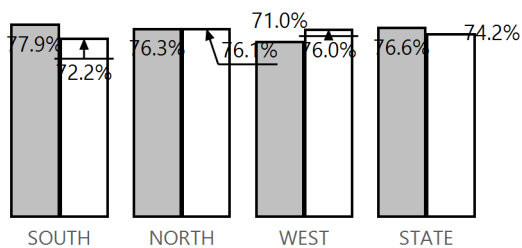

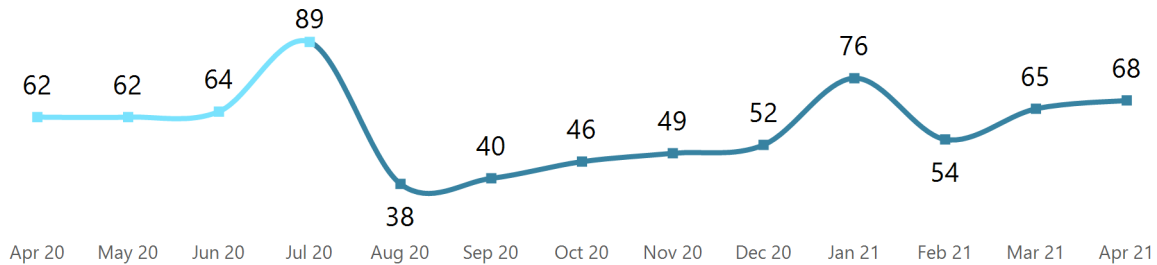

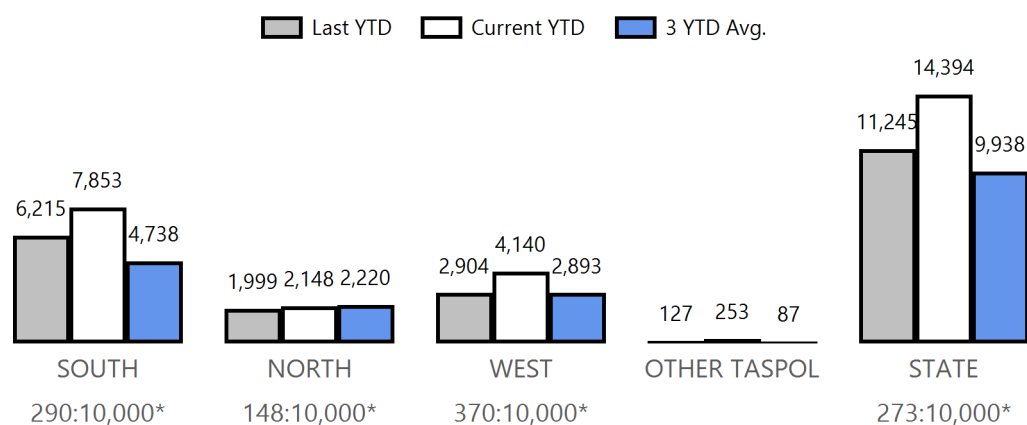

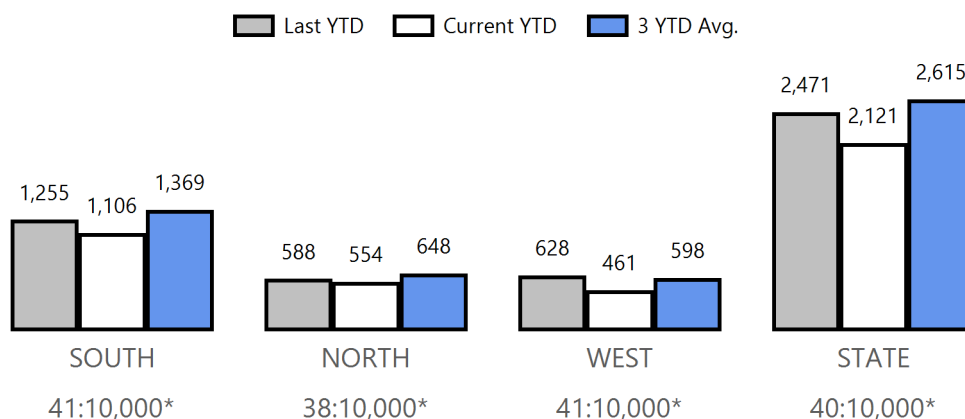
Total Street Checks - April 2021

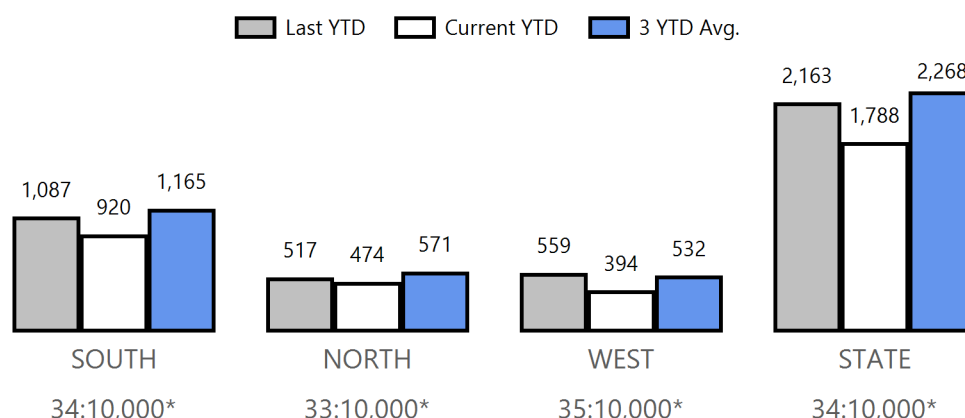
CIB: Total Offenders - April 2021

CIB: Total Crime Offenders - April 2021



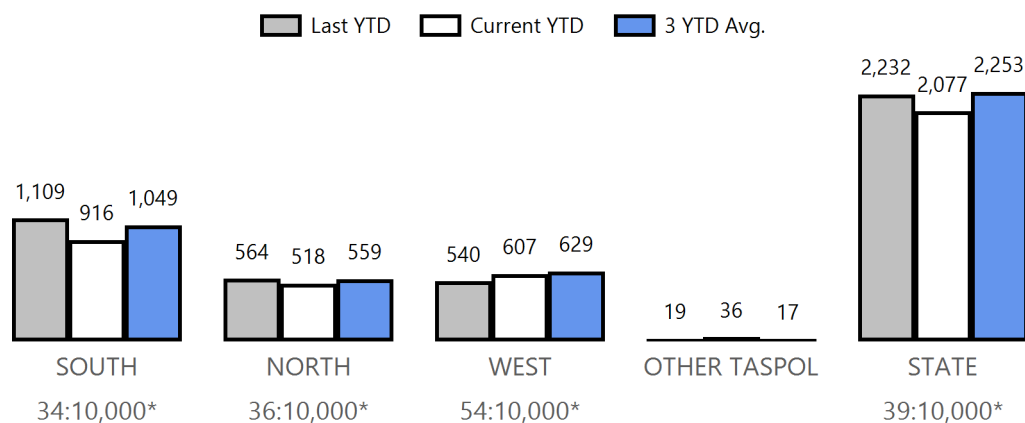

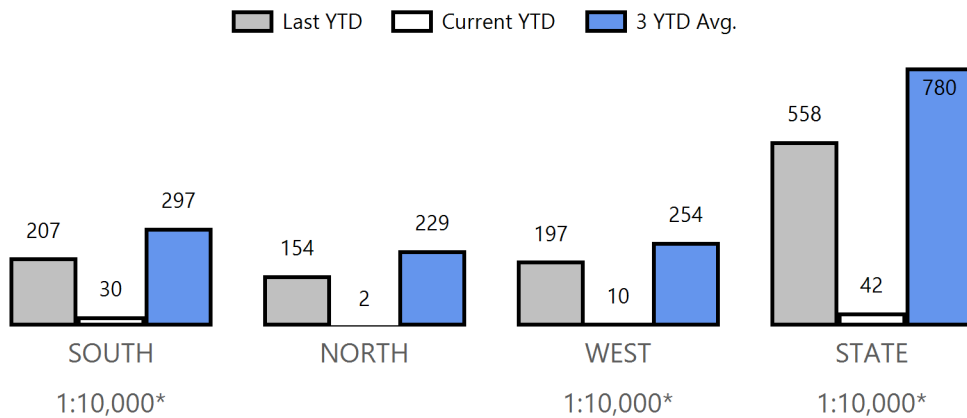
Major Traffic Operations - April 2021

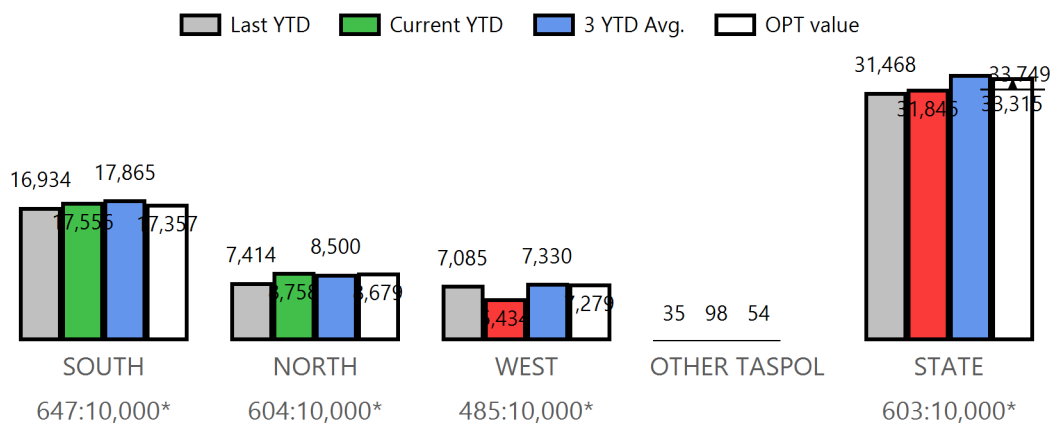

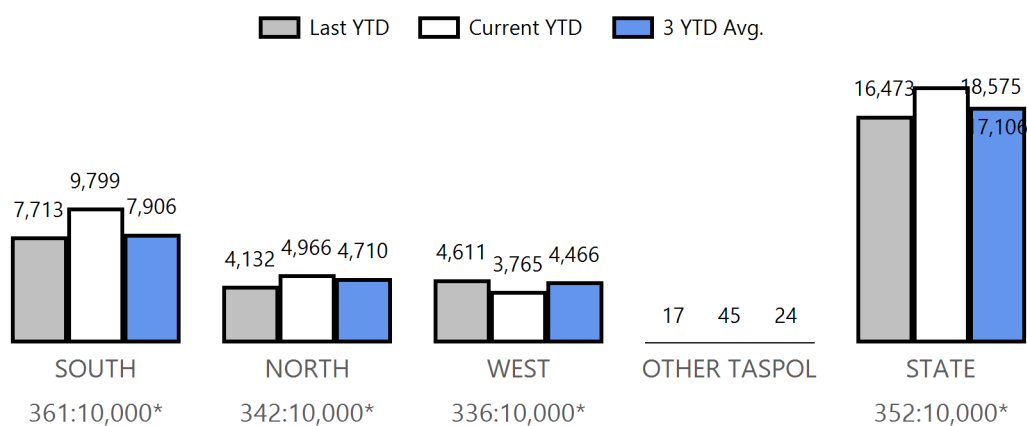
Speeding Offenders - April 2021

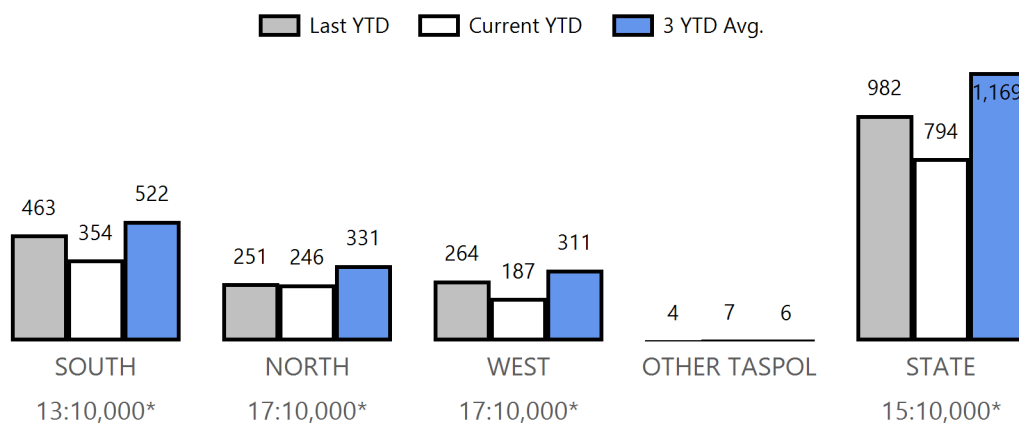
Excessive Speed Offenders - 15-29km/h - April 2021

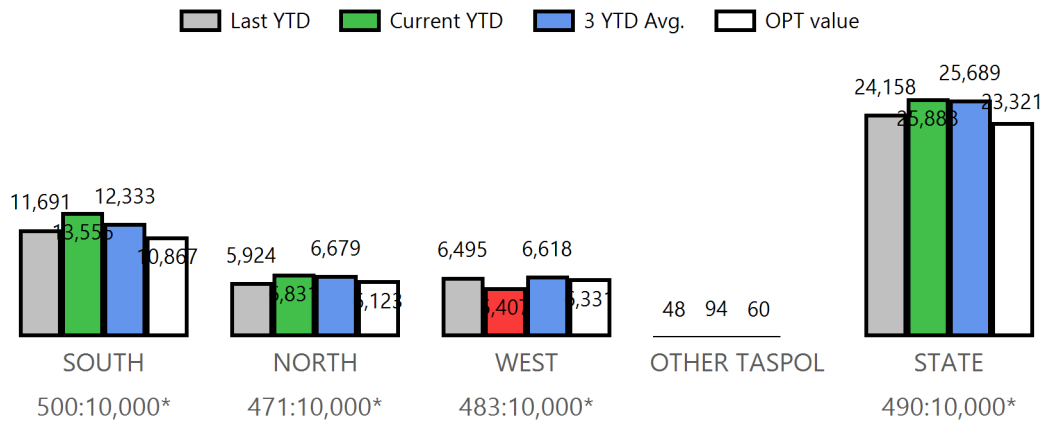
Excessive Speed Offenders - 30km/h + - April 2021

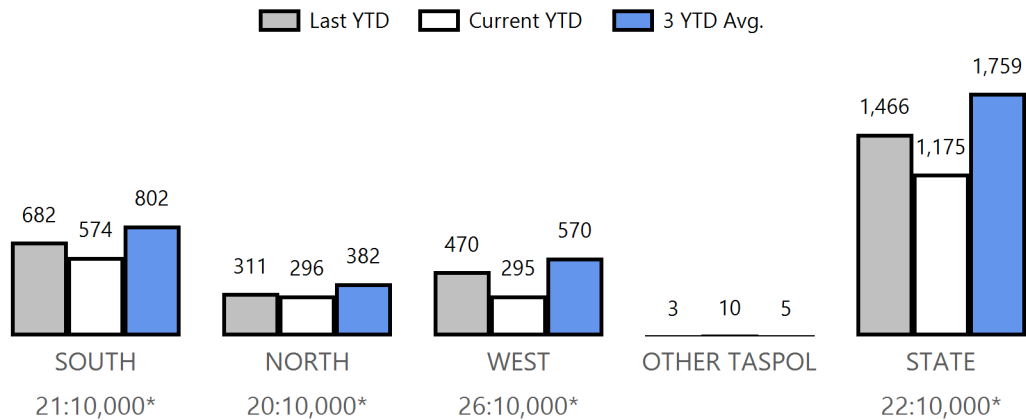
High Risk Offenders - April 2021

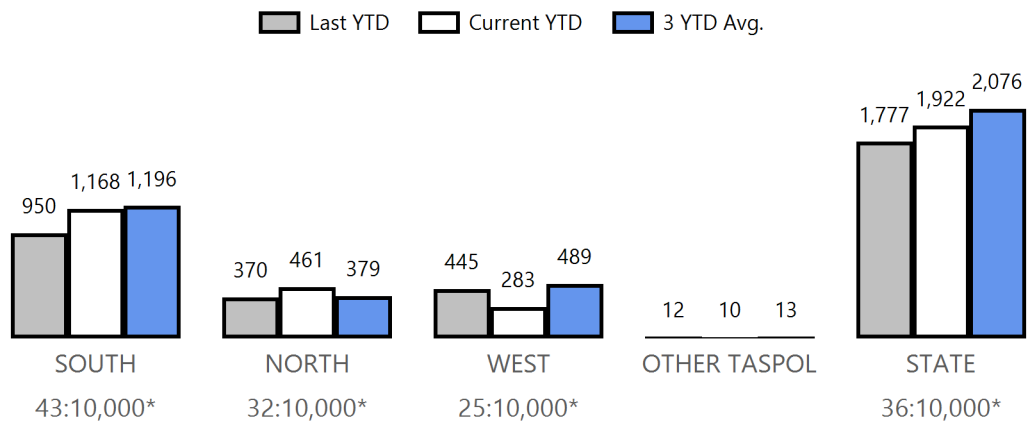
Seatbelt Compliance Offenders - April 2021

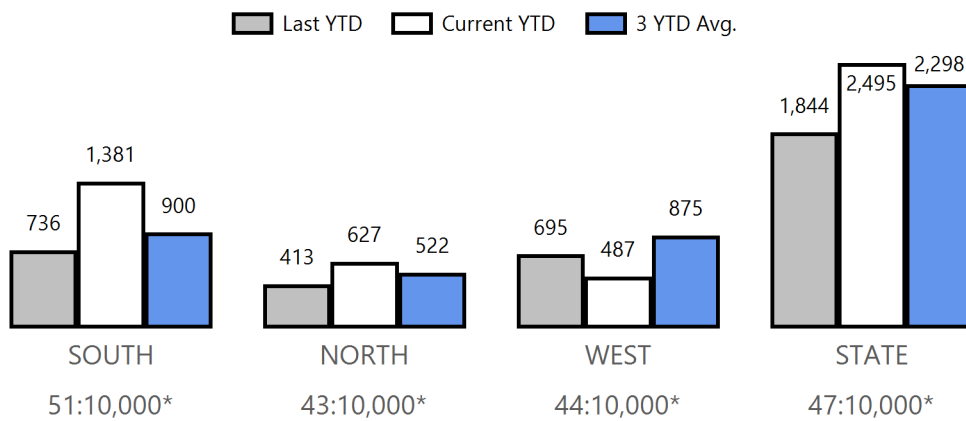
Mobile Phone Offenders - April 2021

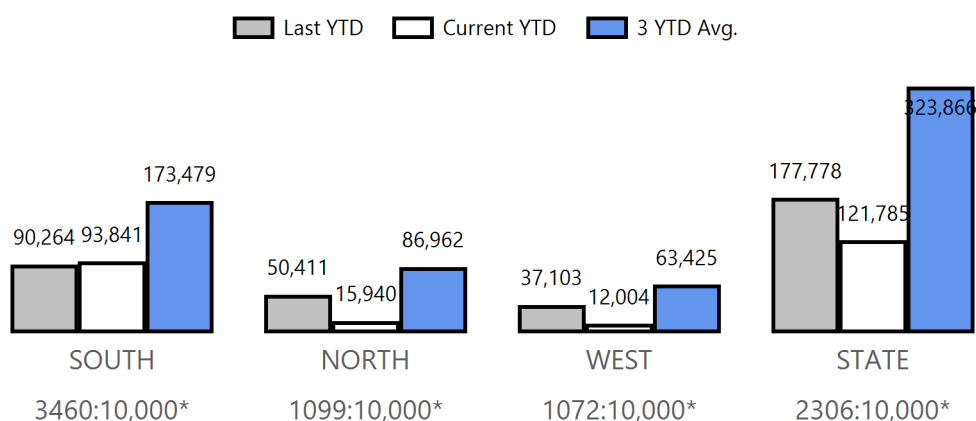
Vehicle Defect Notices - April 2021

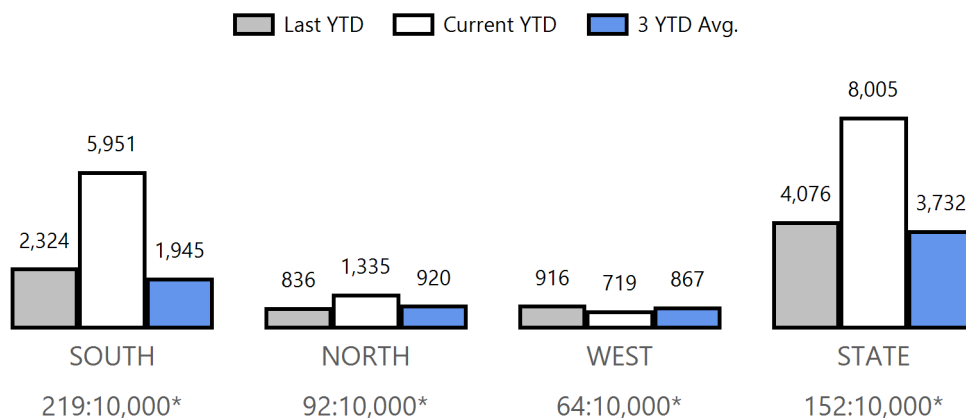
Random Breath Tests (ALCOHOL) - April 2021

Oral Fluid Tests (Drugs) - April 2021



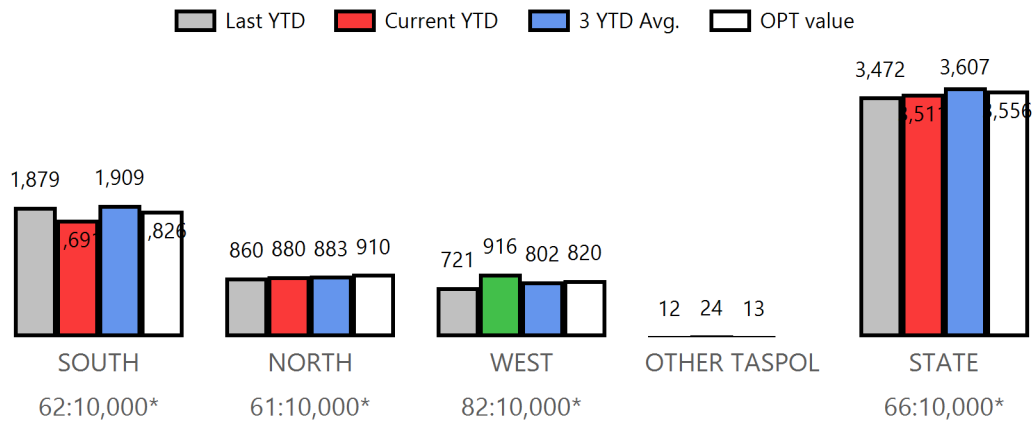

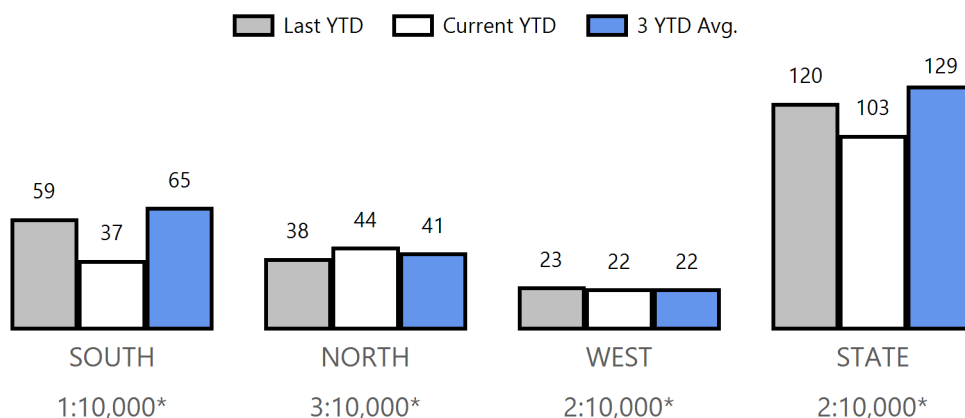

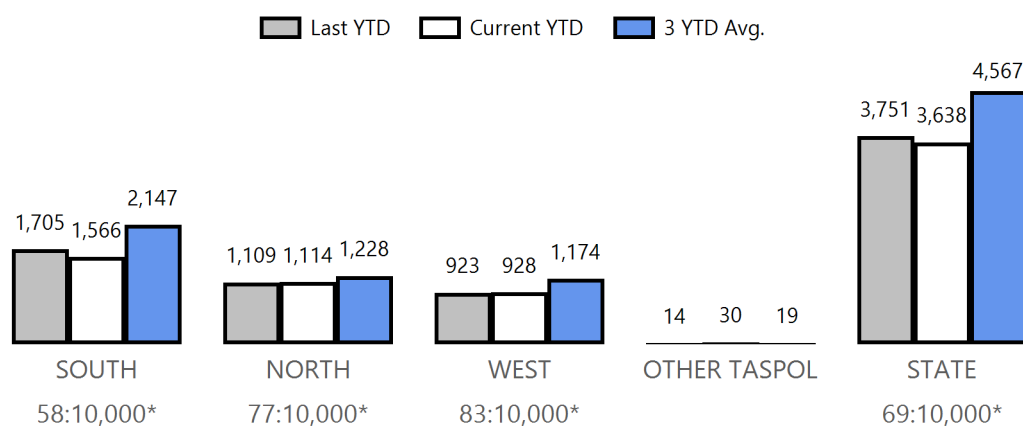
Dangerous and Reckless Driving Offenders - April 2021

Disqualified and Unlicensed Driving Offenders - April 2021



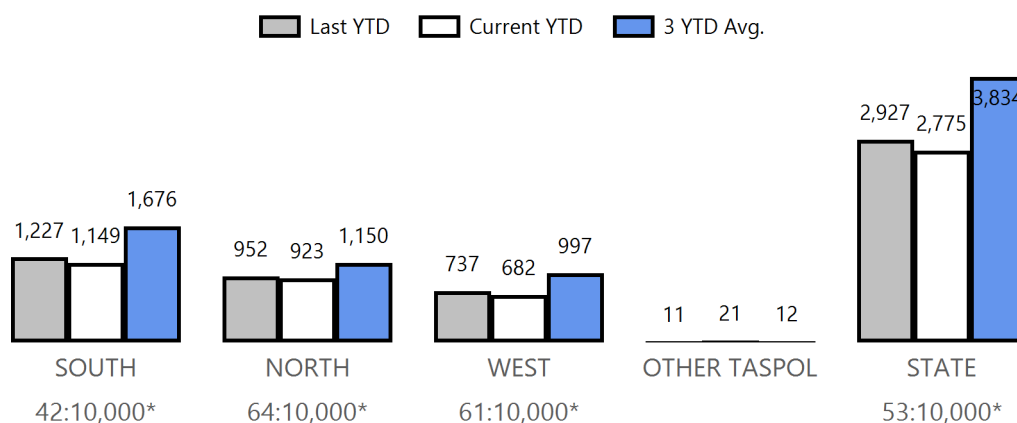

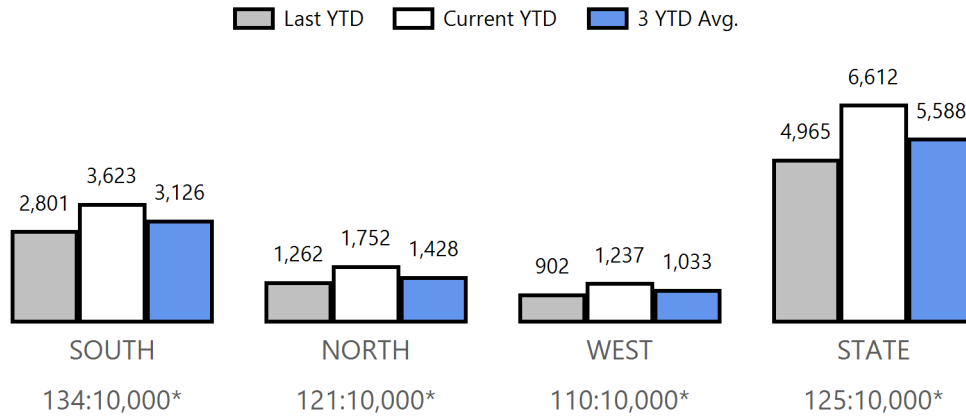
Unregistered Vehicle Offenders - April 2021

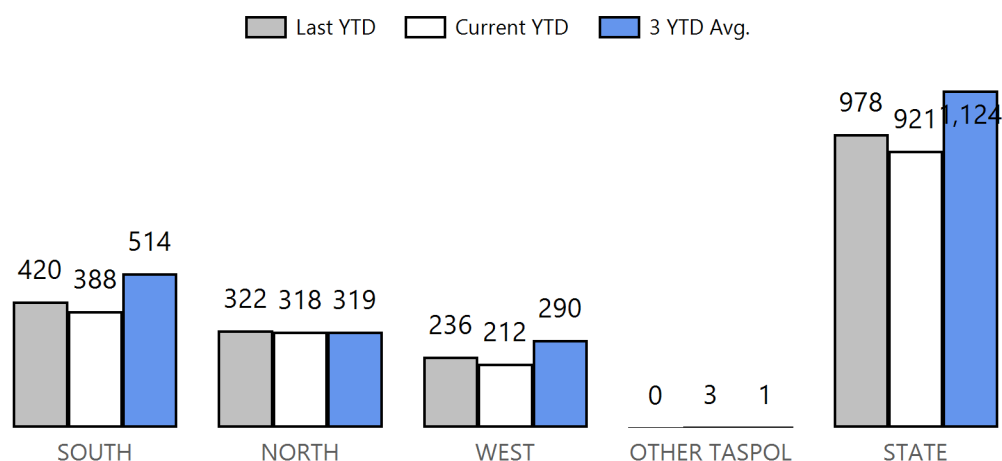
Vehicle Complaints made to RDS - April 2021

Vehicles Clamped or Confiscated - April 2021



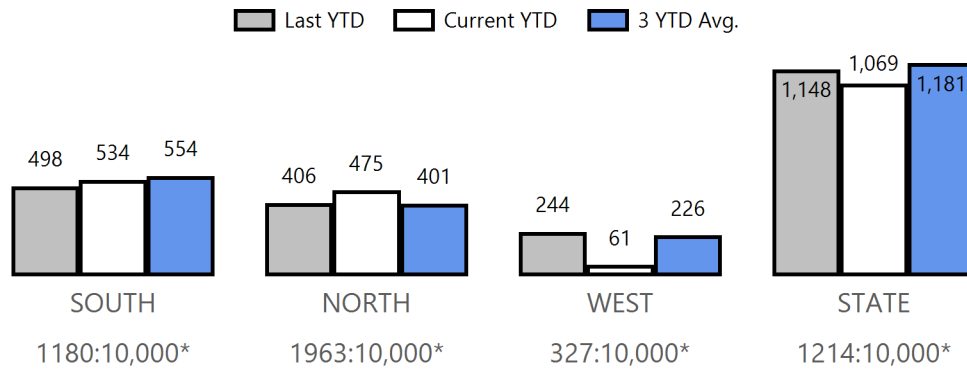

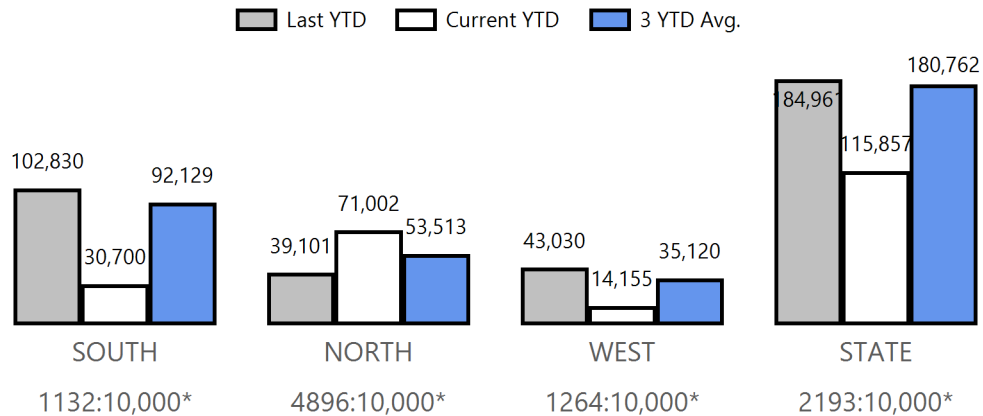
Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - April 2021

ANPR: Total Vehicles Captured - April 2021



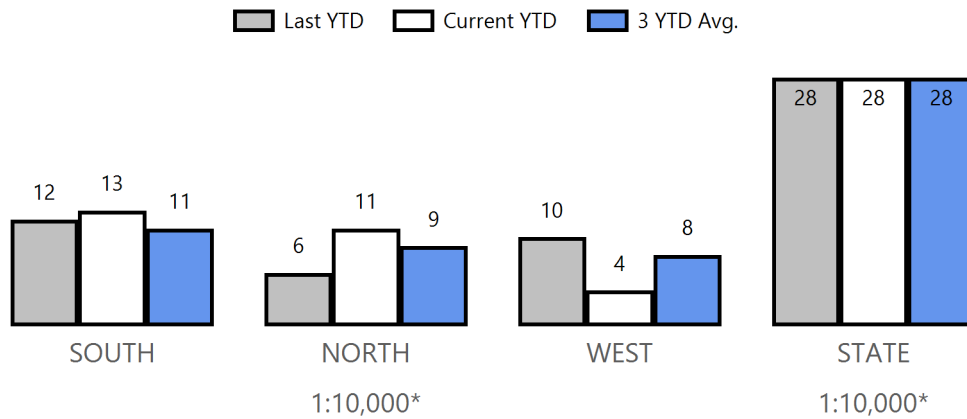

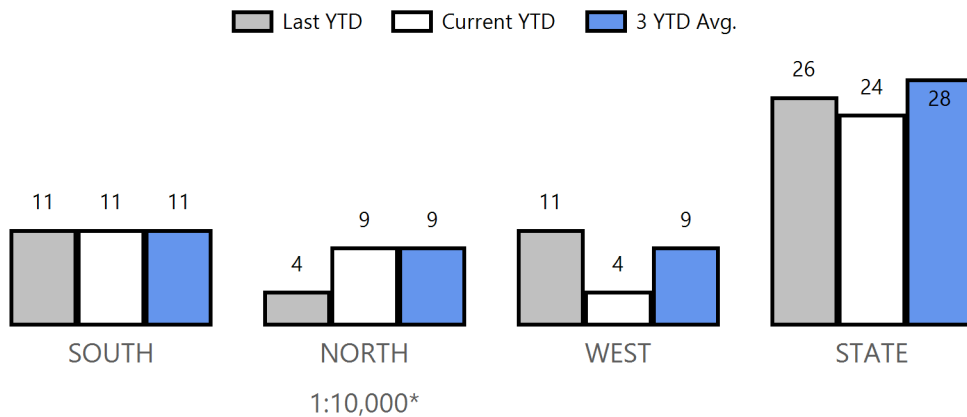
Road Crashes: Fatalities YTD - April 2021

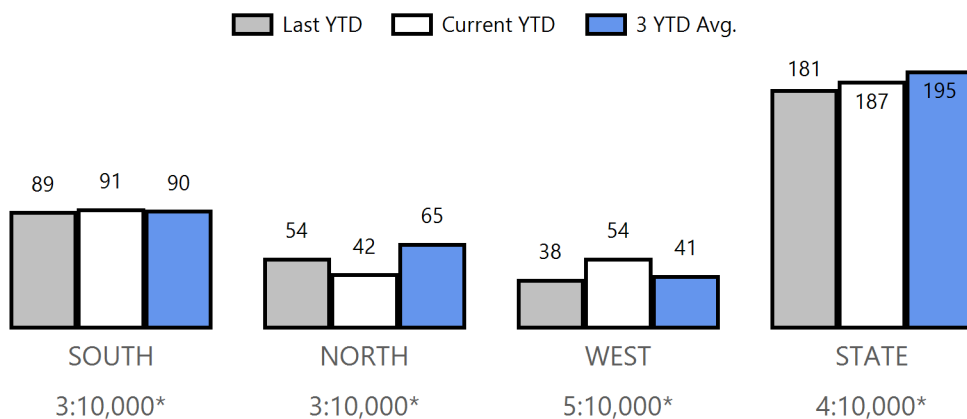
Fatal Crashes - April 2021

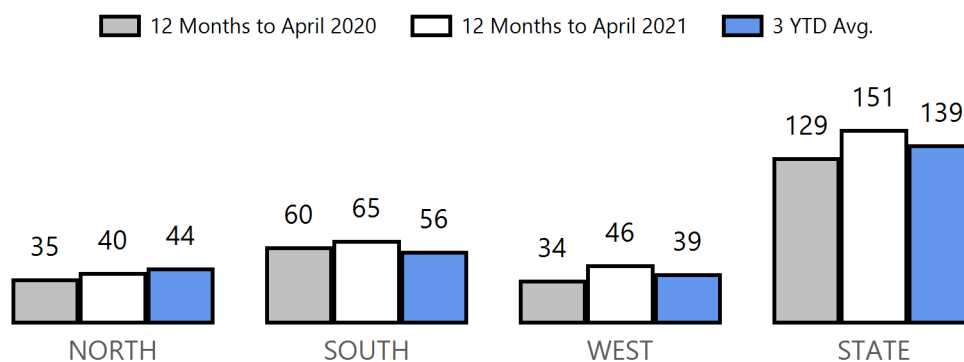

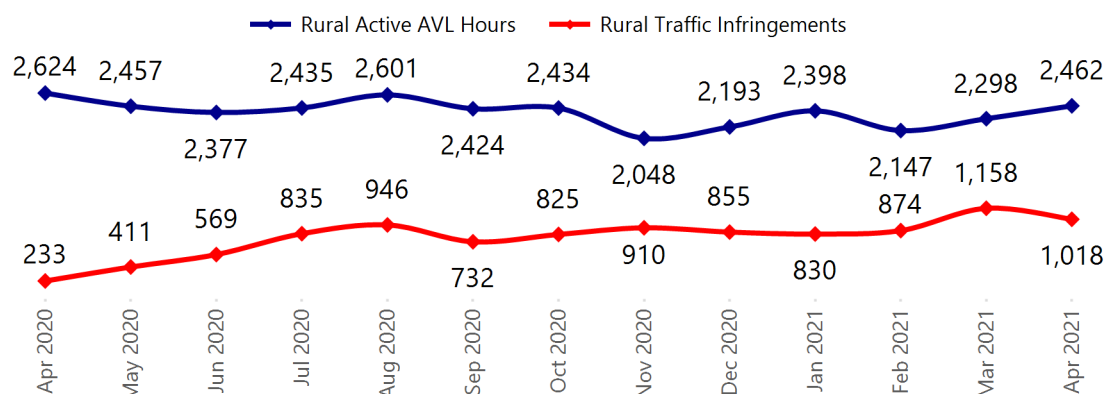
On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)



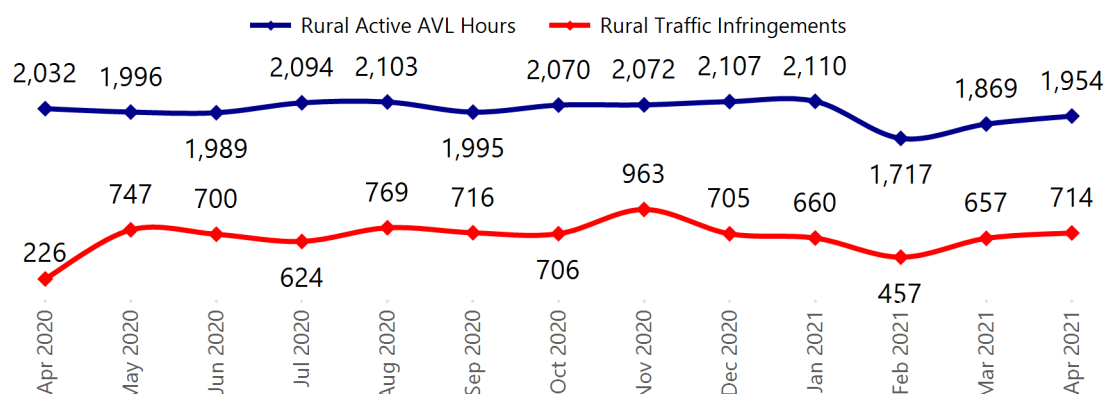

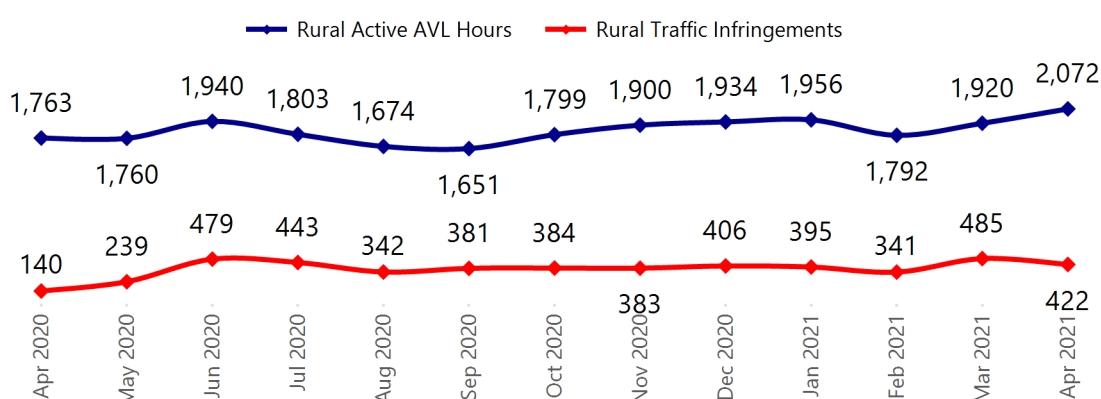
Southern District Rural Policing



Northern District Rural Policing

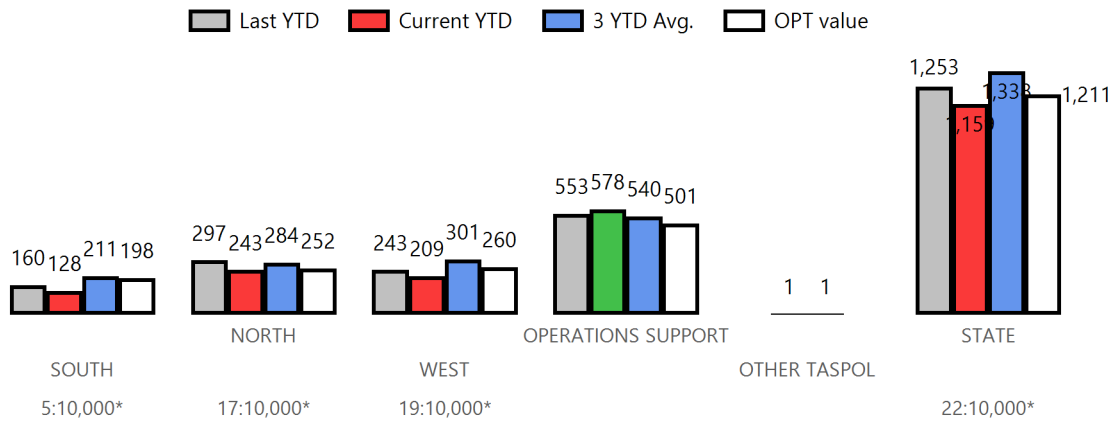

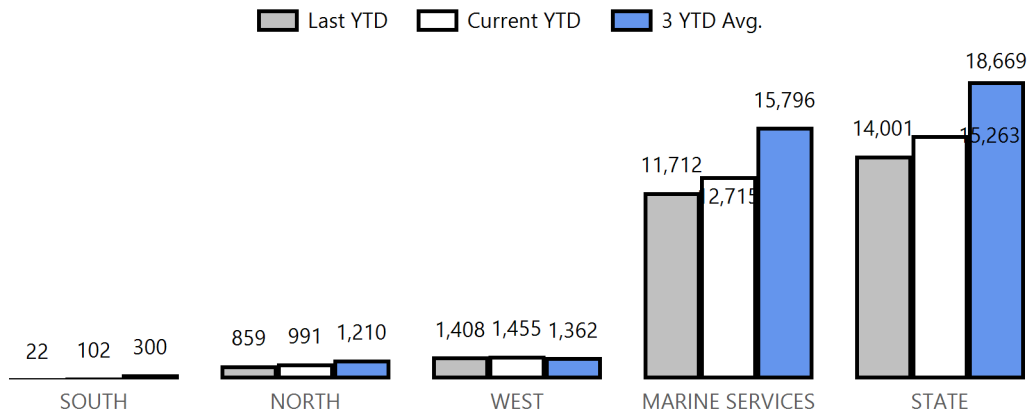

Marine Offenders - April 2021



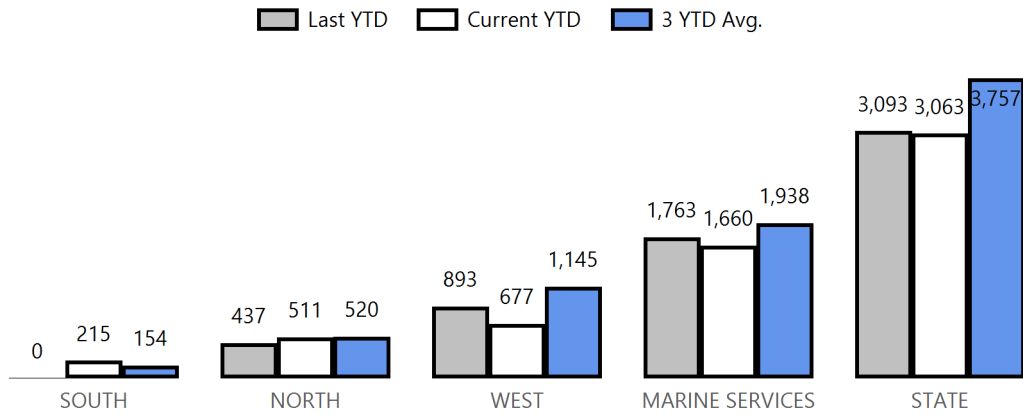

Sea Inspections (Vessel & Non-Vessel) - April 2021



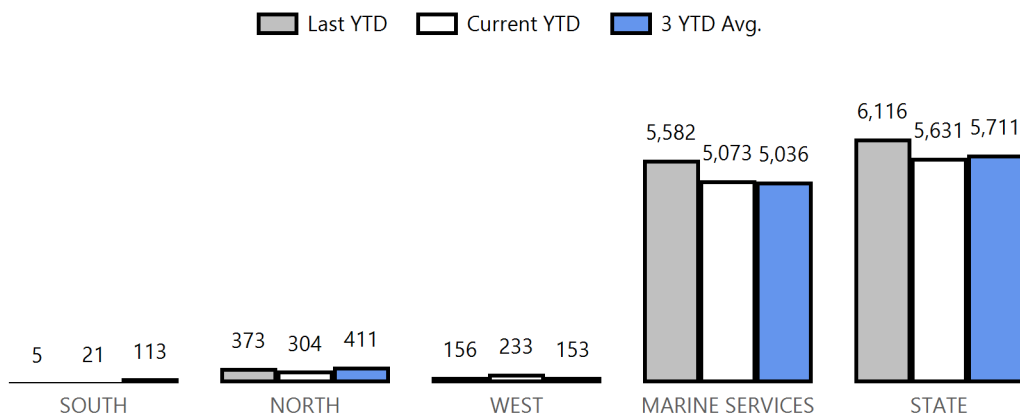
