#### Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.






## Safety In Neighbourhood During the Day






## Public Order Incidents - April 2024


## Public Order : Disturbance - April 2024


## Public Order : Noise - April 2024


## Public Order : Vandalism - April 2024


## Public Order : Offensive Behaviour - April 2024

## Liquor Infringement Notices - April 2024















## Total Person Offences - Victim Relationship - SOUTH








## Uniform Police - Patrol Hours

## Uniform Police Hours on Dispatch Tasks - April 2024







### Family Violence Incidents - April 2024





### Family Violence RAST - Excludes Other and Argument Categories






## Family Violence Incidents with Child Witness - April 2024

## Family Violence Incidents: Weapons Present - April 2024






### FV Incidents with Police FV Order Issued - April 2024


### FV Incidents with FV Order Application - April 2024


## Breach of Police Family Violence Orders - April 2024

## Breach of Family Violence Orders (excluding PFVOs) - April 2024










## SMV : Recovered Fire Damaged - April 2024




## Intelligence Submission Occurrences - April 2024


## Street Check Occurrences - April 2024


## CIB: Total Offenders - April 2024










## Speeding Offenders - April 2024


## Speeding 15-29 km/h Offenders - April 2024


## Speeding 30+ km/h Offenders - April 2024


## High Risk Traffic Offenders - April 2024


## Seatbelt Compliance Offenders - April 2024






## Random Breath Tests (Alcohol) - April 2024









## Unregistered Vehicle Offenders - April 2024








## Crash Fatalities - April 2024


## Fatal Crashes - April 2024

## Serious Injury Crashes - April 2024






## On Road Fatal and Serious Crashes in Rural Areas - April 2024












## Sea Inspections (Vessel & Non-Vessel) - April 2024


## Vessel Inspections on Land - April 2024
