Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 2 November 2022. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

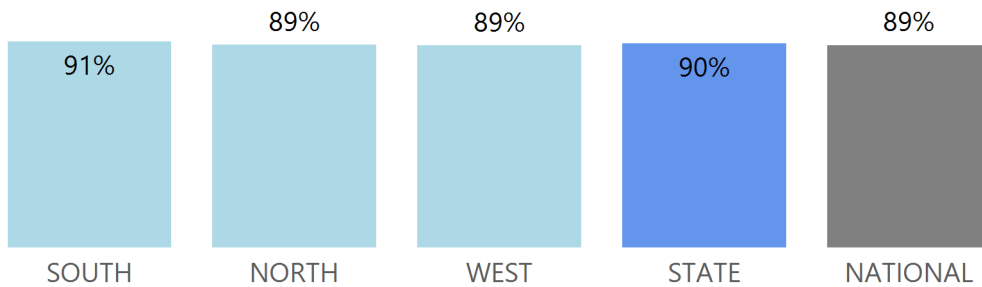

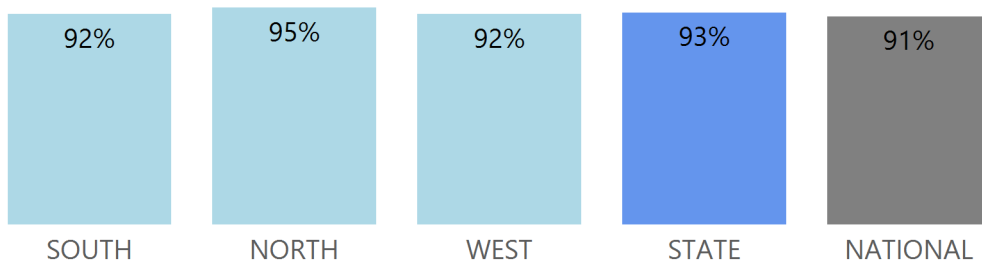

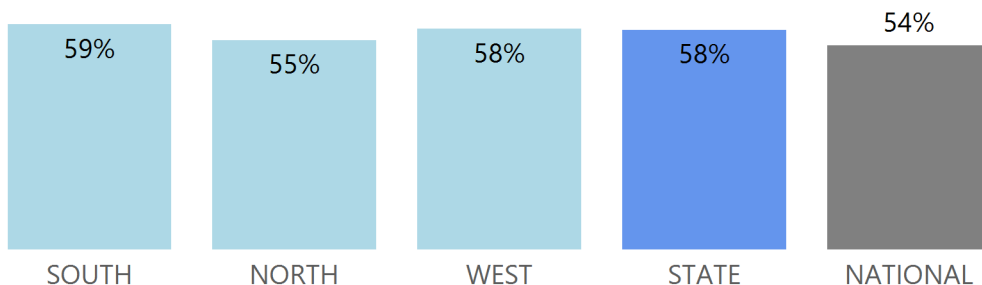
Public Safety - Out in Public Locally (Daytime)

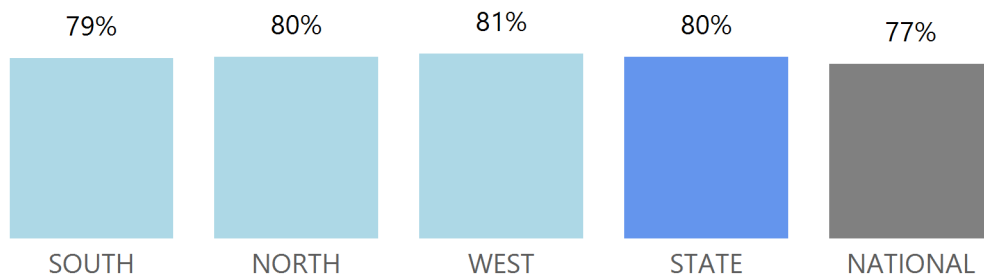

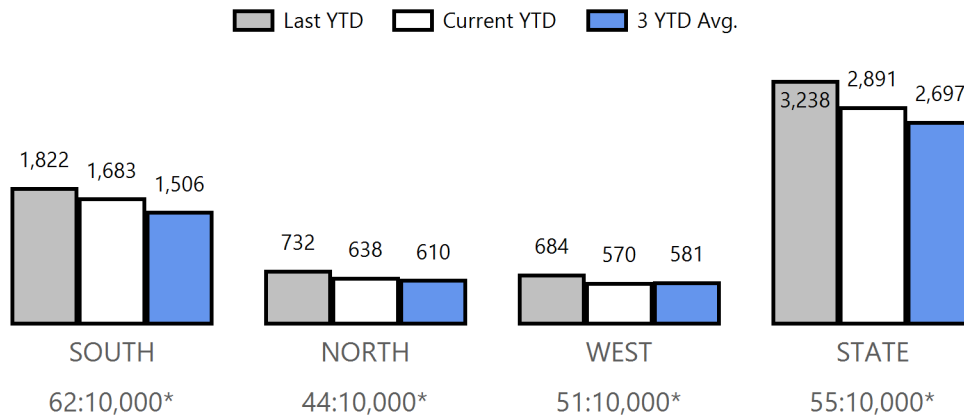

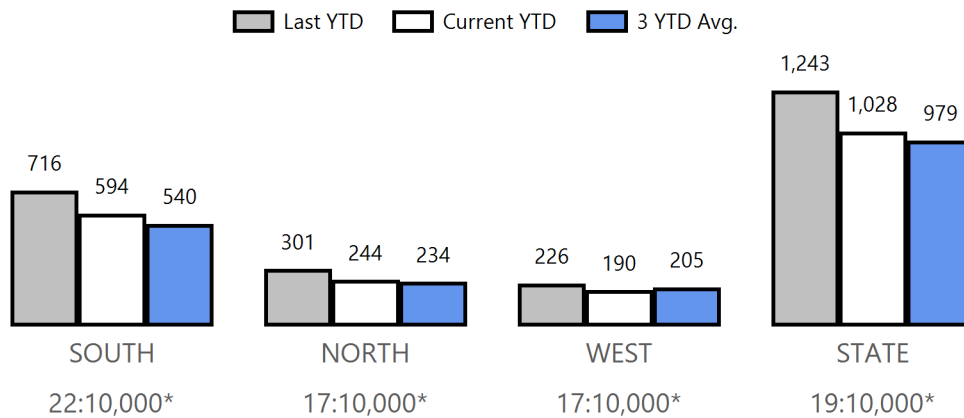
Public Order Incidents - August 2022

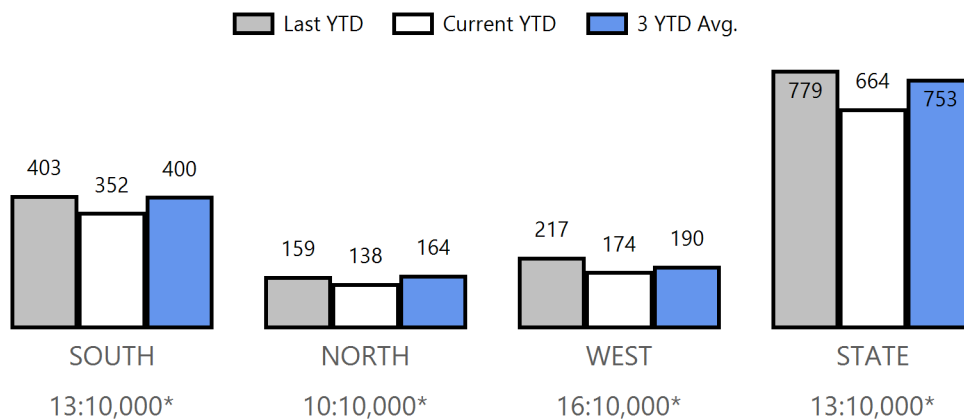
Public Order : Disturbance - August 2022

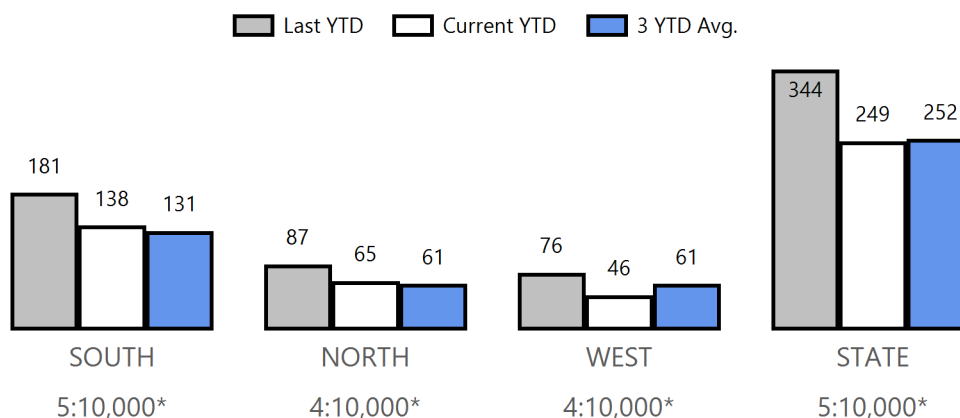
Public Order : Noise - August 2022

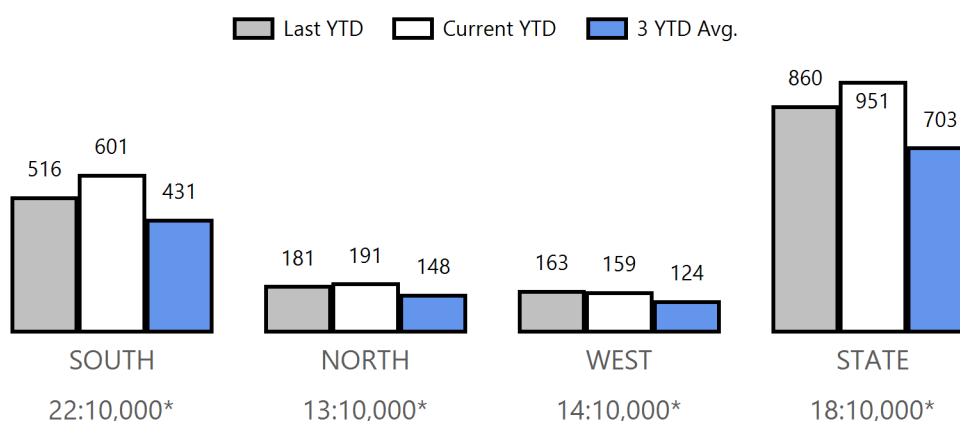
Public Order : Vandalism - August 2022

Public Order : Offensive Behaviour - August 2022

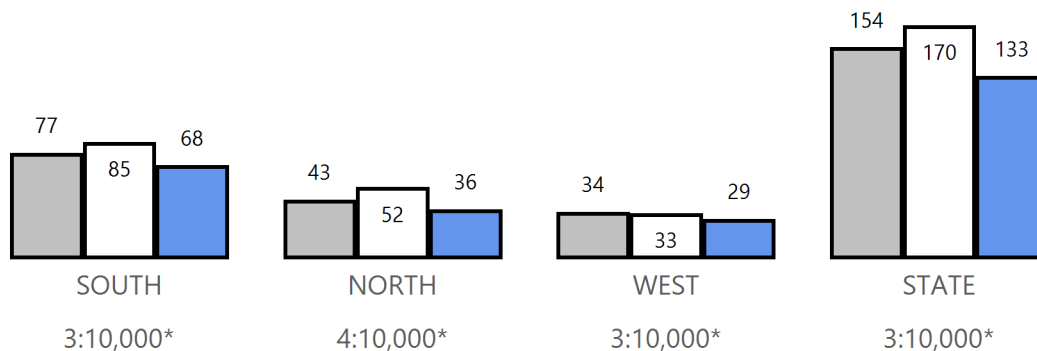

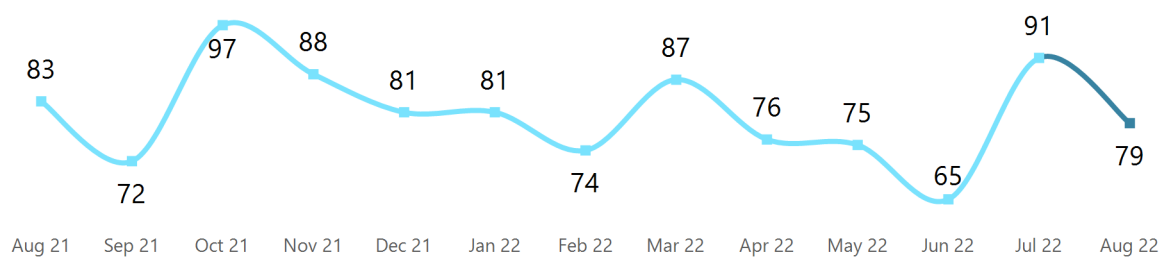

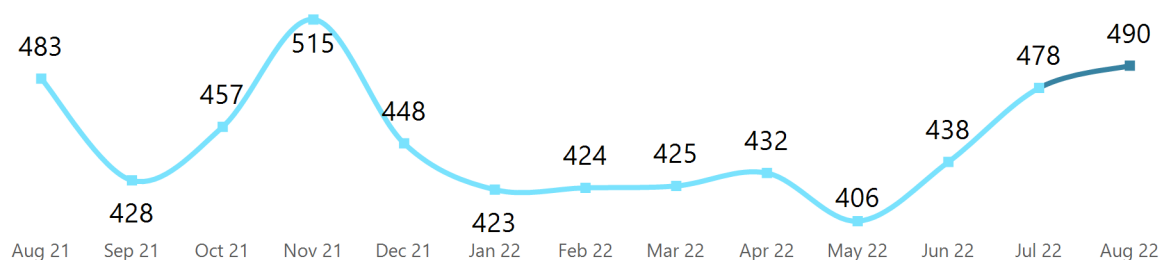

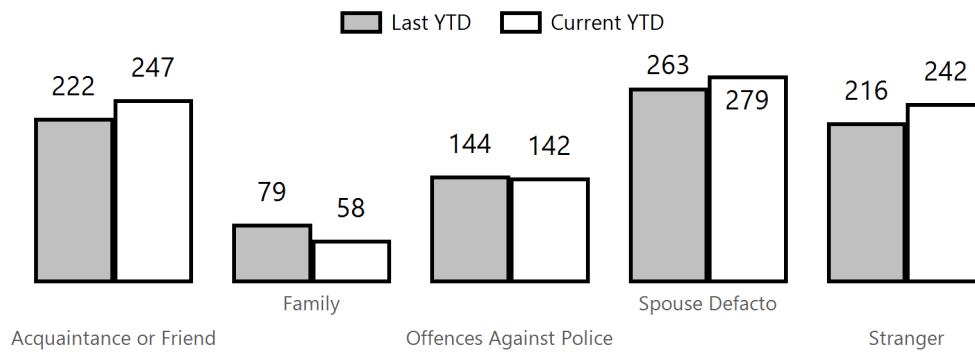

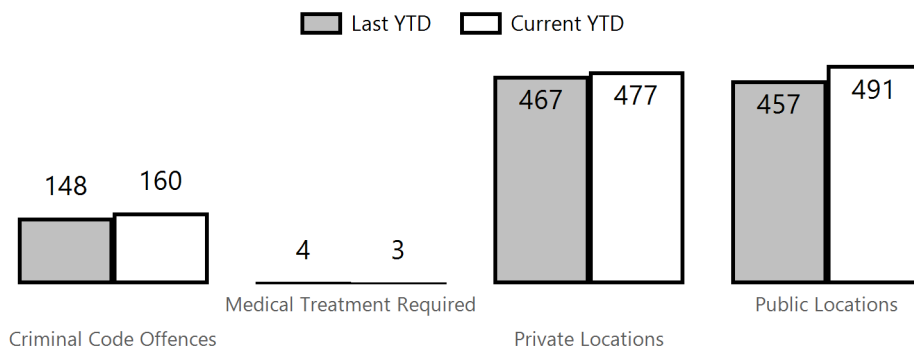

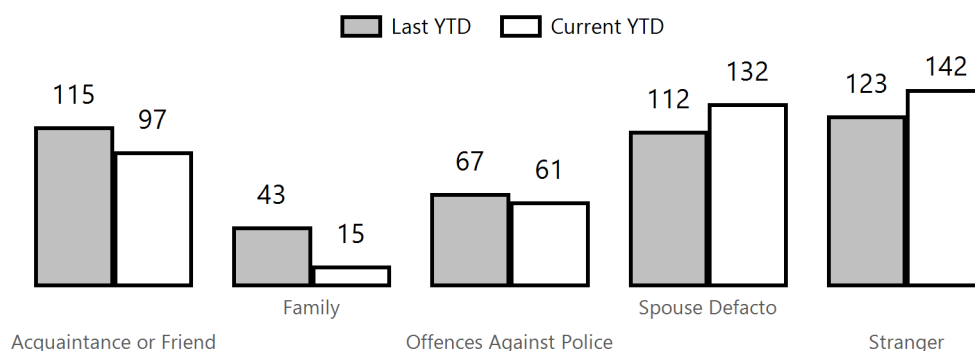

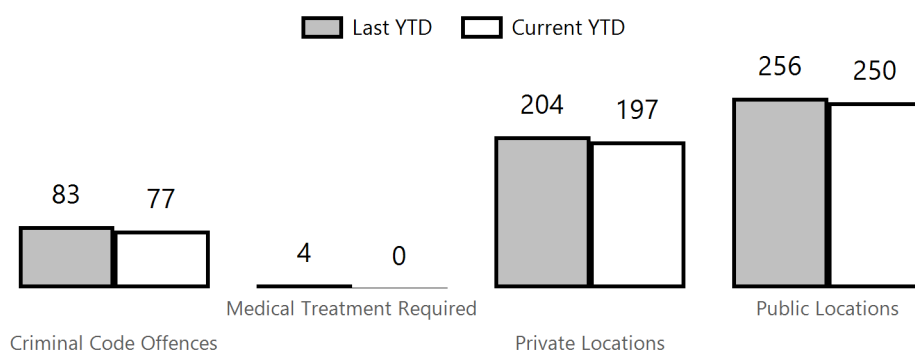

Total Person Offences - Victim Categories - SOUTH



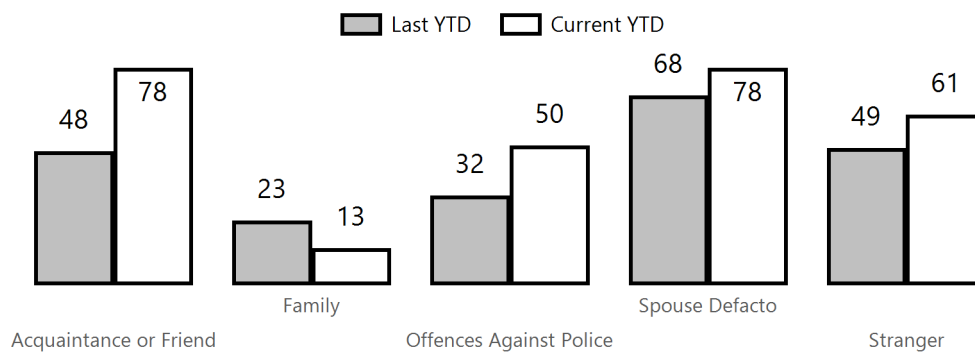

Total Person Offences - SOUTH



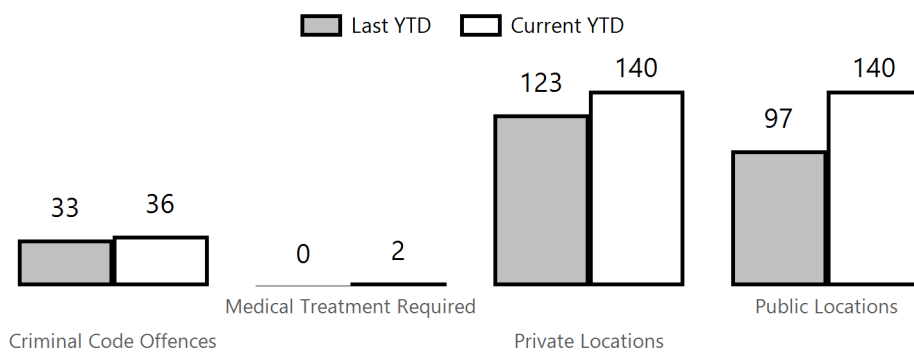

Total Person Offences - Victim Categories - NORTH



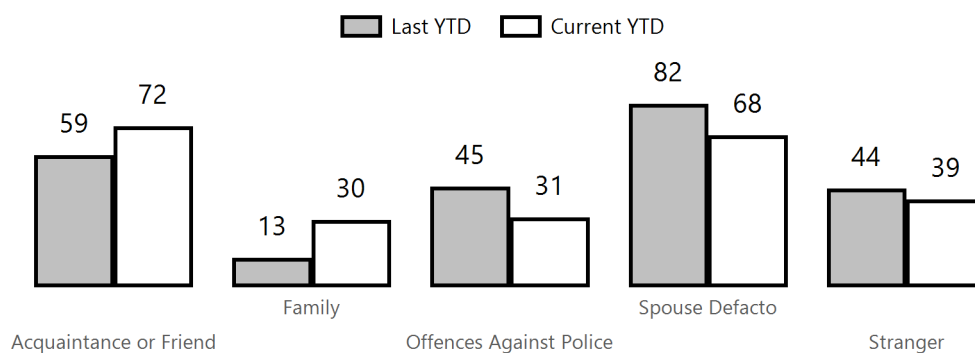

Total Person Offences - NORTH



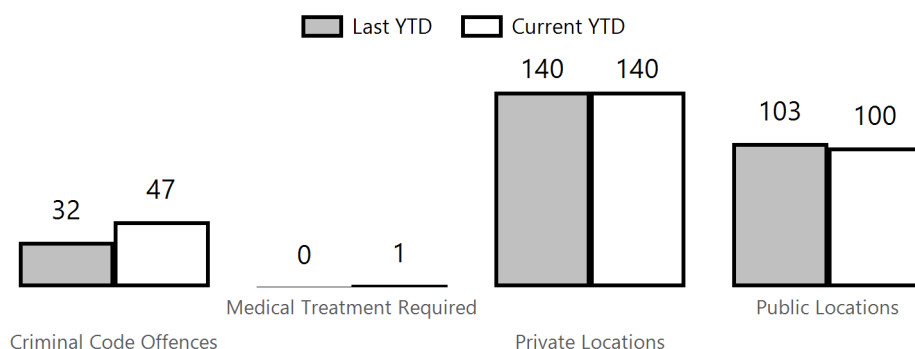

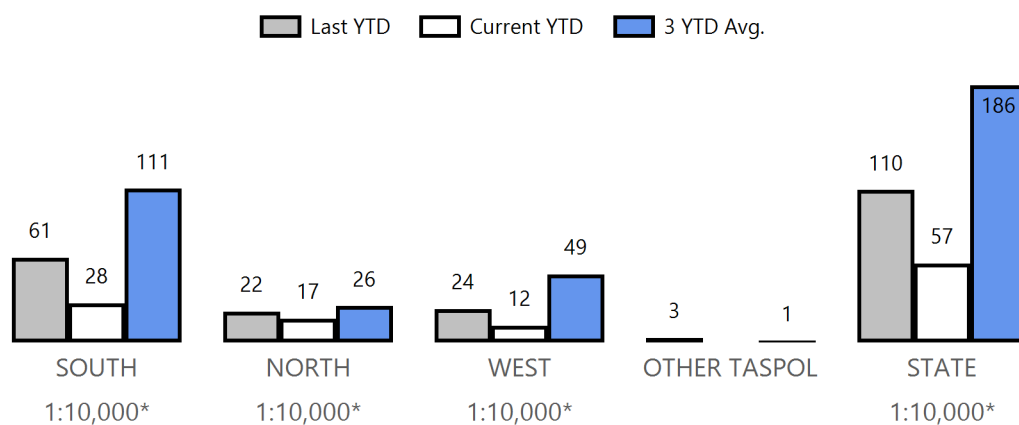

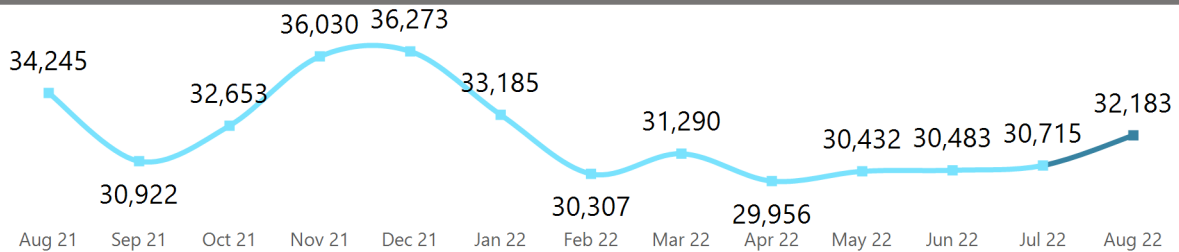
Total Uniform Police Patrol Hours - August 2022

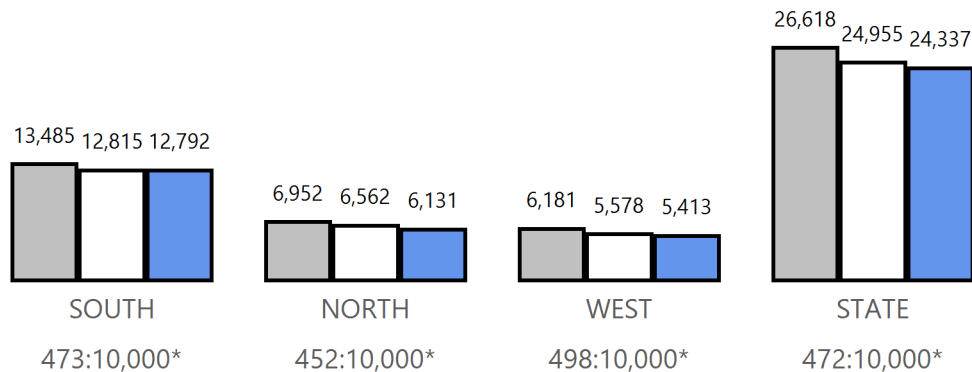
Uniform Police - Patrol Hours

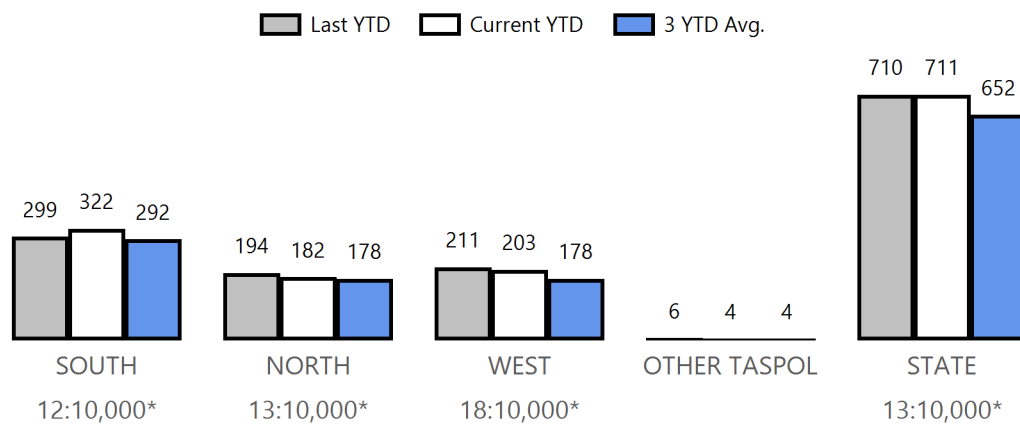

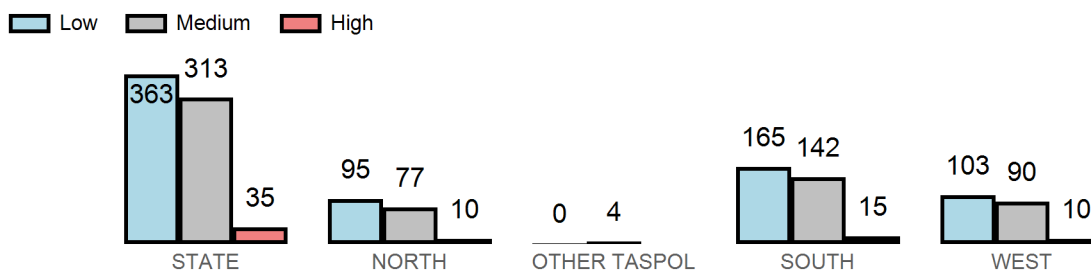
Family Violence Incidents - August 2022

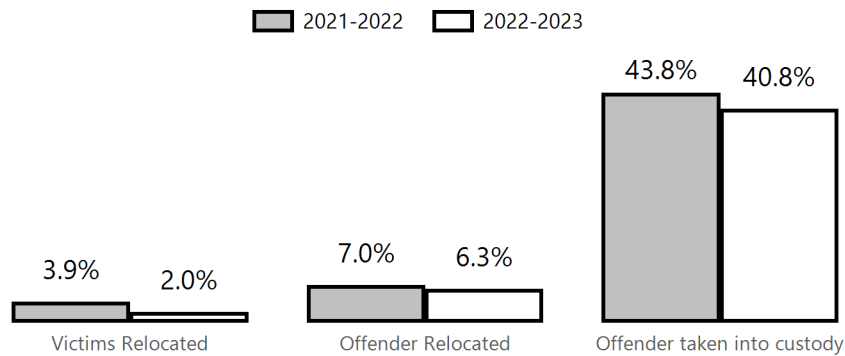

Family Violence RAST - Excludes Other and Argument Categories



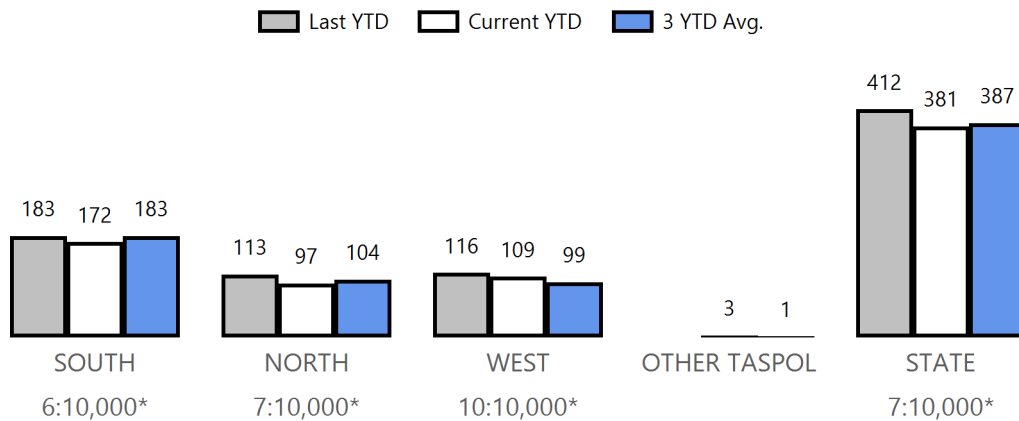

Family Violence - Action at Scene (Excludes 'Other' and 'Argument' categories)



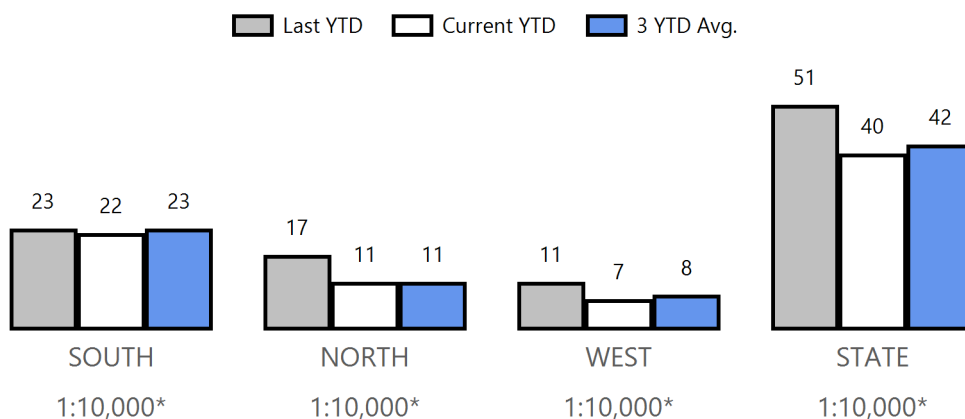

Family Violence : Weapons Present - August 2022

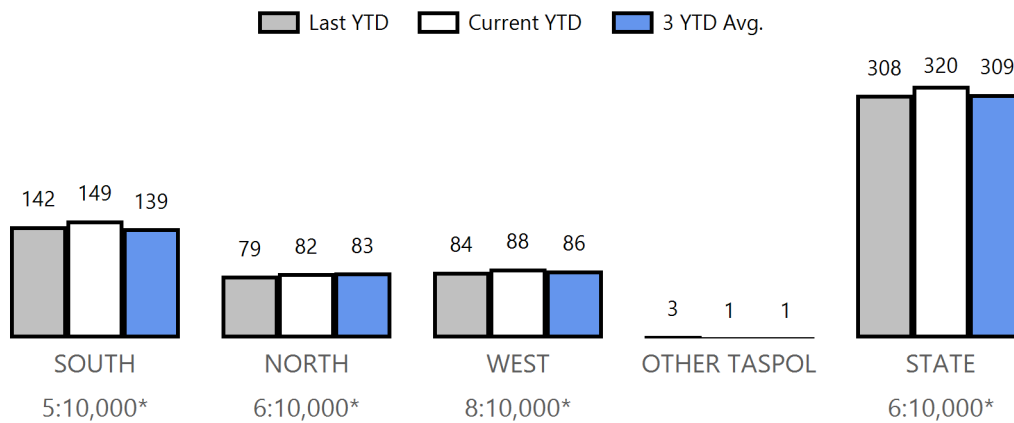

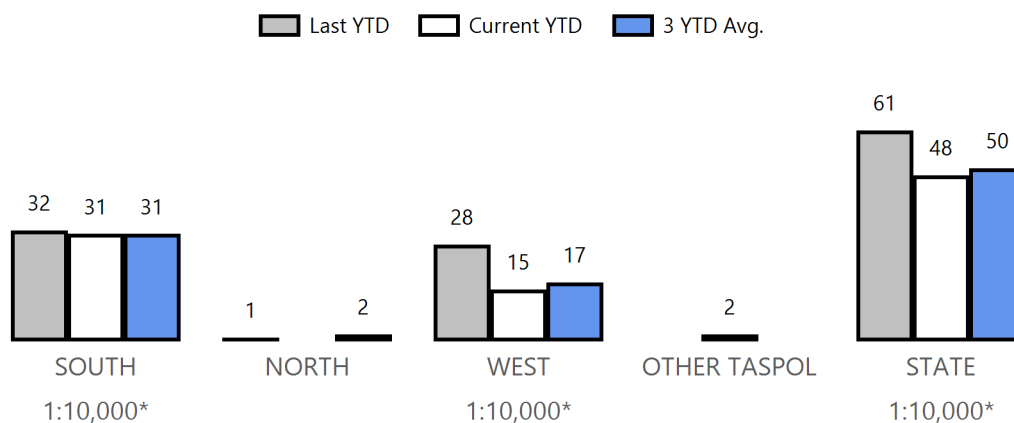
Family Violence Orders : Police Issued - August 2022

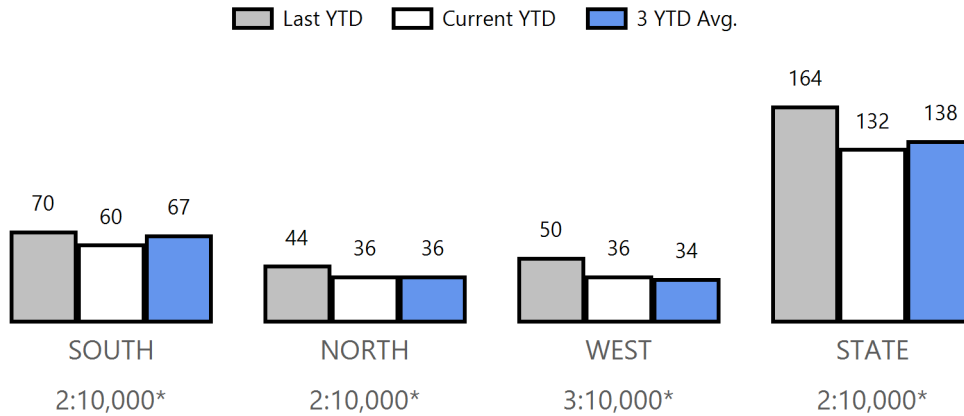
Family Violence Orders : Court Application - August 2022

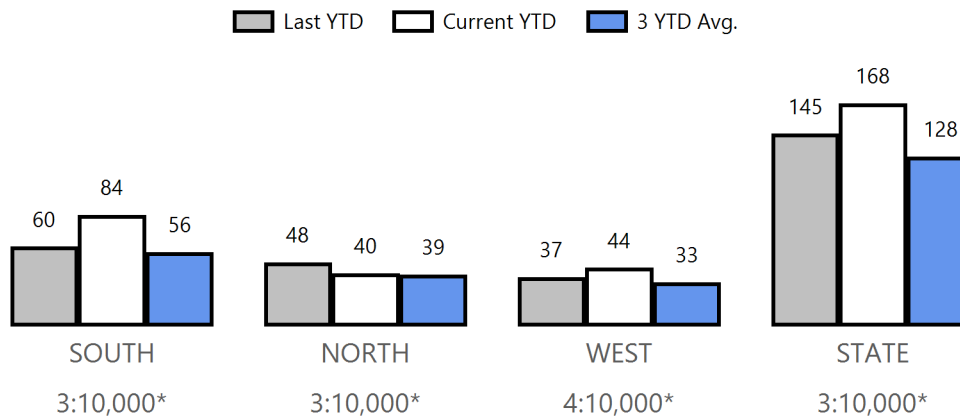
Family Violence - PFVO Breaches - August 2022

Family Violence - FVO Breaches - August 2022

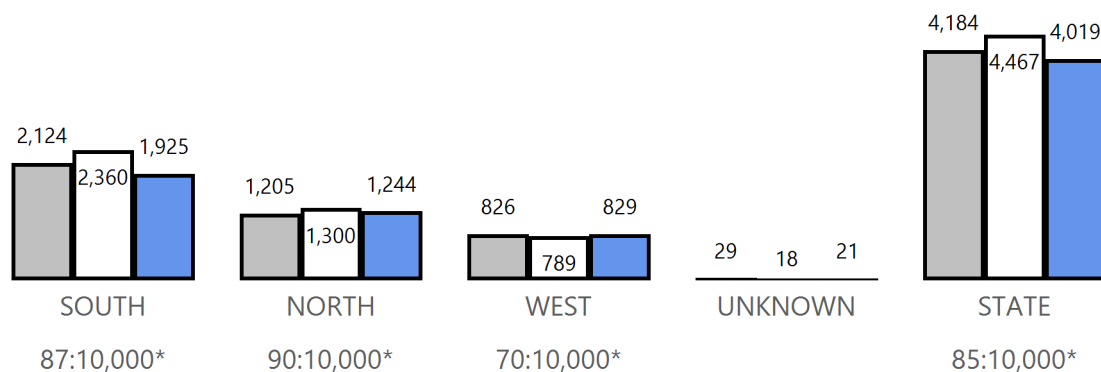

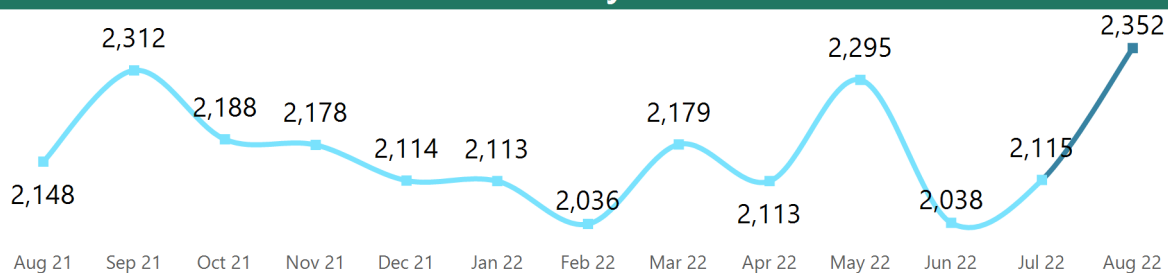

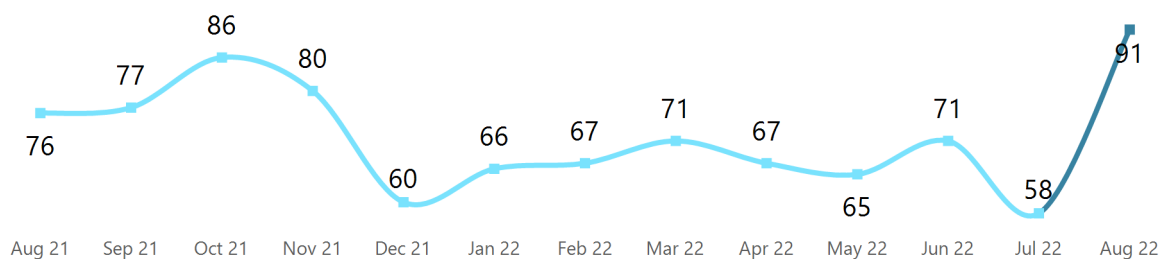

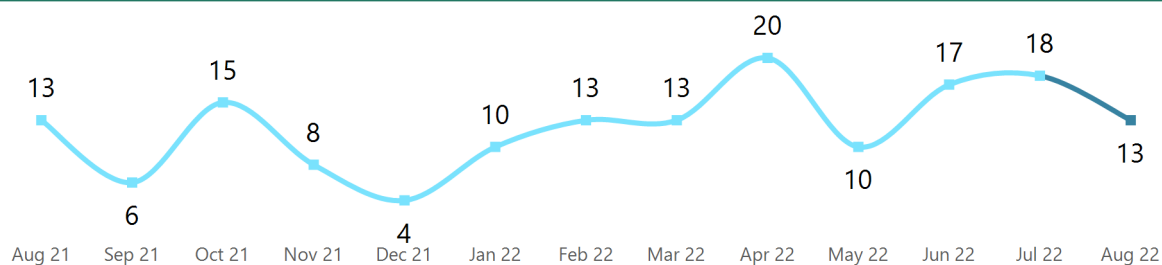

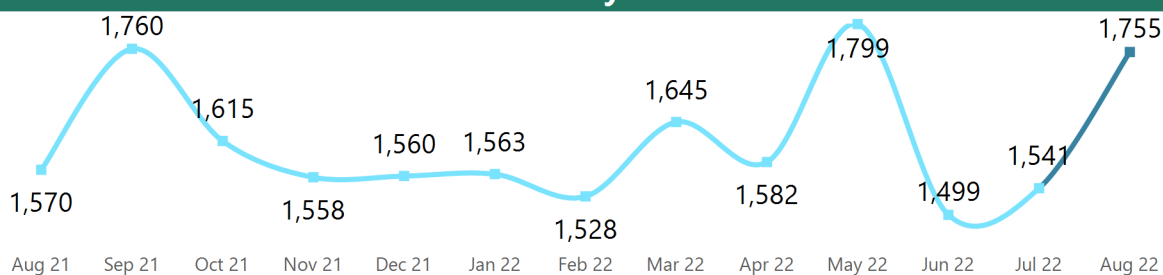

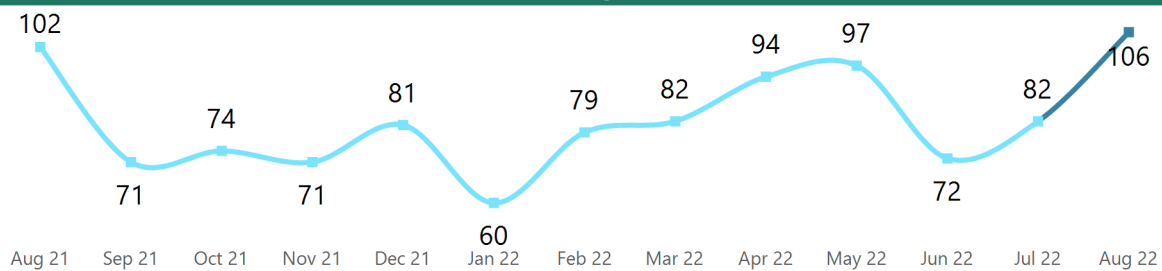

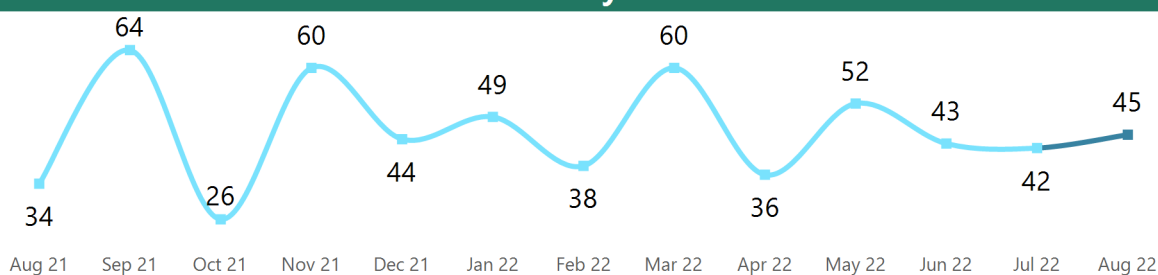

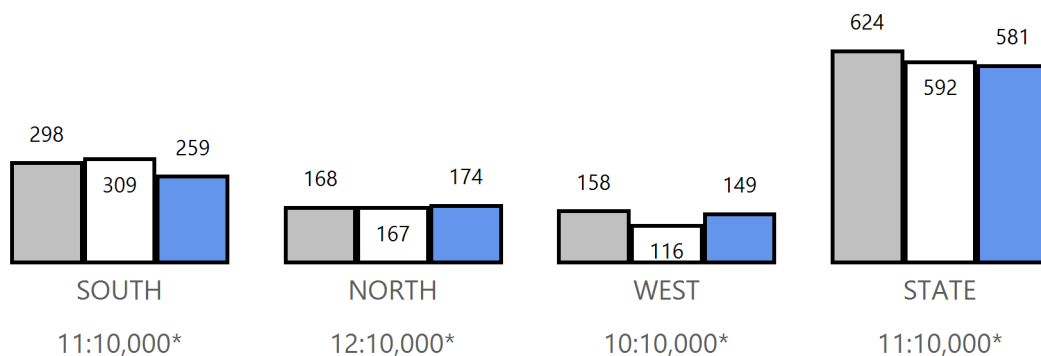

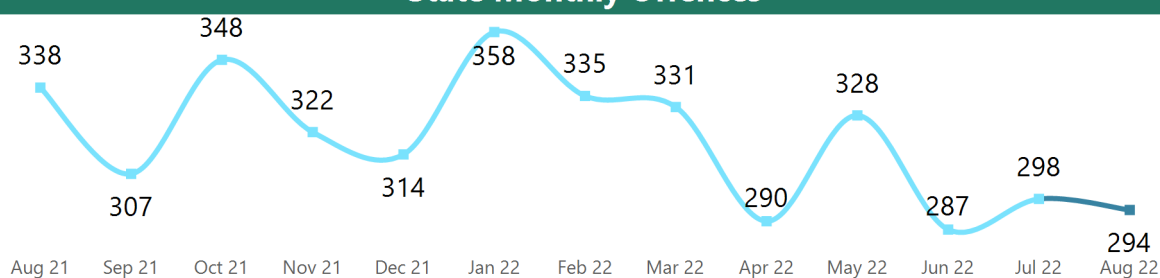

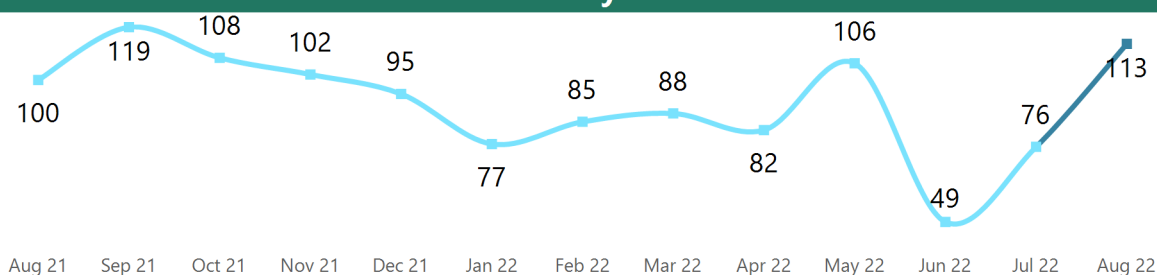

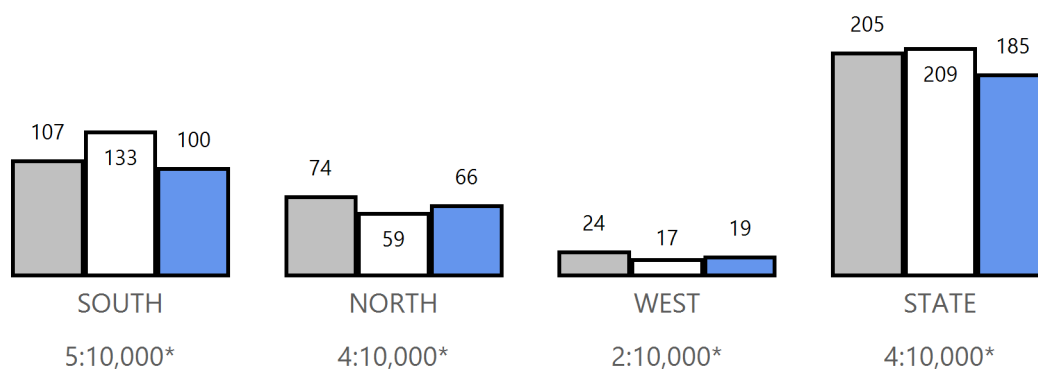

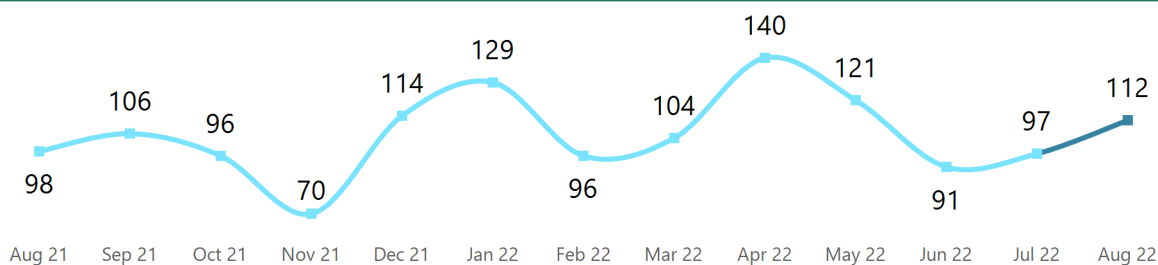

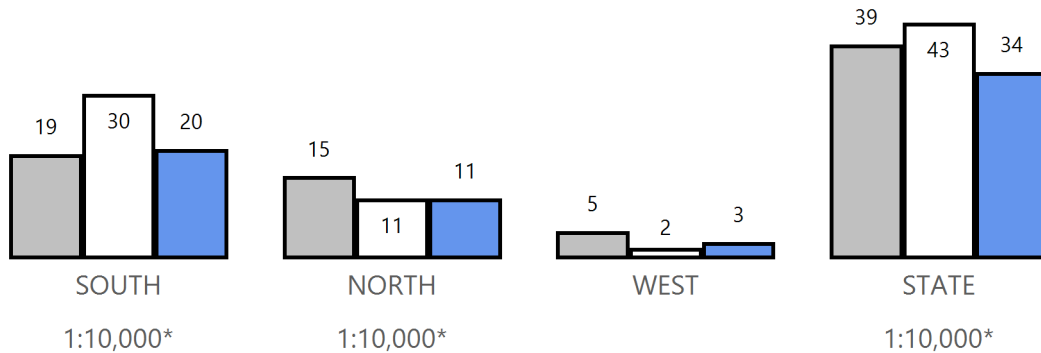

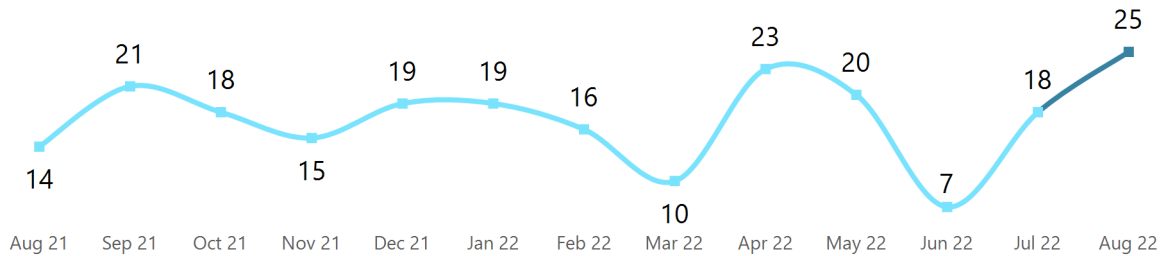
SMV : Fire Damaged - August 2022

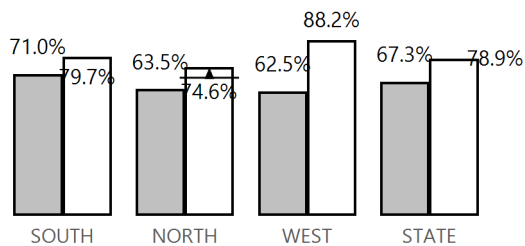

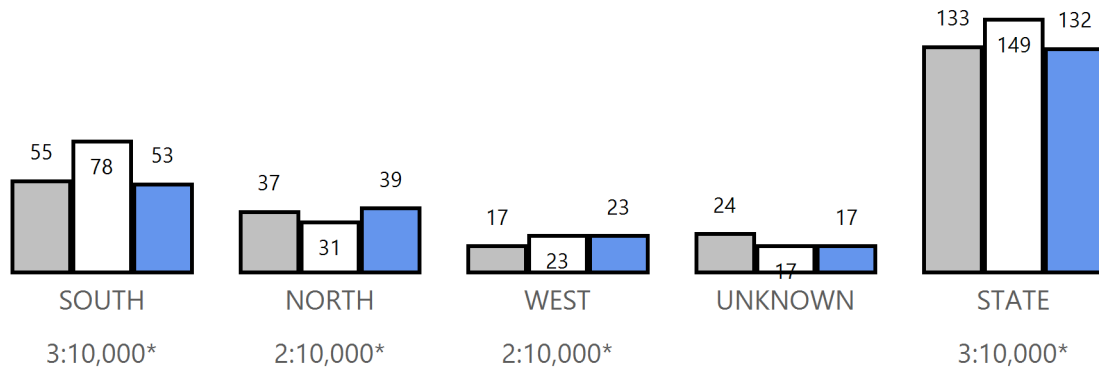

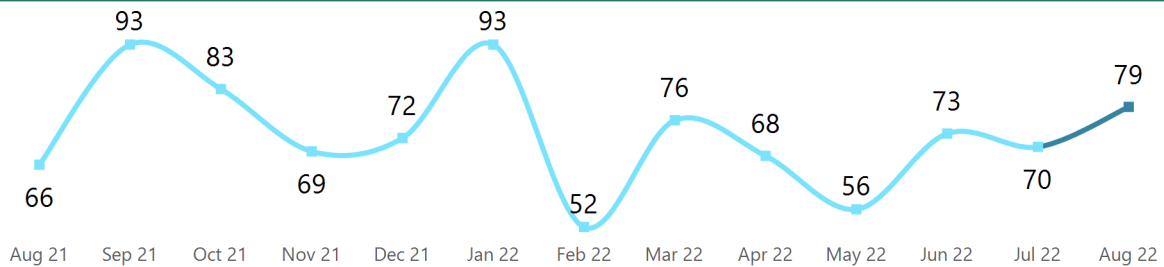

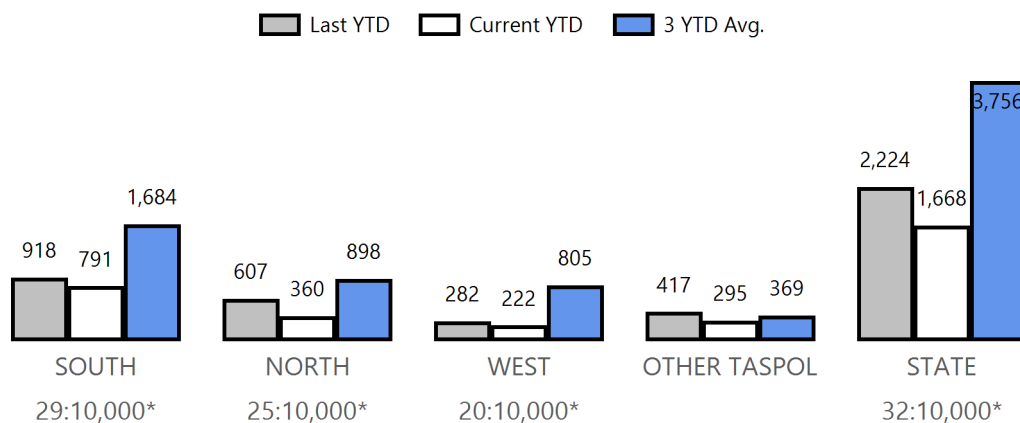

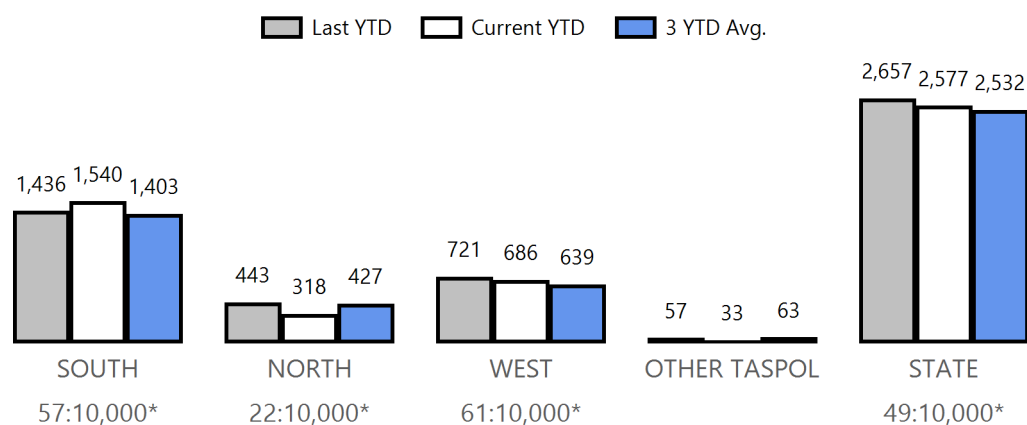

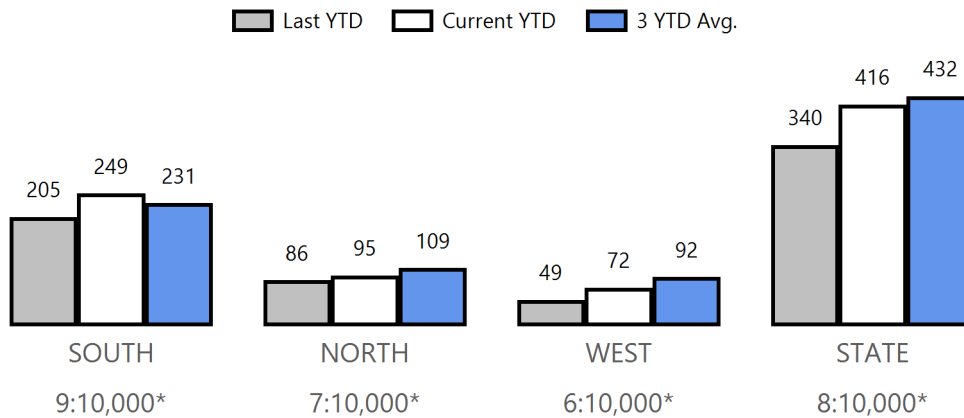
Total Street Checks - August 2022

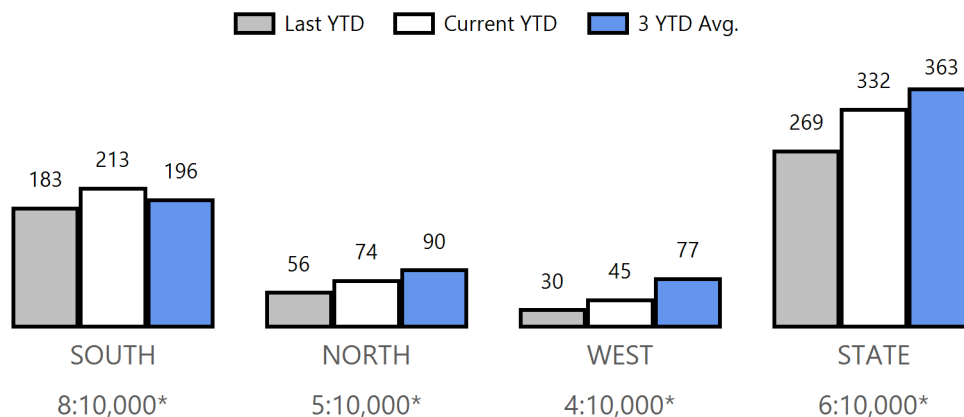
CIB: Total Offenders - August 2022

CIB: Total Crime Offenders - August 2022



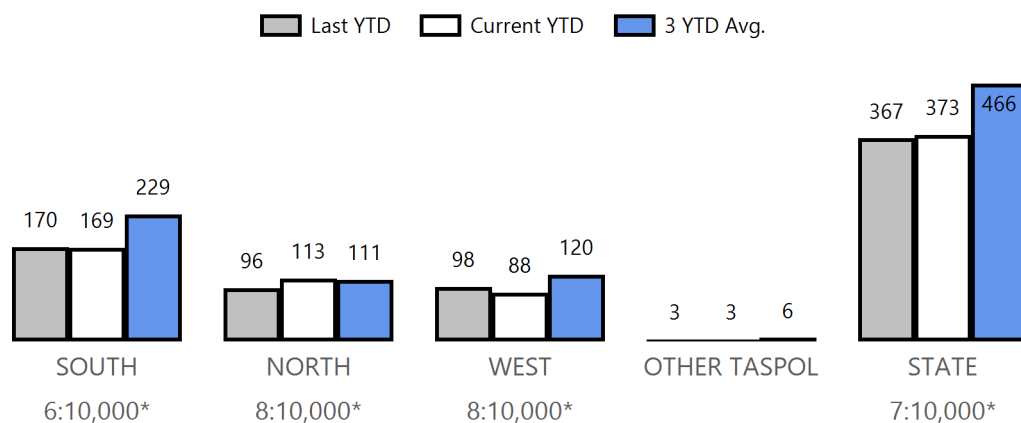

Total Drug Offenders - August 2022



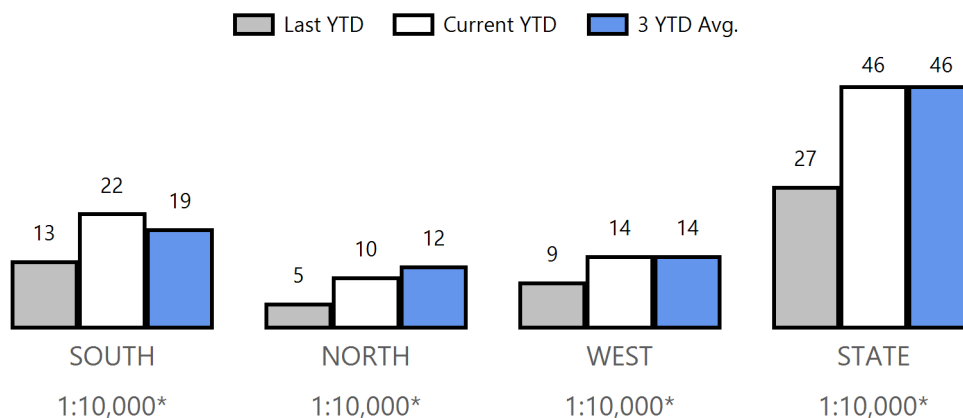

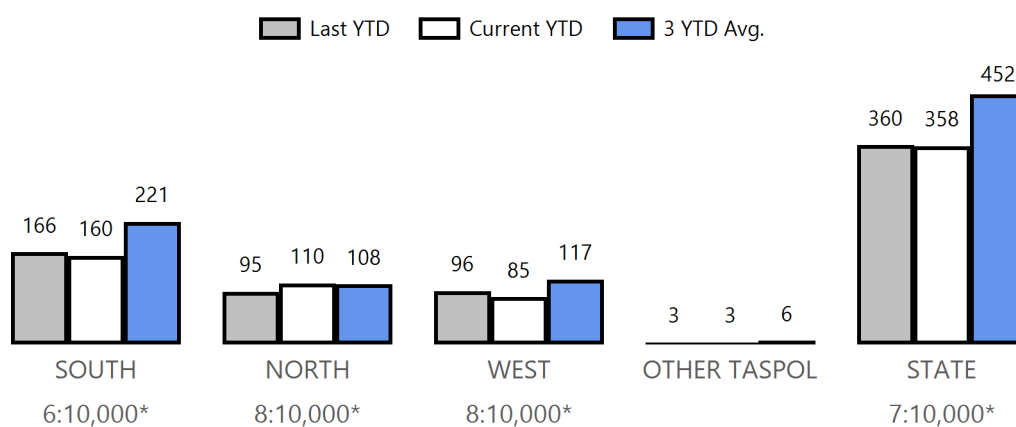

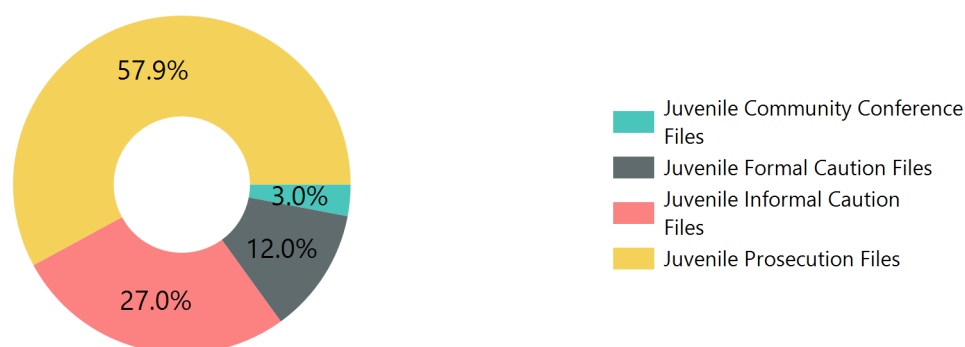

Total Traffic Offenders - August 2022



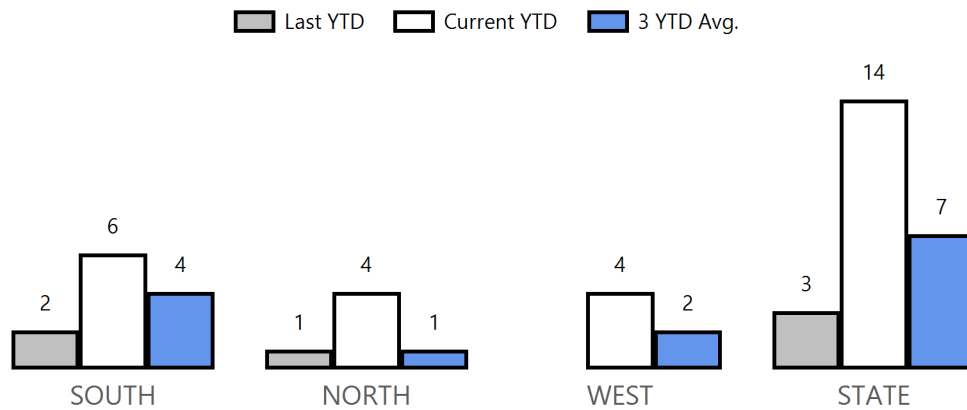

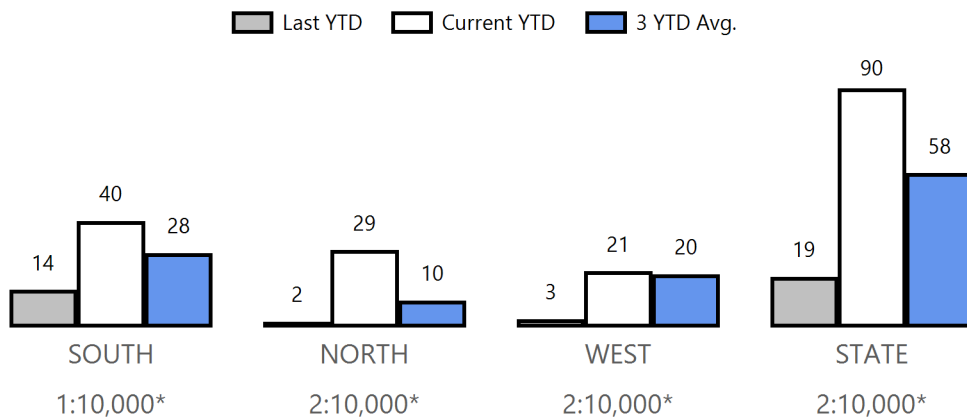
Major Traffic Operations - August 2022

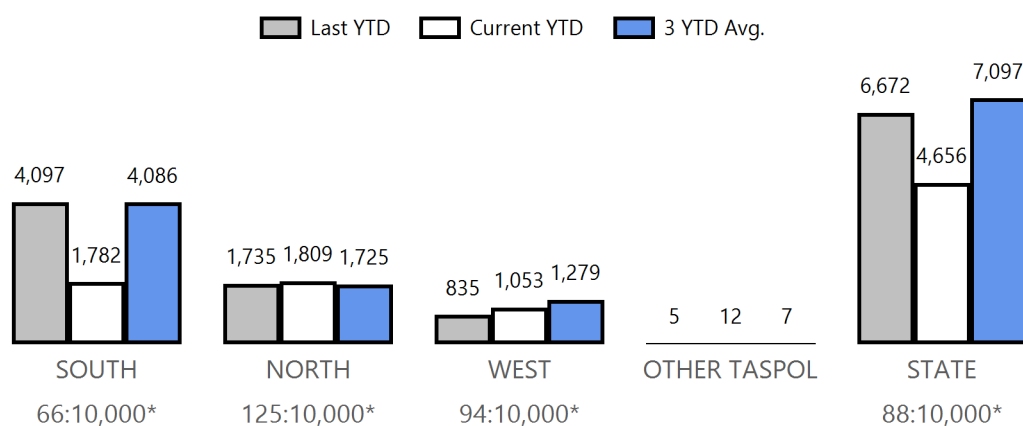

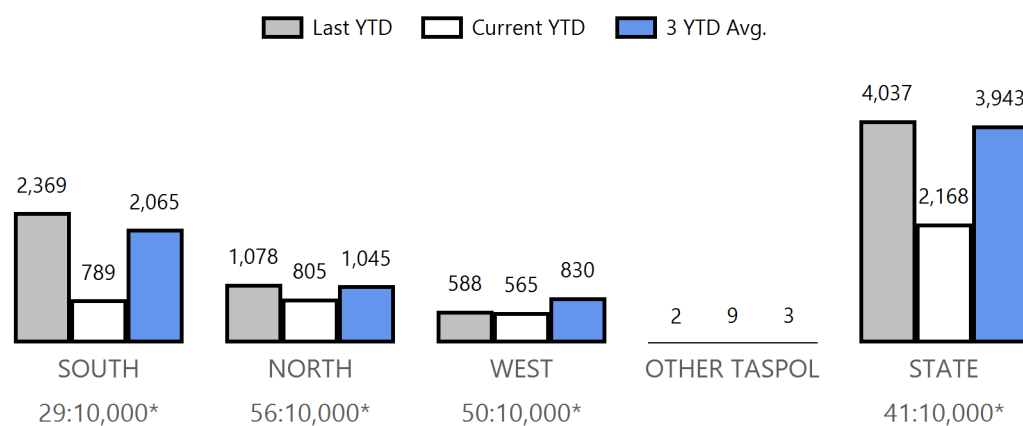
Speeding Offenders - August 2022

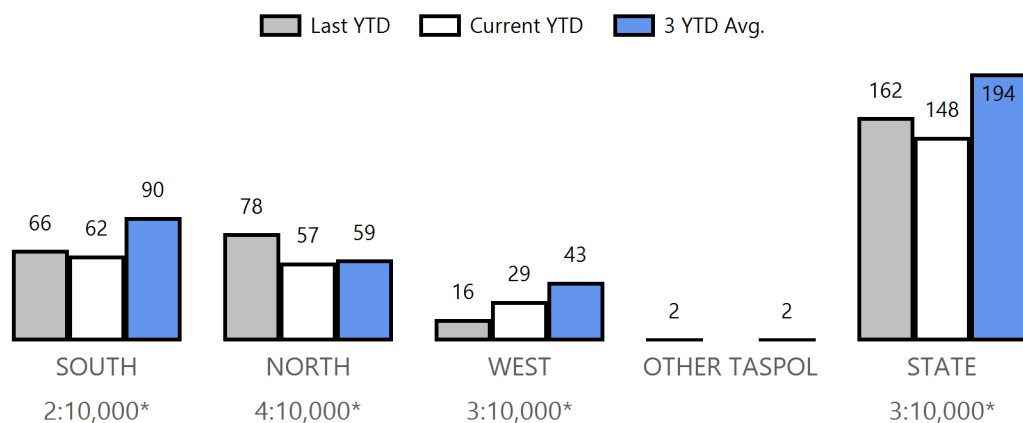
Excessive Speed Offenders - 15-29km/h - August 2022

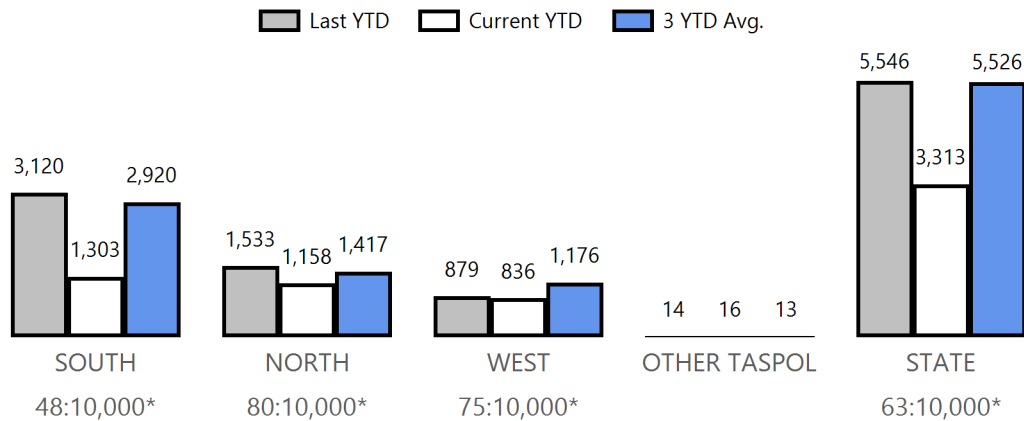
Excessive Speed Offenders - 30km/h + - August 2022

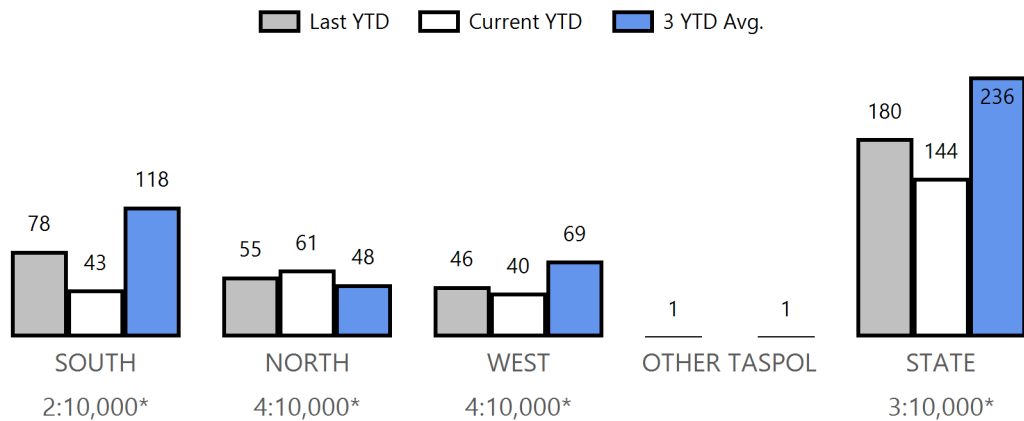
High Risk Offenders - August 2022

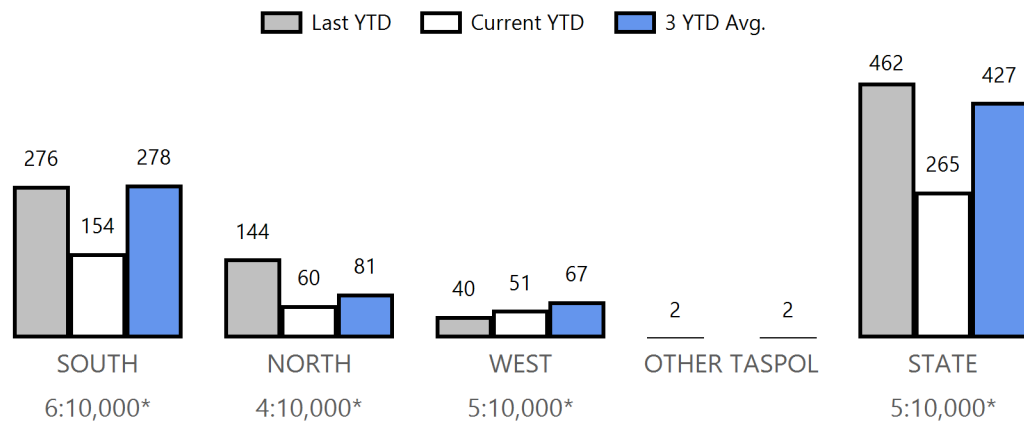
Seatbelt Compliance Offenders - August 2022

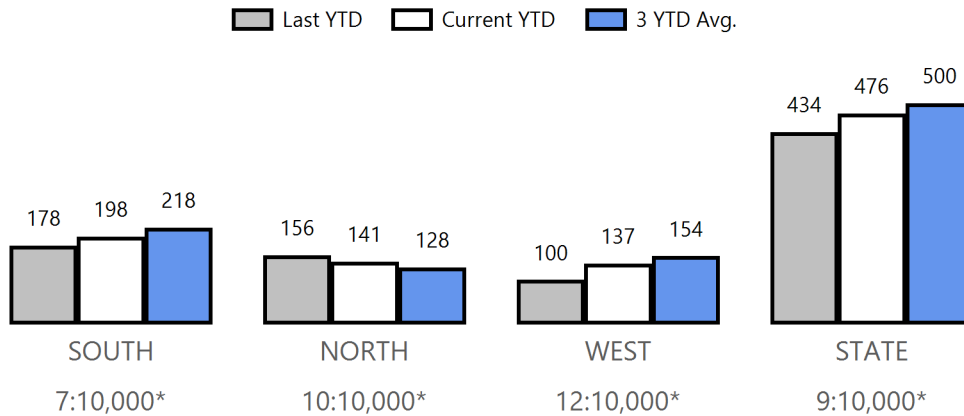
Mobile Phone Offenders - August 2022

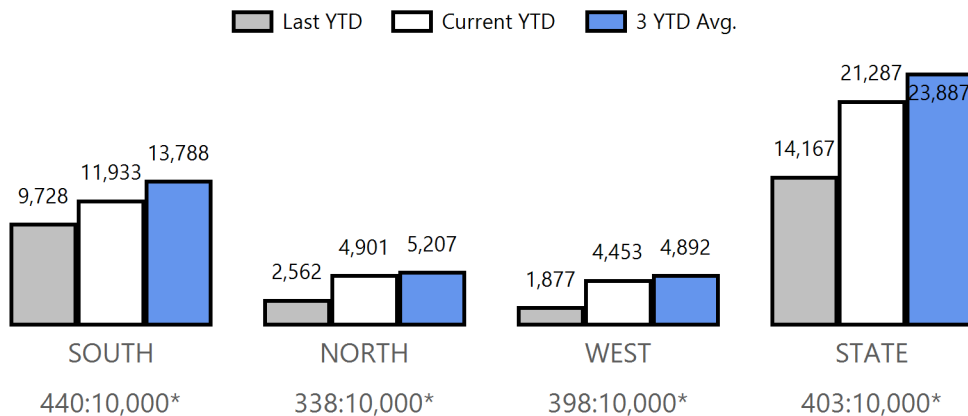
Vehicle Defect Notices - August 2022

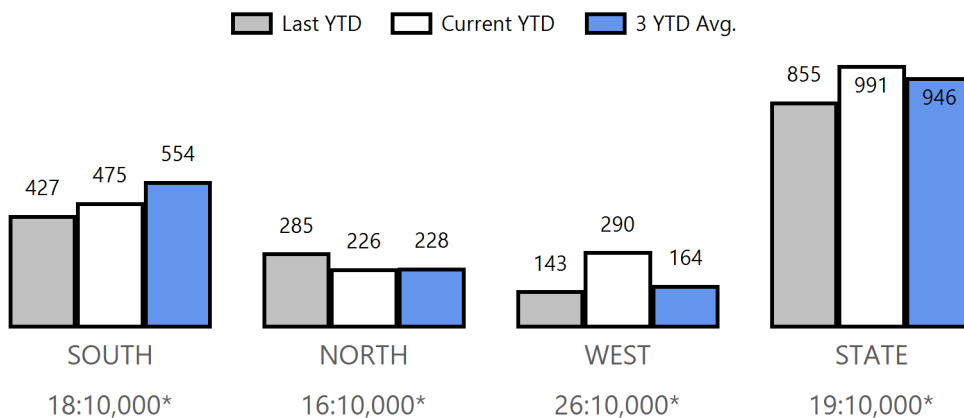
Random Breath Tests (ALCOHOL) - August 2022

Oral Fluid Tests (Drugs) - August 2022



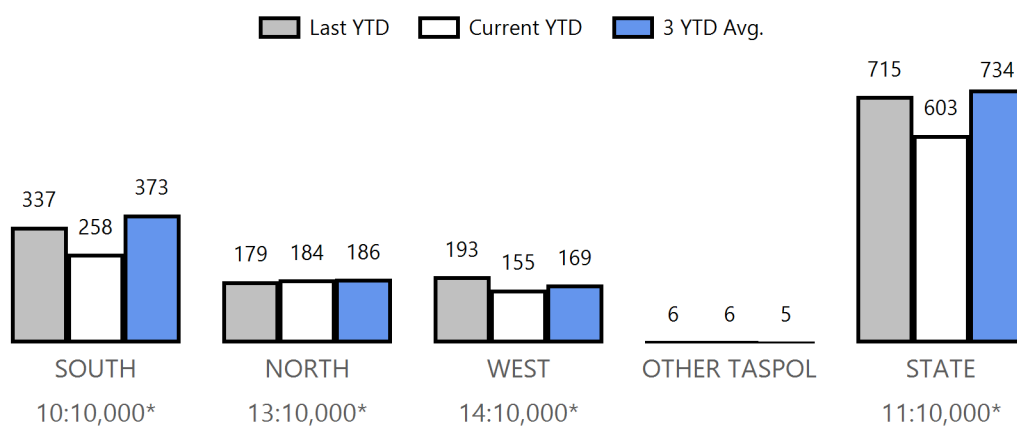

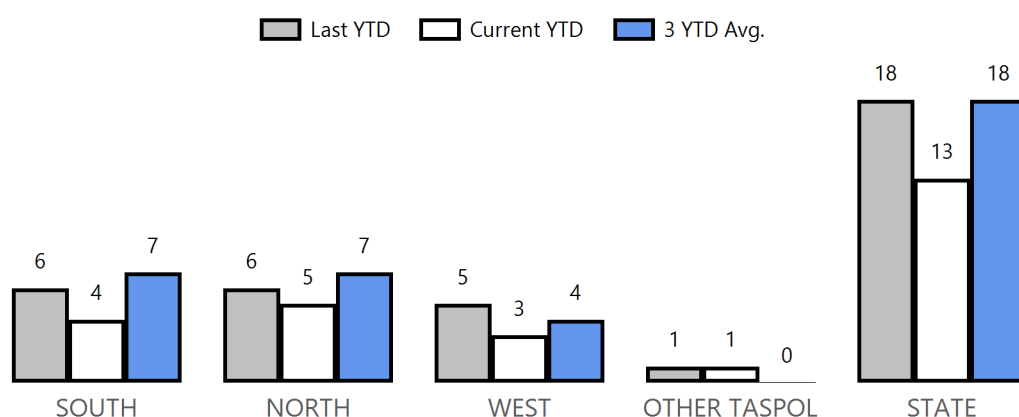

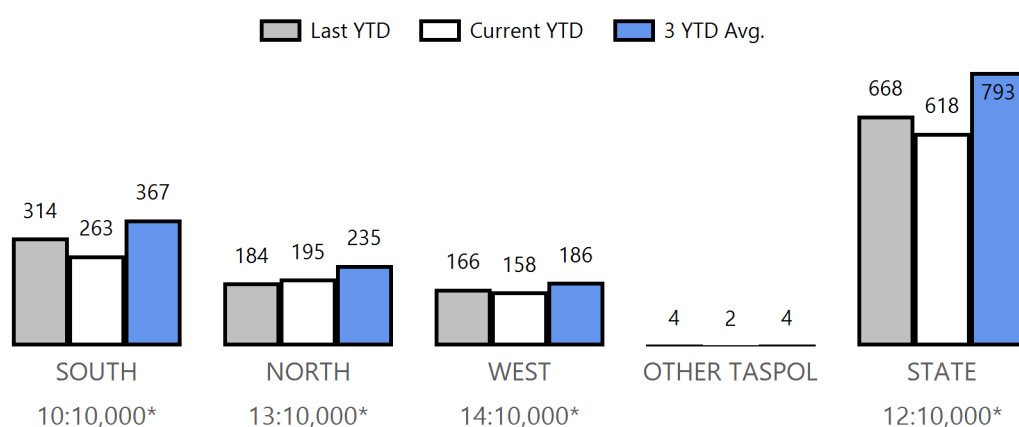
Dangerous and Reckless Driving Offenders - August 2022

Disqualified and Unlicensed Driving Offenders - August 2022



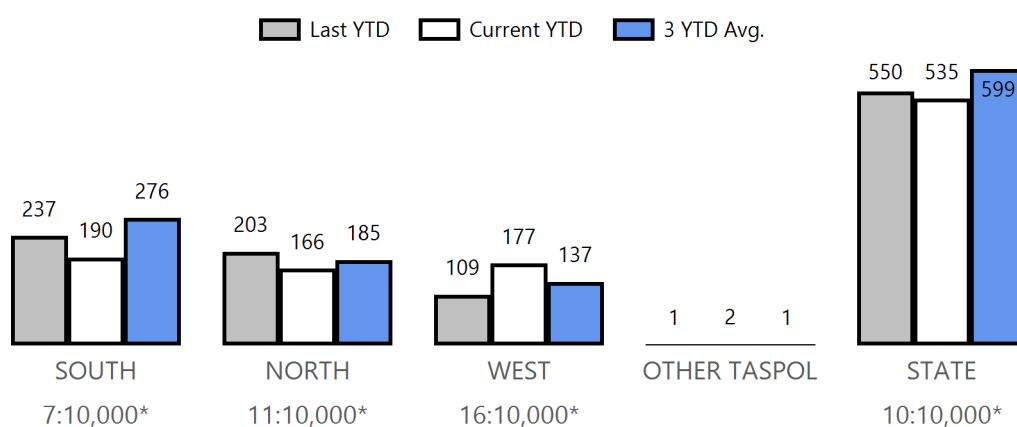

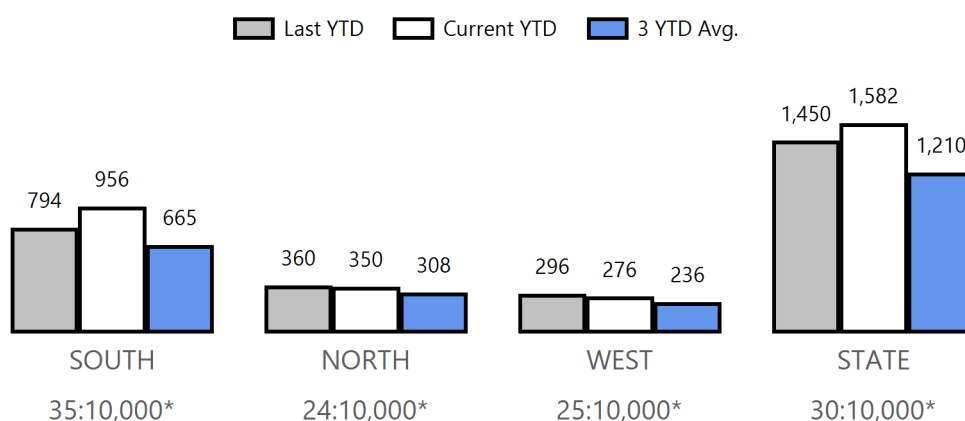
Unregistered Vehicle Offenders - August 2022

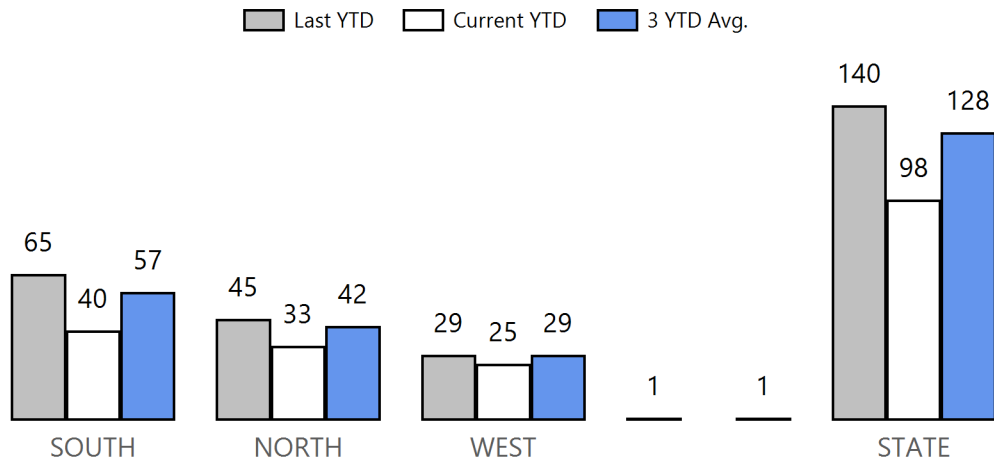
Vehicle Complaints made to RDS - August 2022

Vehicles Clamped or Confiscated - September 2022



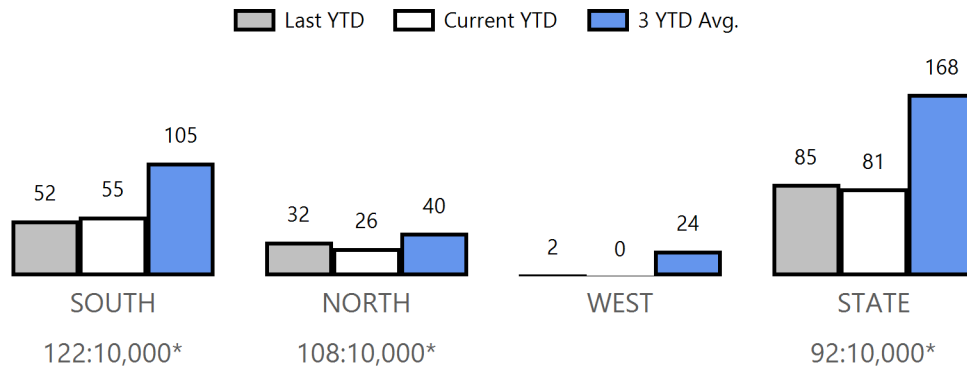

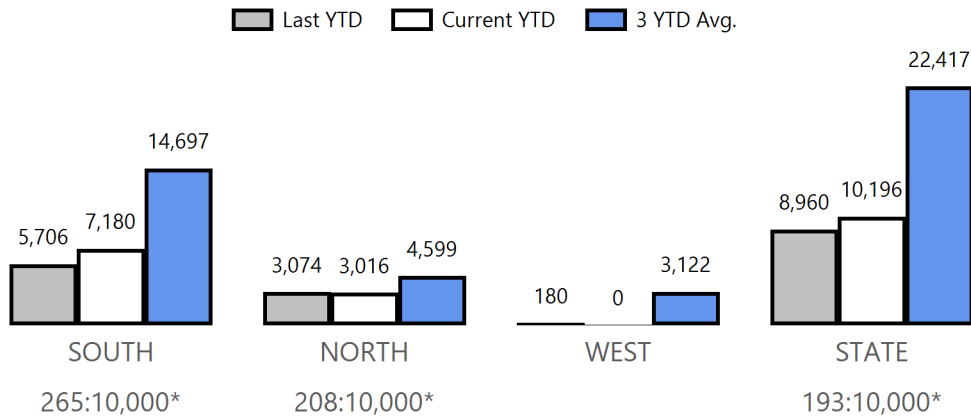
Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - August 2022

ANPR: Total Vehicles Captured - August 2022



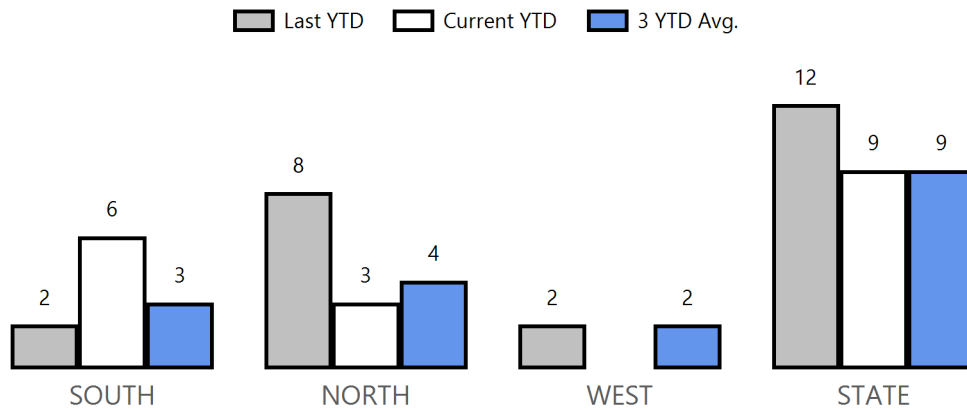

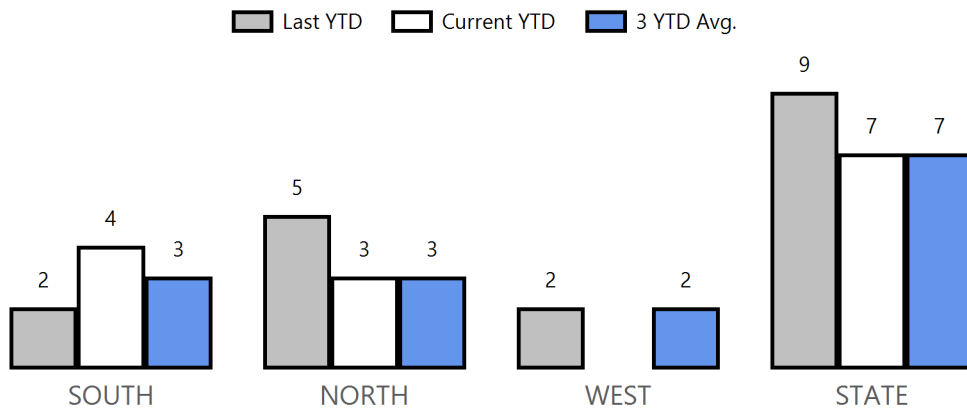
Road Crashes: Fatalities YTD - August 2022

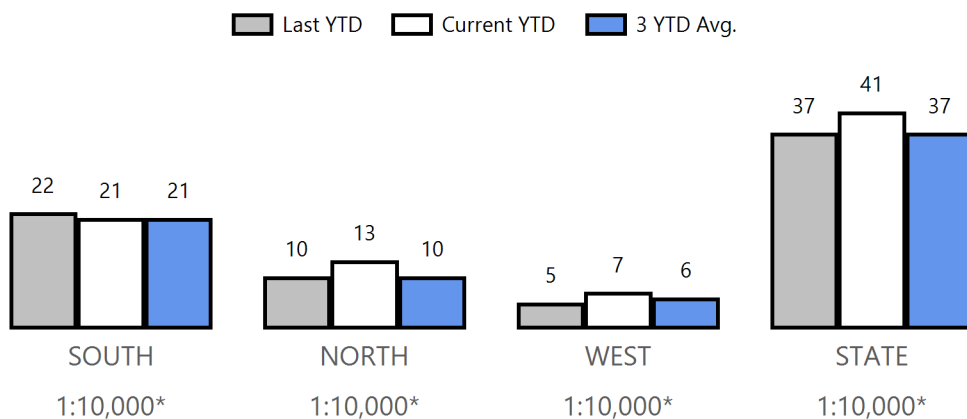
Fatal Crashes - August 2022

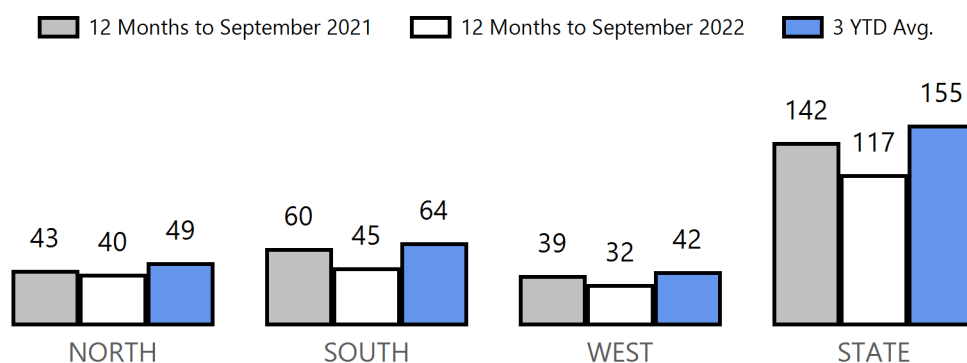

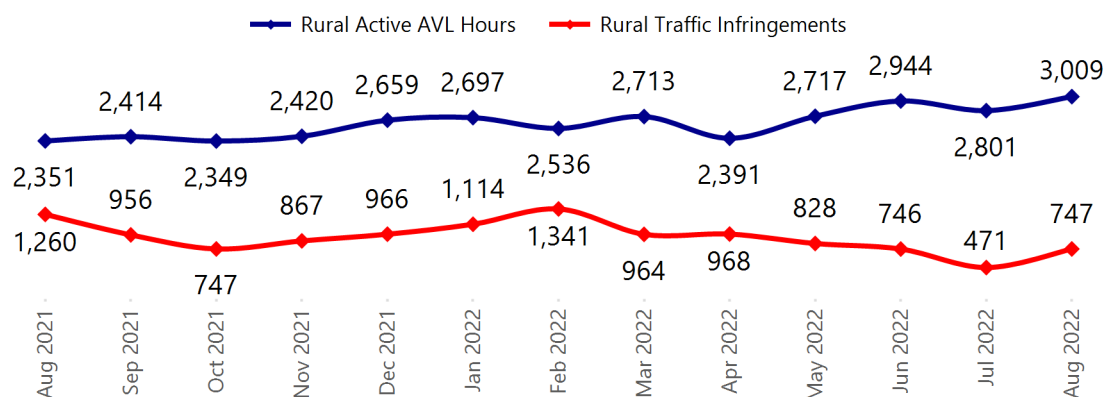
On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)



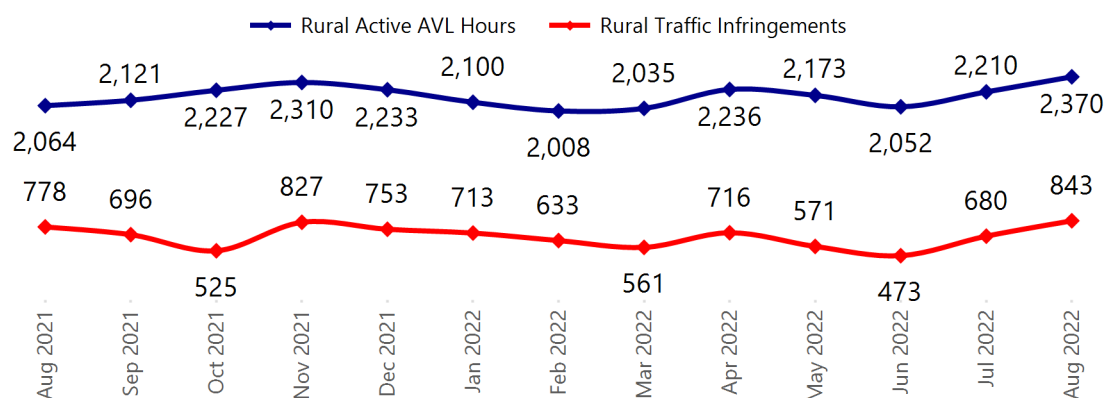

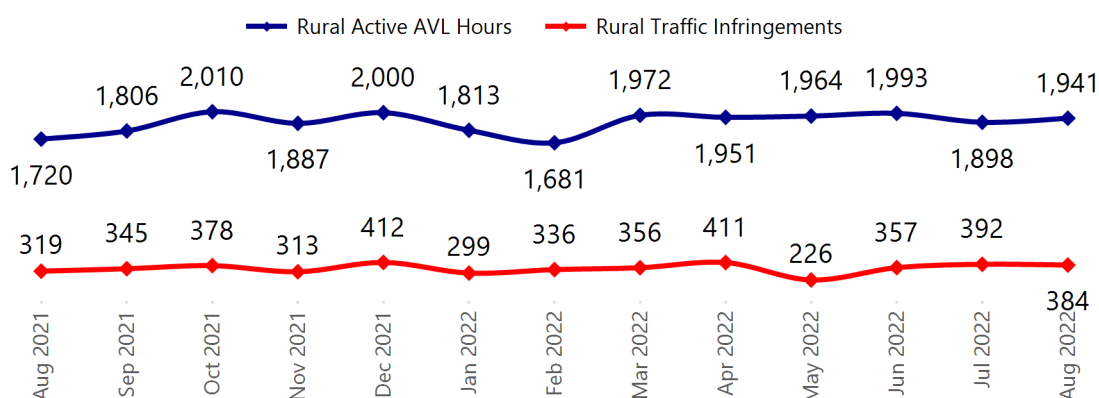

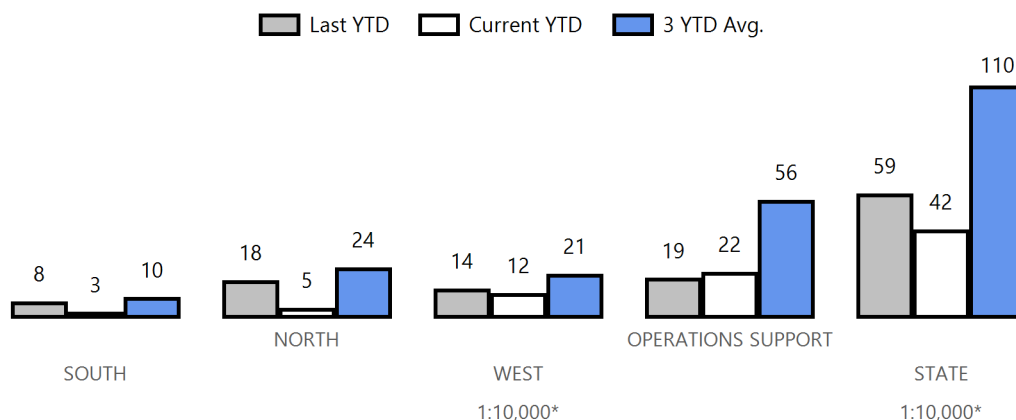

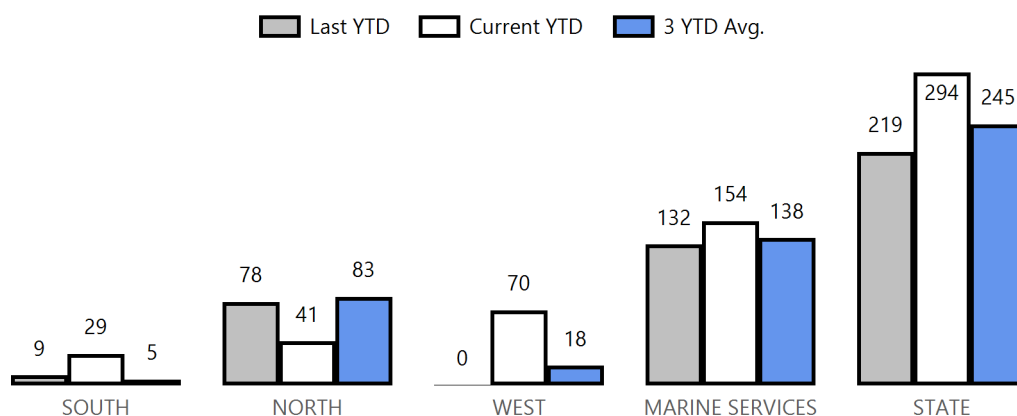

Sea Inspections (Vessel & Non-Vessel) - August 2022



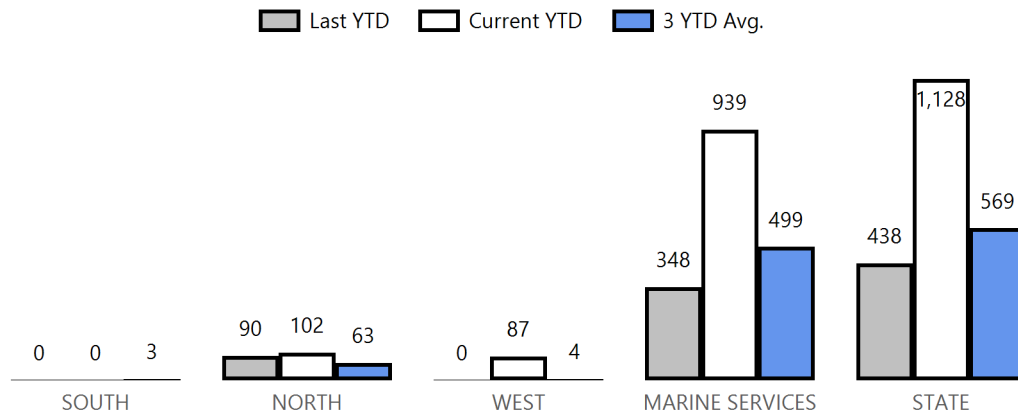
