


Public Safety - Out in Public Locally (Daytime)

Public Safety - Out in Public Locally (After Dark)










Satisfaction - Dealing with Public Order Problems














Family Violence - PFVO Breaches - December 2020







Annual Clear Up % (OPT=84%)





Total Drug Offenders - December 2020






Major Traffic Operations - December 2020




Random Breath Tests (ALCOHOL) - December 2020

Oral Fluid Tests (Drugs) - December 2020







Disqualified and Unlicensed Driving Offenders - December 2020






Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - December 2020

ANPR: Total Vehicles Captured - December 2020







Road Crashes: Fatalities YTD - December 2020




