Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

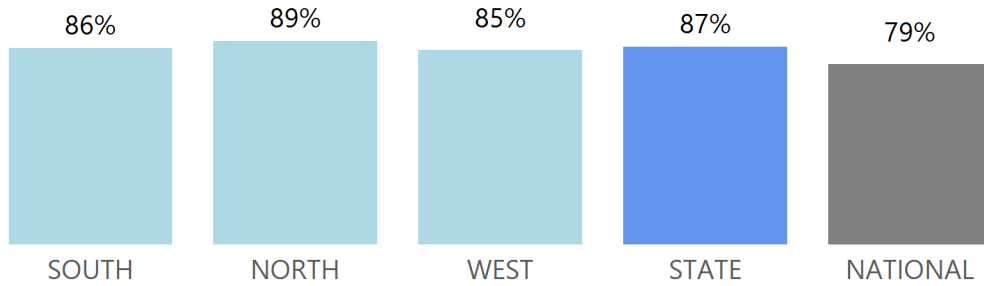

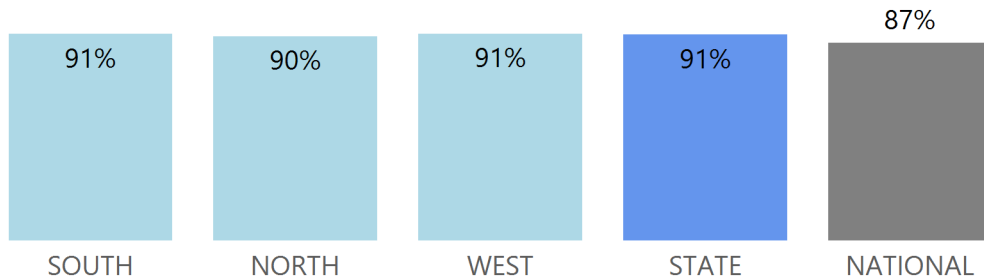
Safety at Home During the Night

(Survey respondents who answered "Safe/Very Safe".)



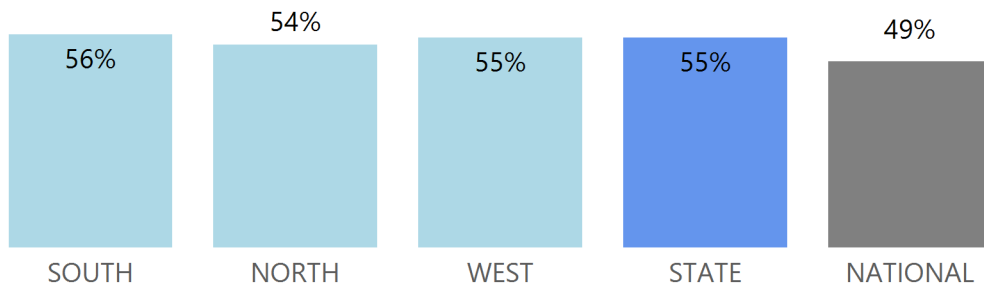
Safety In Neighbourhood During the Day

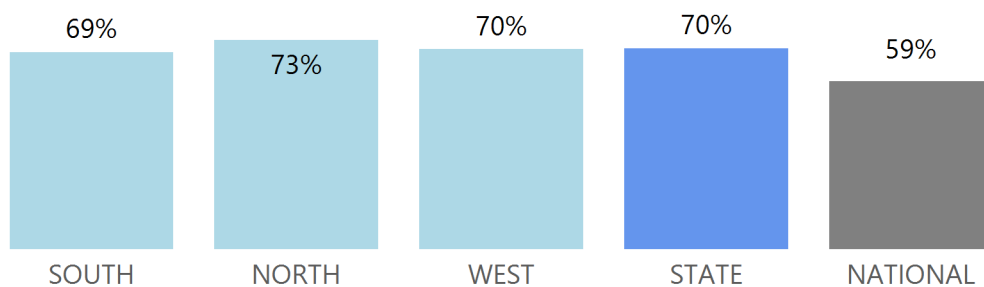

General Satisfaction with Police Services

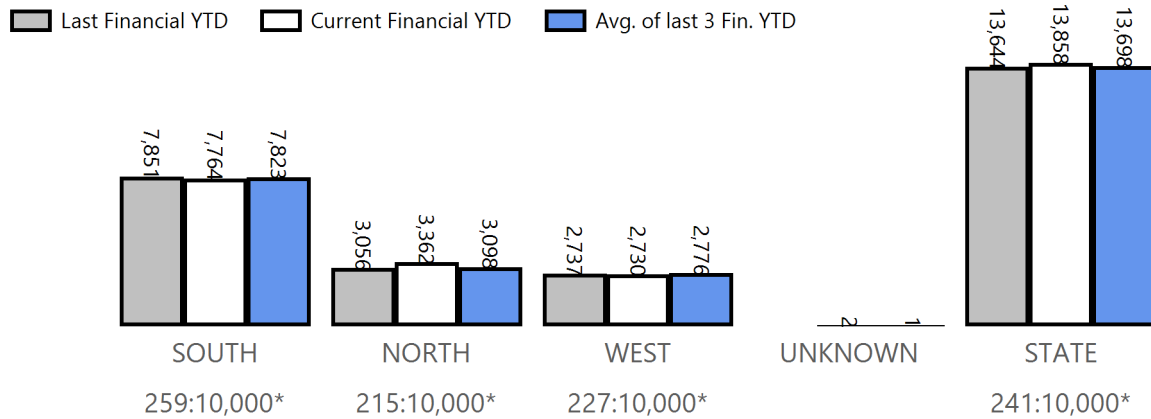

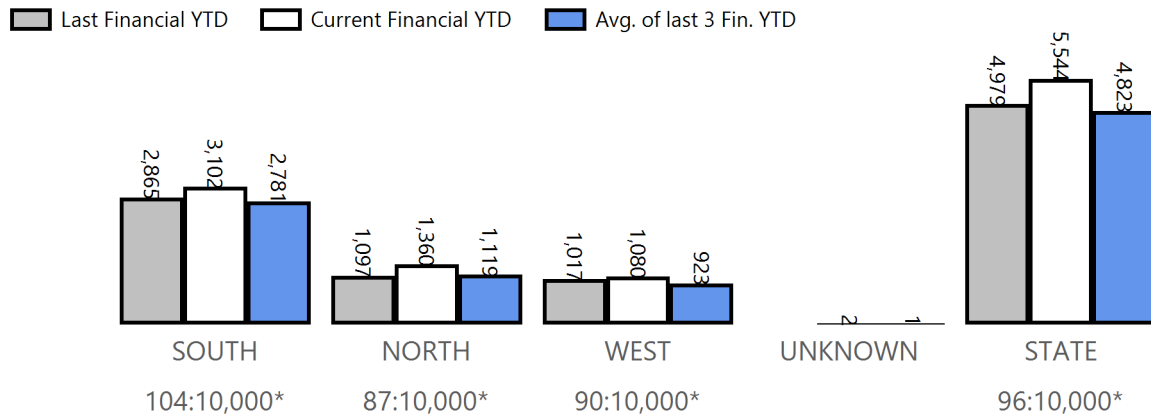
Public Order Incidents - February 2025

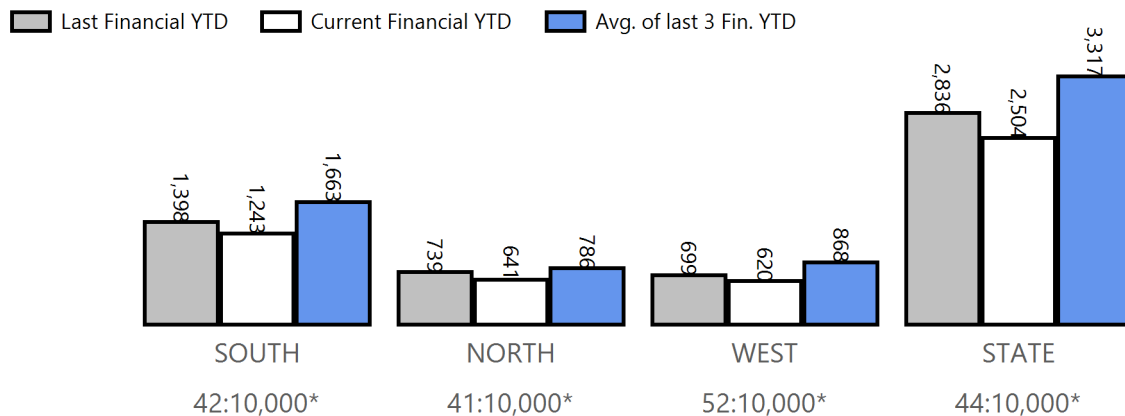
Public Order : Disturbance - February 2025

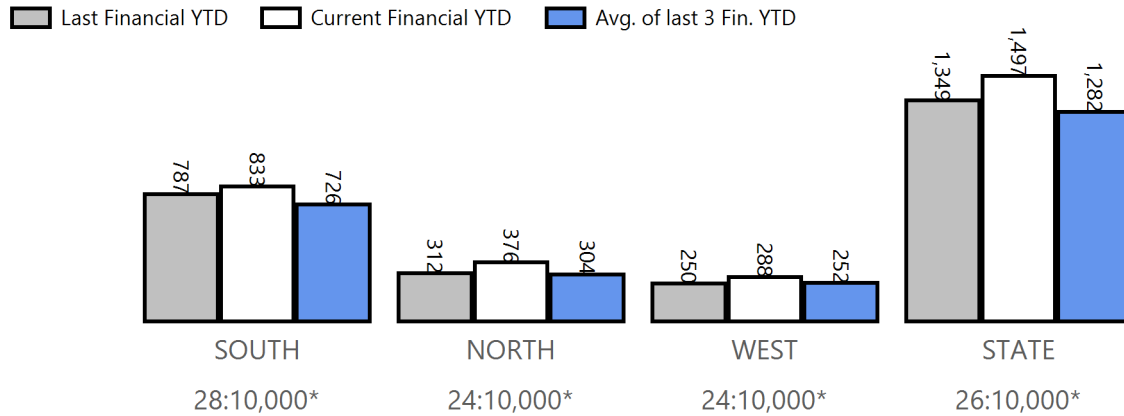
Public Order : Noise - February 2025

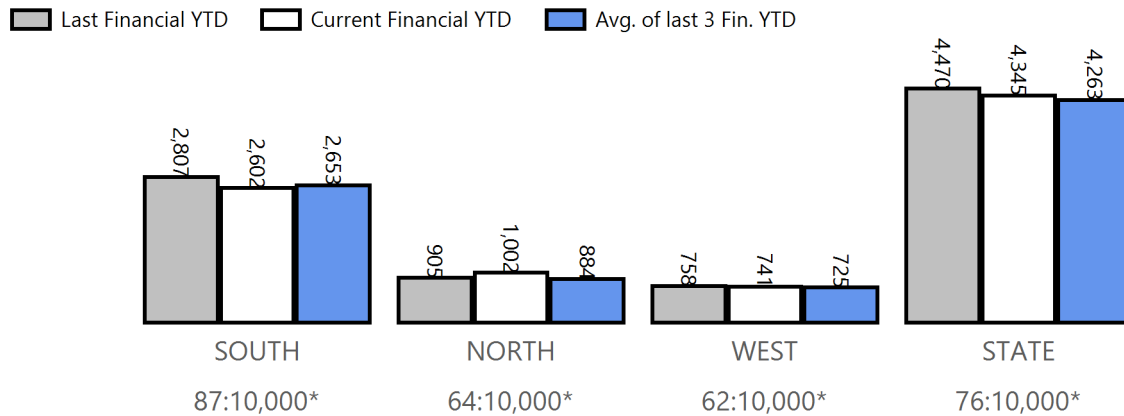
Public Order : Vandalism - February 2025

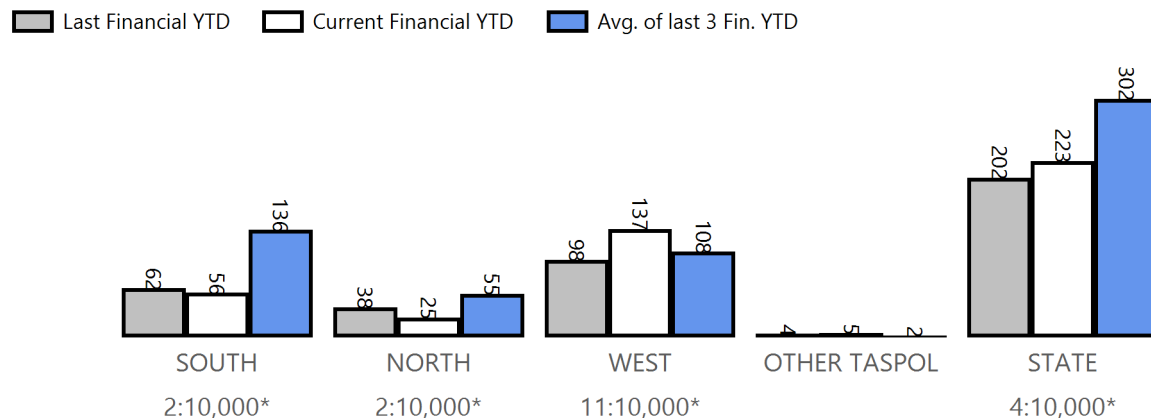
Public Order : Offensive Behaviour - February 2025

Liquor Infringement Notices - February 2025

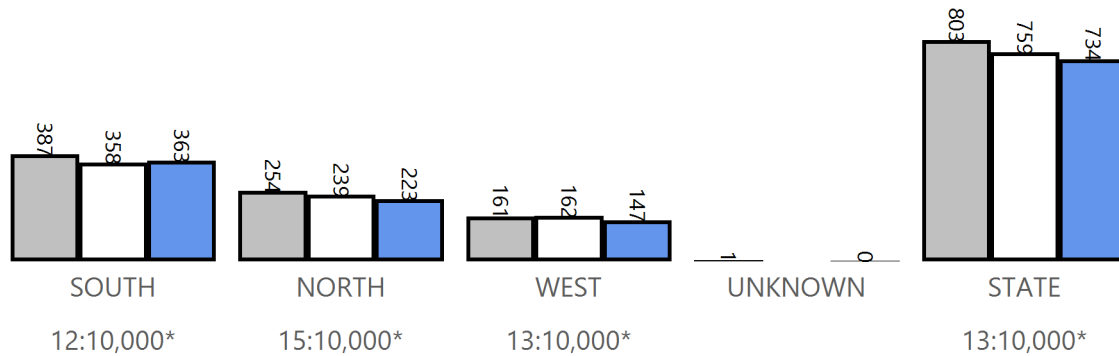

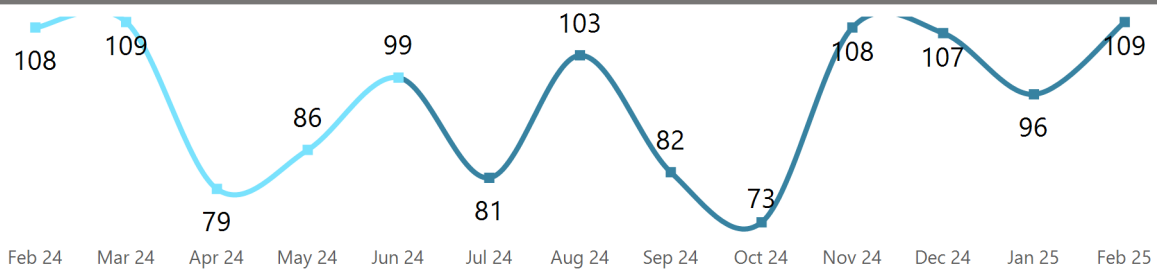

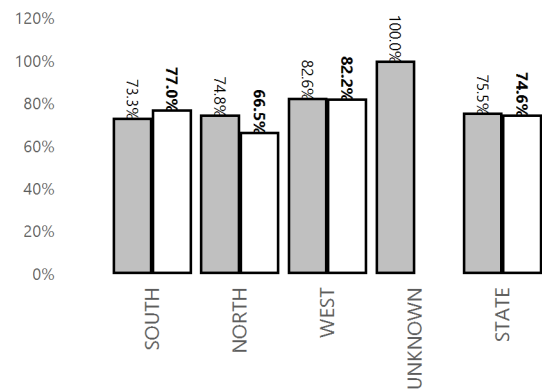

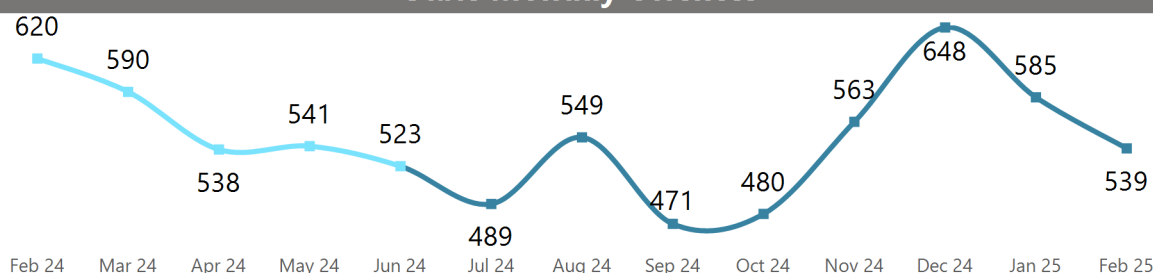

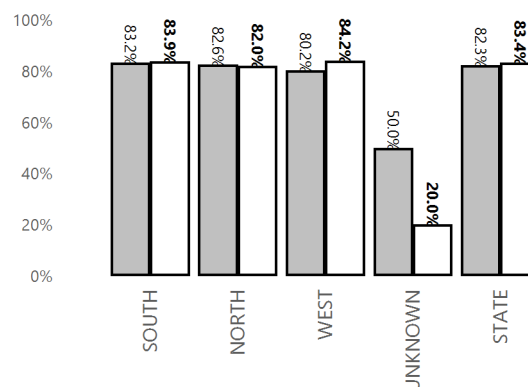

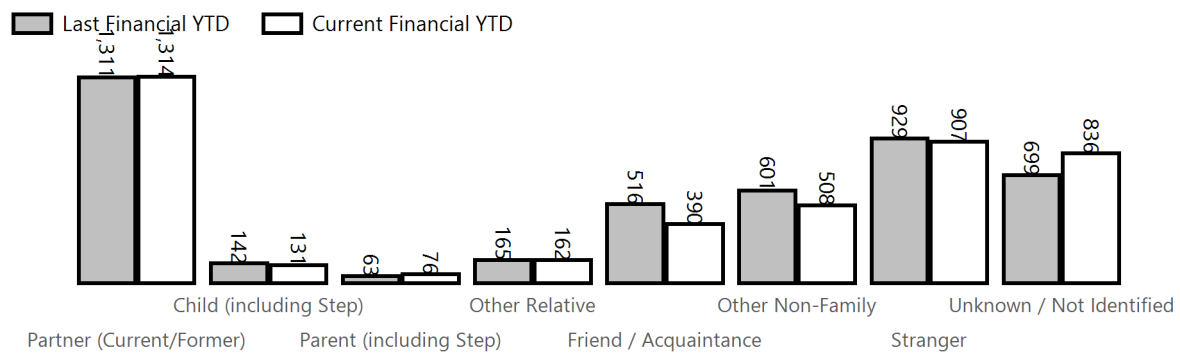

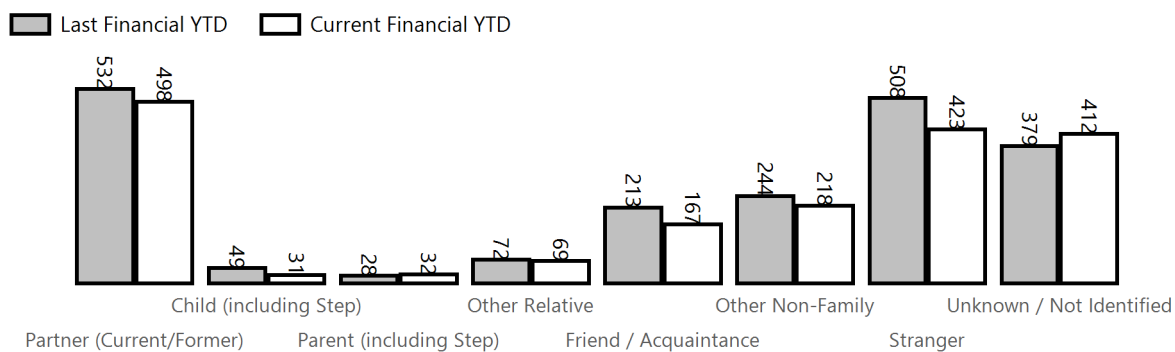

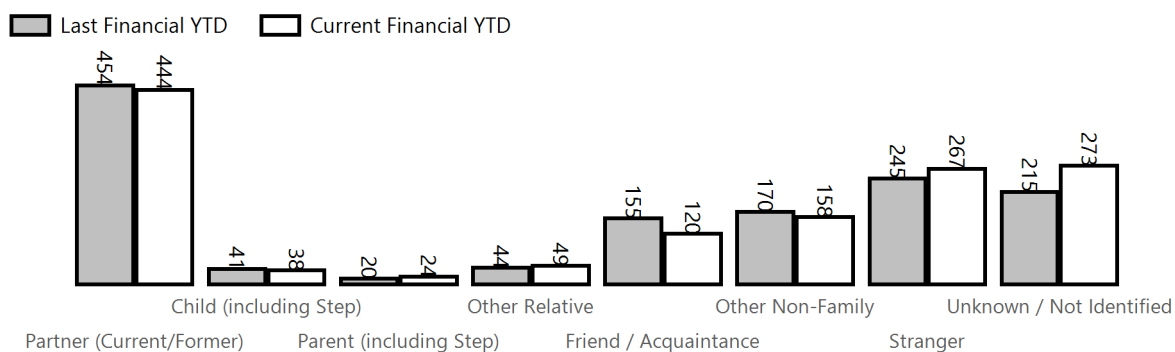

Total Person Offences - Victim Relationship - SOUTH



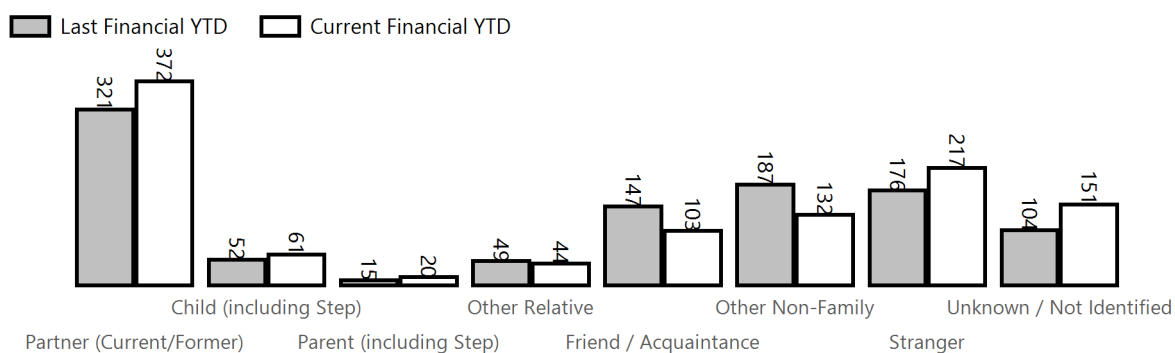

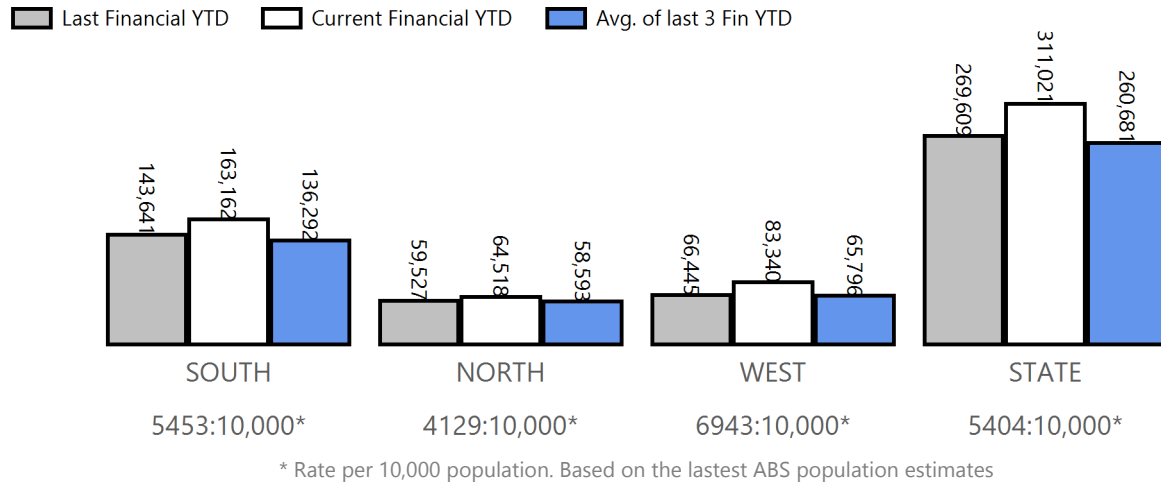

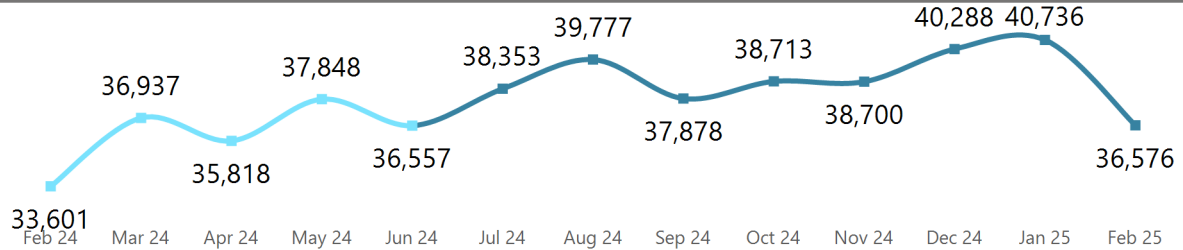

Uniform Police Patrol Hours - February 2025

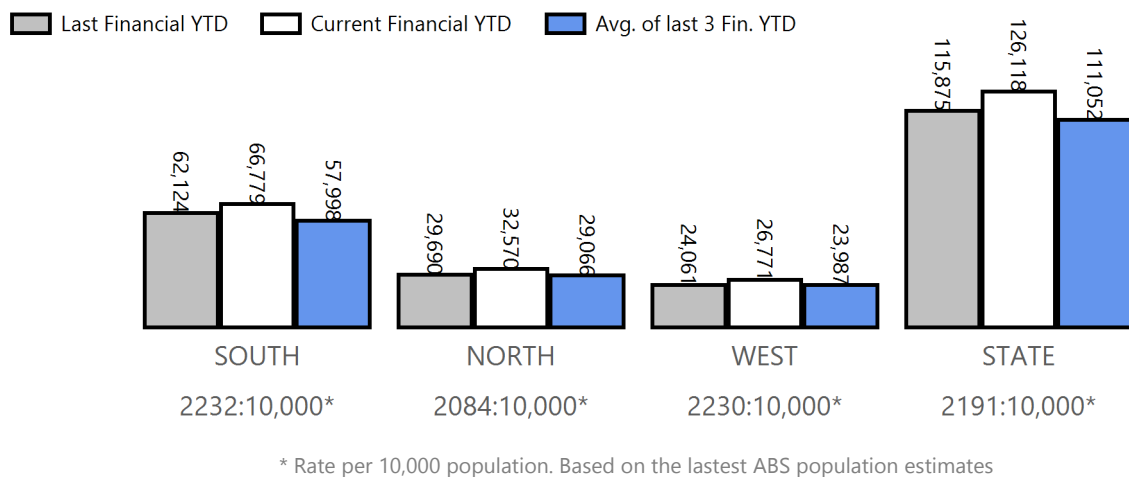


Uniform Police - Patrol Hours

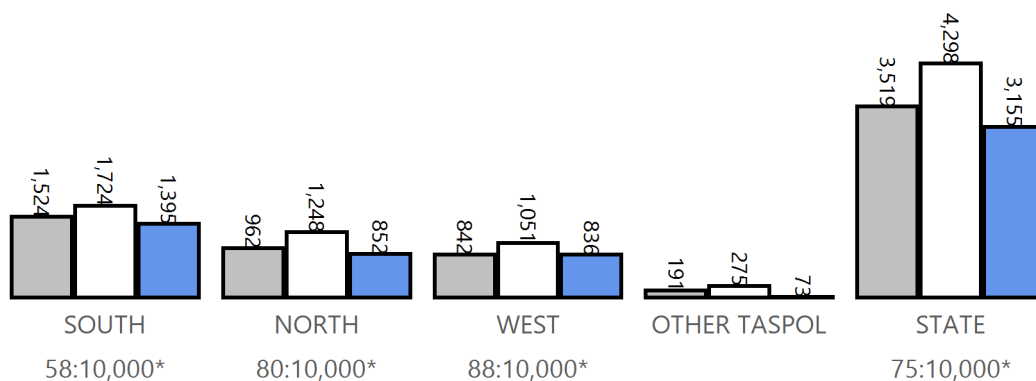

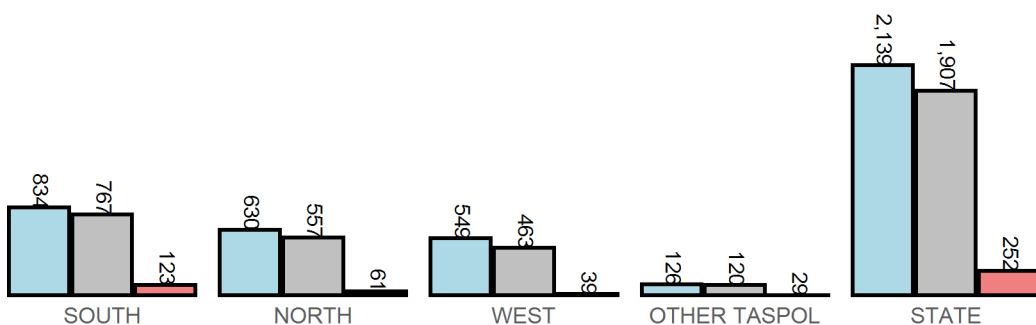

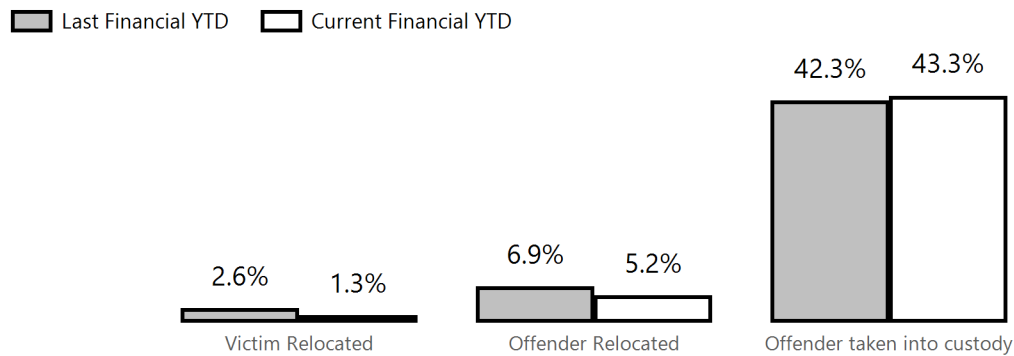
Family Violence RAST - Excludes Other and Argument Categories

■ Low ■ Medium ■ High



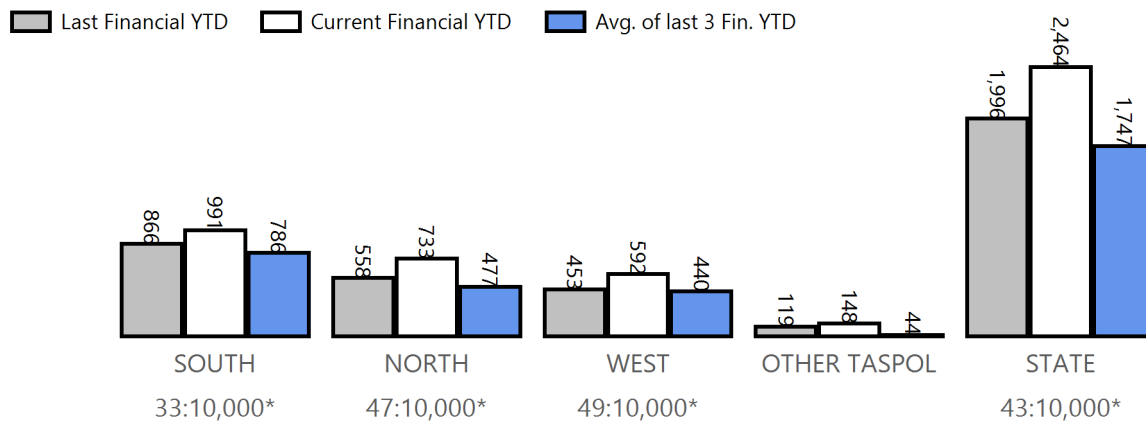

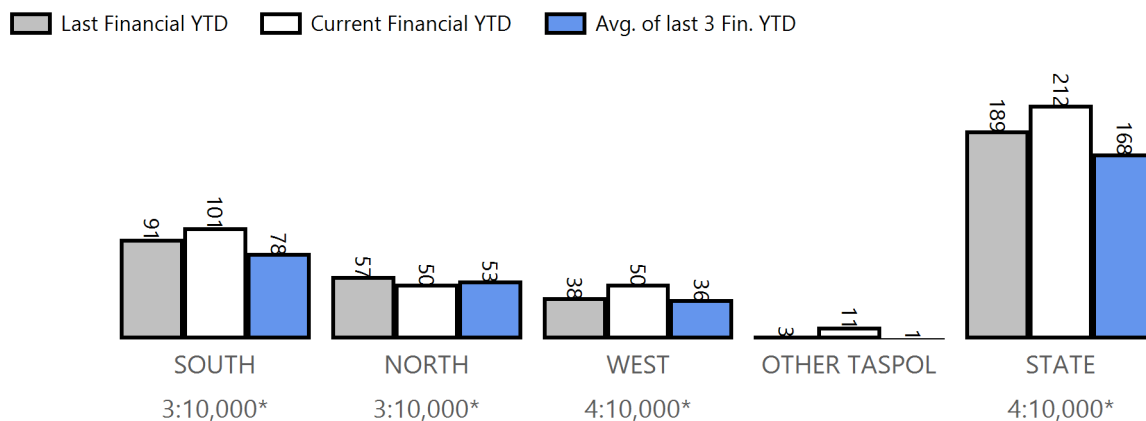
Family Violence Incidents with Child Witness - February 2025

Family Violence Incidents: Weapons Present - February 2025



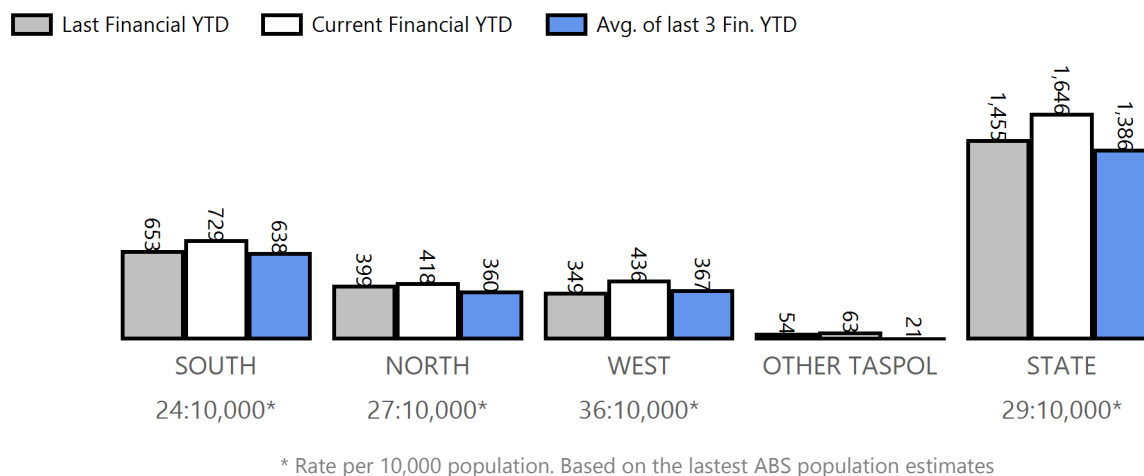

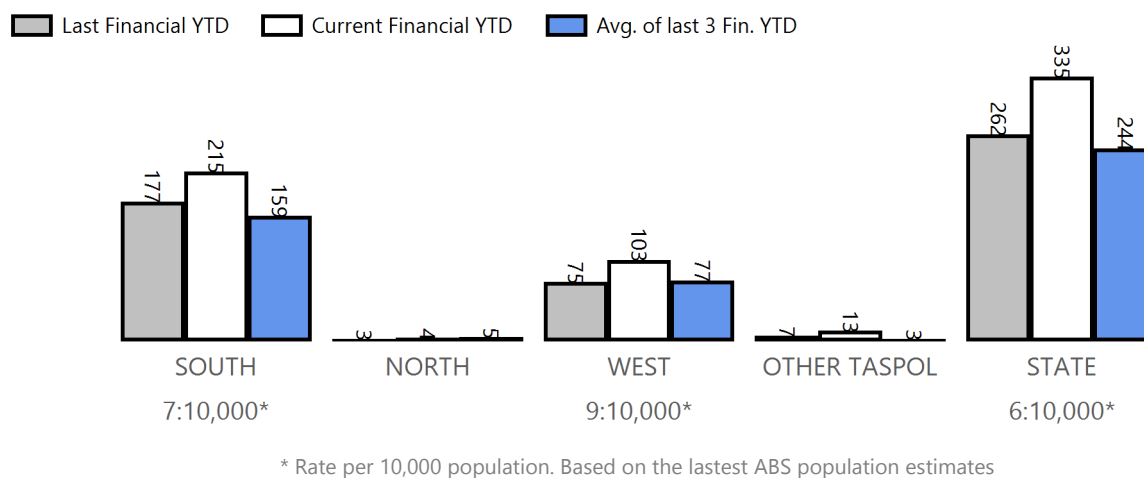

FV Incidents with Police FV Order Issued - February 2025



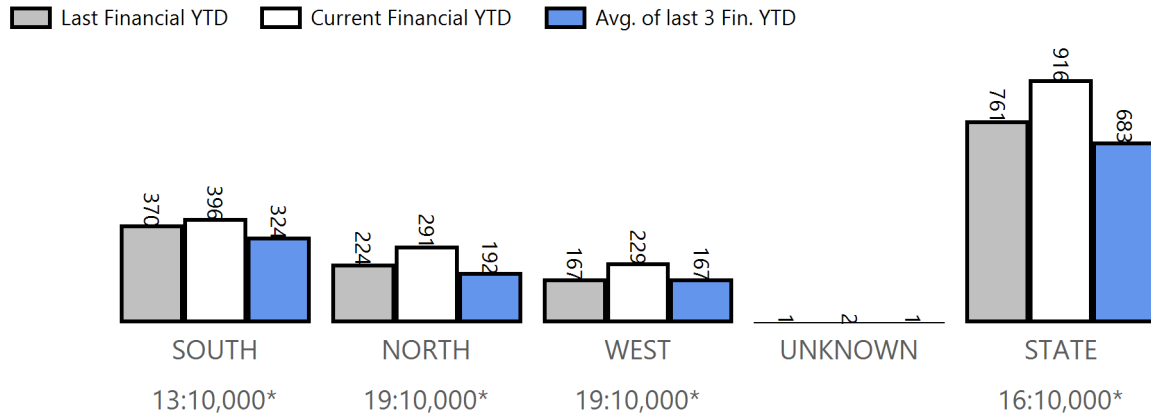

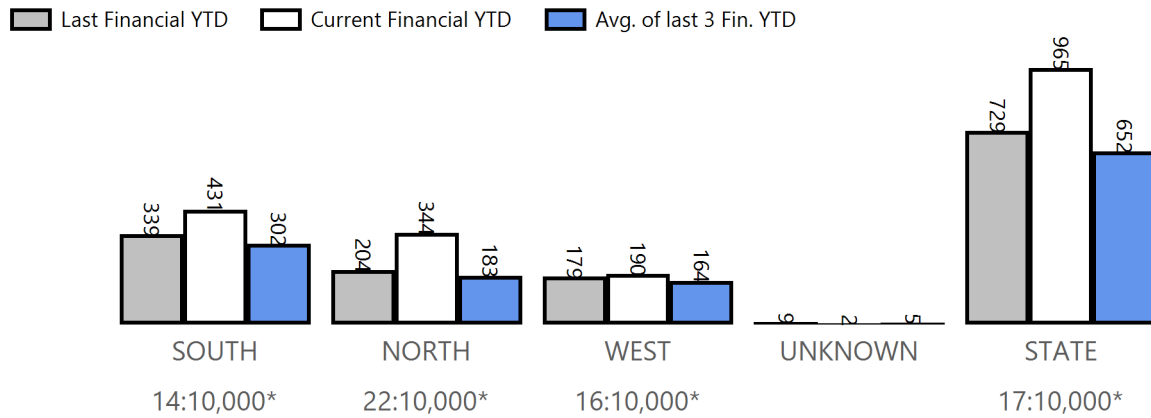
Breach of Police Family Violence Orders - February 2025

Breach of Family Violence Orders (excluding PFVOs) - February 2025

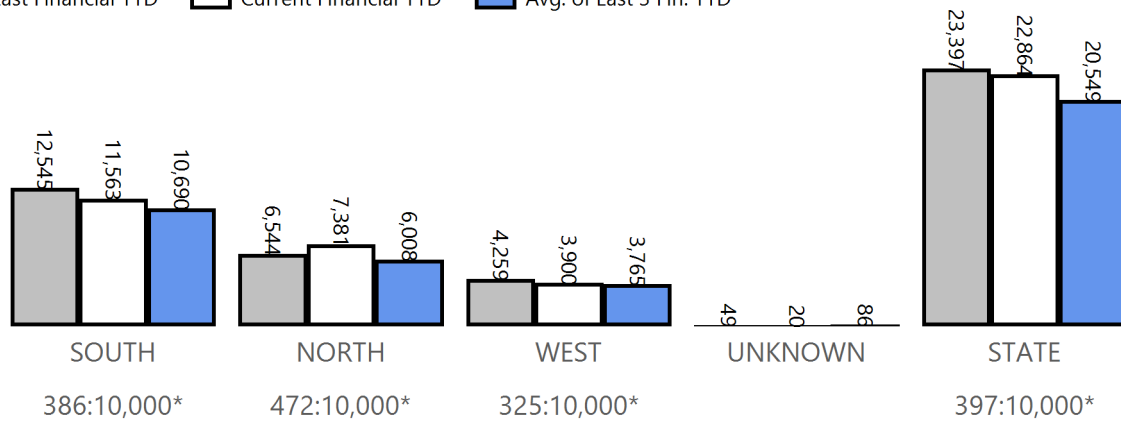

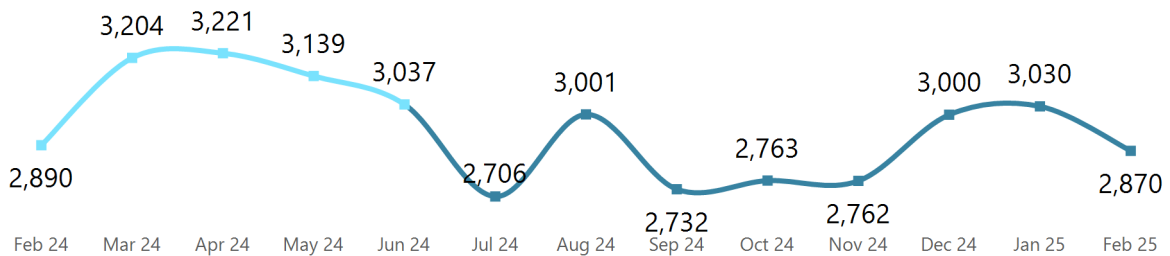

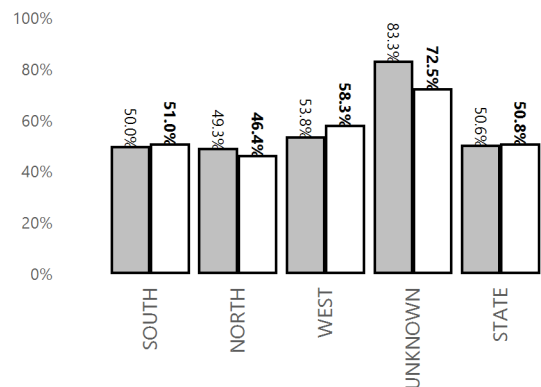

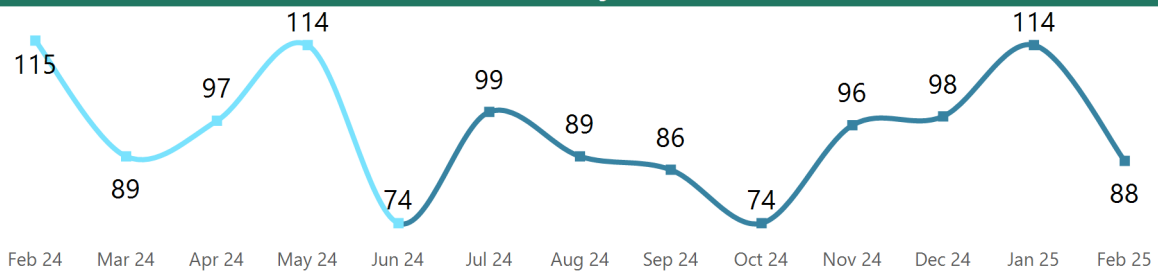

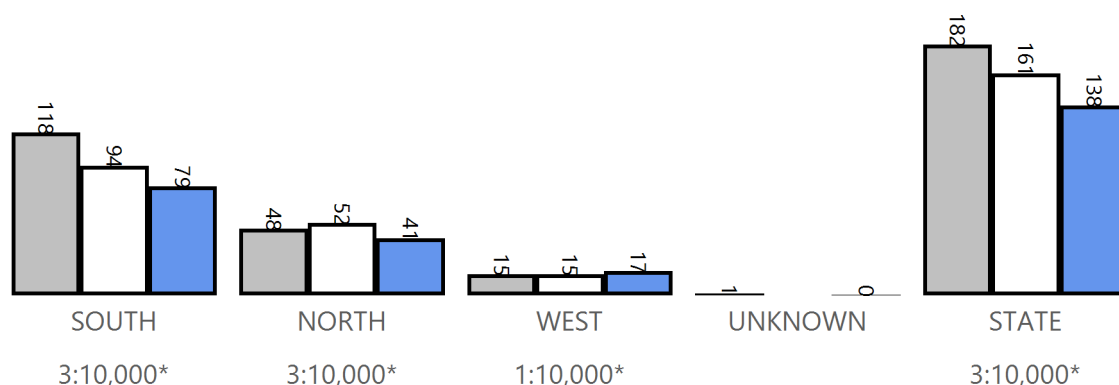

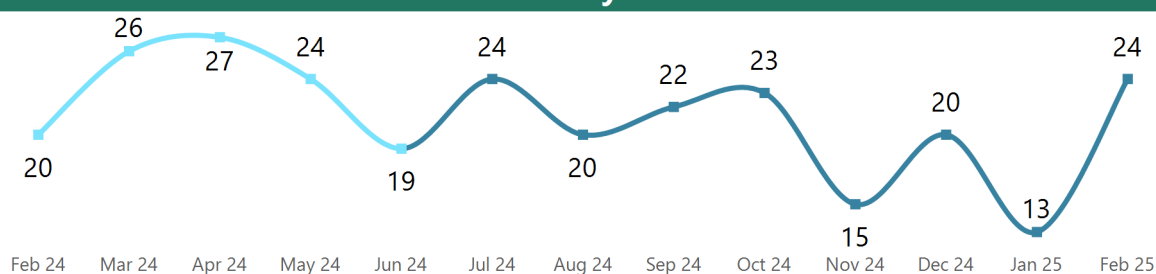

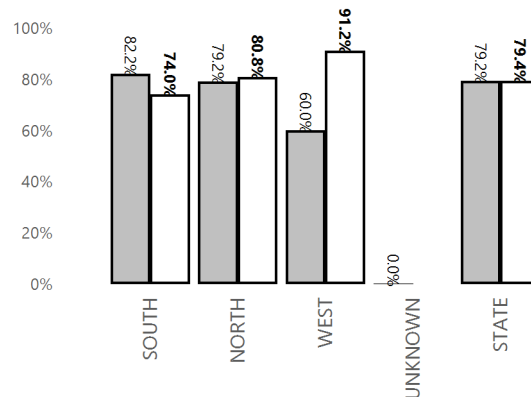

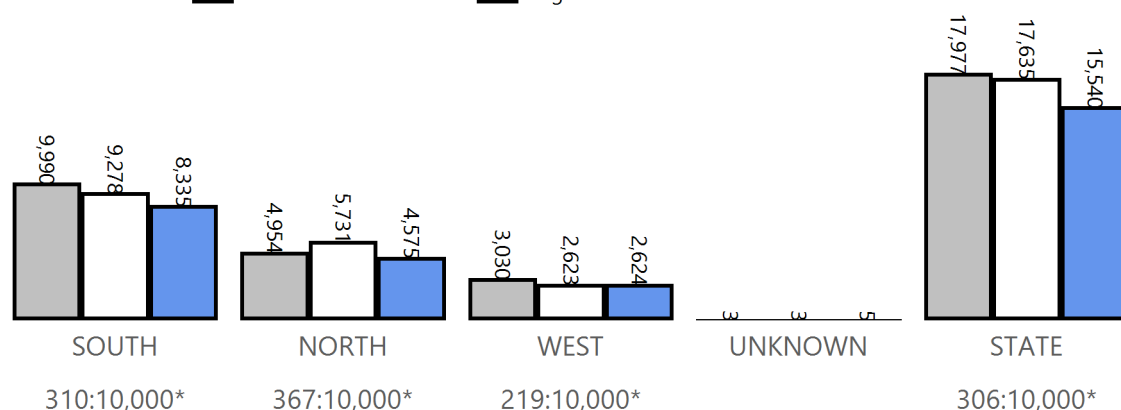

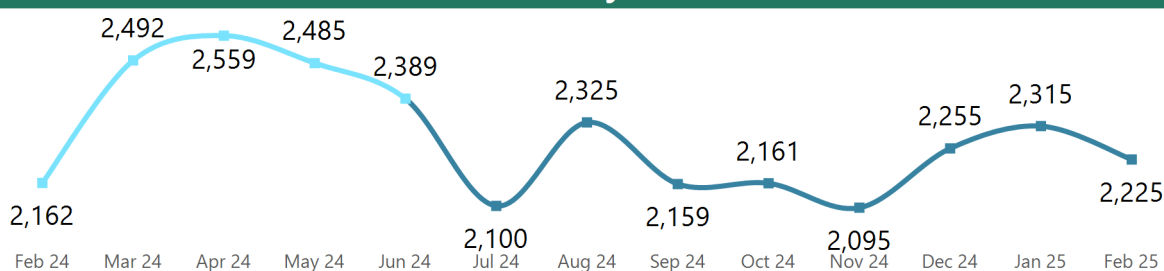

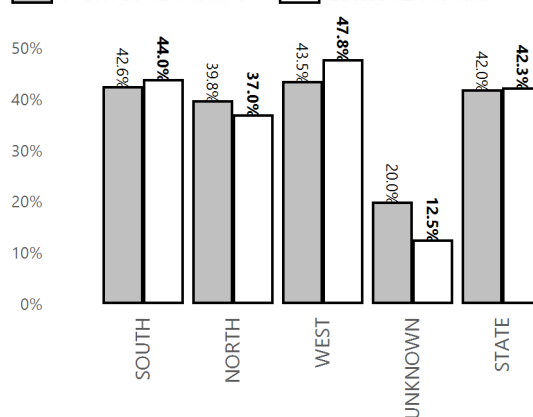

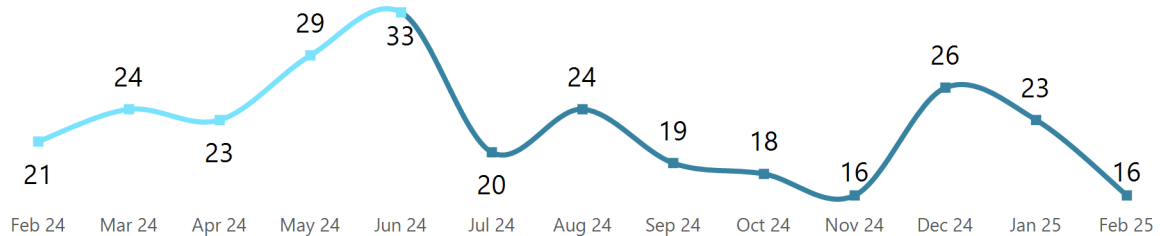
SMV : Recovered Fire Damaged - February 2025

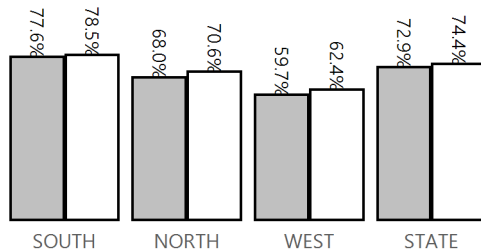

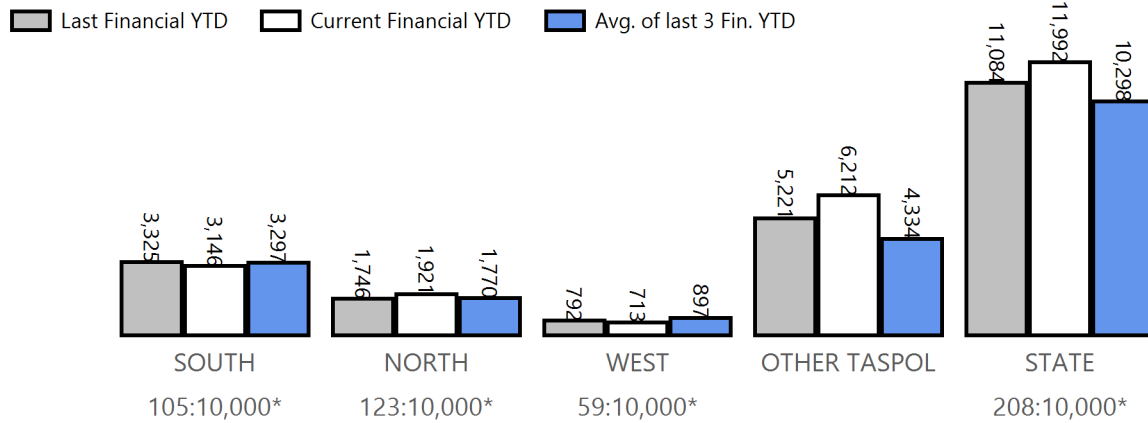

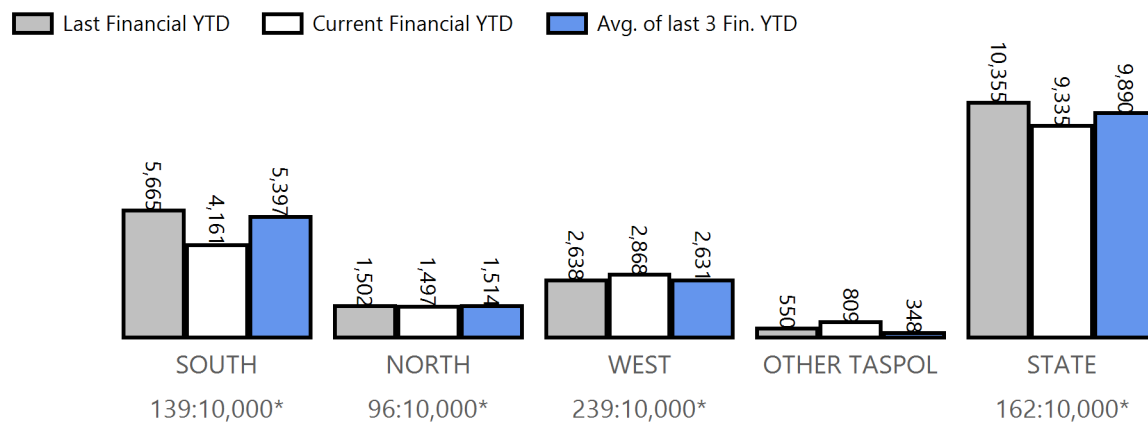
Intelligence Submission Occurrences - February 2025

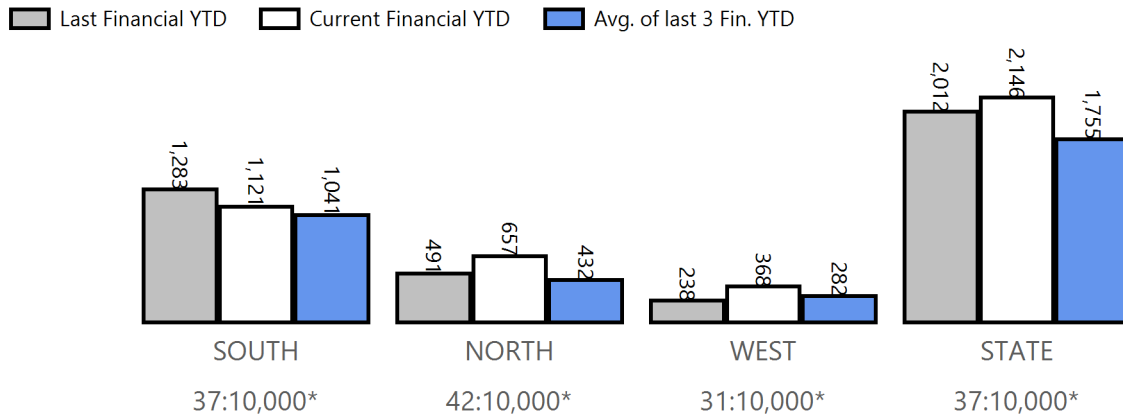
Street Check Occurrences - February 2025

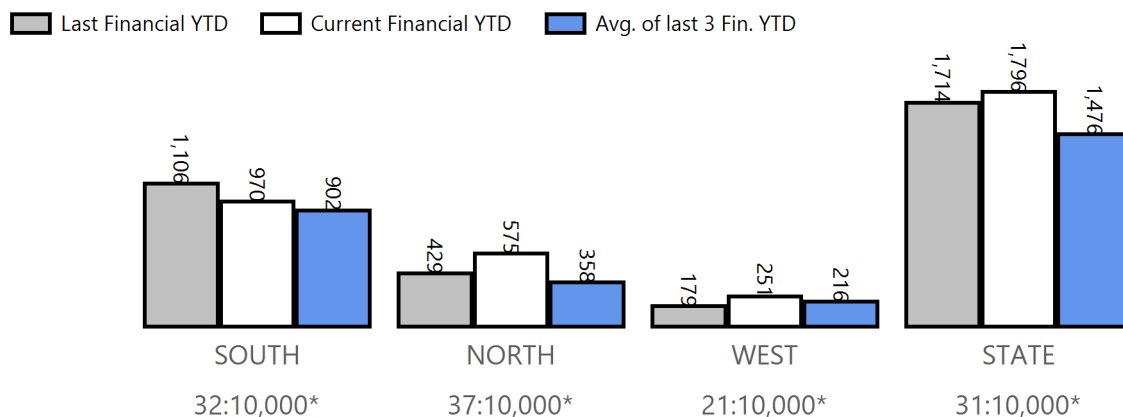
CIB: Total Offenders - February 2025

CIB: Total Crime Offenders - February 2025



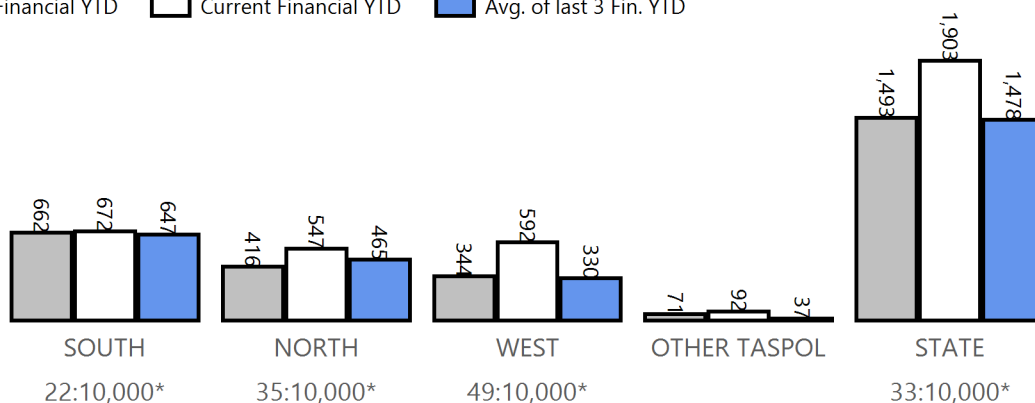

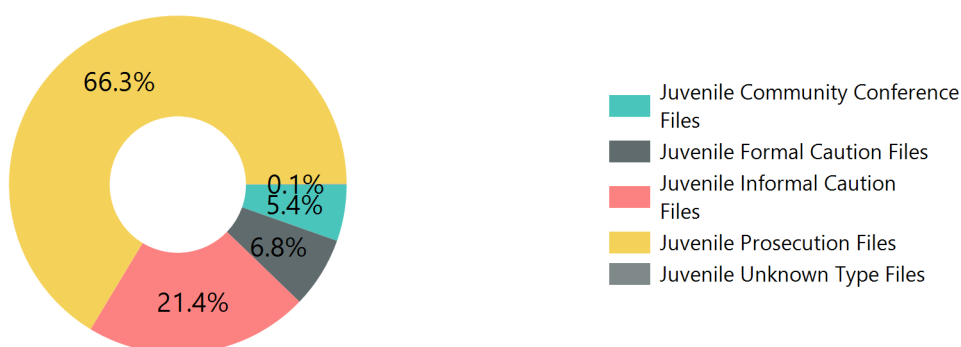

Total Traffic Offenders - February 2025



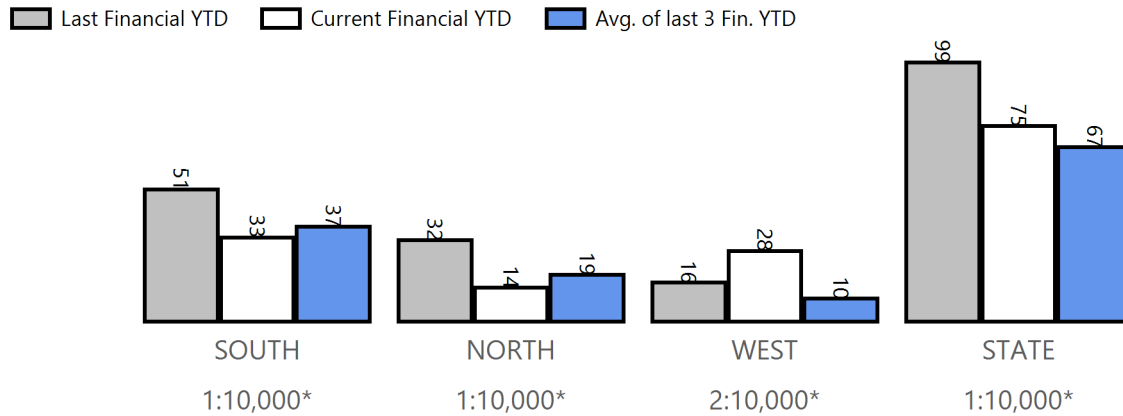

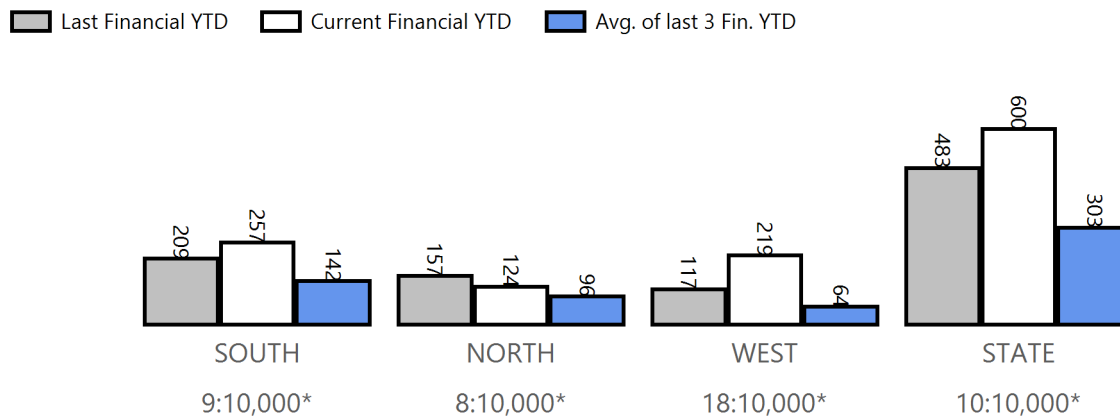

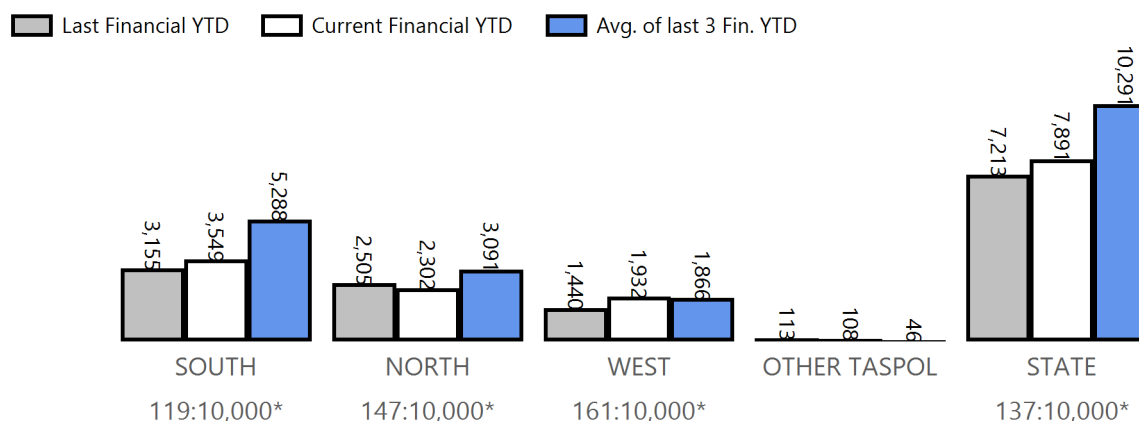
Speeding Offenders - February 2025

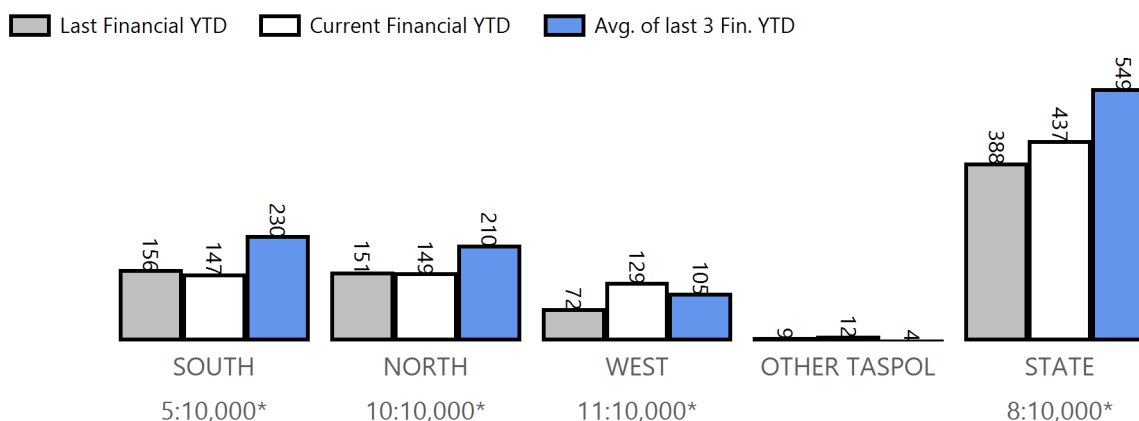
Speeding 15-29 km/h Offenders - February 2025

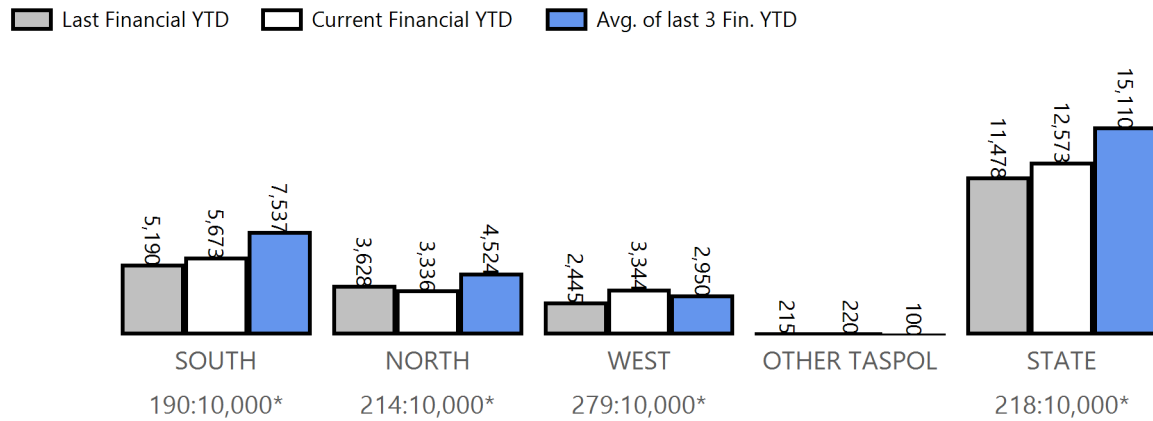
Speeding 30+ km/h Offenders - February 2025

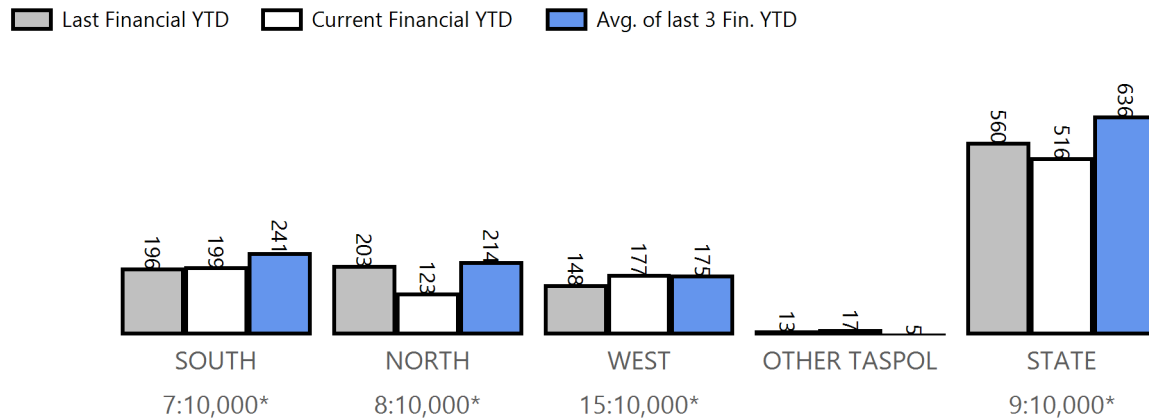
High Risk Traffic Offenders - February 2025

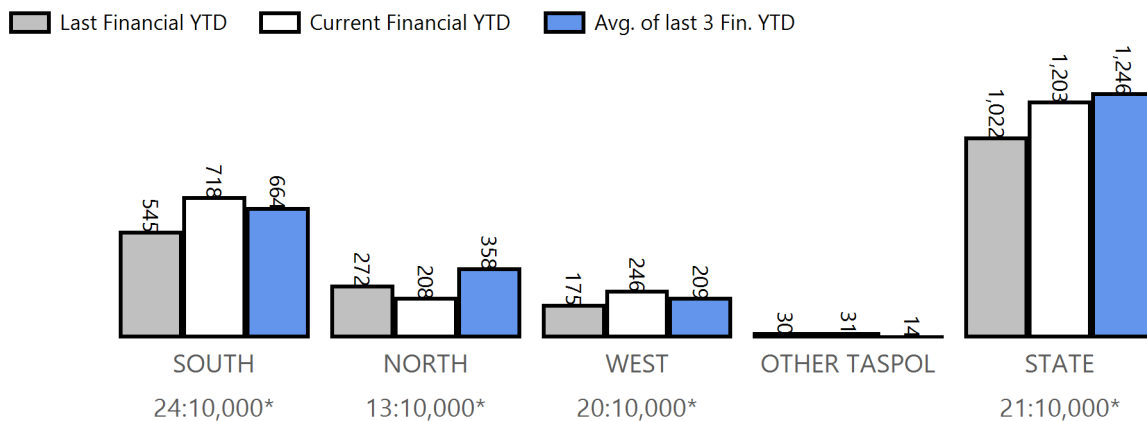
Seatbelt Compliance Offenders - February 2025

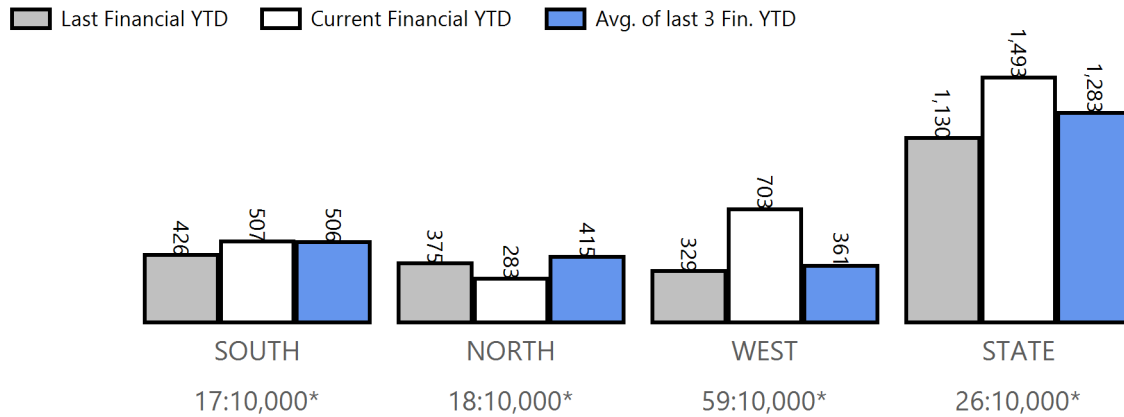
Mobile Phone Offenders - February 2025

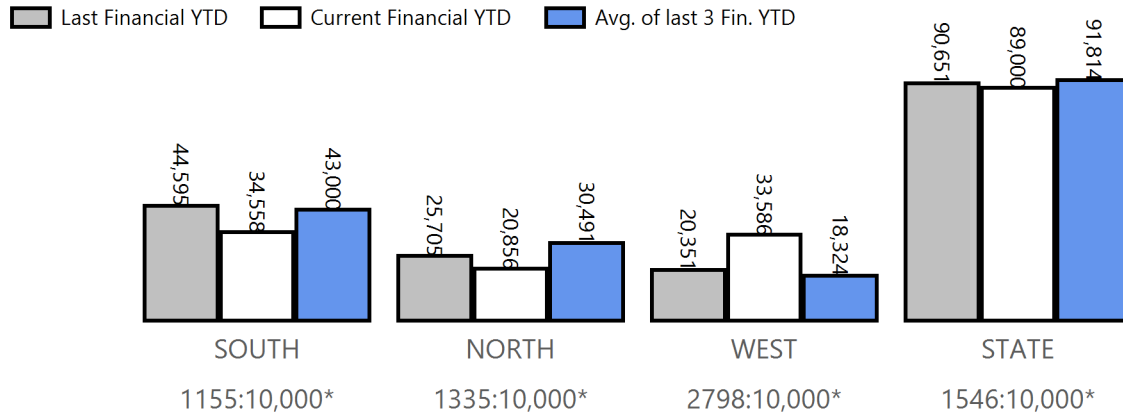
Vehicle Defect Notices - February 2025

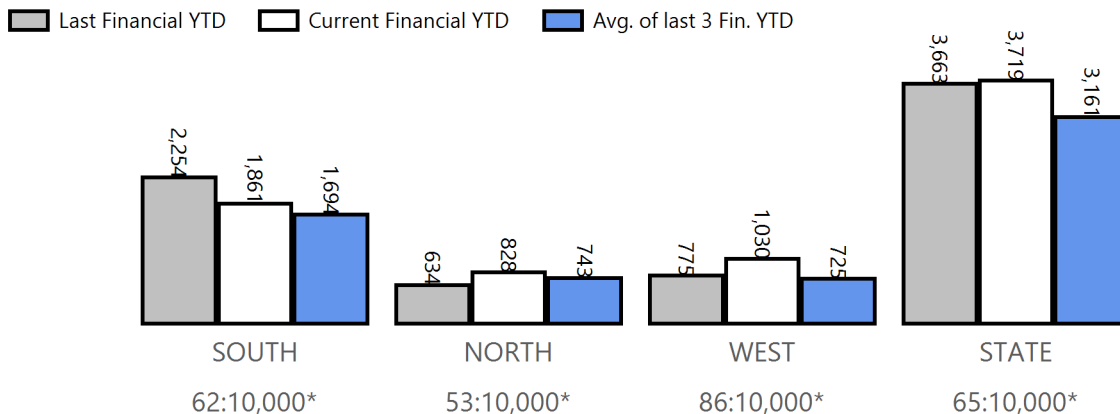
Random Breath Tests (Alcohol) - February 2025

Oral Fluid Tests (Drugs) - February 2025

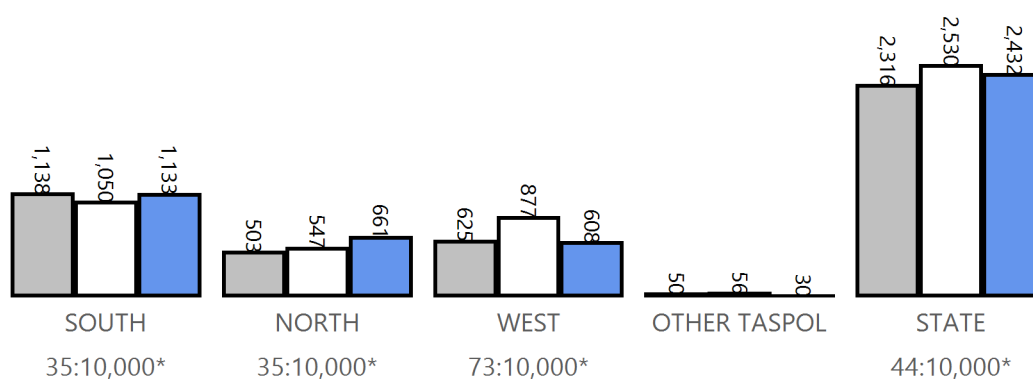

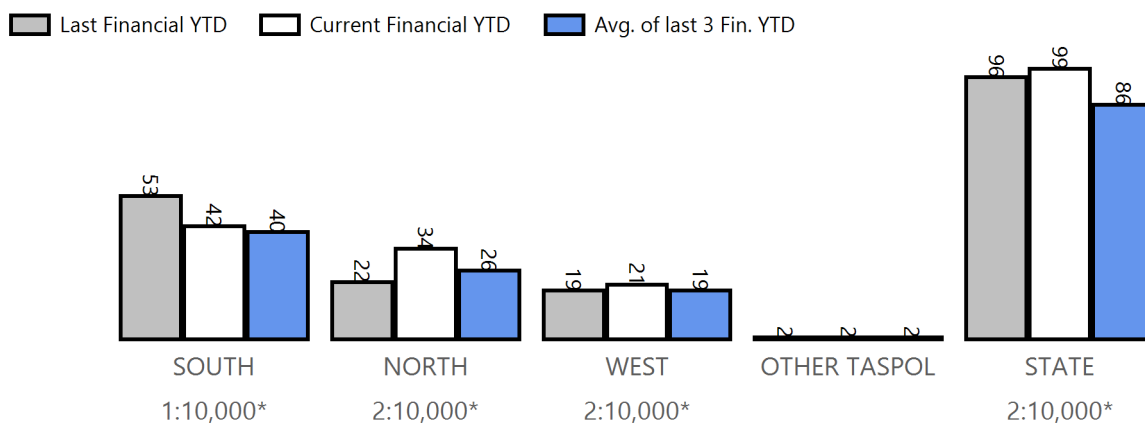

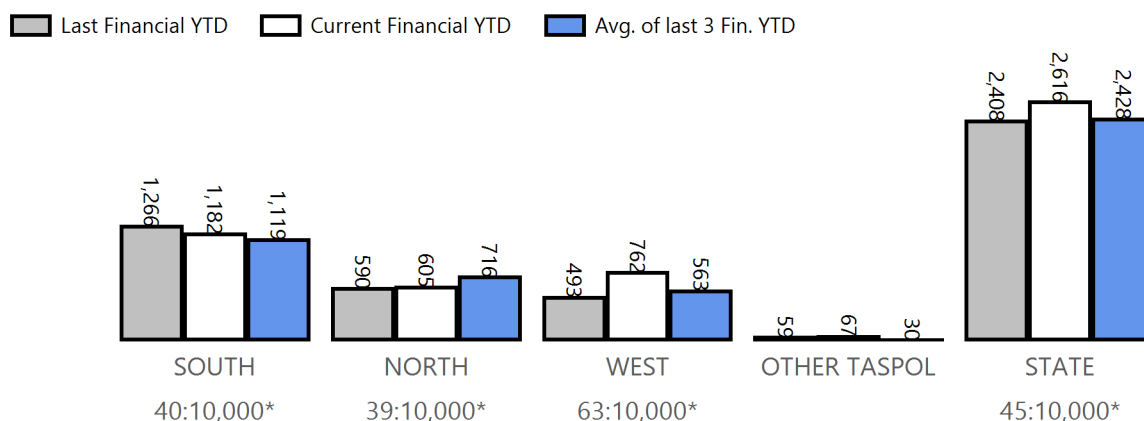
Dangerous and Reckless Driving Offenders - February 2025

Disqualified and Unlicensed Driving Offenders - February 2025



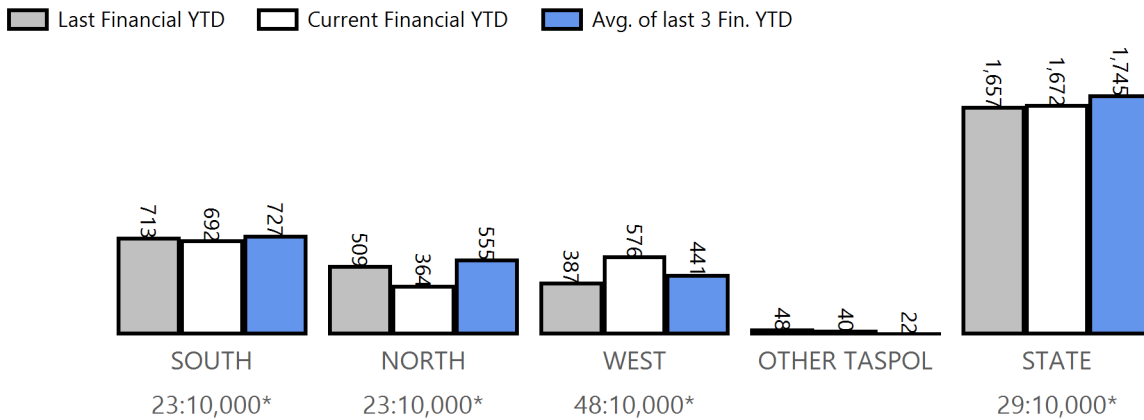

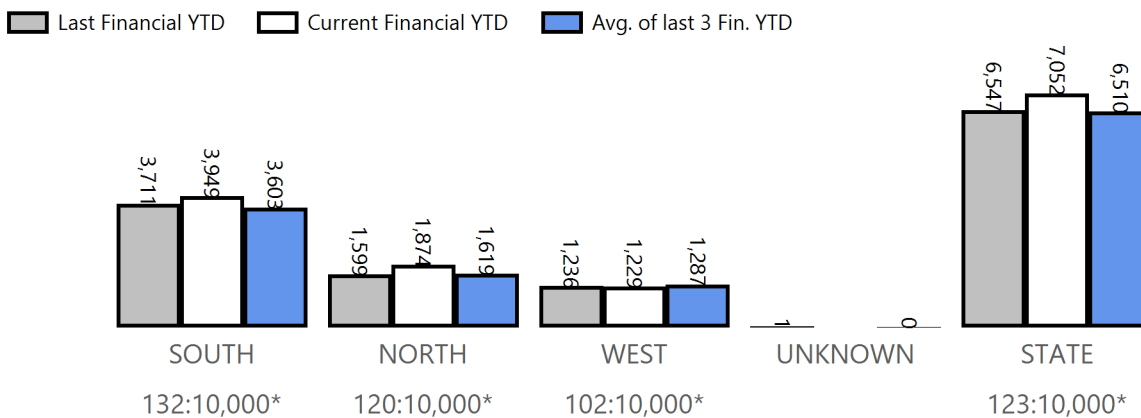
Unregistered Vehicle Offenders - February 2025

Vehicle Complaint Dispatch Incidents - February 2025

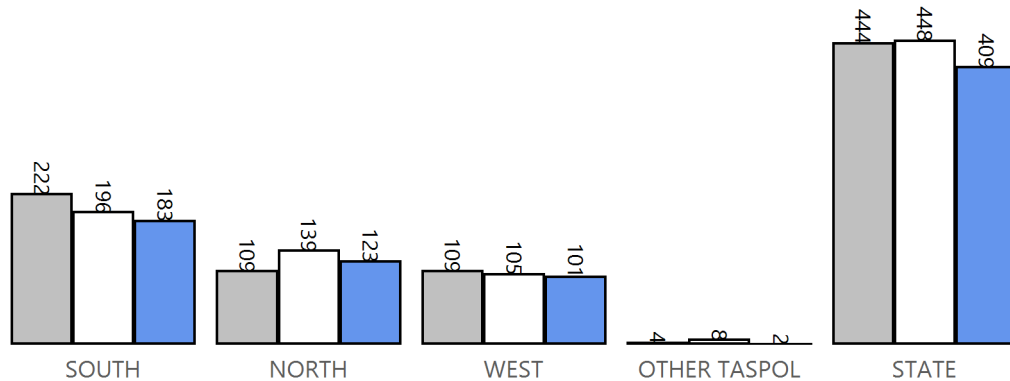

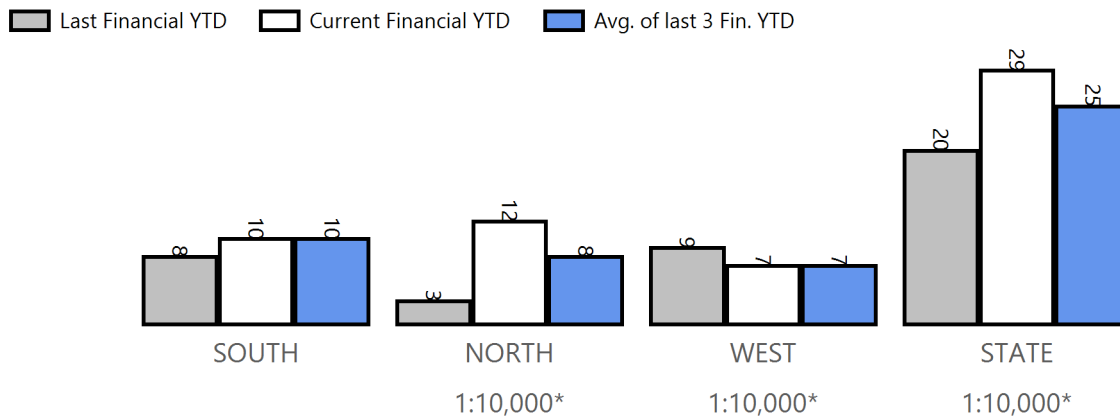

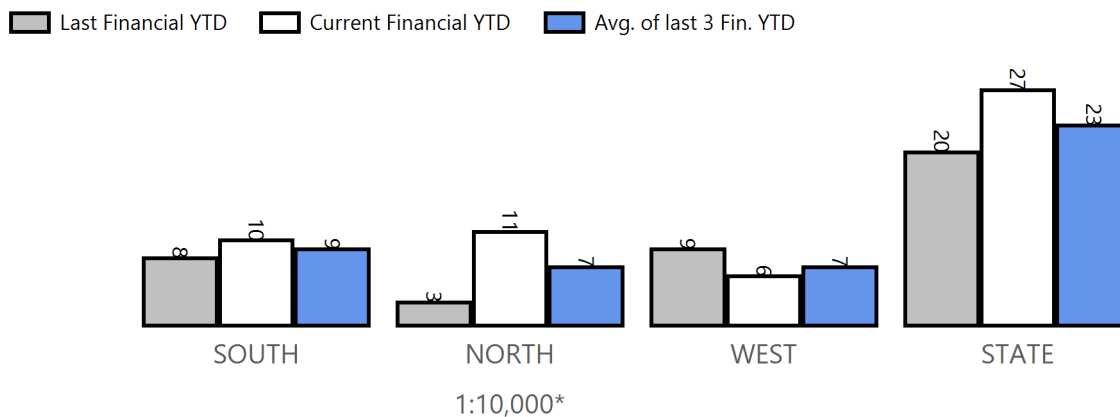
Crash Fatalities - February 2025

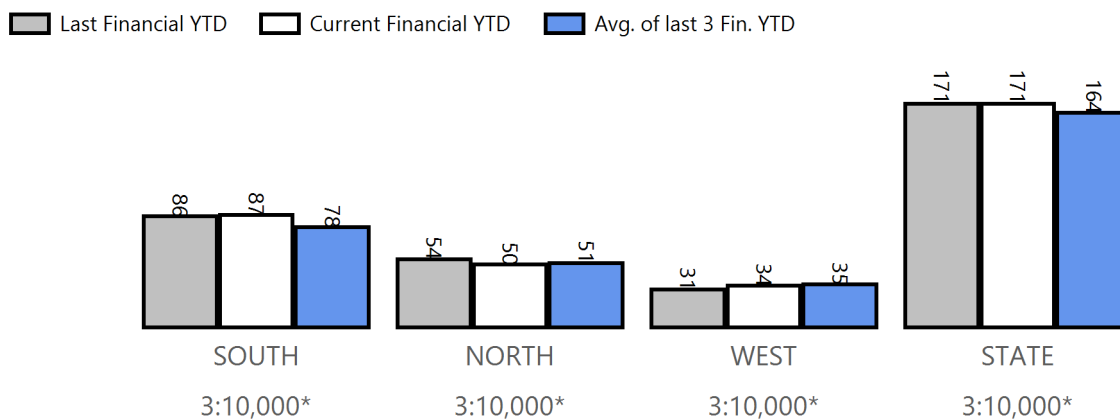
Fatal Crashes - February 2025

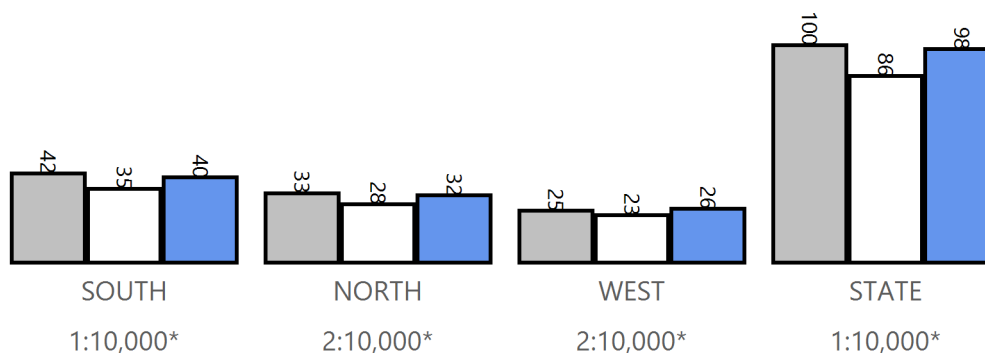

On Road Fatal and Serious Crashes in Rural Areas - February 2025

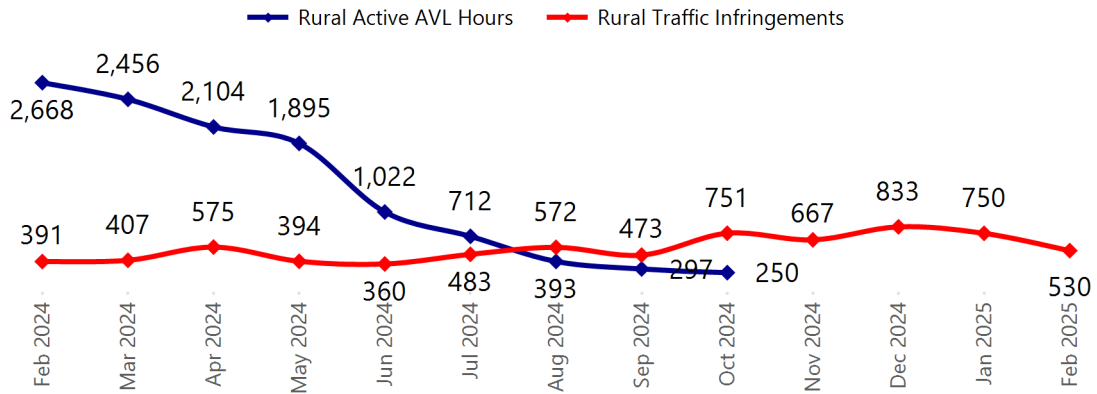

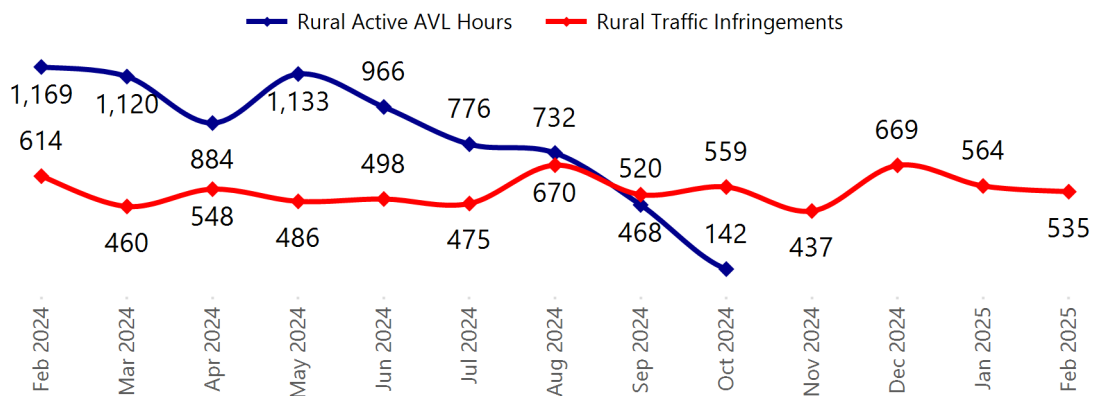

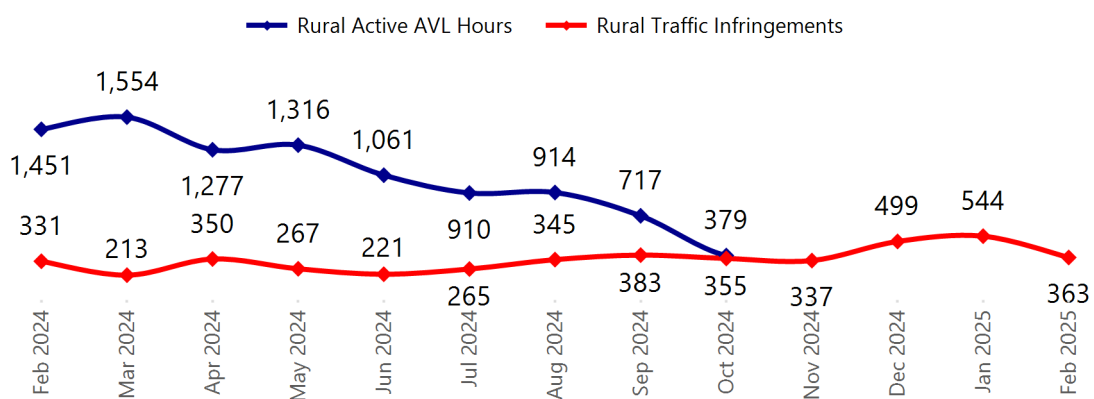
Southern District Rural Policing



Northern District Rural Policing



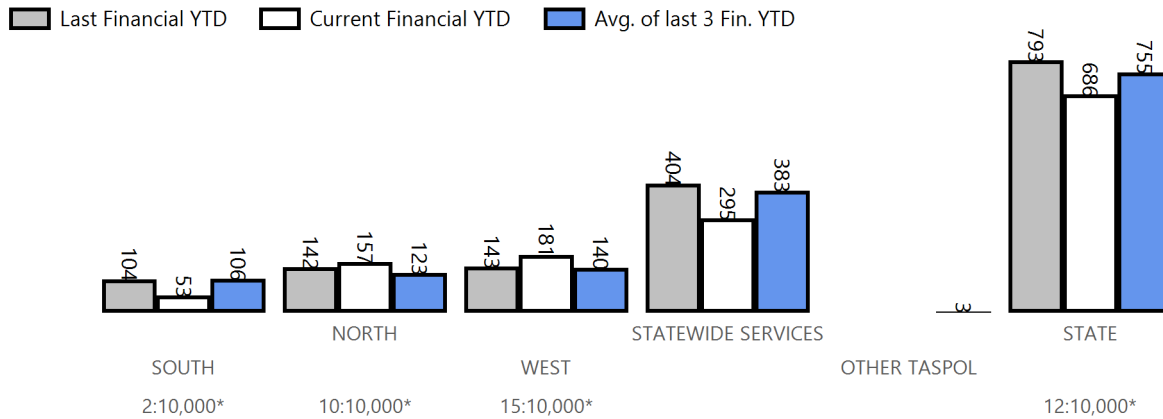

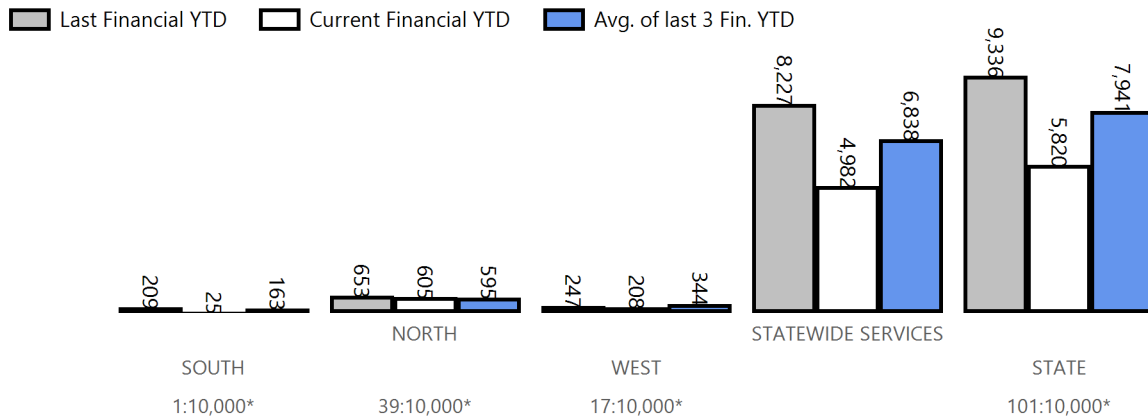

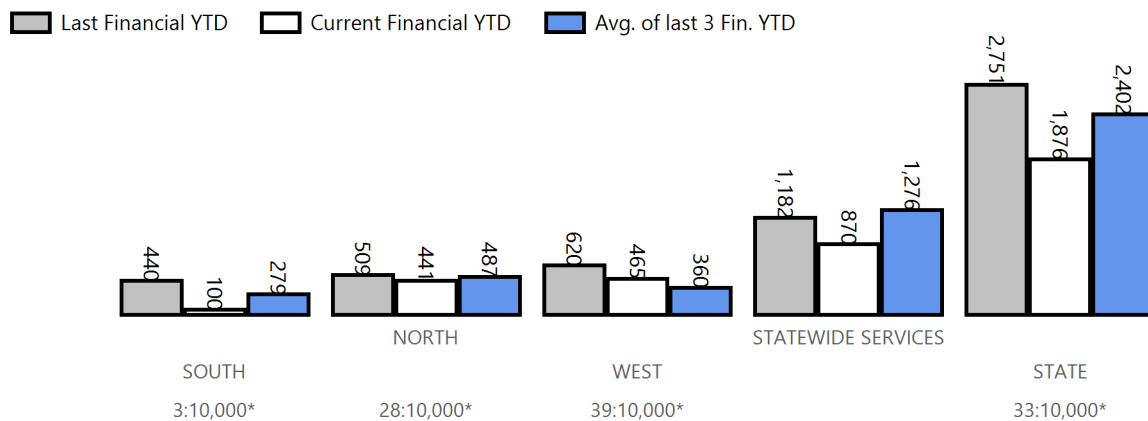
Sea Inspections (Vessel & Non-Vessel) - February 2025

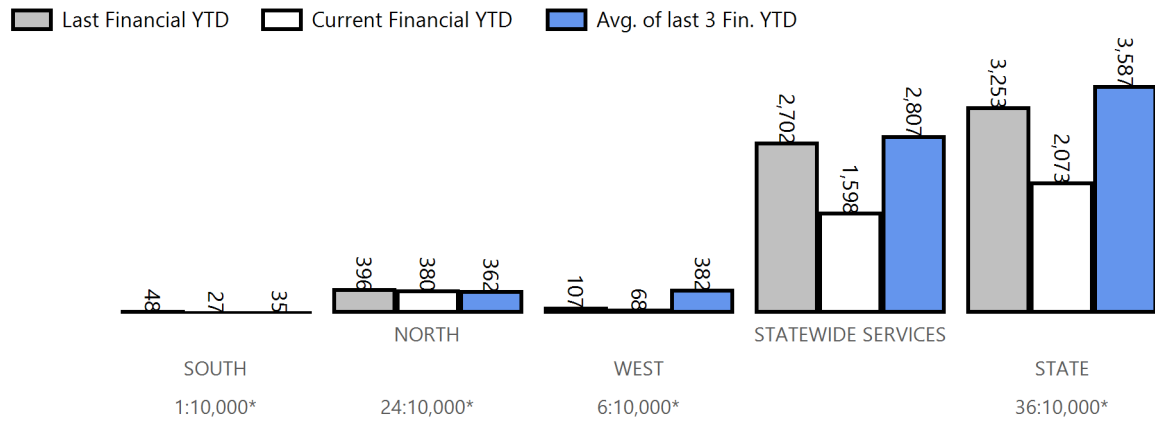
Vessel Inspections on Land - February 2025
