Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 23 September 2022. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

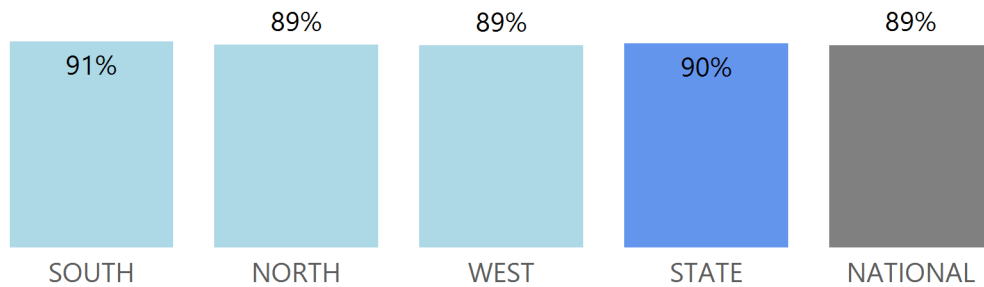

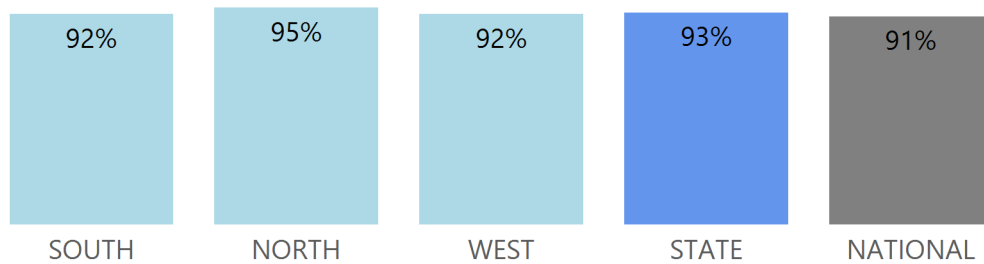

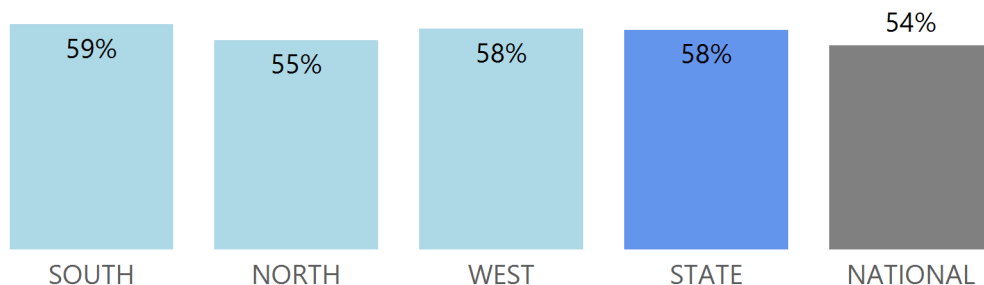
Public Safety - Out in Public Locally (Daytime)

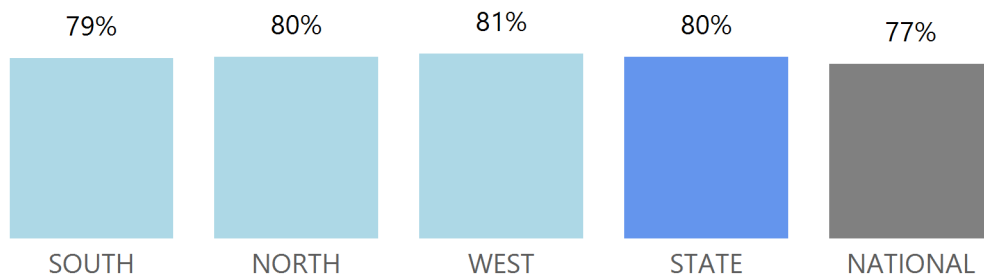

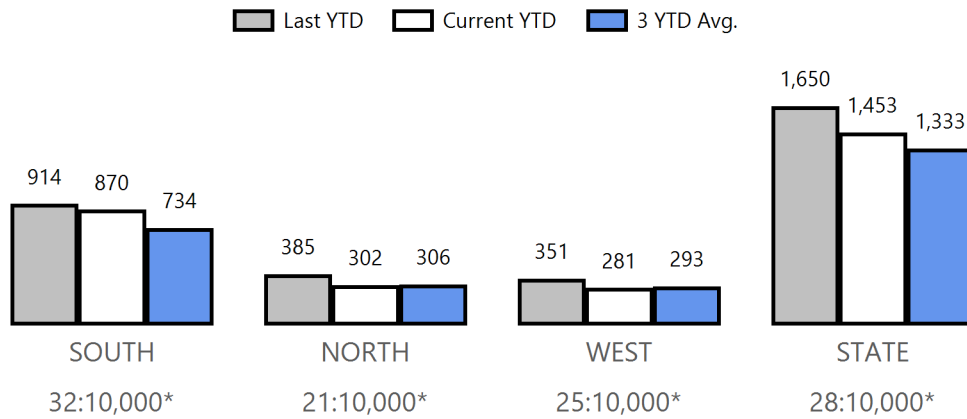

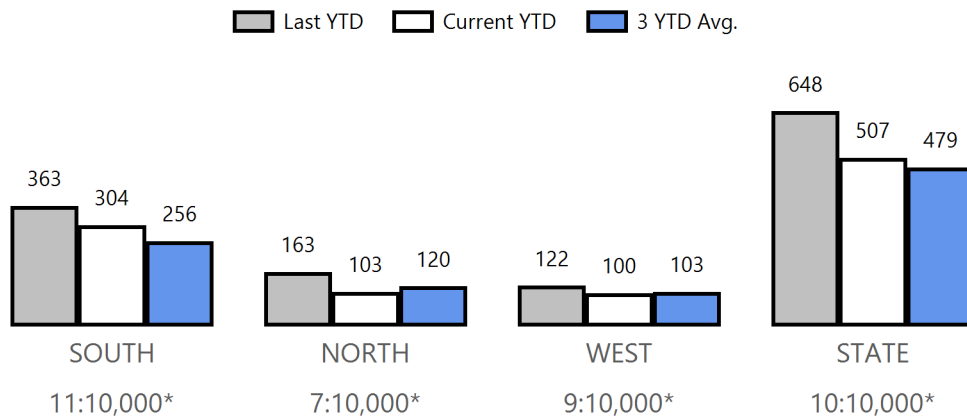
Public Order Incidents - July 2022

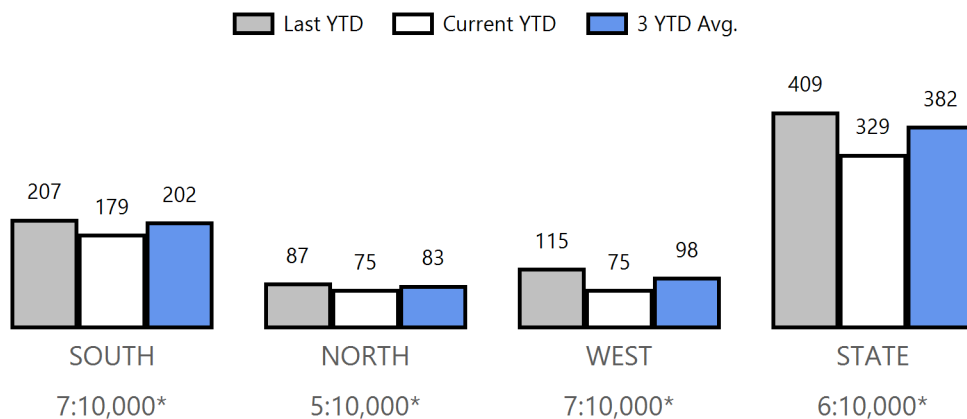
Public Order : Disturbance - July 2022

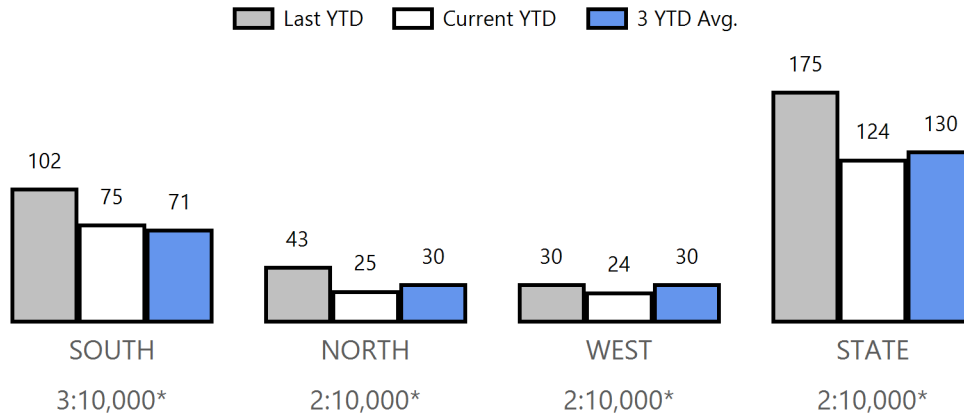
Public Order : Noise - July 2022

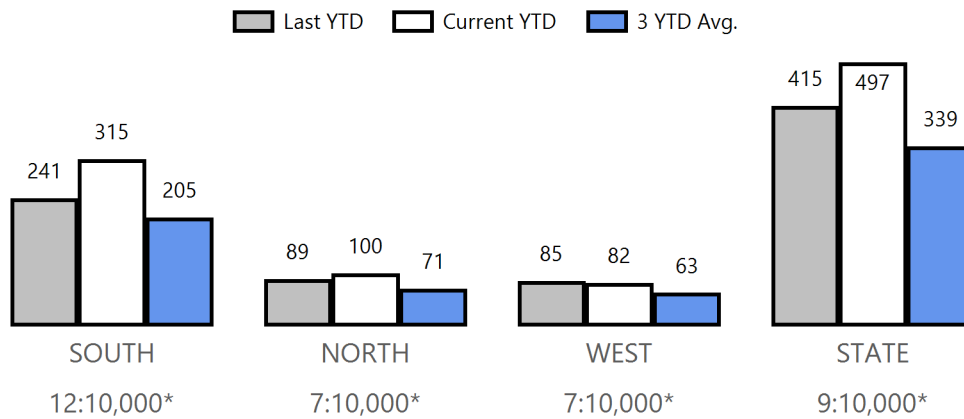
Public Order : Vandalism - July 2022

Public Order : Offensive Behaviour - July 2022

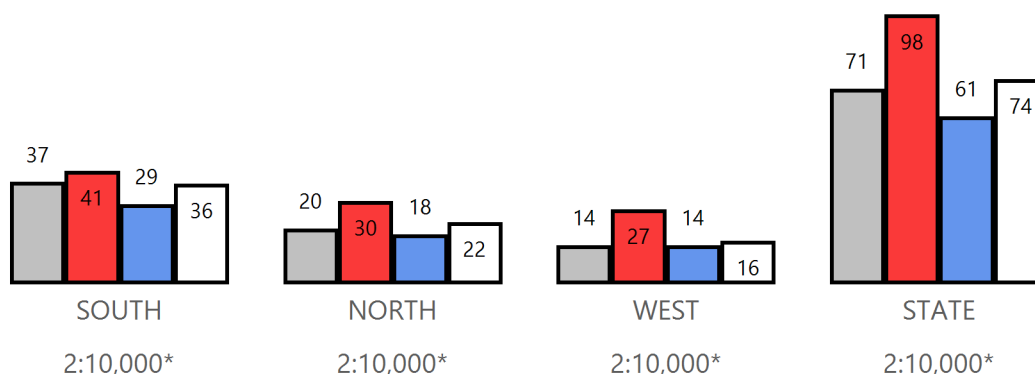

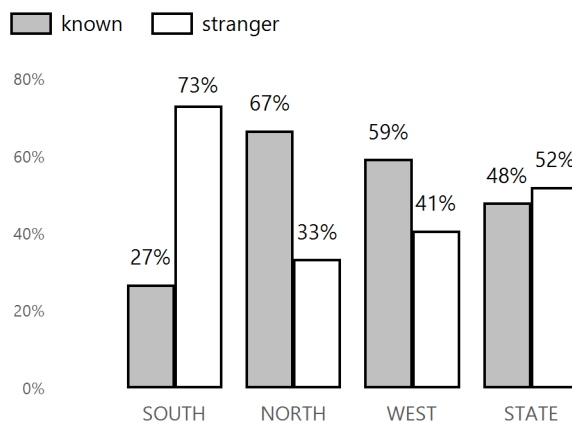

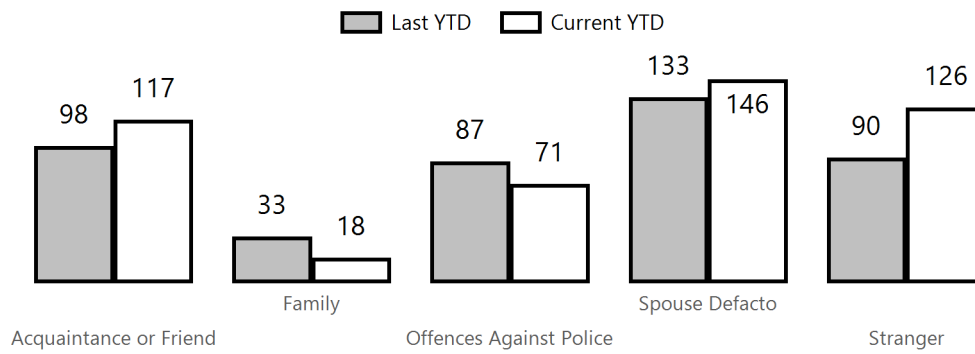

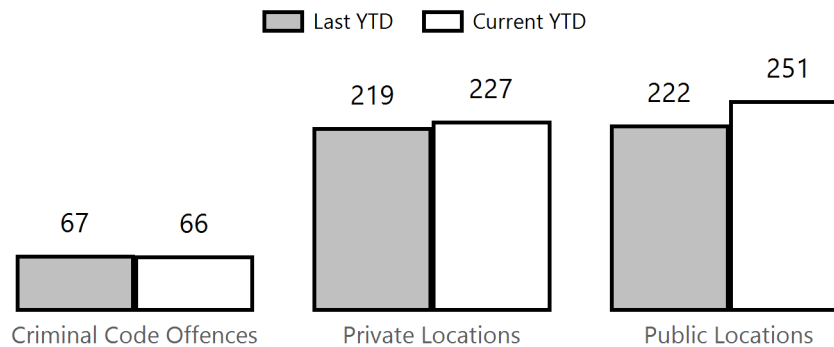

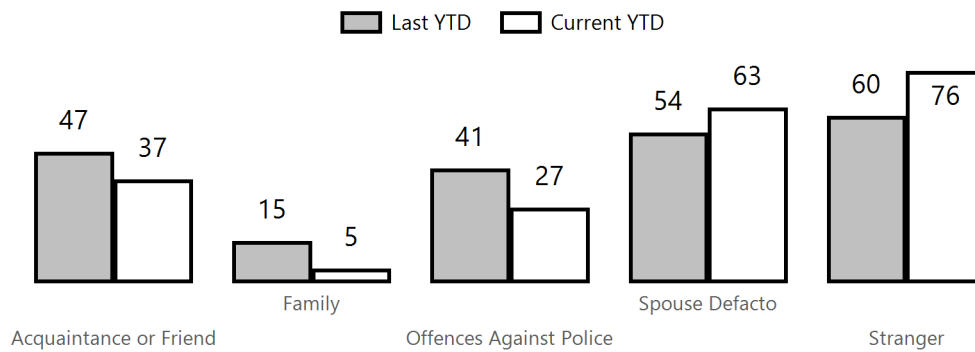

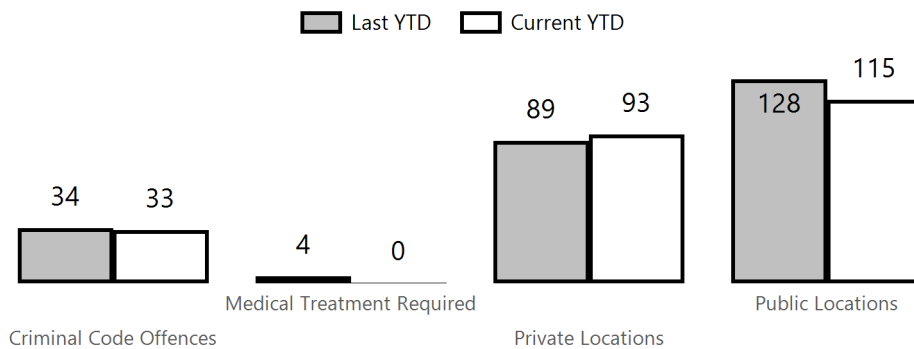

Total Person Offences - Victim Categories - SOUTH



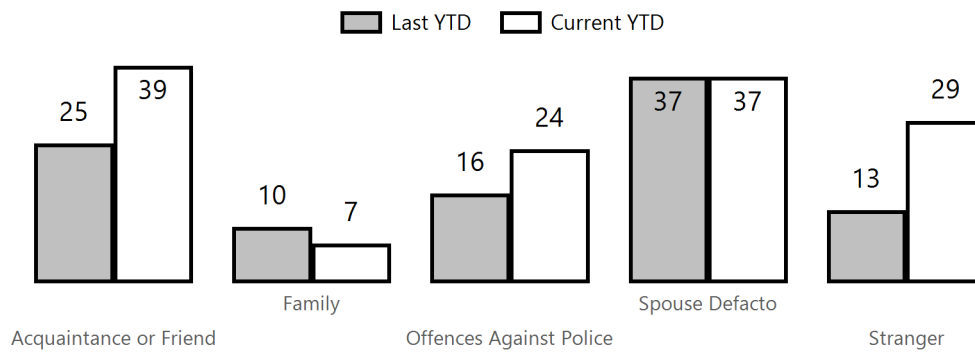

Total Person Offences - SOUTH



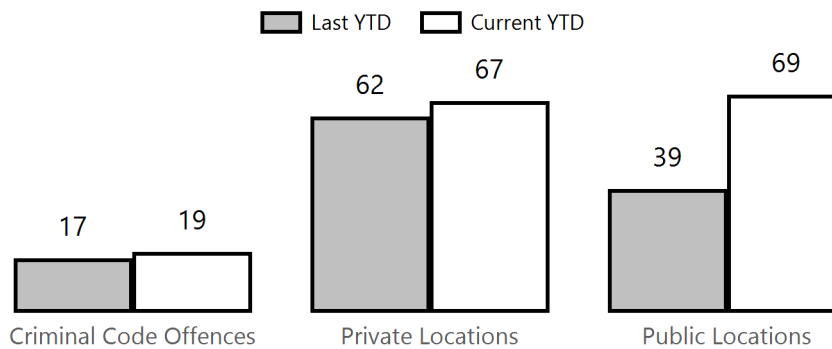

Total Person Offences - Victim Categories - NORTH



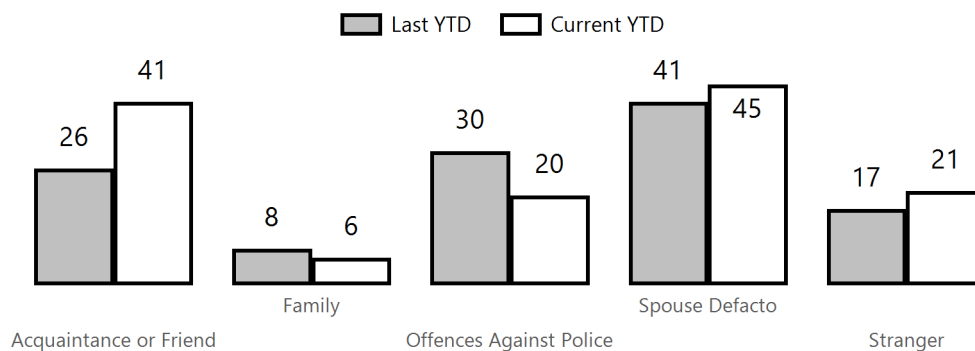

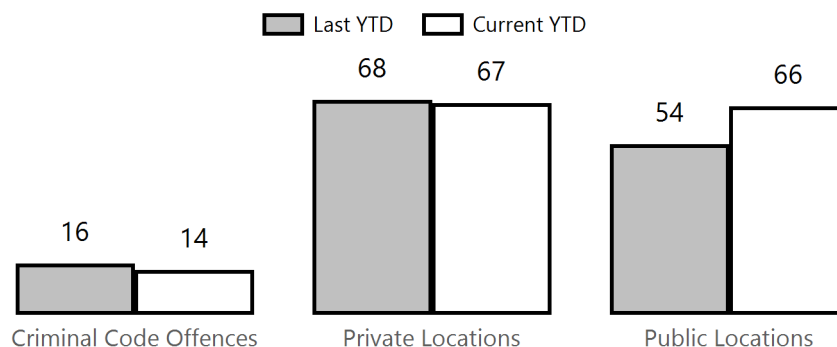

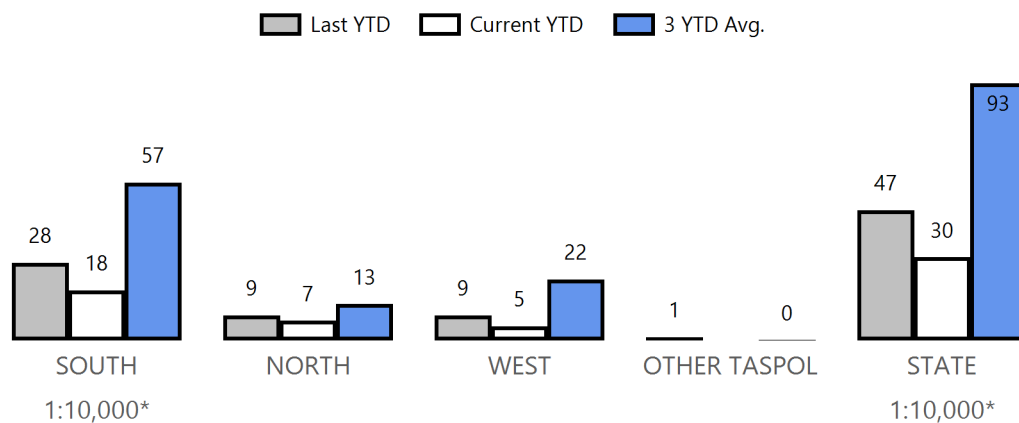

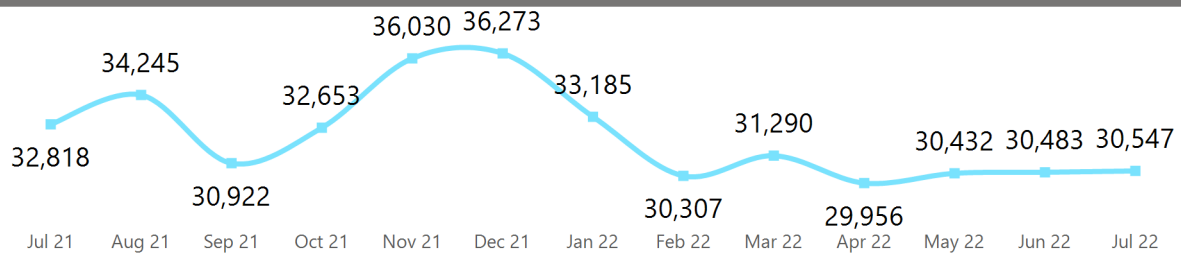
Total Uniform Police Patrol Hours - July 2022

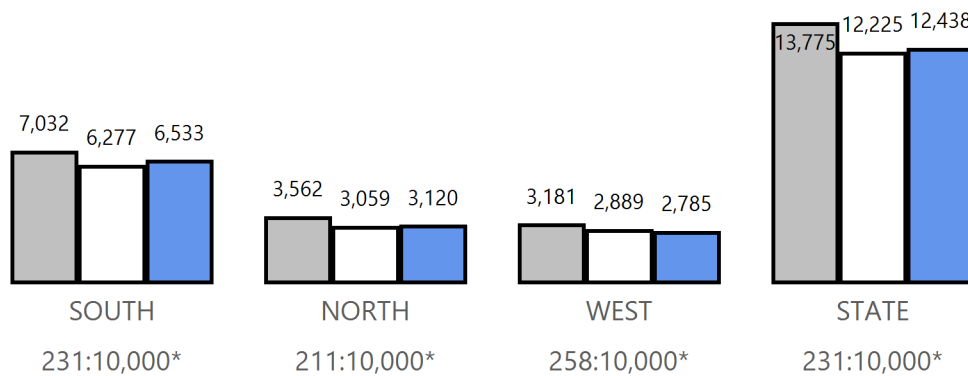
Uniform Police - Patrol Hours

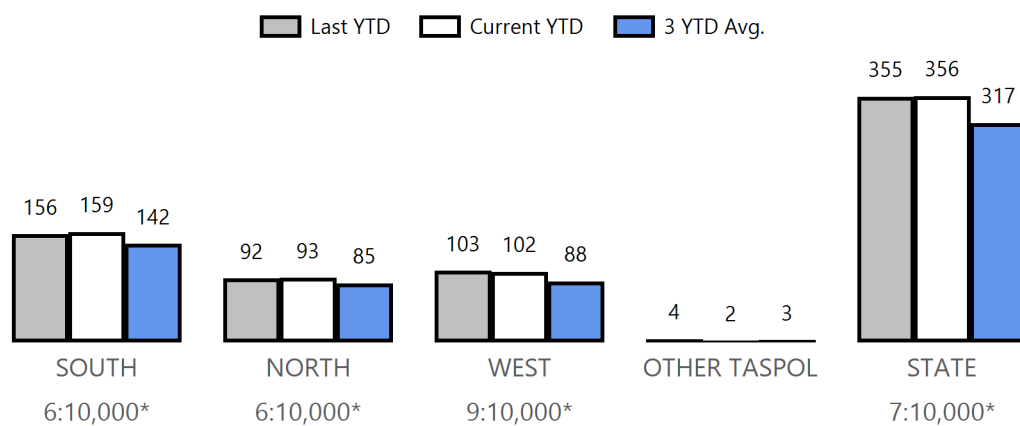

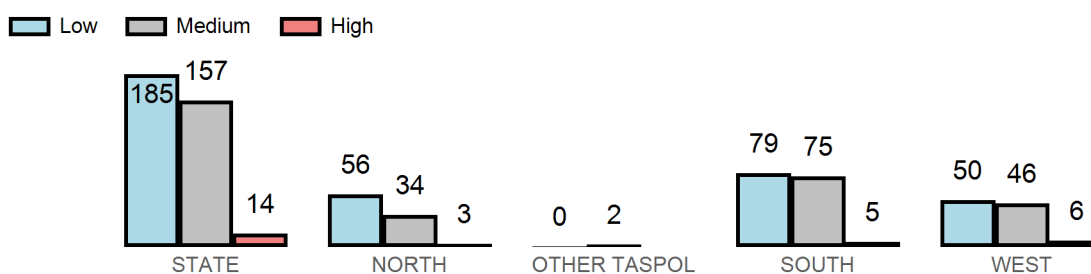
Family Violence Incidents - July 2022

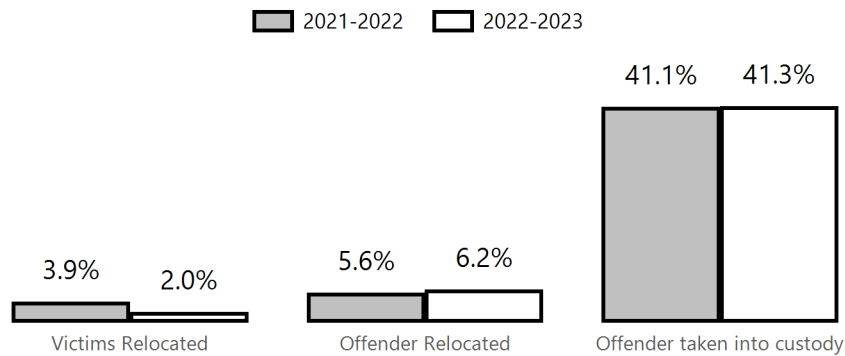

Family Violence RAST - Excludes Other and Argument Categories



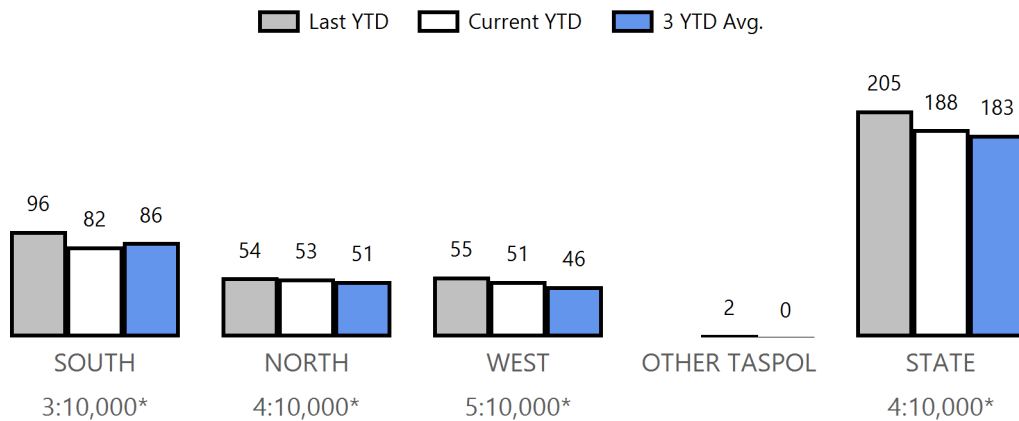

Family Violence - Action at Scene (Excludes 'Other' and 'Argument' categories)



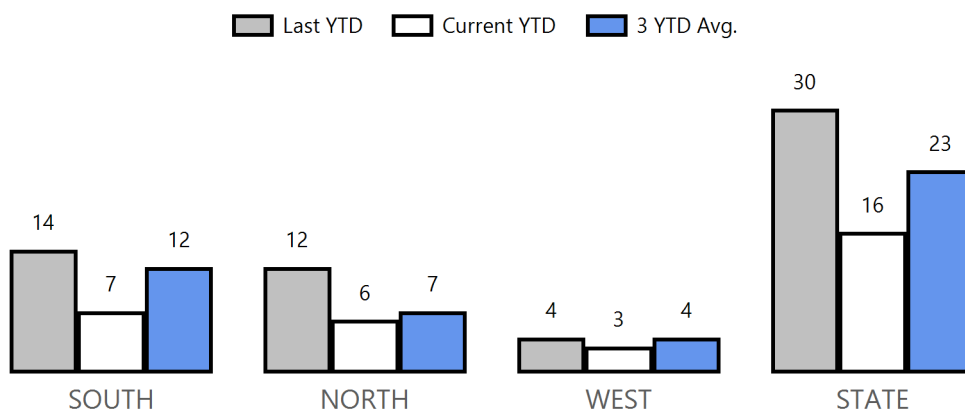

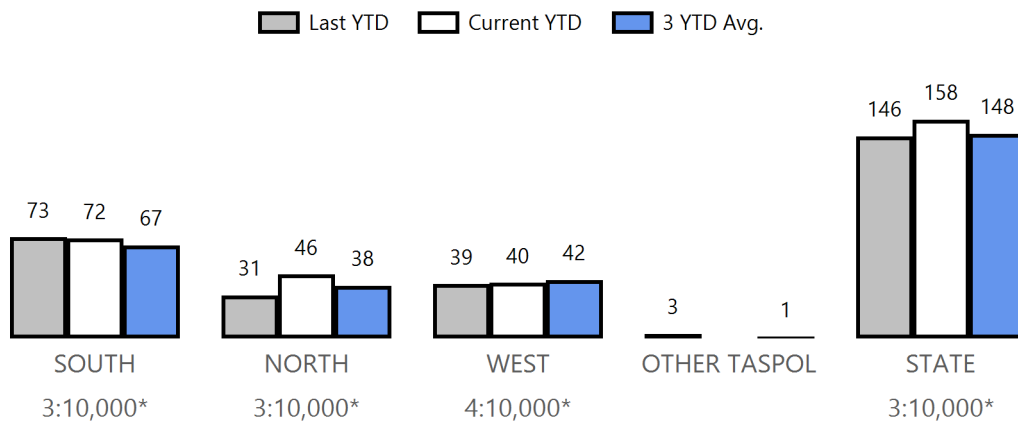

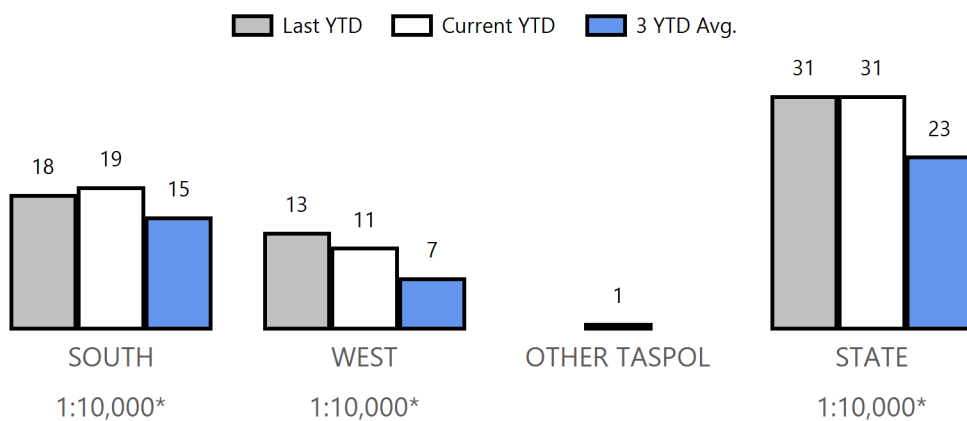
Family Violence Orders : Police Issued - July 2022

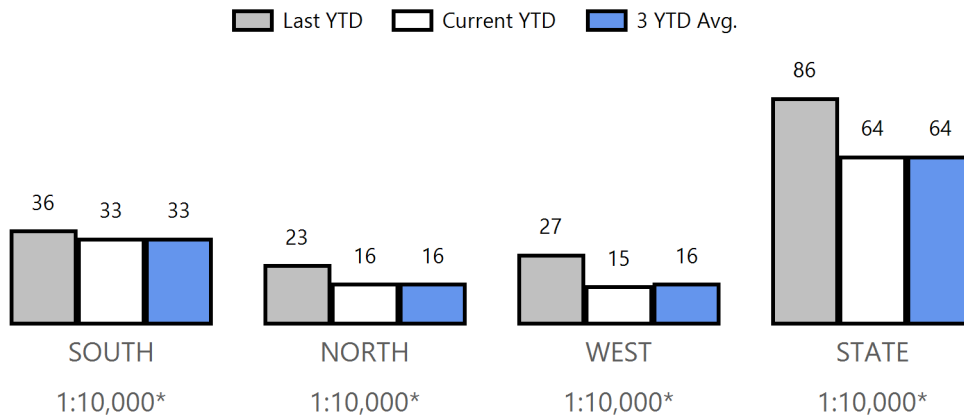
Family Violence Orders : Court Application - July 2022

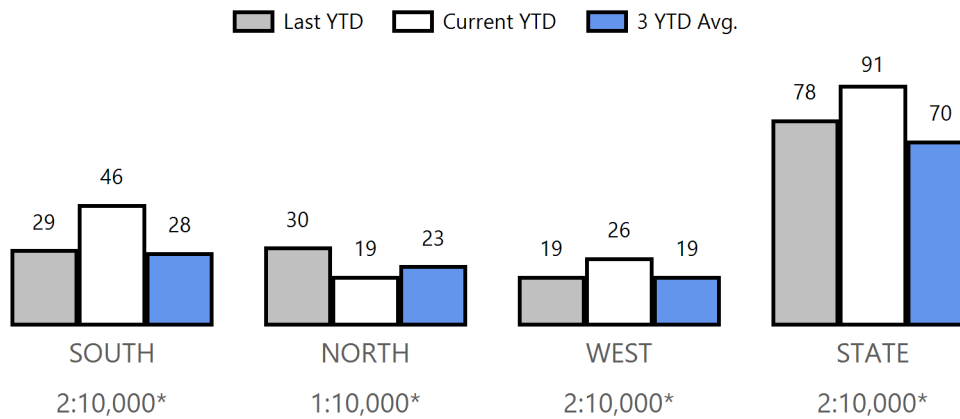

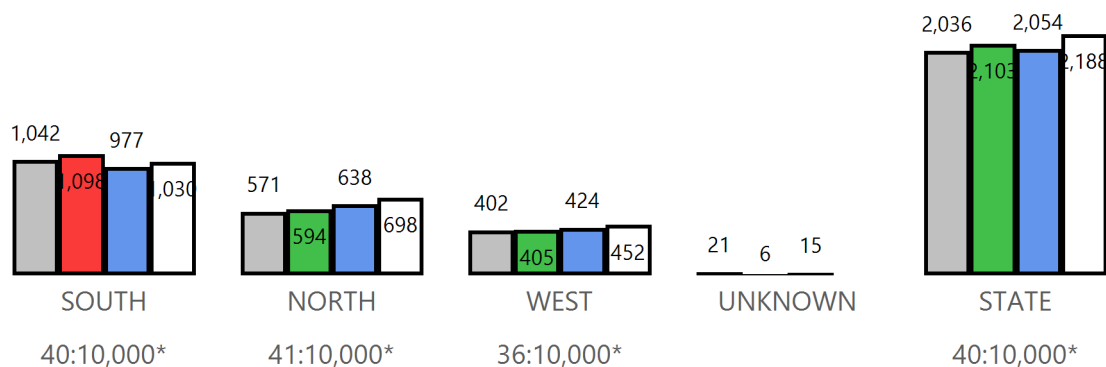
Family Violence - FVO Breaches - July 2022



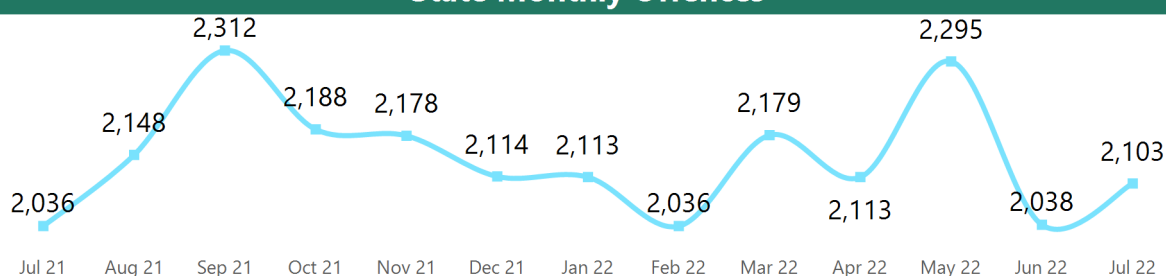

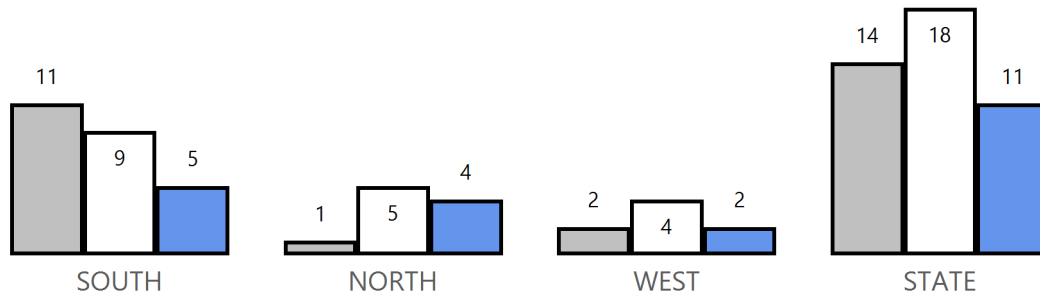

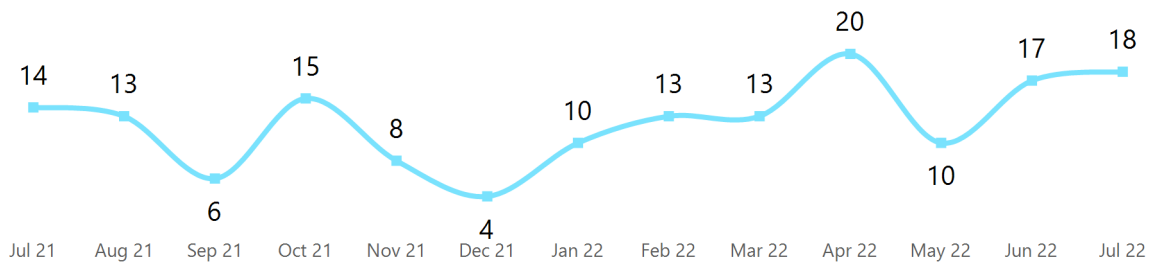

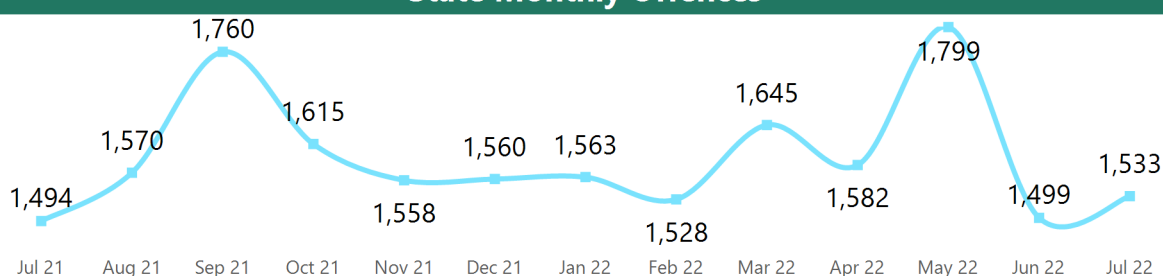

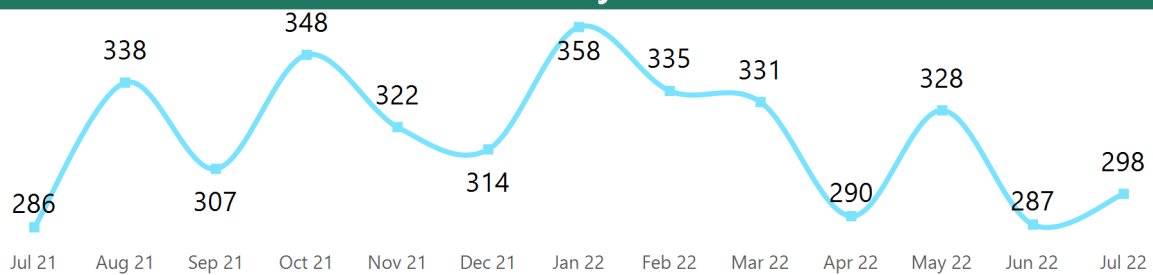

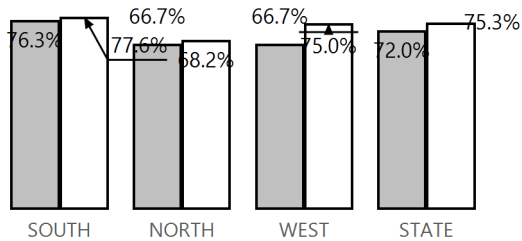


SMV : YTD Recovery %

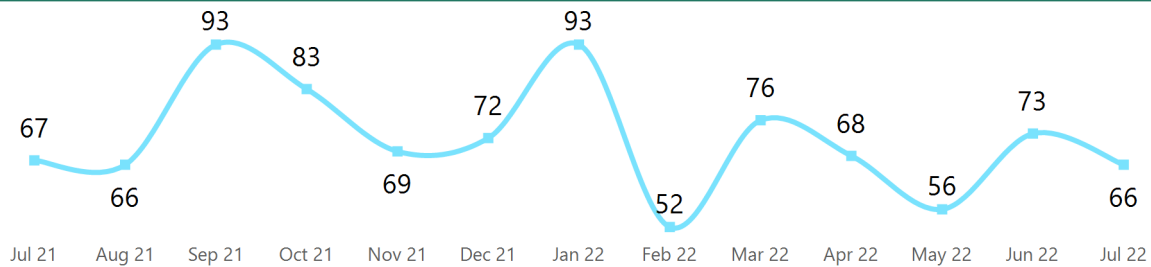

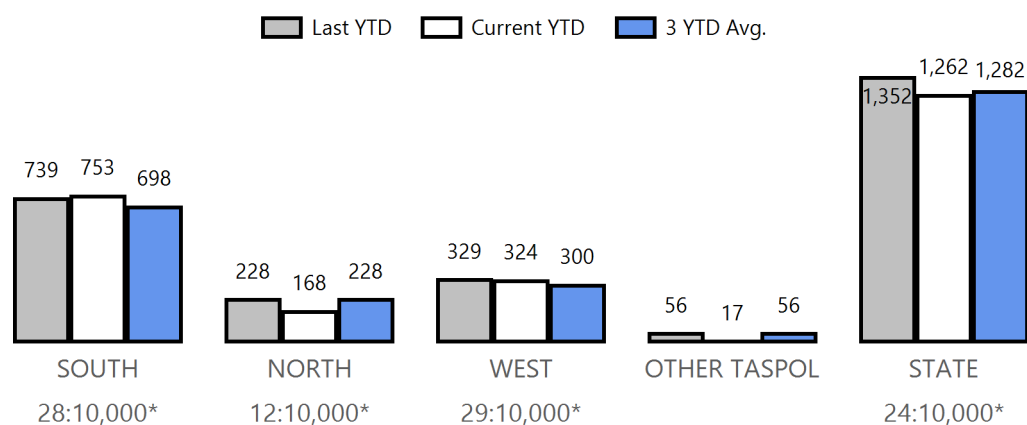

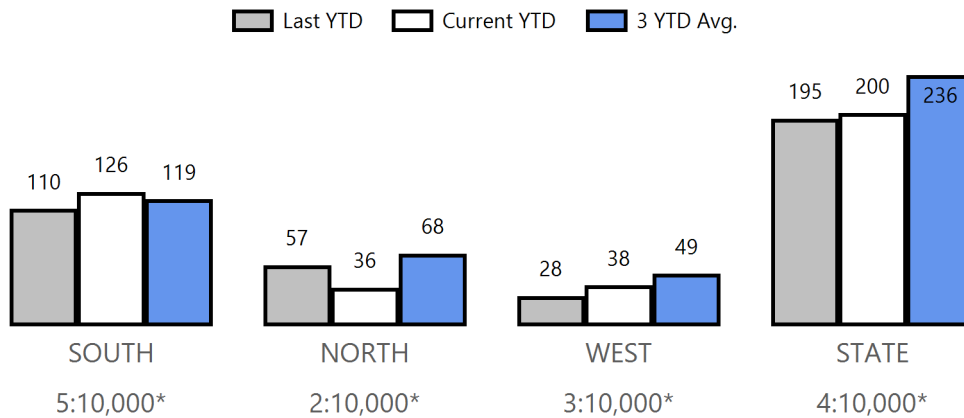
Total Street Checks - July 2022

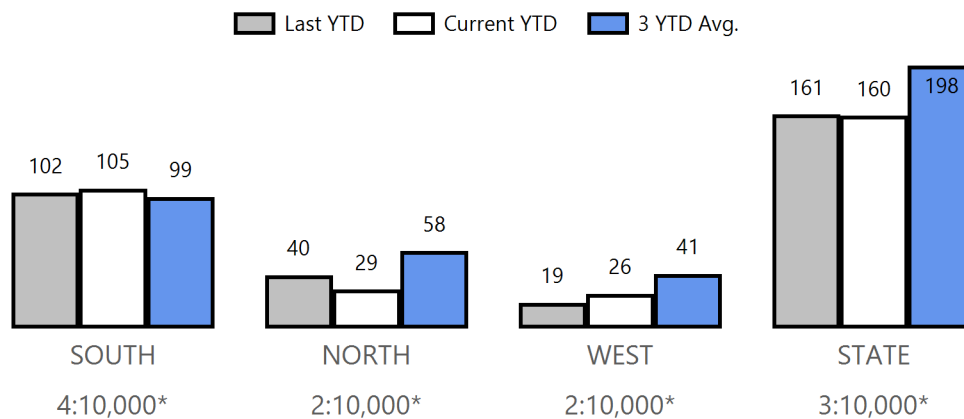
CIB: Total Offenders - July 2022

CIB: Total Crime Offenders - July 2022



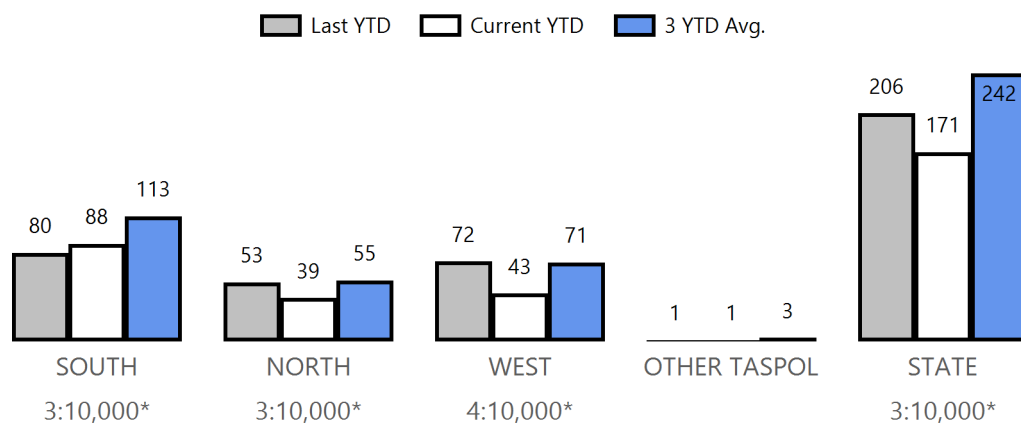

Total Drug Offenders - July 2022



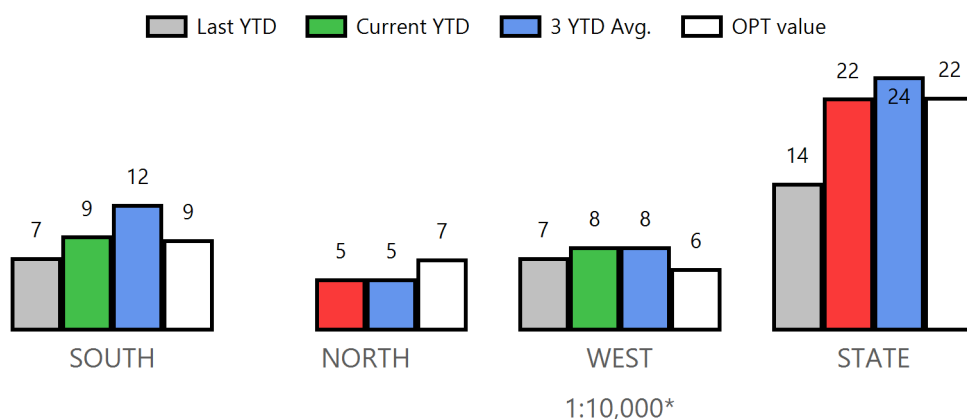

Total Traffic Offenders - July 2022



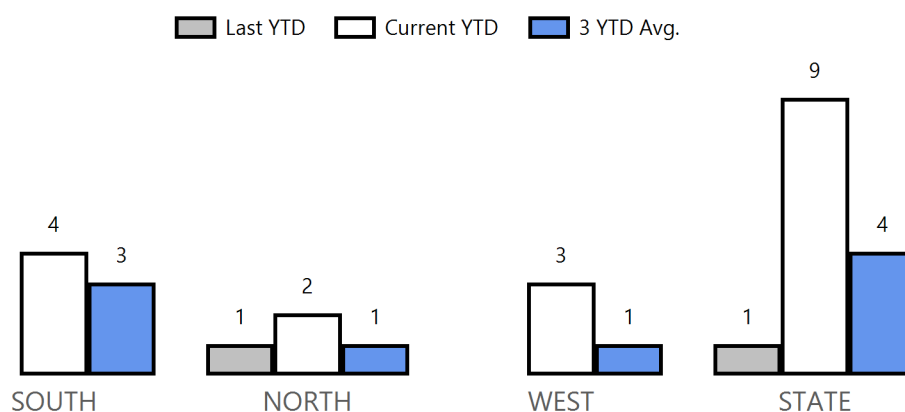

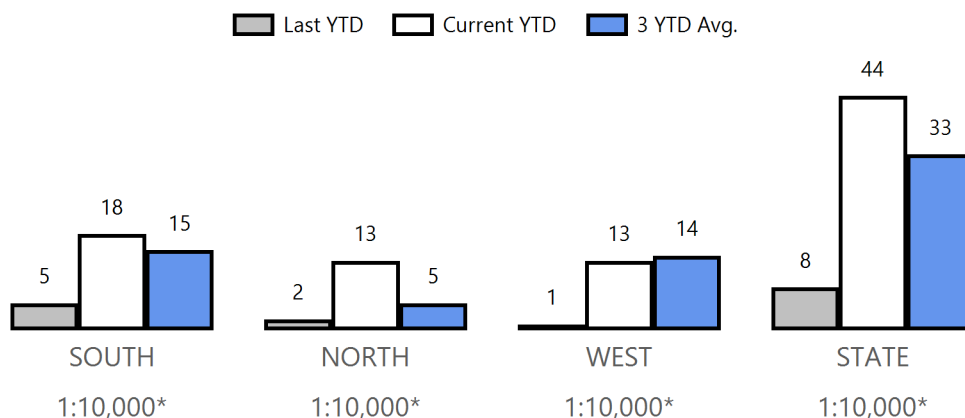
Major Traffic Operations - July 2022

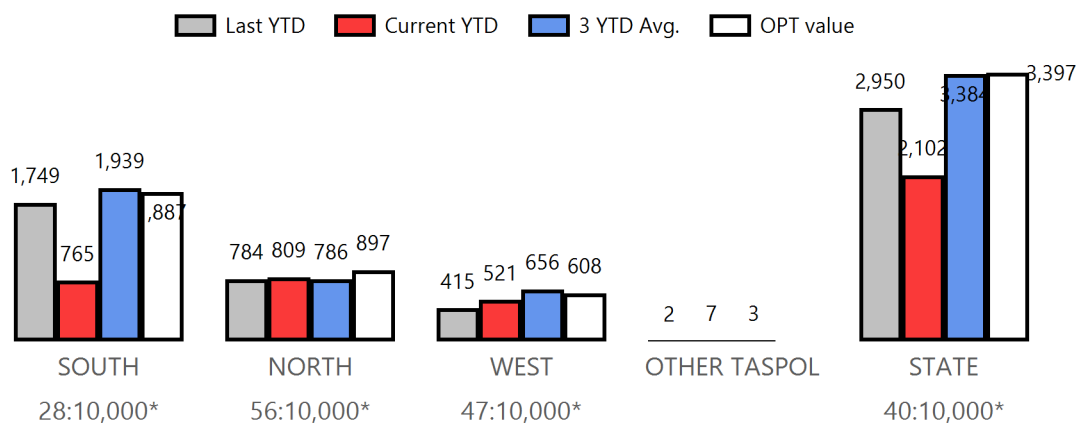

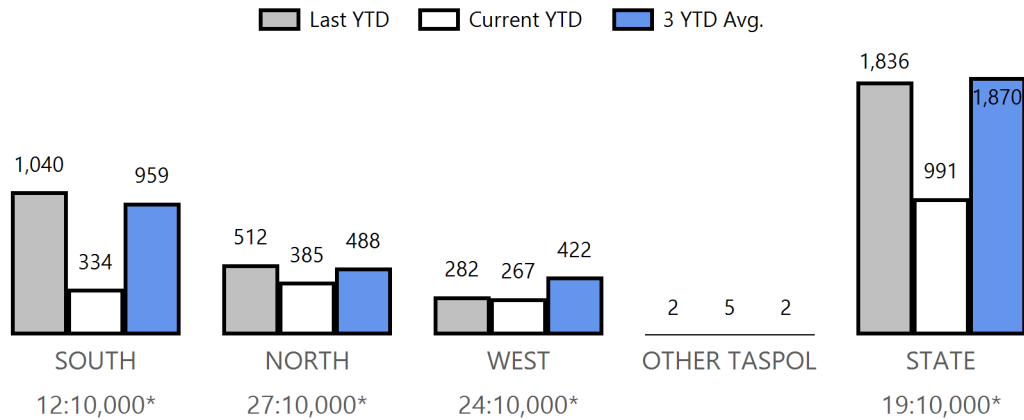

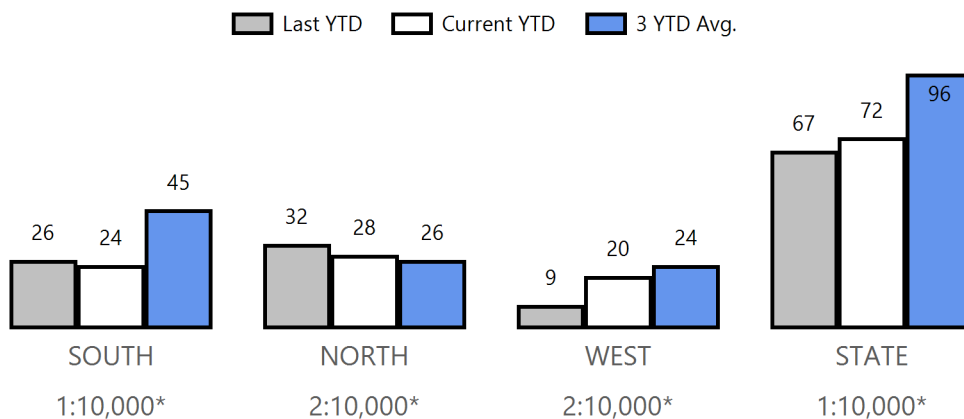
Excessive Speed Offenders - 15-29km/h - July 2022

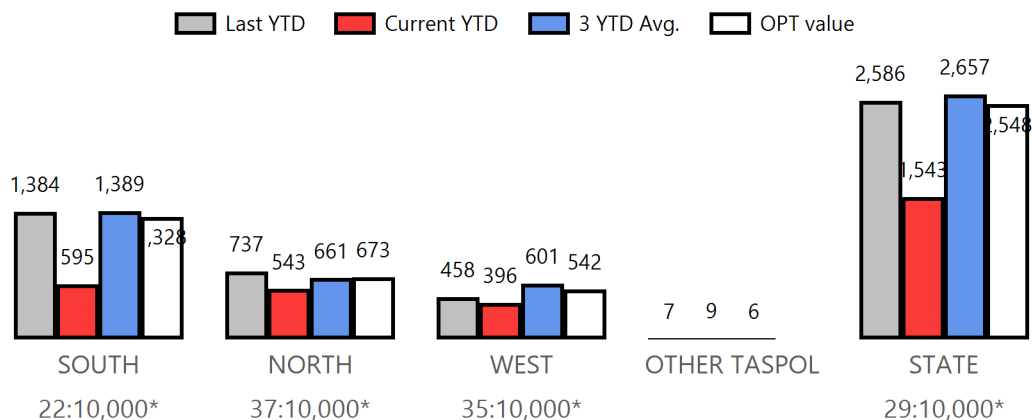
Excessive Speed Offenders - 30km/h + - July 2022

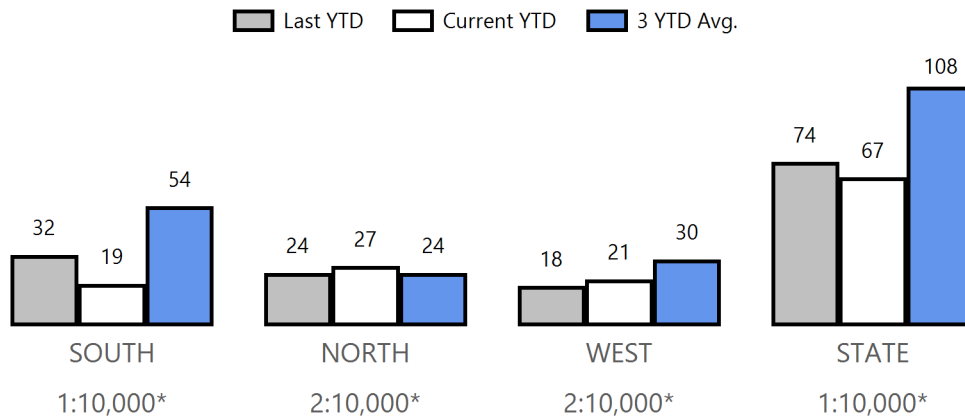
High Risk Offenders - July 2022

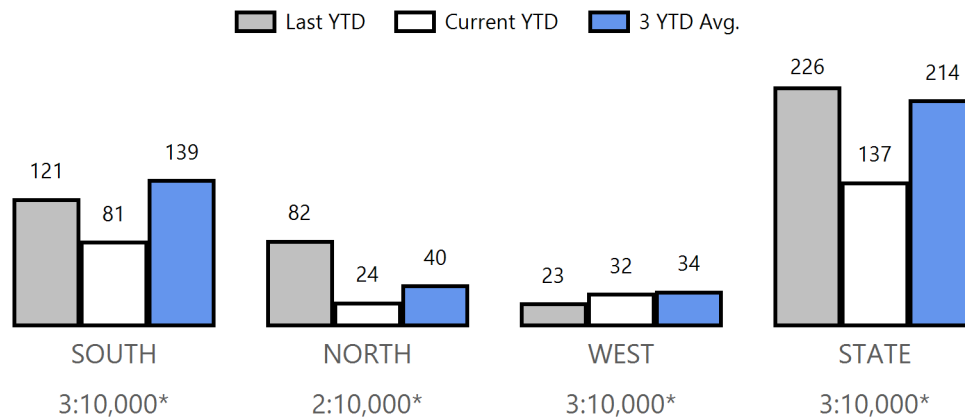
Seatbelt Compliance Offenders - July 2022

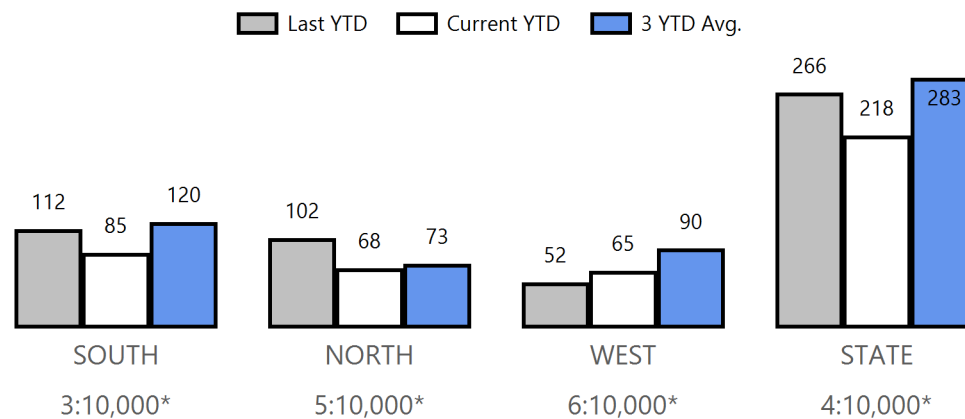
Mobile Phone Offenders - July 2022

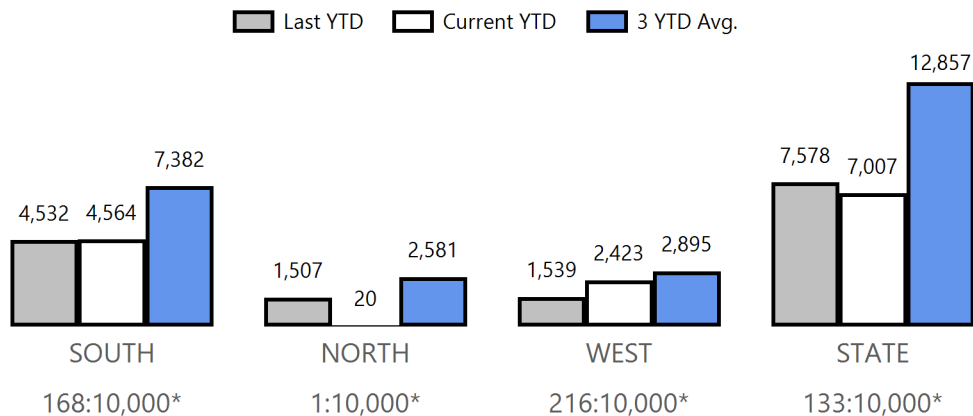
Vehicle Defect Notices - July 2022

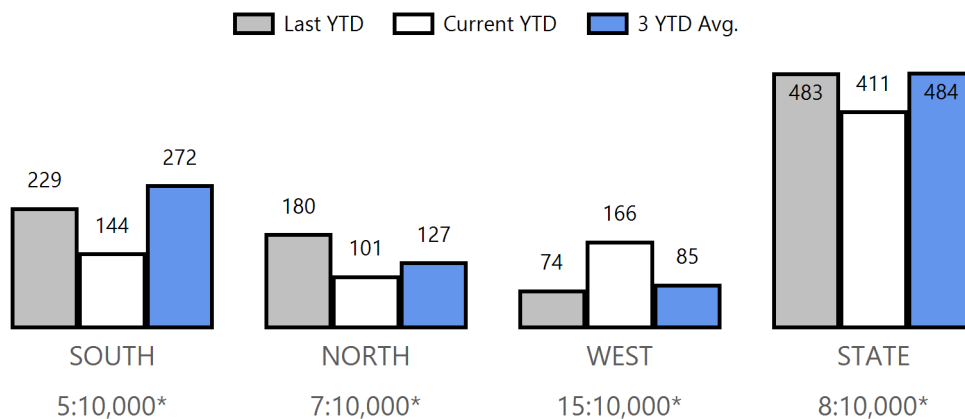
Random Breath Tests (ALCOHOL) - July 2022

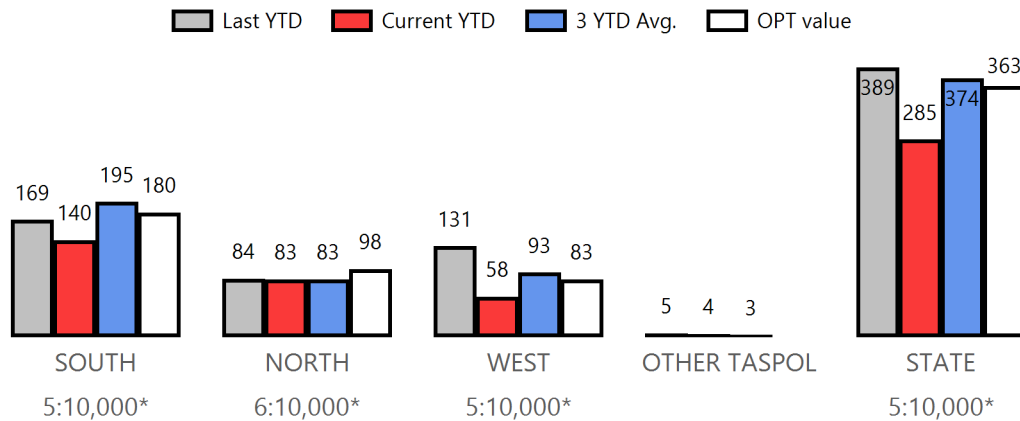

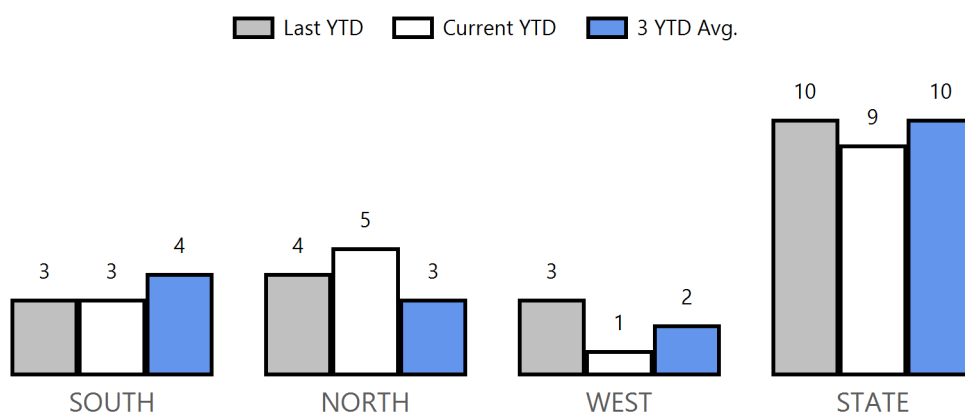

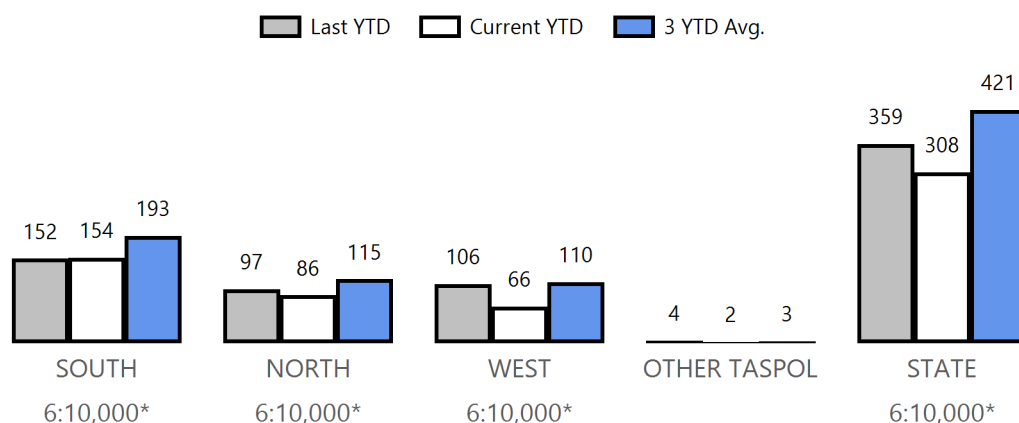
Dangerous and Reckless Driving Offenders - July 2022

Disqualified and Unlicensed Driving Offenders - July 2022



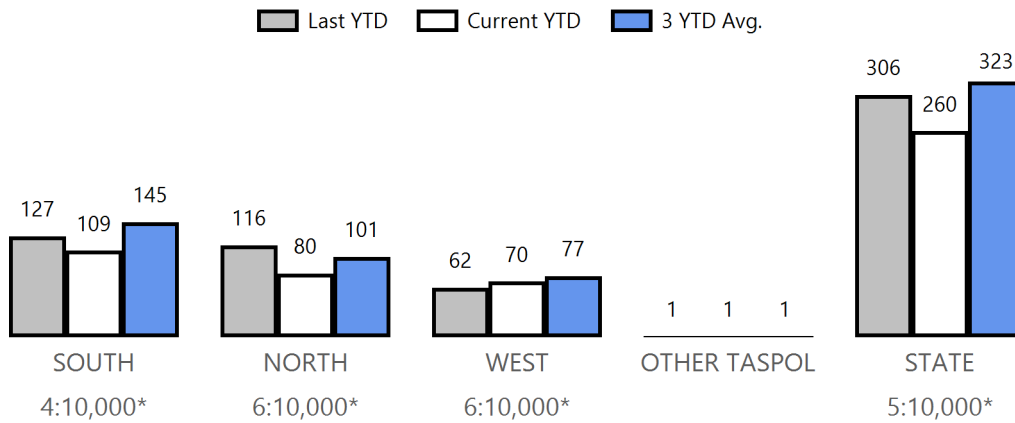

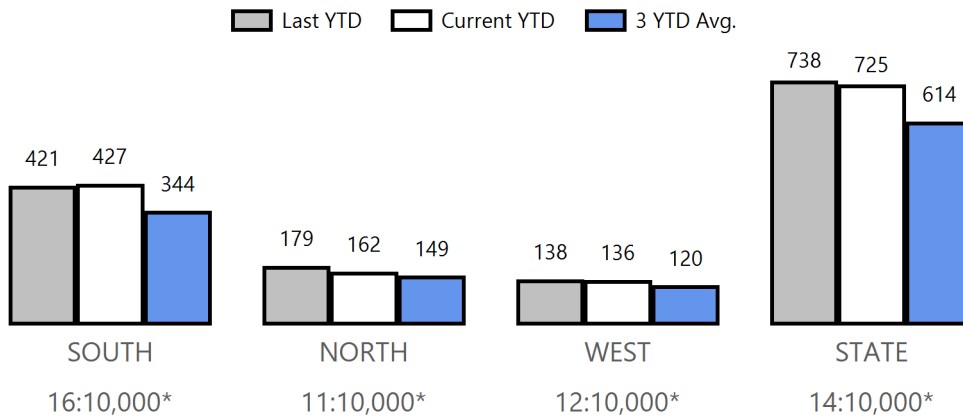
Unregistered Vehicle Offenders - July 2022

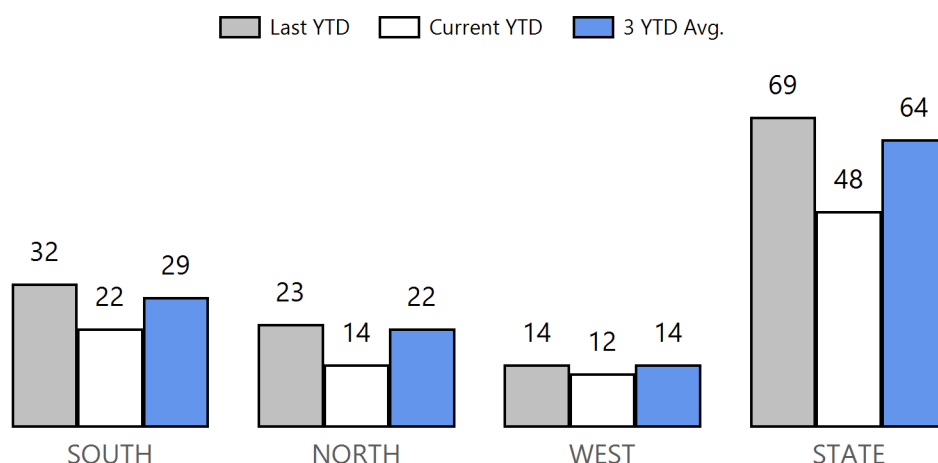
Vehicle Complaints made to RDS - July 2022

Vehicles Clamped or Confiscated - July 2022



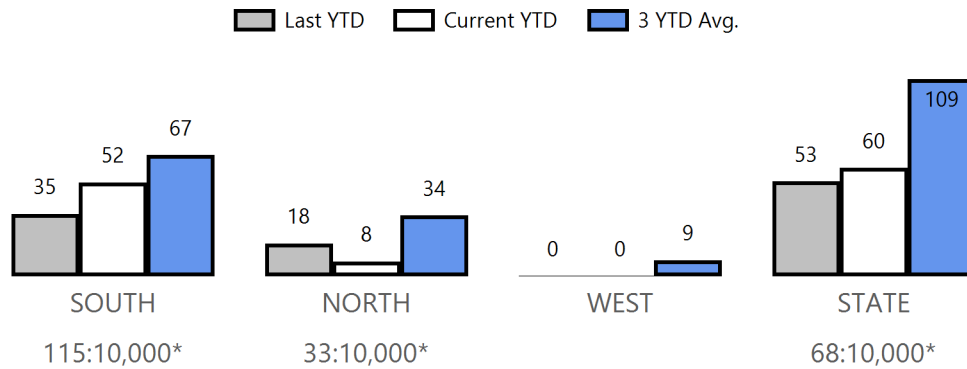

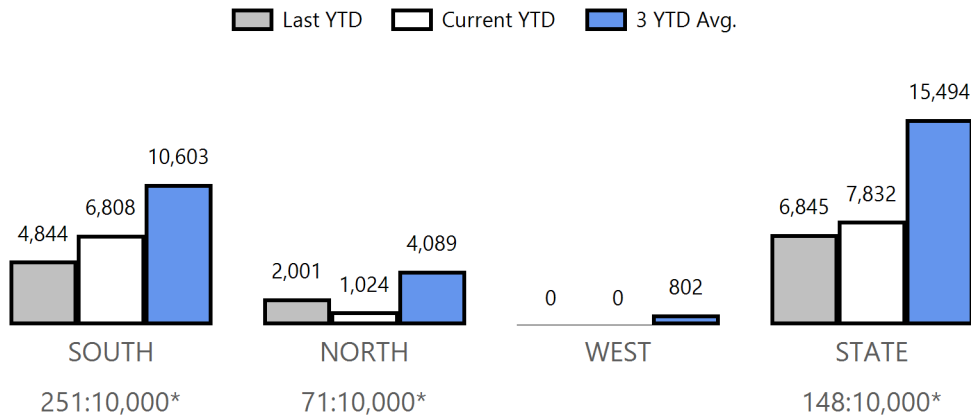
Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - July 2022

ANPR: Total Vehicles Captured - July 2022



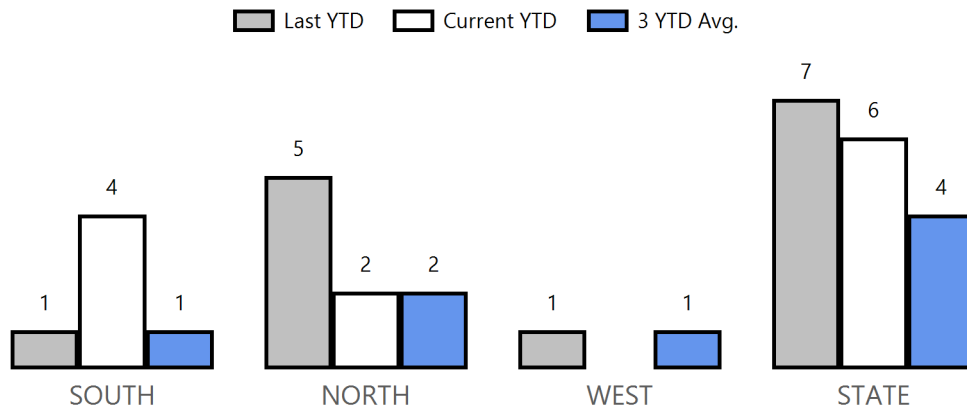

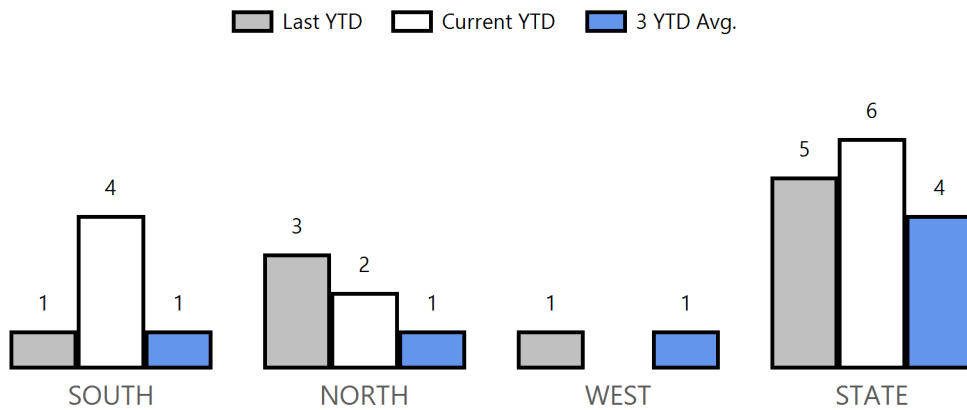
Road Crashes: Fatalities YTD - July 2022

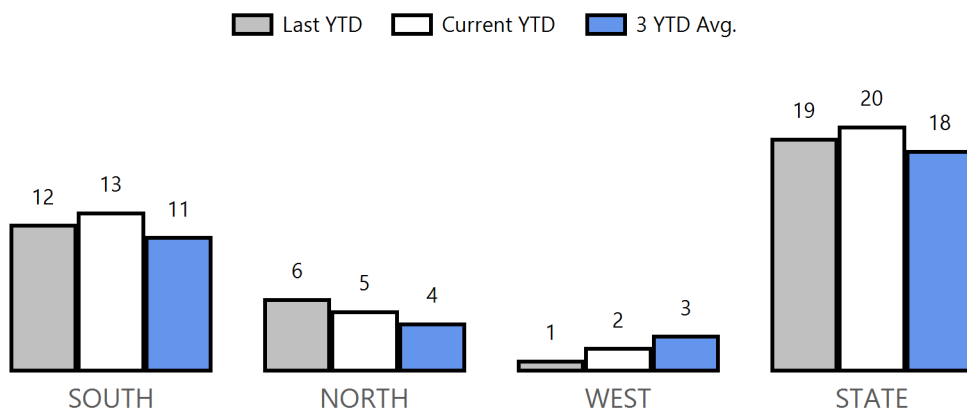
Fatal Crashes - July 2022

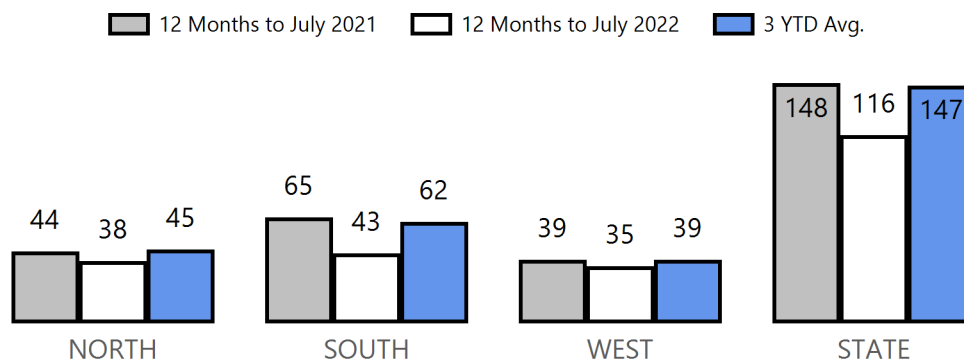

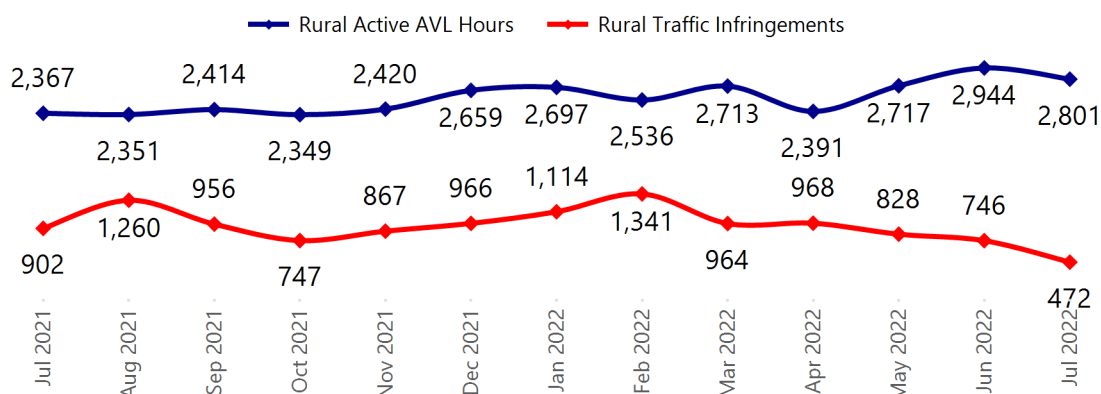
On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)



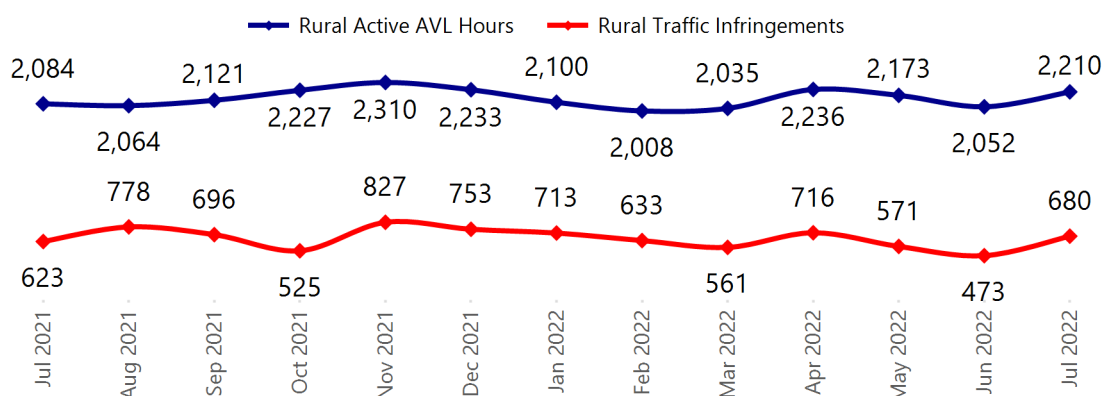

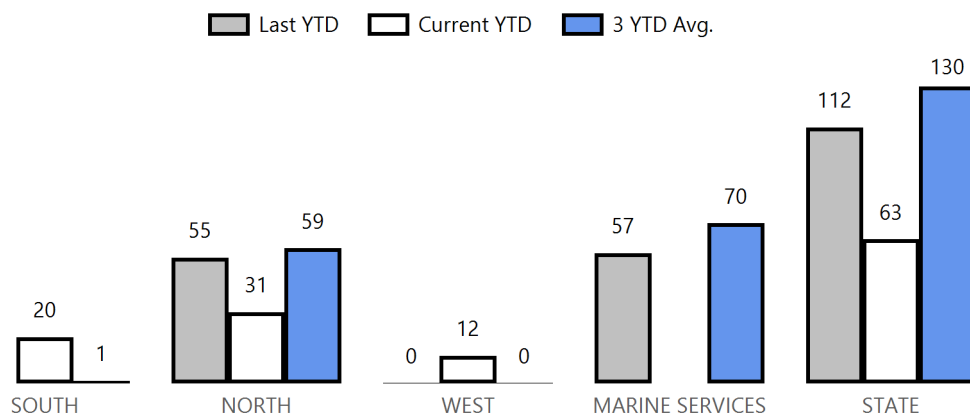

Sea Inspections (Vessel & Non-Vessel) - July 2022



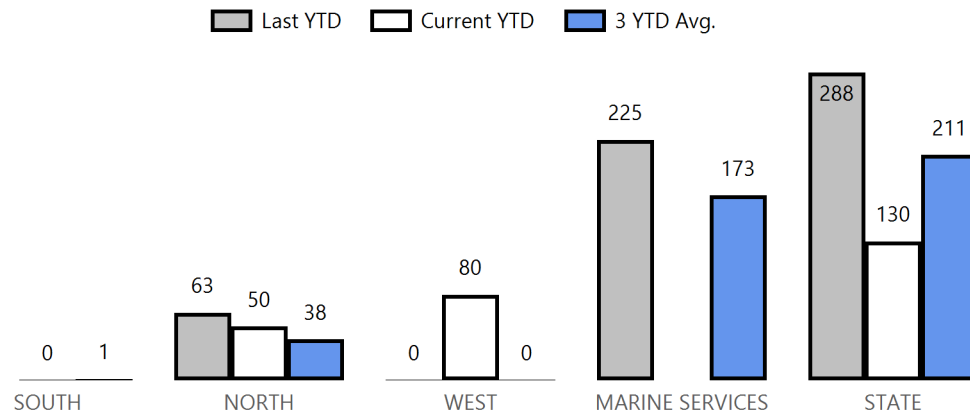
