Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 17 August 2021. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

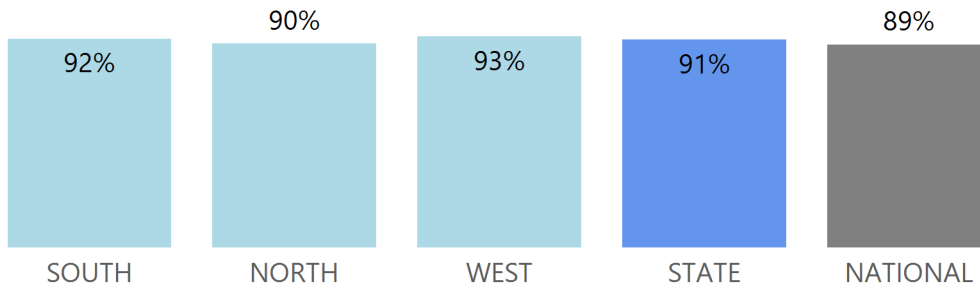

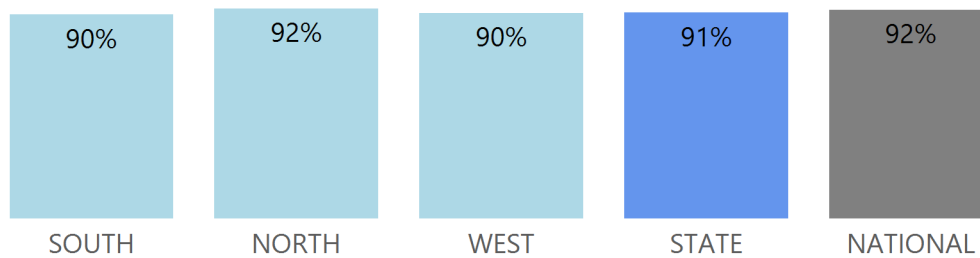

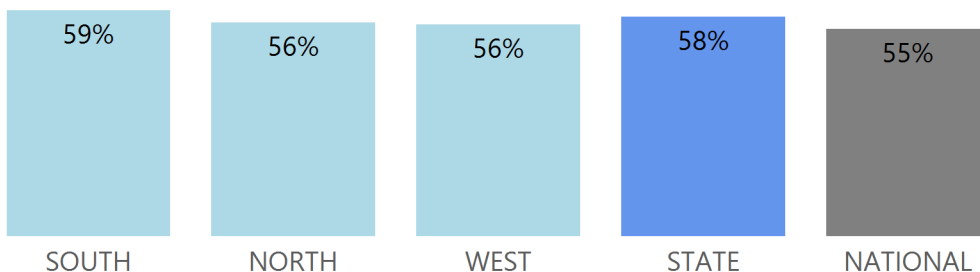
Public Safety - Out in Public Locally (Daytime)

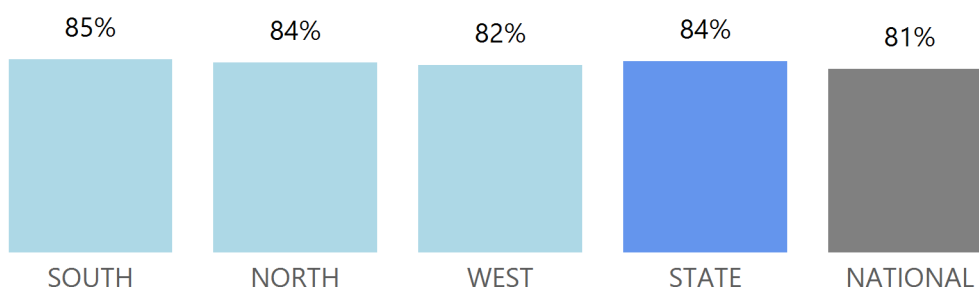

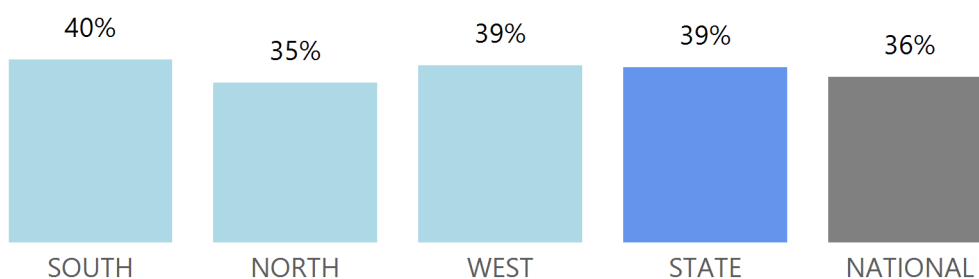
General Satisfaction with Police Services

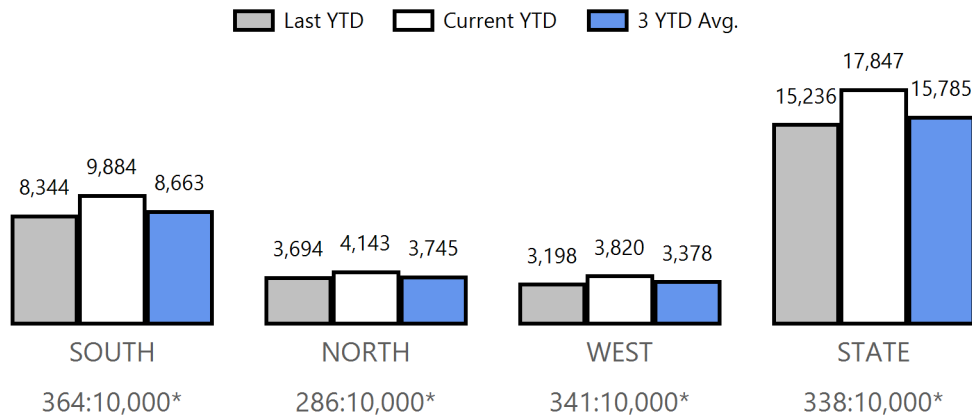
Satisfaction - Dealing with Public Order Problems

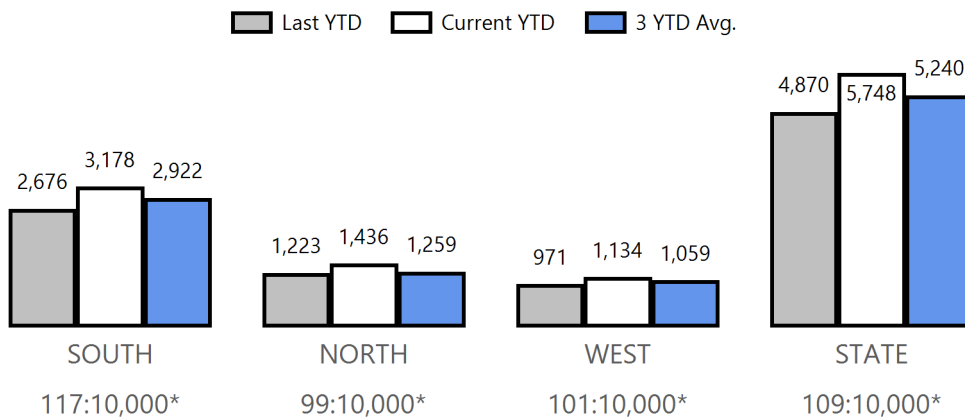
Public Order Incidents - June 2021

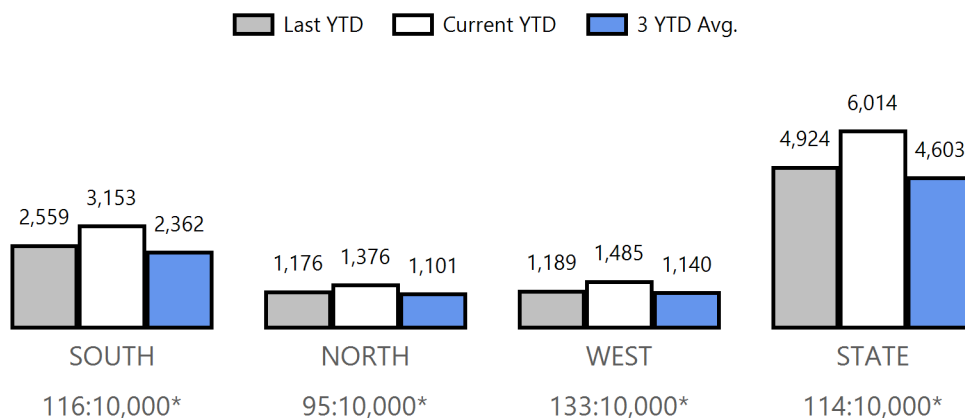
Public Order : Disturbance - June 2021

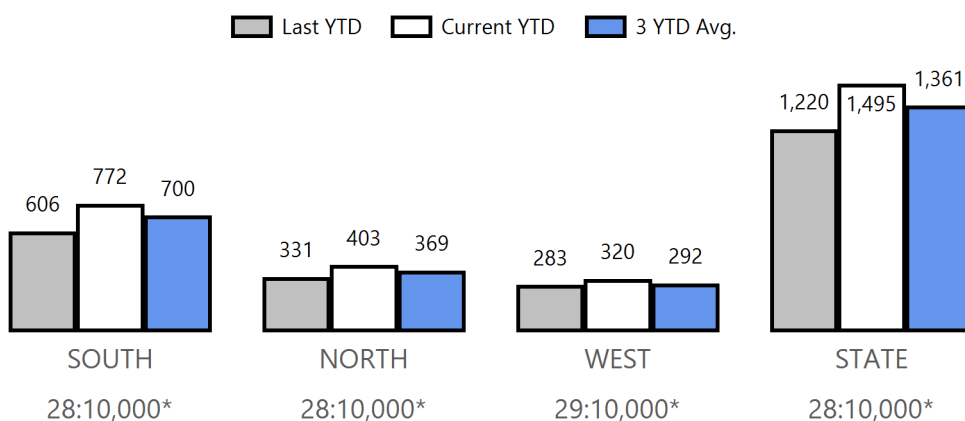
Public Order : Noise - June 2021

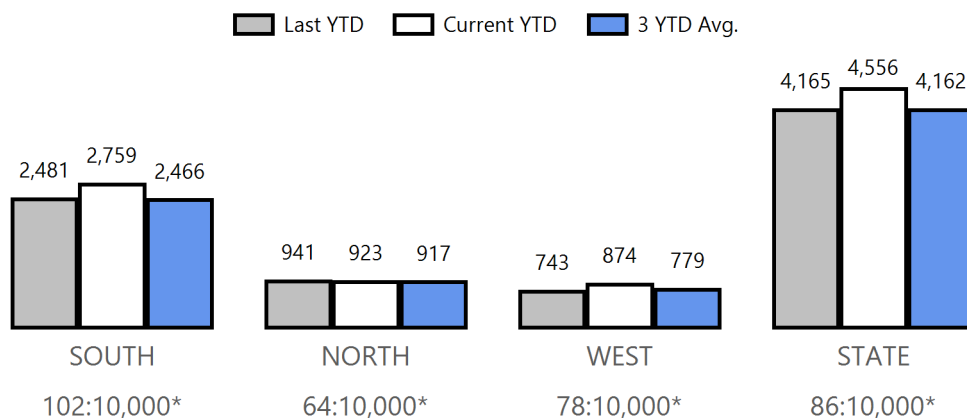
Public Order : Vandalism - June 2021

Public Order : Offensive Behaviour - June 2021

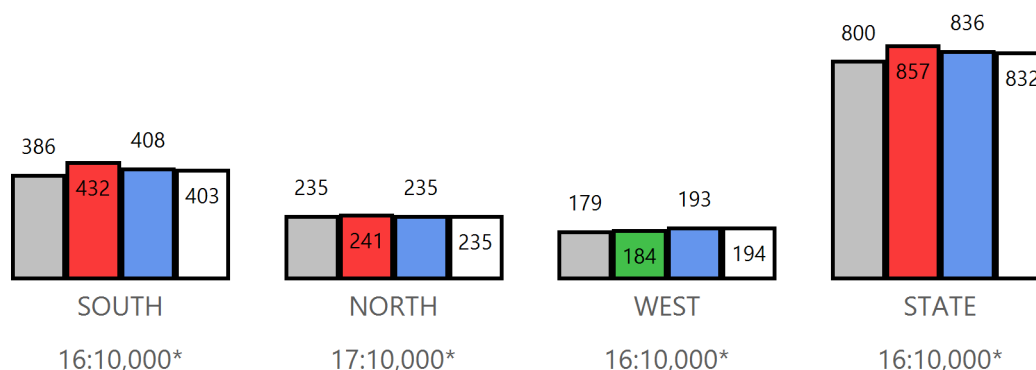

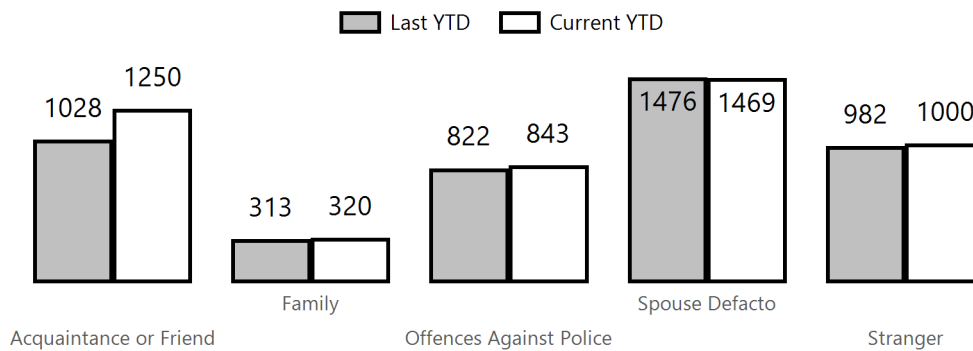

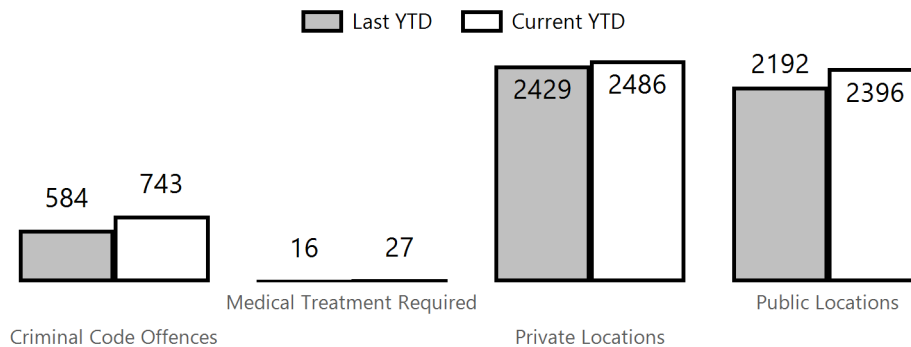

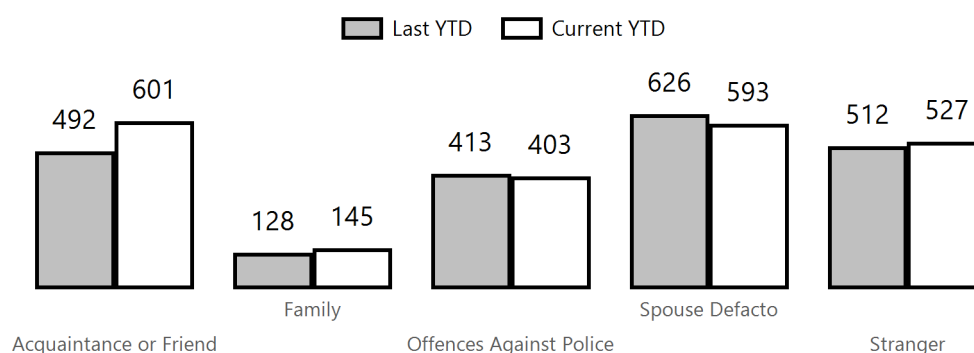

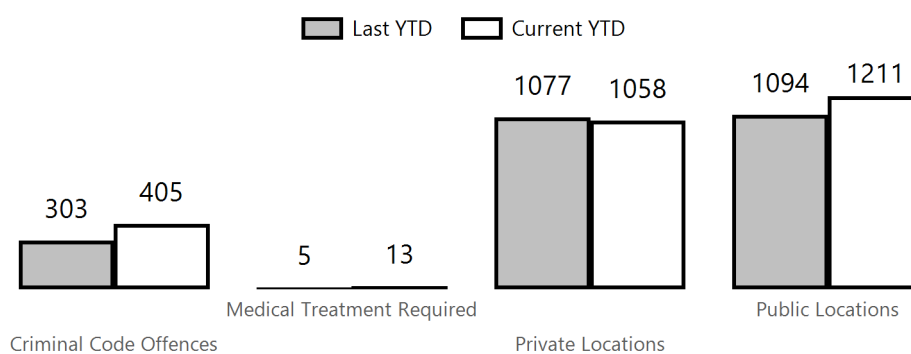

Total Person Offences - Victim Categories - SOUTH



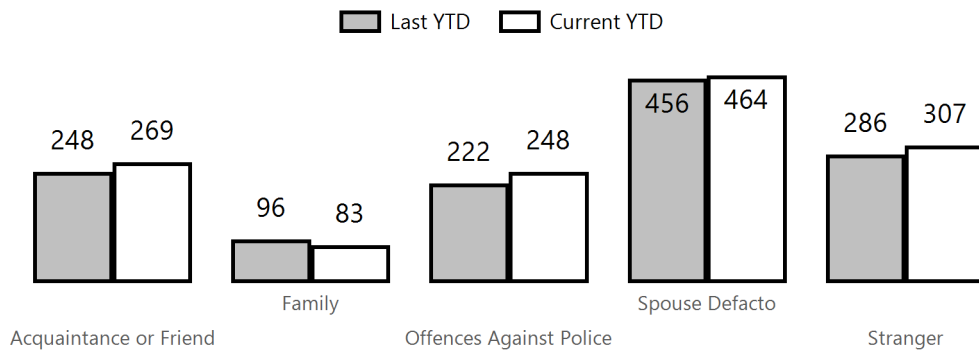

Total Person Offences - SOUTH



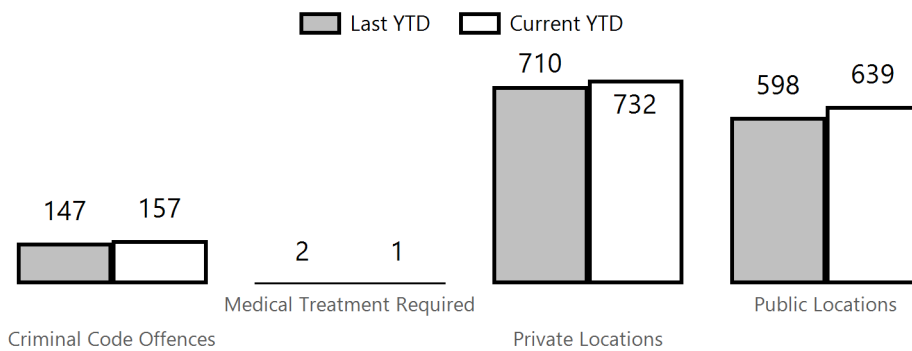

Total Person Offences - Victim Categories - NORTH



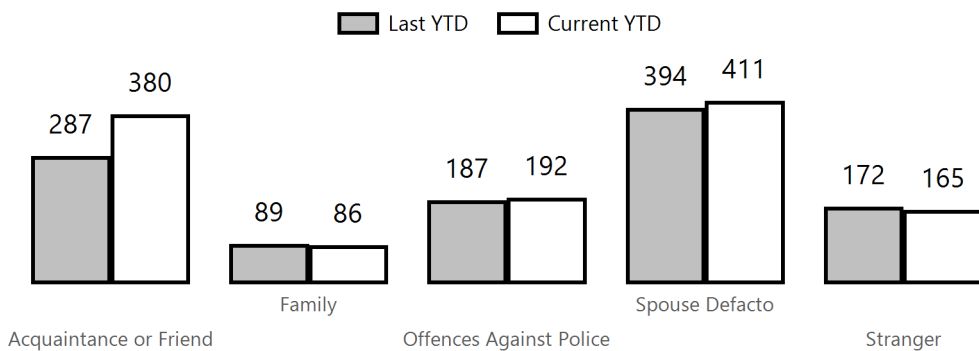

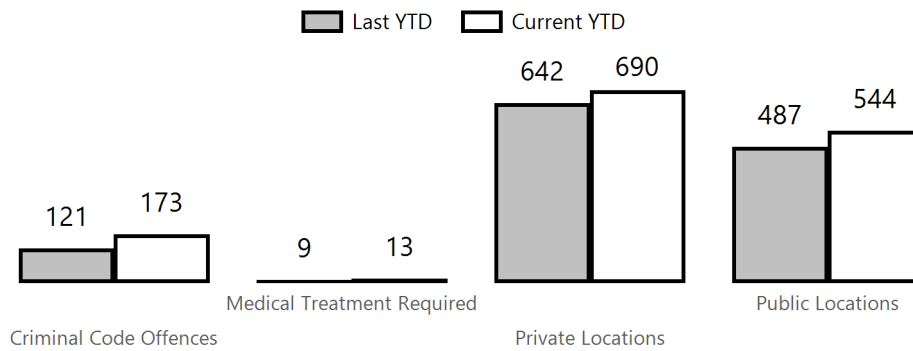

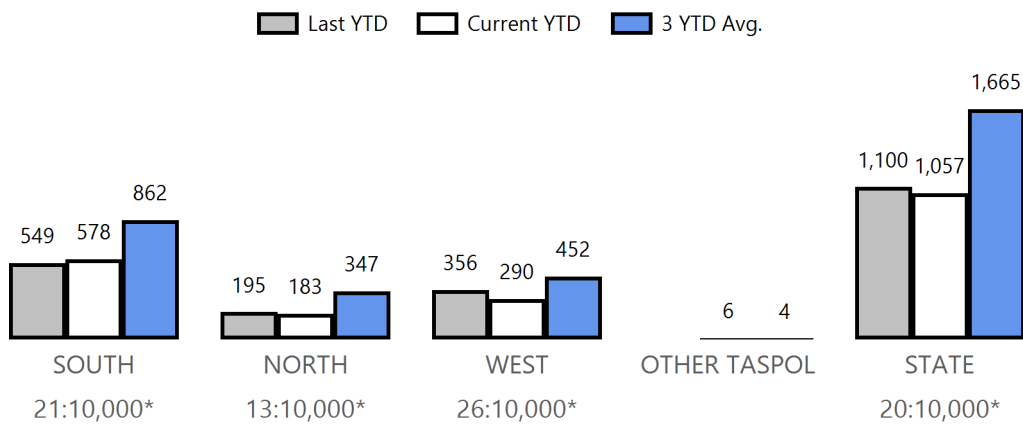

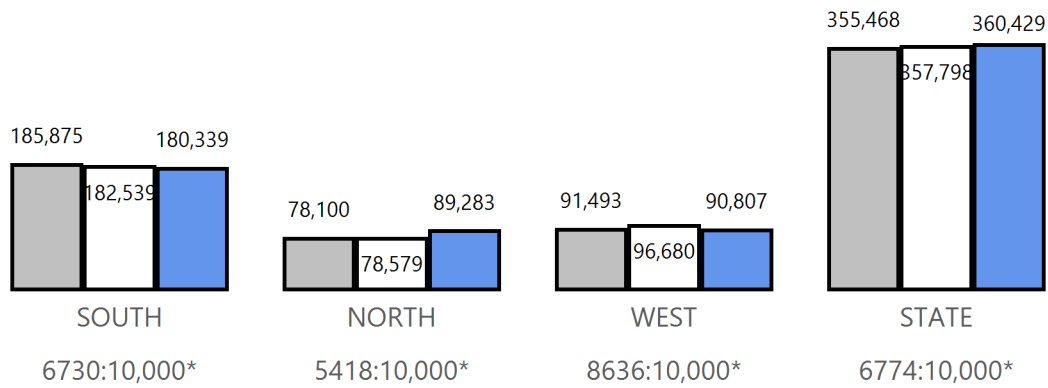

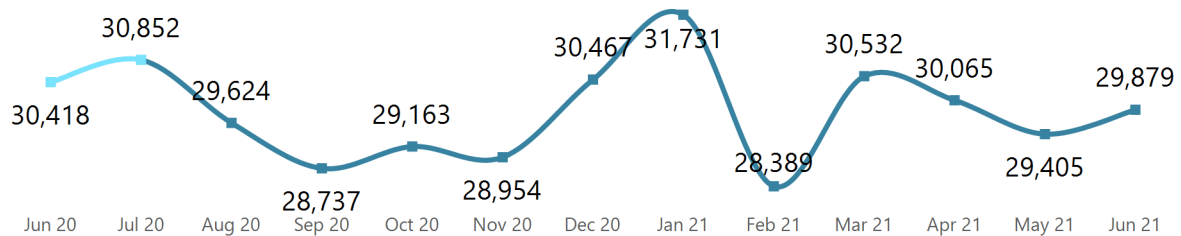
Total Uniform Police Patrol Hours - June 2021

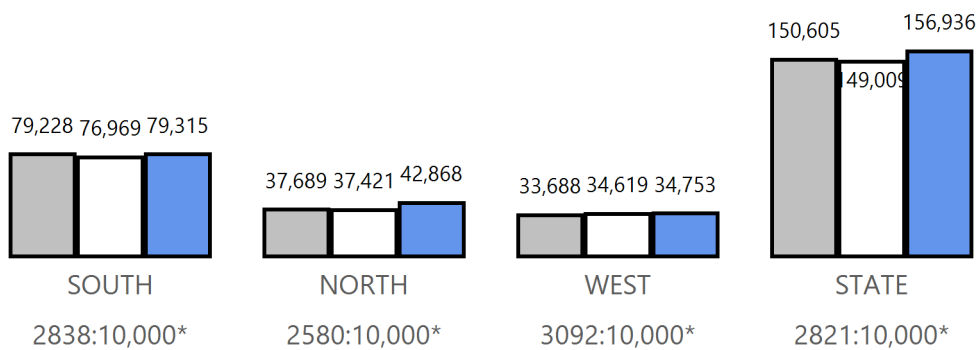
Uniform Police - Patrol Hours

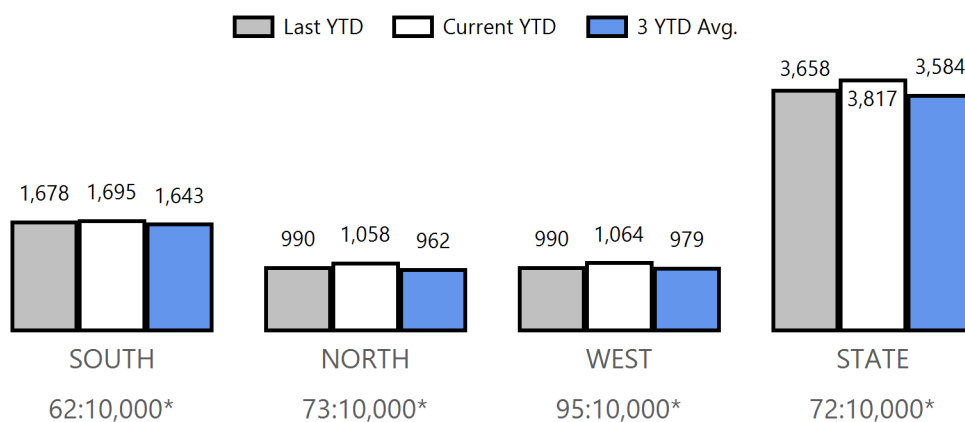

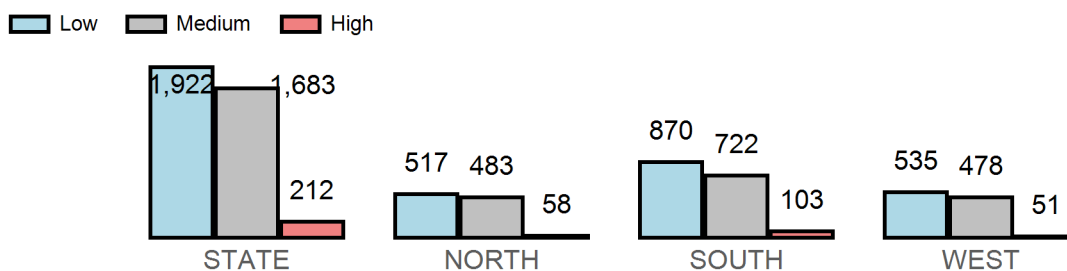
Family Violence Incidents - June 2021

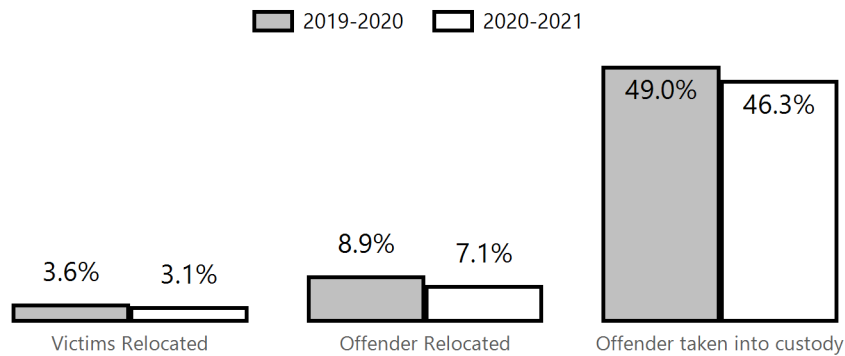

Family Violence RAST - Excludes Other and Argument Categories



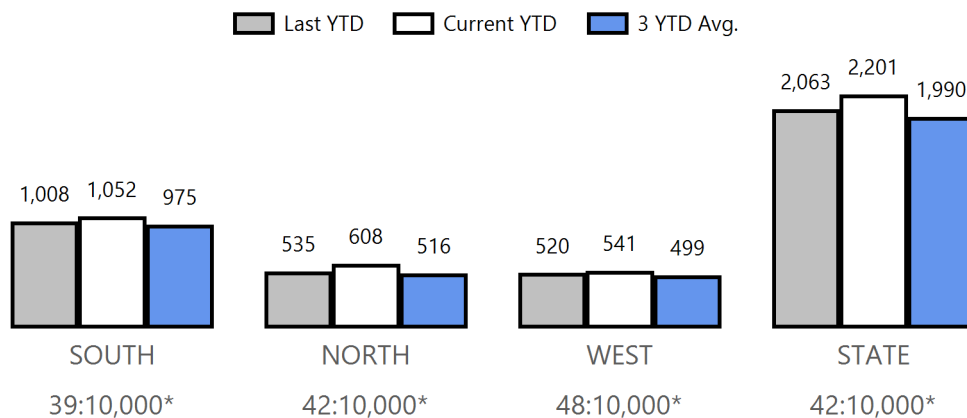

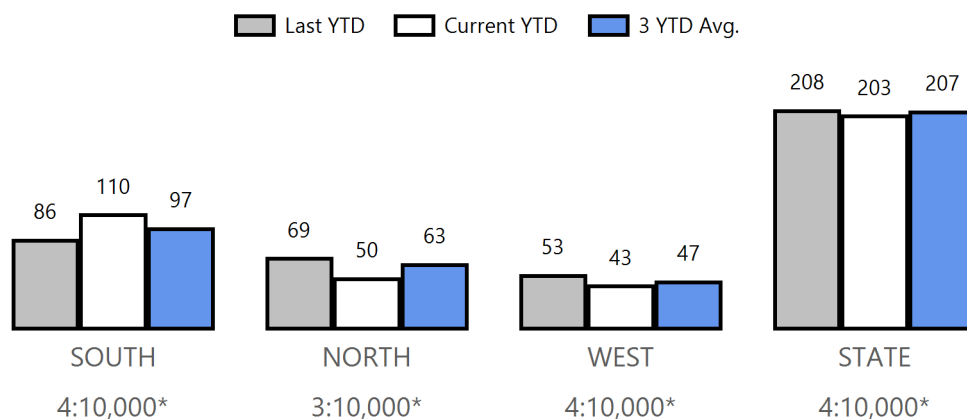
Family Violence : Juveniles Affected - June 2021

Family Violence : Weapons Present - June 2021



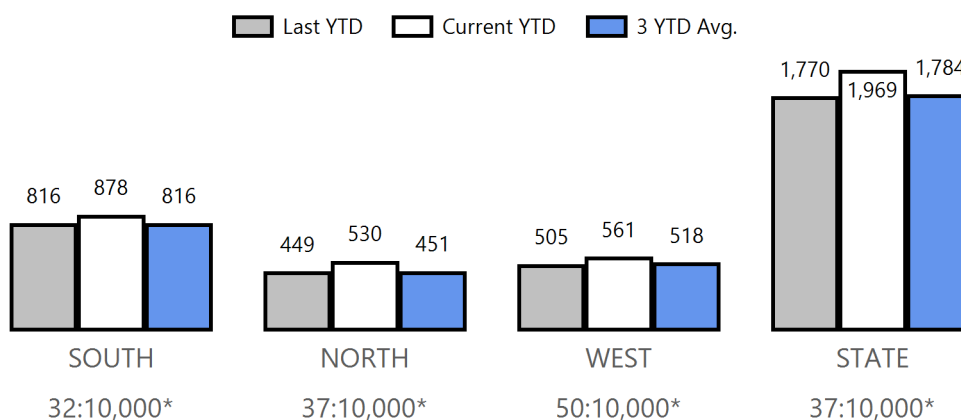

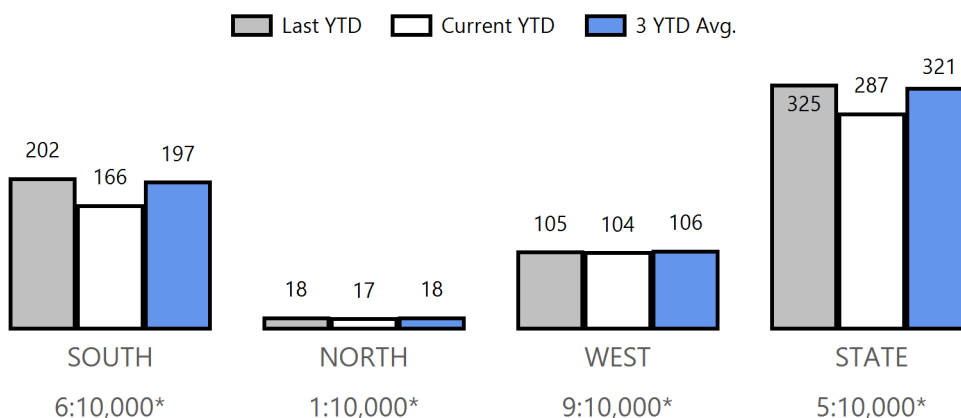
Family Violence Orders : Police Issued - June 2021

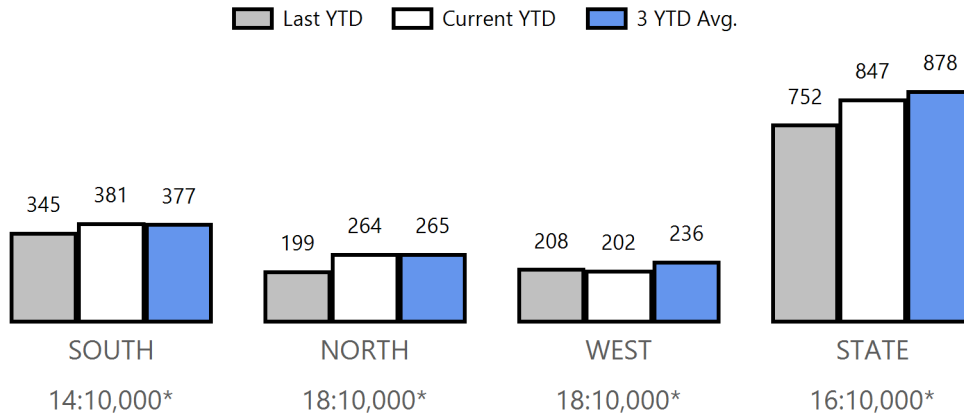
Family Violence Orders : Court Application - June 2021

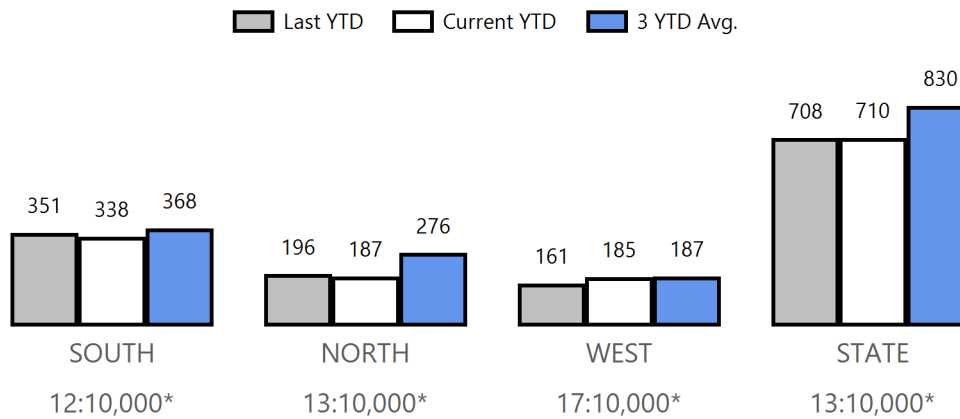
Family Violence - PFVO Breaches - June 2021

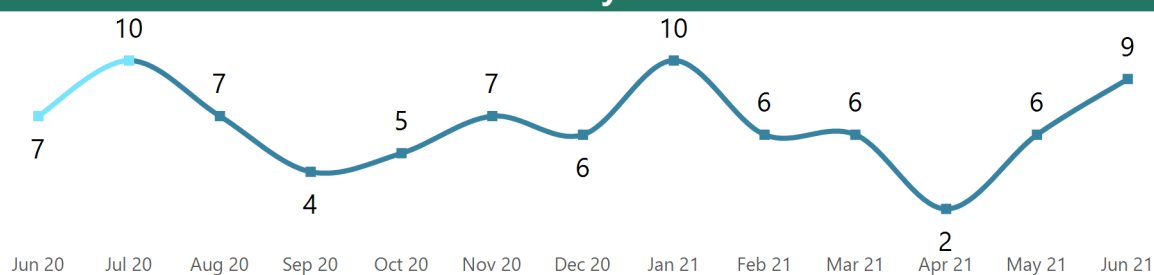

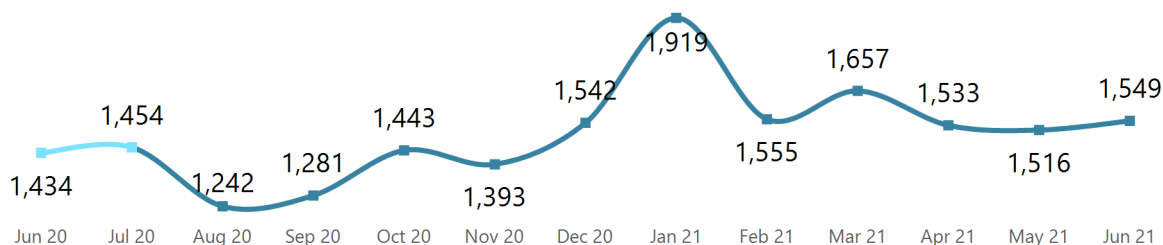

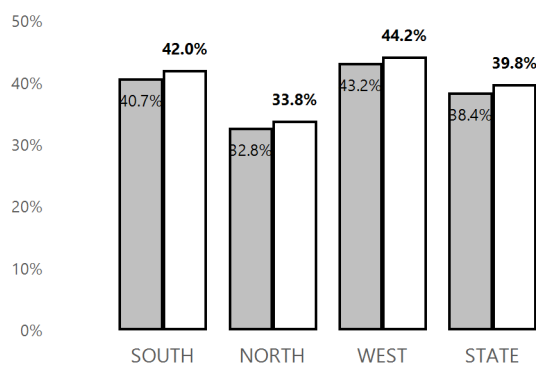

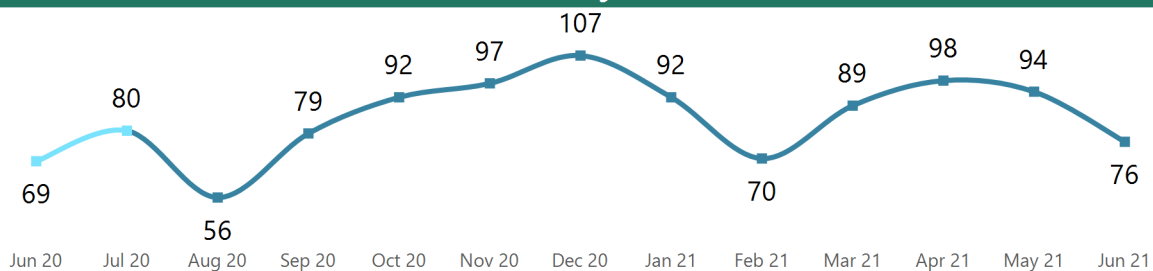

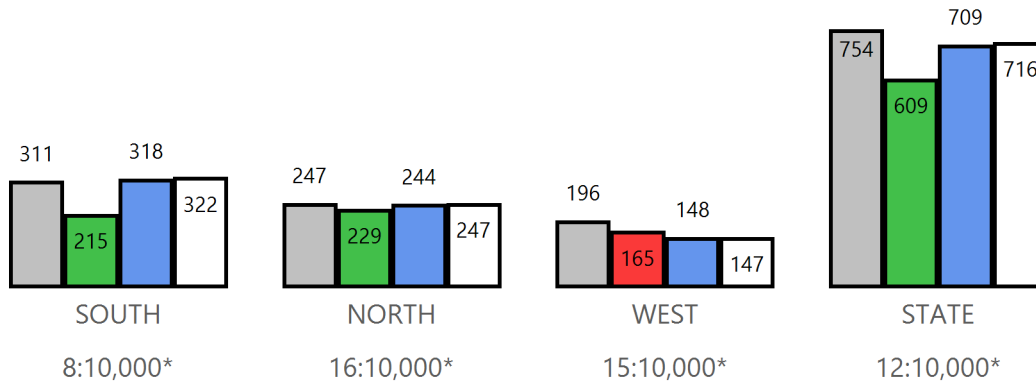

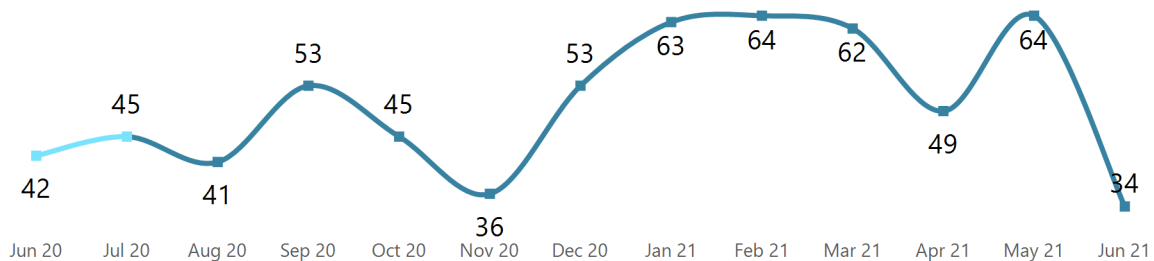

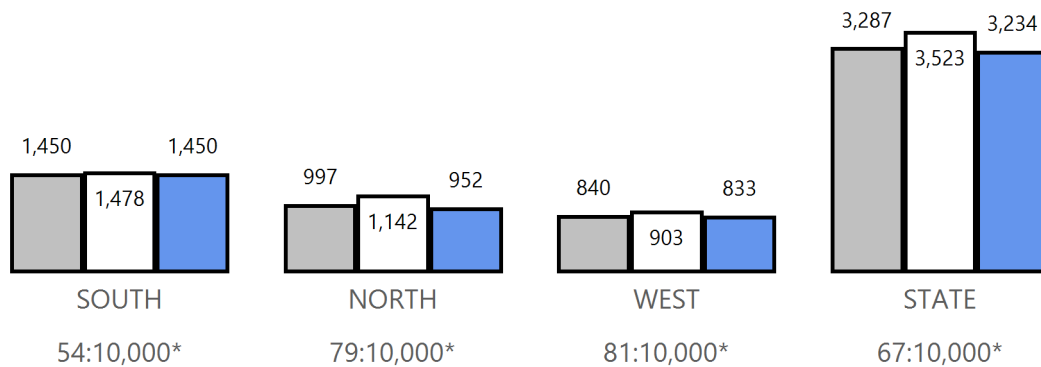

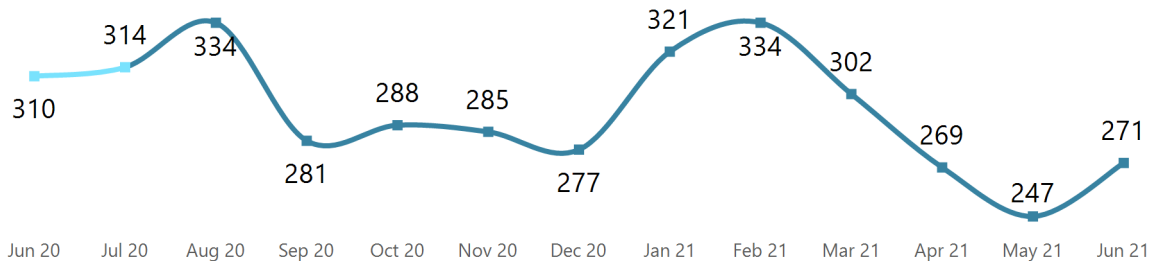

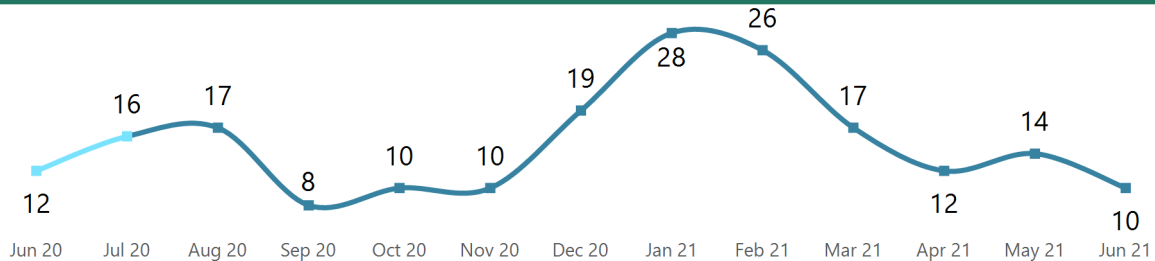
SMV : Fire Damaged - June 2021

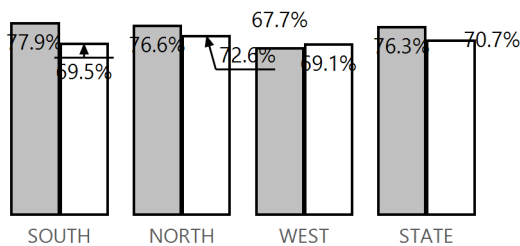

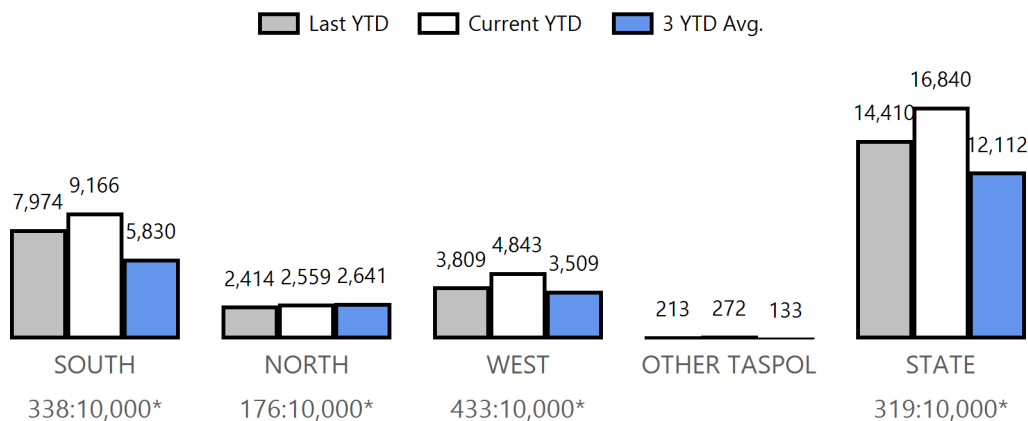

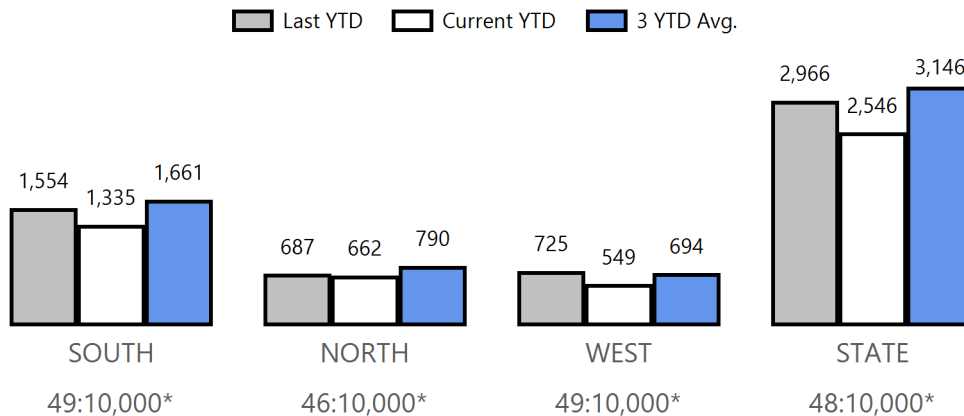
Total Street Checks - June 2021

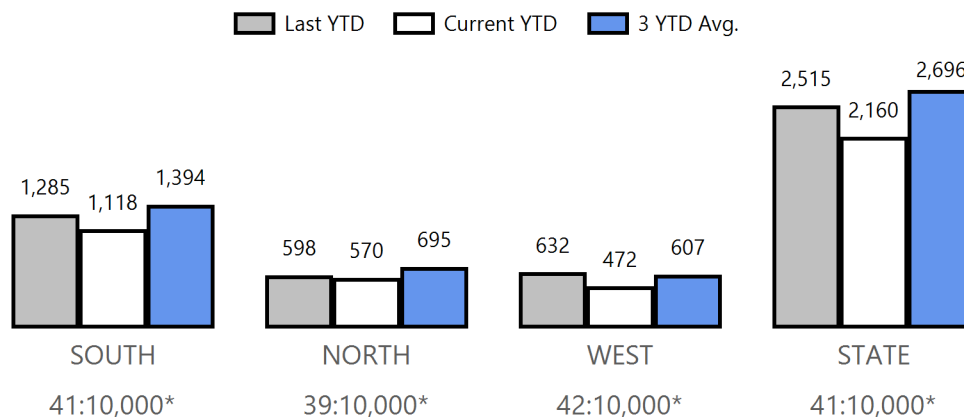
CIB: Total Offenders - June 2021

CIB: Total Crime Offenders - June 2021



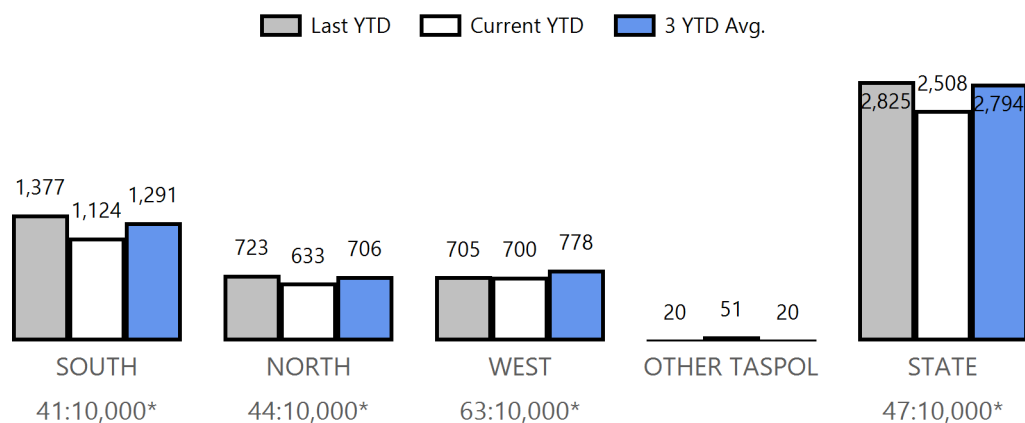

Total Drug Offenders - June 2021



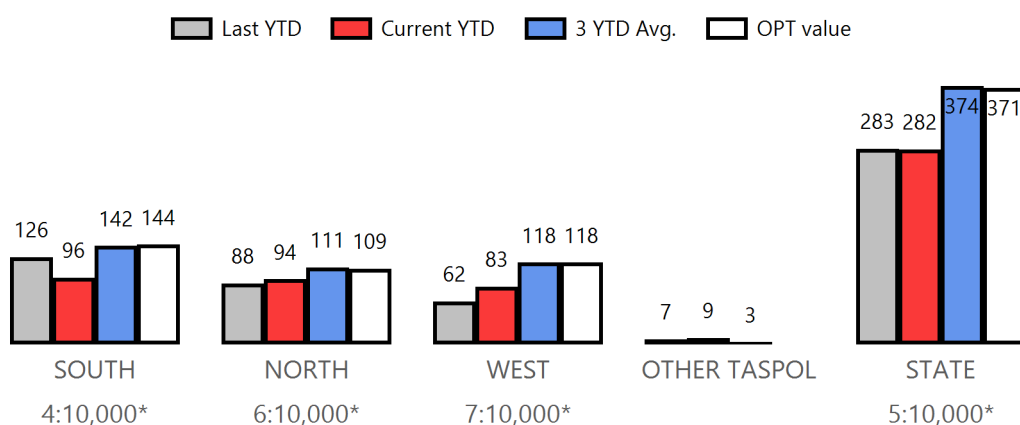

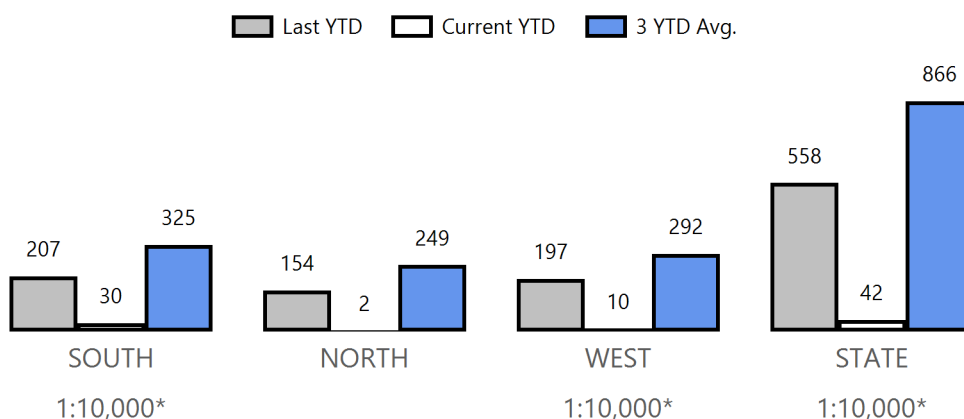
Major Traffic Operations - June 2021

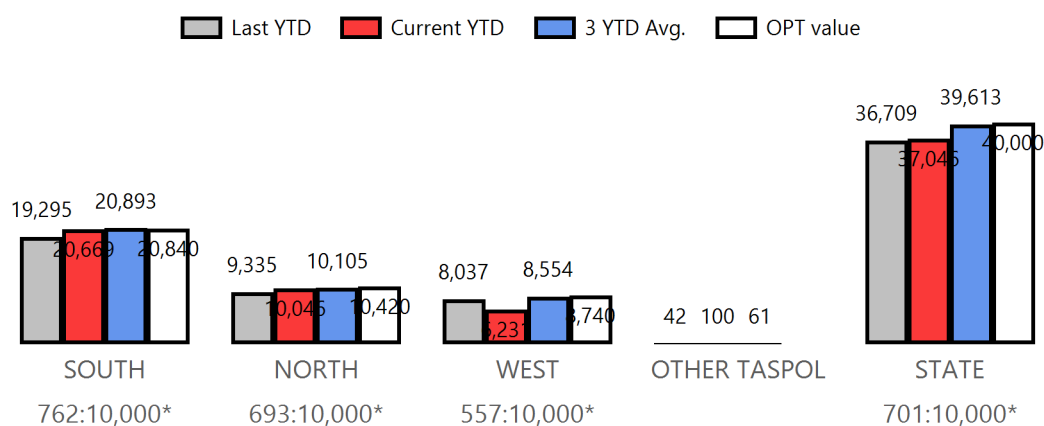

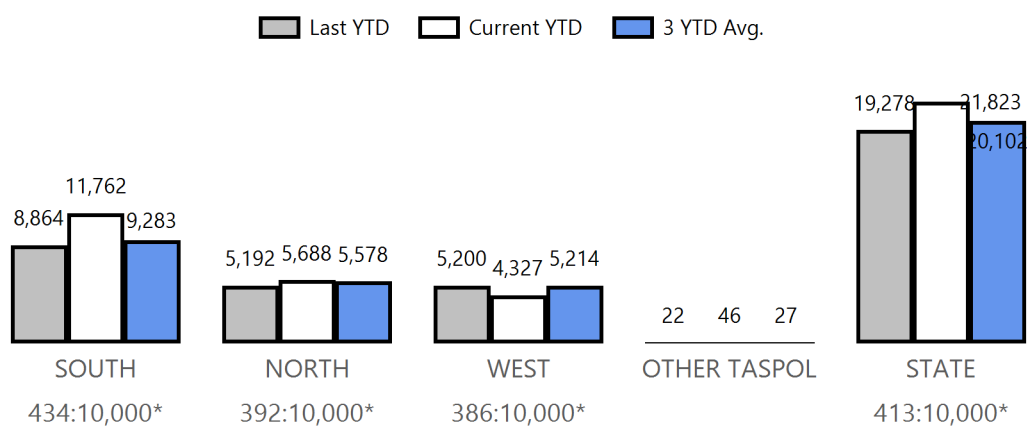
Speeding Offenders - June 2021

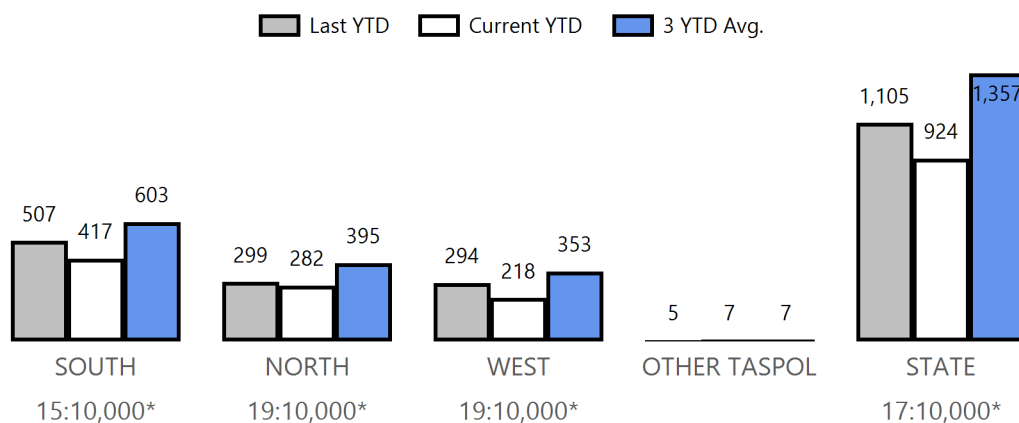
Excessive Speed Offenders - 15-29km/h - June 2021

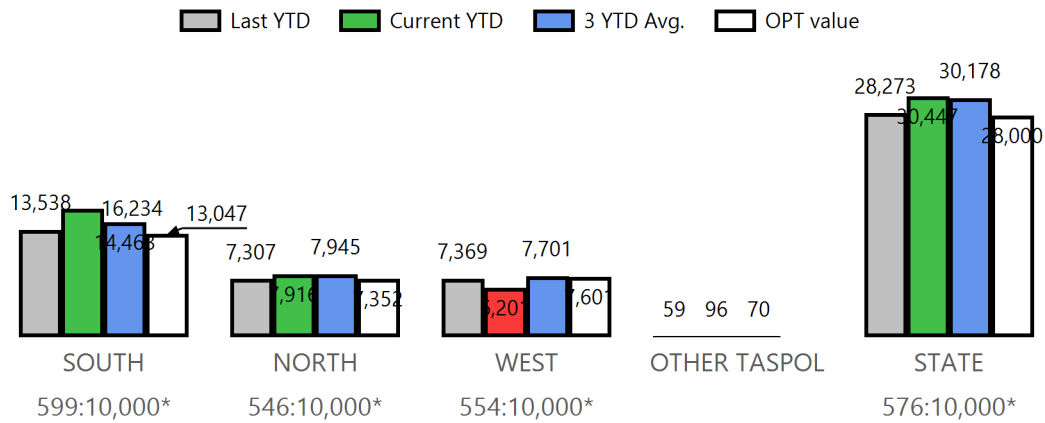
Excessive Speed Offenders - 30km/h + - June 2021

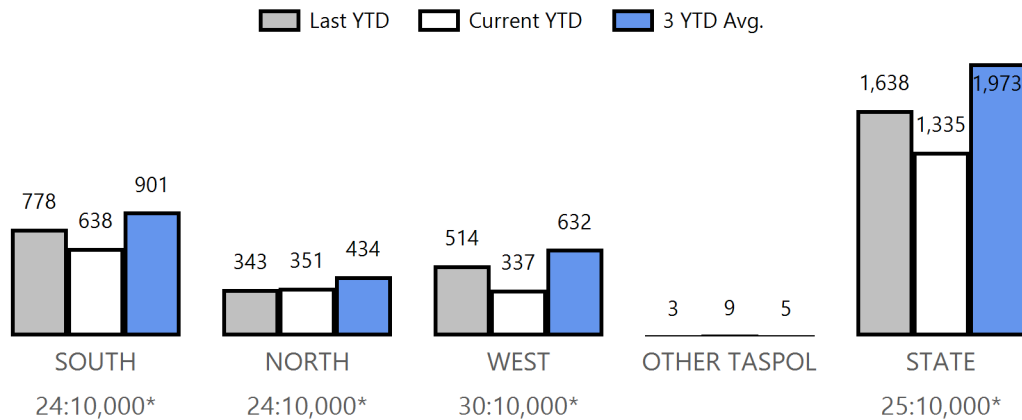
High Risk Offenders - June 2021

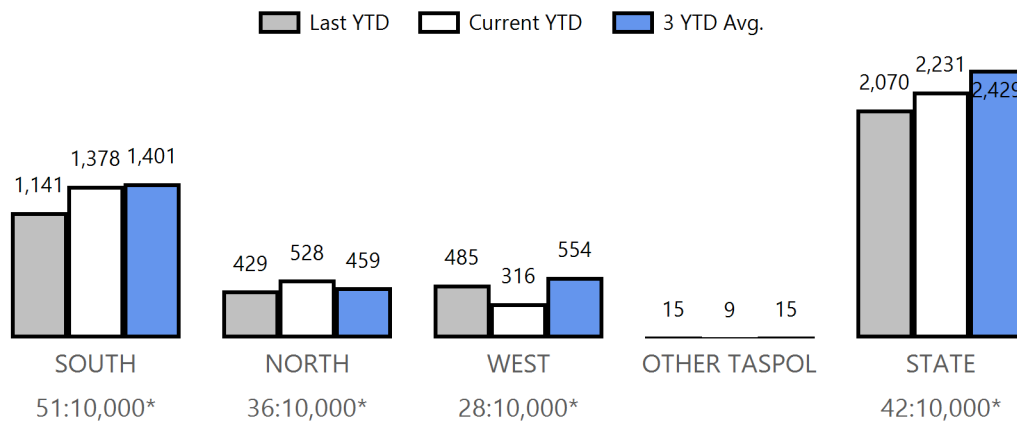
Seatbelt Compliance Offenders - June 2021

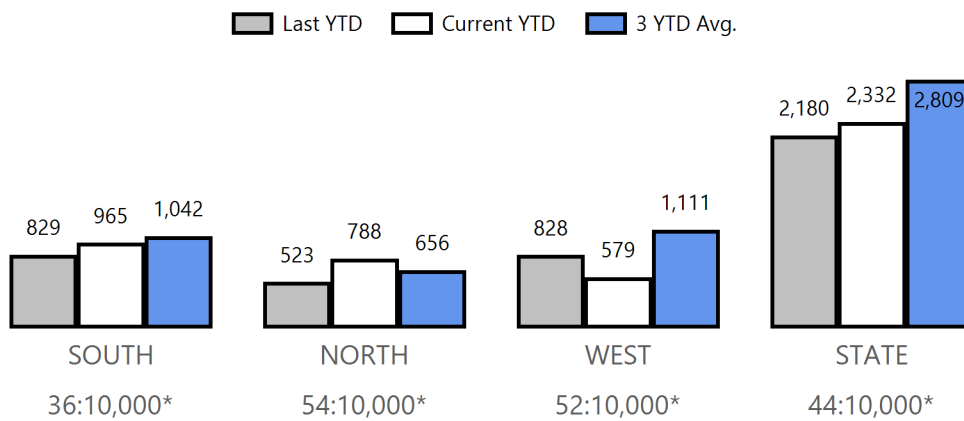
Mobile Phone Offenders - June 2021

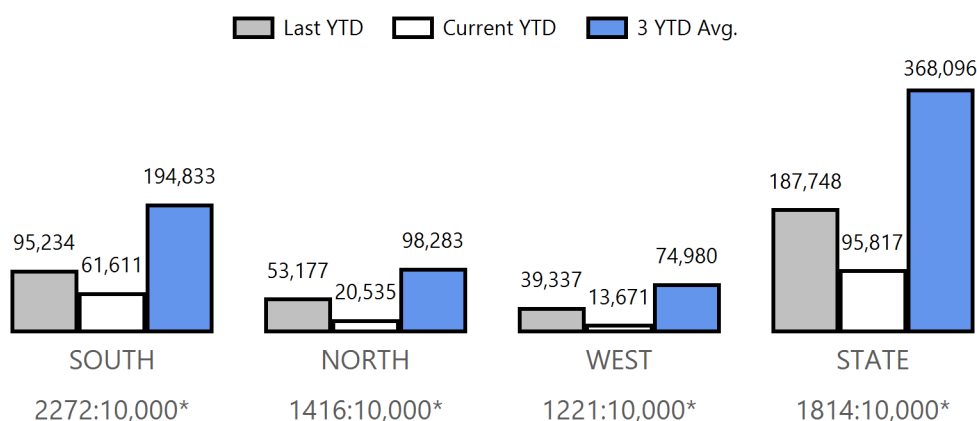
Vehicle Defect Notices - June 2021

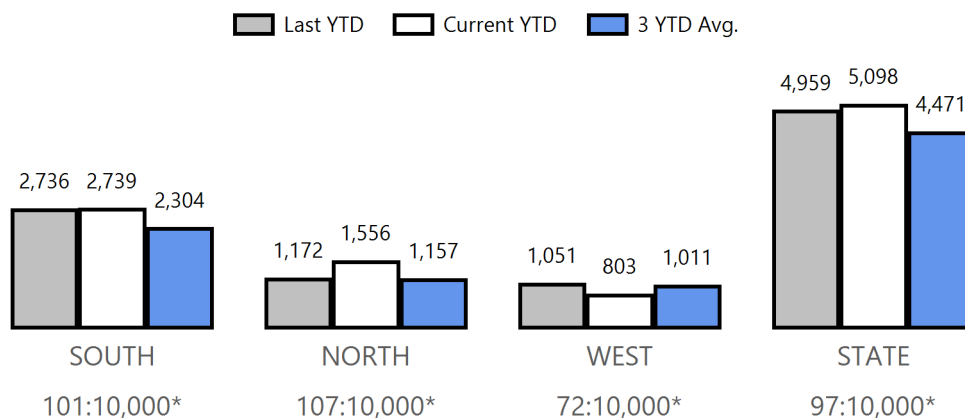
Random Breath Tests (ALCOHOL) - June 2021

Oral Fluid Tests (Drugs) - June 2021



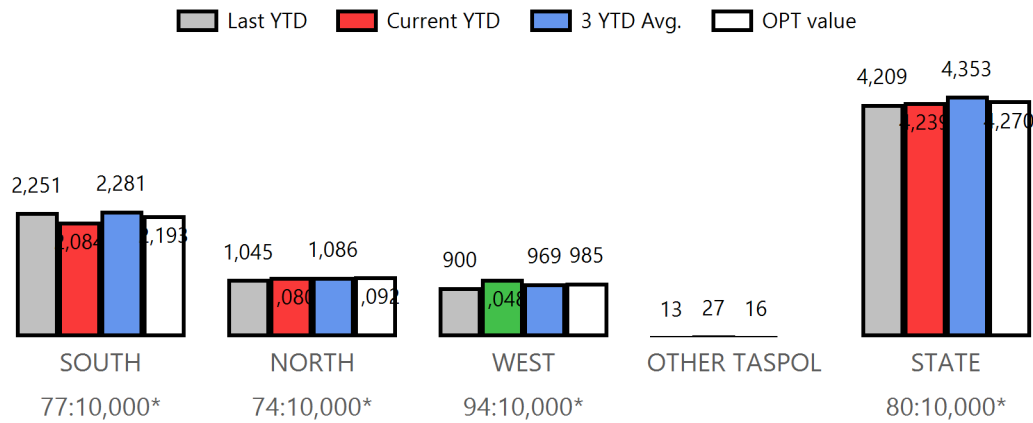

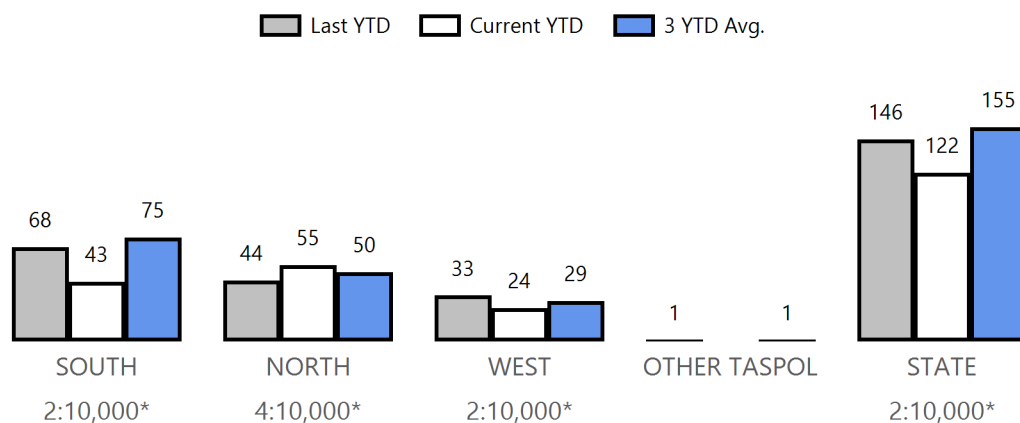

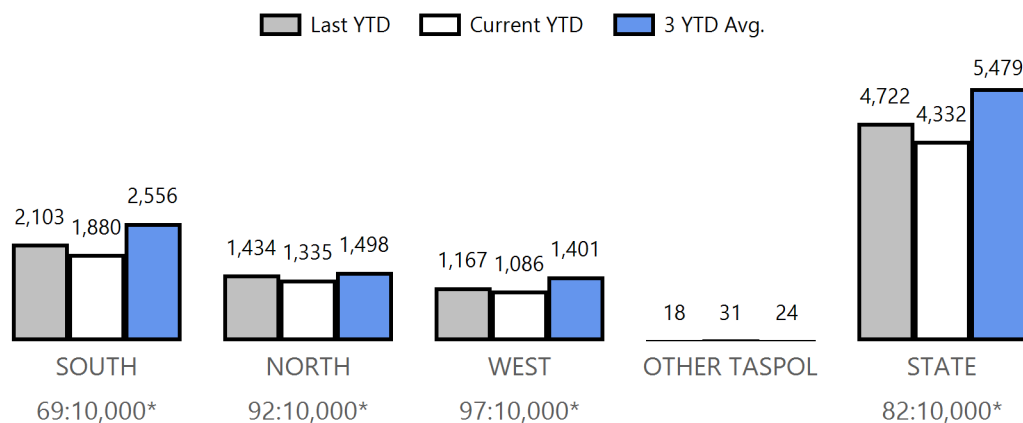
Dangerous and Reckless Driving Offenders - June 2021

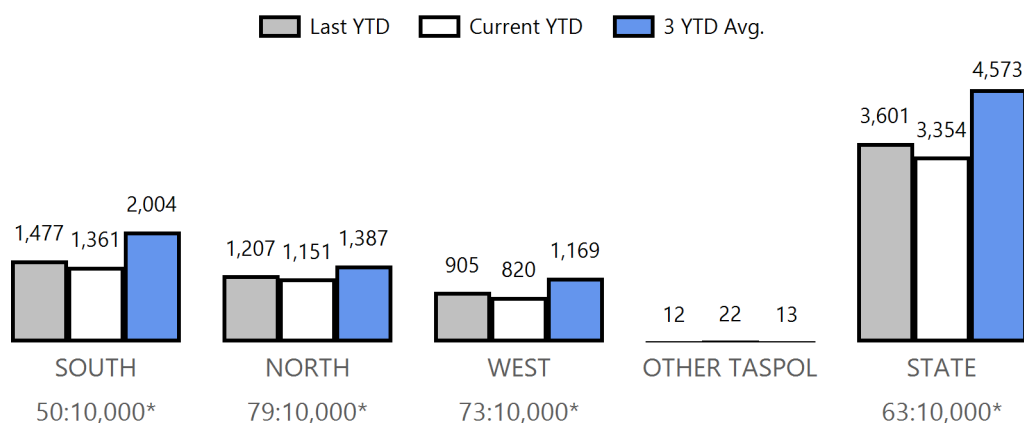

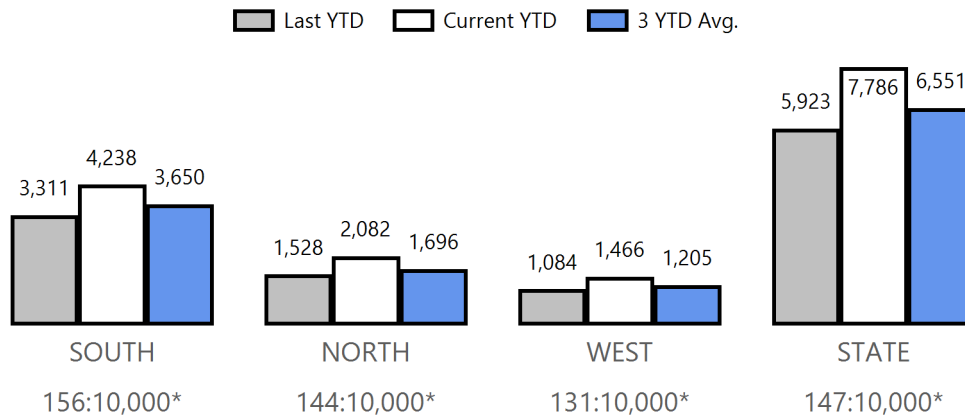

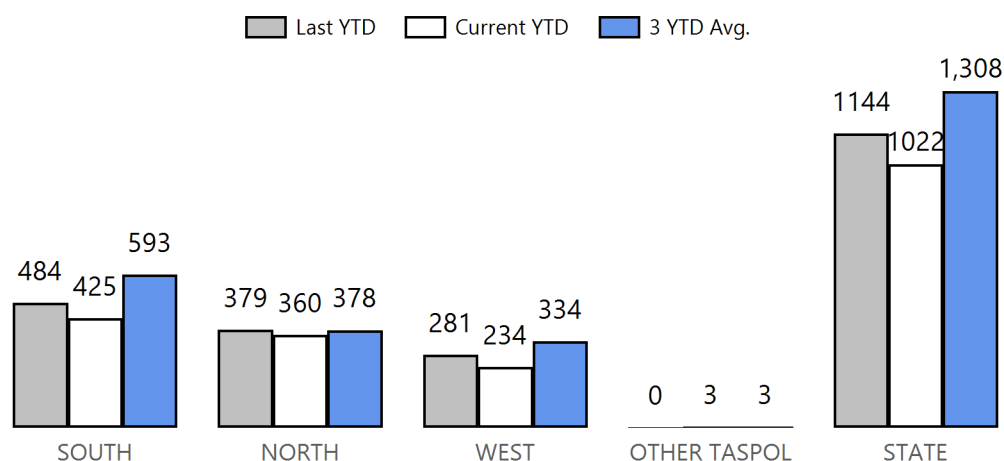
Vehicle Complaints made to RDS - June 2021

Vehicles Clamped or Confiscated - June 2021



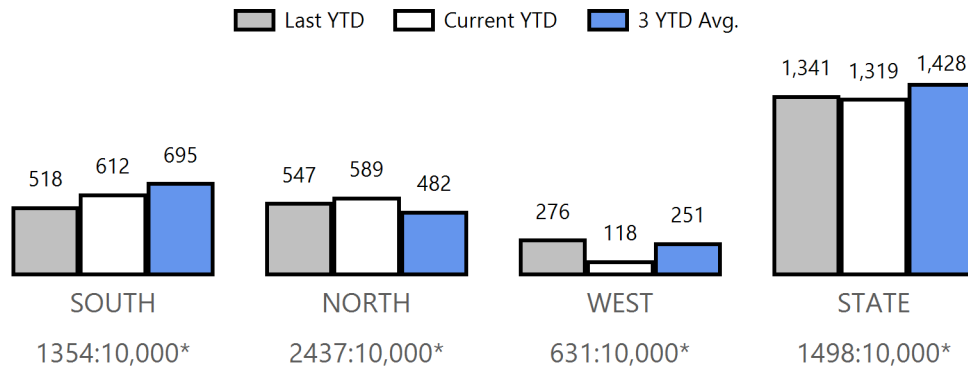

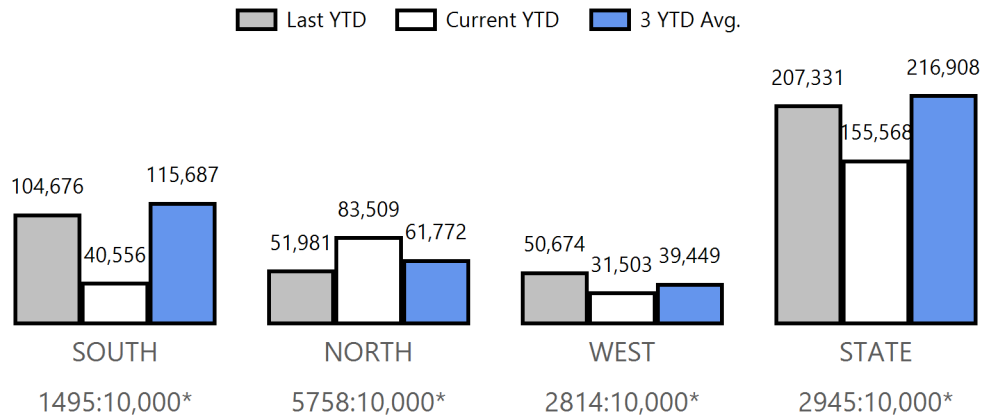
Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - June 2021

ANPR: Total Vehicles Captured - June 2021



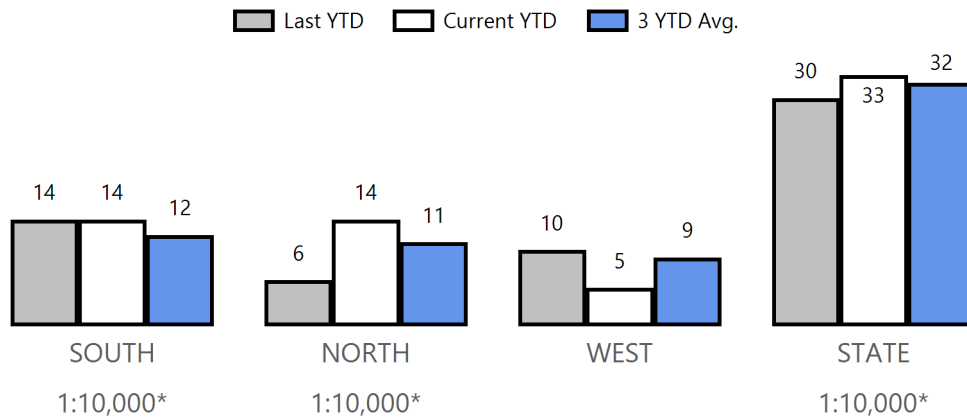

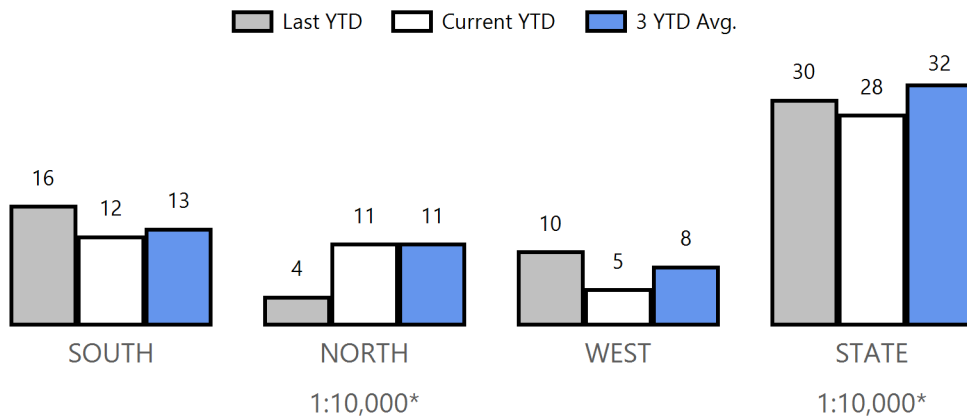

Road Crashes: Fatalities YTD - June 2021



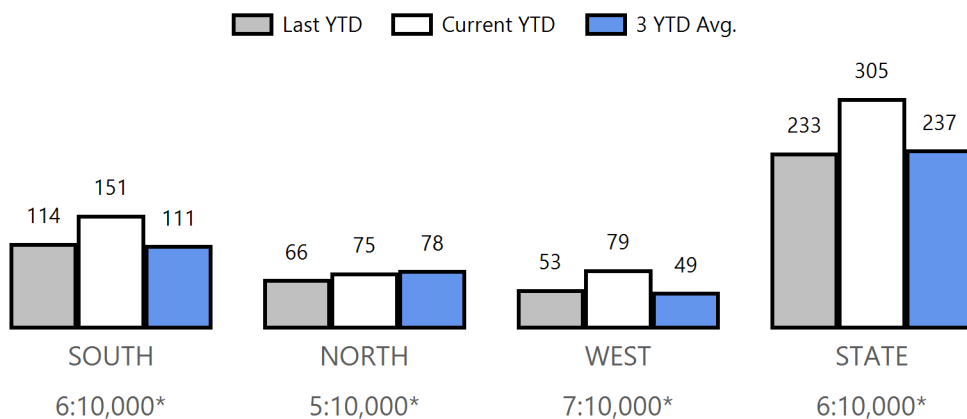

Serious Crashes - June 2021



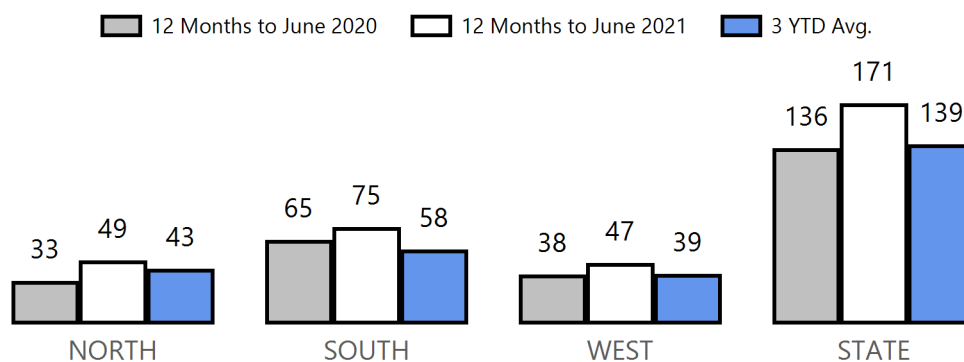

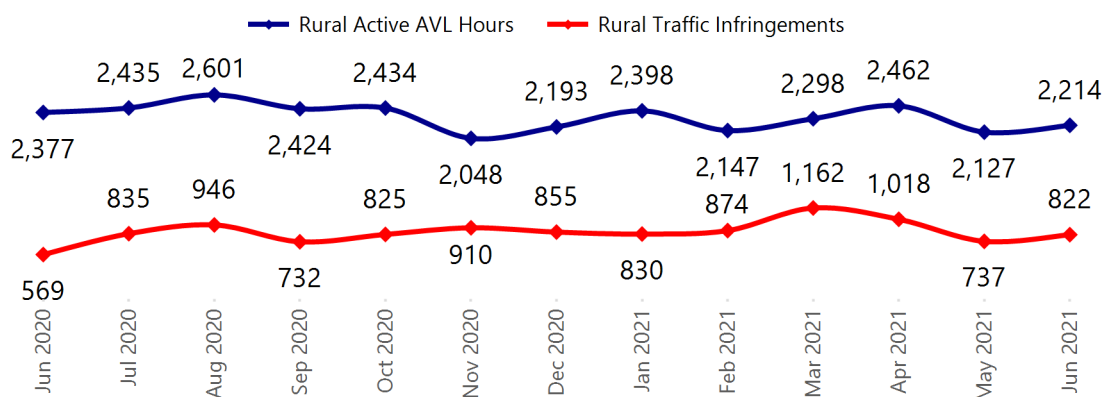
On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)



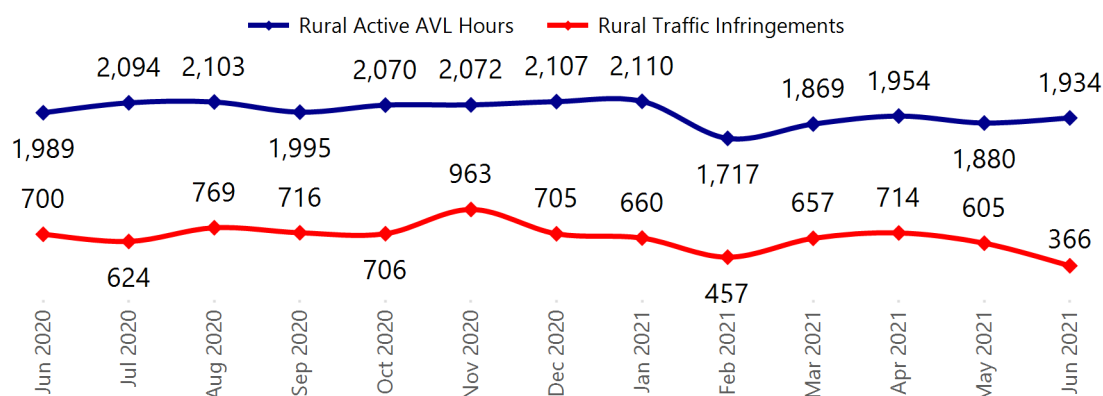

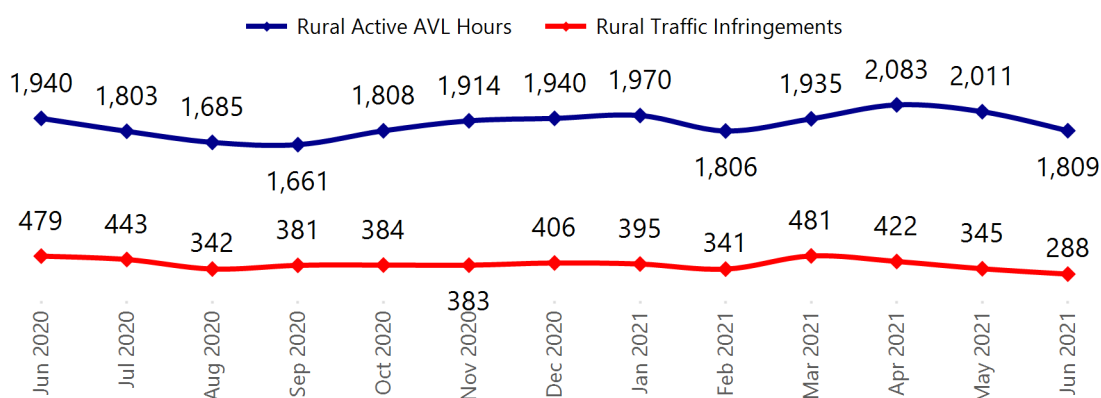
Southern District Rural Policing



Northern District Rural Policing

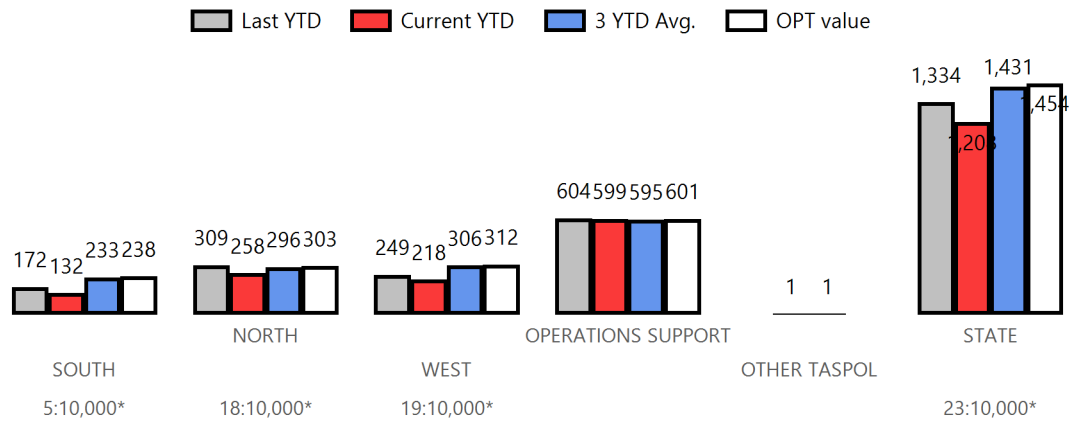

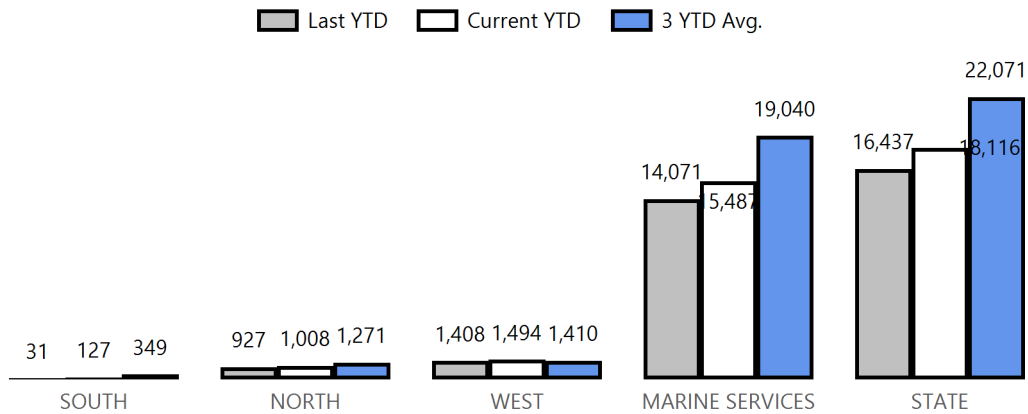

Marine Offenders - June 2021



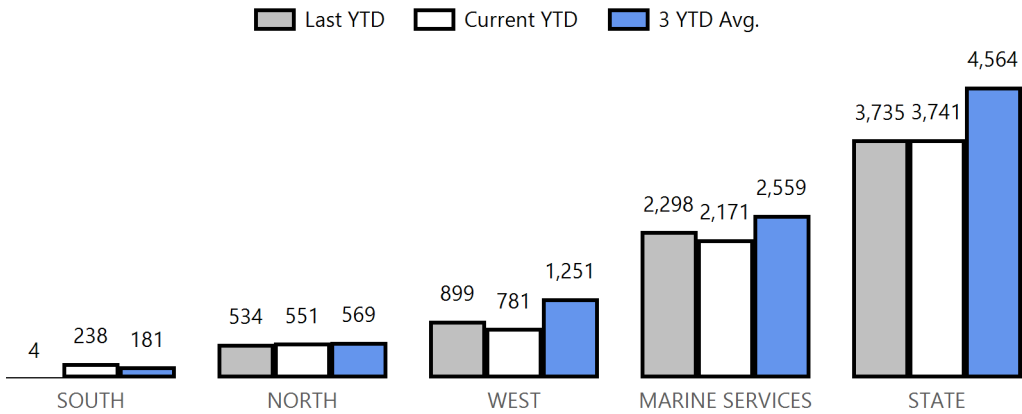

Sea Inspections (Vessel & Non-Vessel) - June 2021



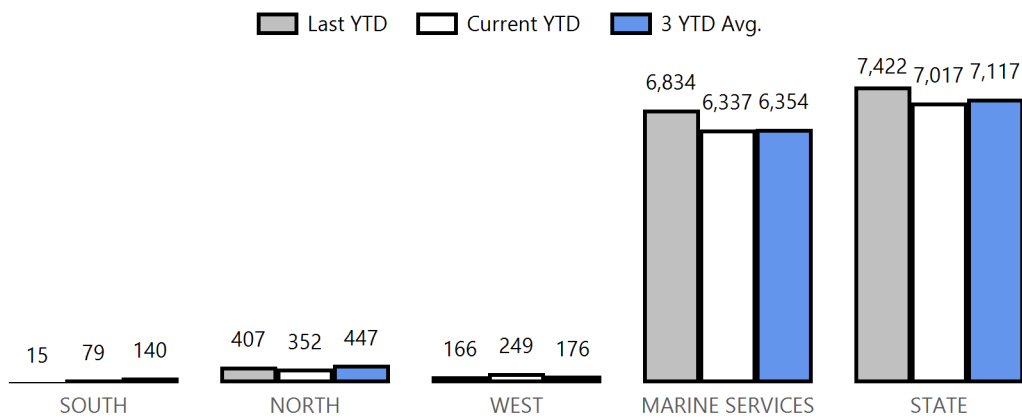
