Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 10 May 2023. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

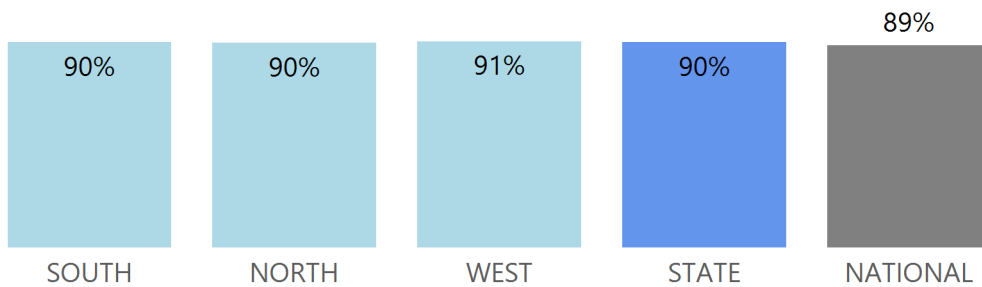

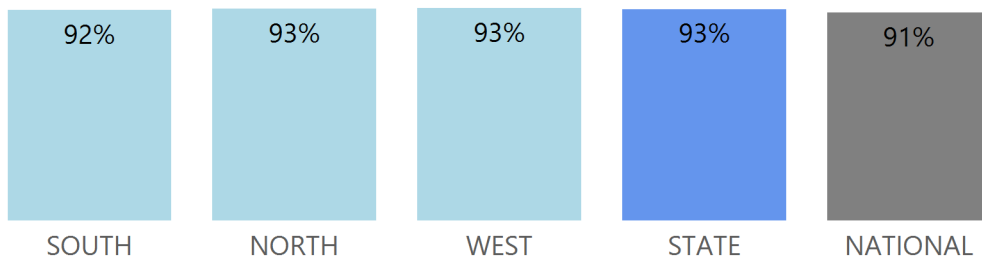

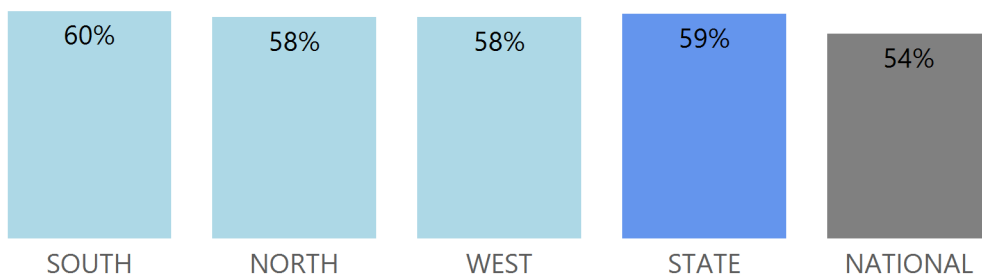
Public Safety - Out in Public Locally (Daytime)

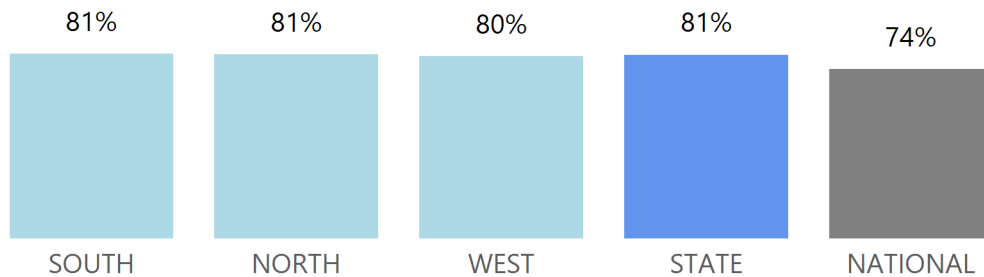

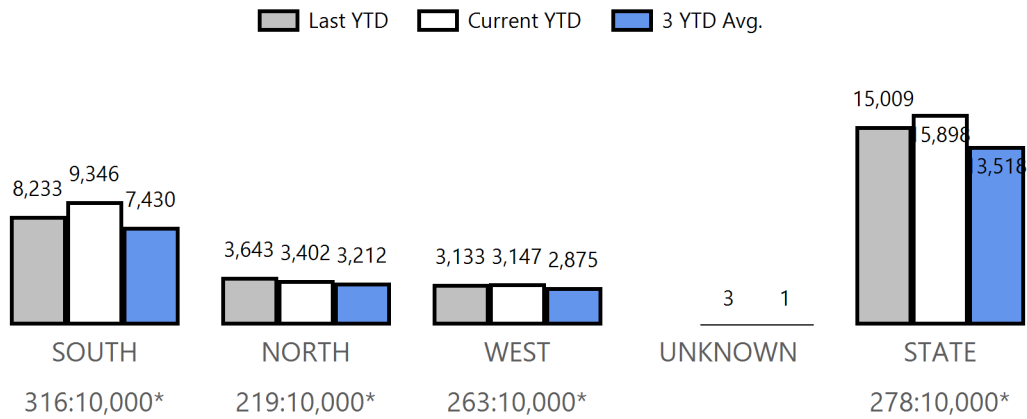

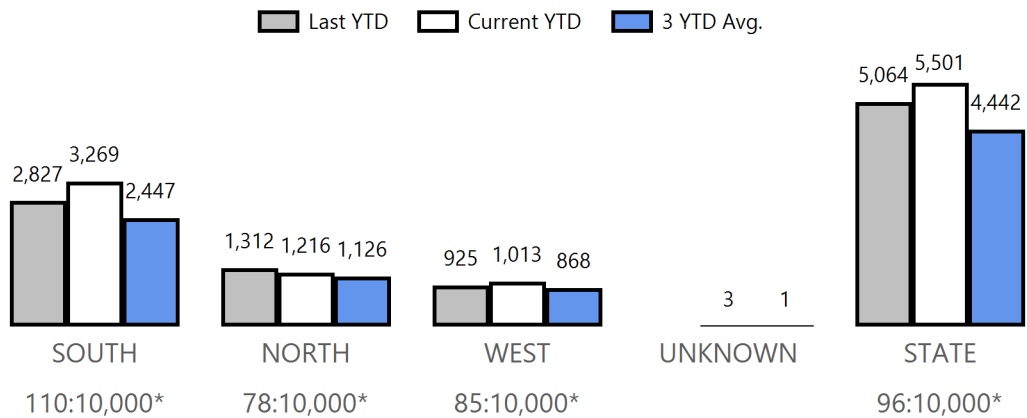
Public Order Incidents - March 2023

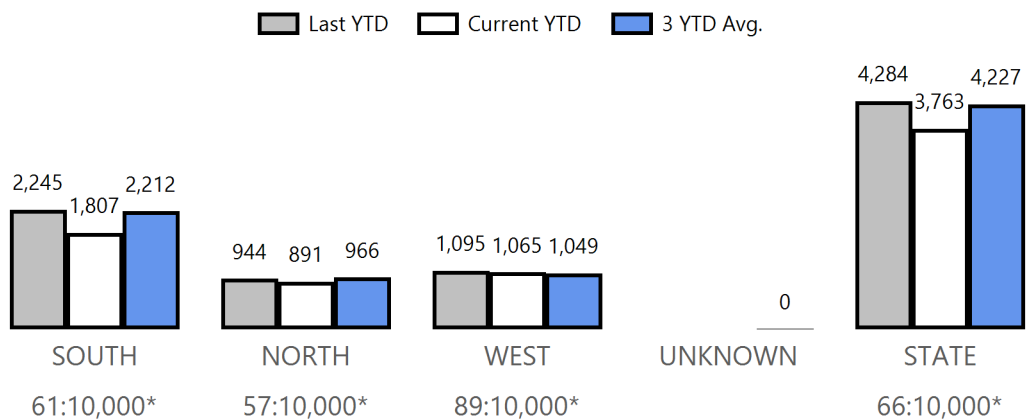
Public Order : Disturbance - March 2023

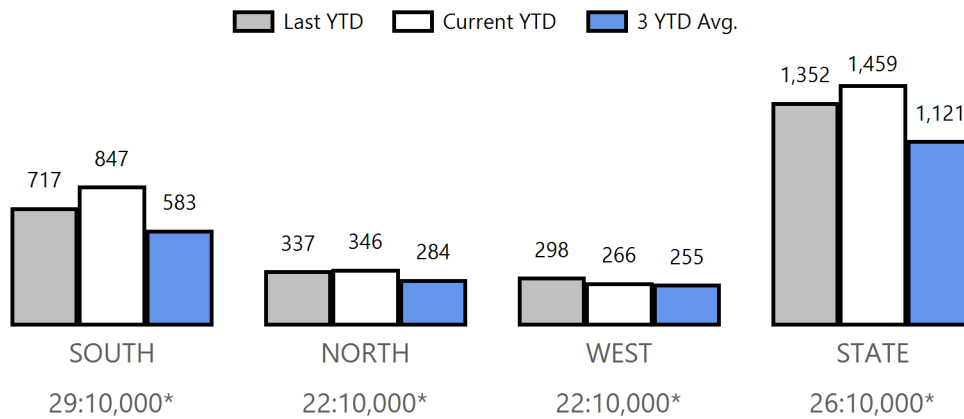
Public Order : Noise - March 2023

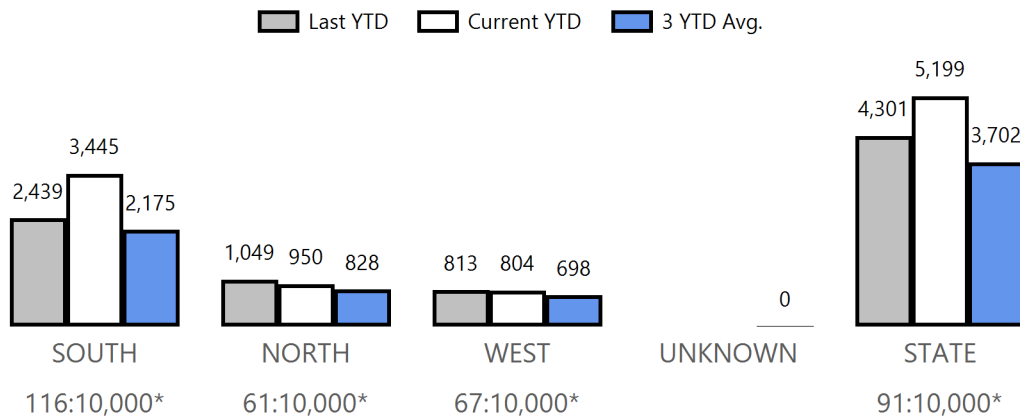
Public Order : Vandalism - March 2023

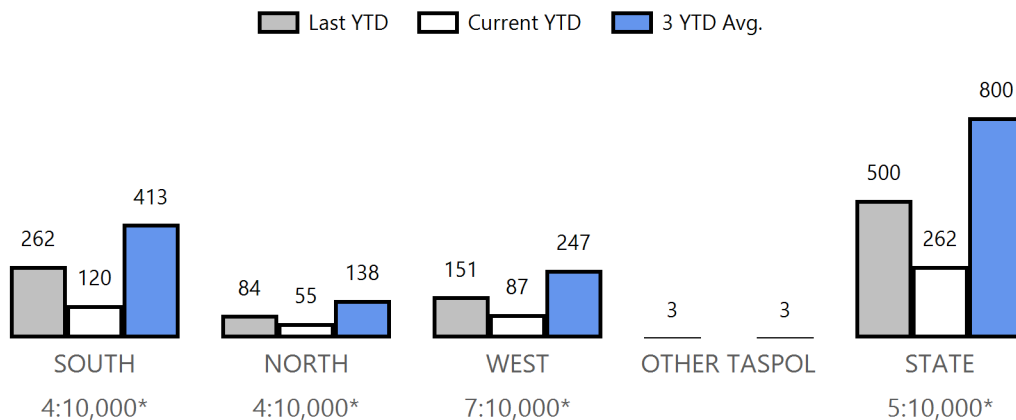
Public Order : Offensive Behaviour - March 2023

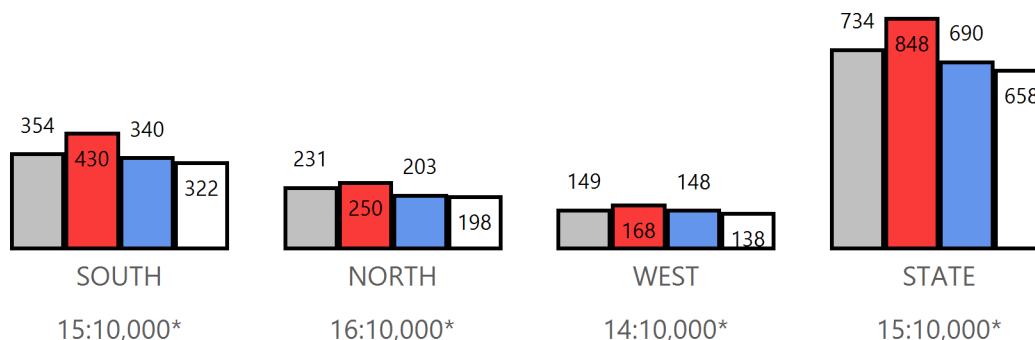

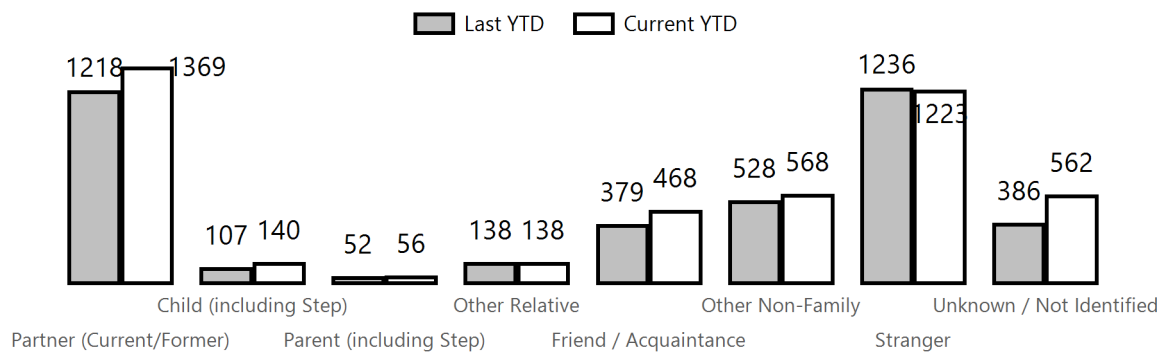

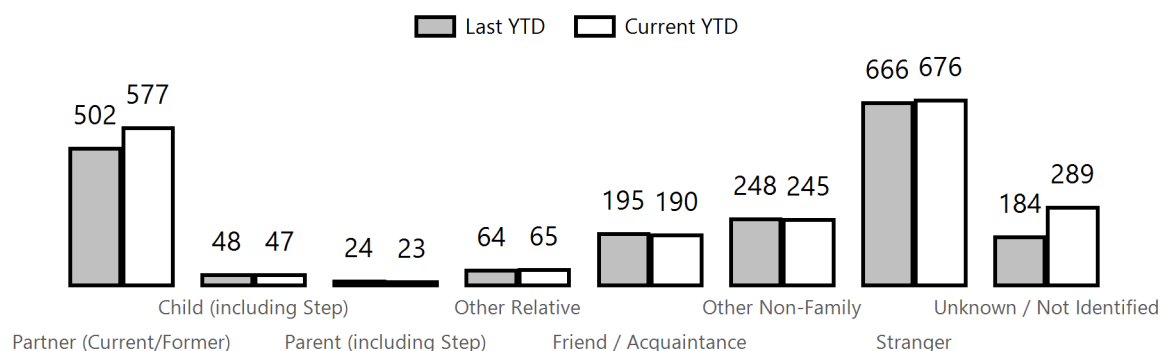

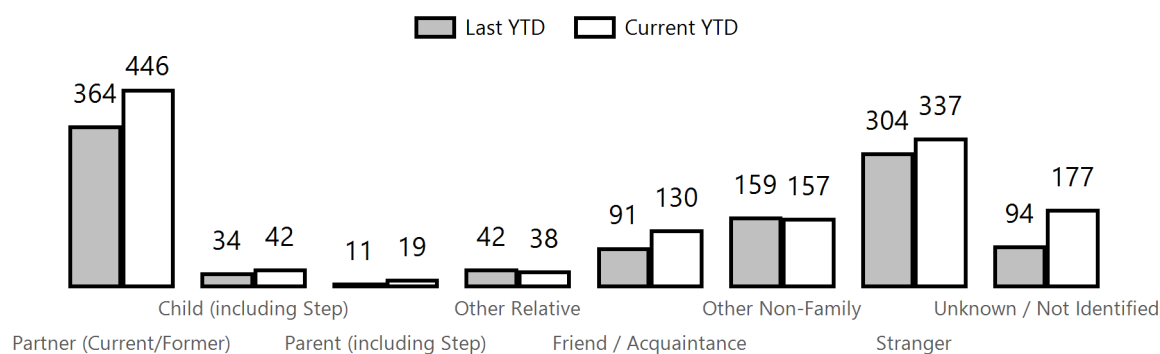

Total Person Offences - Victim Relationship - SOUTH



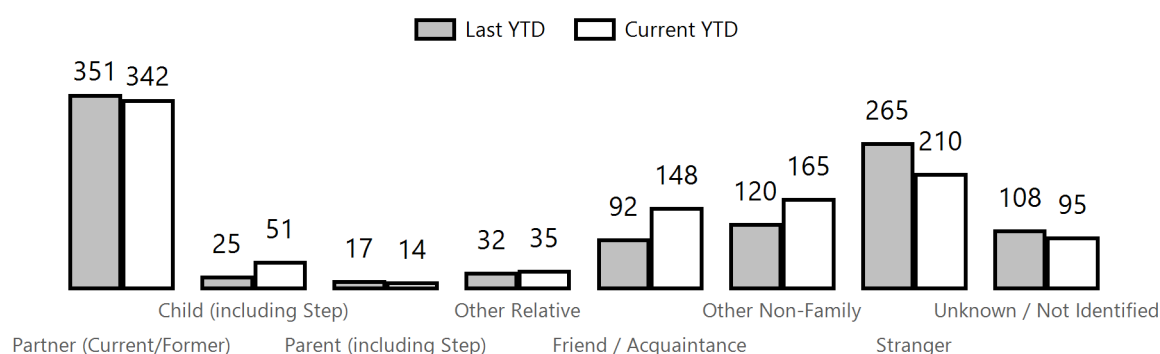

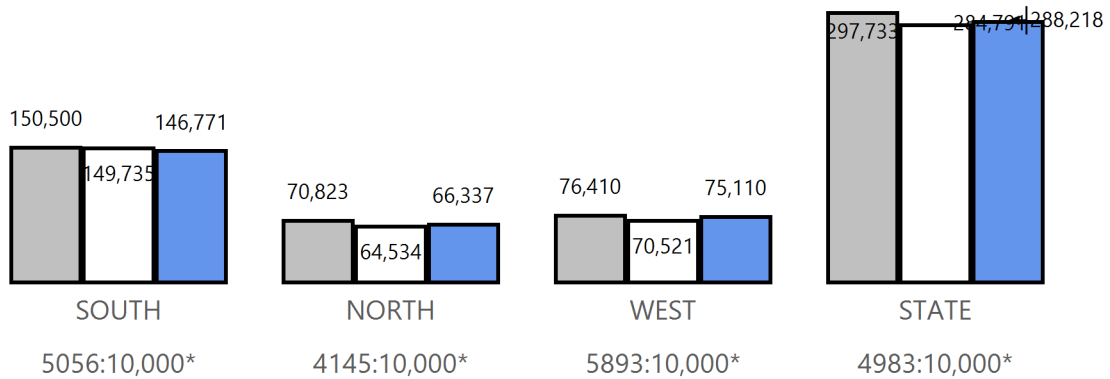

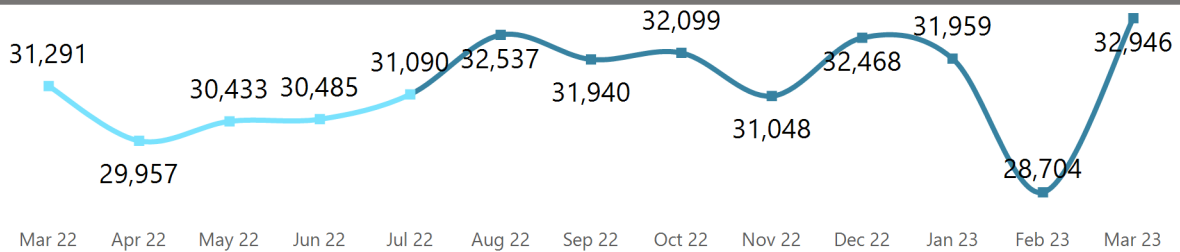
Total Uniform Police Patrol Hours - March 2023

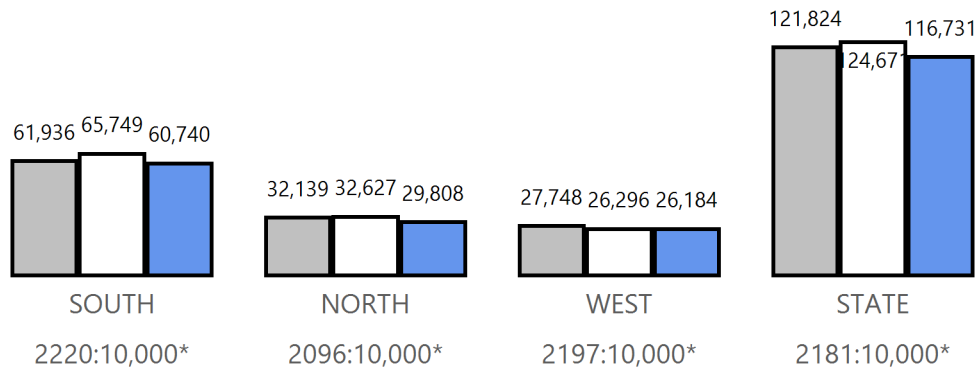
Uniform Police - Patrol Hours

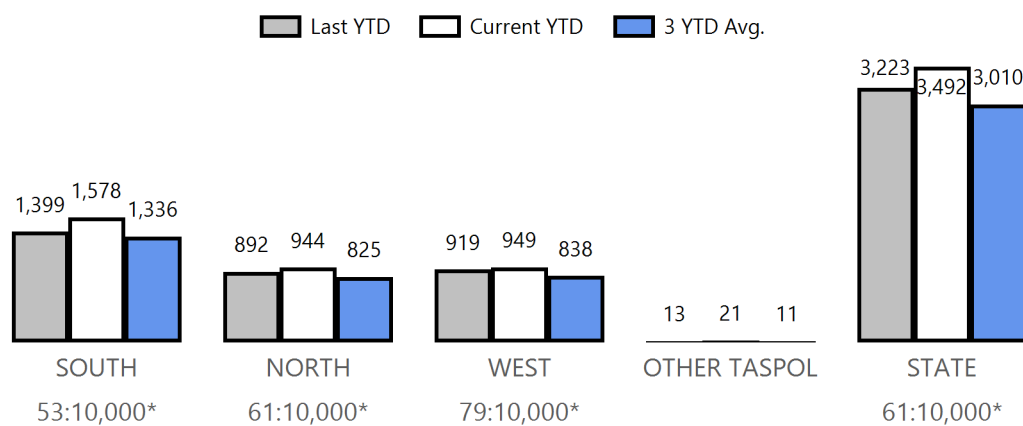

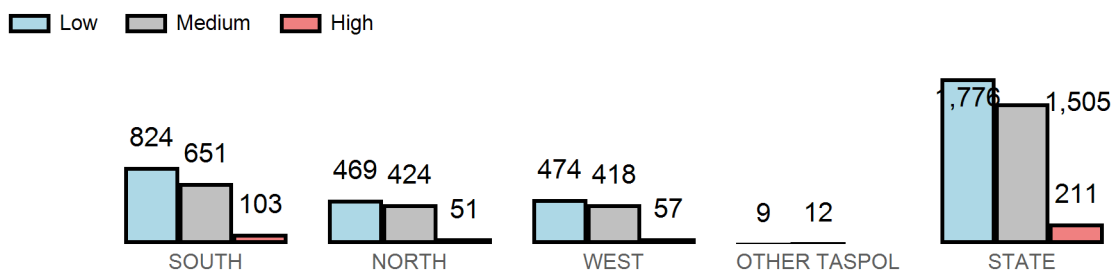
Family Violence Incidents - March 2023

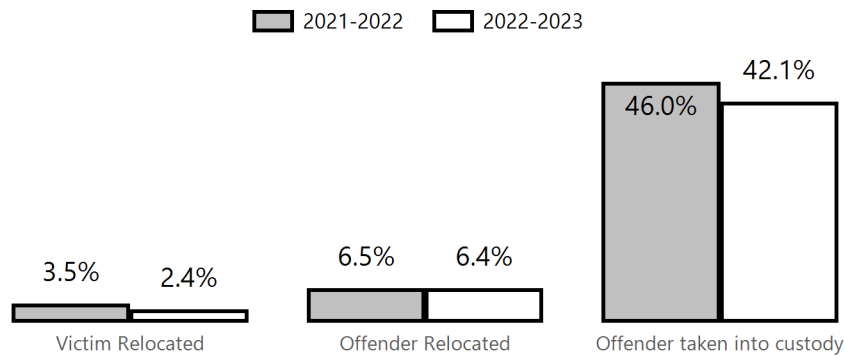

Family Violence RAST - Excludes Other and Argument Categories



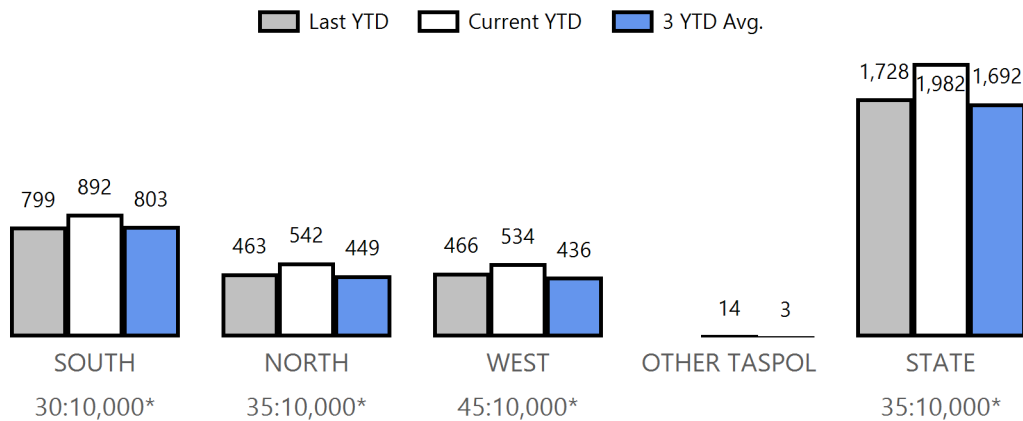

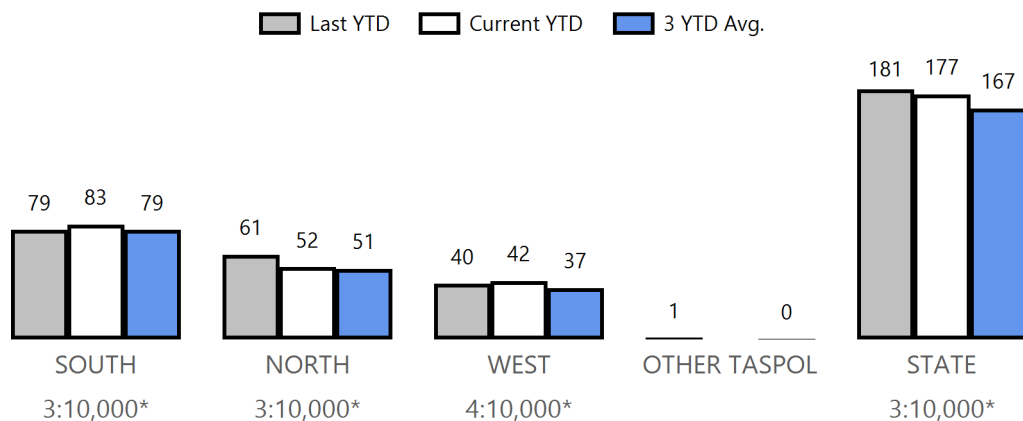
Family Violence : Juveniles Affected - March 2023

Family Violence : Weapons Present - March 2023



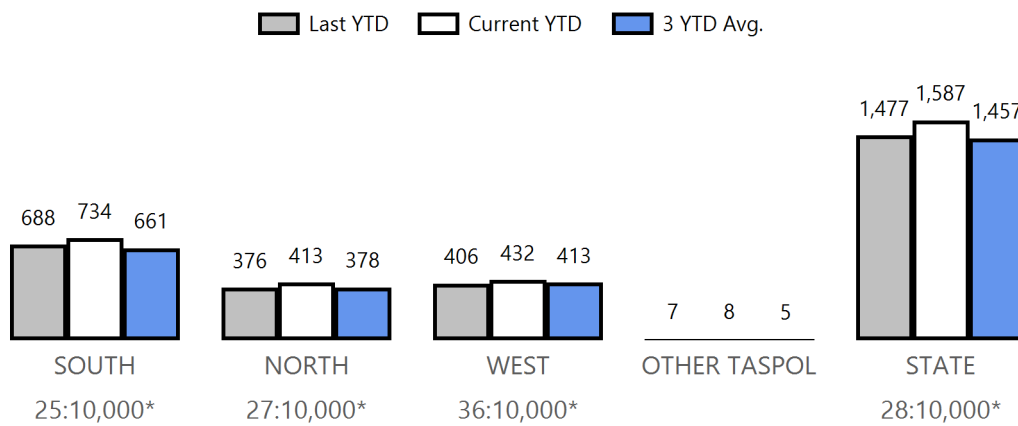

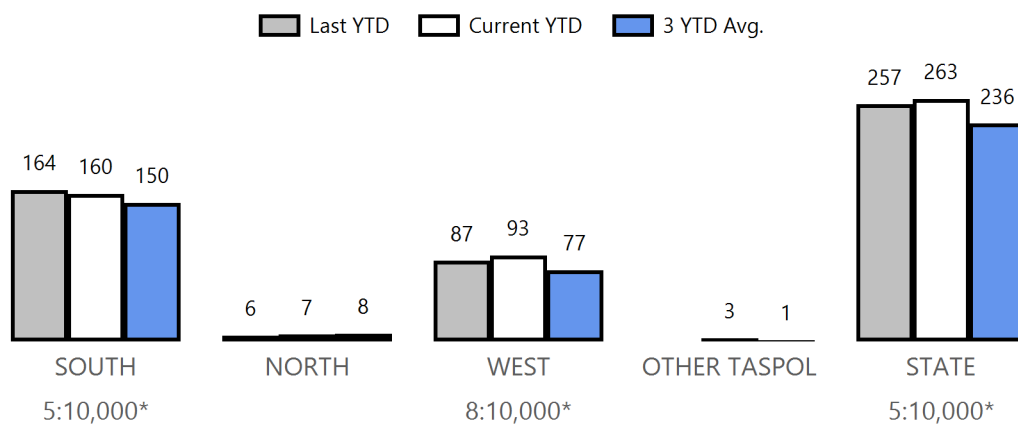

Family Violence Orders : Police Issued - March 2023



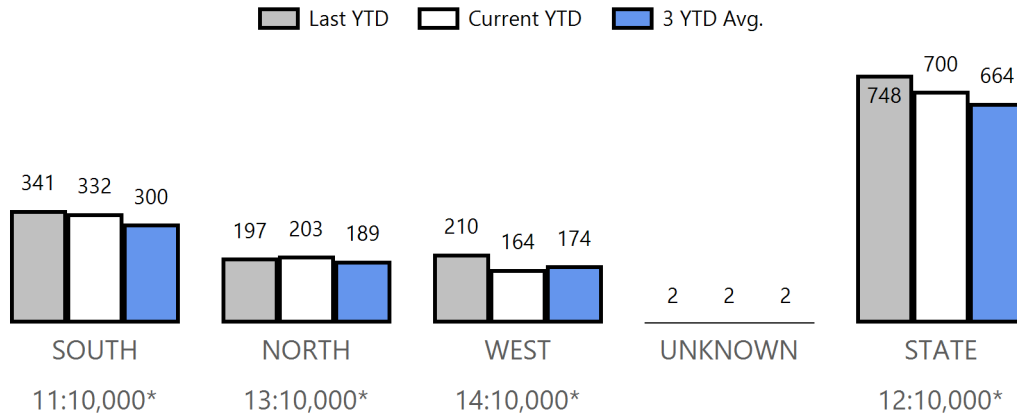

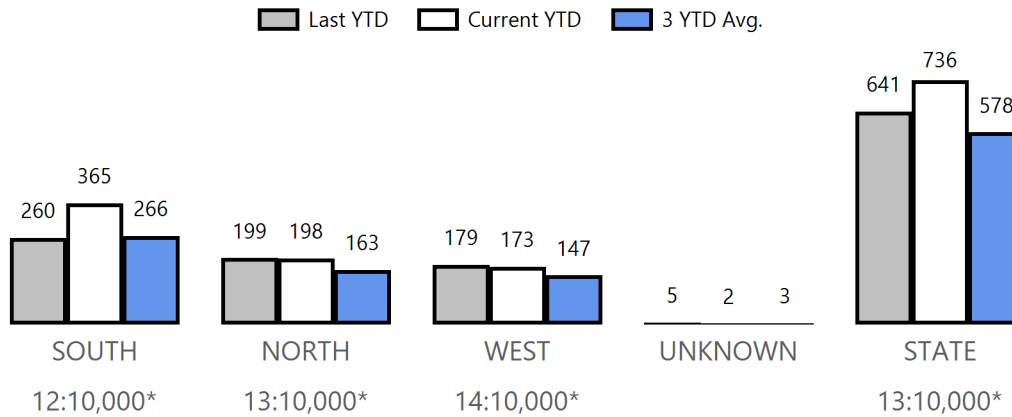
Family Violence - PFVO Breaches - March 2023

Family Violence - FVO Breaches - March 2023

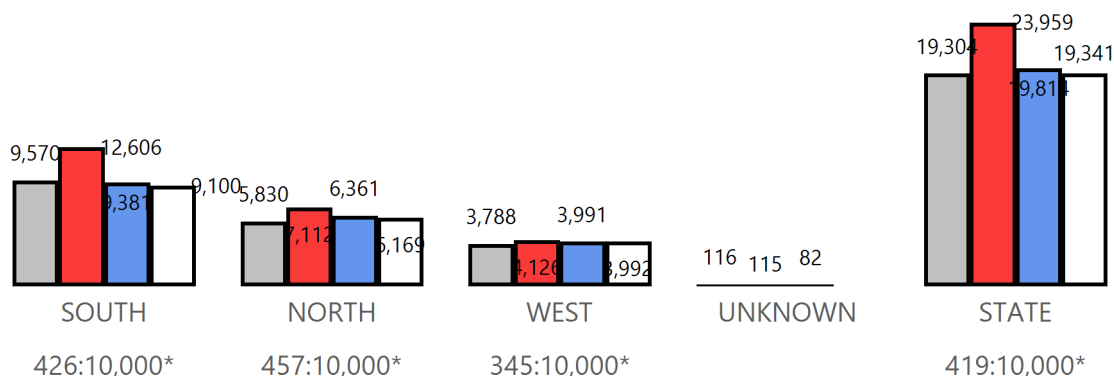

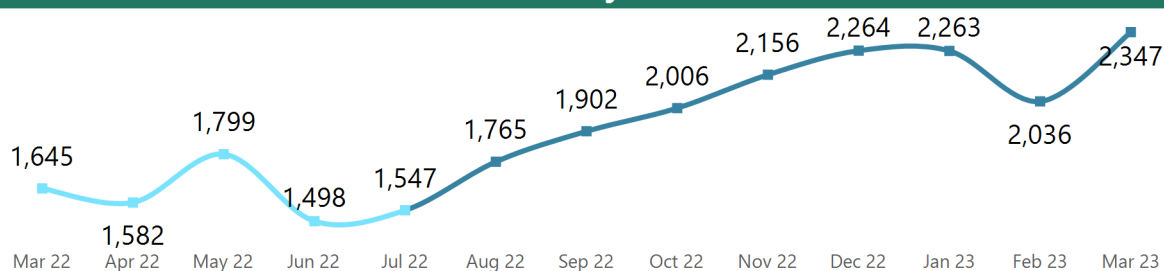

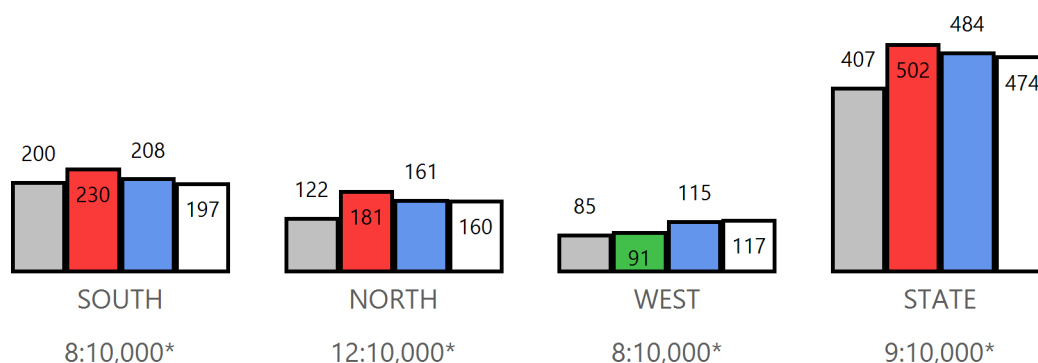

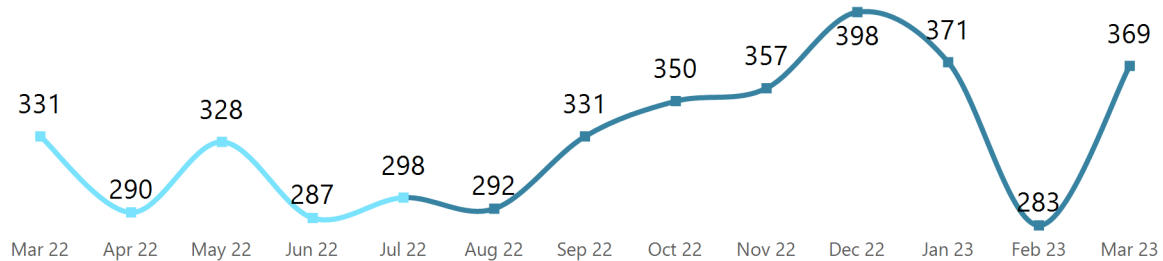

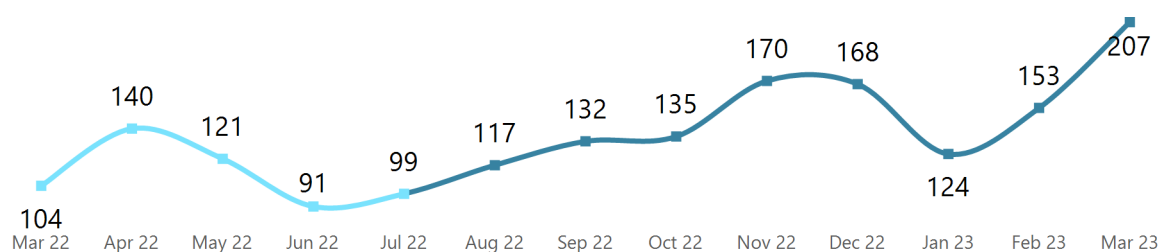

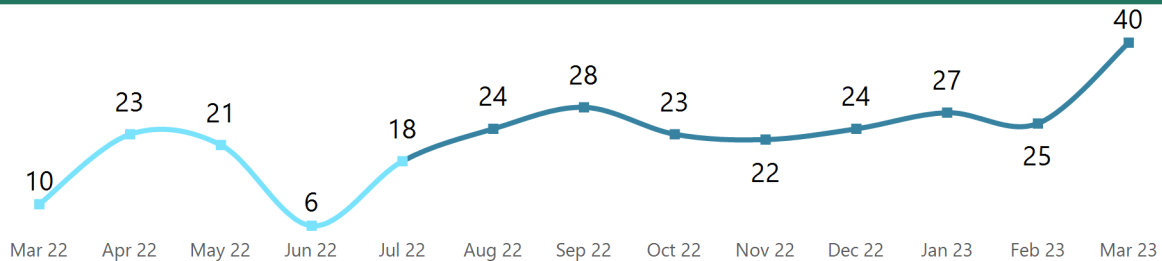
SMV : Recovered Fire Damaged - March 2023

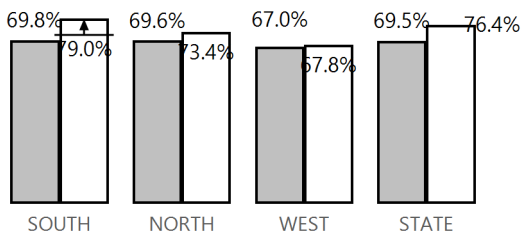

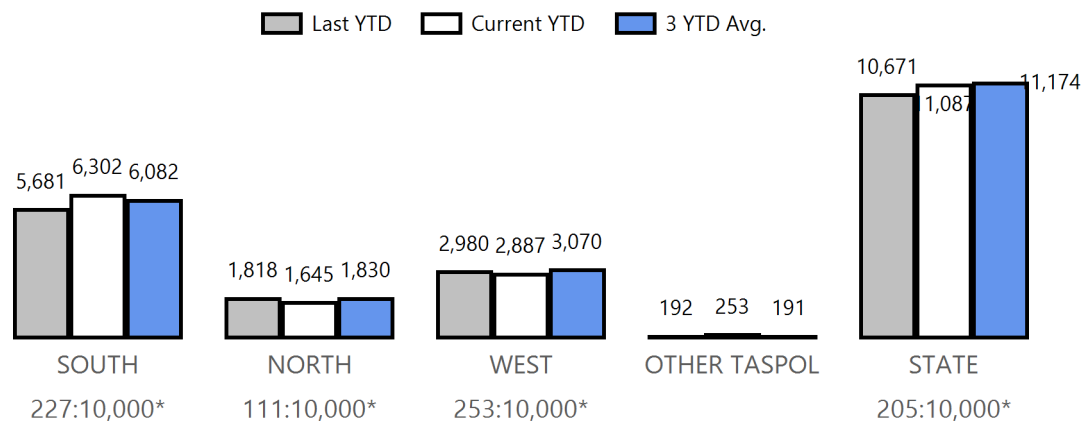

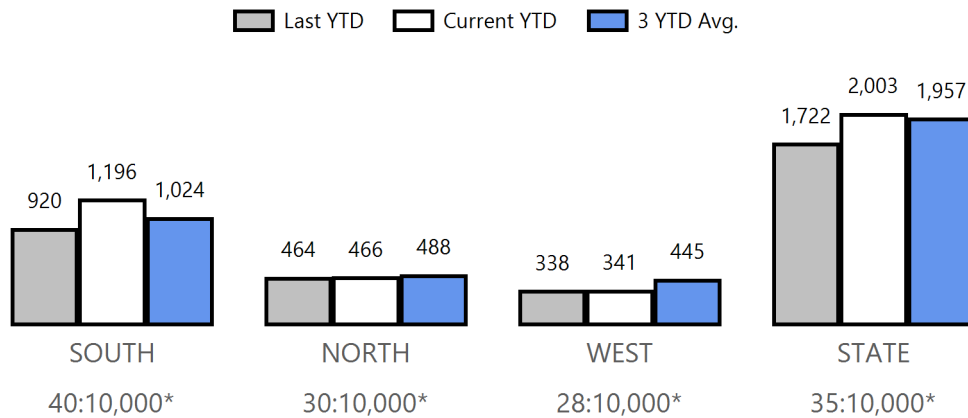
Total Street Checks - March 2023

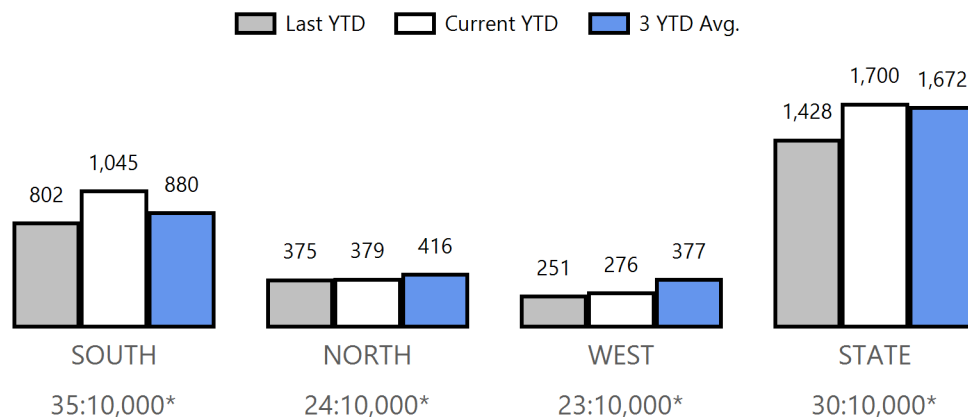
CIB: Total Offenders - March 2023

CIB: Total Crime Offenders - March 2023



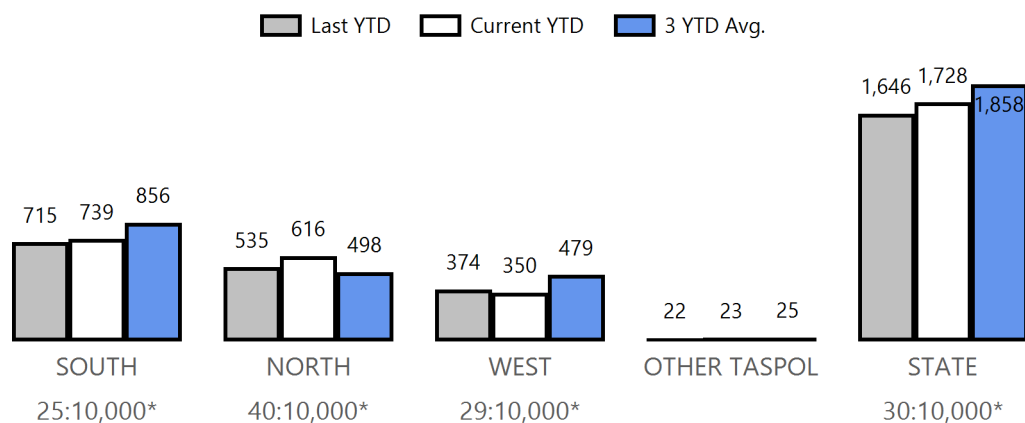

Total Traffic Offenders - March 2023



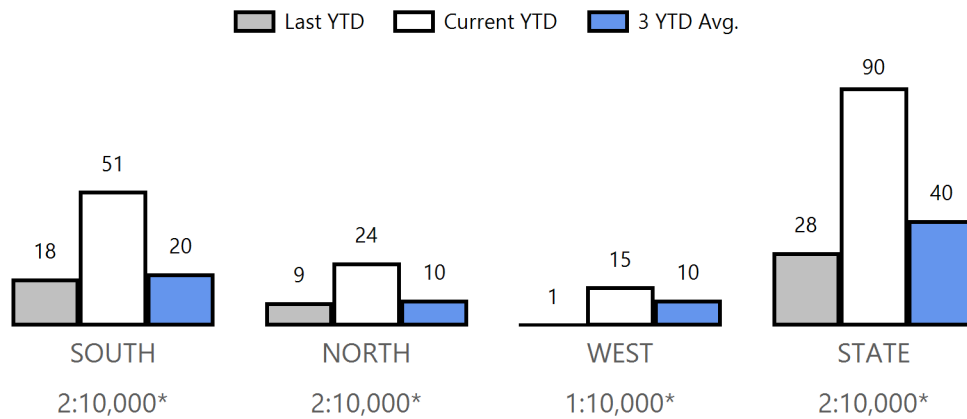

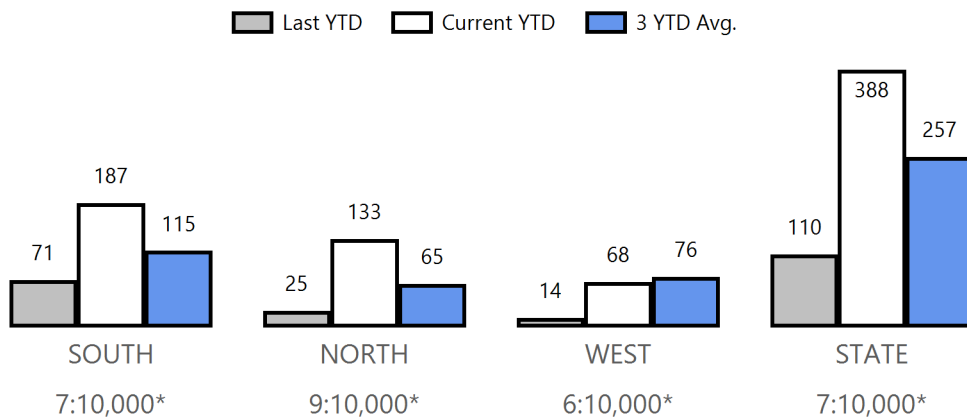
Major Traffic Operations - March 2023

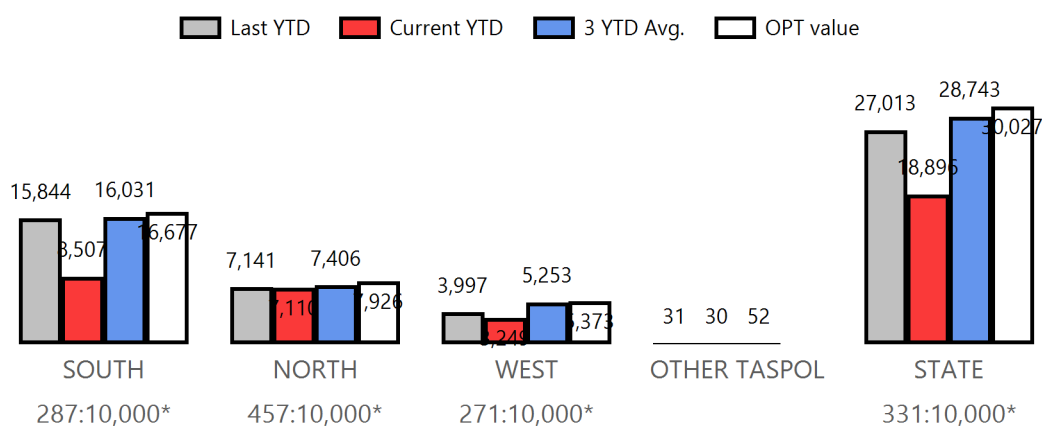

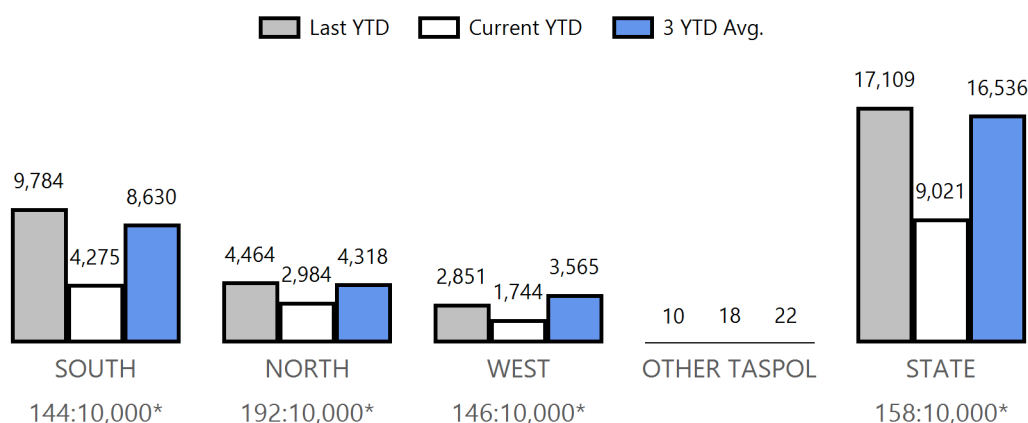
Speeding Offenders - March 2023

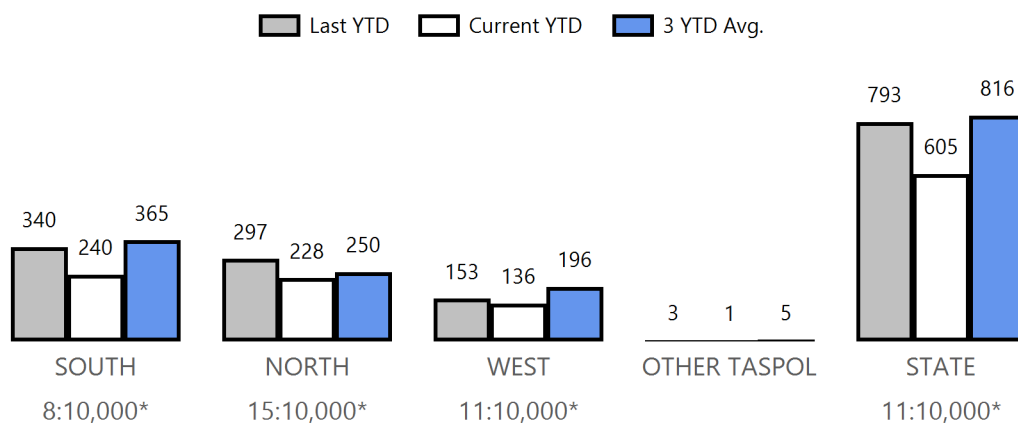
Excessive Speed Offenders - 15-29km/h - March 2023

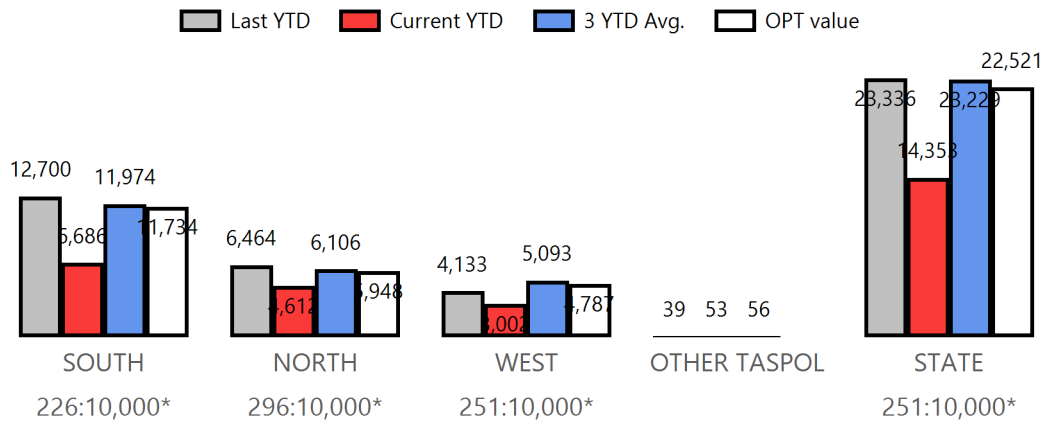
Excessive Speed Offenders - 30km/h + - March 2023

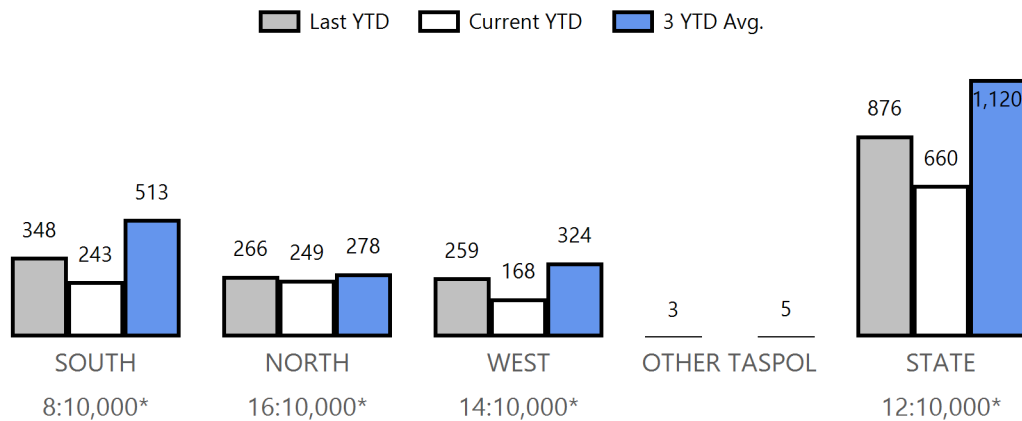
High Risk Offenders - March 2023

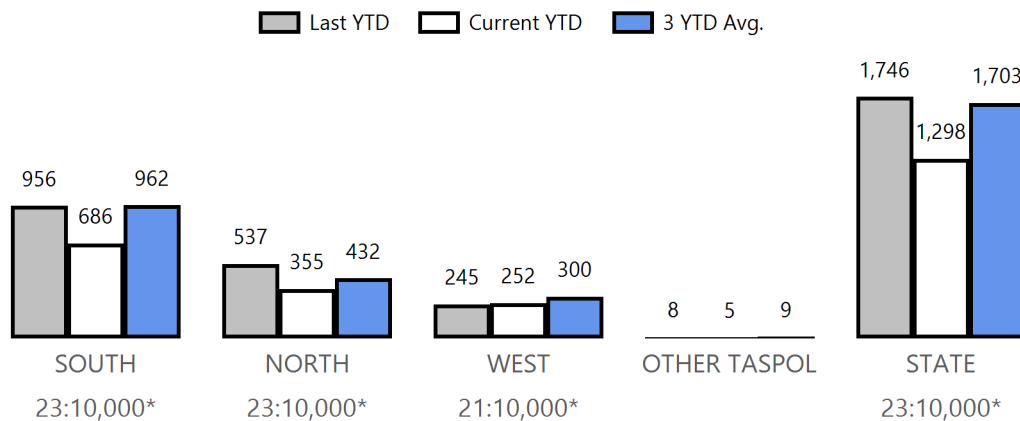
Seatbelt Compliance Offenders - March 2023

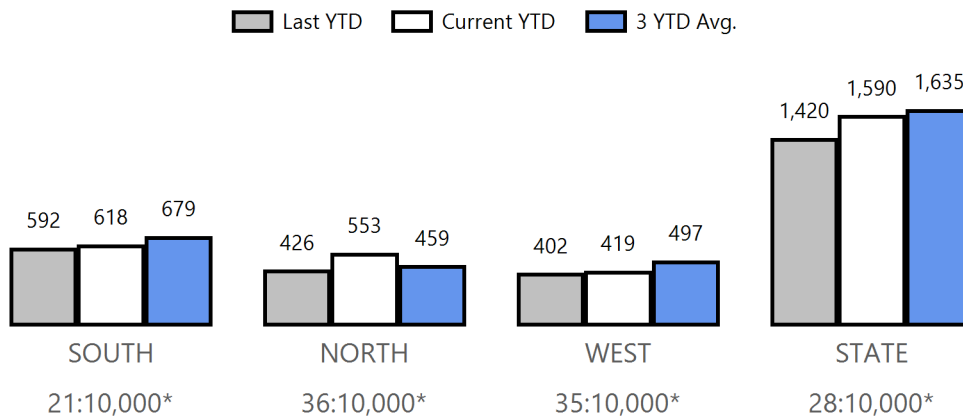
Mobile Phone Offenders - March 2023

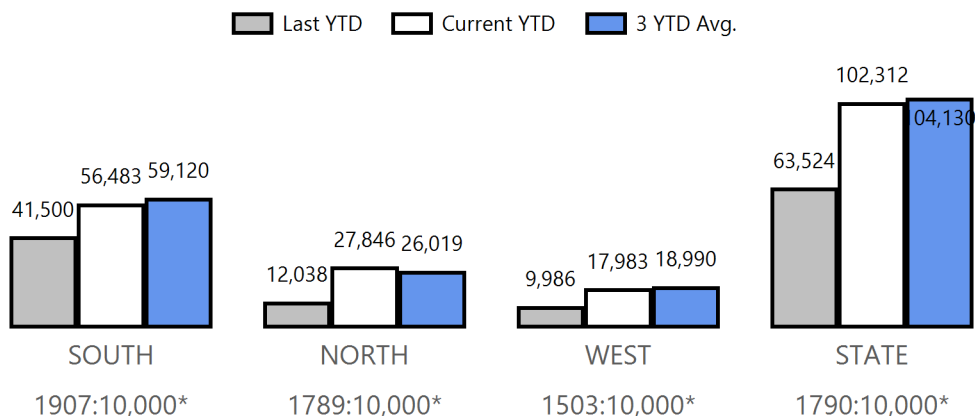
Vehicle Defect Notices - March 2023

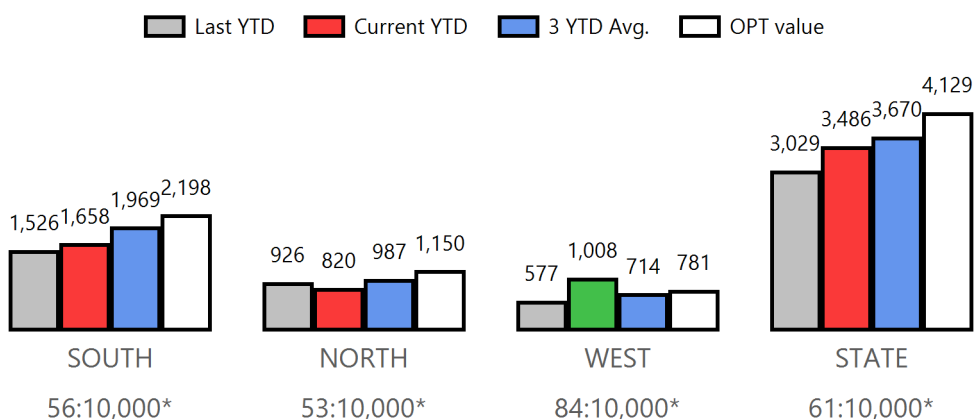
Random Breath Tests (ALCOHOL) - March 2023

Oral Fluid Tests (Drugs) - March 2023



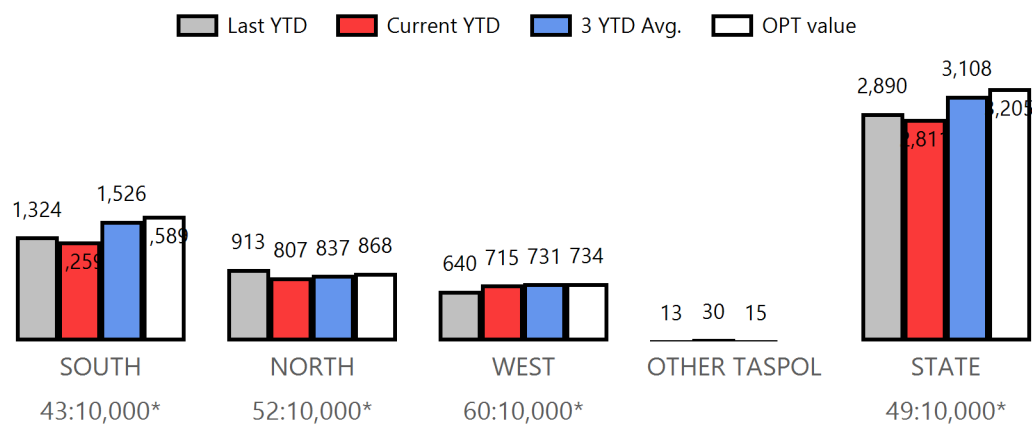

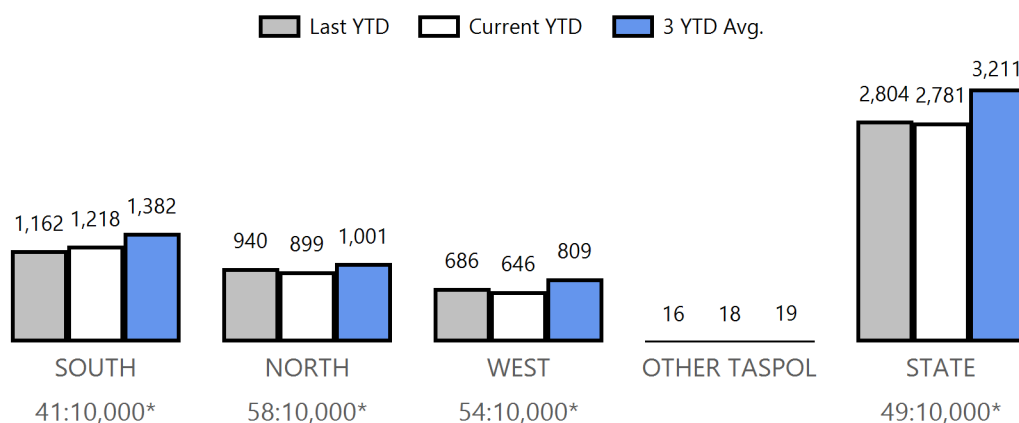

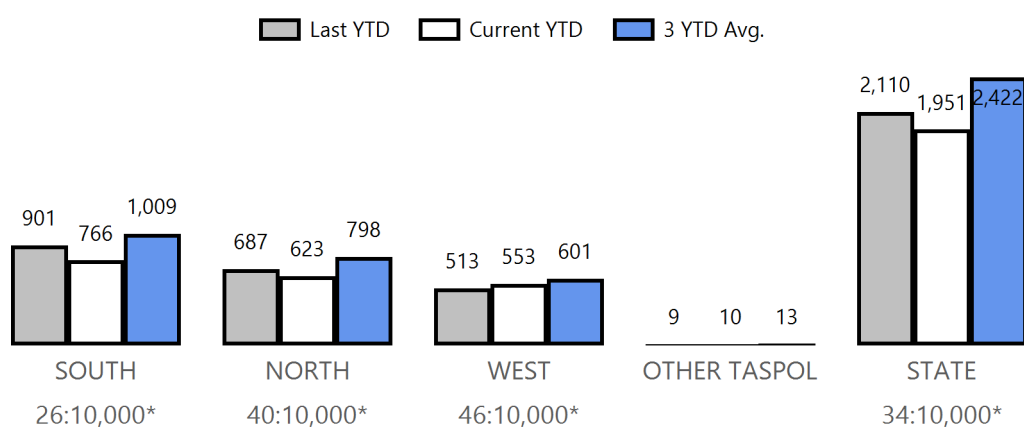

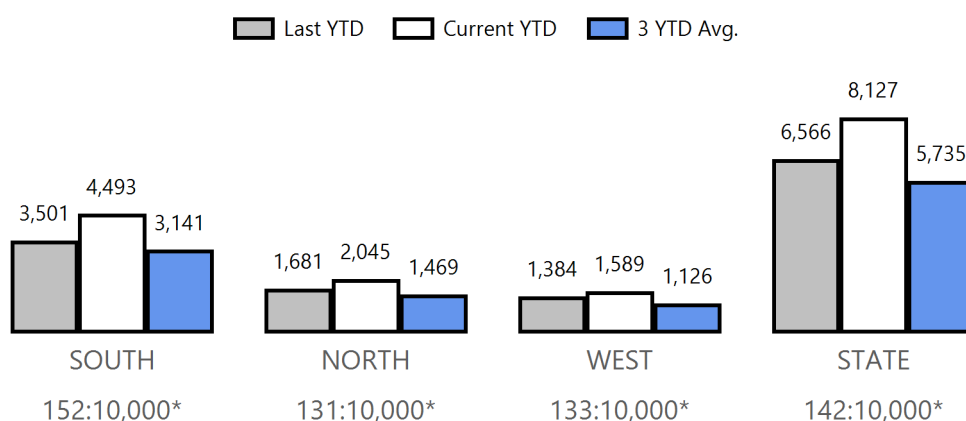
Unregistered Vehicle Offenders - March 2023

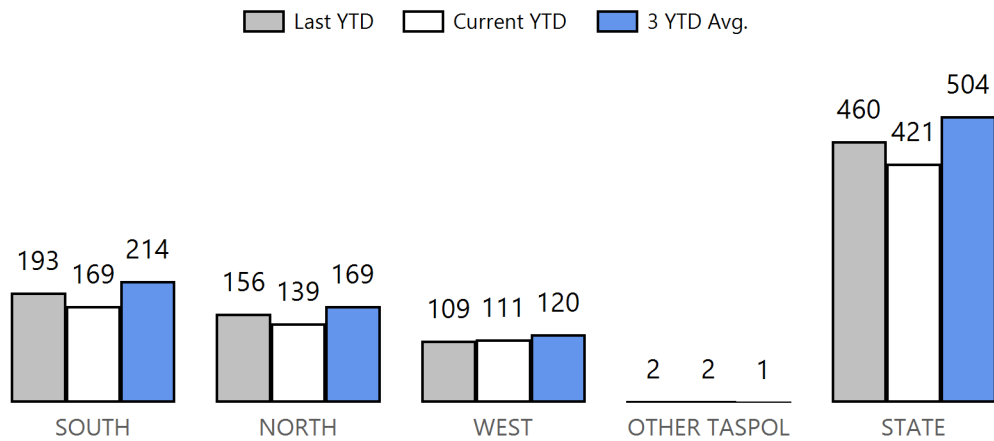
Vehicle Complaints made to RDS - March 2023

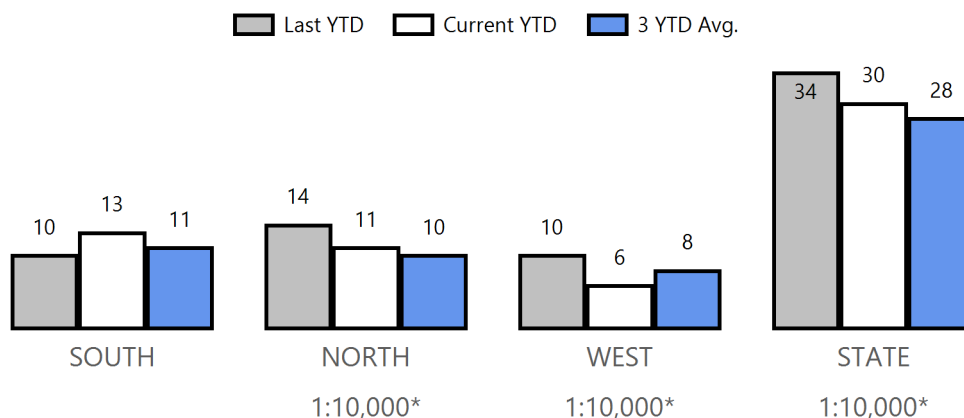

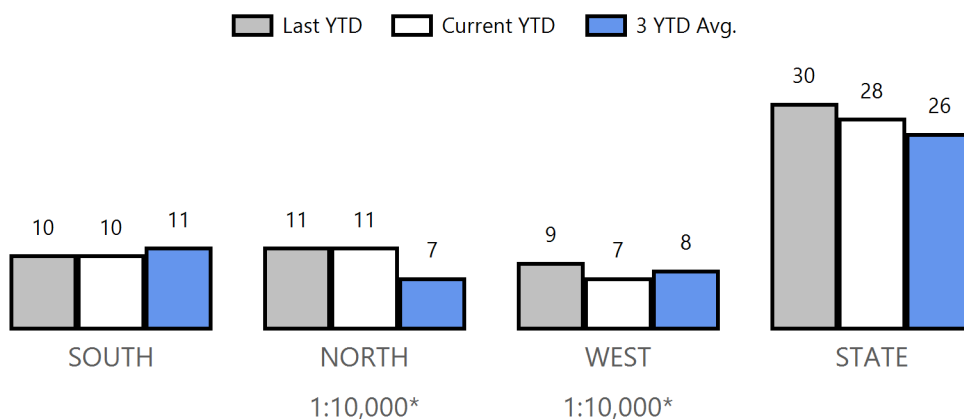

Road Crashes: Fatalities YTD - March 2023



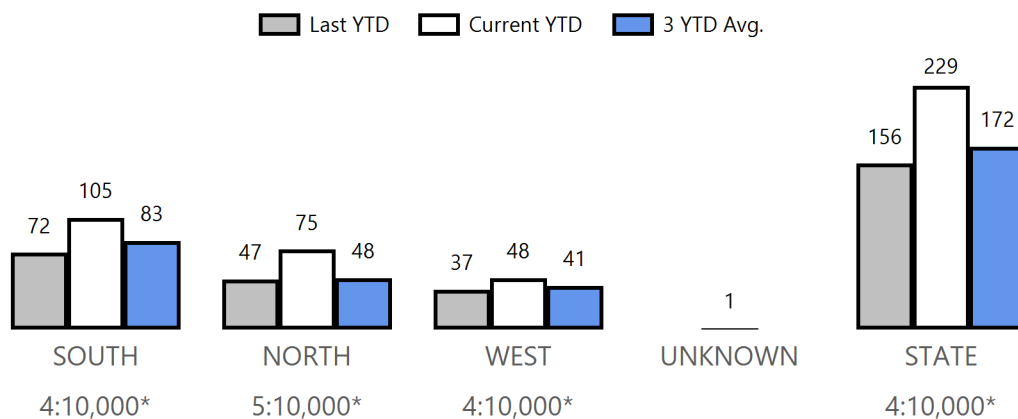

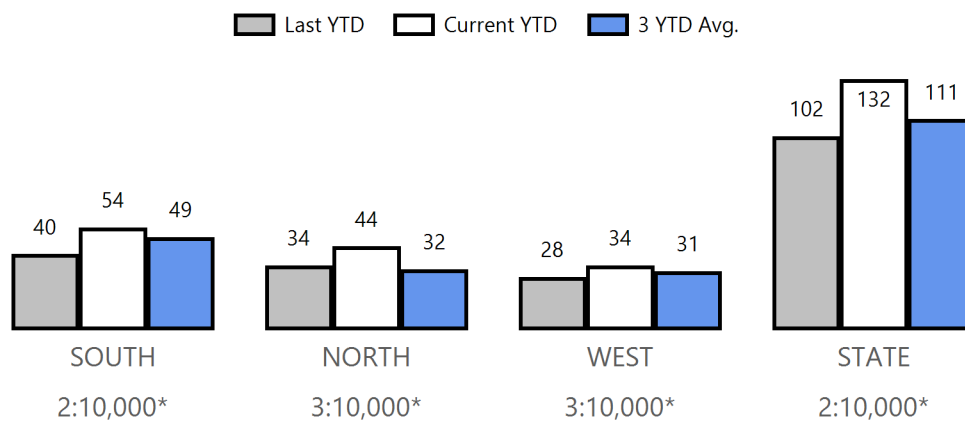

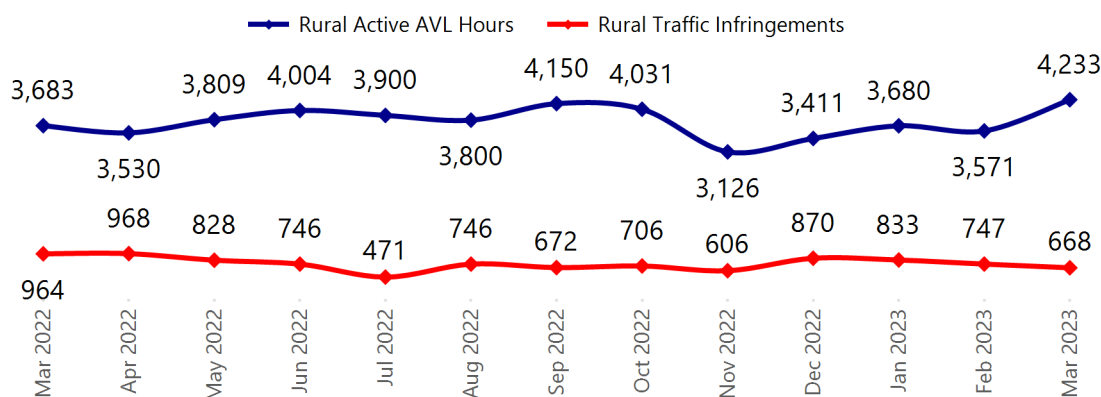
On Road Fatal and Serious Crashes in Rural Areas - March 2023



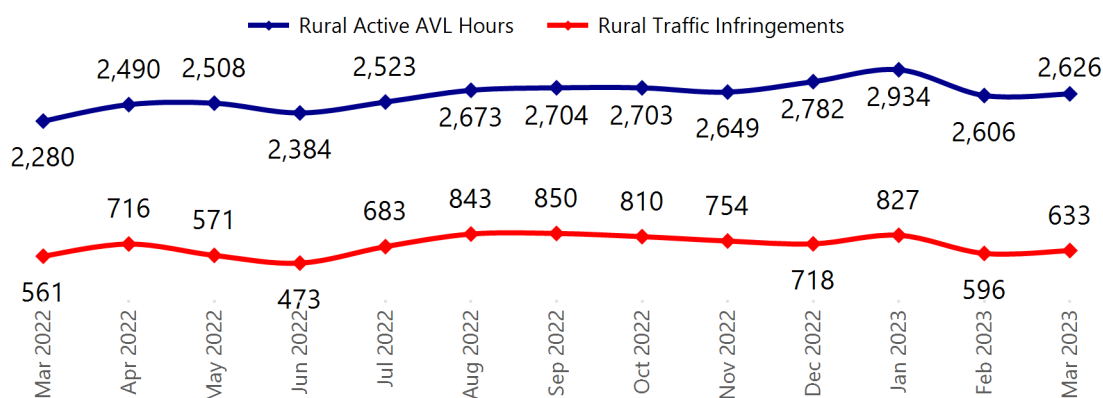

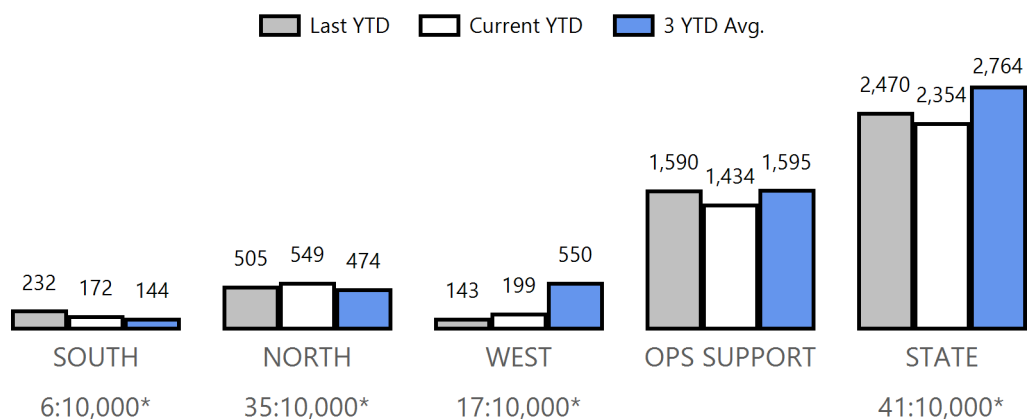
Sea Inspections (Vessel & Non-Vessel) - March 2023

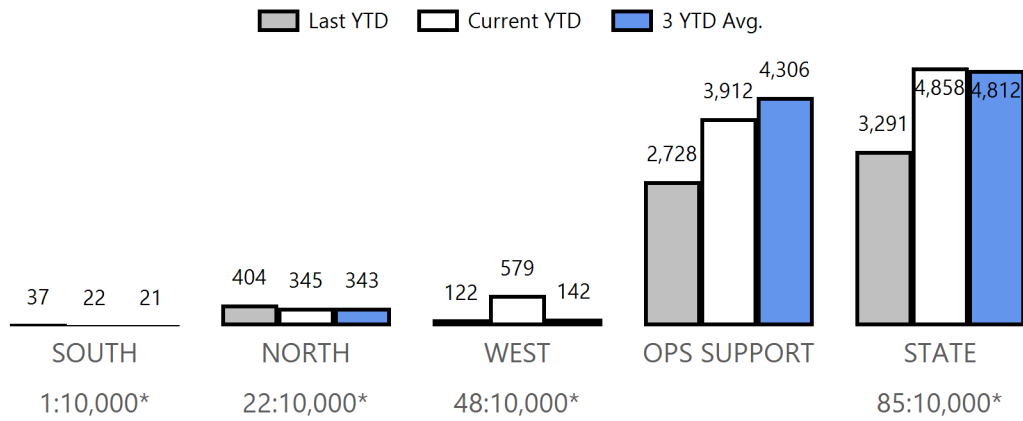
Vessel Inspections on Land - March 2023
