Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.




Safety at Home During the Night


Safety In Neighbourhood During the Day



General Satisfaction with Police Services




Public Order Incidents - May 2025


Public Order : Disturbance - May 2025


Public Order : Noise - May 2025


Public Order : Vandalism - May 2025


Public Order : Offensive Behaviour - May 2025

Liquor Infringement Notices - May 2025











Total Person Offences - Victim Relationship - SOUTH









Uniform Police Patrol Hours - May 2025




Uniform Police - Patrol Hours

Uniform Police Hours on Dispatch Tasks - May 2025






Family Violence Incidents - May 2025



Family Violence RAST - Excludes Other and Argument Categories





Family Violence - Action at Scene (Excludes 'Other' and 'Argument' categories)





Family Violence Incidents: Weapons Present - May 2025





FV Incidents with Police FV Order Issued - May 2025






Breach of Police Family Violence Orders - May 2025

Breach of Family Violence Orders (excluding PFVOs) - May 2025


















SMV : Recovered Fire Damaged - May 2025




Intelligence Submission Occurrences - May 2025


Street Check Occurrences - May 2025


CIB: Total Offenders - May 2025

CIB: Total Crime Offenders - May 2025










Major Static District Traffic Operations - May 2025




Speeding Offenders - May 2025


Speeding 15-29 km/h Offenders - May 2025


Speeding 30+ km/h Offenders - May 2025


High Risk Traffic Offenders - May 2025


Seatbelt Compliance Offenders - May 2025


Mobile Phone Offenders - May 2025


Vehicle Defect Notices - May 2025


Random Breath Tests (Alcohol) - May 2025

Oral Fluid Tests (Drugs) - May 2025






Dangerous and Reckless Driving Offenders - May 2025

Disqualified and Unlicensed Driving Offenders - May 2025






Unregistered Vehicle Offenders - May 2025

Vehicle Complaint Dispatch Incidents - May 2025




On Road Fatal and Serious Crashes in Rural Areas - May 2025






Southern District Rural Policing



Northern District Rural Policing








Sea Inspections (Vessel & Non-Vessel) - May 2025


Vessel Inspections on Land - May 2025
