Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 7 January 2020. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

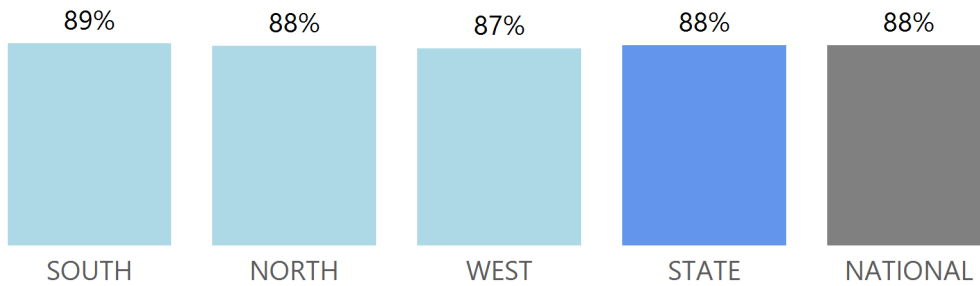

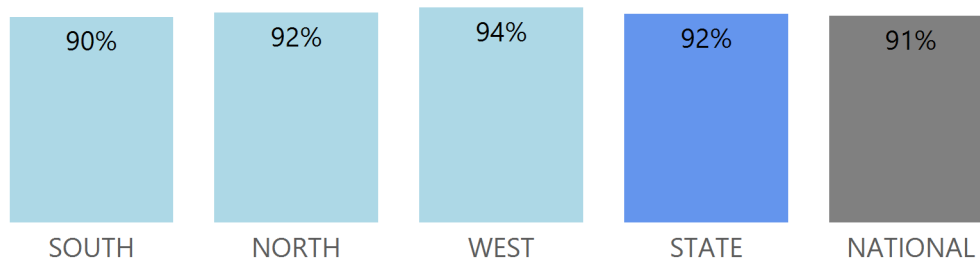

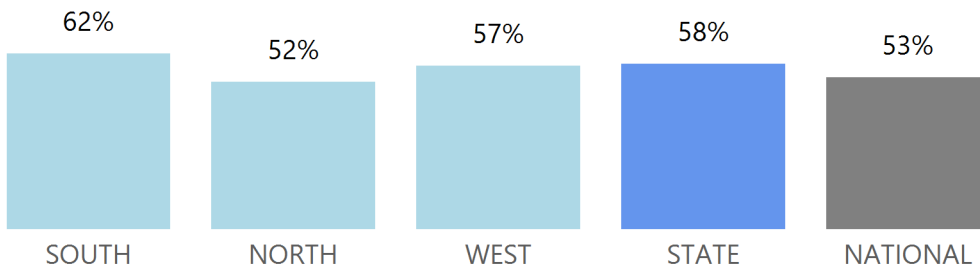
Public Safety - Out in Public Locally (Daytime)

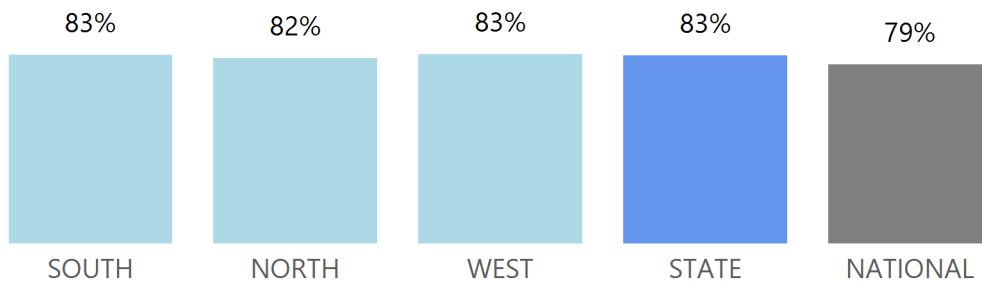

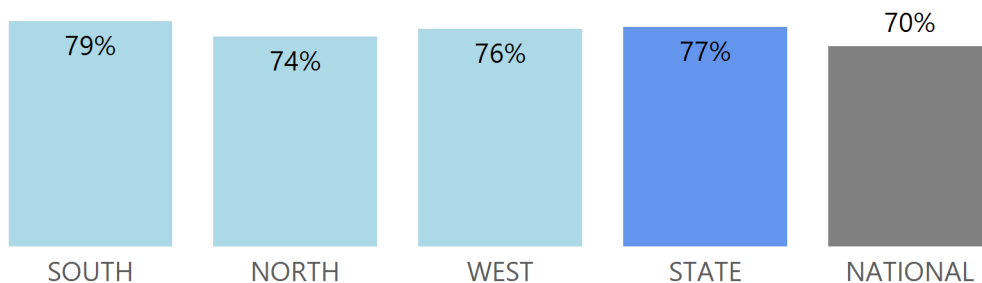
General Satisfaction with Police Services

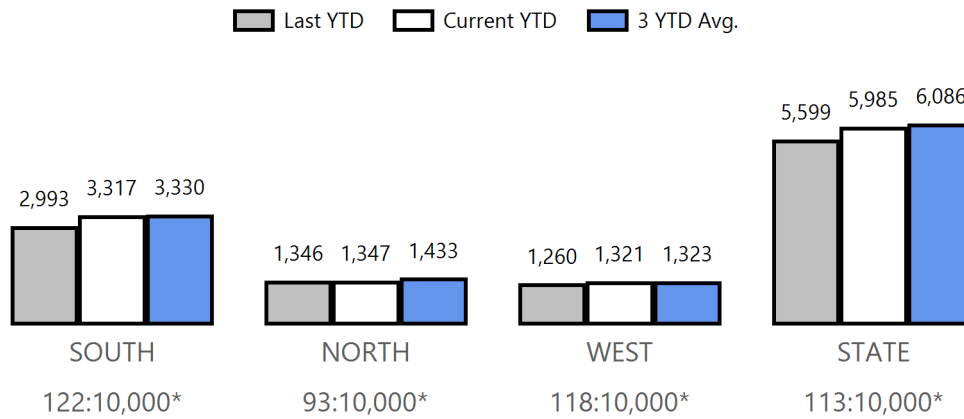
Satisfaction - Dealing with Public Order Problems

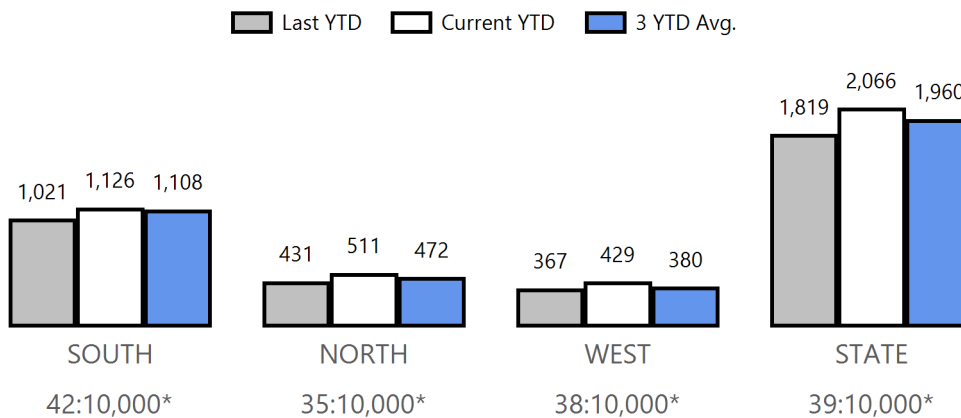
Public Order Incidents - November 2019

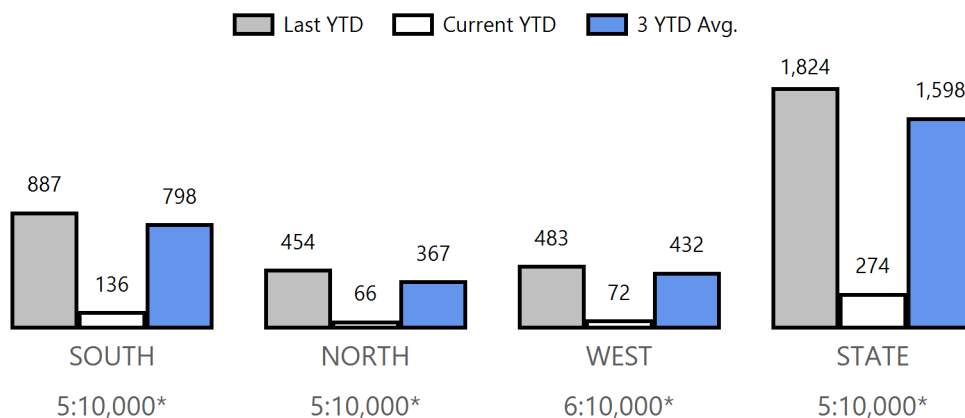
Public Order : Disturbance - November 2019

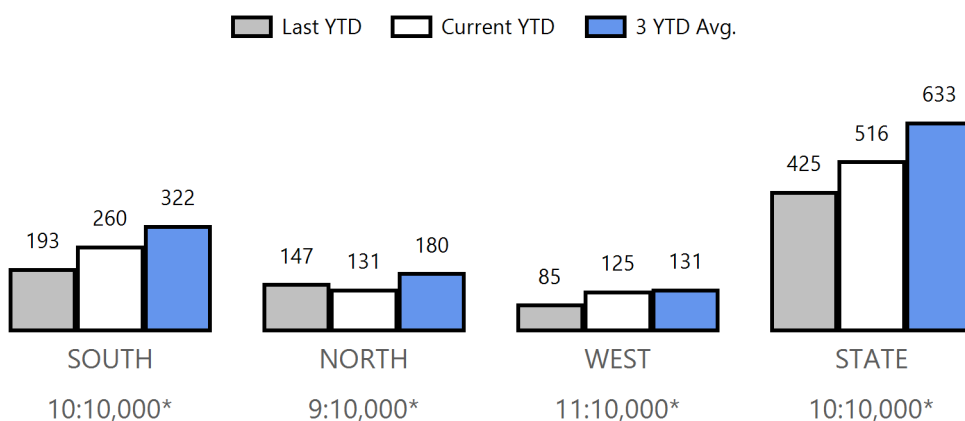
Public Order : Noise - November 2019

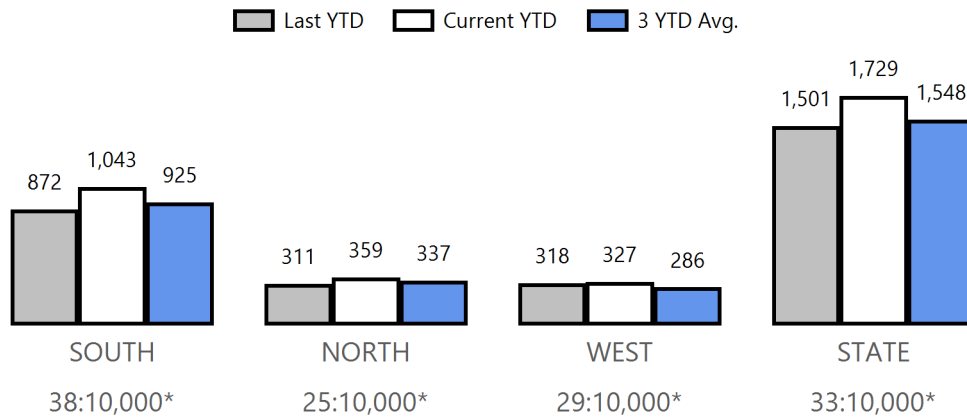
Public Order : Vandalism - November 2019

Public Order : Offensive Behaviour - November 2019

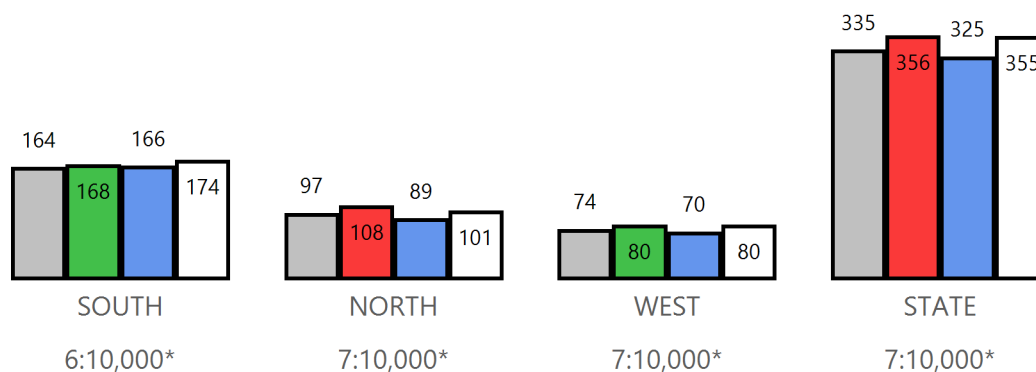

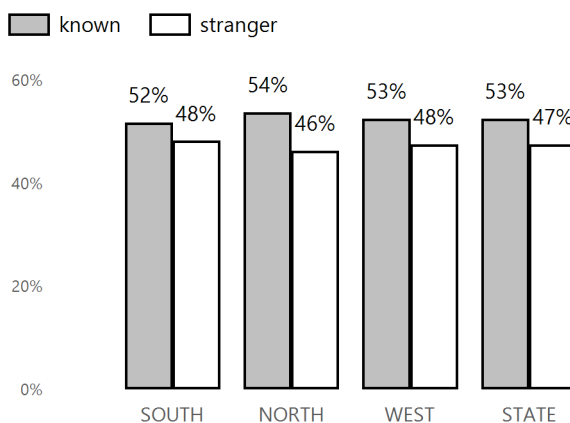

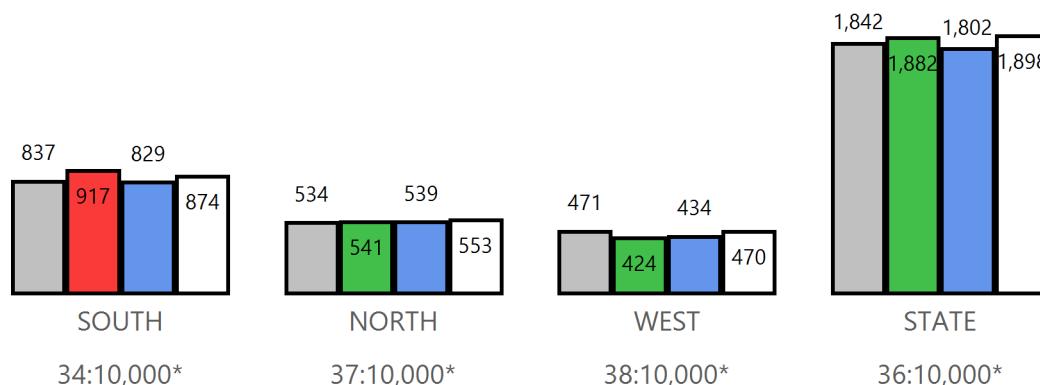

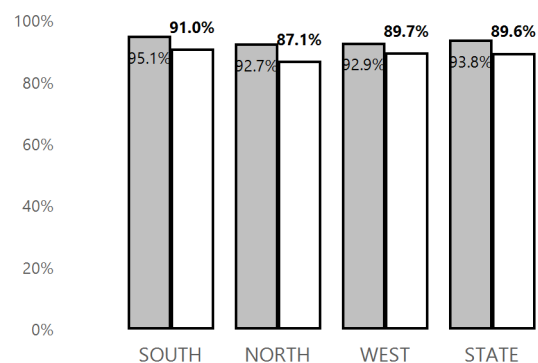

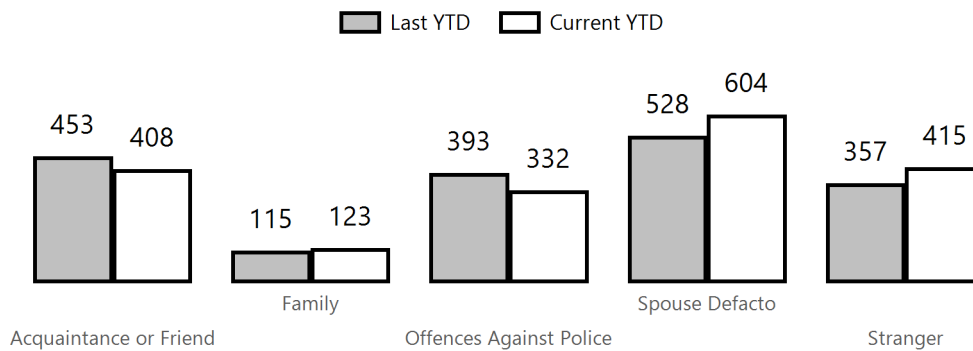

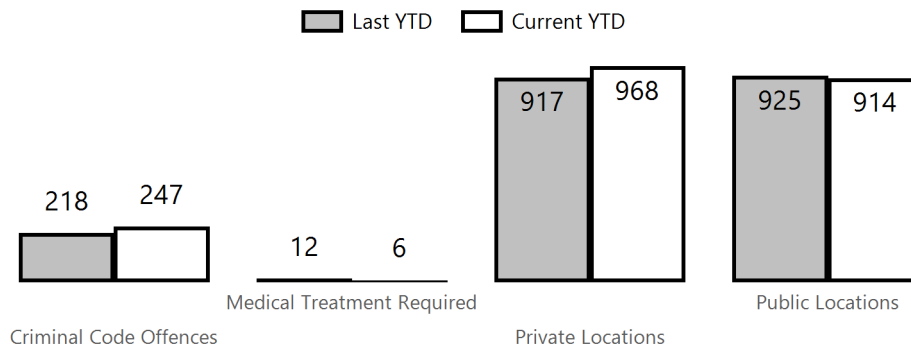

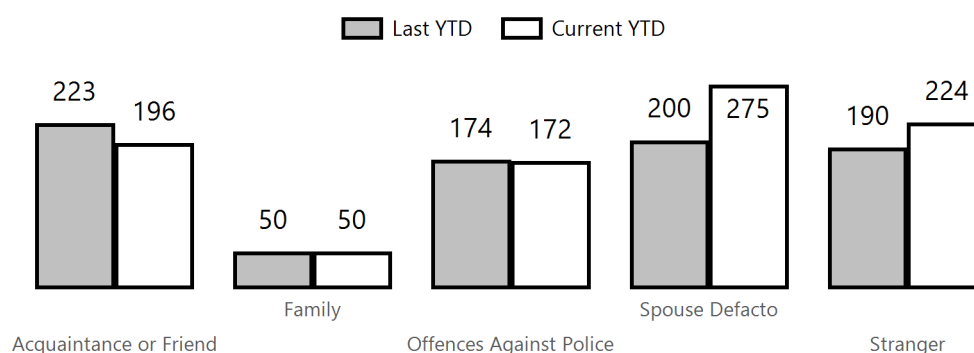

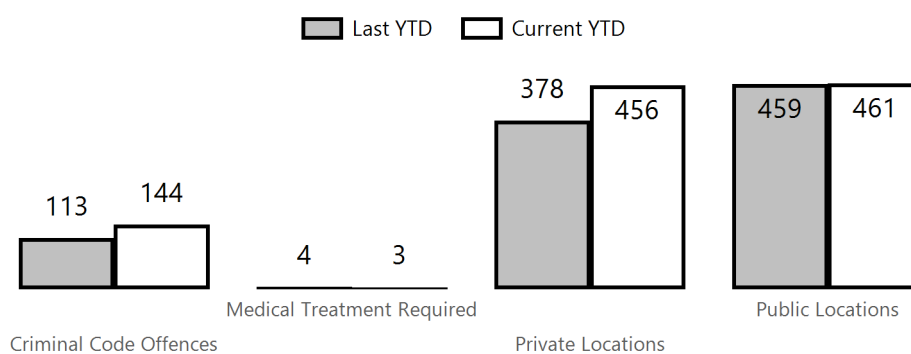

Total Person Offences - Victim Categories - SOUTH



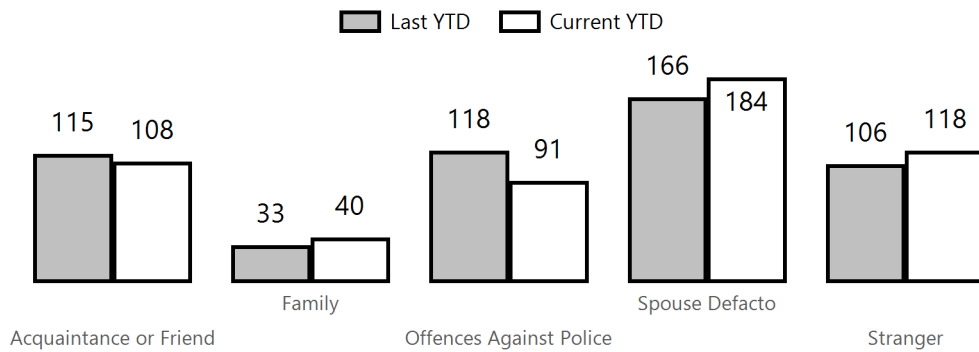

Total Person Offences - SOUTH



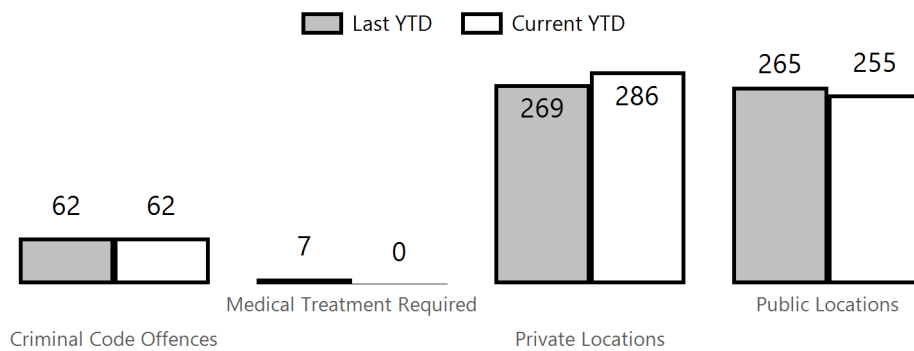

Total Person Offences - Victim Categories - NORTH



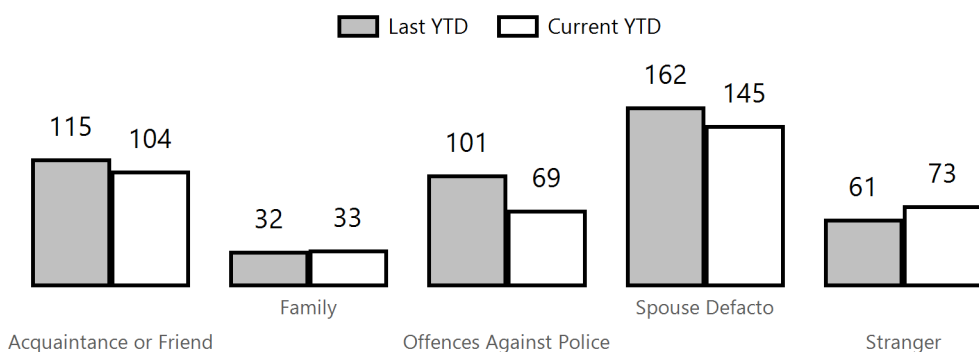

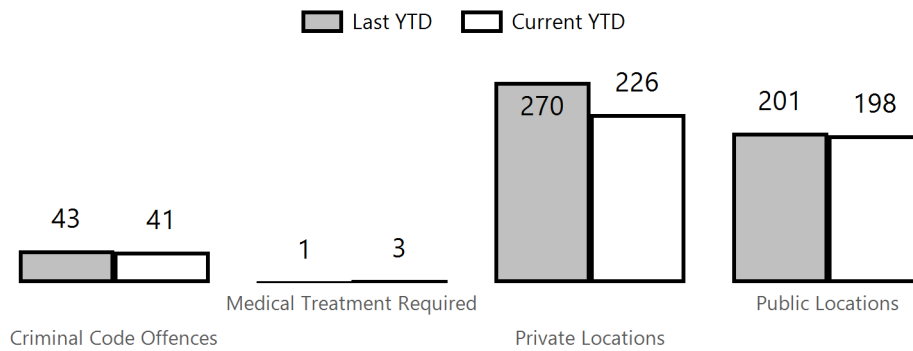

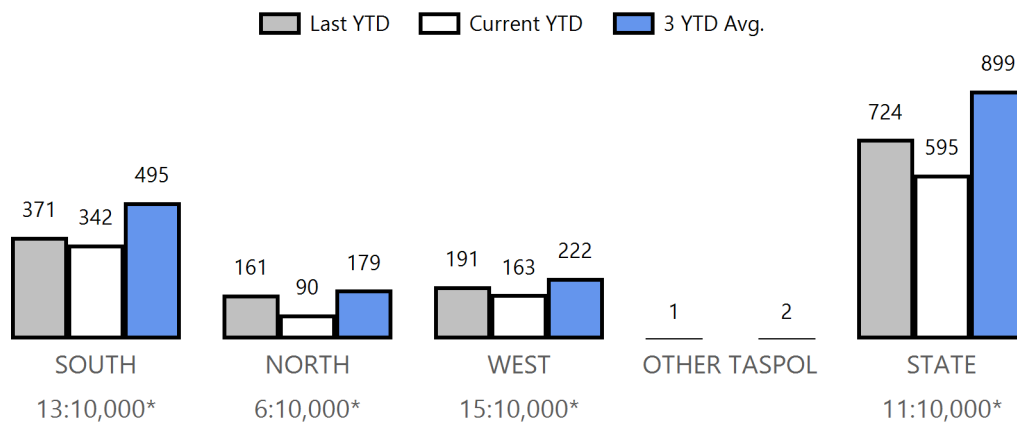

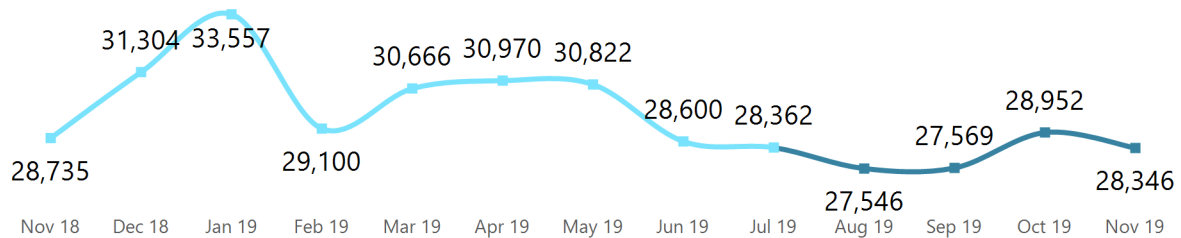
Total Uniform Police Patrol Hours - November 2019

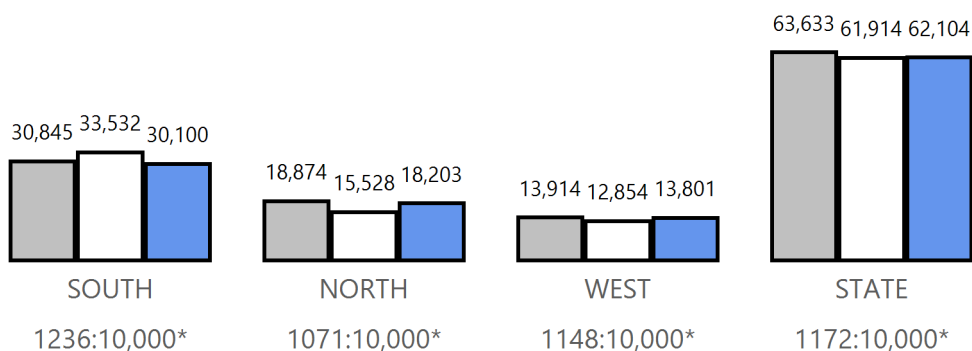
Uniform Police - Patrol Hours

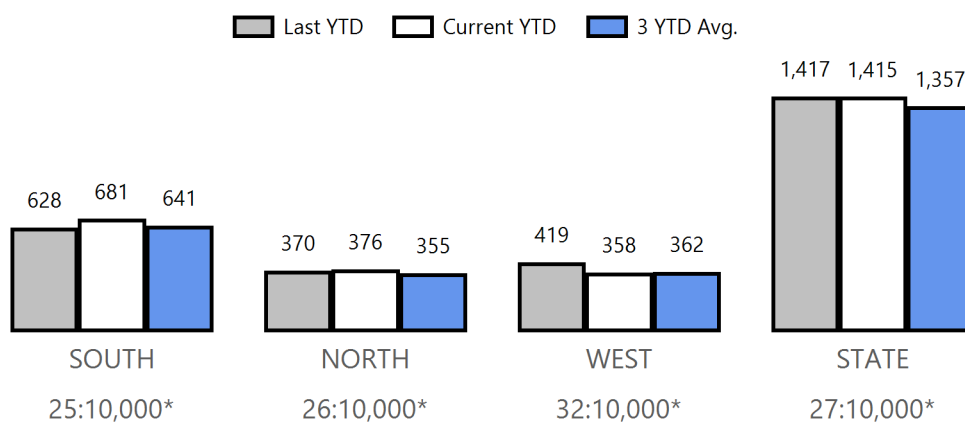

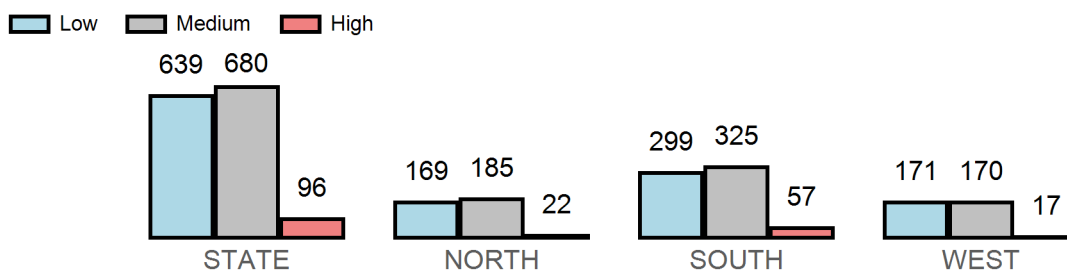
Family Violence Incidents - November 2019

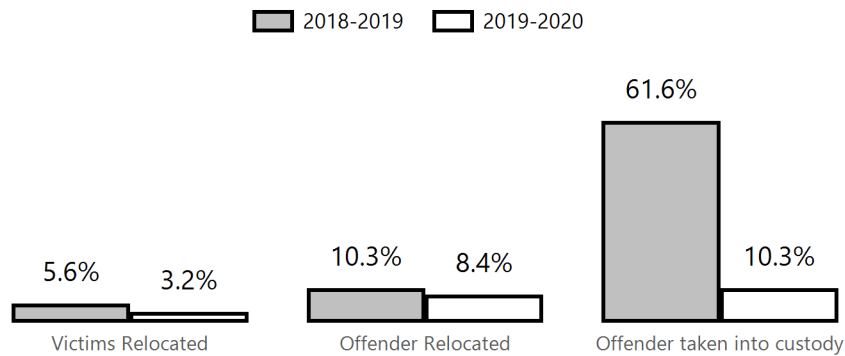

Family Violence RAST - Excludes Other and Argument Categories



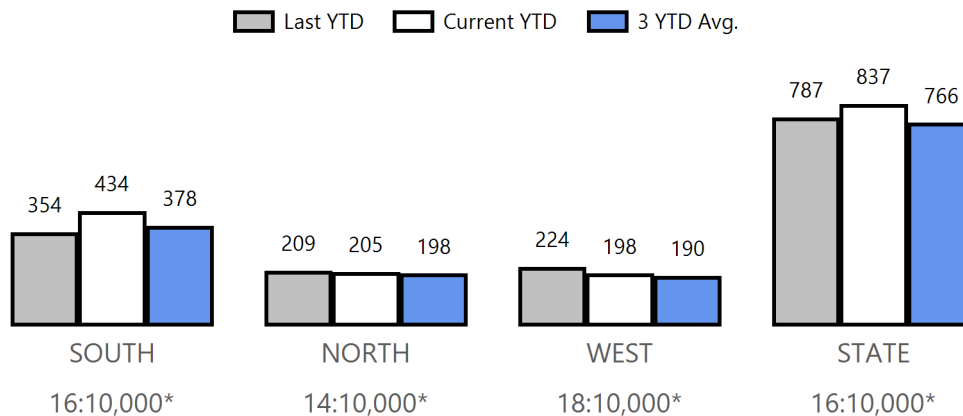

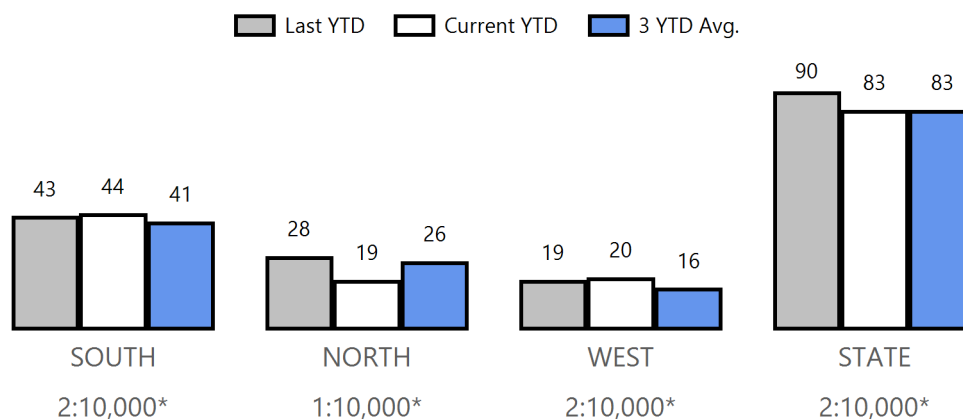
Family Violence : Juveniles Affected - November 2019

Family Violence : Weapons Present - November 2019



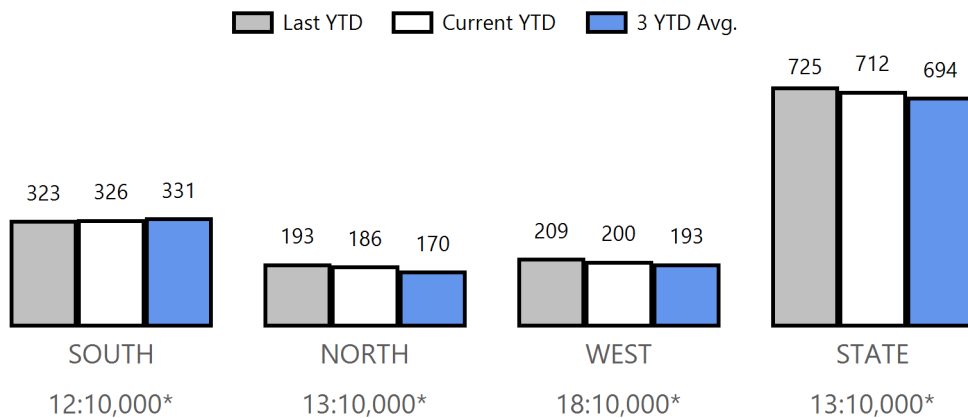

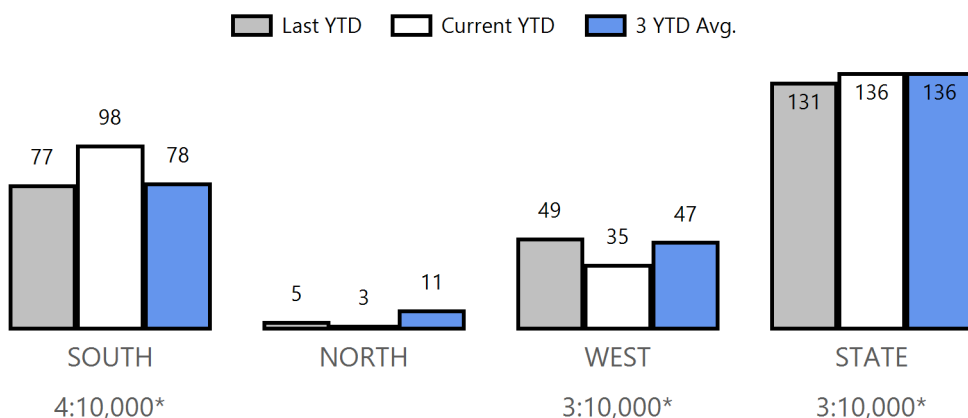
Family Violence Orders : Police Issued - November 2019

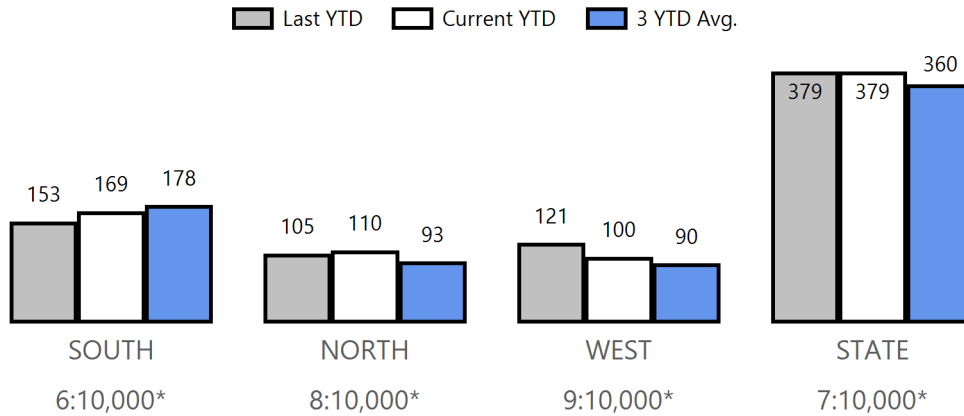
Family Violence Orders : Court Application - November 2019

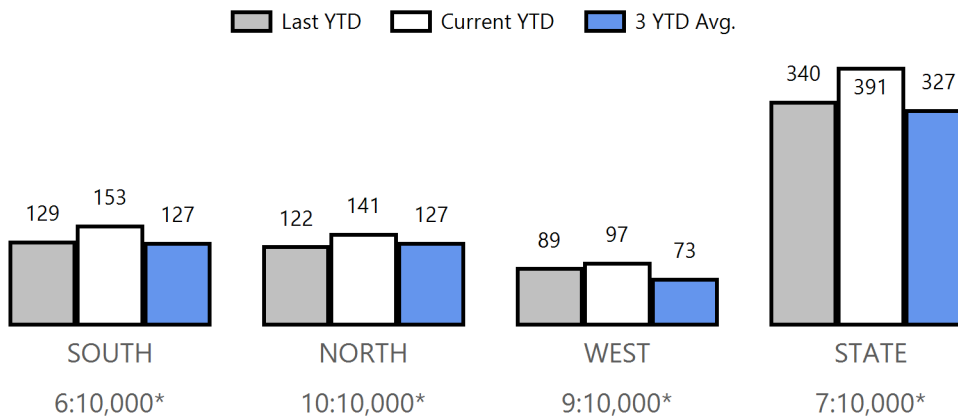
Family Violence - PFVO Breaches - November 2019

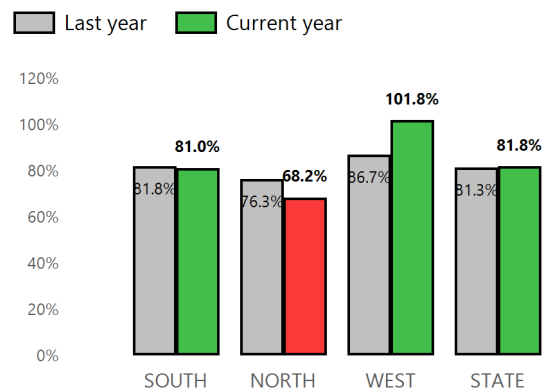

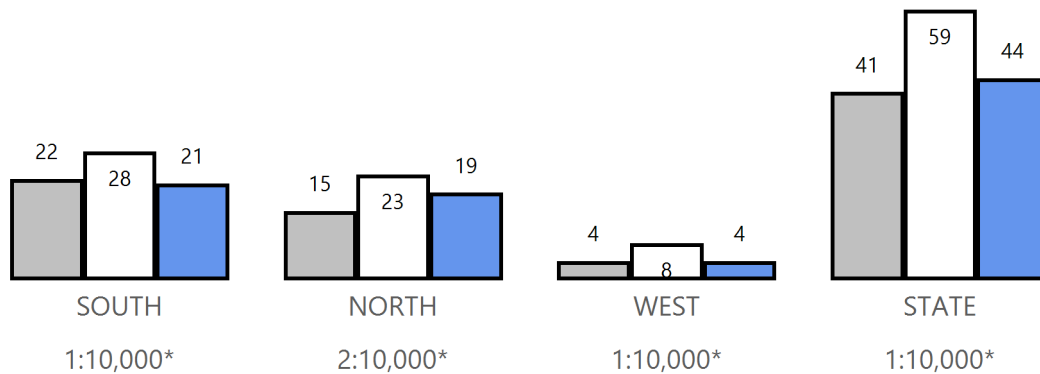

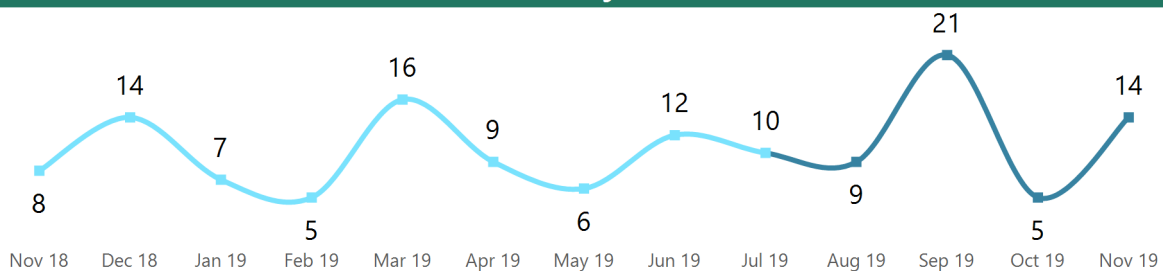

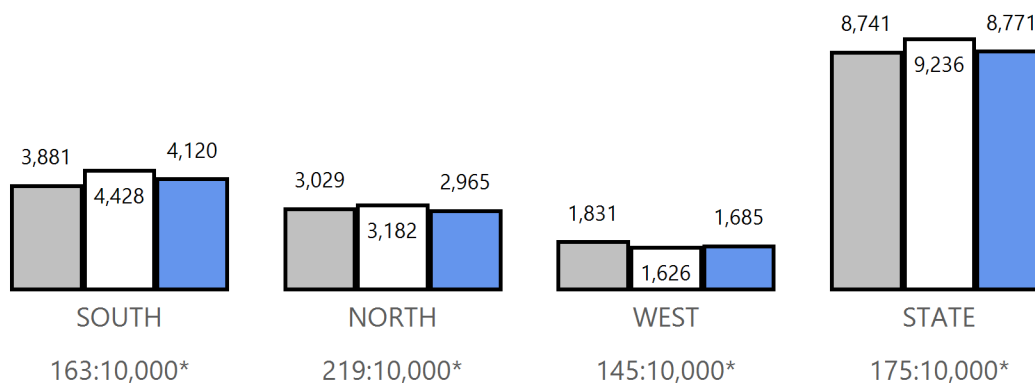

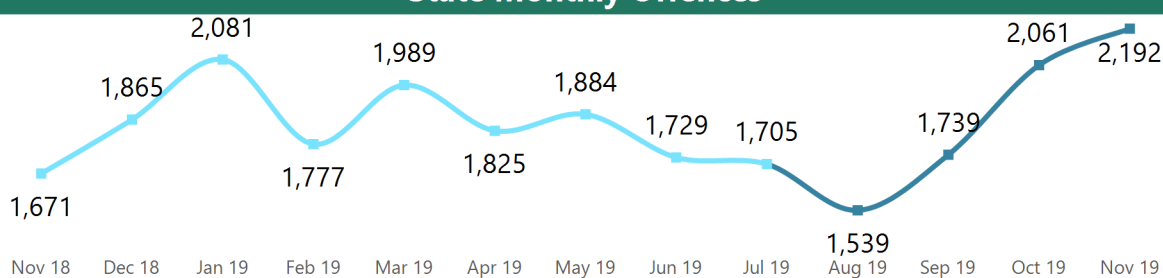

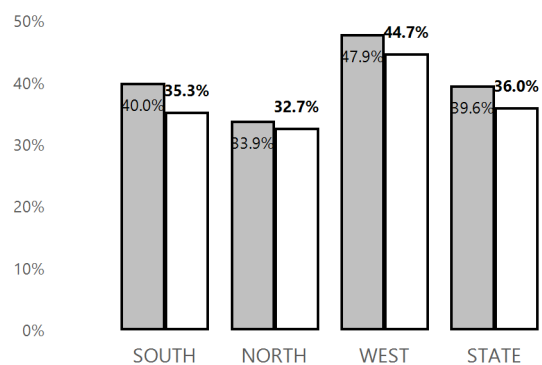

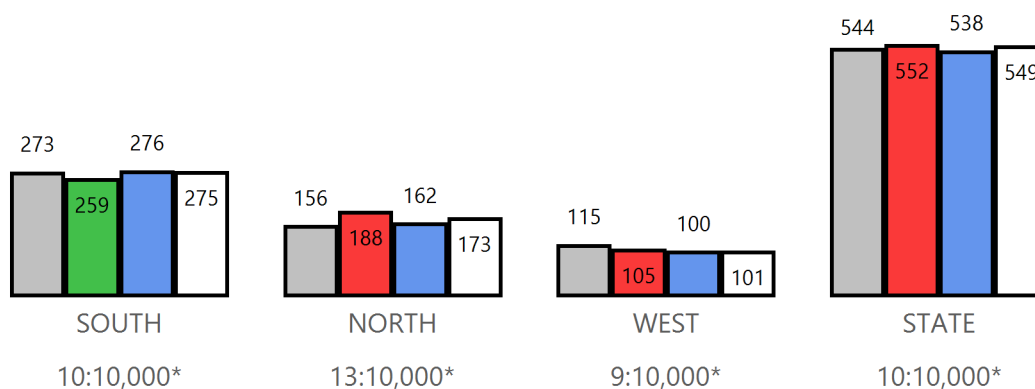

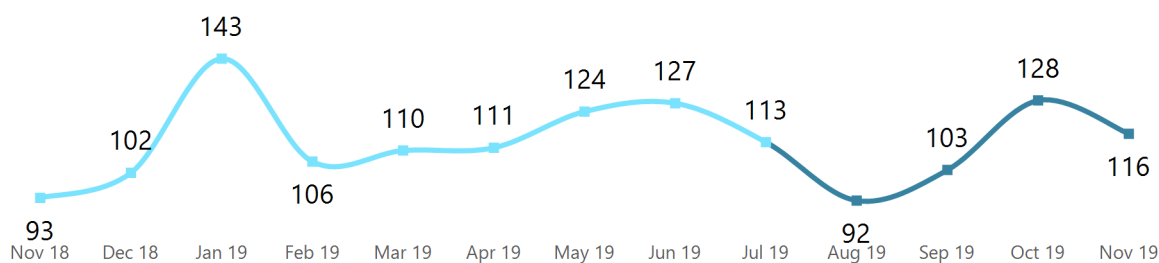

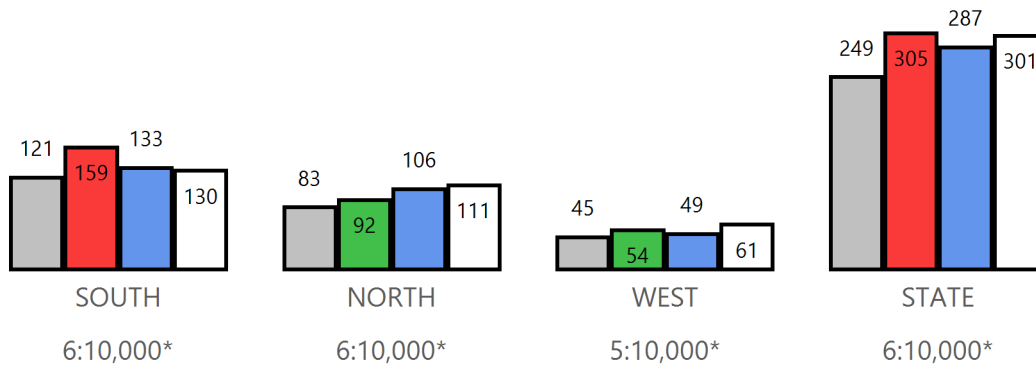

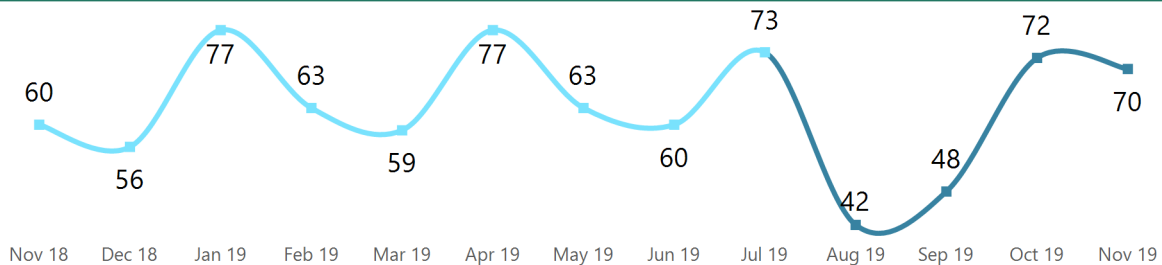

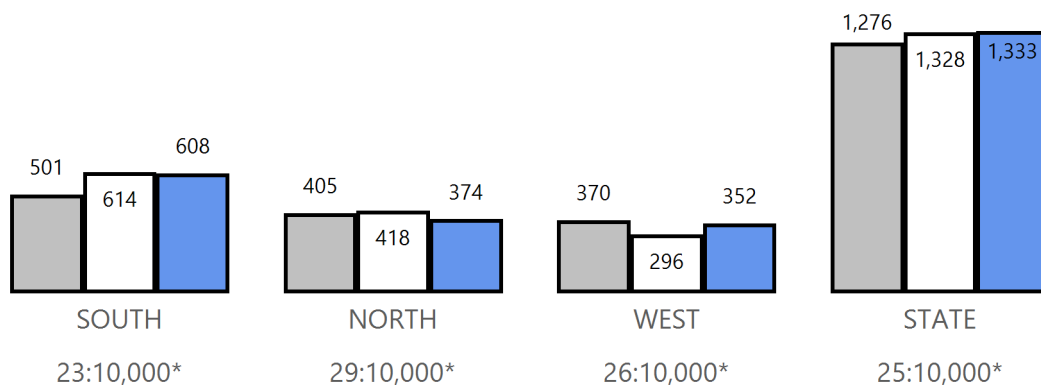

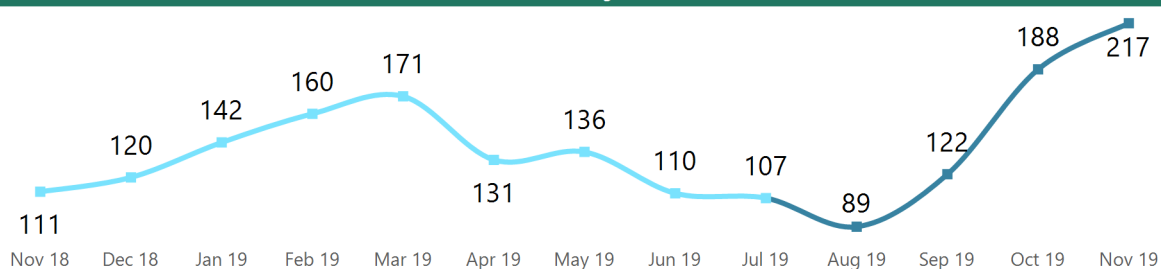

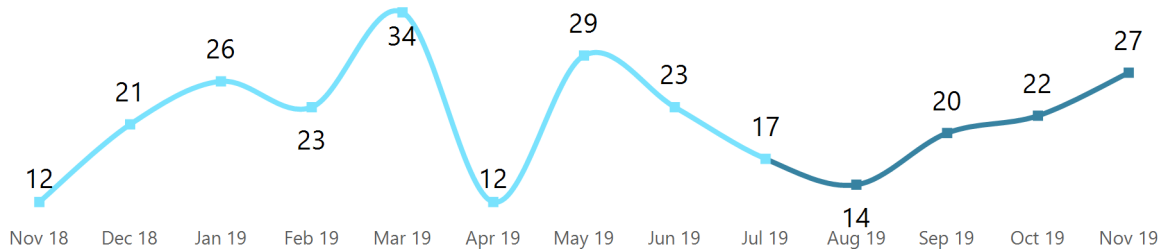
SMV : Fire Damaged - November 2019

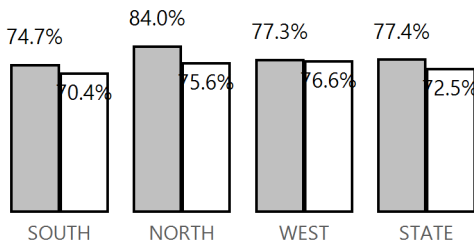

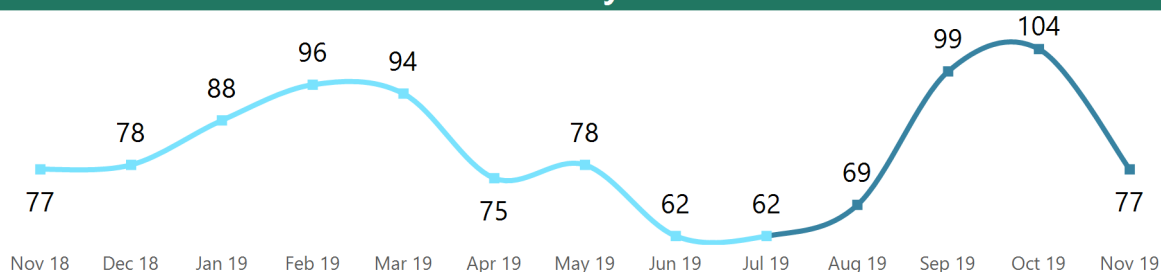

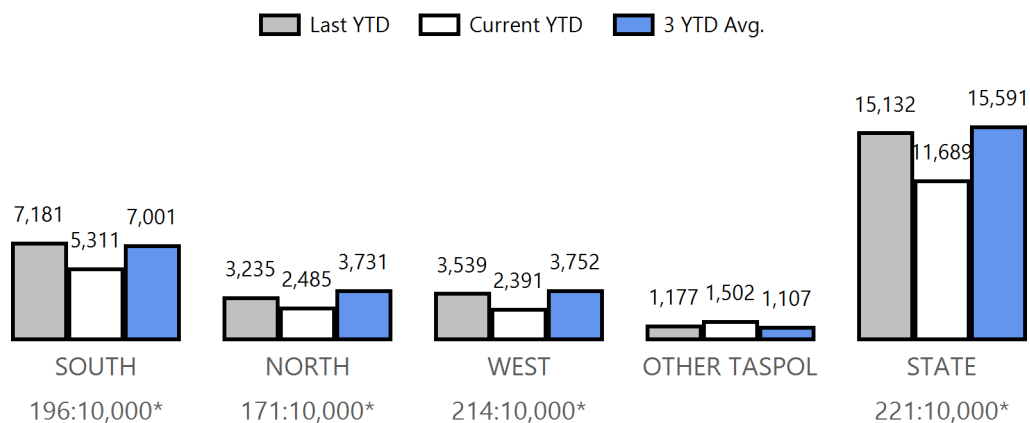

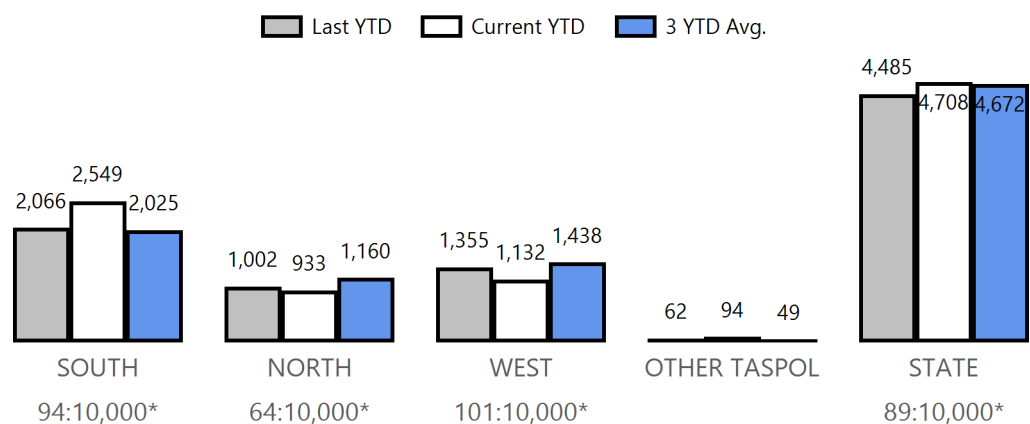

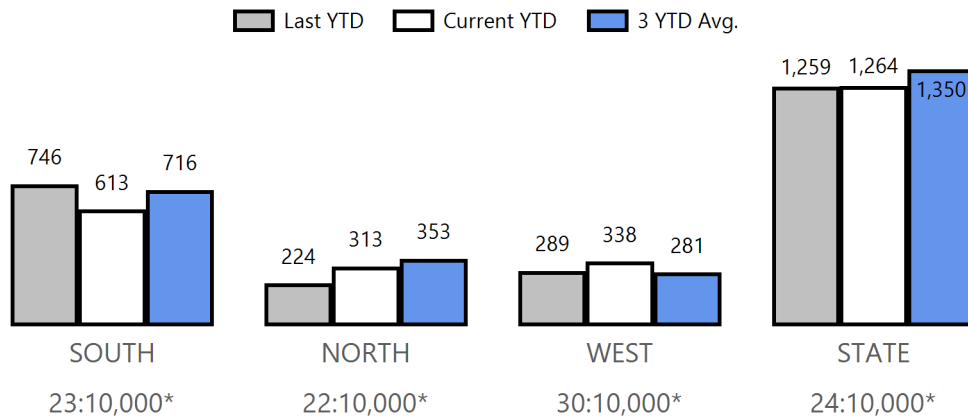
Total Street Checks - November 2019

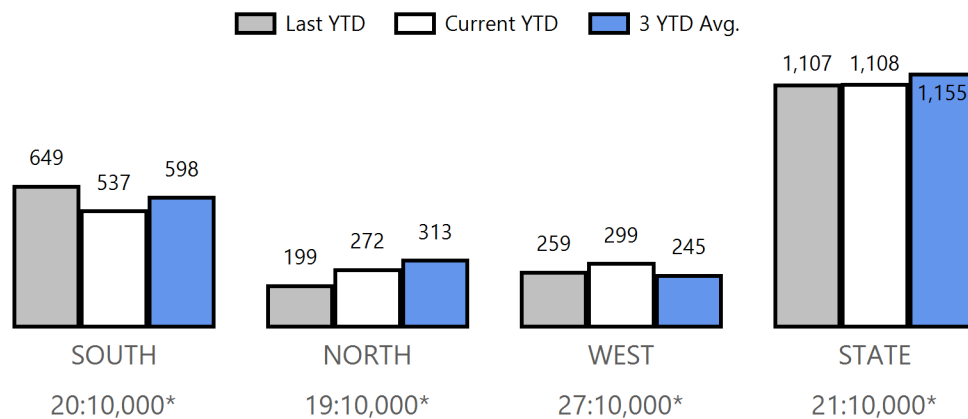
CIB: Total Offenders - November 2019

CIB: Total Crime Offenders - November 2019



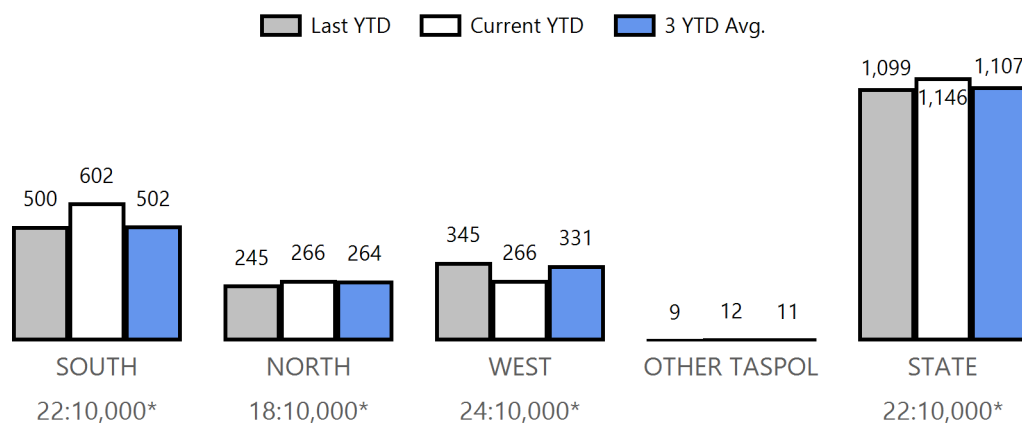

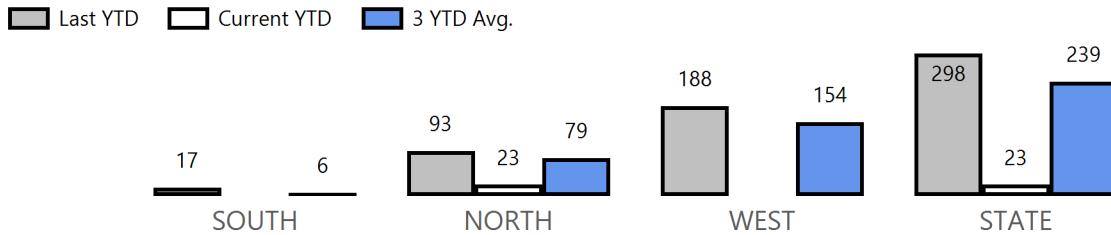

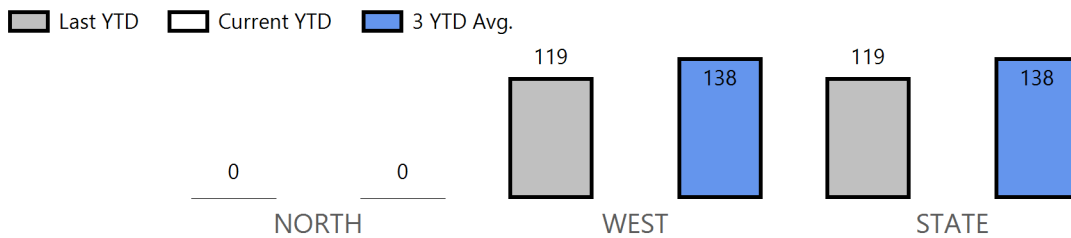
Drug Detector Dogs - Deployments - November 2019



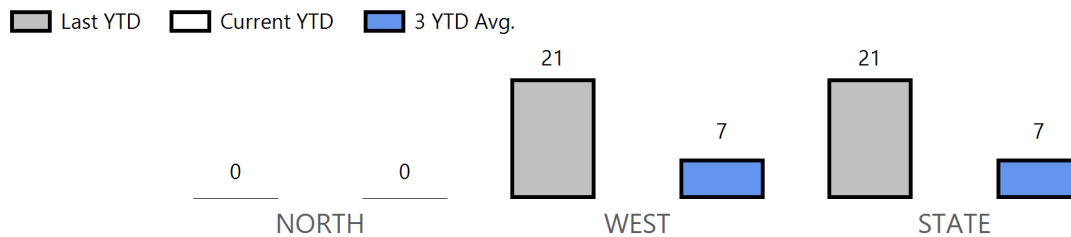
Drug Detector Dogs - Drug Detections - November 2019



Explosive Detector Dog - Deployments - November 2019

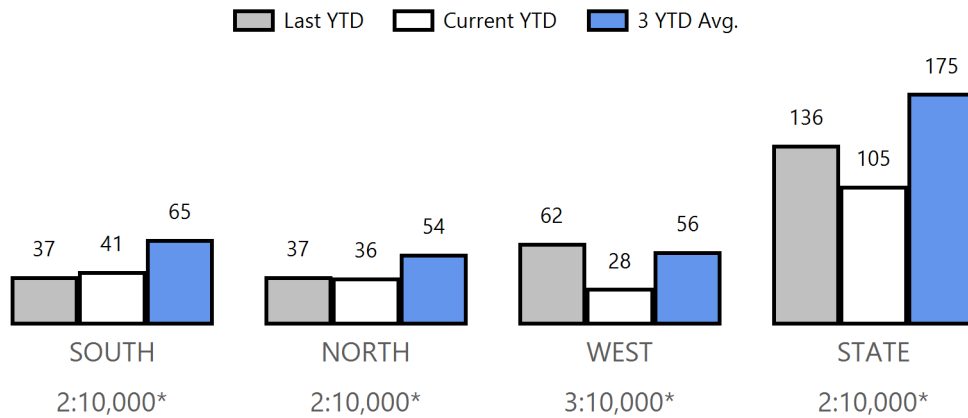


Explosive Detector Dog - Detections - November 2019



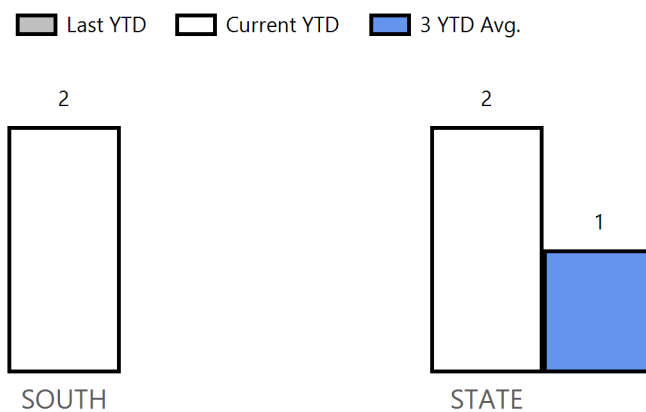

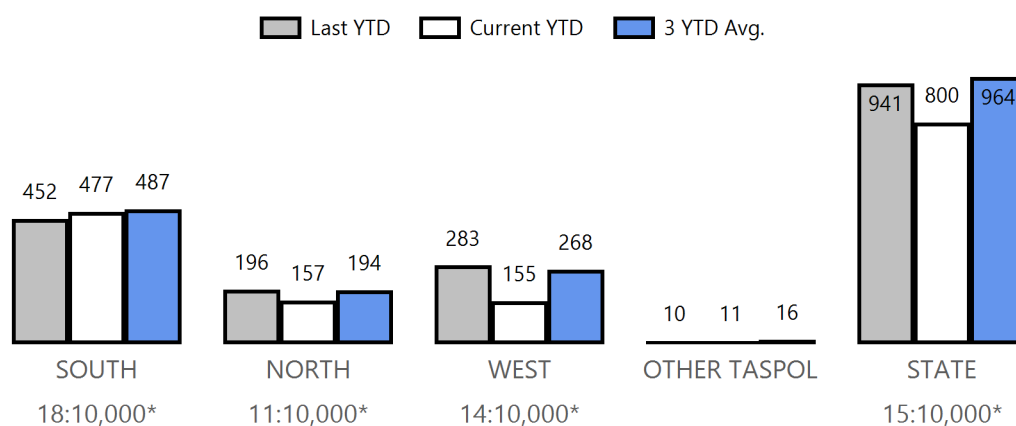

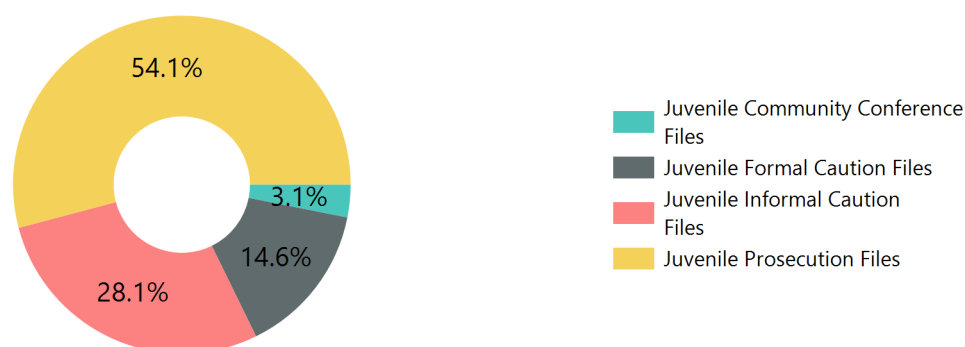

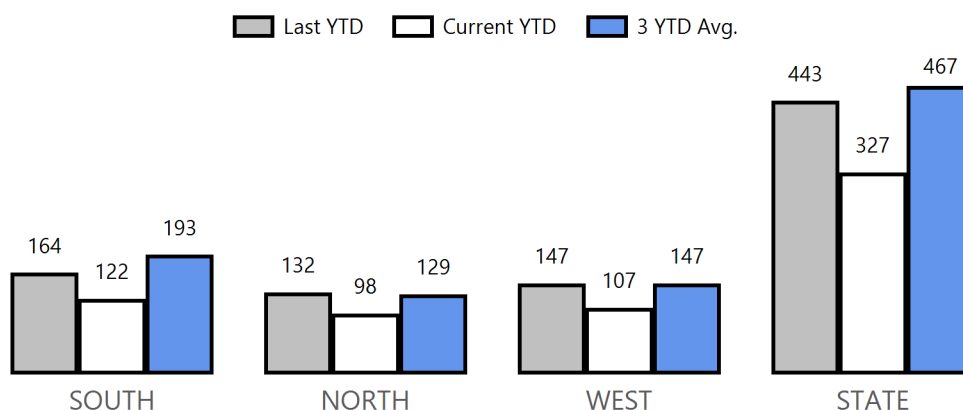
Major Traffic Operations - November 2019

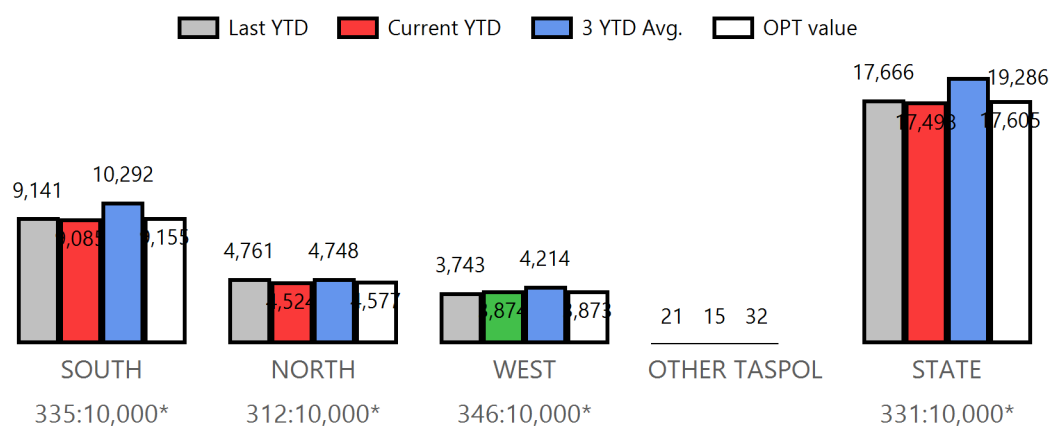

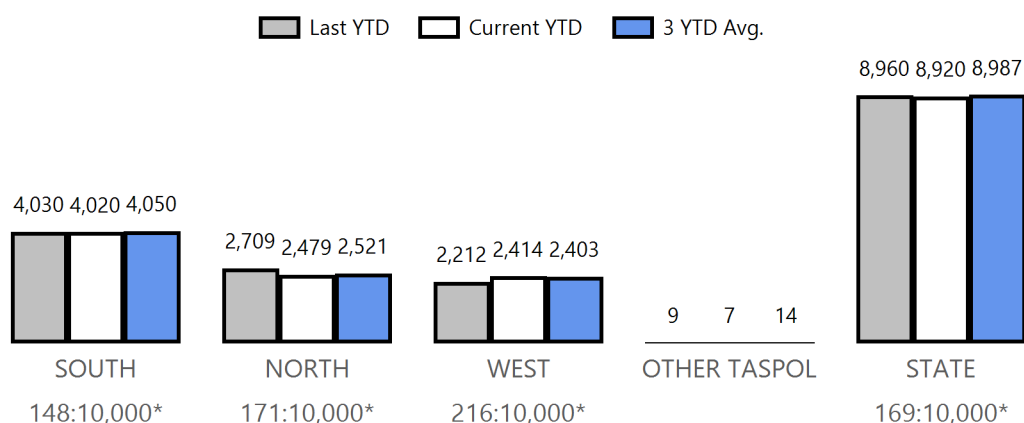
Speeding Offenders - November 2019

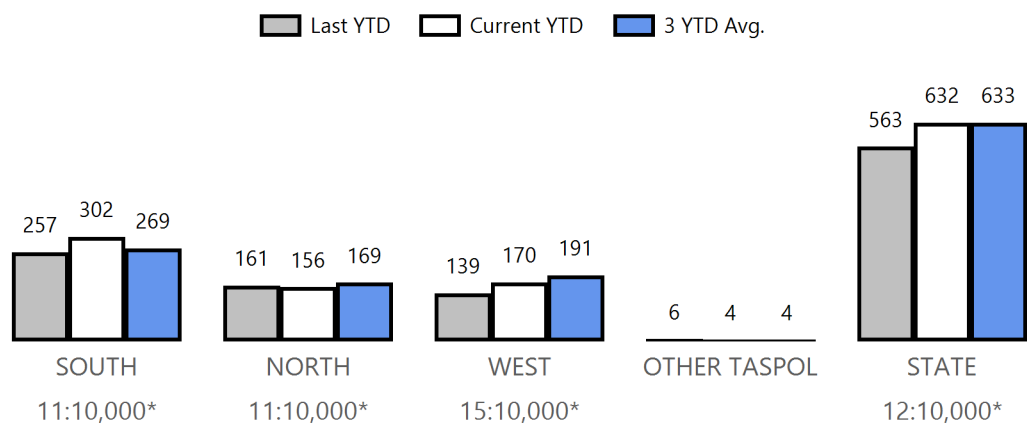
Excessive Speed Offenders - 15-29km/h - November 2019

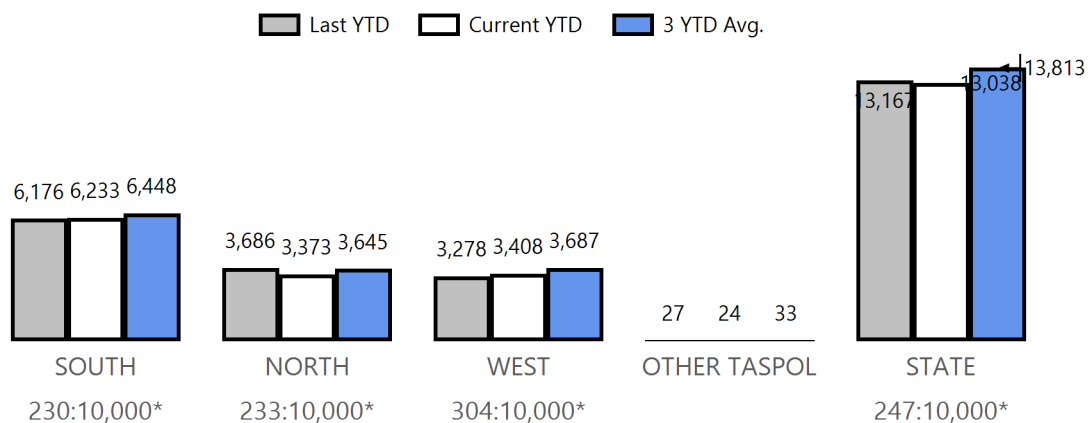
Excessive Speed Offenders - 30km/h + - November 2019

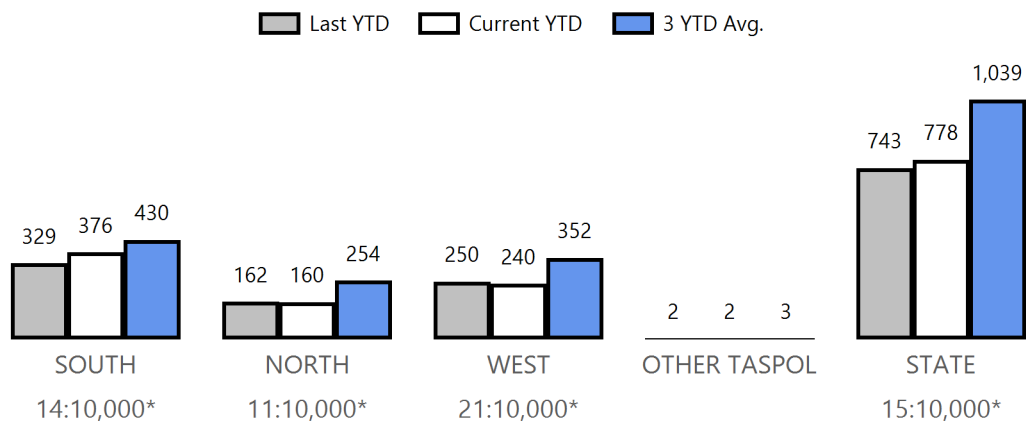
High Risk Offenders - November 2019

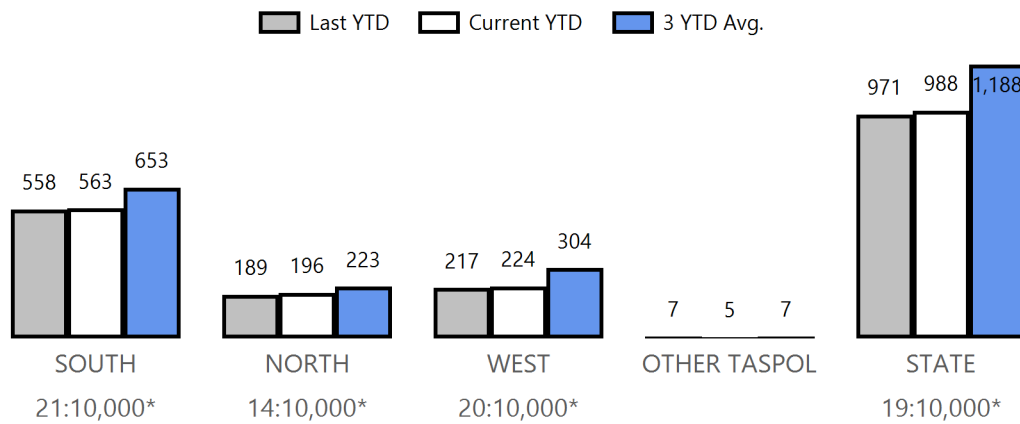
Seatbelt Compliance Offenders - November 2019

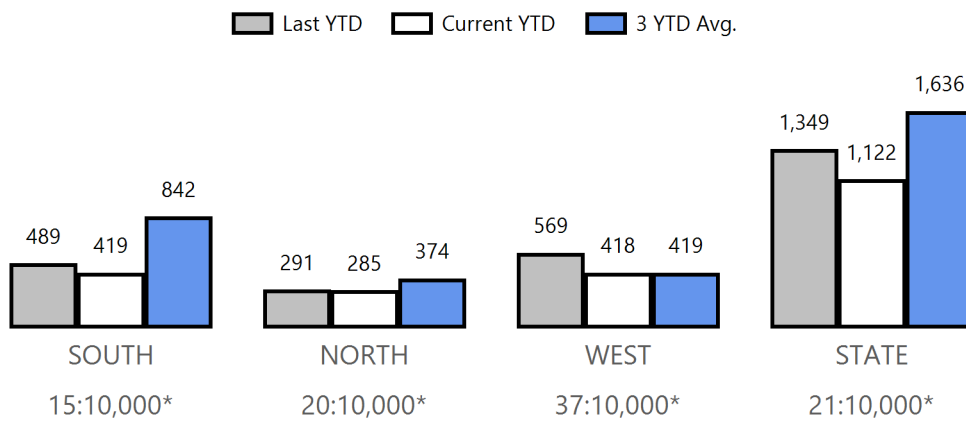
Mobile Phone Offenders - November 2019

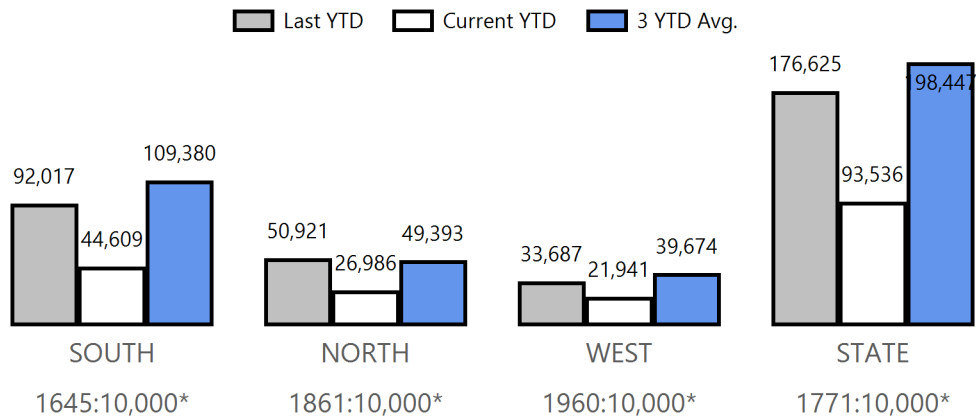
Vehicle Defect Notices - November 2019

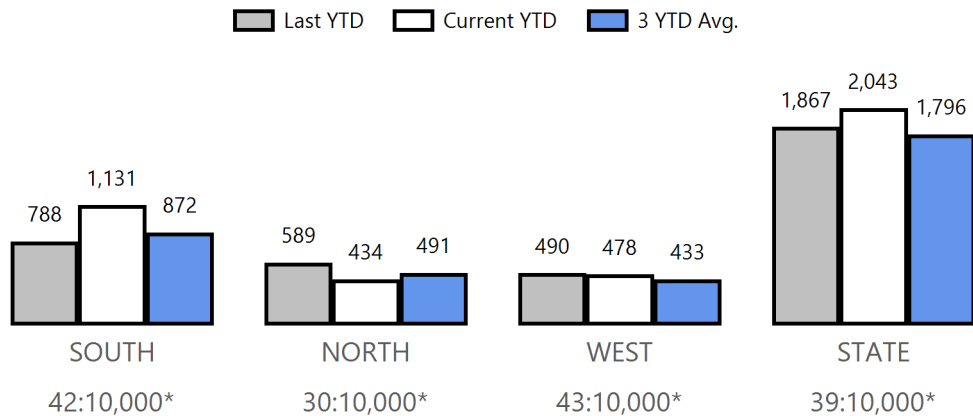
Random Breath Tests (ALCOHOL) - November 2019

Oral Fluid Tests (Drugs) - November 2019



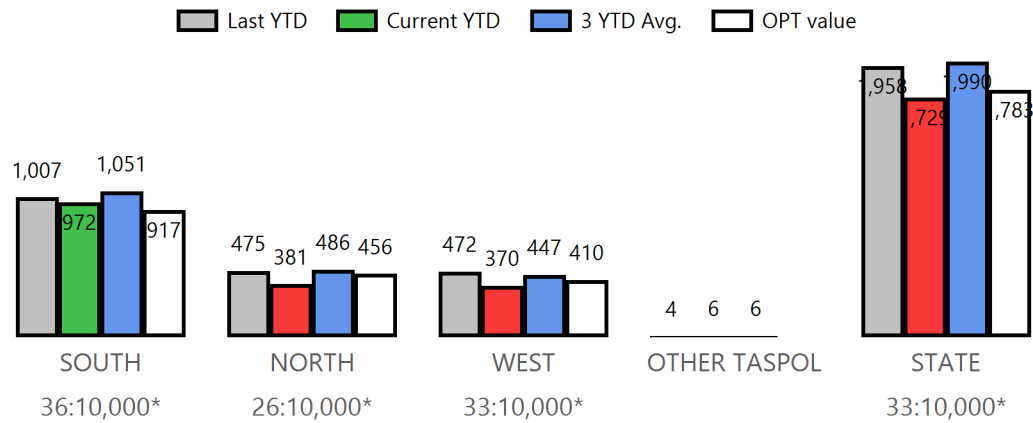

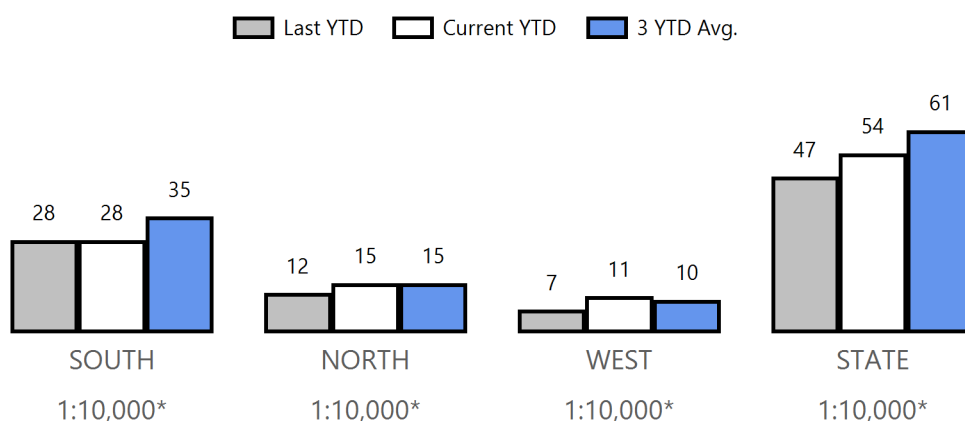

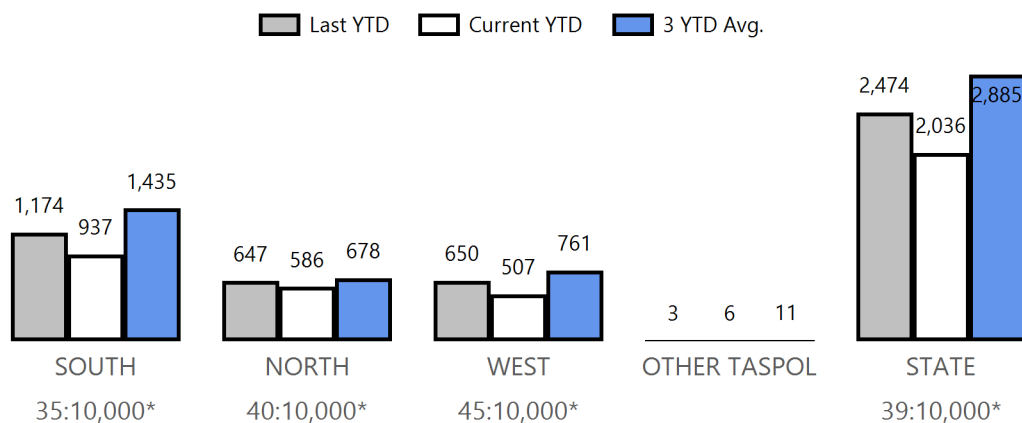

Disqualified and Unlicensed Driving Offenders - November 2019



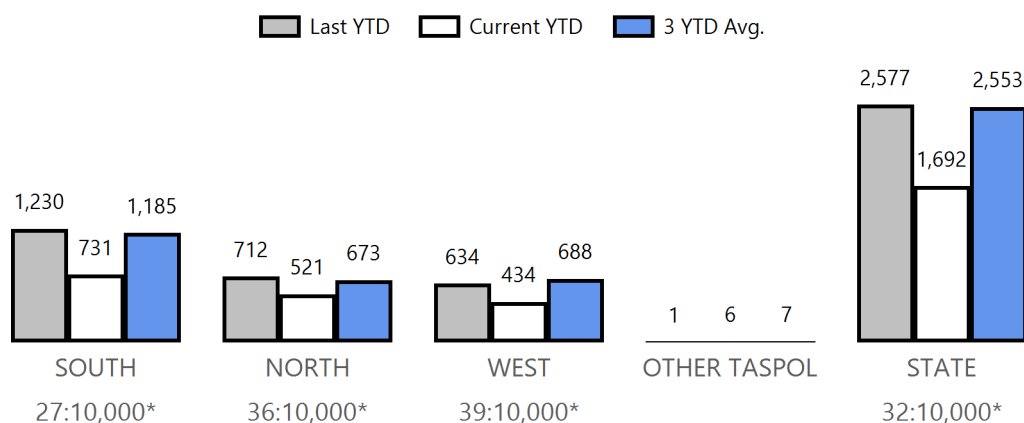

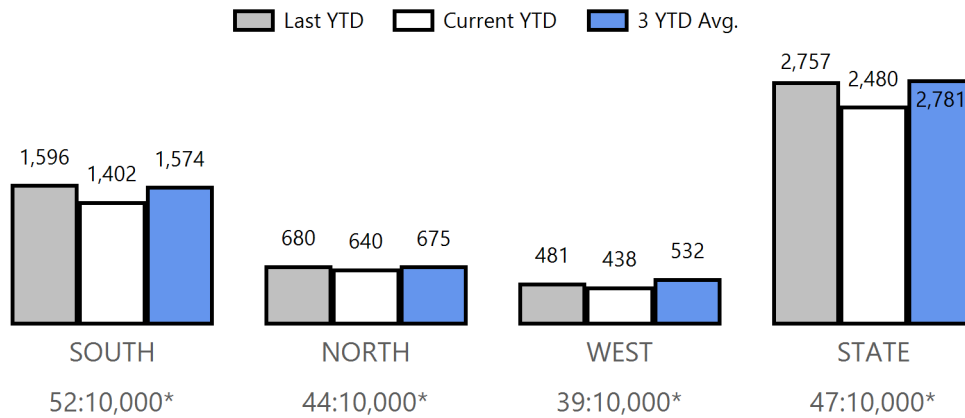
Unregistered Vehicle Offenders - November 2019

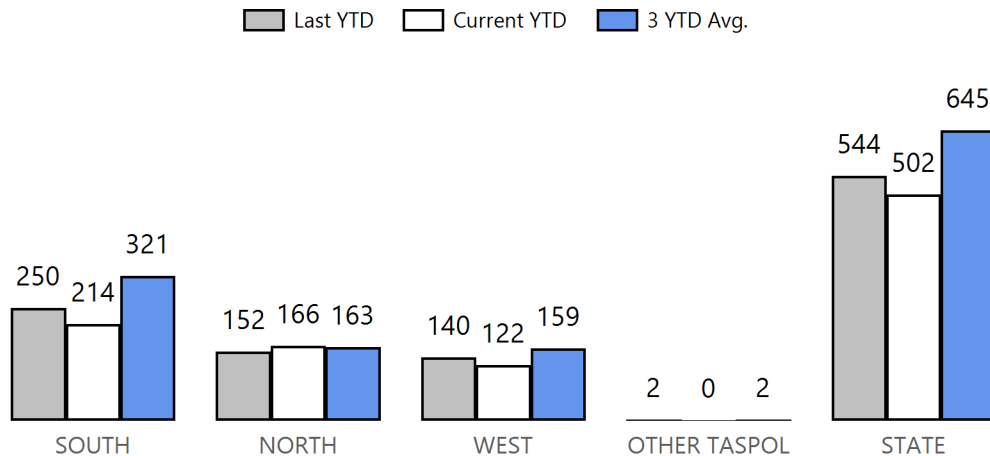
Vehicle Complaints made to RDS - November 2019

Vehicles Clamped or Confiscated - November 2019



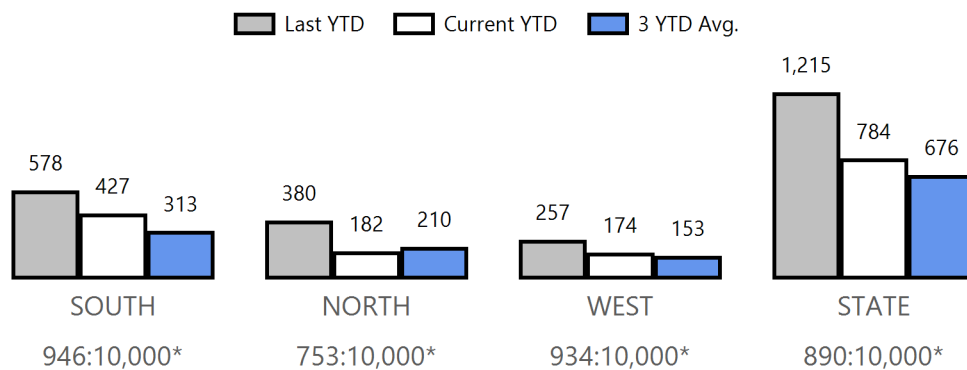

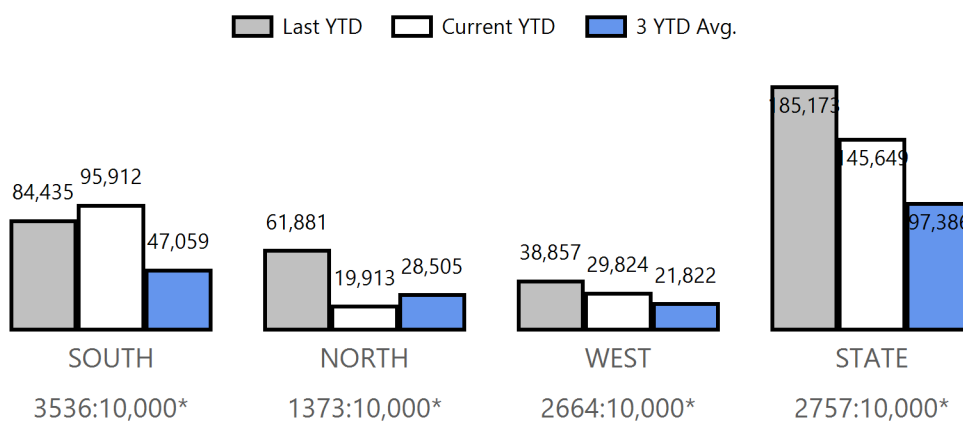
Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - November 2019

ANPR: Total Vehicles Captured - November 2019



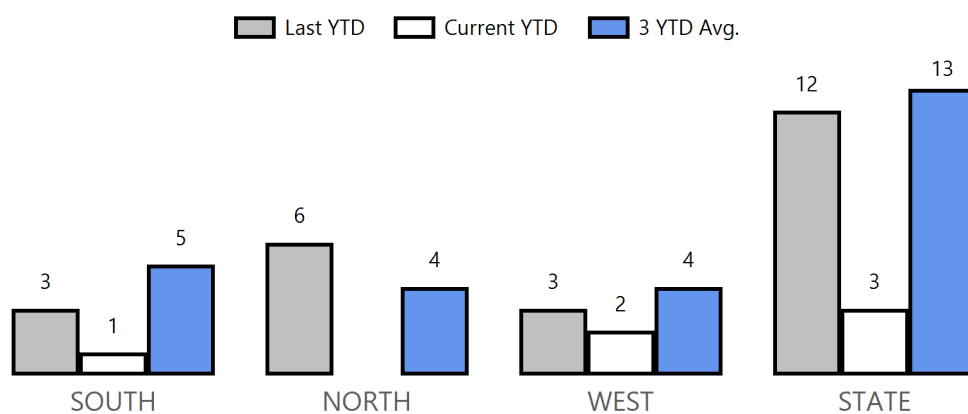

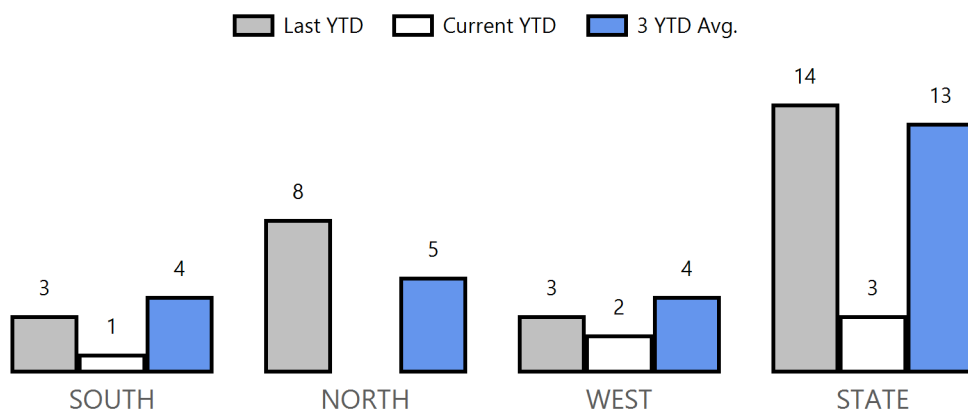
Road Crashes: Fatalities YTD - November 2019

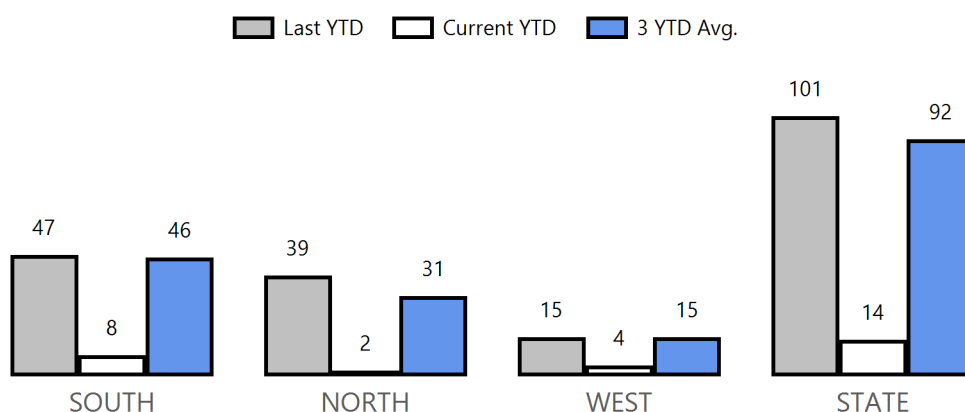
Fatal Crashes - November 2019

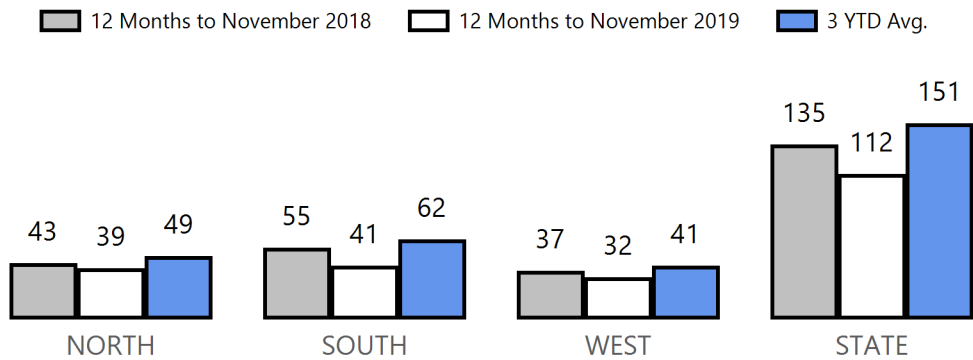

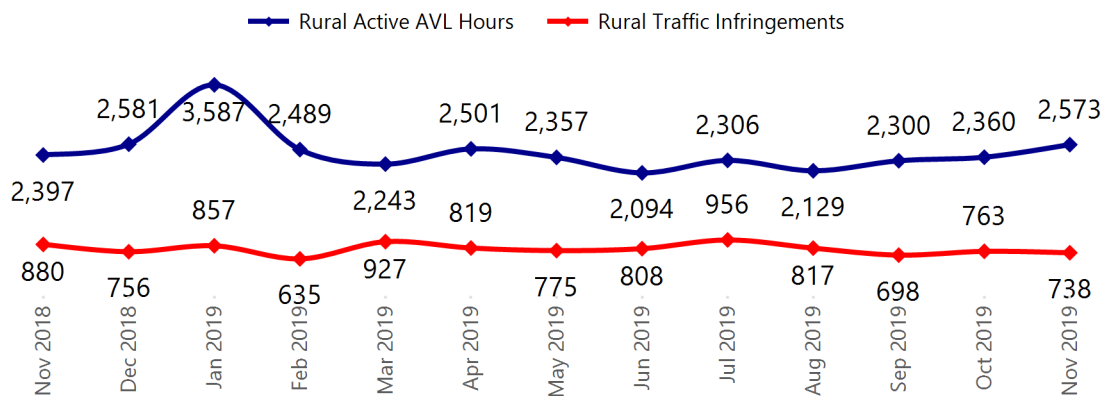
On Road Fatal and Serious Crashes in Rural Areas (Over the last 12 months)



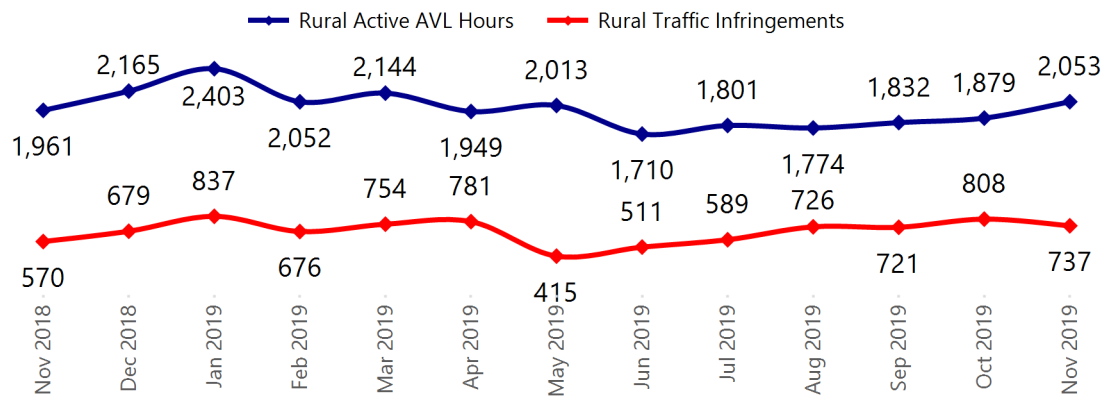

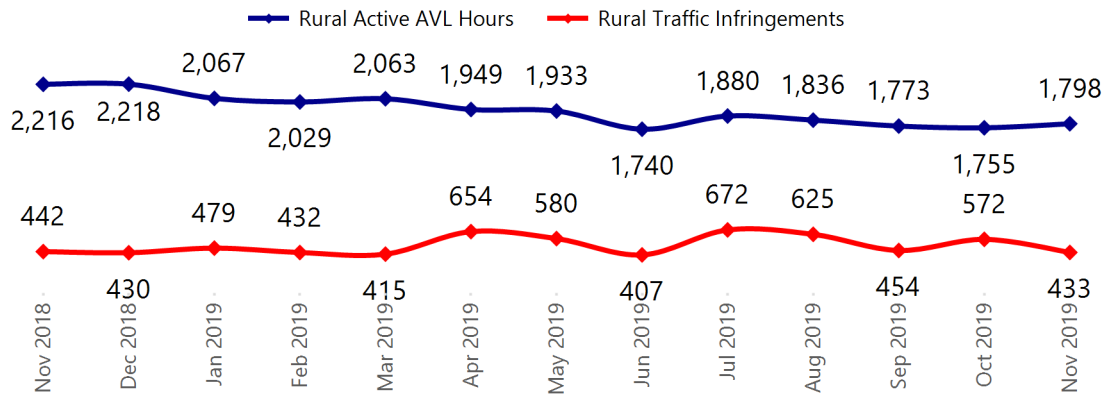
Southern District Rural Policing



Northern District Rural Policing

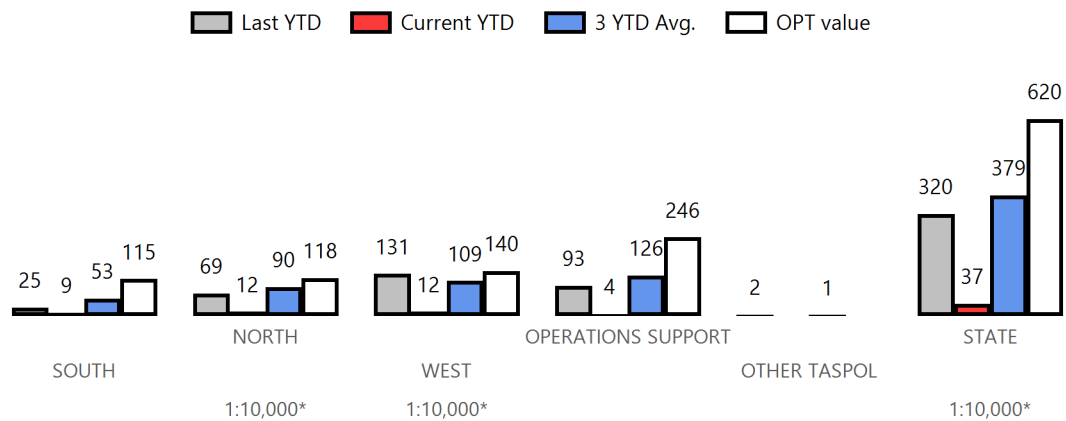

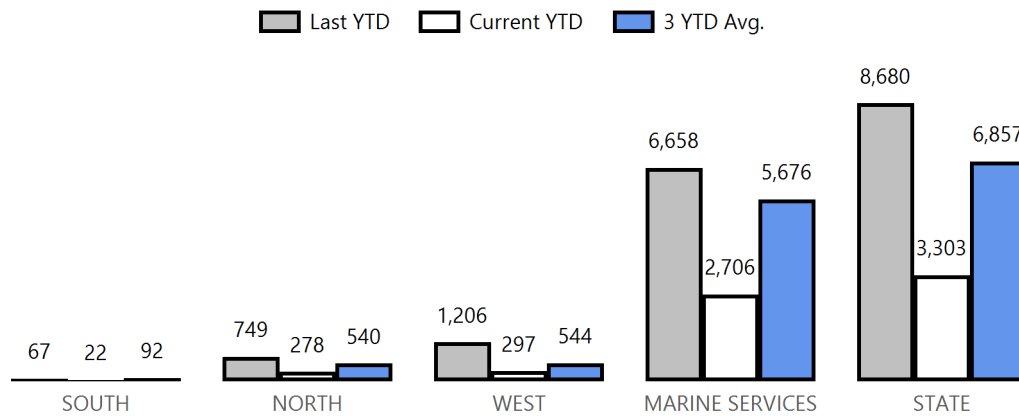

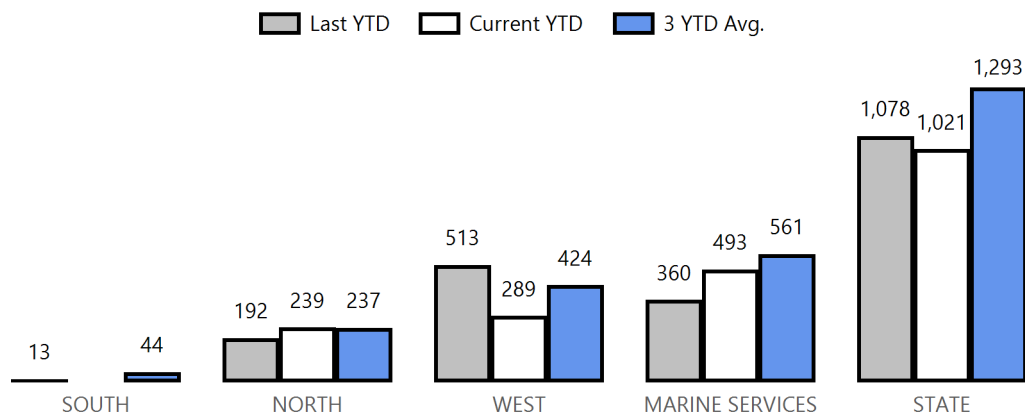


Sea Inspections (Vessel & Non-Vessel) - November 2019



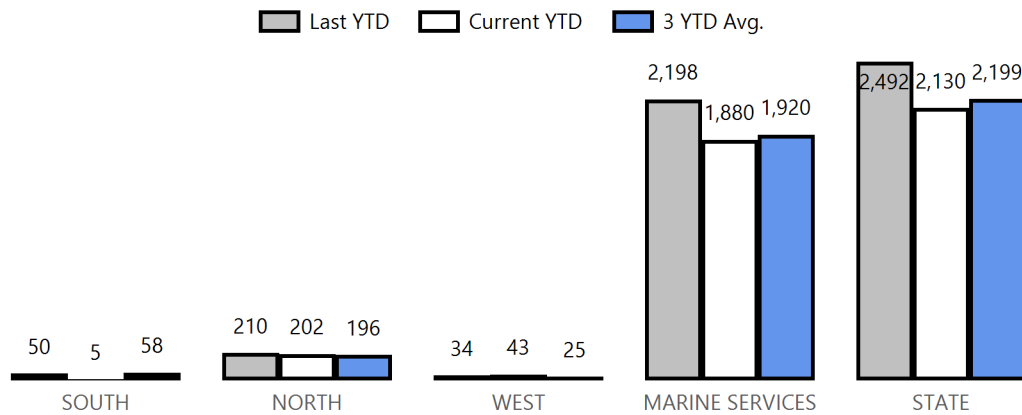

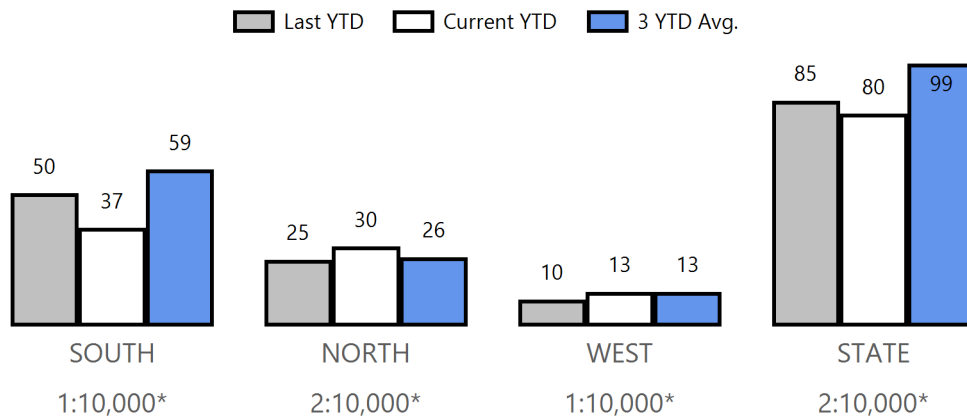

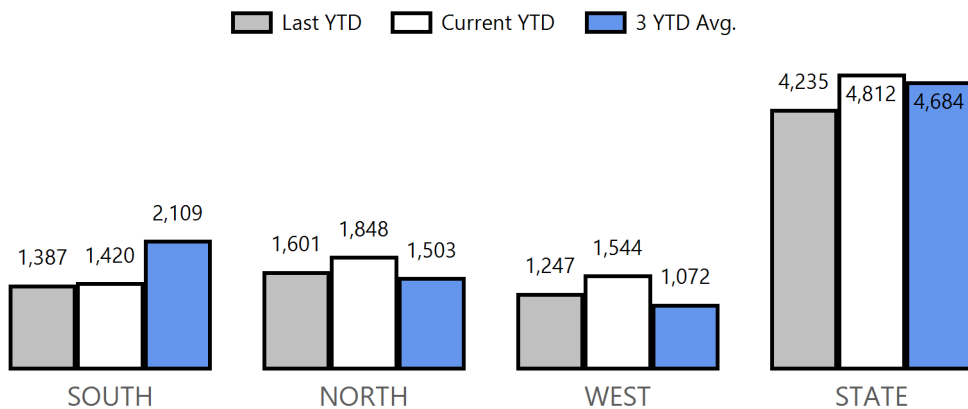
Search and Rescue Operations - November 2019
