Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 10 May 2023. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

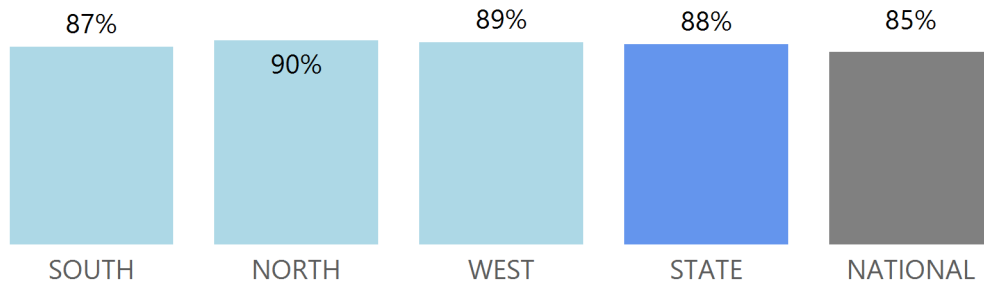

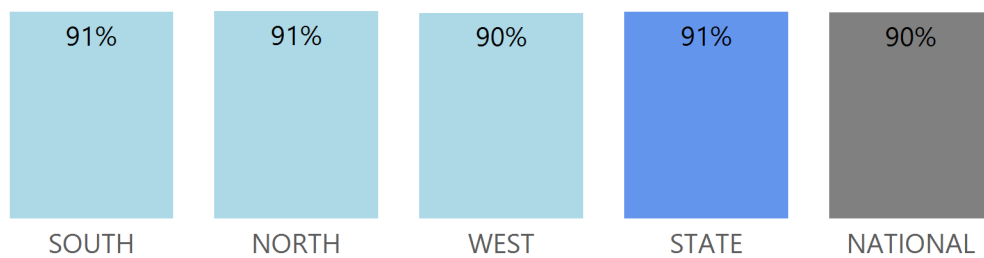
Safety at Home During the Night

(Survey respondents who answered "Safe/Very Safe".)



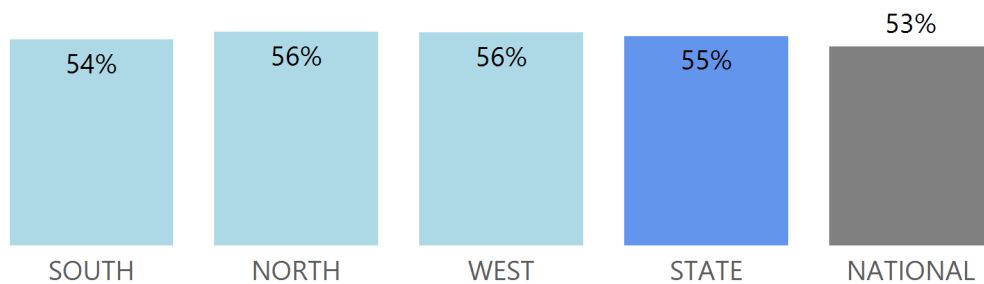
Safety In Neighbourhood During the Day

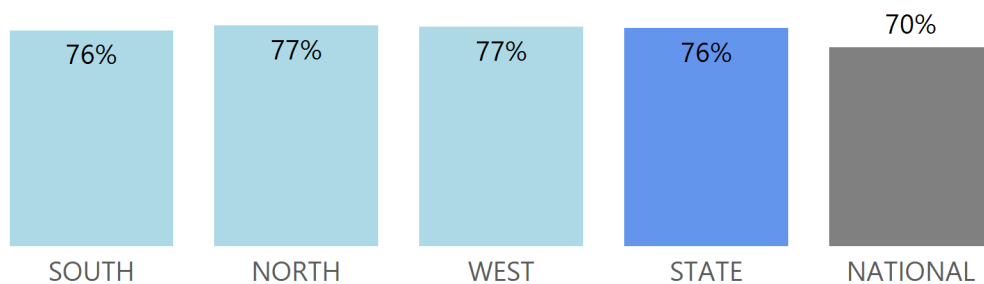

General Satisfaction with Police Services

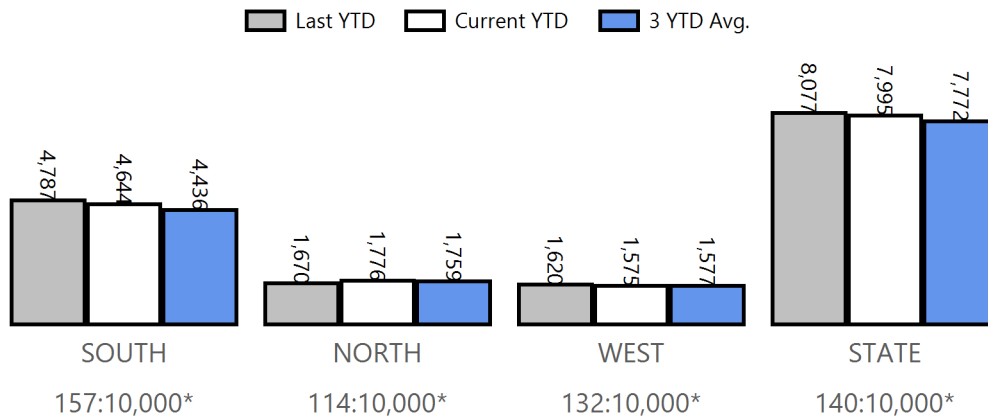

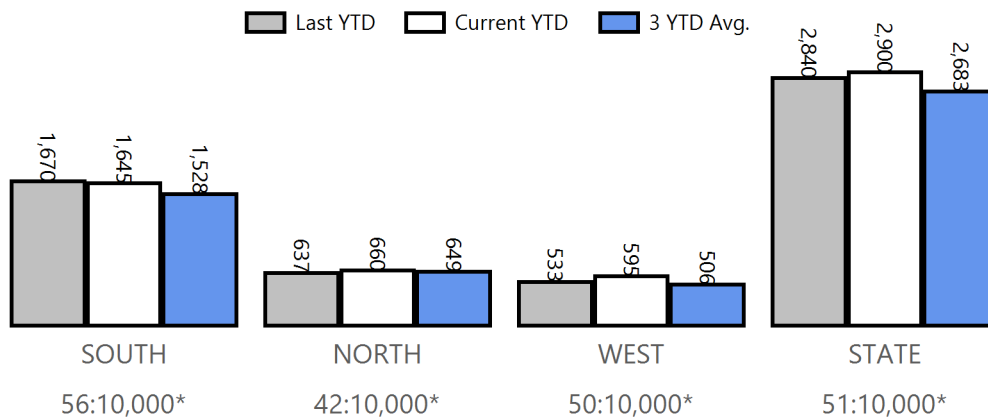
Public Order Incidents - November 2023

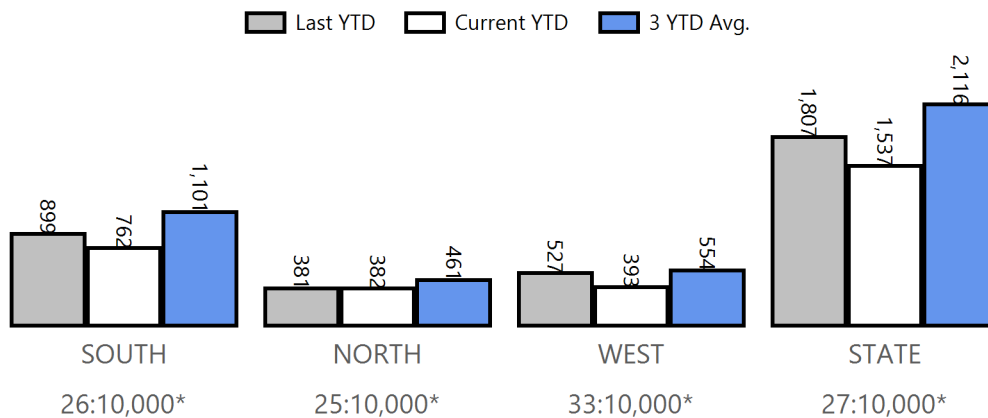
Public Order : Disturbance - November 2023

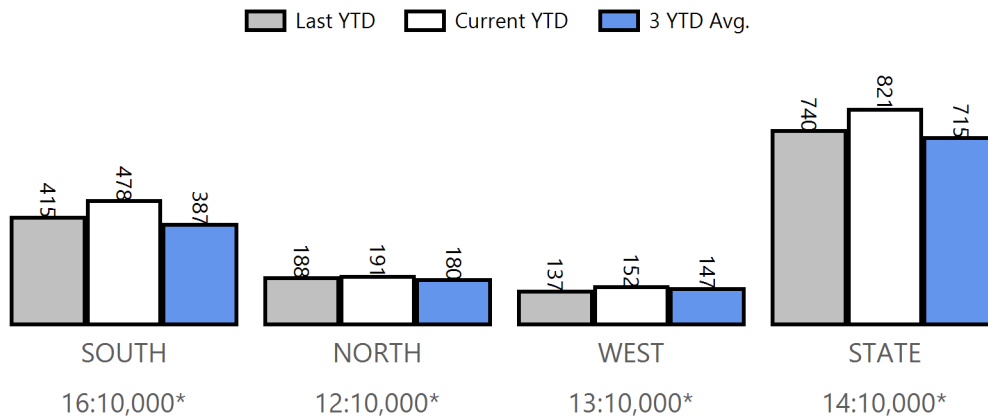
Public Order : Noise - November 2023

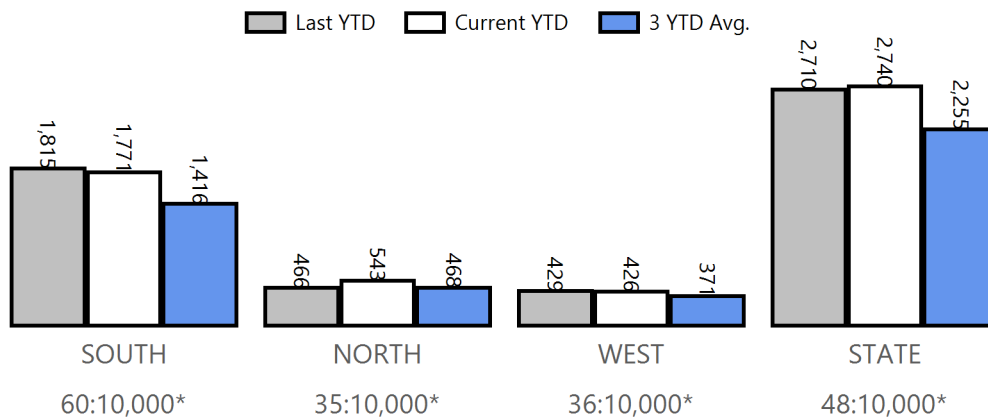
Public Order : Vandalism - November 2023

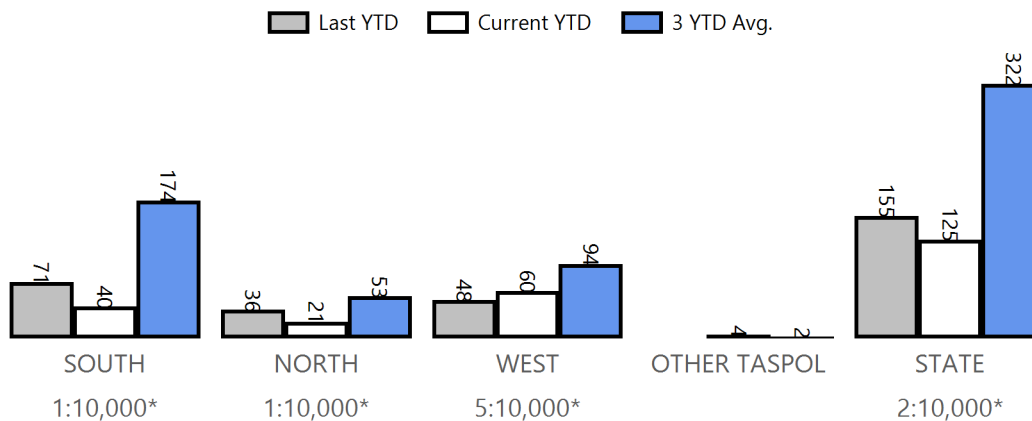
Public Order : Offensive Behaviour - November 2023

Liquor Infringement Notices - November 2023

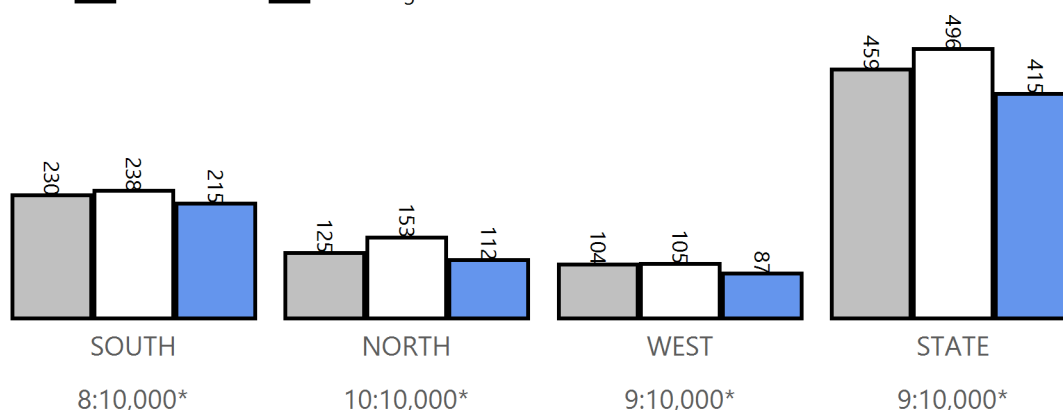

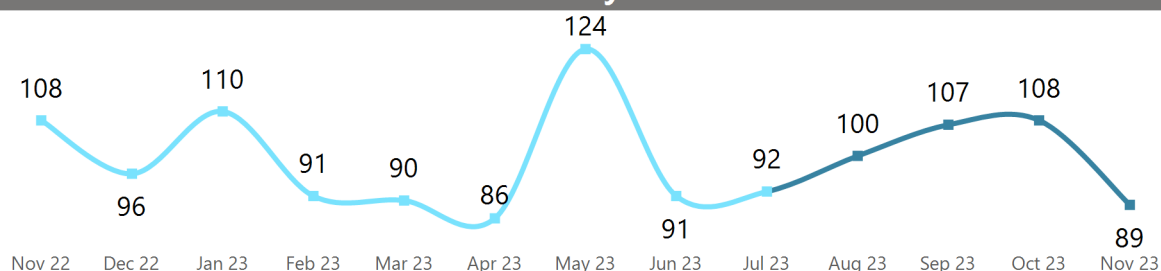

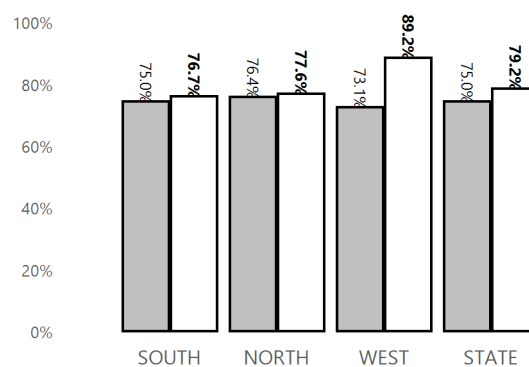

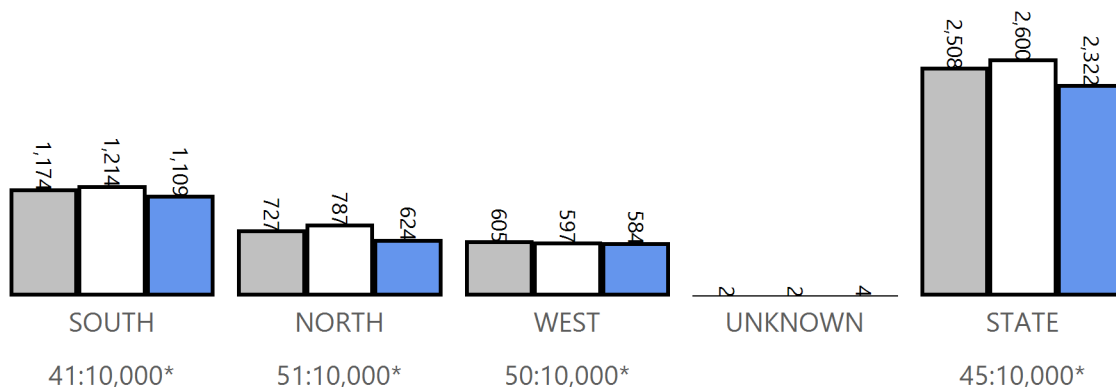

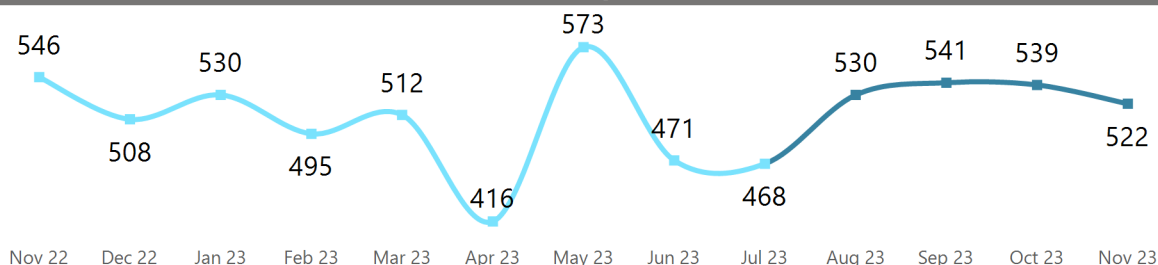

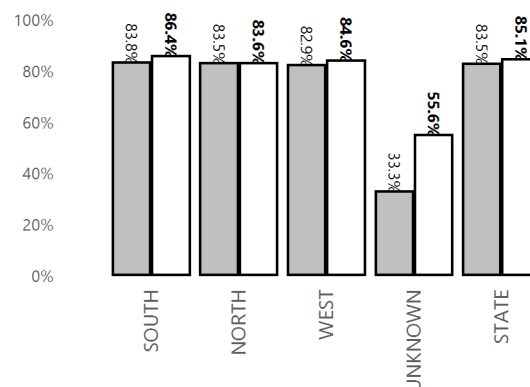

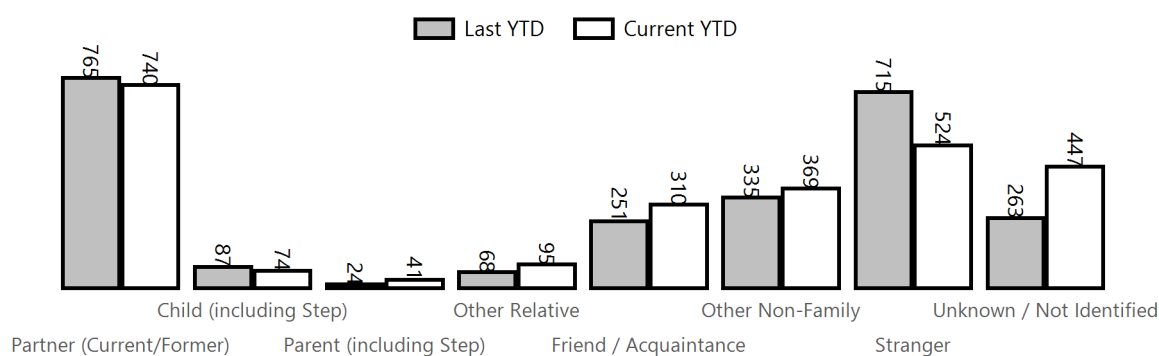

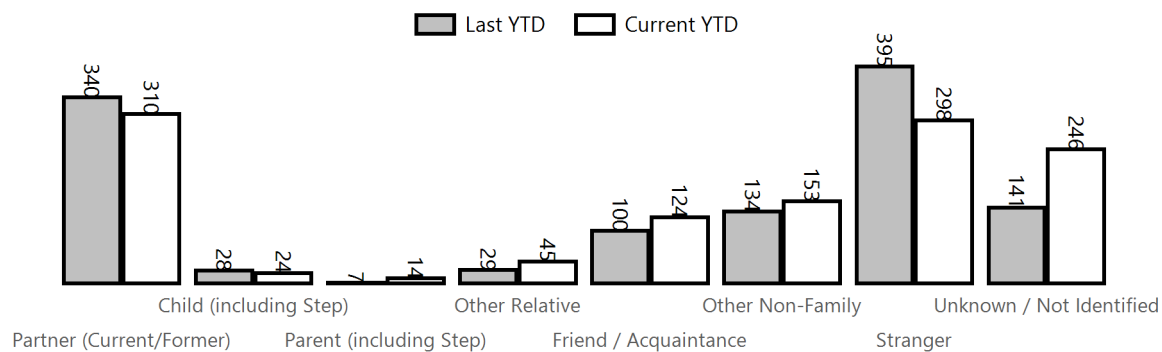

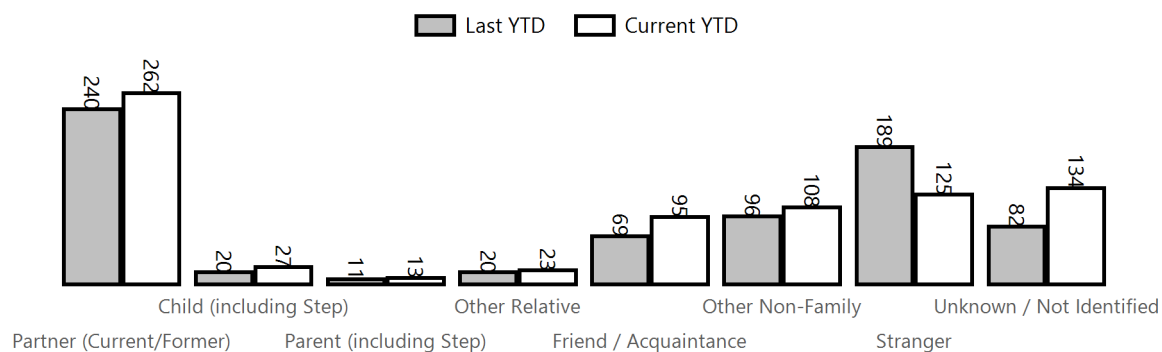

Total Person Offences - Victim Relationship - SOUTH



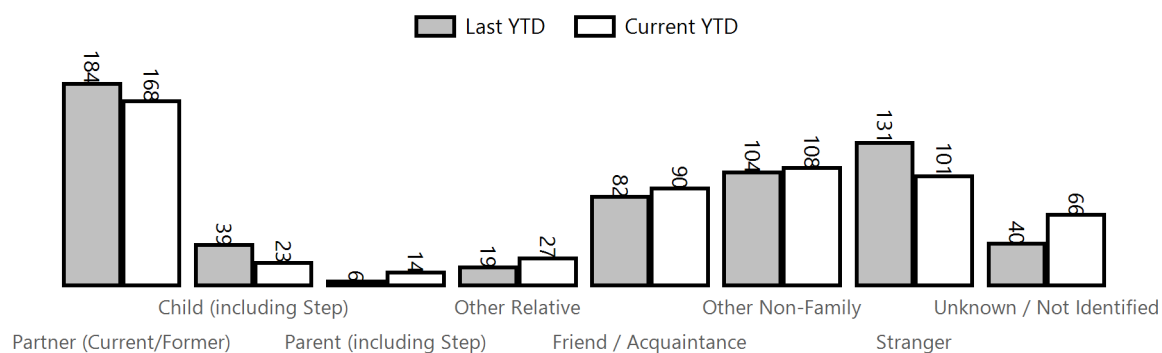

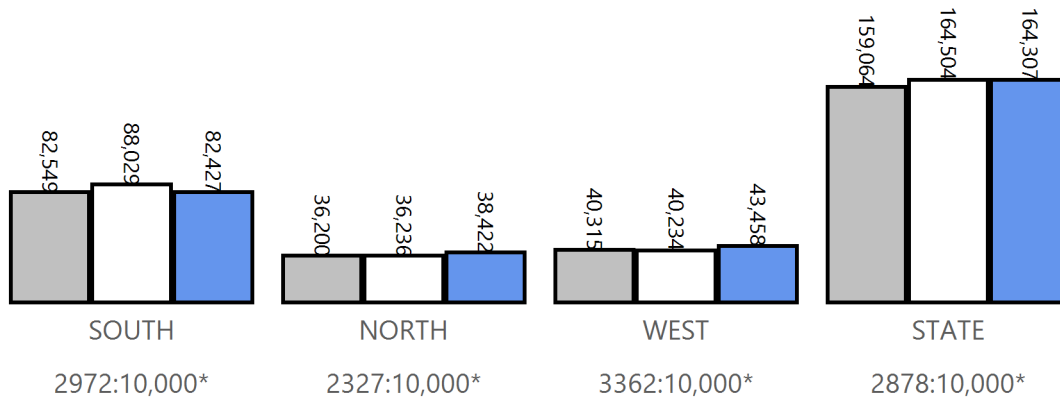

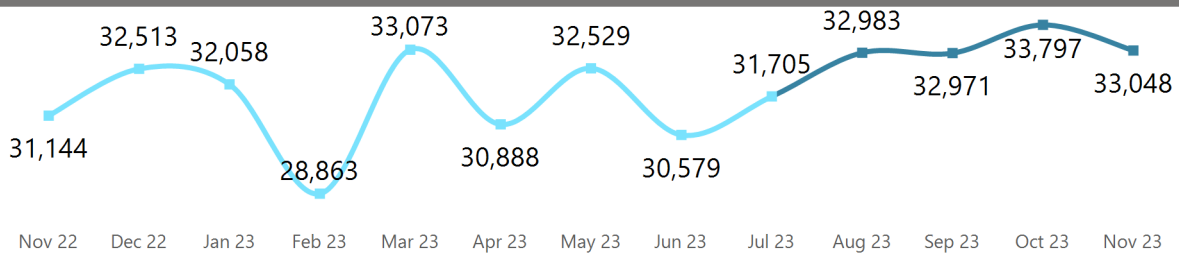
Uniform Police Patrol Hours - November 2023

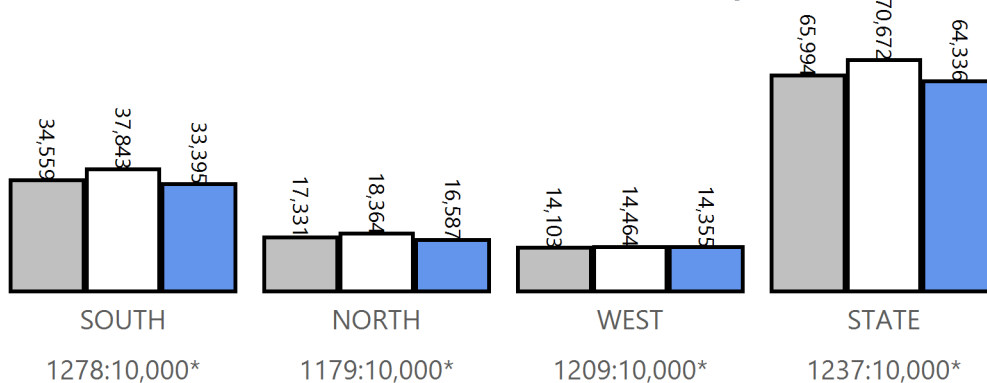
Uniform Police - Patrol Hours

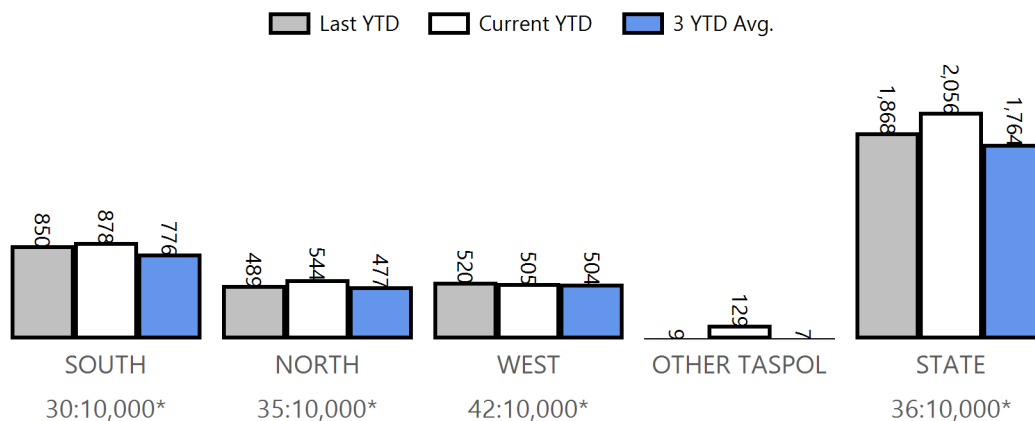

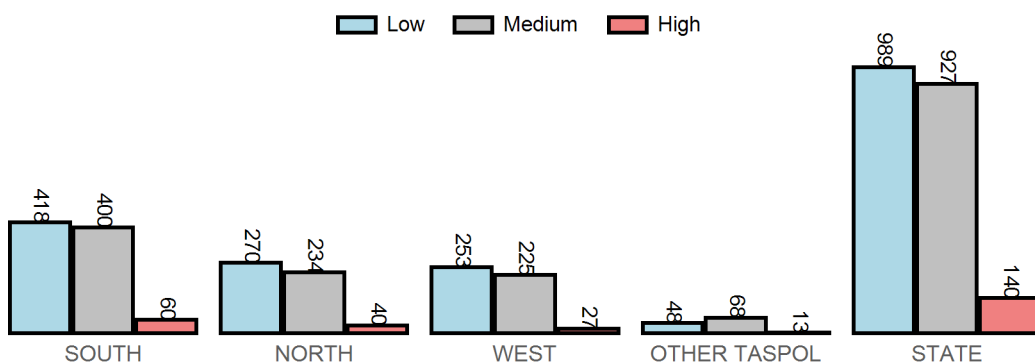
Family Violence Incidents - November 2023

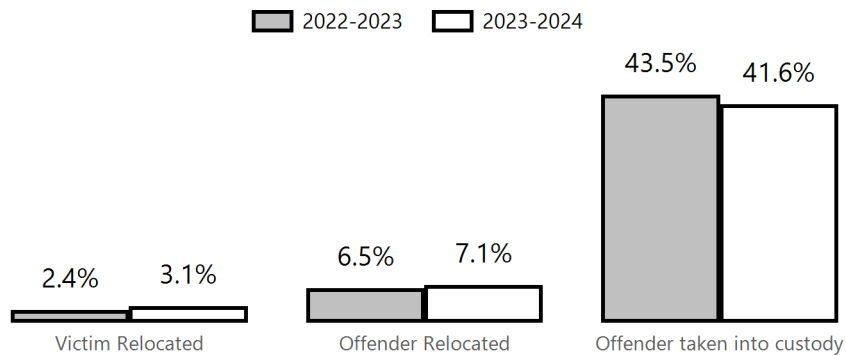

Family Violence RAST - Excludes Other and Argument Categories



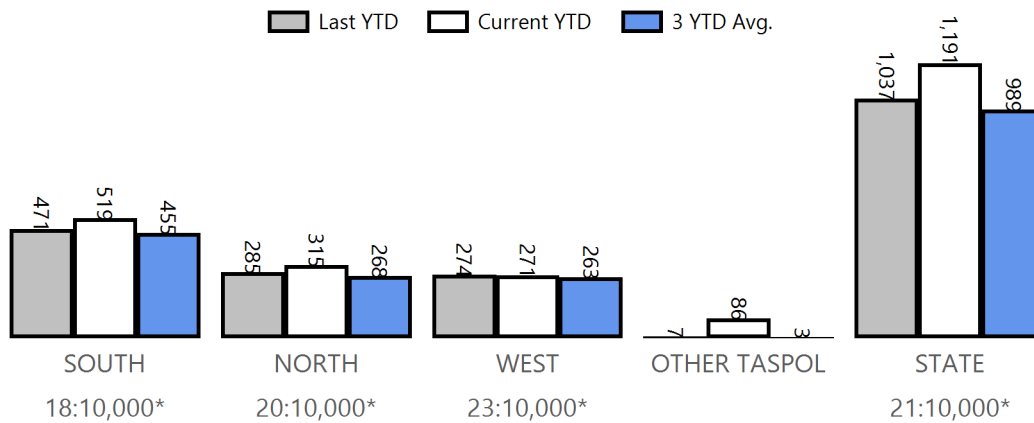

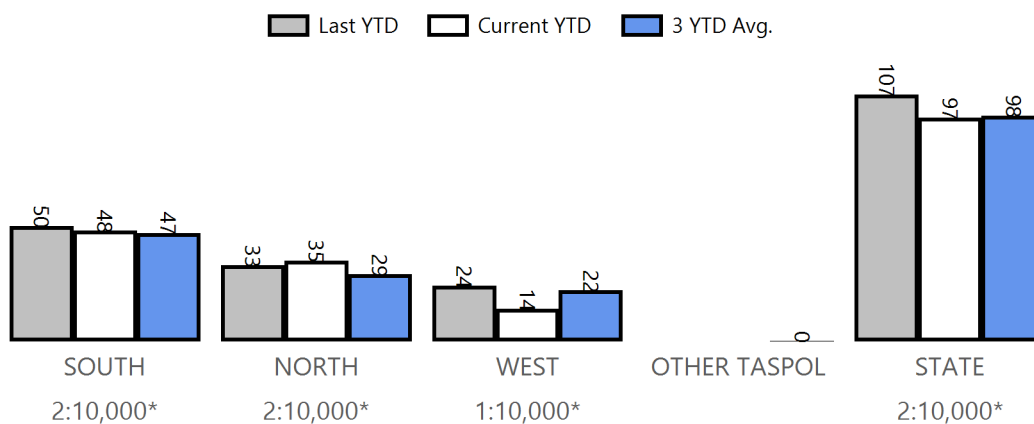
Family Violence Incidents with Child Witness - November 2023

Family Violence Incidents: Weapons Present - November 2023



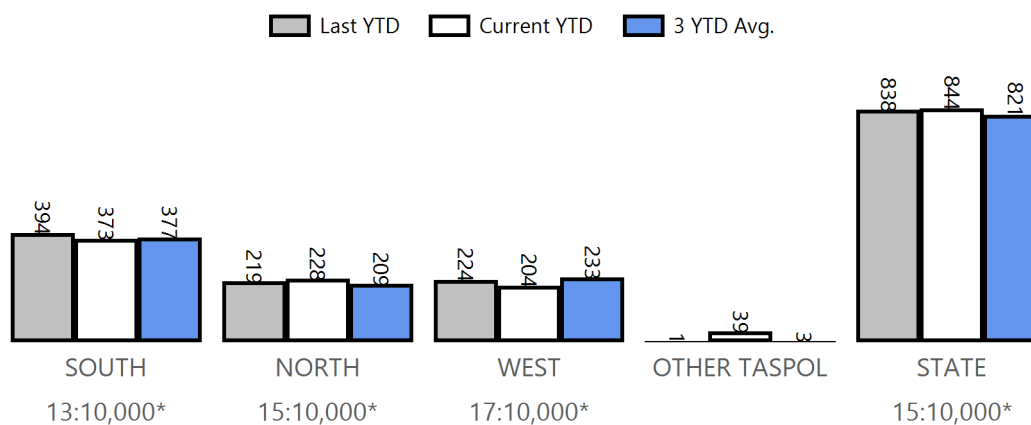

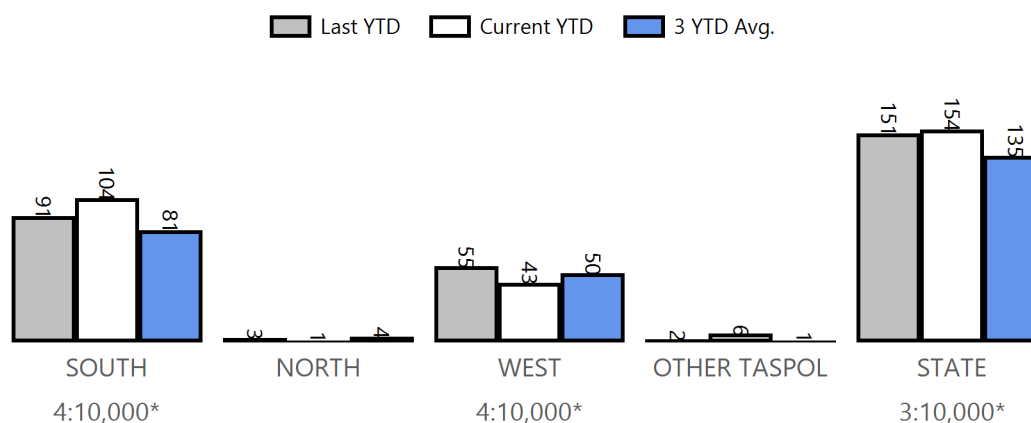
FV Incidents with Police FV Order Issued - November 2023

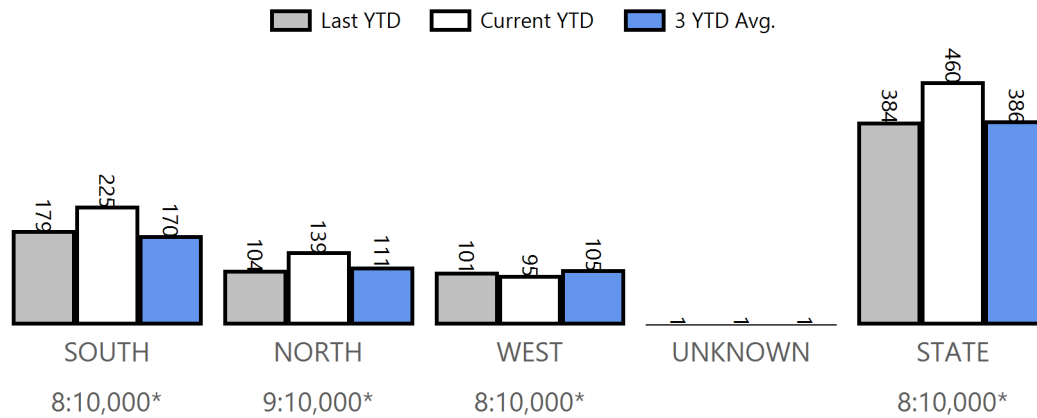
FV Incidents with FV Order Application - November 2023

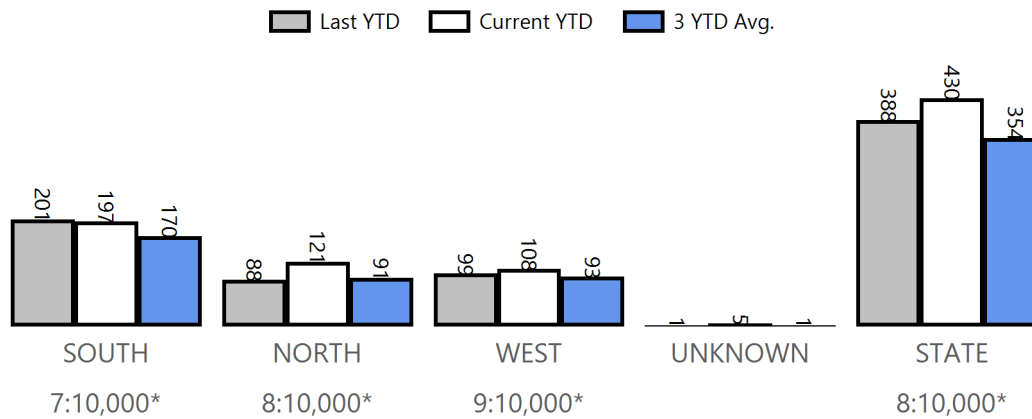
Breach of Police Family Violence Orders - November 2023

Breach of Family Violence Orders (excluding PFVOs) - November 2023

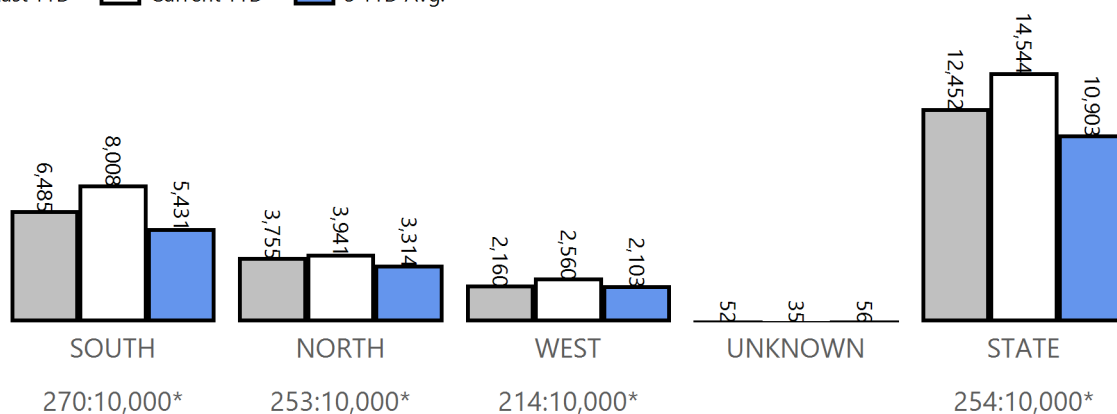

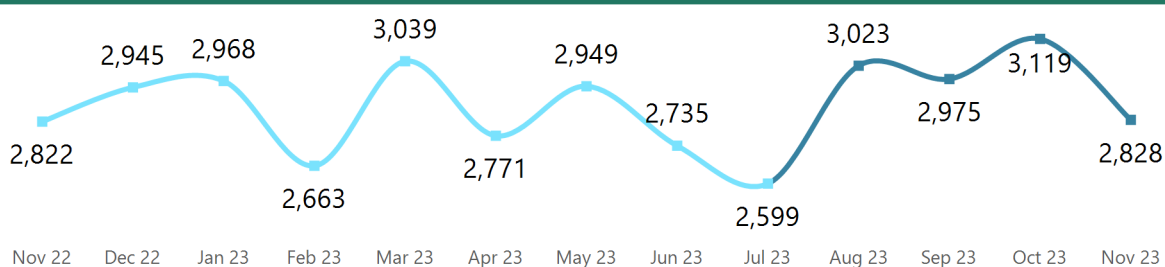

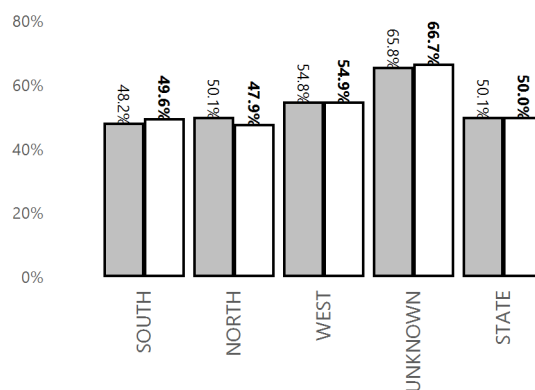

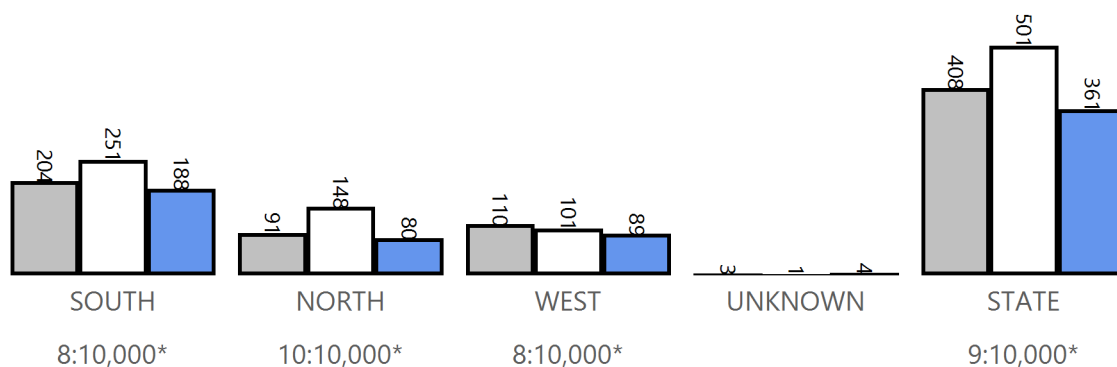

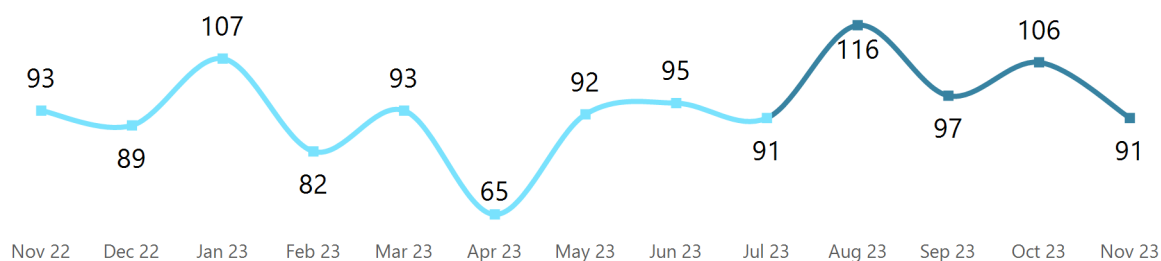

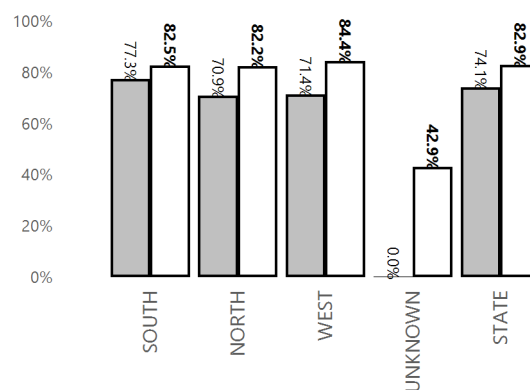

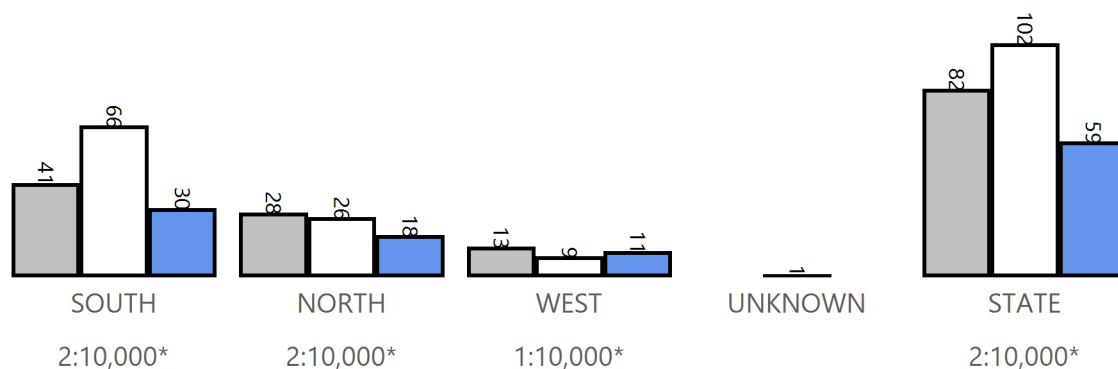

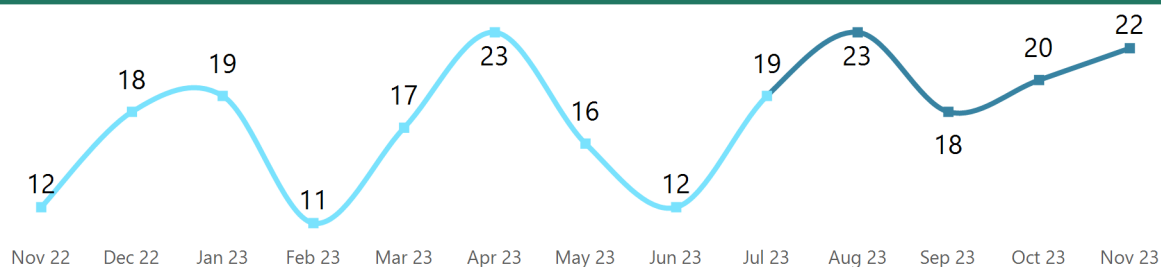

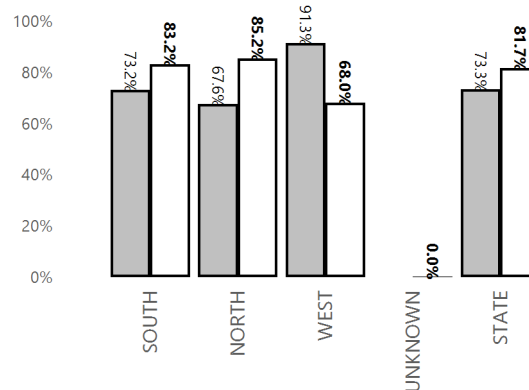

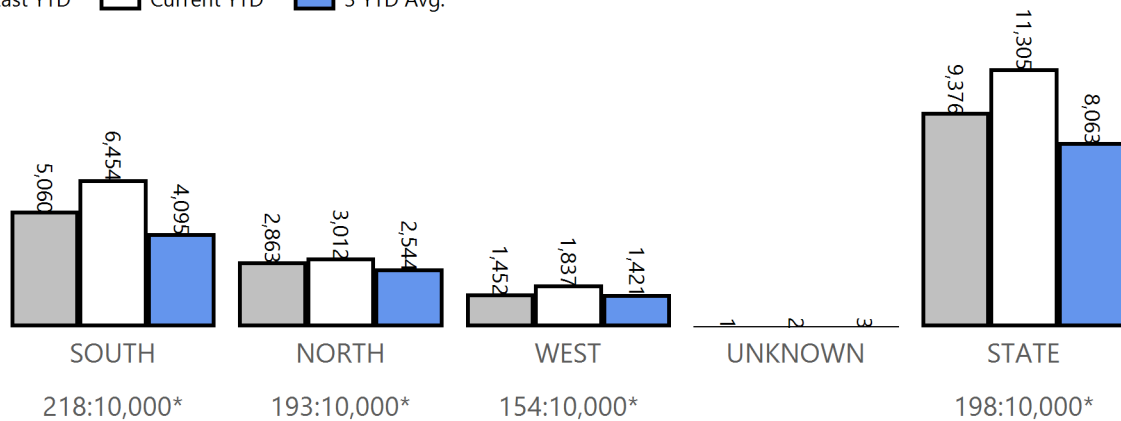

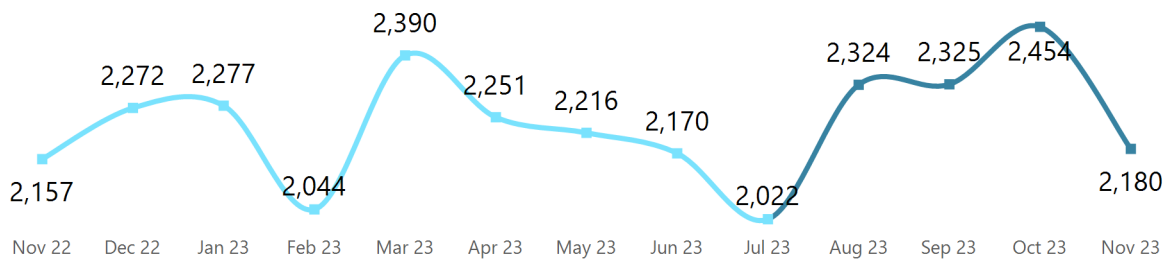

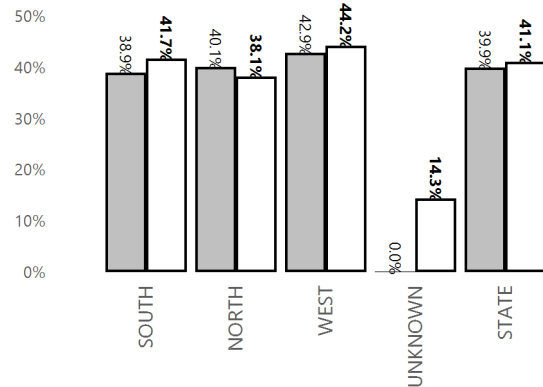

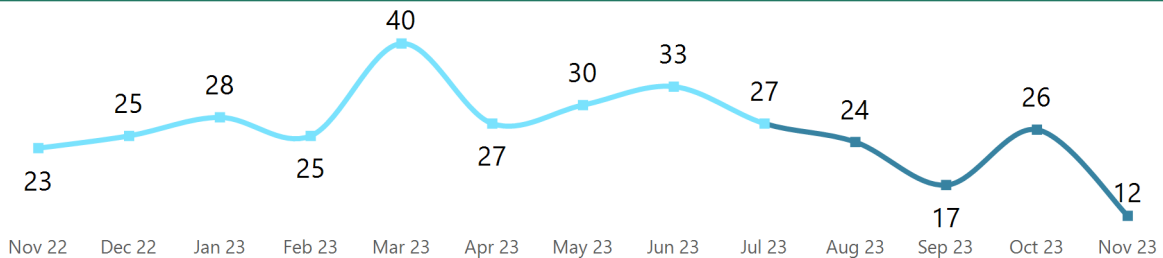
SMV : Recovered Fire Damaged - November 2023

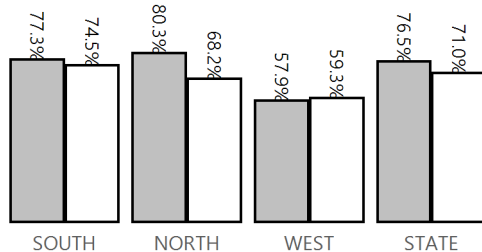

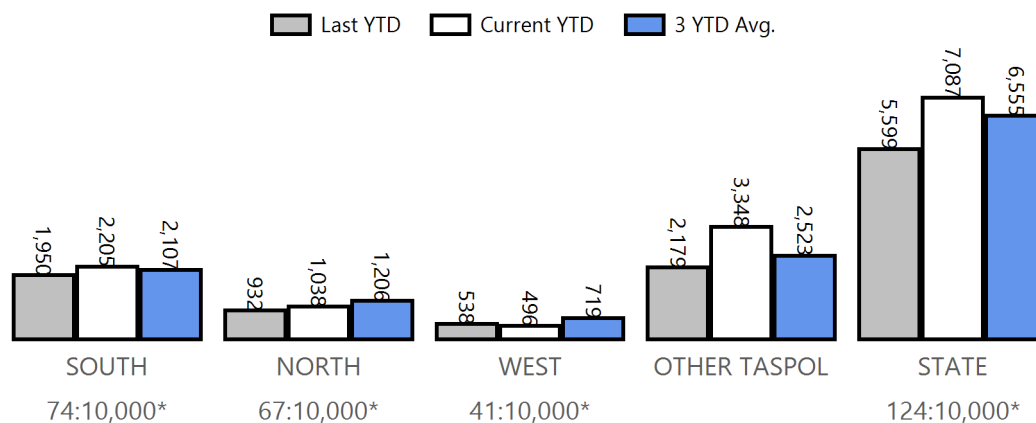

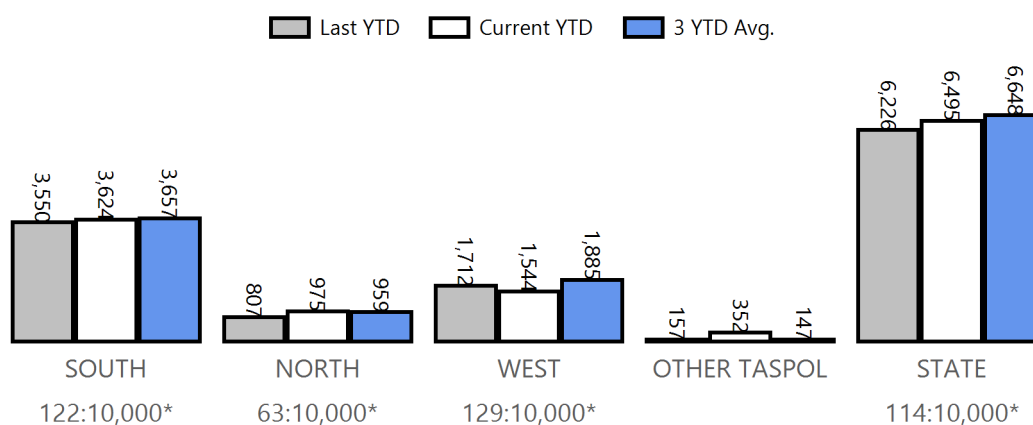
Intelligence Submission Occurrences - November 2023

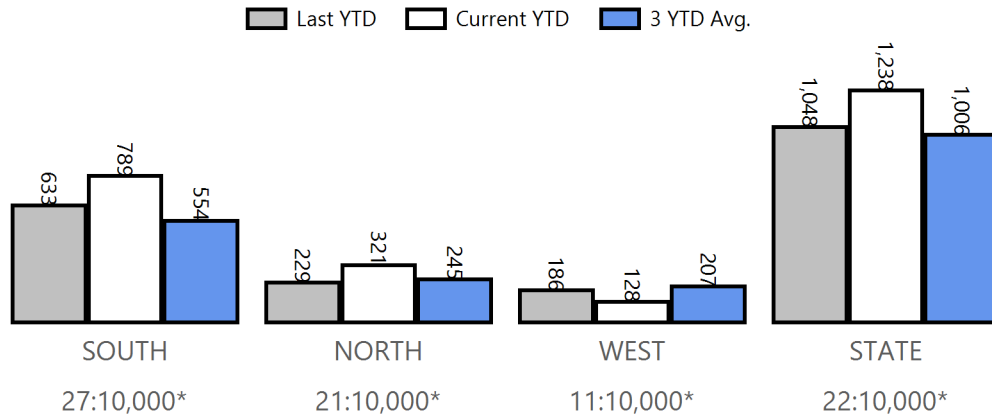
Street Check Occurrences - November 2023

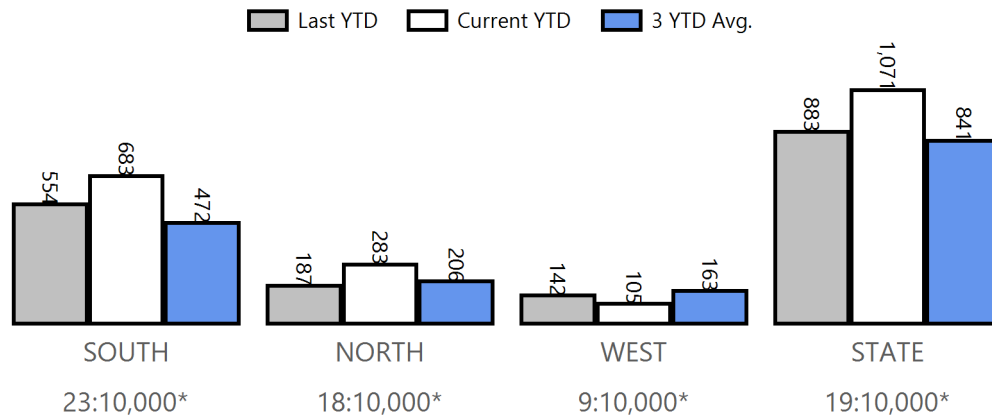
CIB: Total Offenders - November 2023

CIB: Total Crime Offenders - November 2023



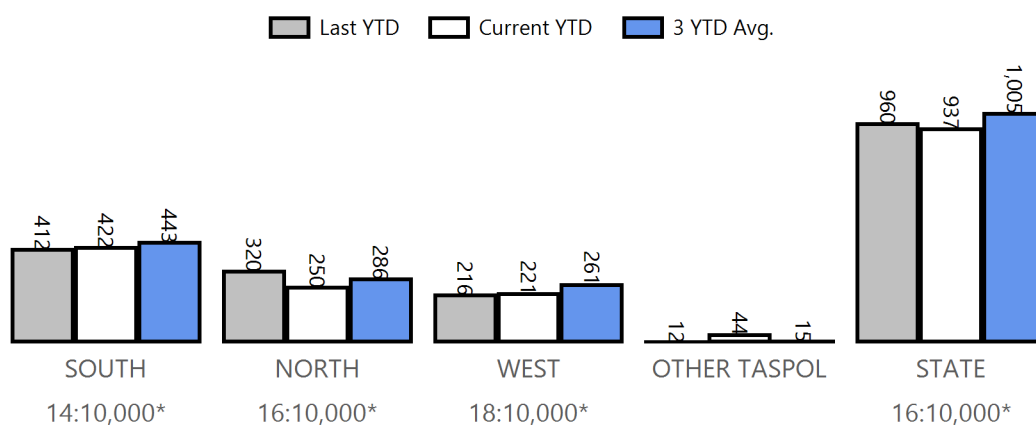

Total Drug Offenders - November 2023



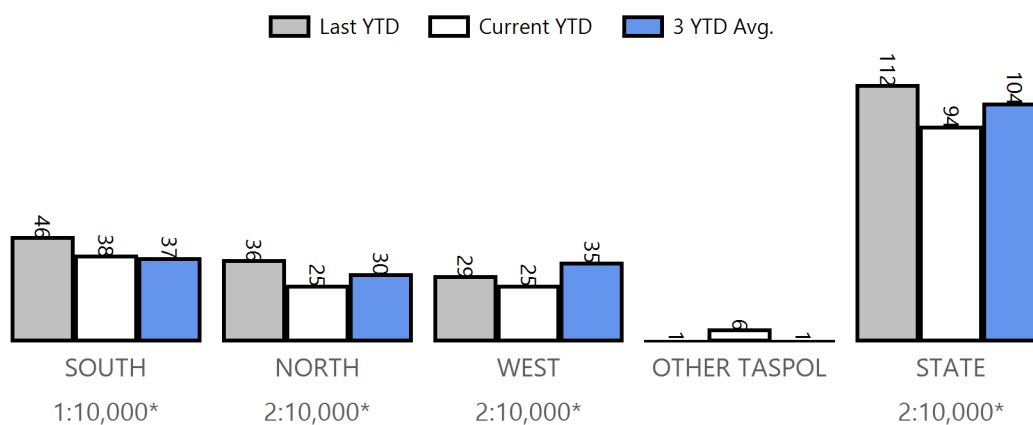

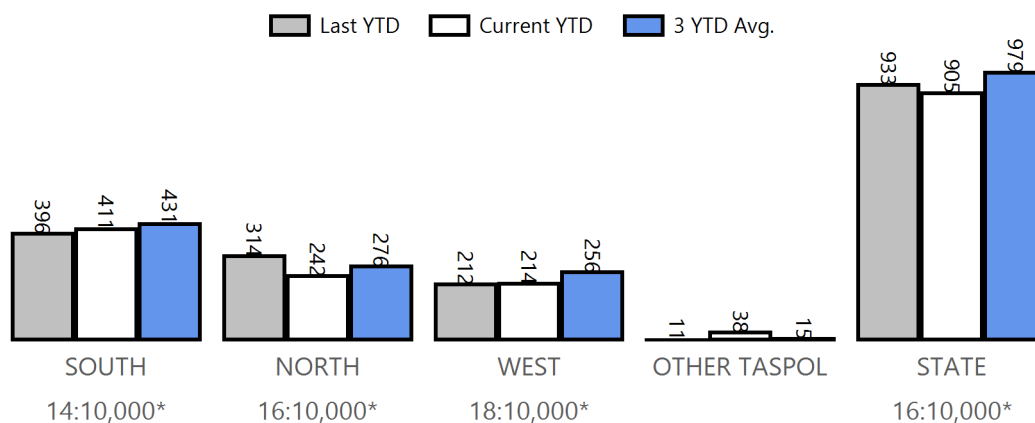

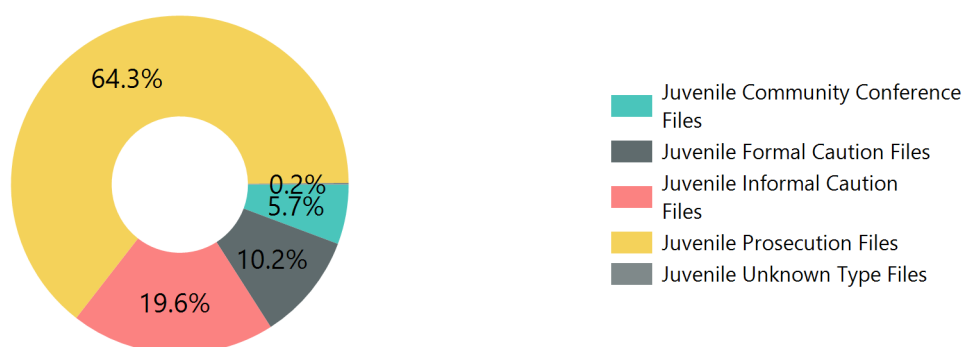

Total Traffic Offenders - November 2023



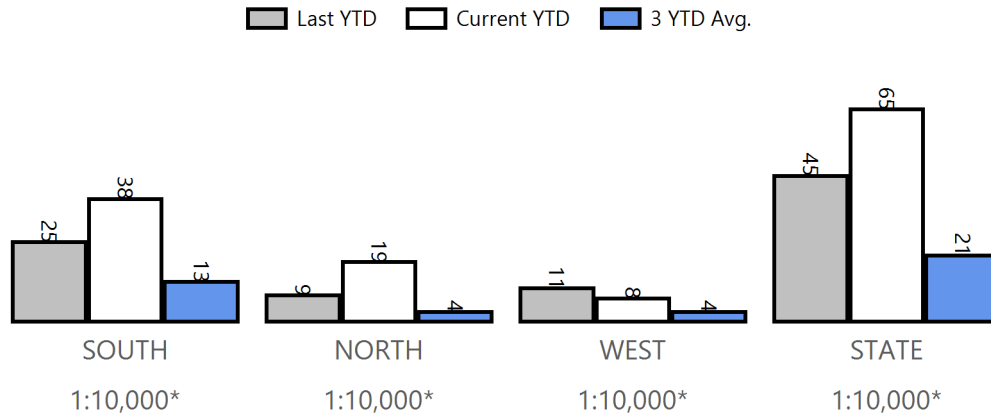

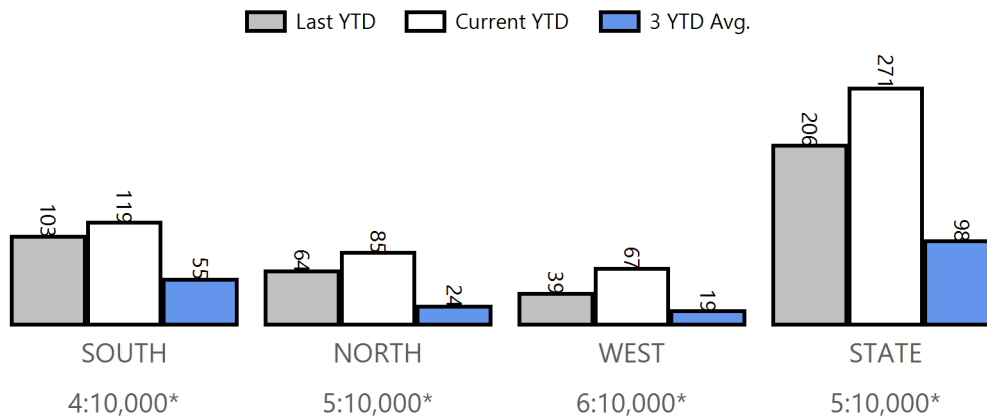

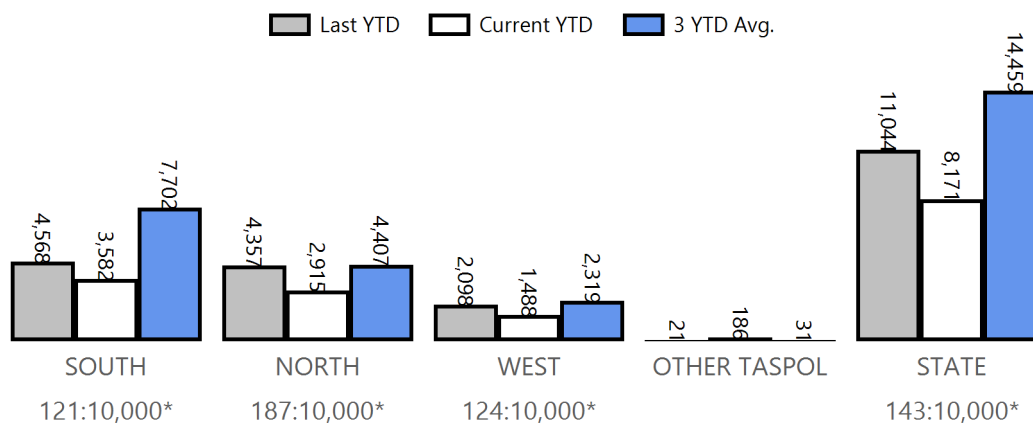

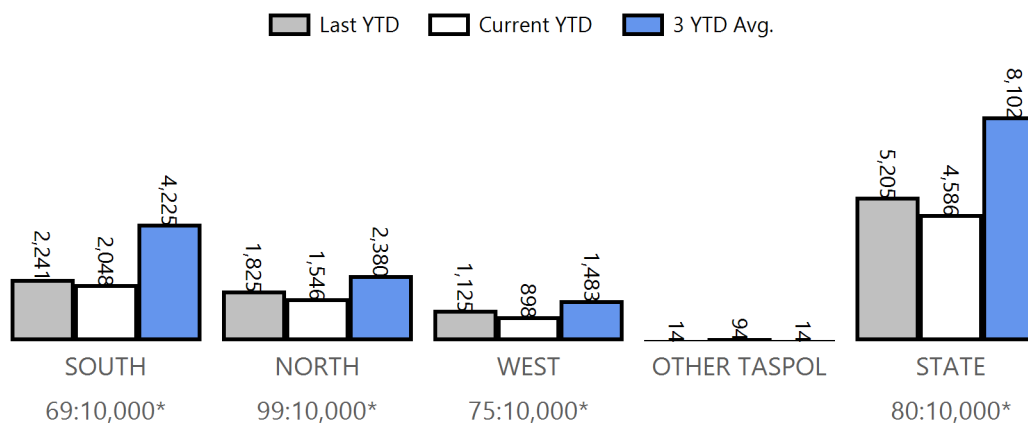
Speeding Offenders - November 2023

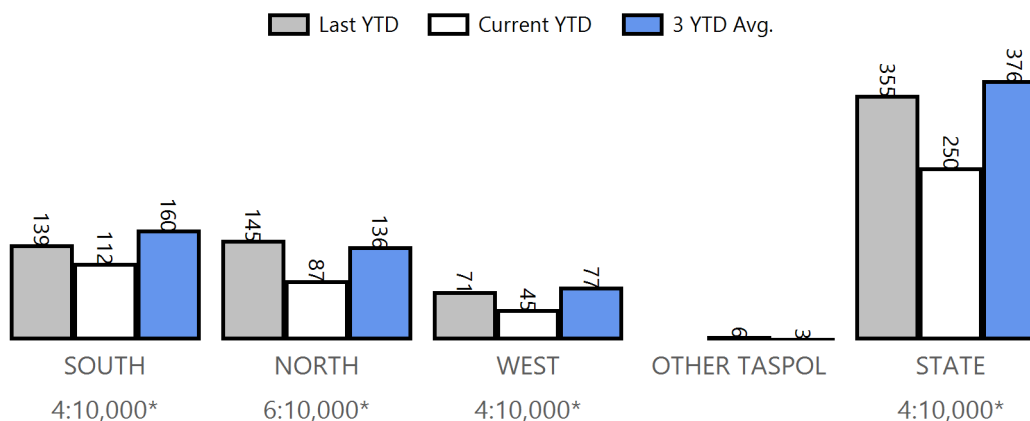
Speeding 15-29 km/h Offenders - November 2023

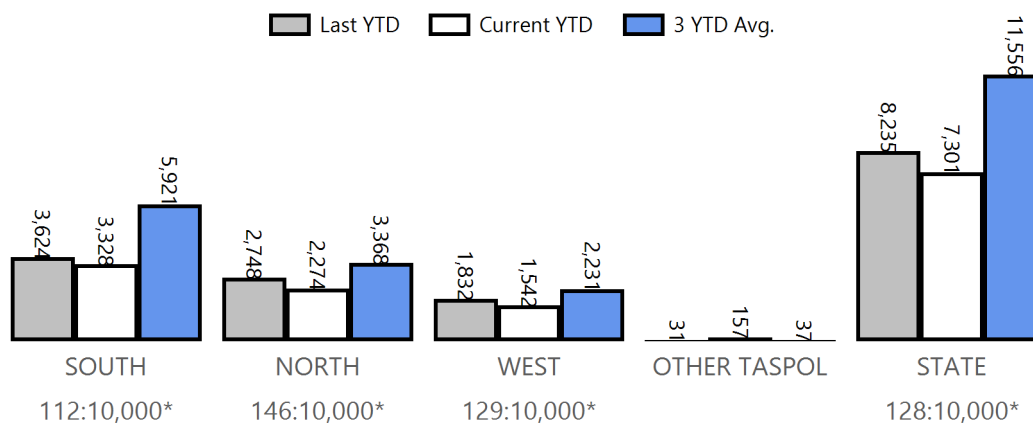
Speeding 30+ km/h Offenders - November 2023

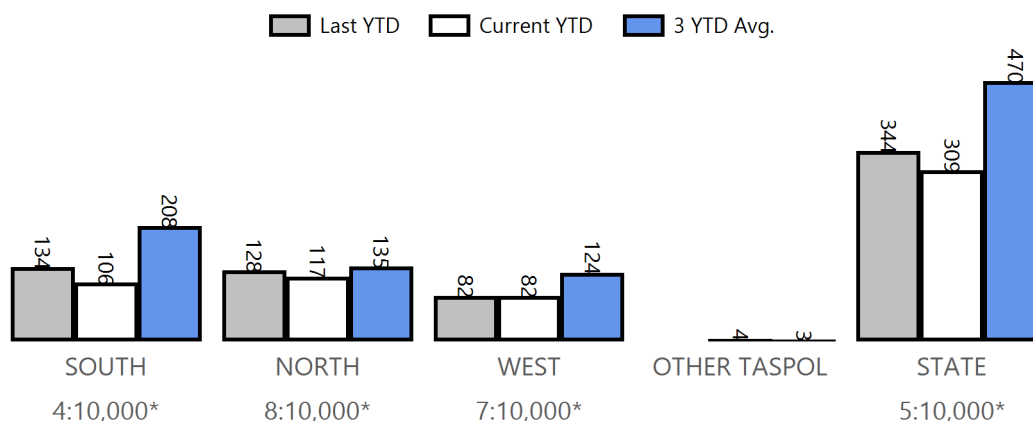
High Risk Traffic Offenders - November 2023

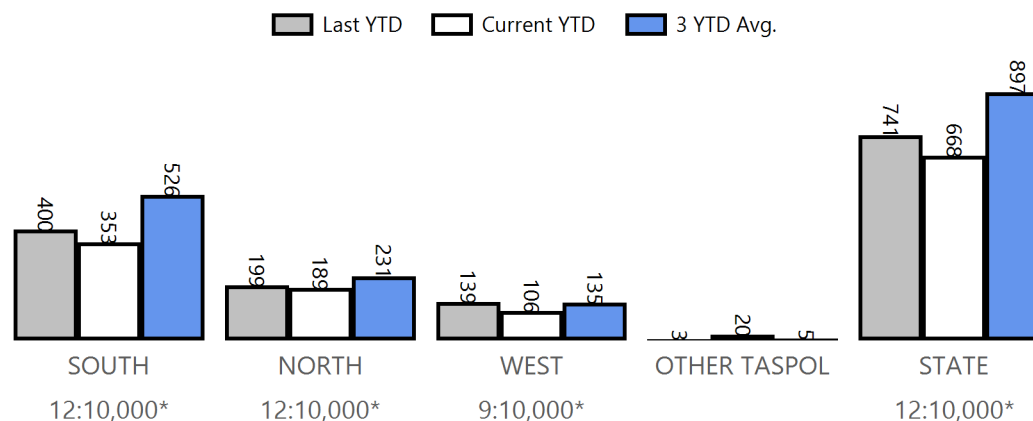
Seatbelt Compliance Offenders - November 2023

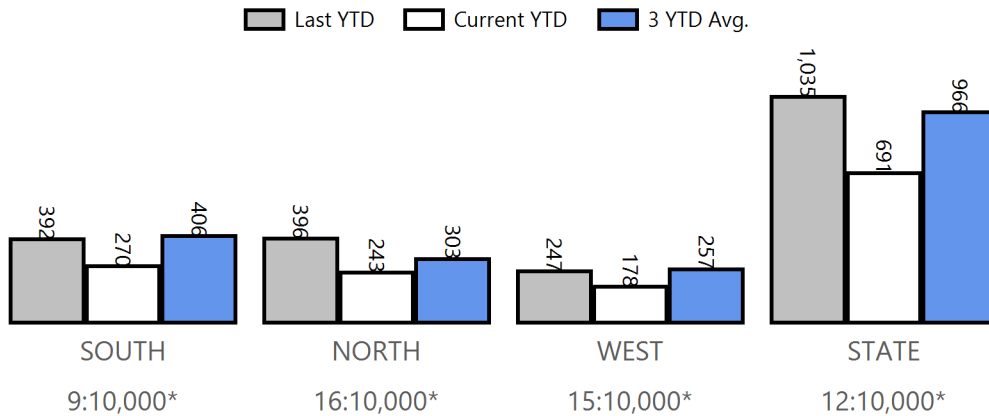
Mobile Phone Offenders - November 2023

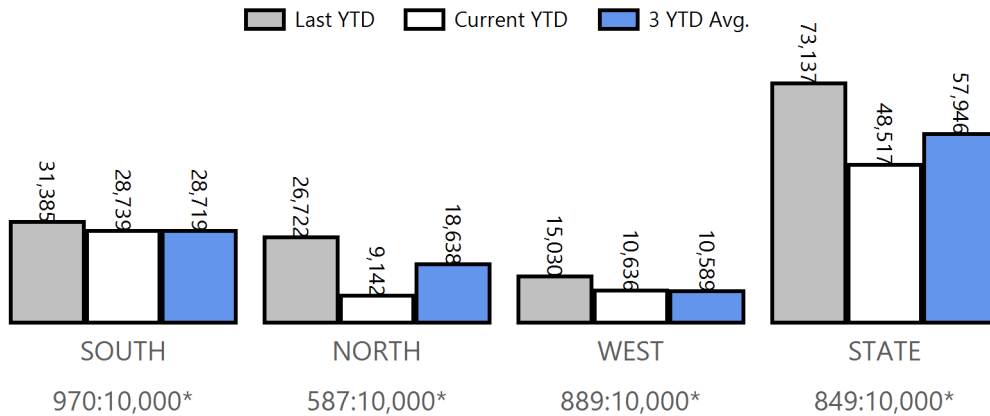
Vehicle Defect Notices - November 2023

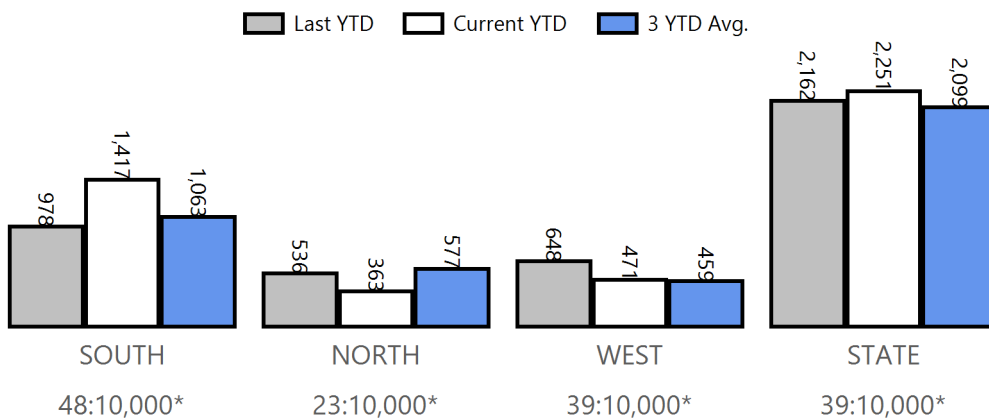
Random Breath Tests (Alcohol) - November 2023

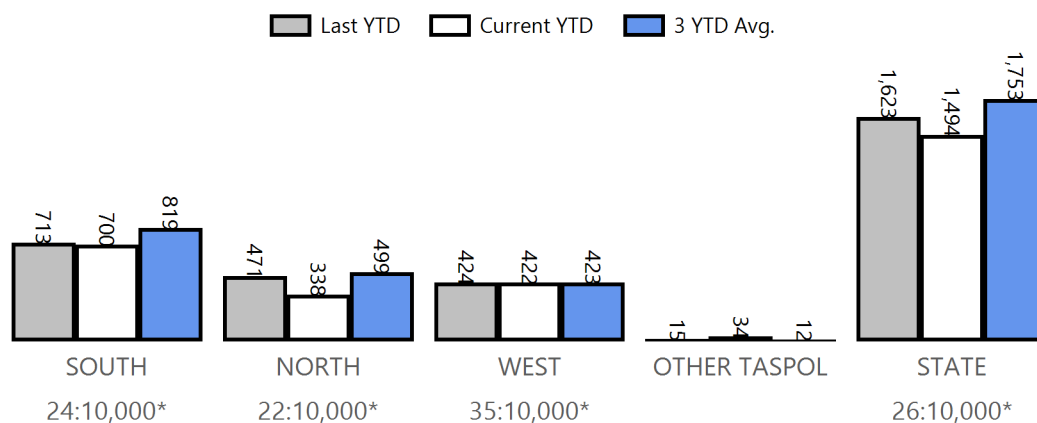
Oral Fluid Tests (Drugs) - November 2023

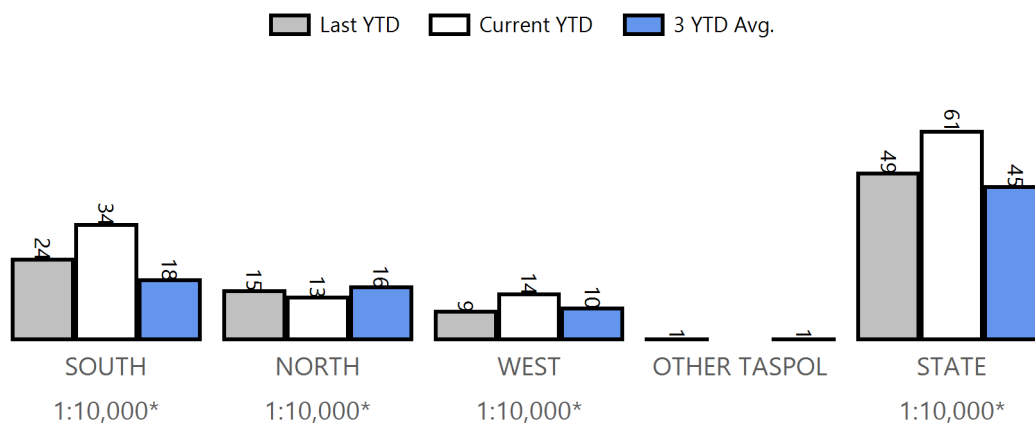

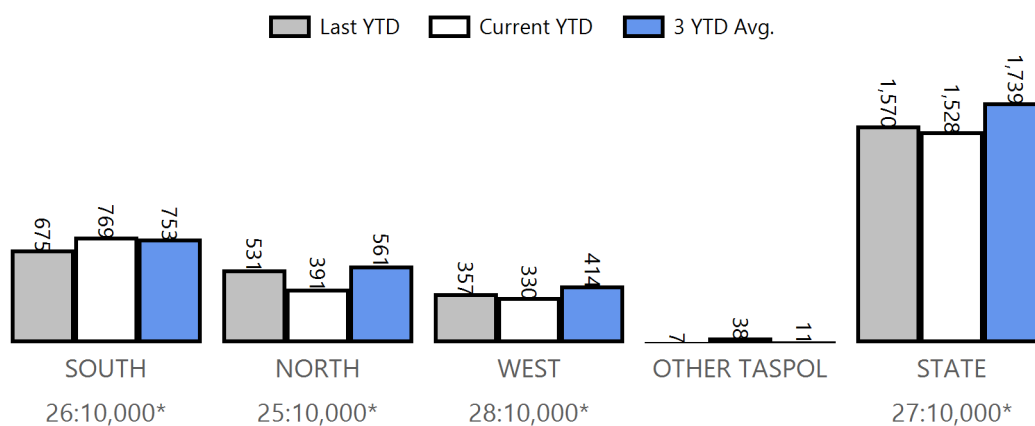

Disqualified and Unlicensed Driving Offenders - November 2023

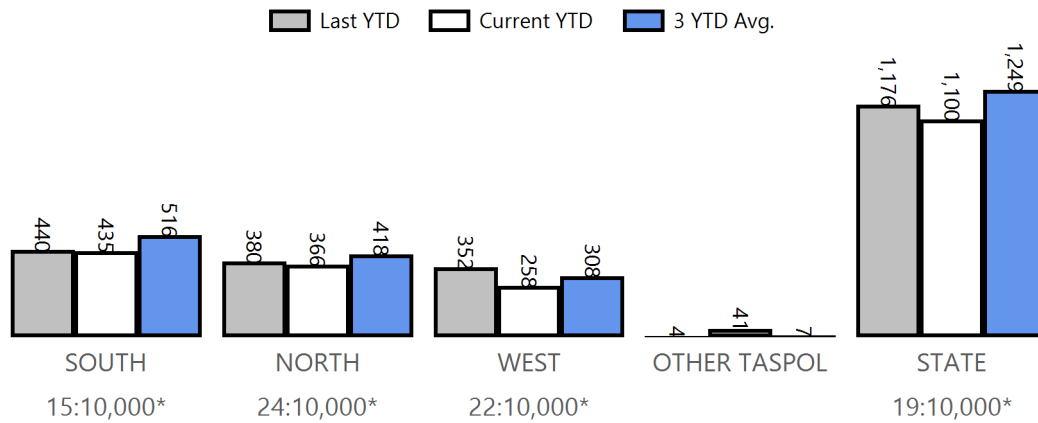

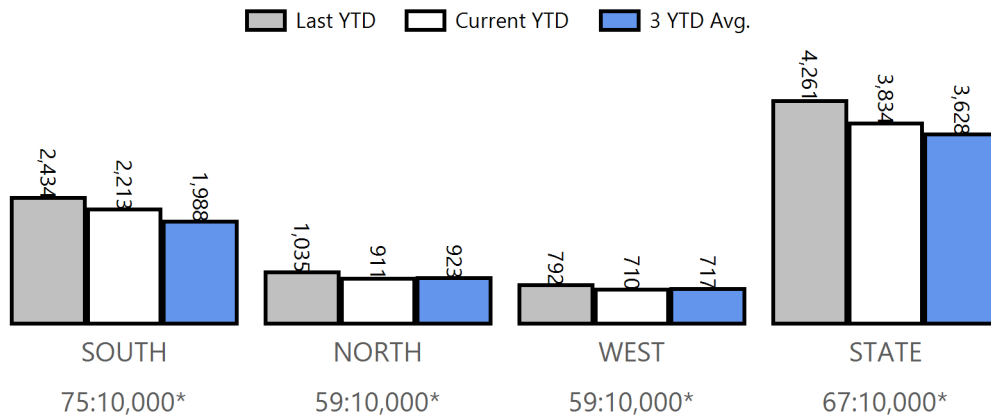
Unregistered Vehicle Offenders - November 2023

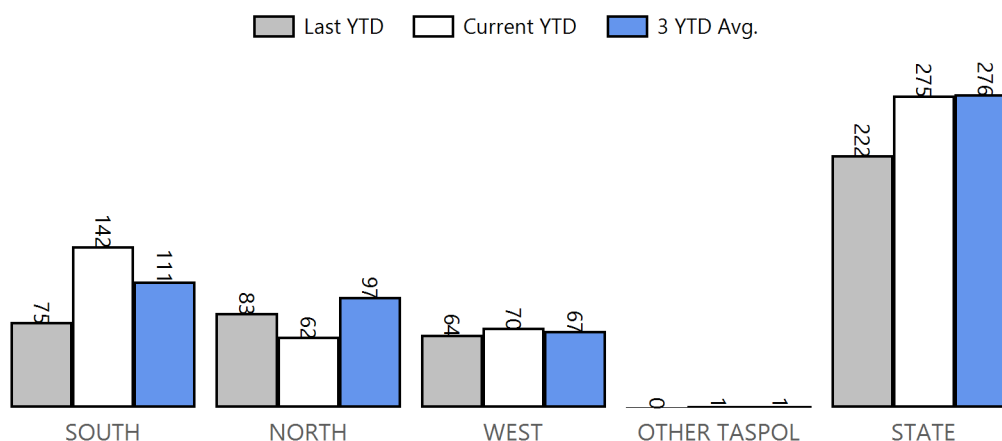
Vehicle Complaint Dispatch Incidents - November 2023

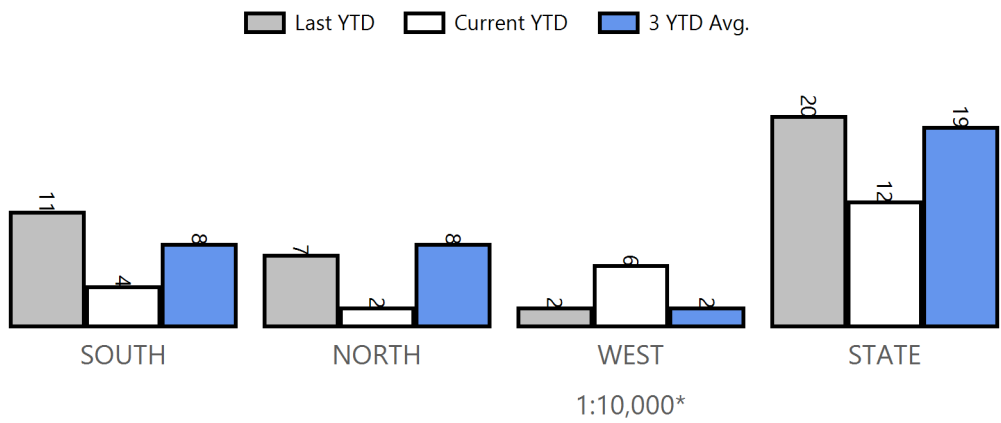

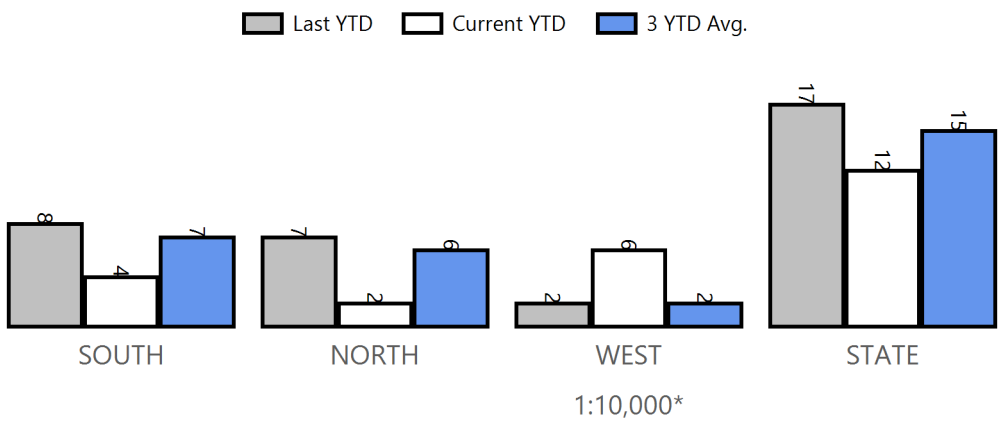
Crash Fatalities - November 2023

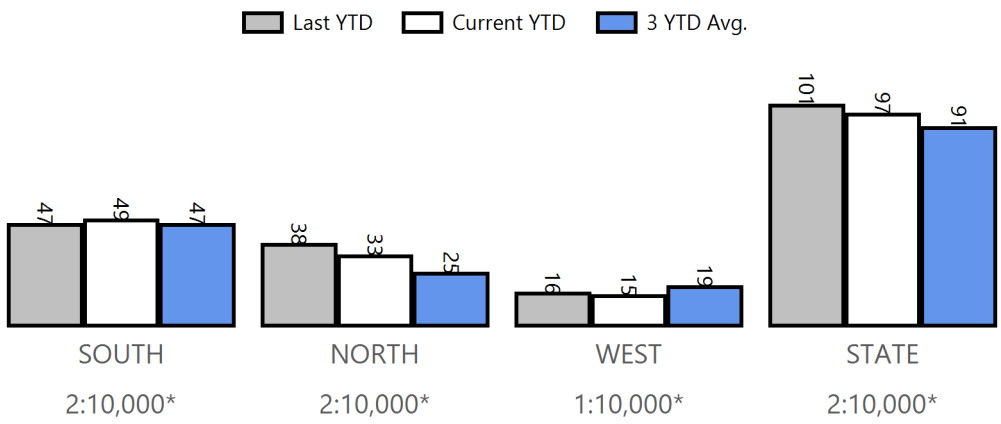
Fatal Crashes - November 2023

Serious Injury Crashes - November 2023



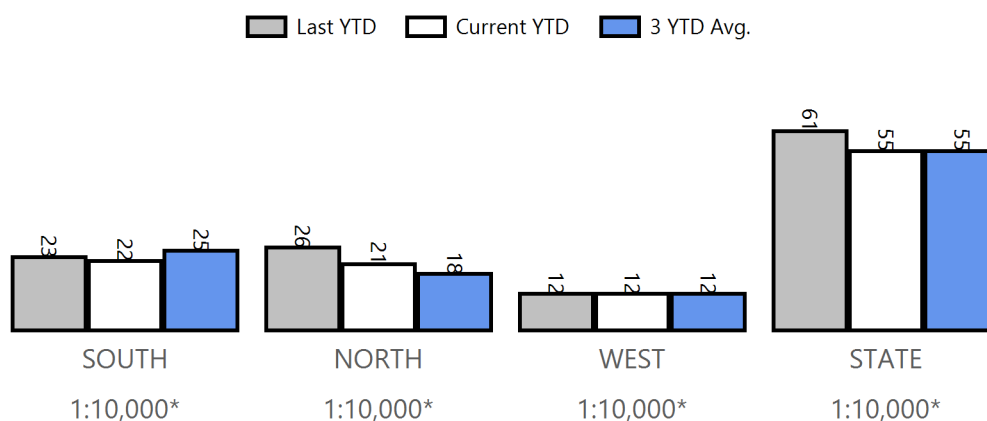

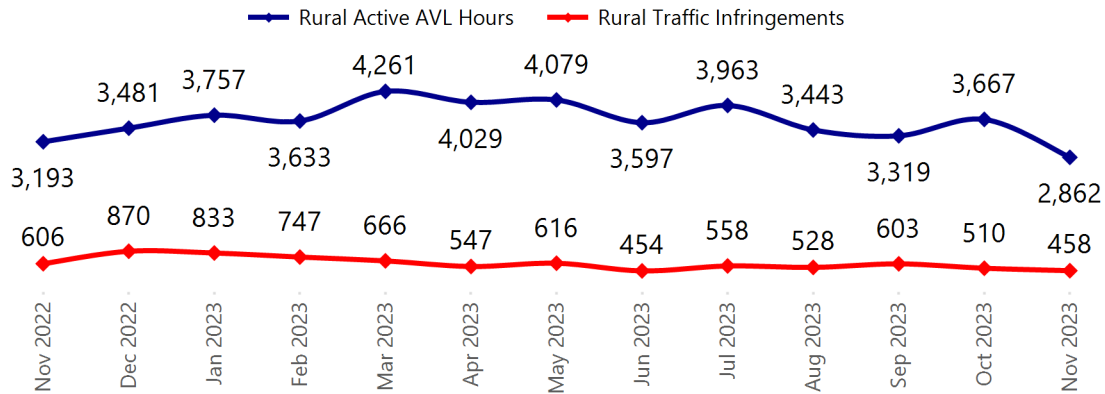
On Road Fatal and Serious Crashes in Rural Areas - November 2023



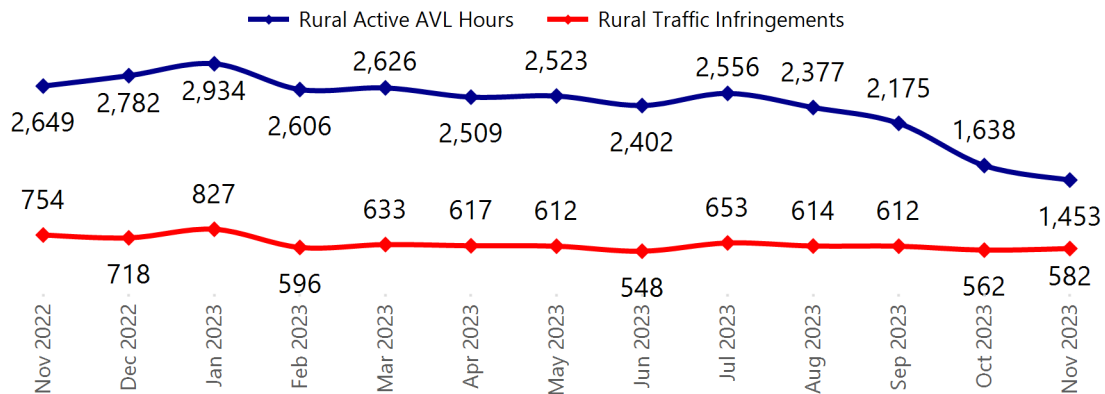

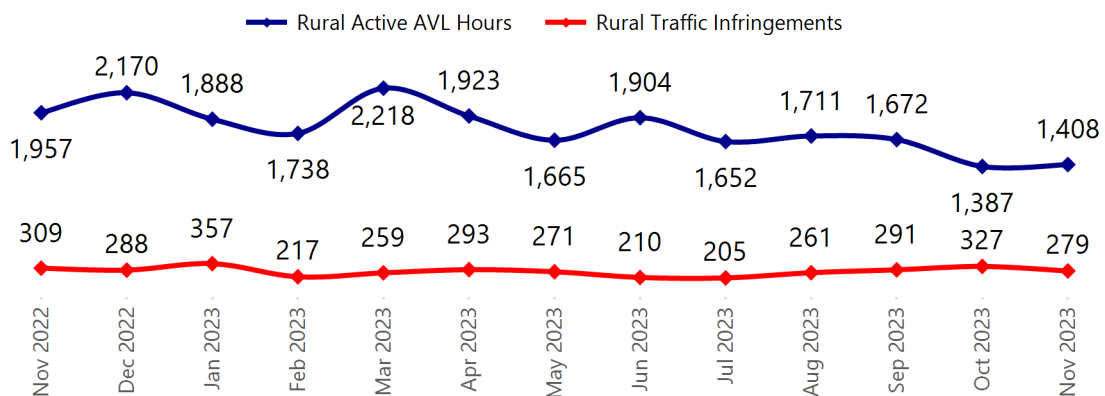

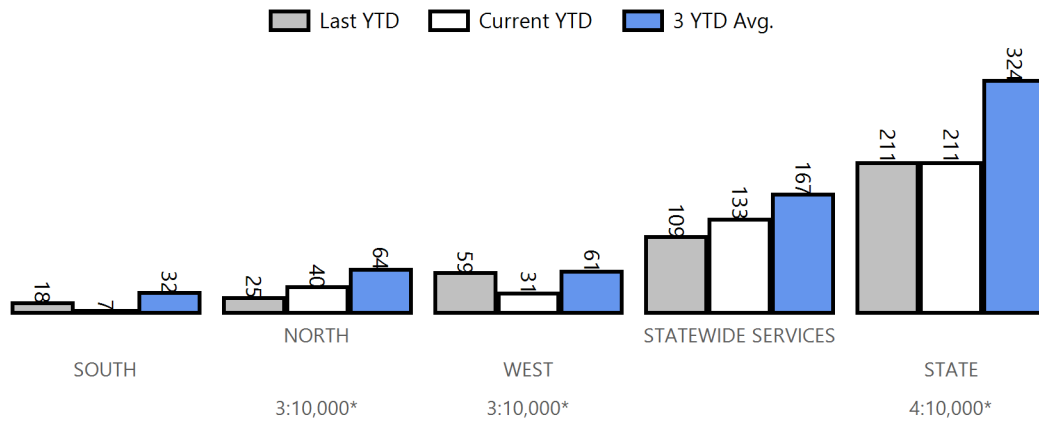

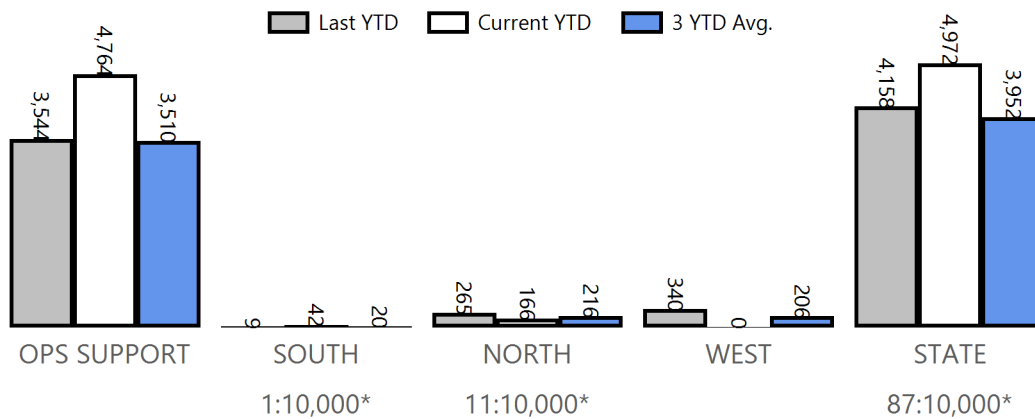

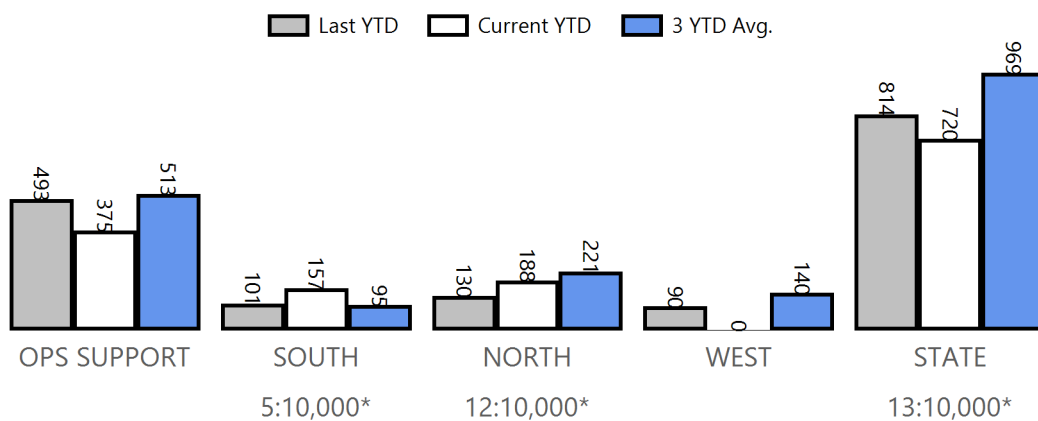
Sea Inspections (Vessel & Non-Vessel) - November 2023

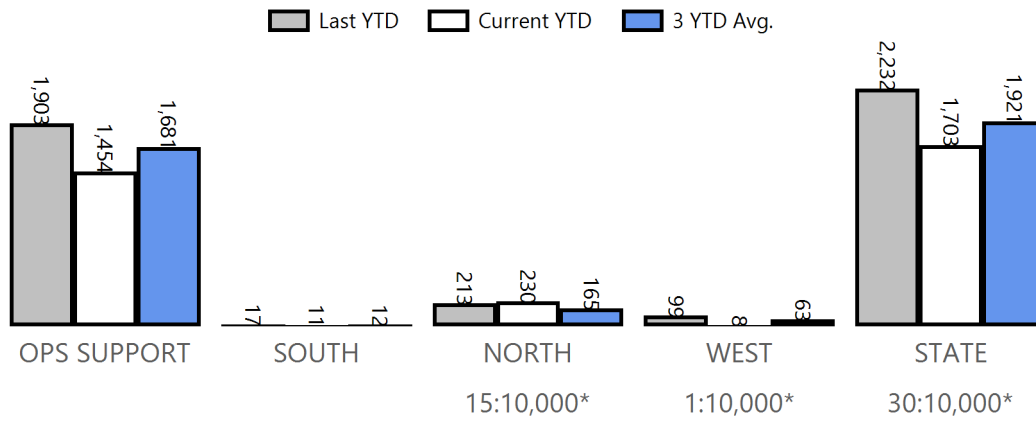
Vessel Inspections on Land - November 2023
