Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

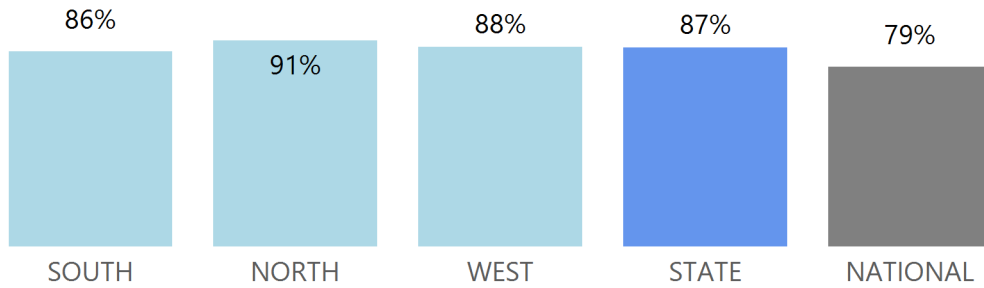

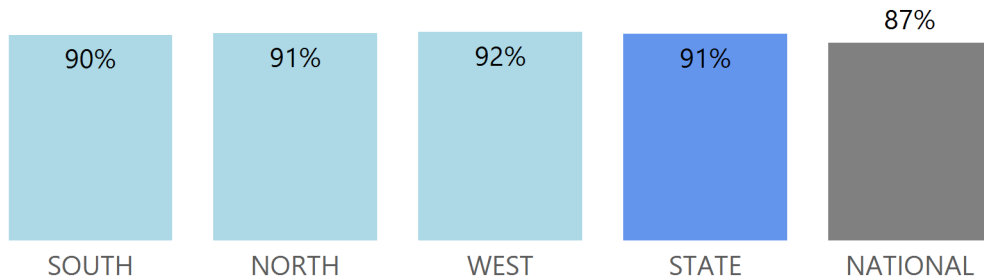
Safety at Home During the Night

(Survey respondents who answered "Safe/Very Safe".)



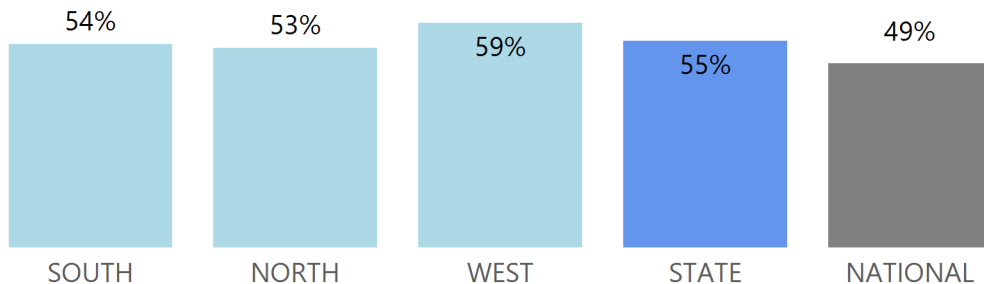
Safety In Neighbourhood During the Day

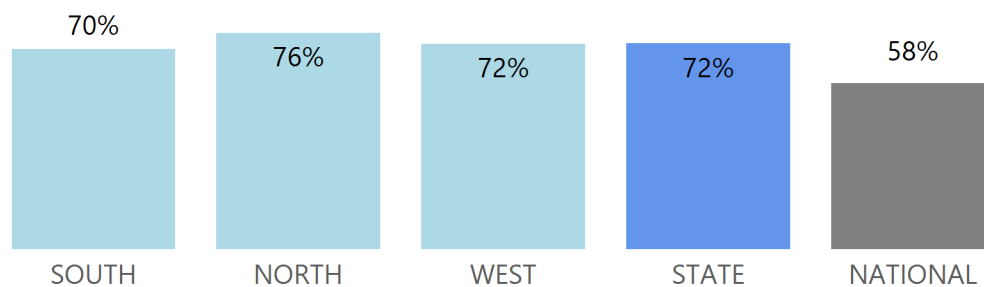

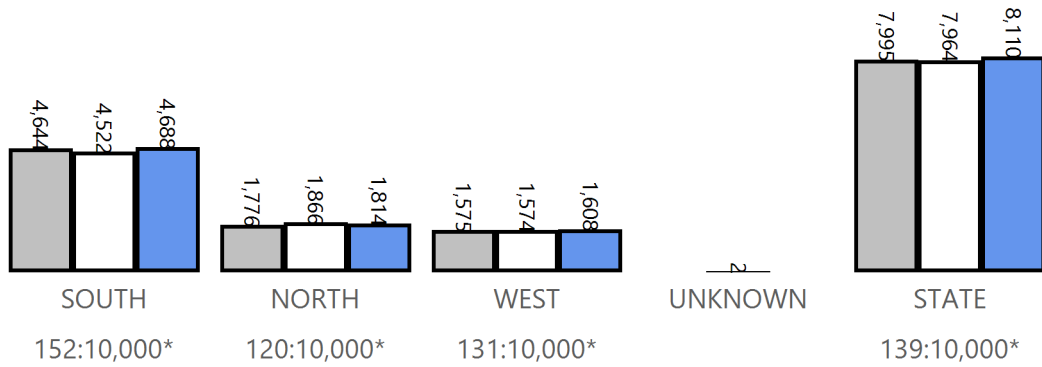

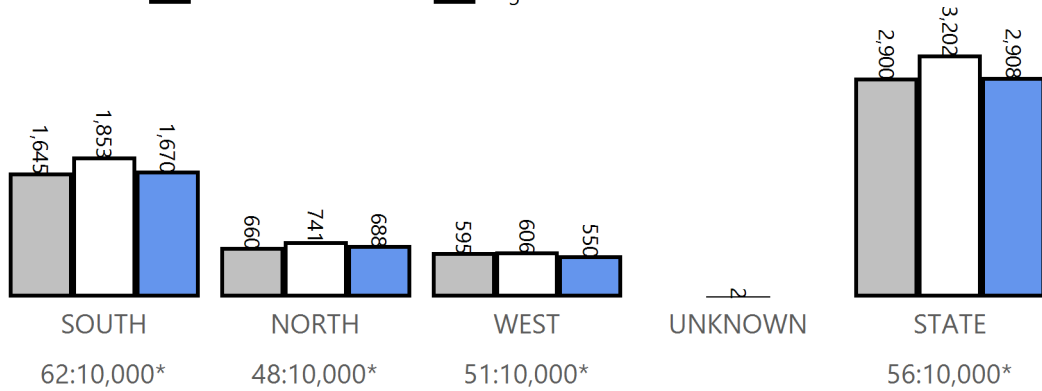

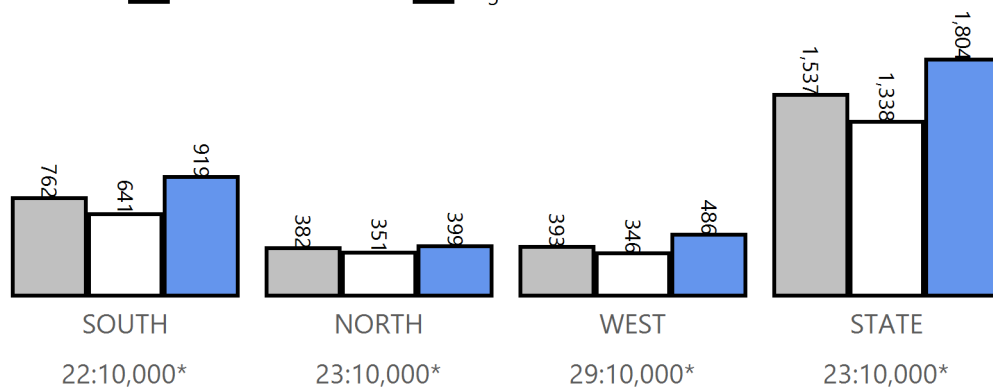

Public Order : Noise - November 2024

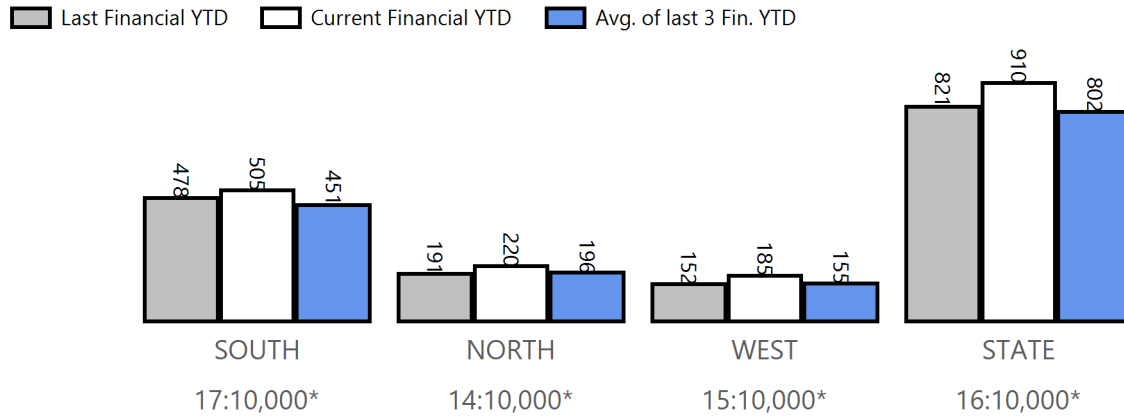

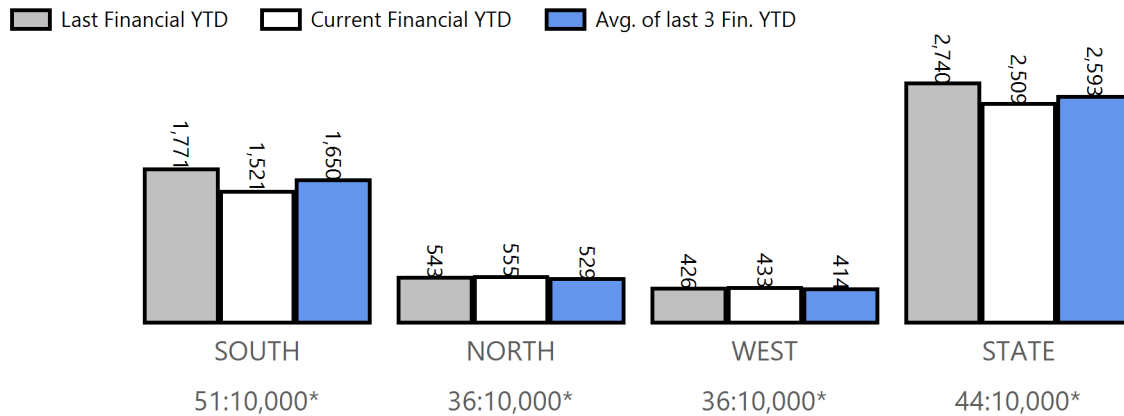
Public Order : Vandalism - November 2024

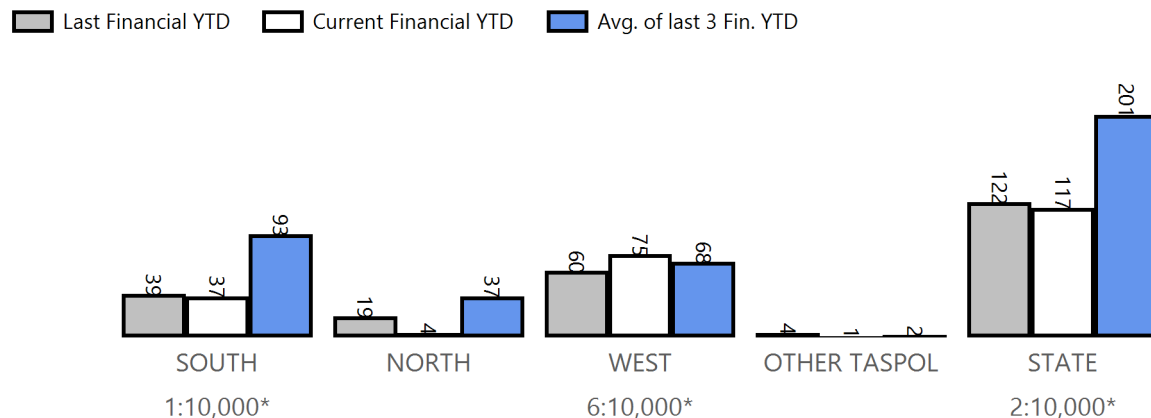
Public Order : Offensive Behaviour - November 2024

Liquor Infringement Notices - November 2024

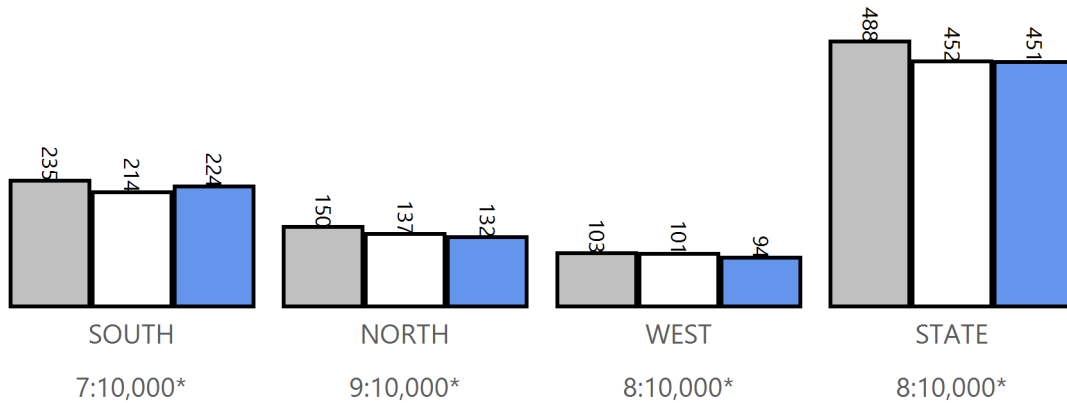

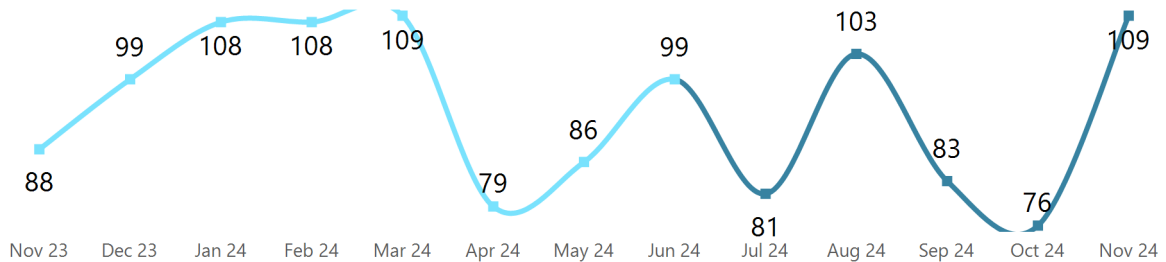

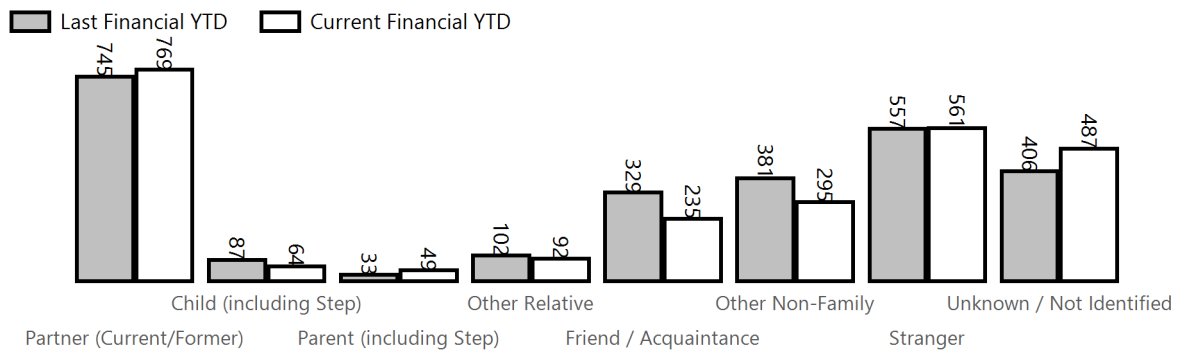

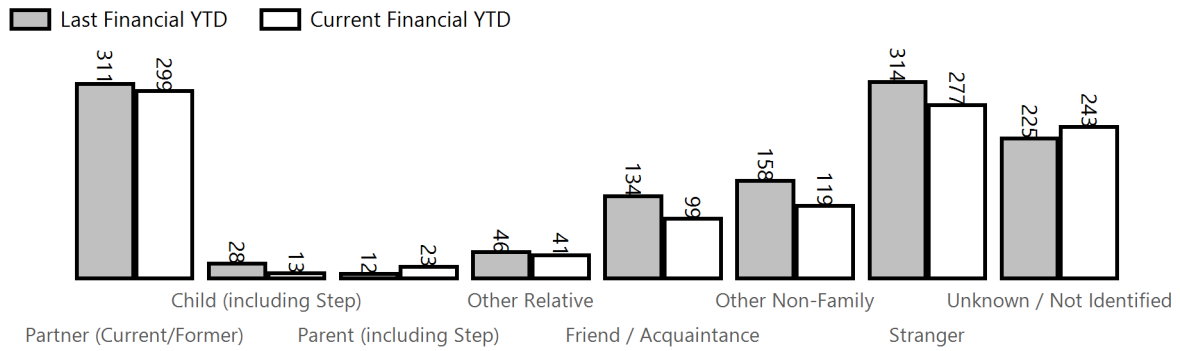

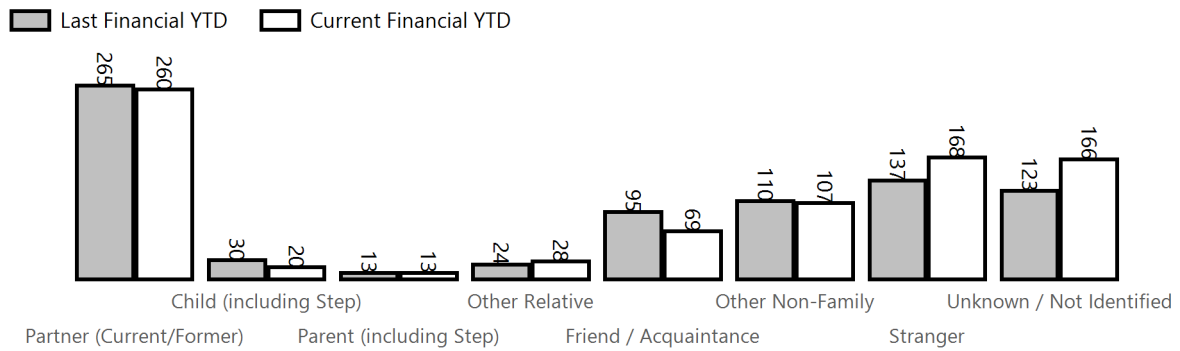

Total Person Offences - Victim Relationship - SOUTH



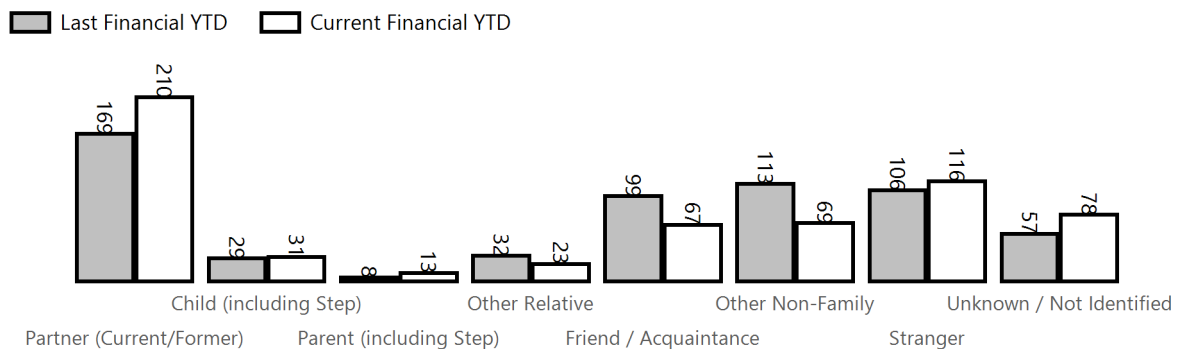

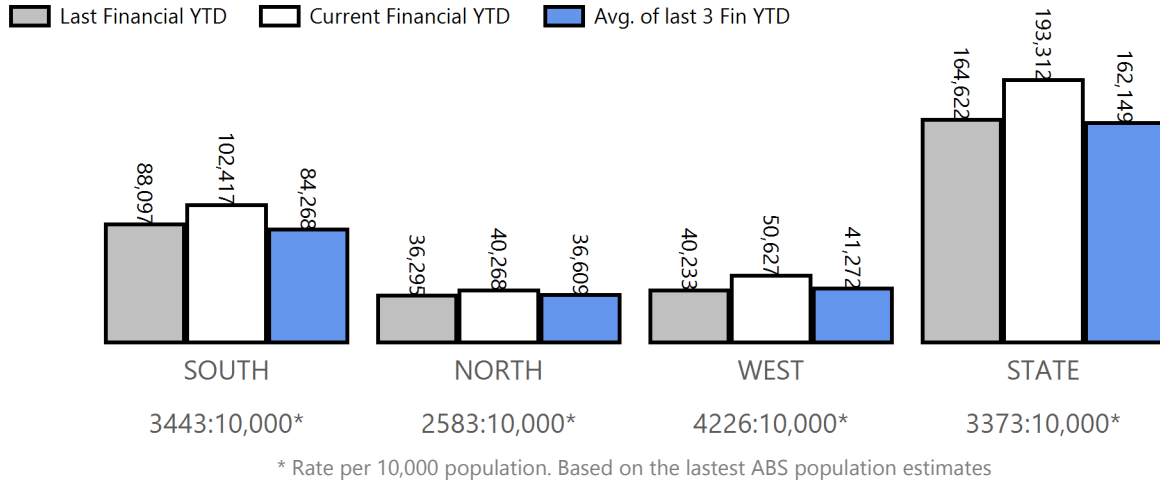

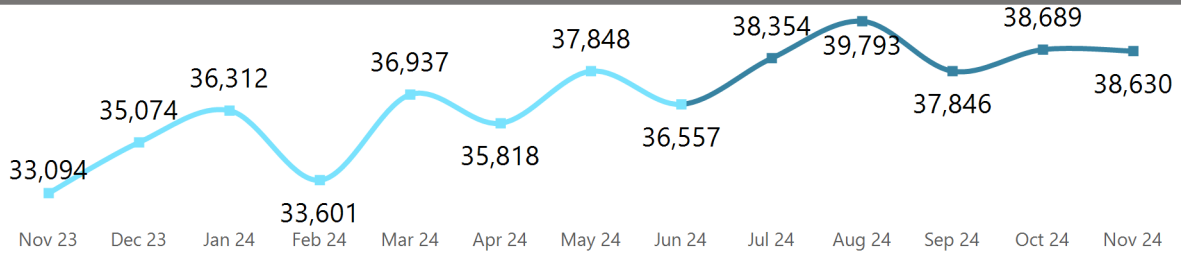

Uniform Police Patrol Hours - November 2024

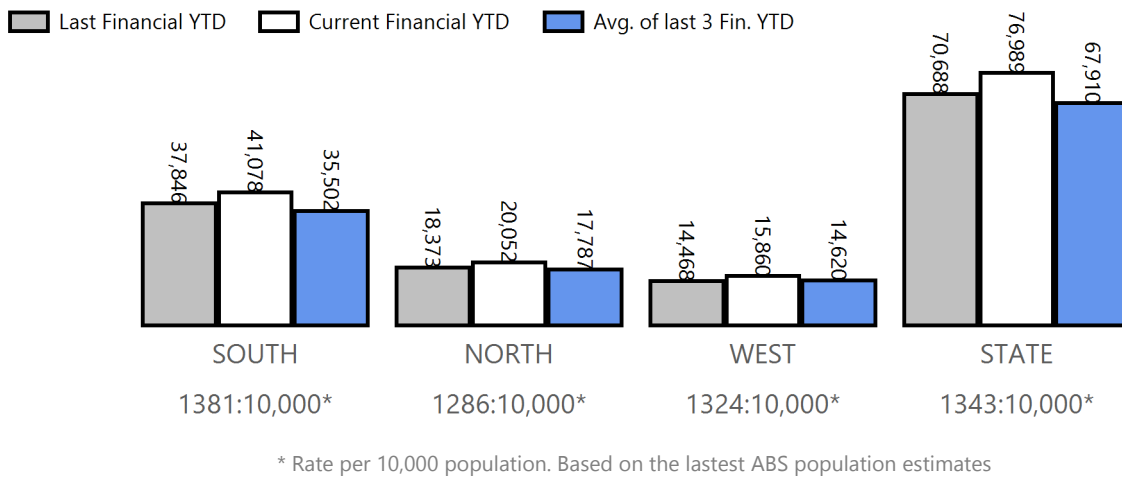


Uniform Police - Patrol Hours

Uniform Police Hours on Dispatch Tasks - November 2024



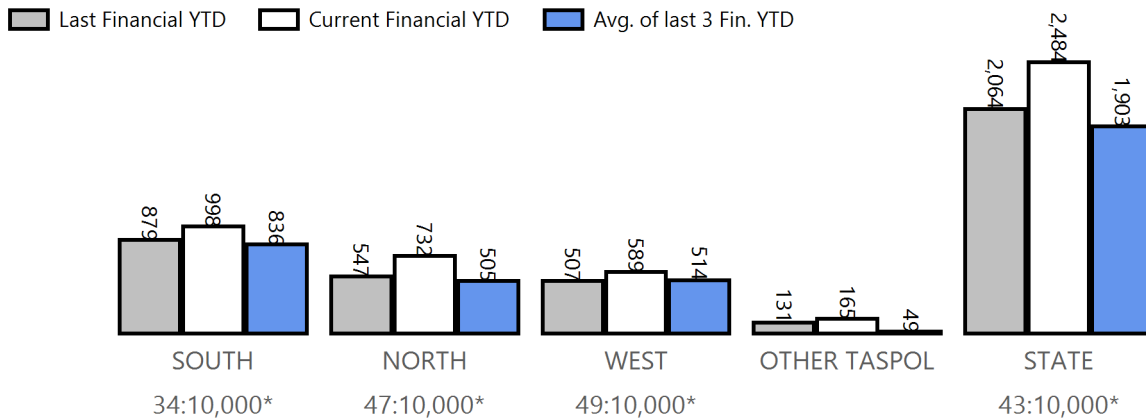

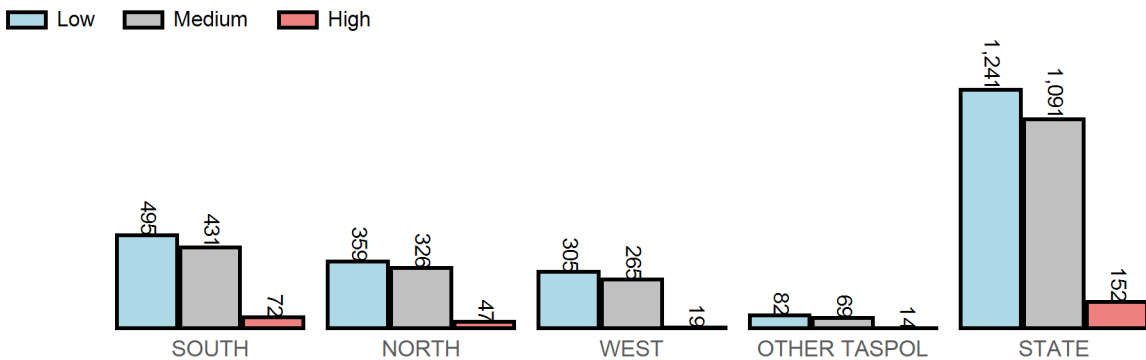
Family Violence Incidents - November 2024

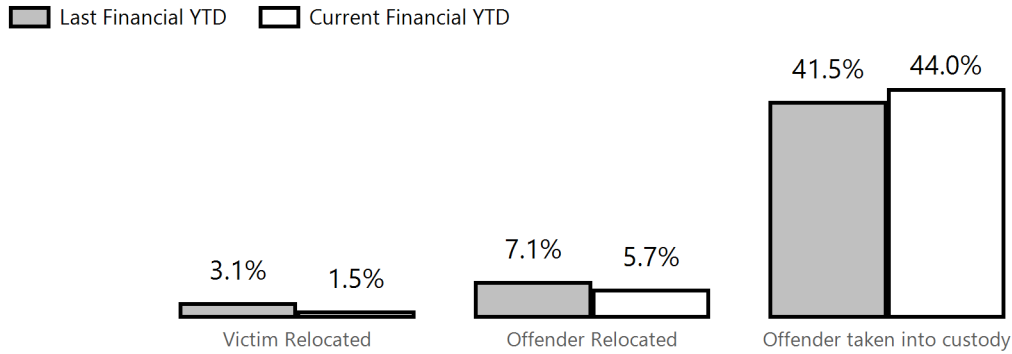

Family Violence RAST - Excludes Other and Argument Categories



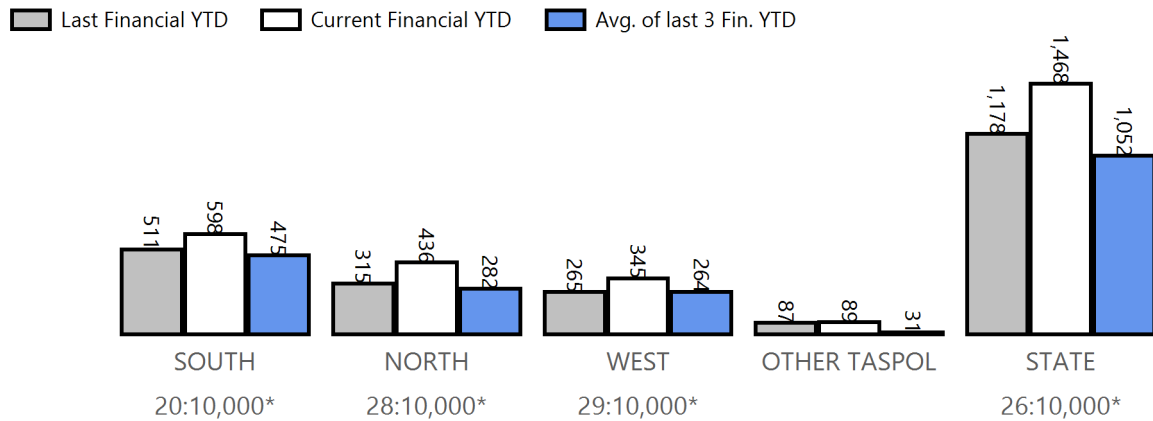

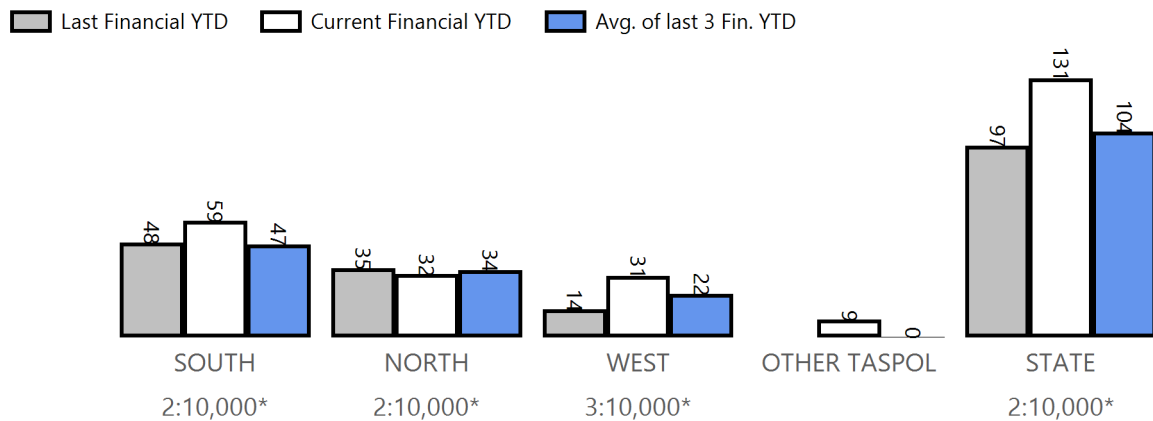
Family Violence Incidents with Child Witness - November 2024

Family Violence Incidents: Weapons Present - November 2024



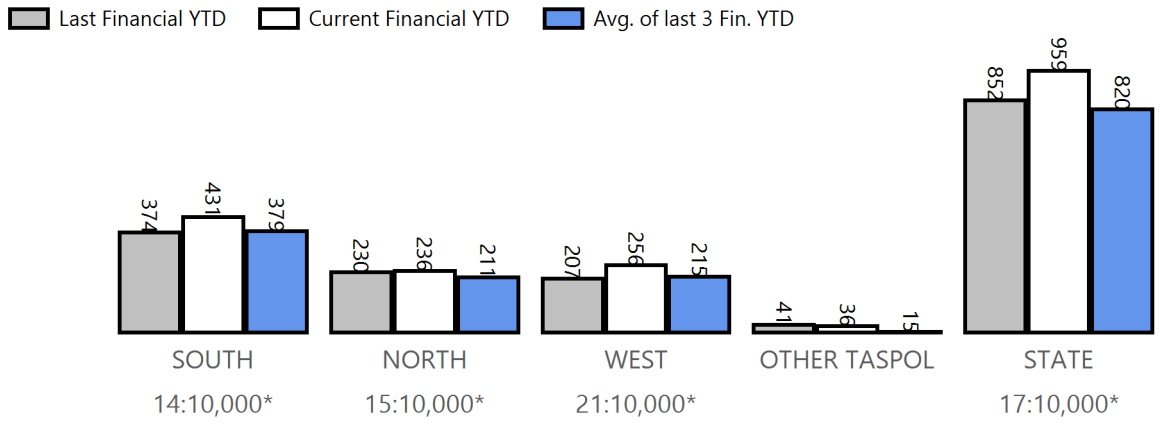

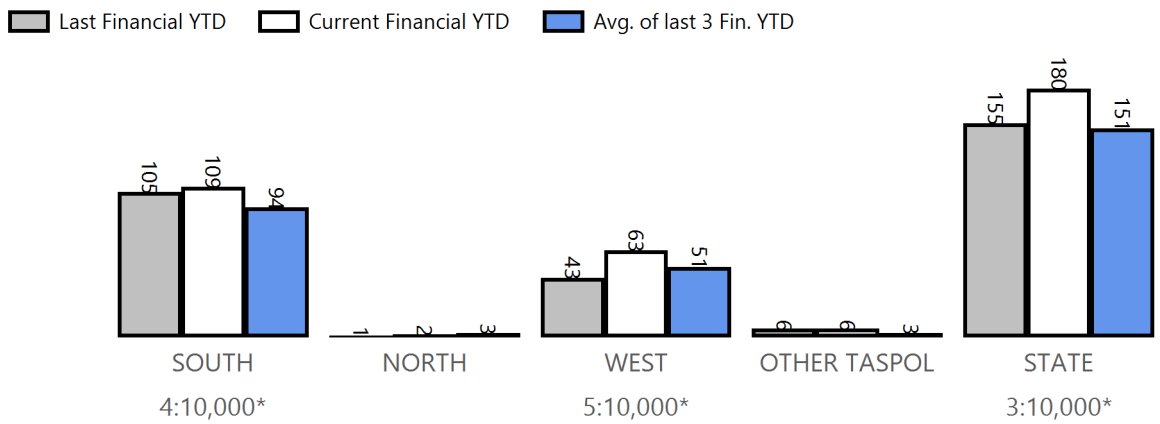
FV Incidents with Police FV Order Issued - November 2024

FV Incidents with FV Order Application - November 2024

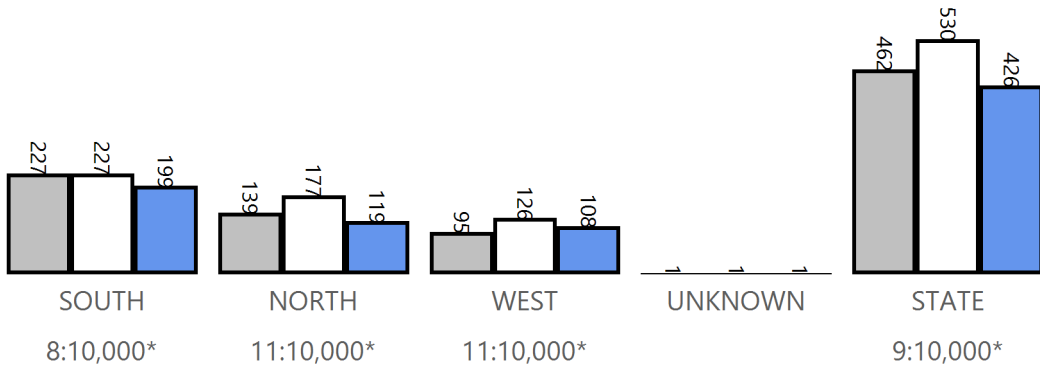

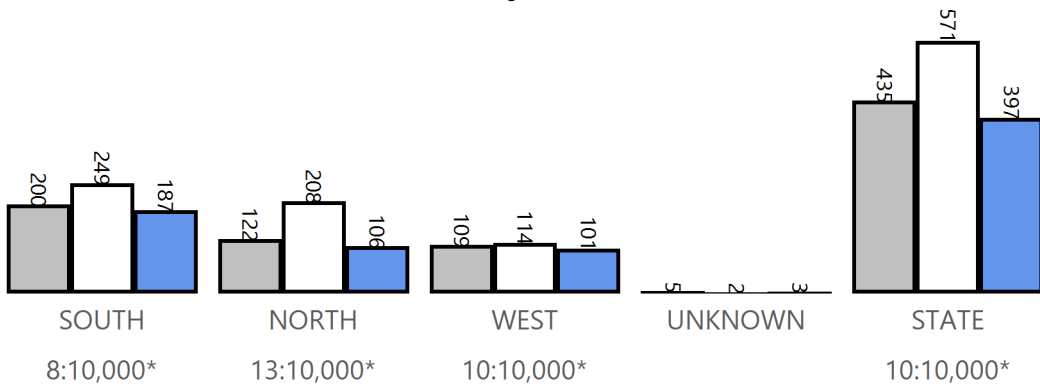

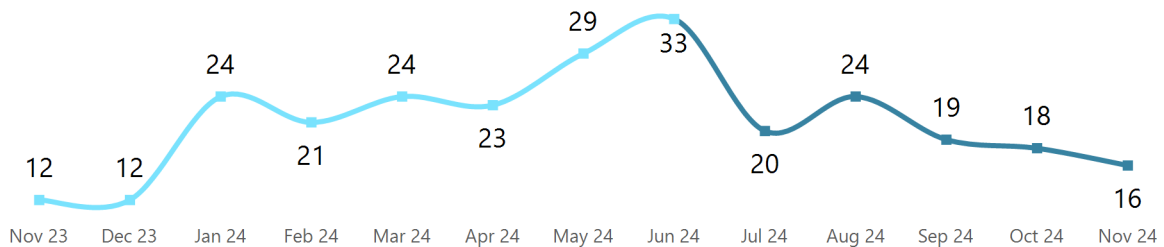
SMV : Recovered Fire Damaged - November 2024

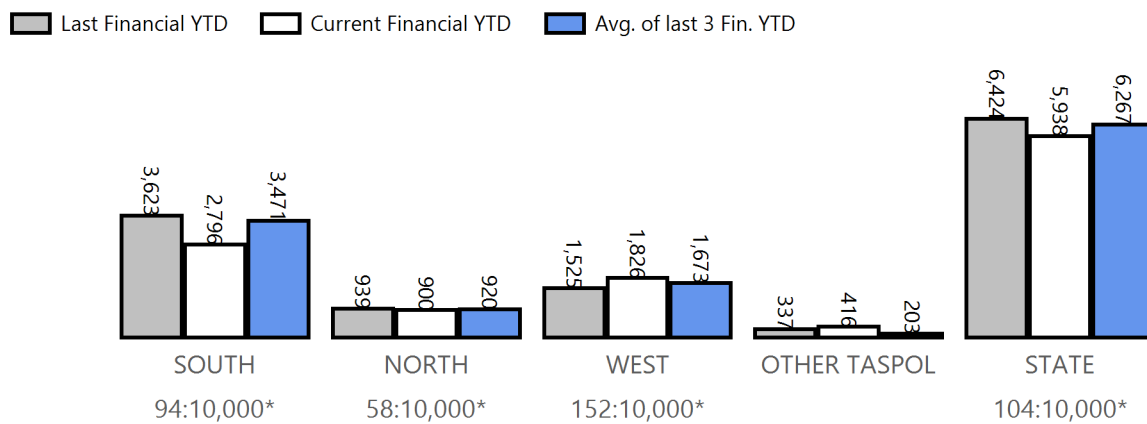
Intelligence Submission Occurrences - November 2024

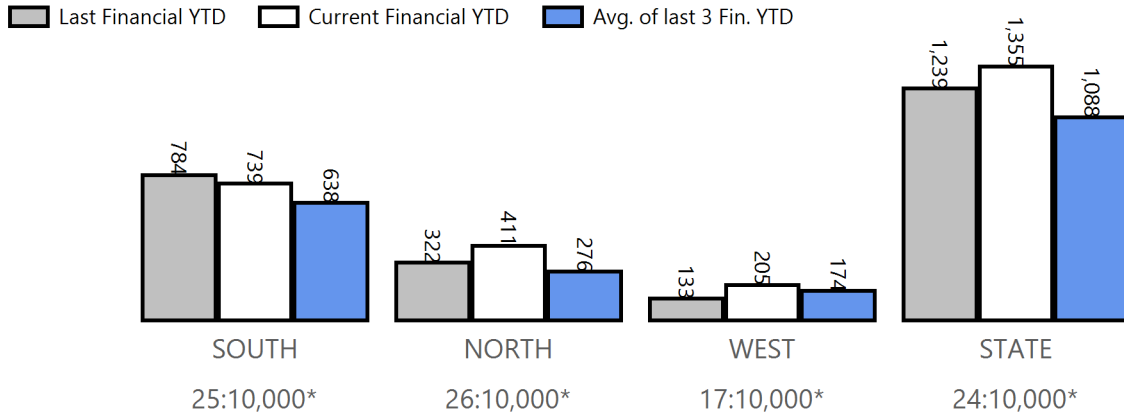
Street Check Occurrences - November 2024

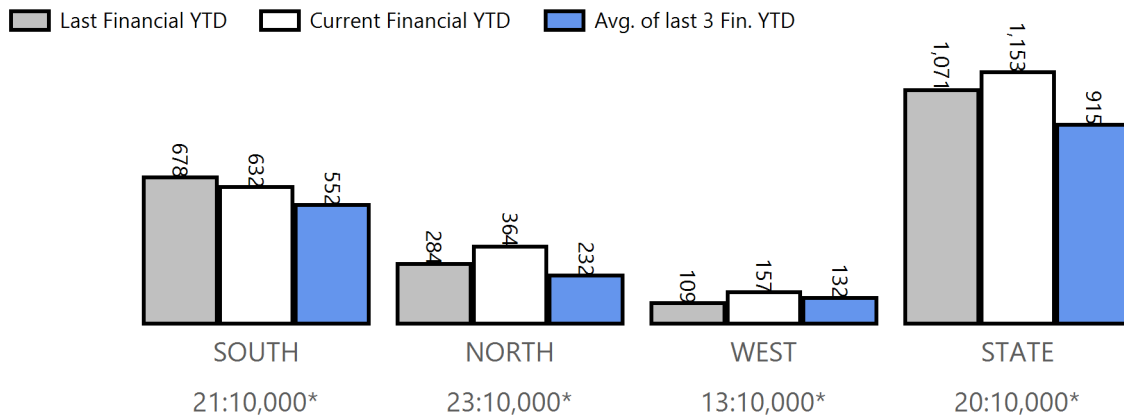
CIB: Total Offenders - November 2024

CIB: Total Crime Offenders - November 2024

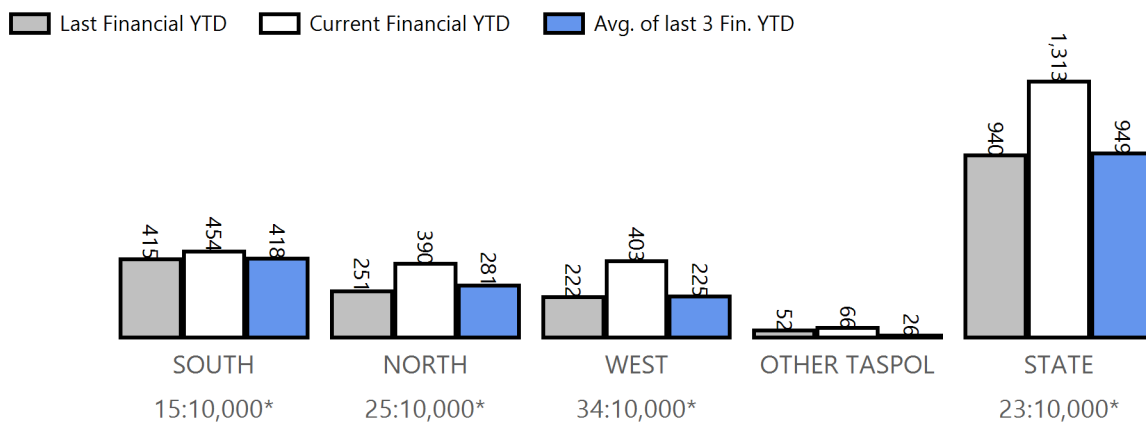

Total Traffic Offenders - November 2024



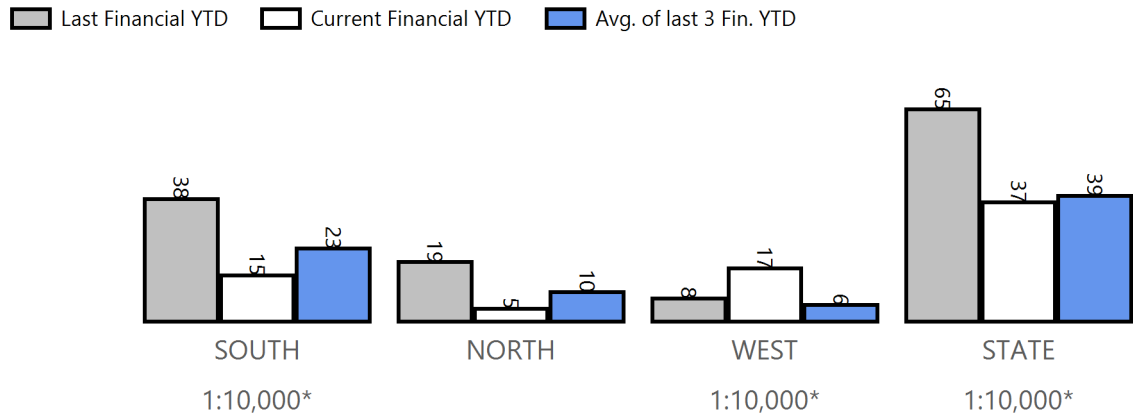

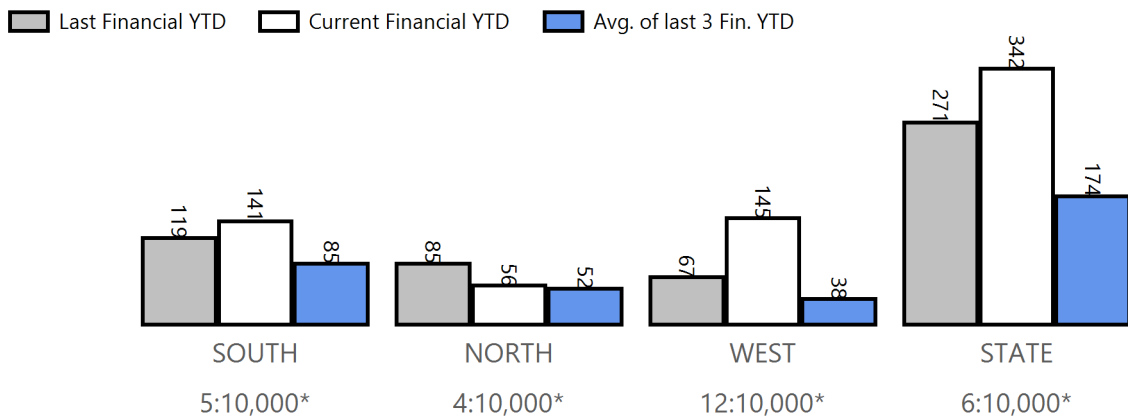
Major Static District Traffic Operations - November 2024

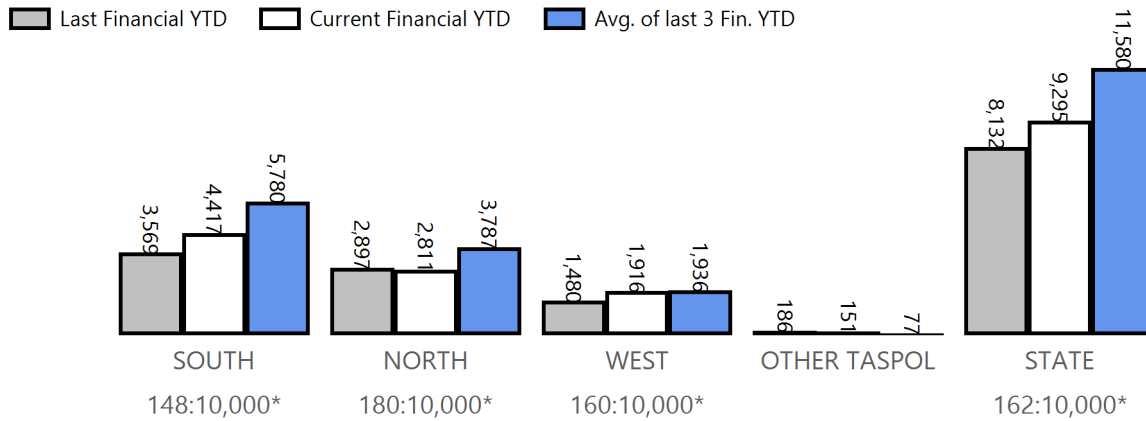

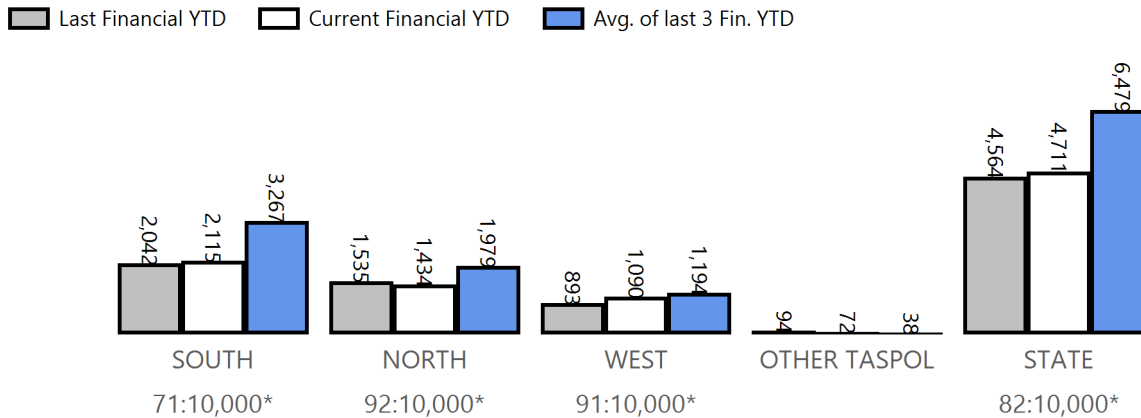
Speeding Offenders - November 2024

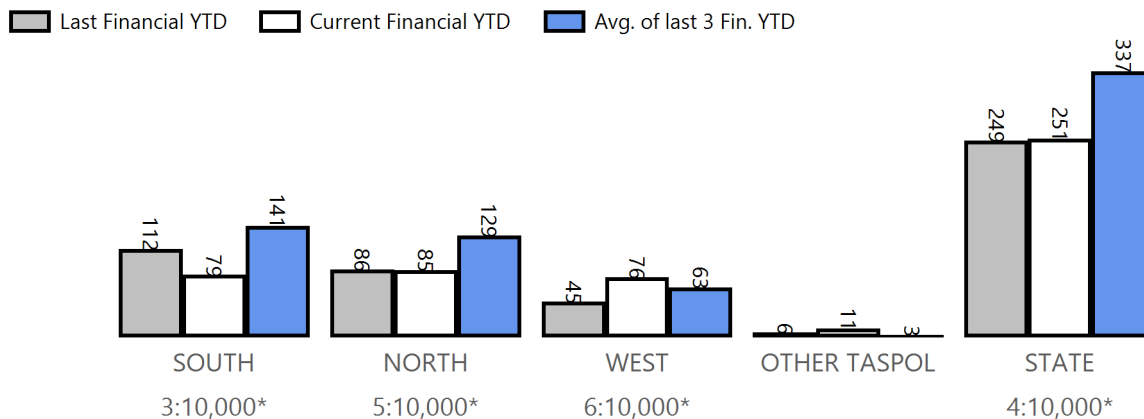
Speeding 15-29 km/h Offenders - November 2024

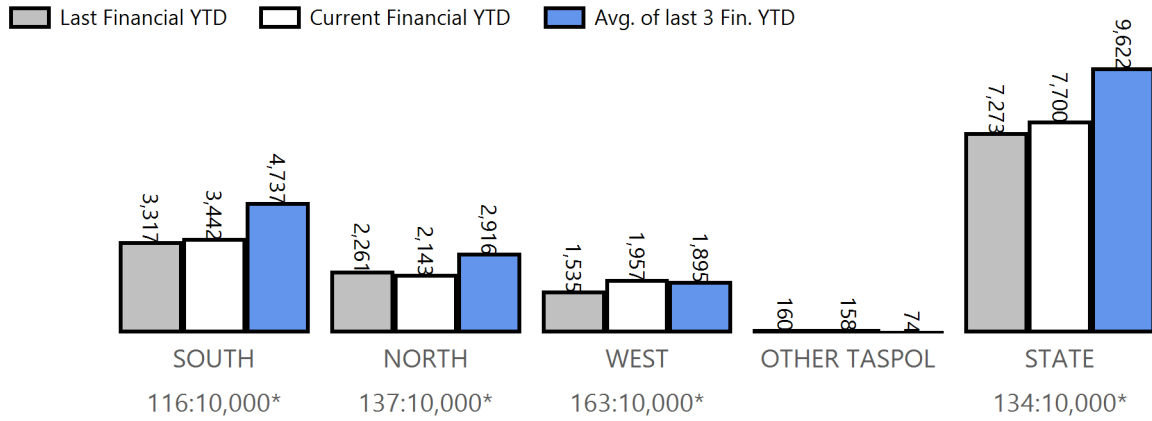
Speeding 30+ km/h Offenders - November 2024

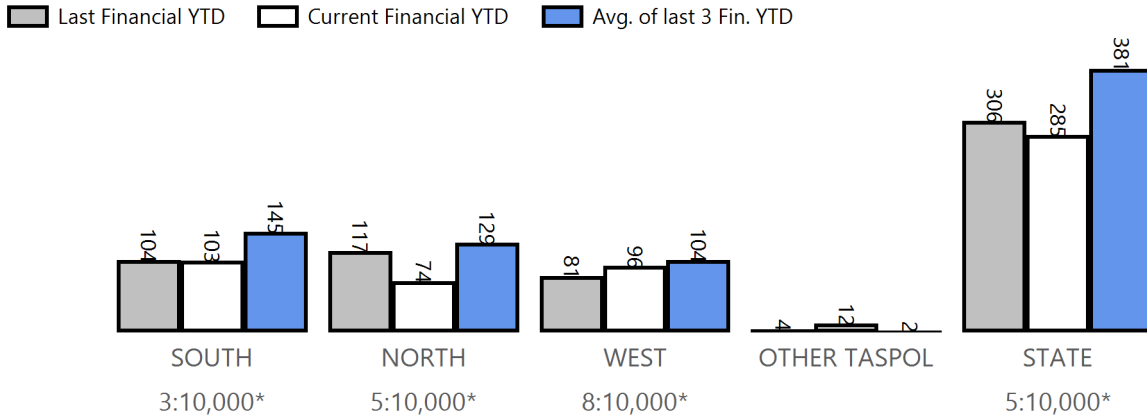
High Risk Traffic Offenders - November 2024

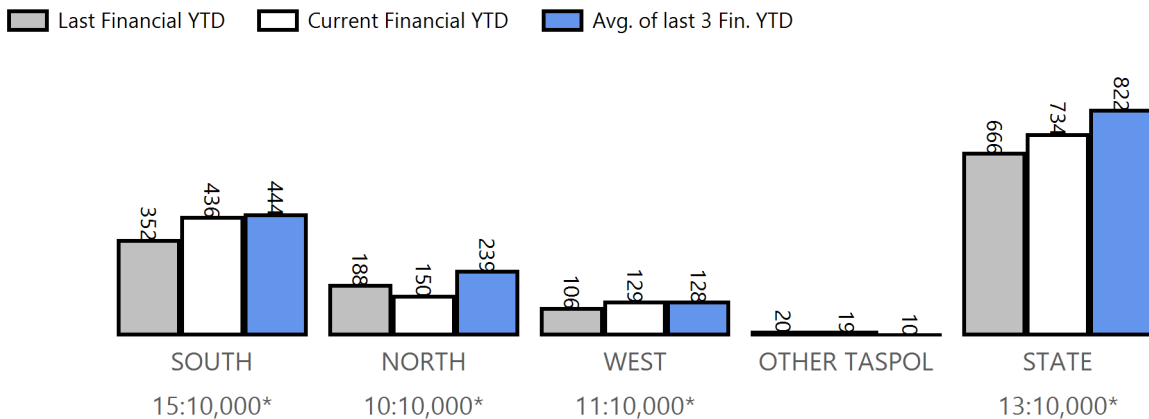
Seatbelt Compliance Offenders - November 2024

Mobile Phone Offenders - November 2024

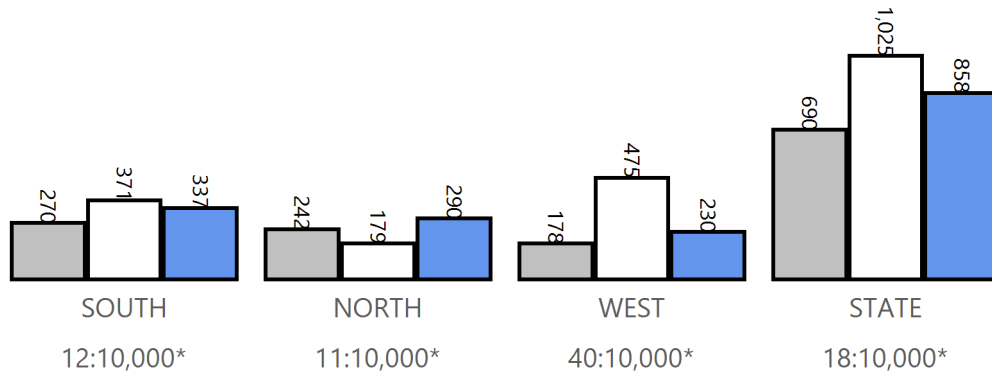

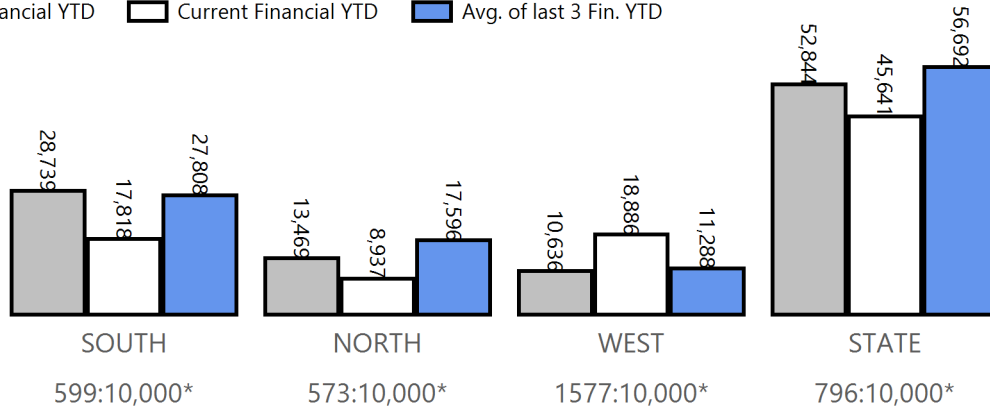

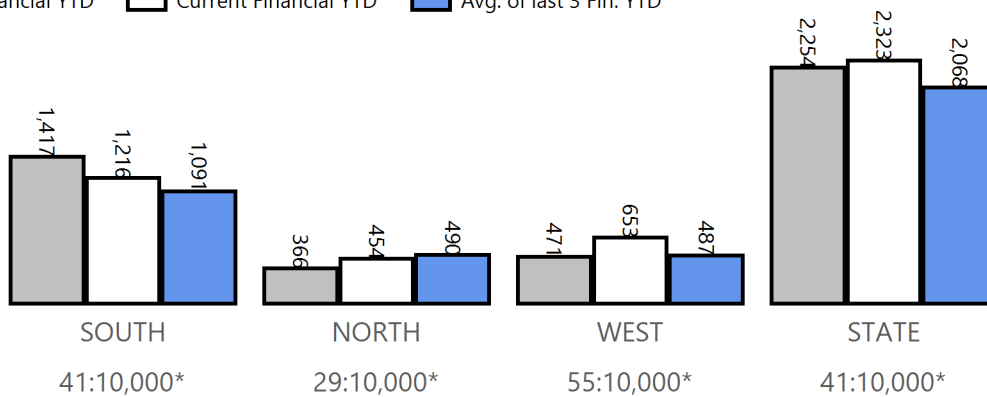

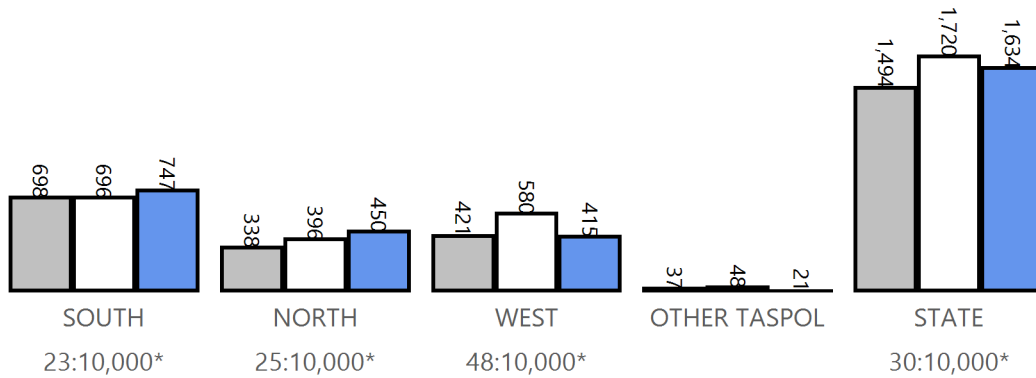

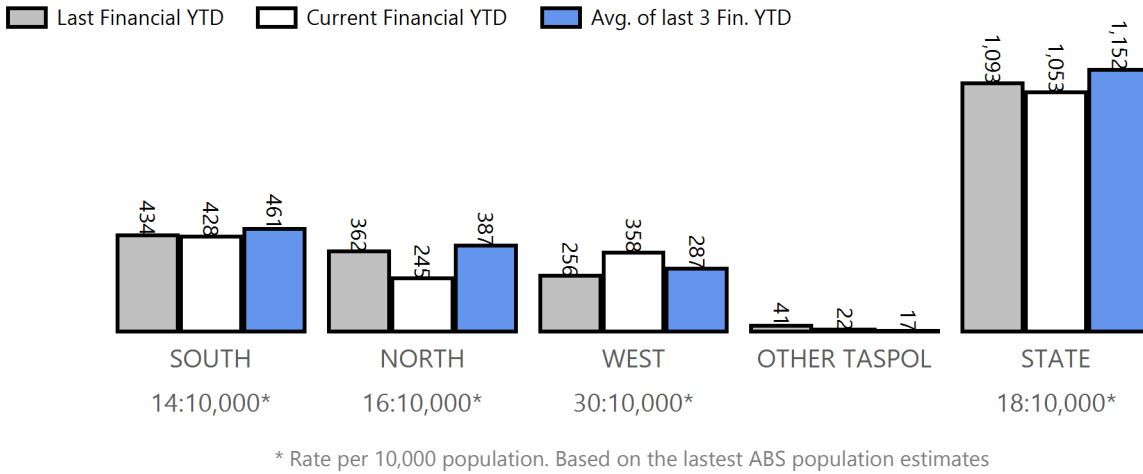

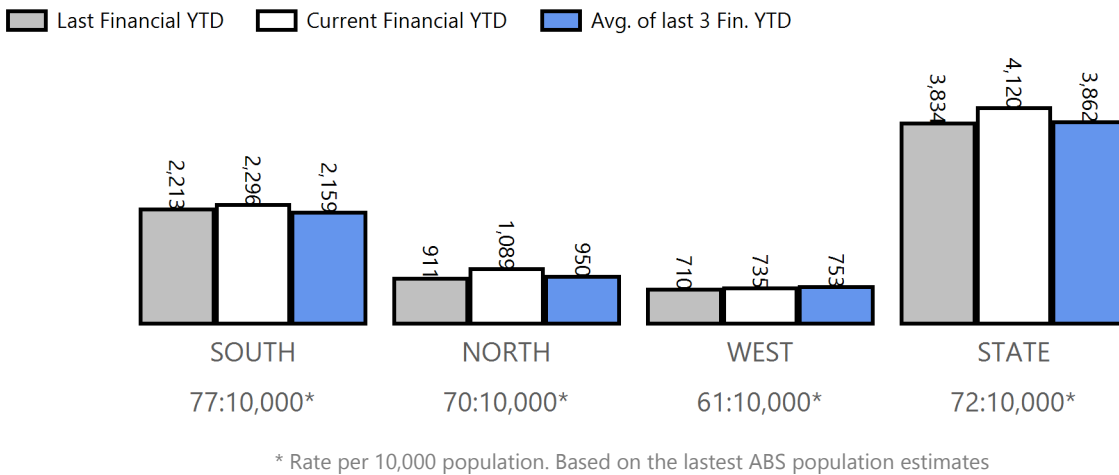

Unregistered Vehicle Offenders - November 2024



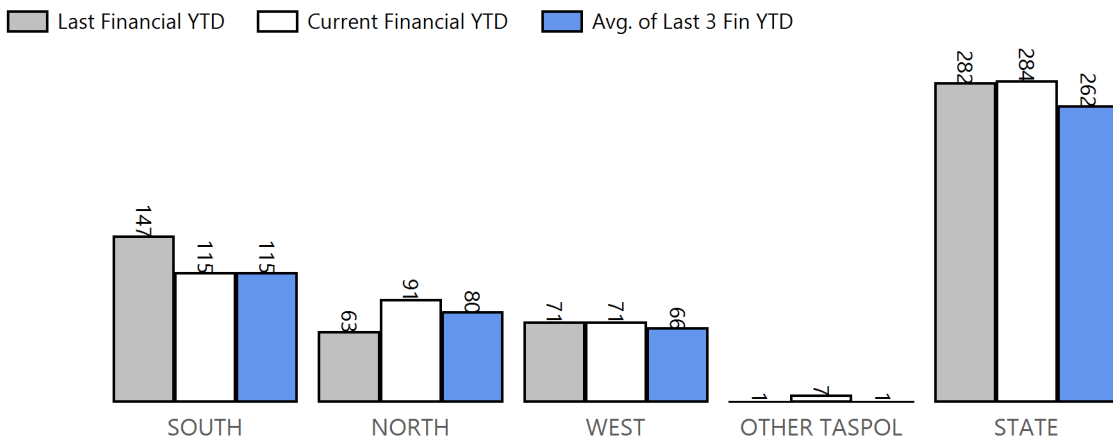

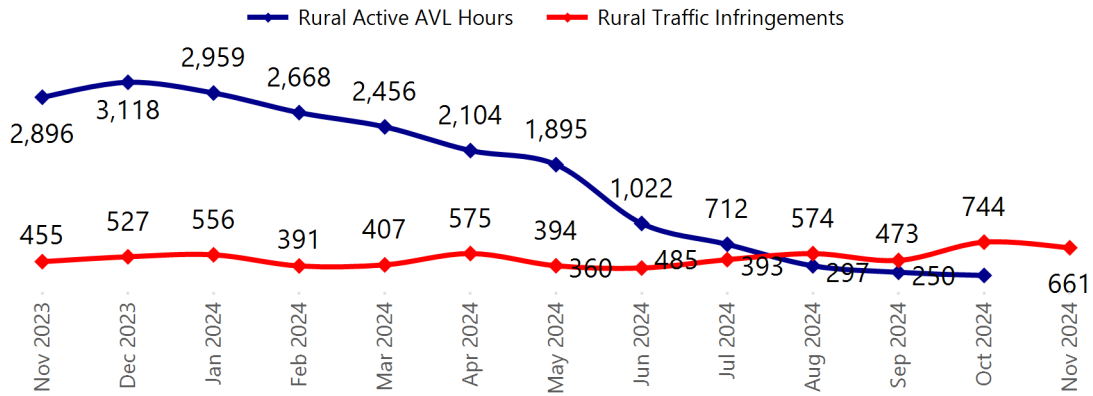
On Road Fatal and Serious Crashes in Rural Areas - November 2024



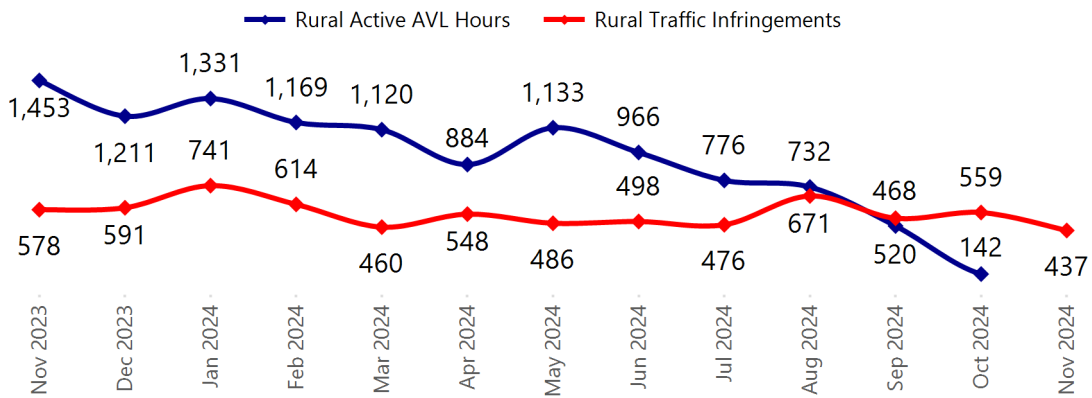

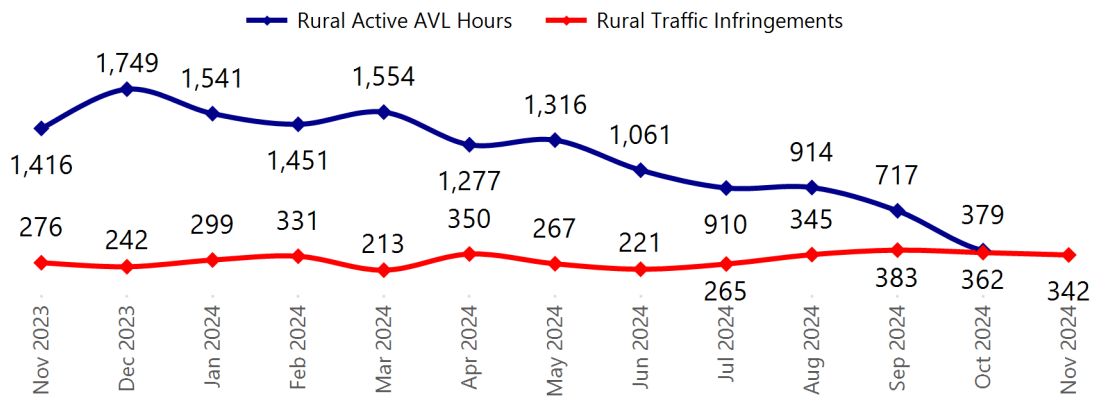
Southern District Rural Policing



Northern District Rural Policing

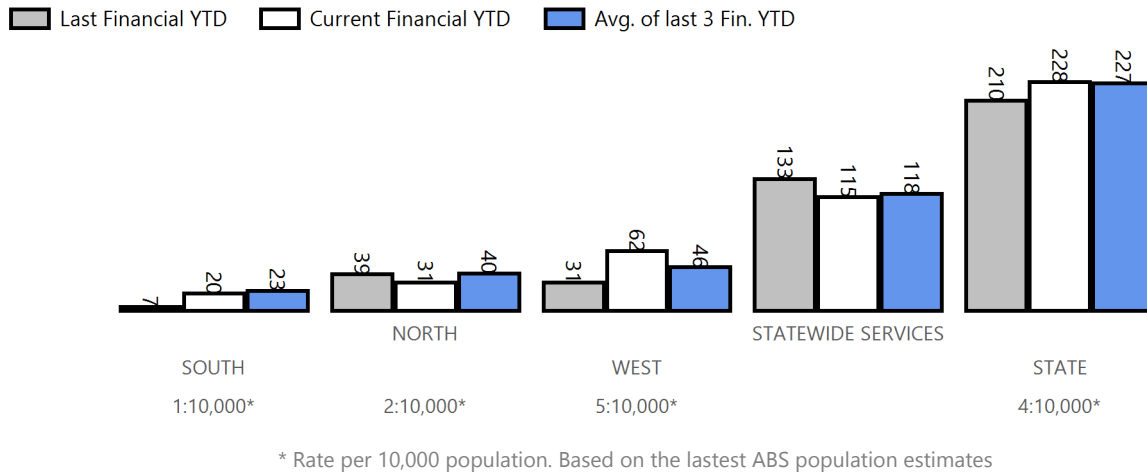

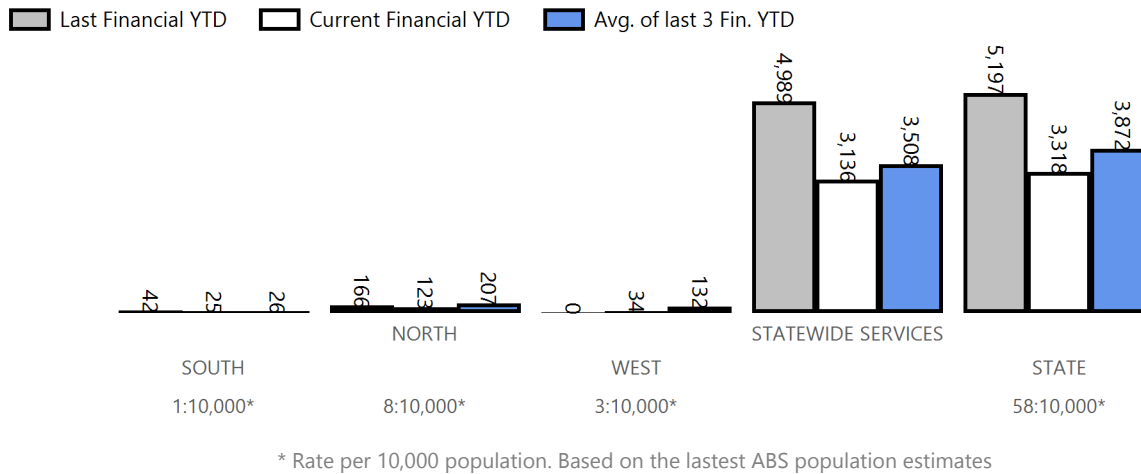

Total Marine Offenders - November 2024

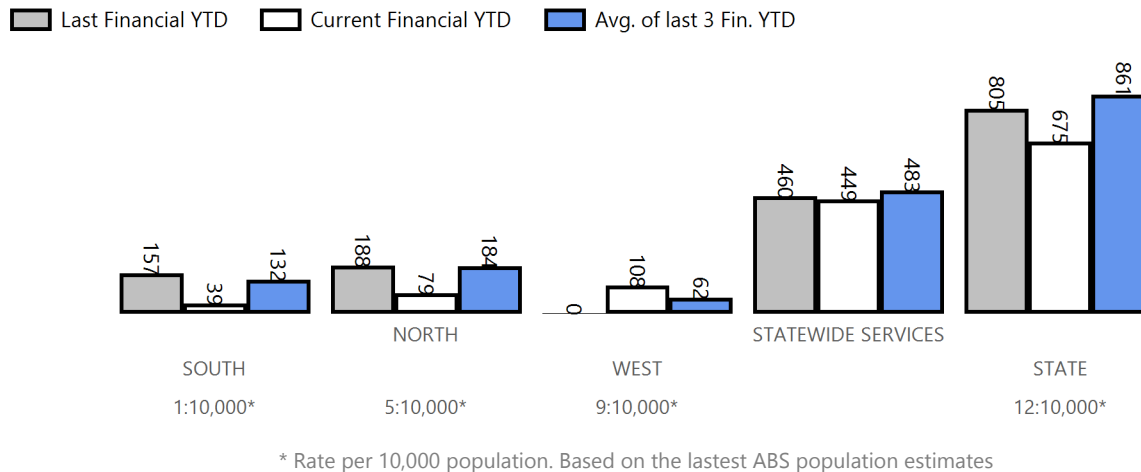


Sea Inspections (Vessel & Non-Vessel) - November 2024



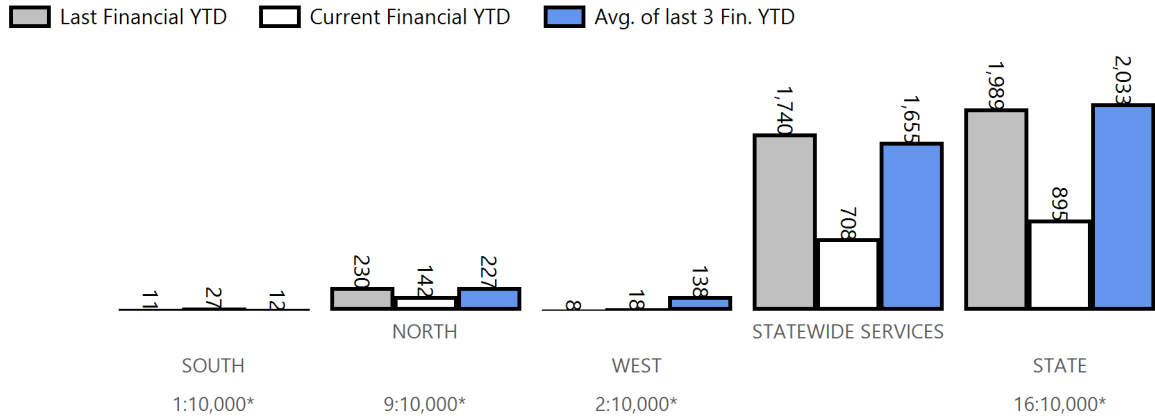
