The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data was extracted on 5 December 2022. Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.






Public Safety - Out in Public Locally (Daytime)




General Satisfaction with Police Services



Public Order Incidents - October 2022








Public Order: Vandalism - October 2022

Public Order: Offensive Behaviour - October 2022









Total Person Offences - Victim Categories - SOUTH



Total Person Offences - Victim Categories - NORTH





Total Person Offences - Victim Categories - WEST






Total Uniform Police Patrol Hours - October 2022








Family Violence: Juveniles Affected - October 2022




Family Violence Orders : Police Issued - October 2022

Family Violence Orders: Court Application - October 2022




Family Violence - PFVO Breaches - October 2022


Family Violence - FVO Breaches - October 2022



Serious Crime - October 2022






Robbery Offences - October 2022










Major Traffic Operations - October 2022




Speeding Offenders - October 2022


Excessive Speed Offenders - 15-29km/h - October 2022

Excessive Speed Offenders - 30km/h + - October 2022





High Risk Offenders - October 2022








Vehicle Defect Notices - October 2022


Random Breath Tests (ALCOHOL) - October 2022




Dangerous and Reckless Driving Offenders - October 2022




Unregistered Vehicle Offenders - October 2022




Automatic Number Plate Recognition (ANPR) Camera : Roadside Hours - October 2022





Road Crashes: Fatalities YTD - October 2022










Southern District Rural Policing



Northern District Rural Policing





Marine Offenders - October 2022






Vessel Inspections on Land - October 2022
