Disclaimer

The Corporate Performance Report is produced for internal purposes to measure the performance of our people, resources and systems, and to assist with the management of our business. The Report is made available to external stakeholders as the figures contained may be of public interest. Data are not extracted for the Report until one month after the reporting period has concluded. This one month period ensures there are sufficient opportunities for data to be entered into police systems and for quality assurance to be undertaken. However, the primary purpose of the Report is to measure internal performance, not provide official Departmental figures. There may be discrepancies between measures provided in this Report and official Departmental figures due to several possible factors.

Electronic data is extracted one month after the end of the reporting period (on the first day of the month).

Manual data is collated monthly by Reporting Services from information self-reported by organisational units within DPFEM or provided/downloaded from a variety of sources as indicated throughout the Report.

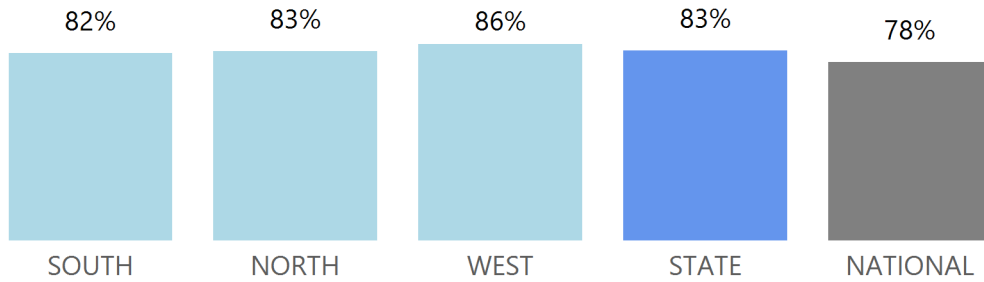

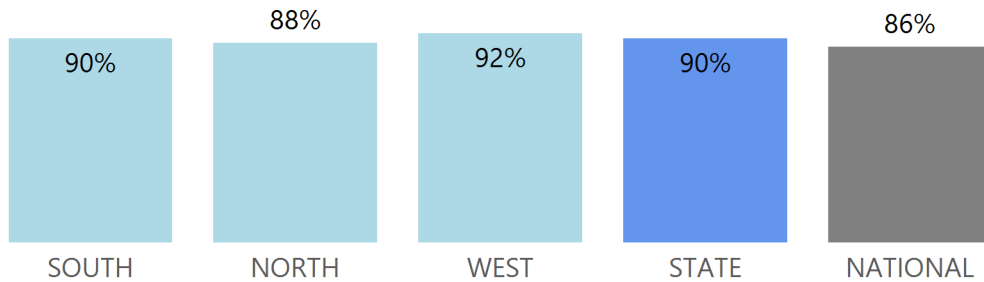
Safety at Home During the Night

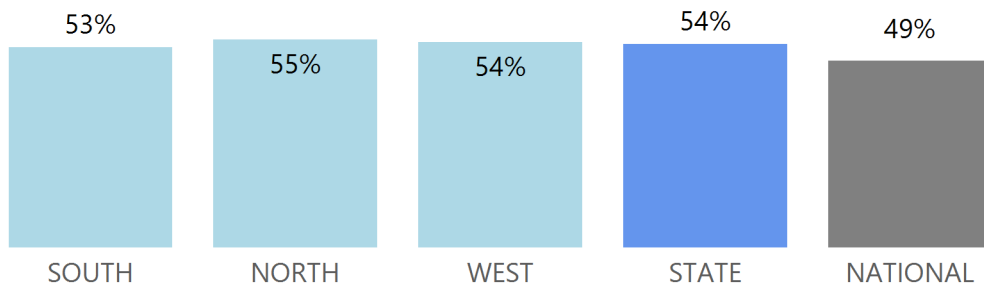
Safety In Neighbourhood During the Day

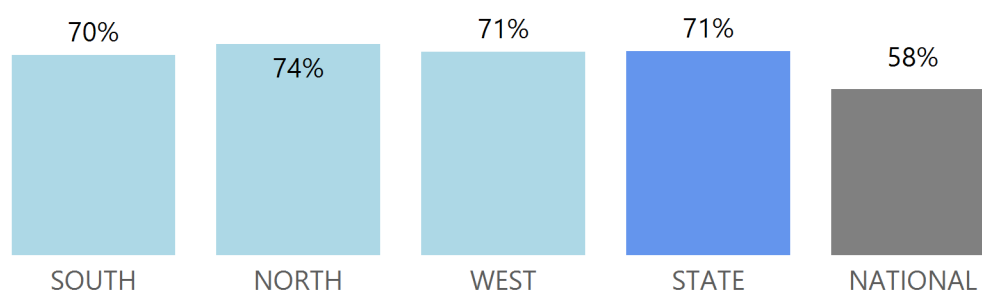

General Satisfaction with Police Services

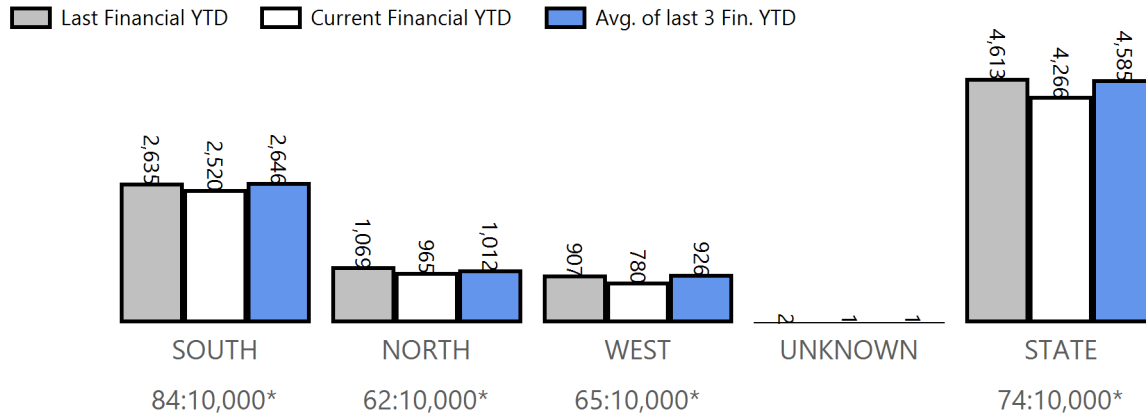

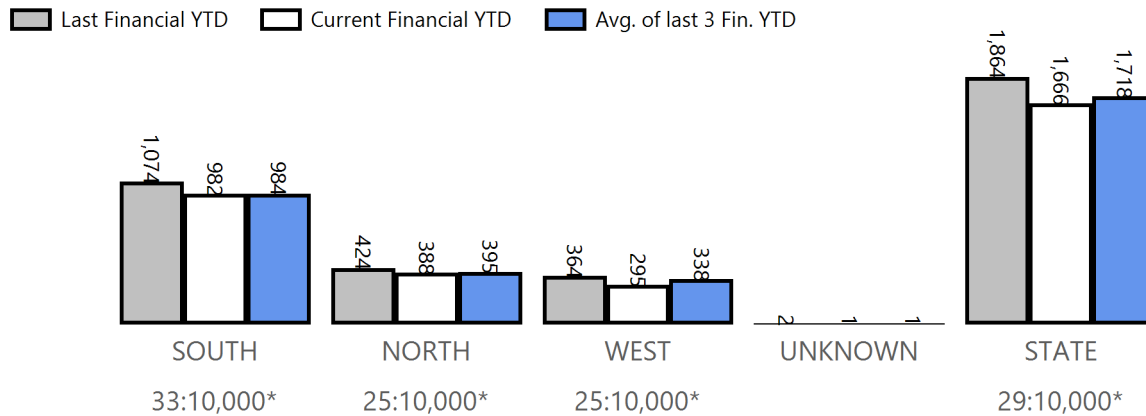
Public Order Incidents - September 2025

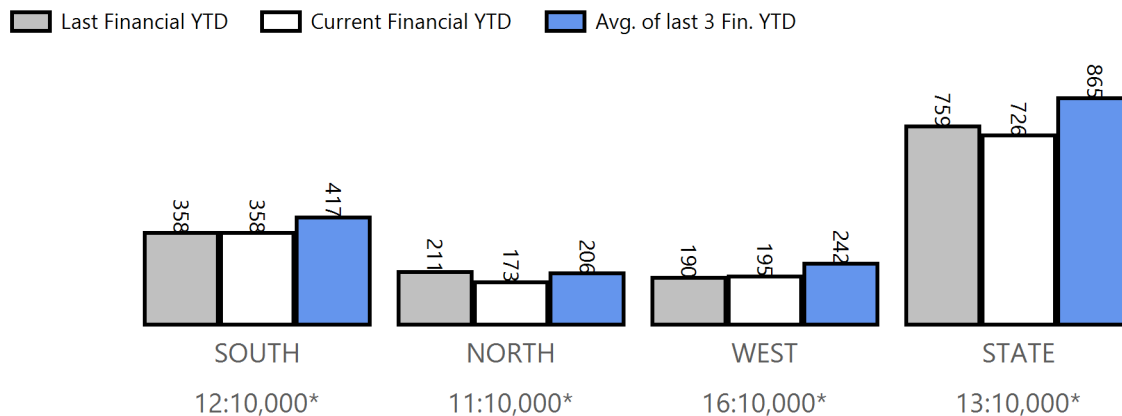
Public Order : Disturbance - September 2025

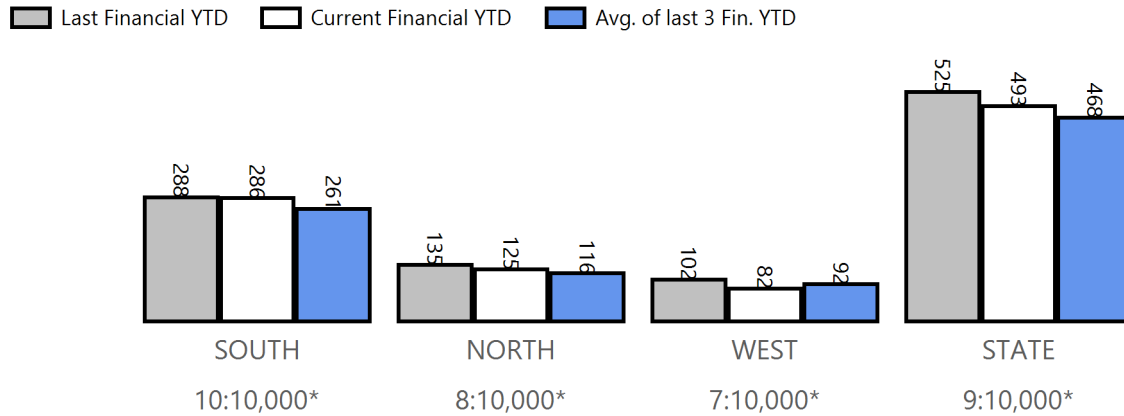
Public Order : Noise - September 2025

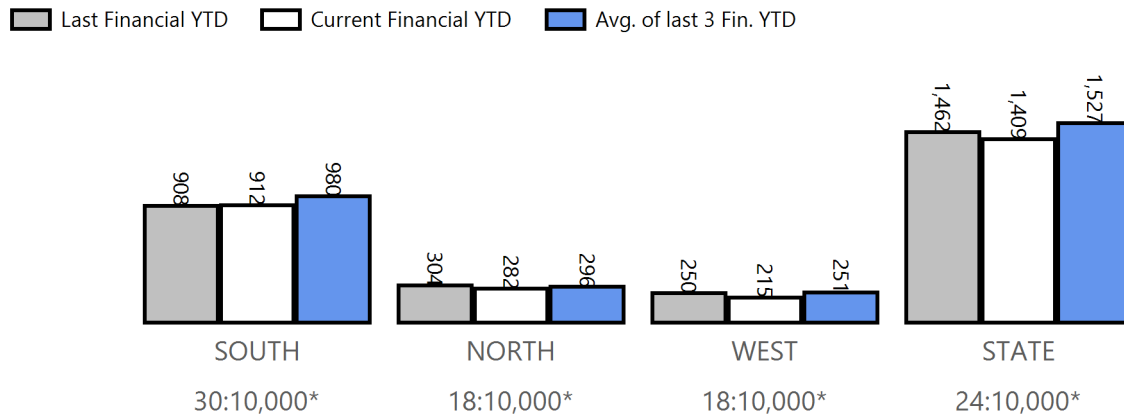
Public Order : Vandalism - September 2025

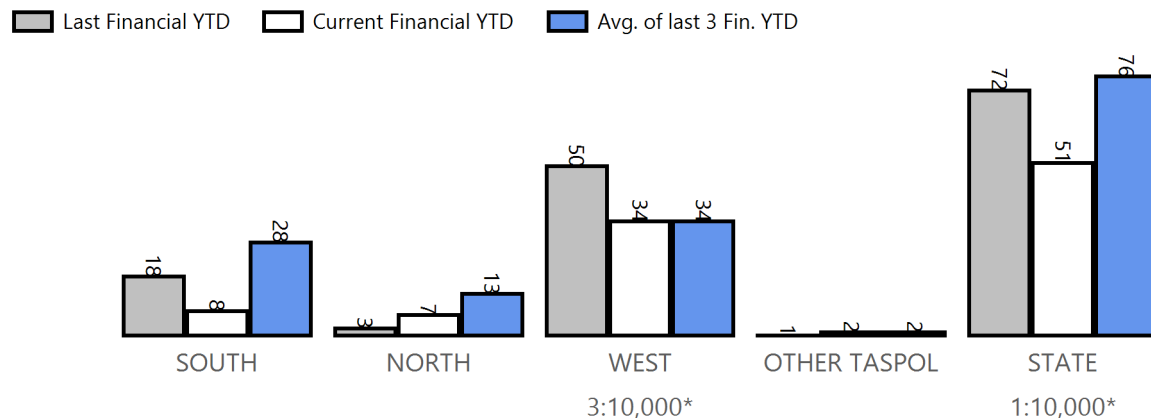
Public Order : Offensive Behaviour - September 2025

Liquor Infringement Notices - September 2025

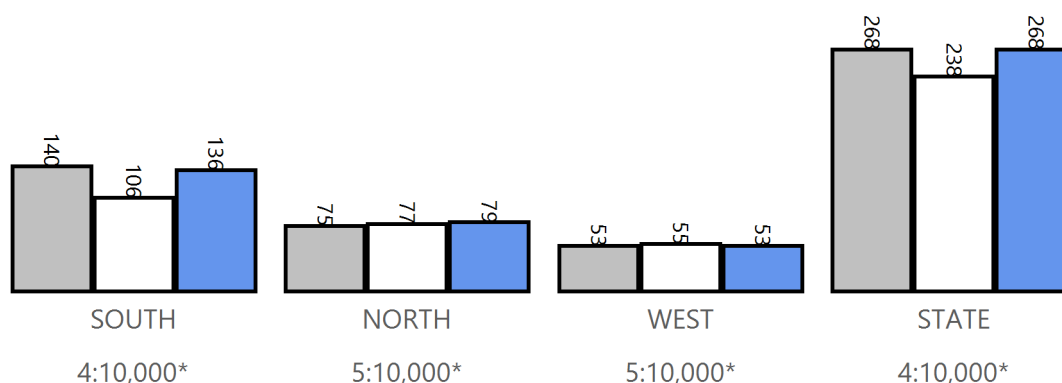

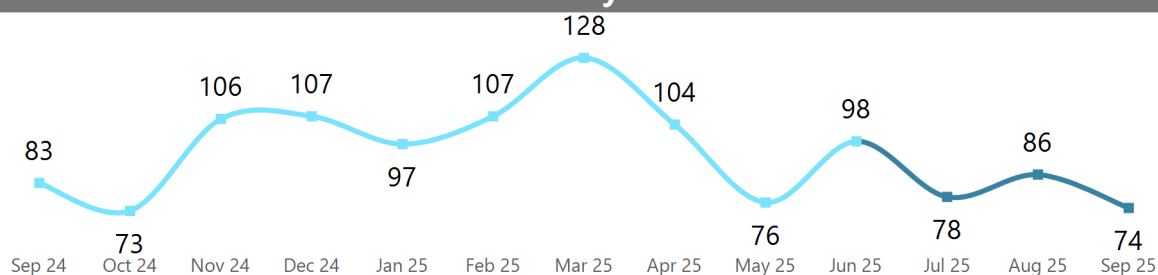

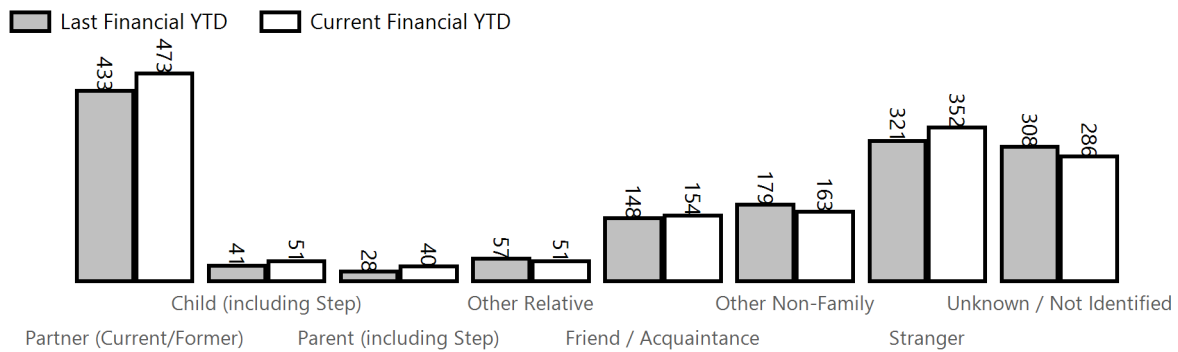

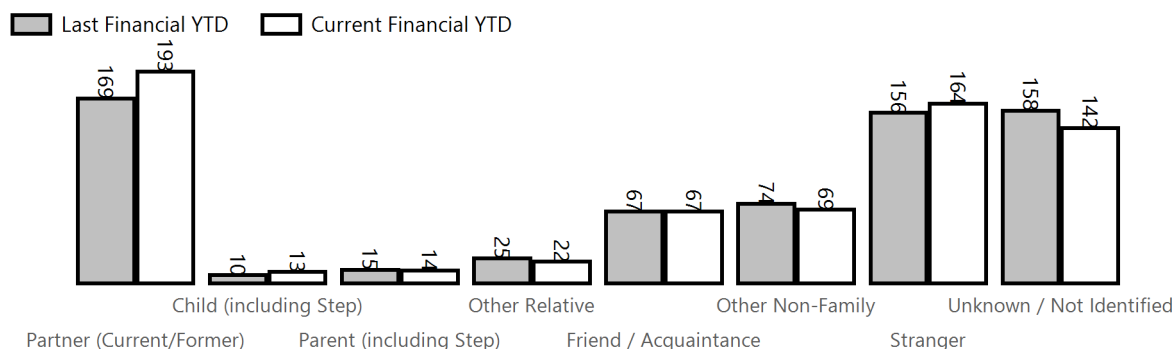

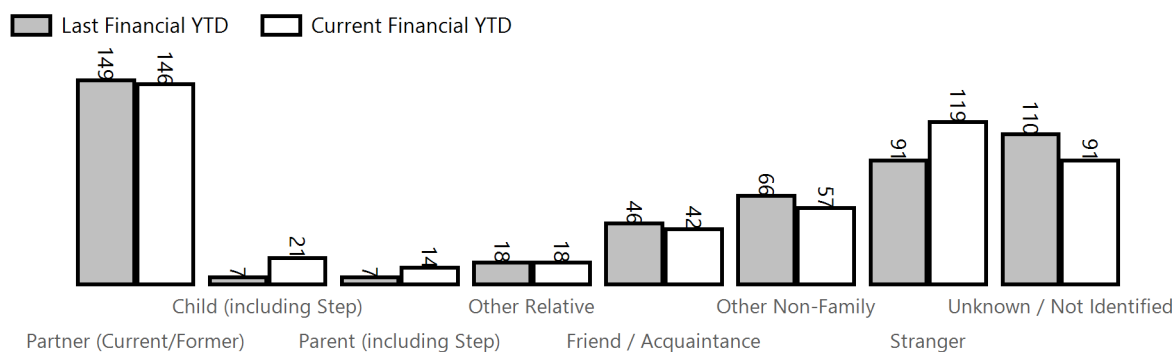

Total Person Offences - Victim Relationship - SOUTH



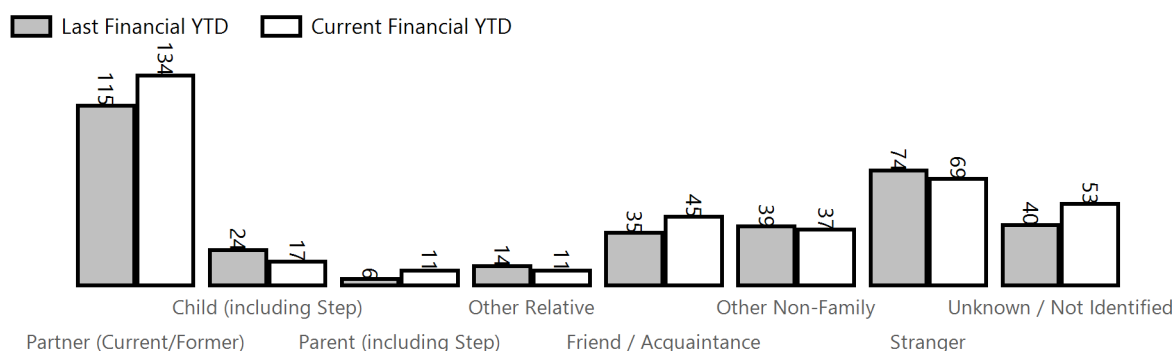

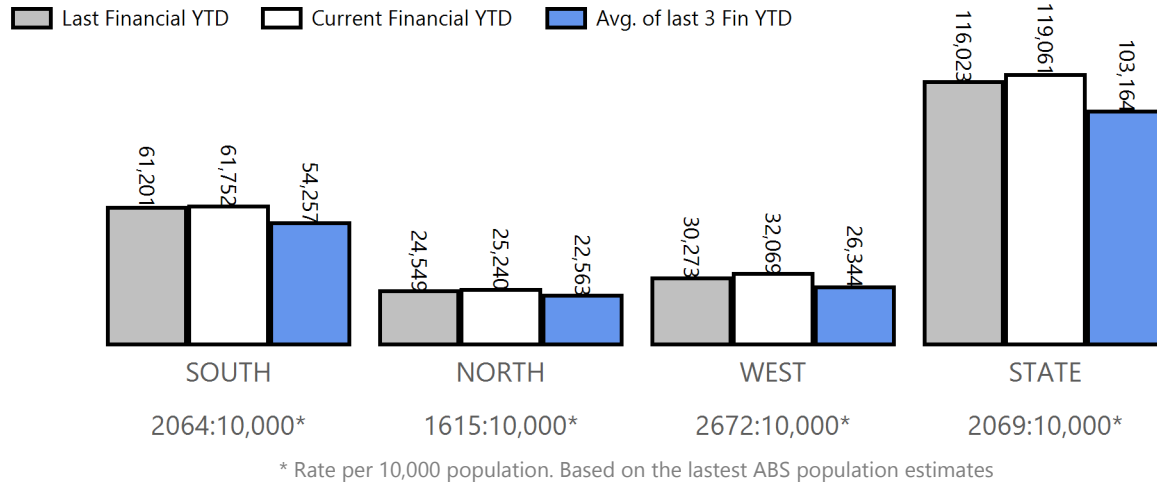

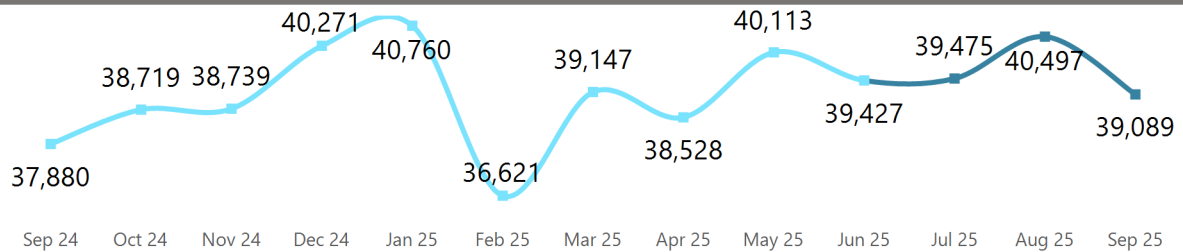

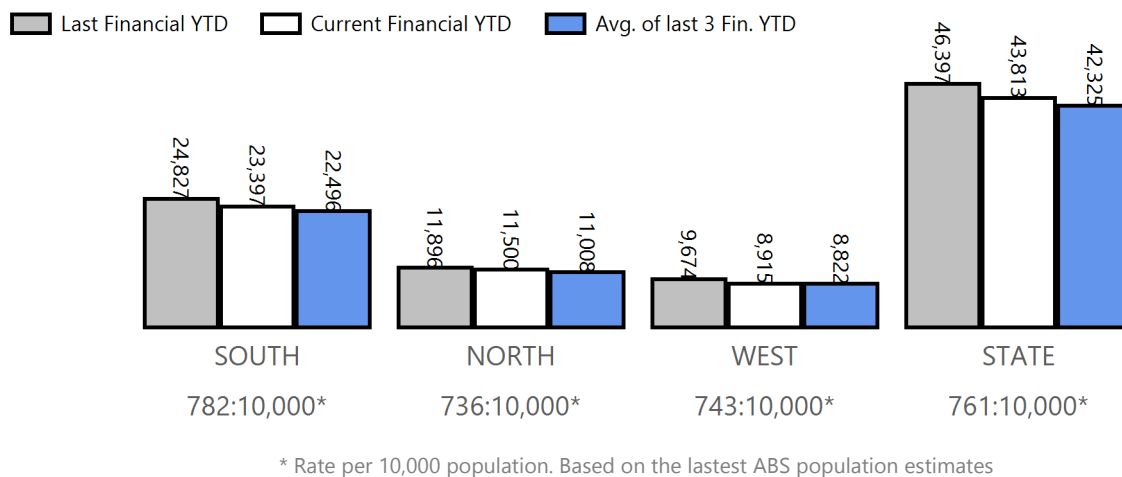


Uniform Police - Patrol Hours

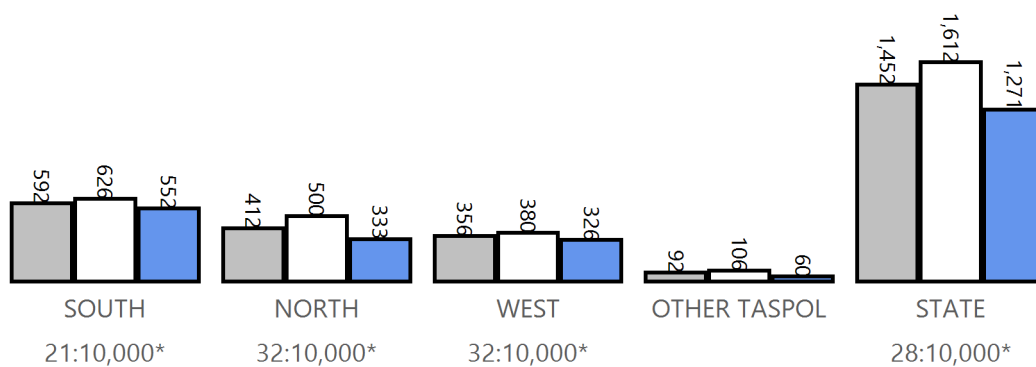

Family Violence Incidents - September 2025

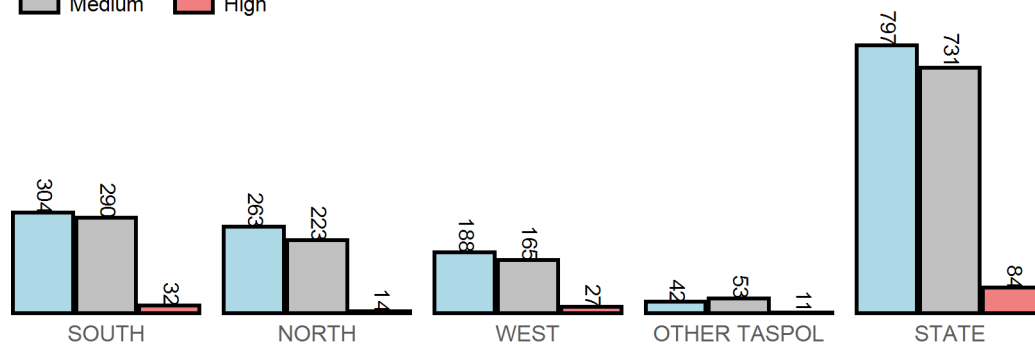

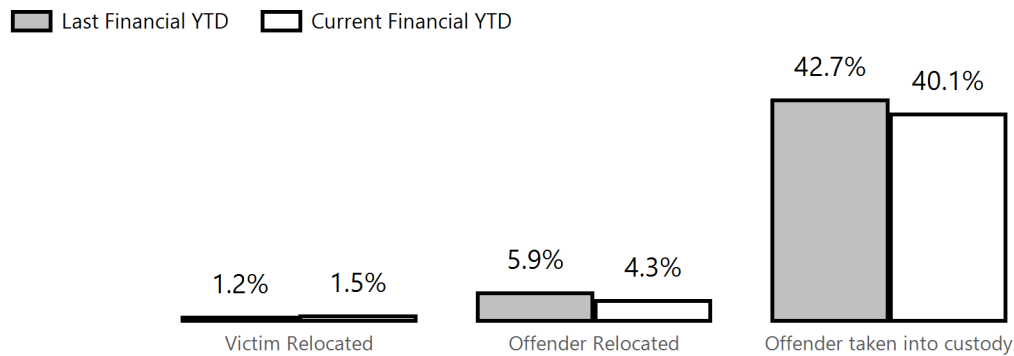
Family Violence RAST - Excludes Other and Argument Categories

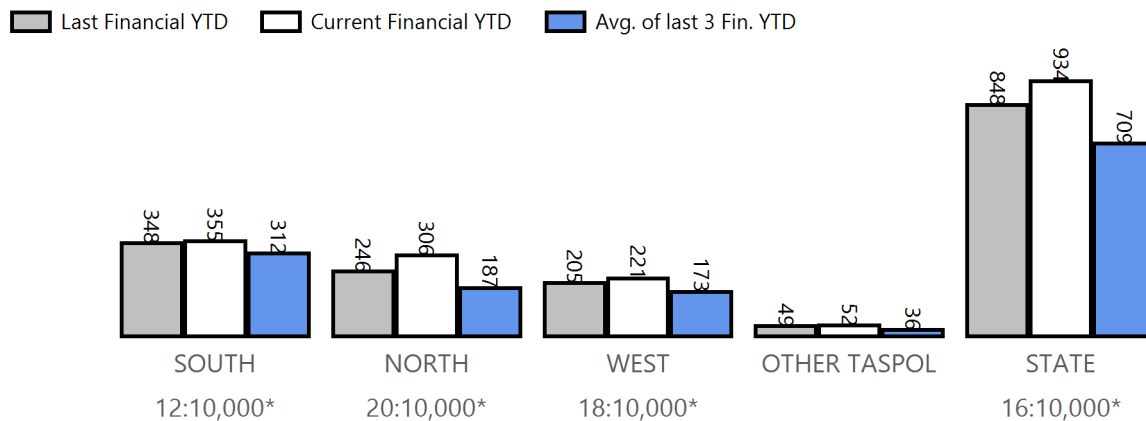

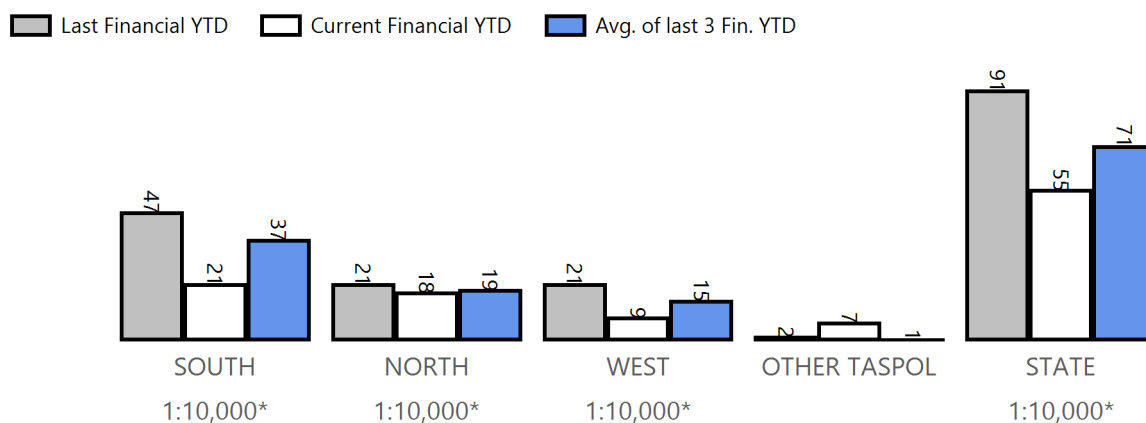
Family Violence Incidents with Child Witness - September 2025

Family Violence Incidents: Weapons Present - September 2025



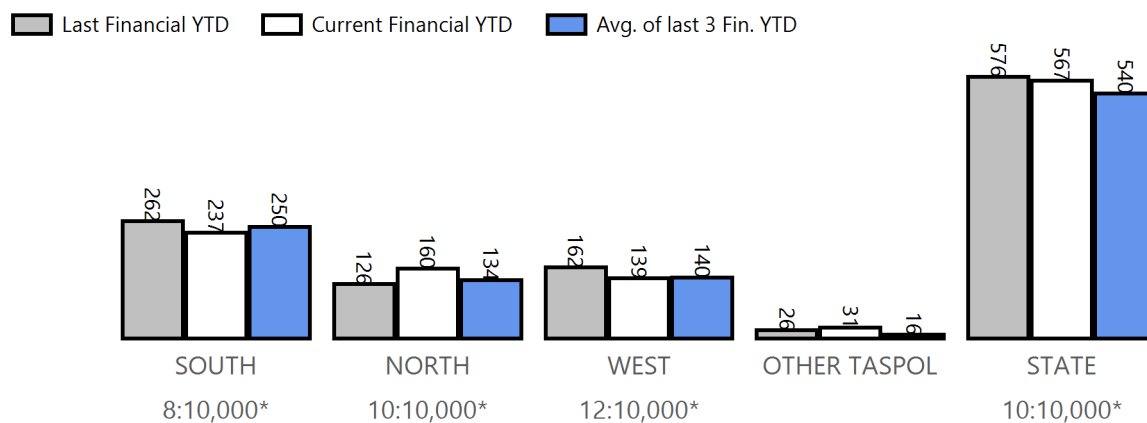

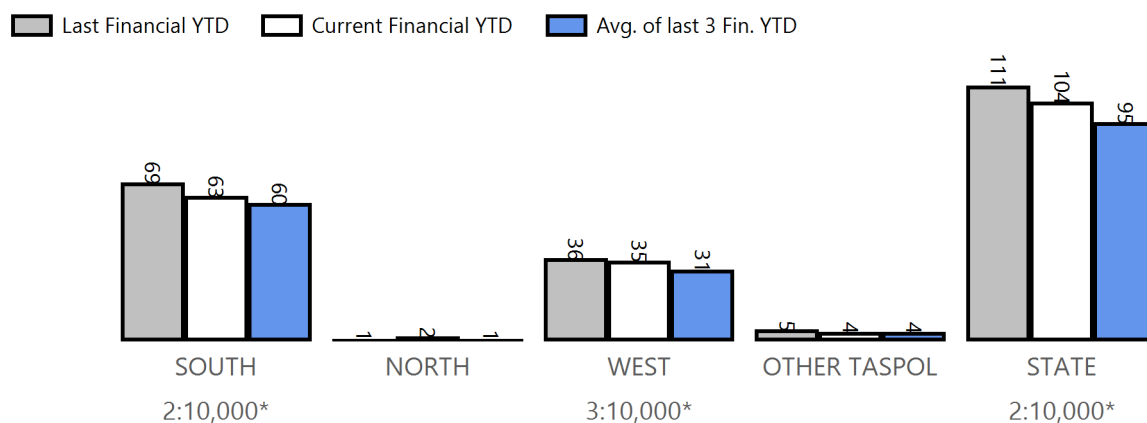
FV Incidents with Police FV Order Issued - September 2025

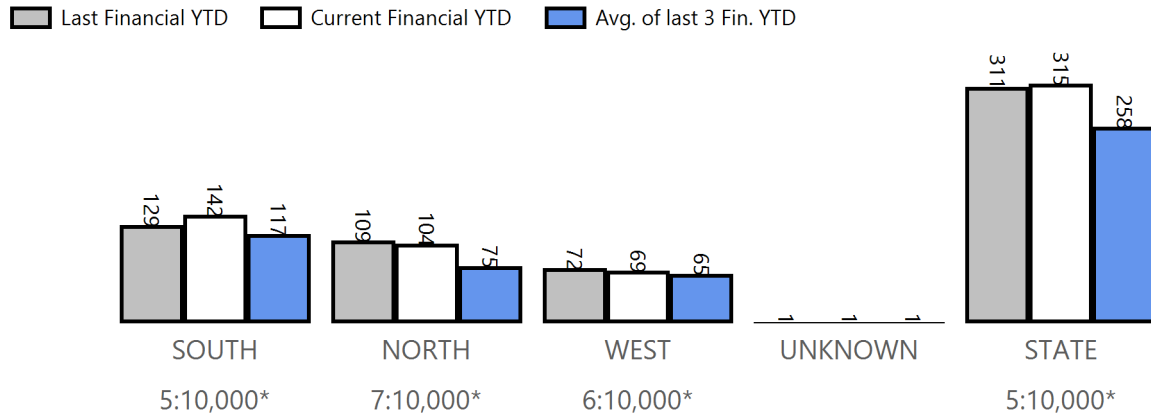
FV Incidents with FV Order Application - September 2025

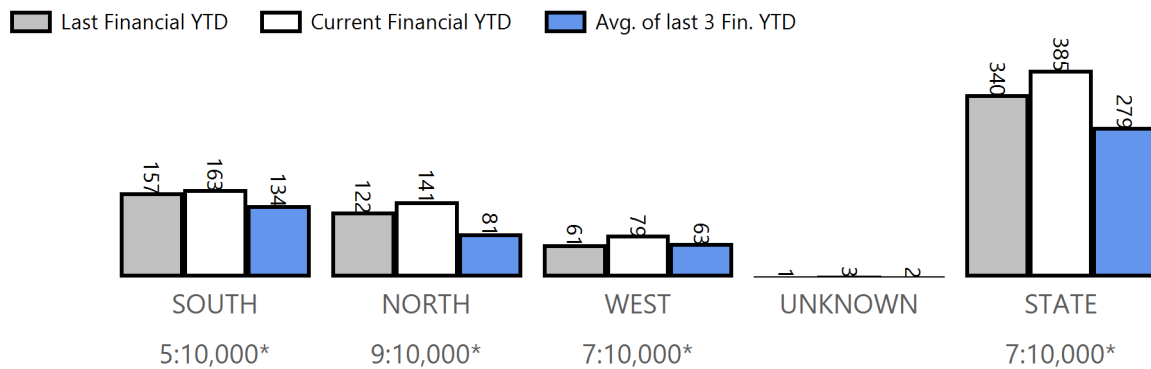
Breach of Police Family Violence Orders - September 2025

Breach of Family Violence Orders (excluding PFVOs) - September 2025

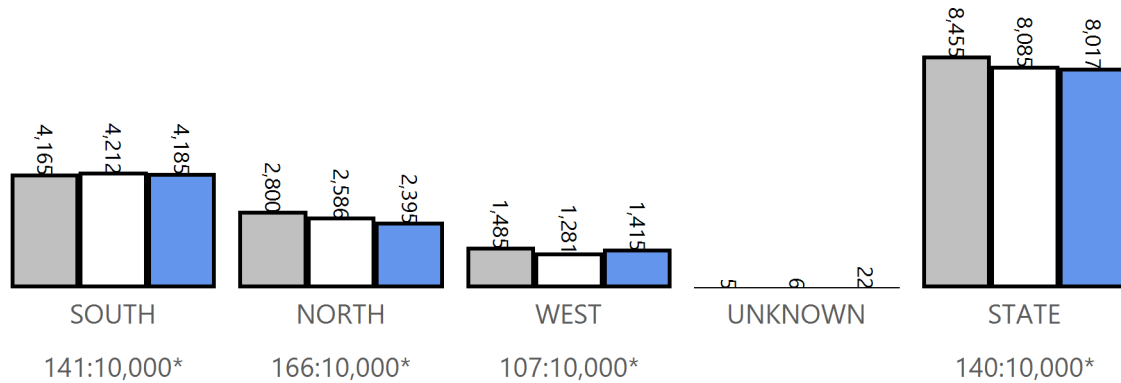

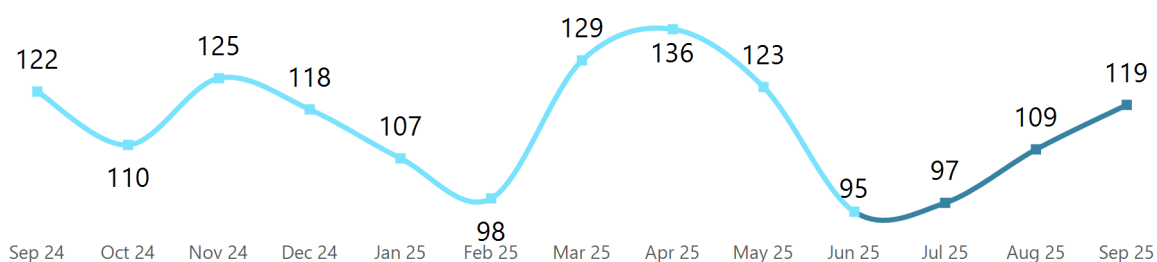

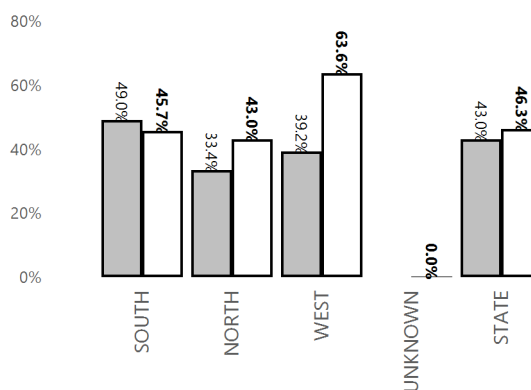

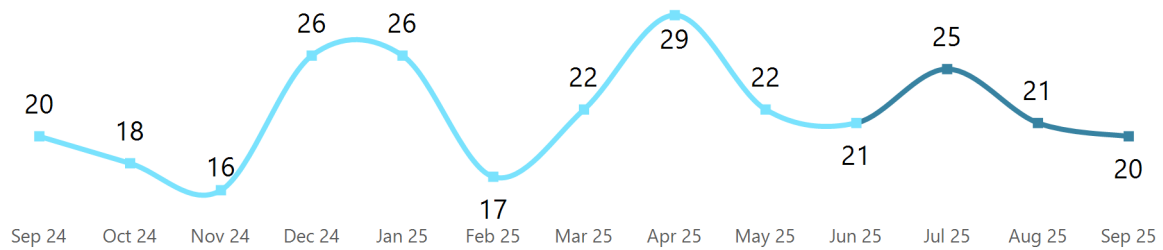
SMV : Recovered Fire Damaged - September 2025

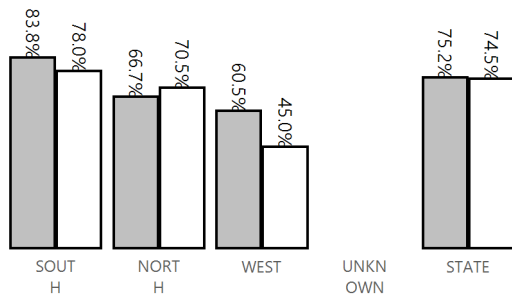

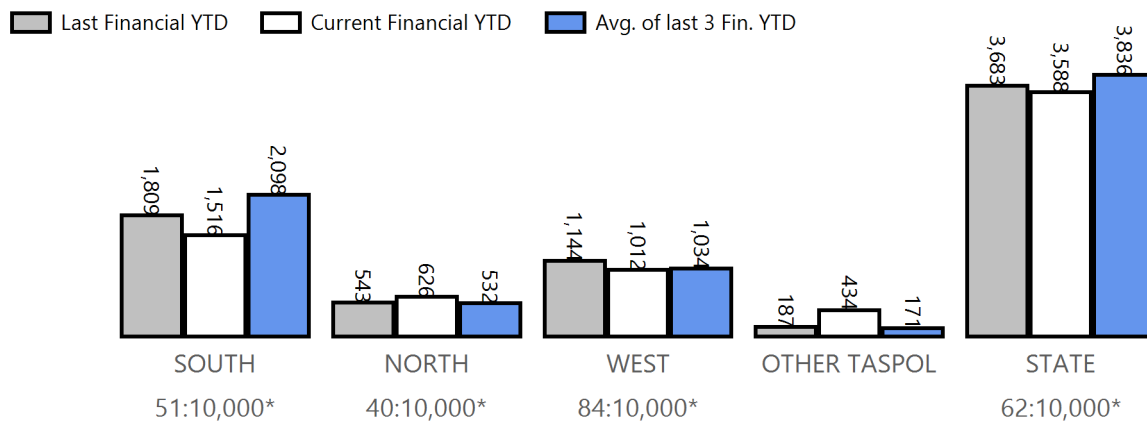
Intelligence Submission Occurrences - September 2025

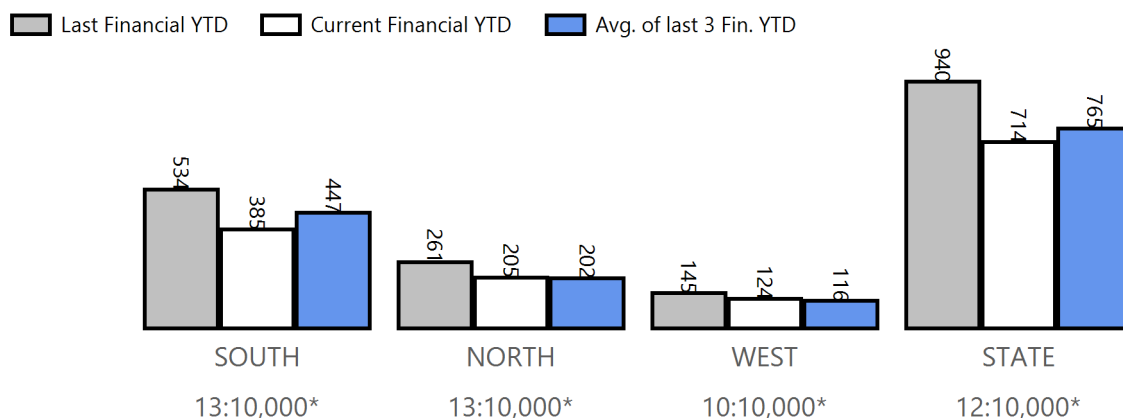
Street Check Occurrences - September 2025

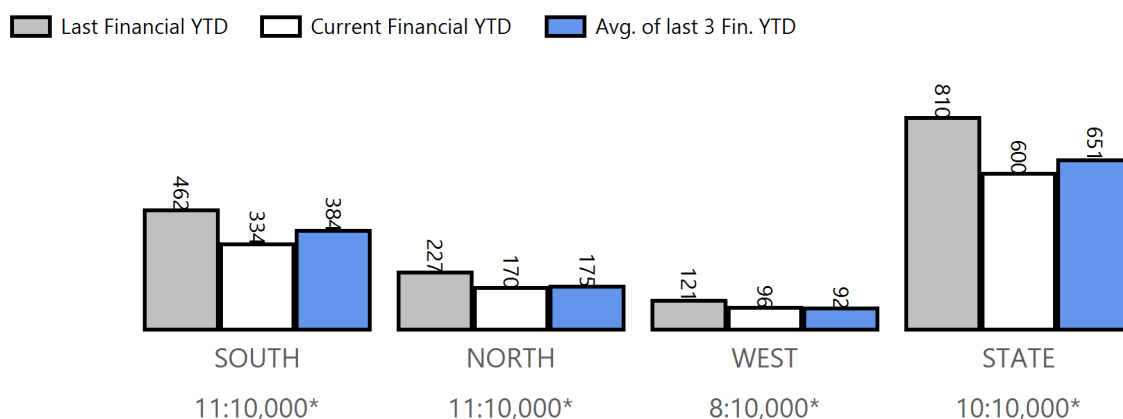
CIB: Total Offenders - September 2025

CIB: Total Crime Offenders - September 2025



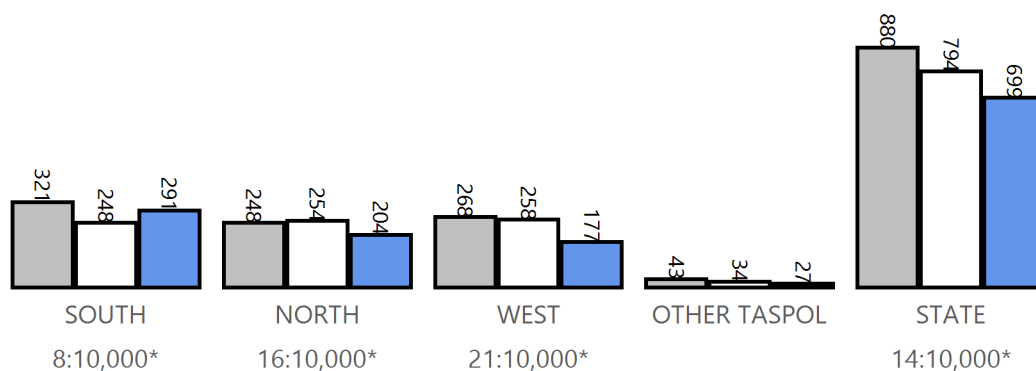

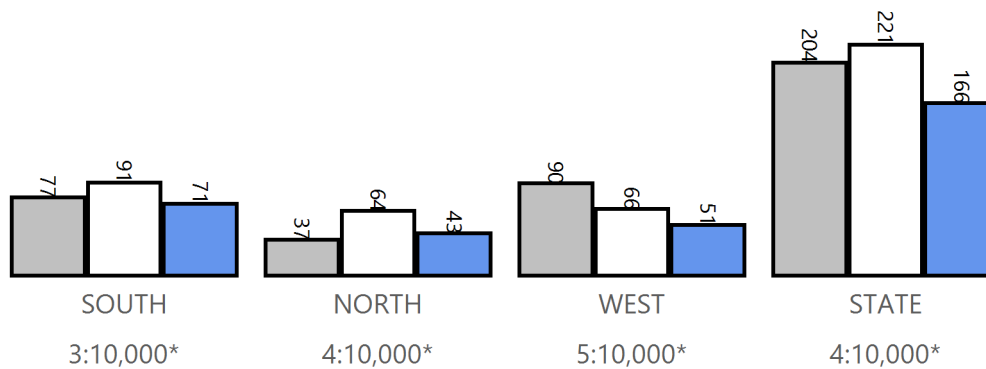

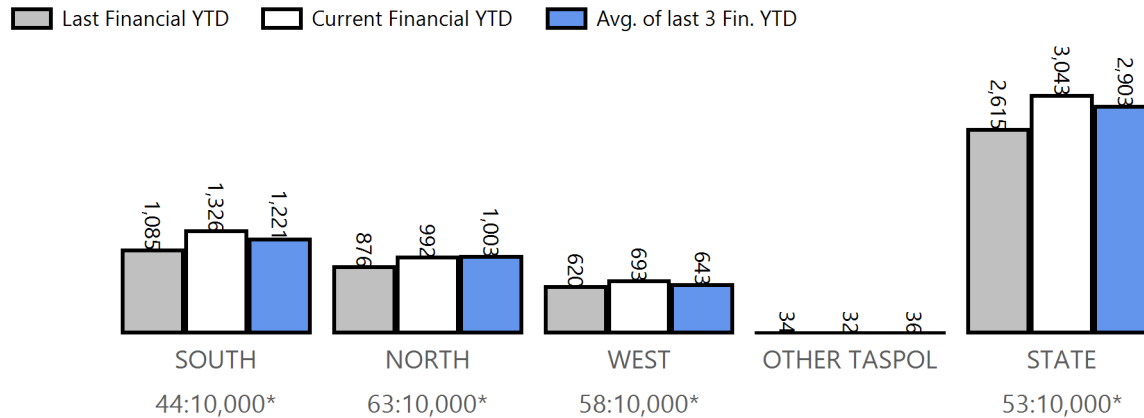
Speeding Offenders - September 2025

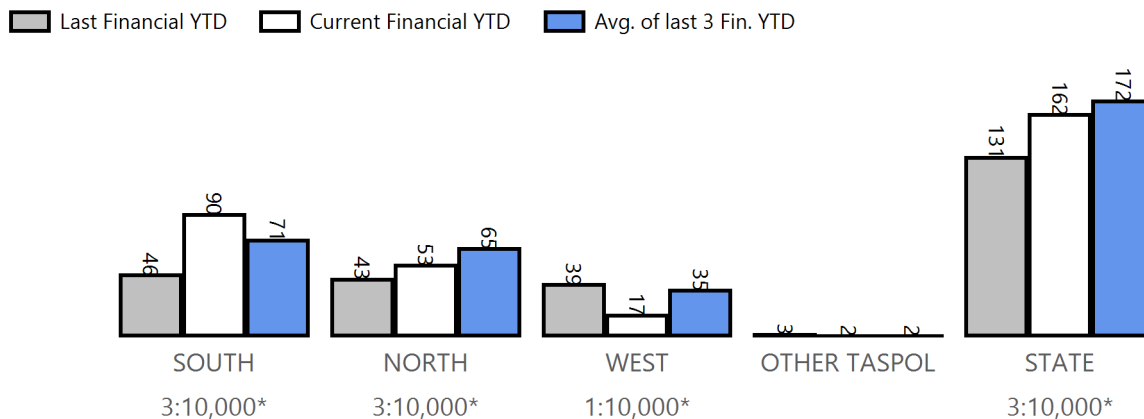
Speeding 15-29 km/h Offenders - September 2025

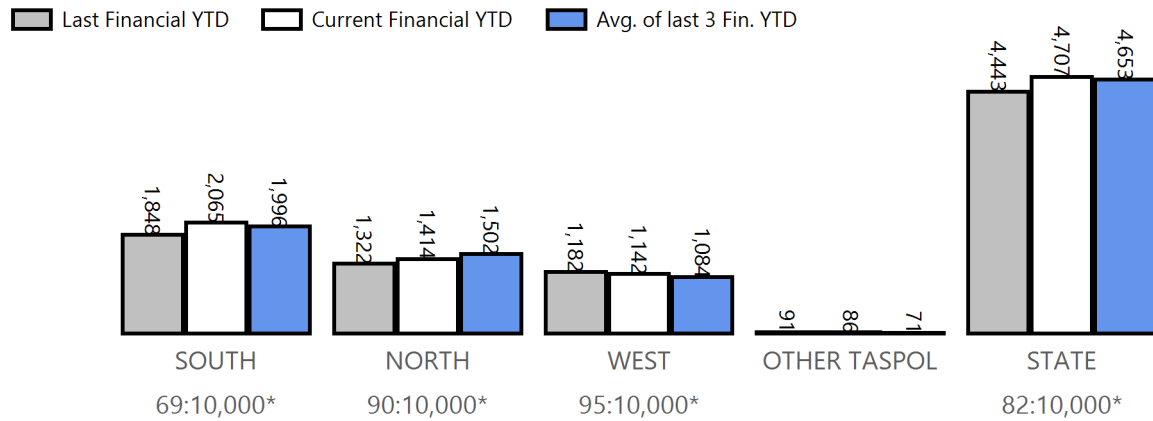
Speeding 30+ km/h Offenders - September 2025

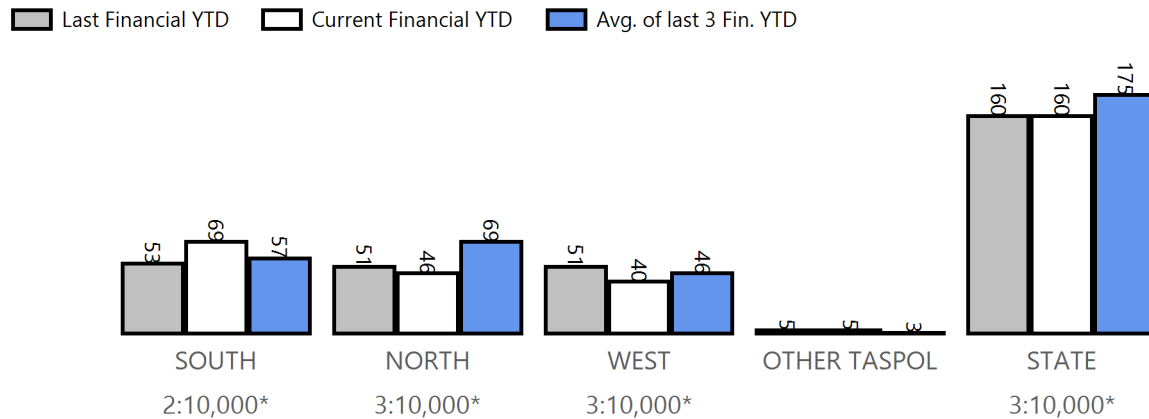
High Risk Traffic Offenders - September 2025

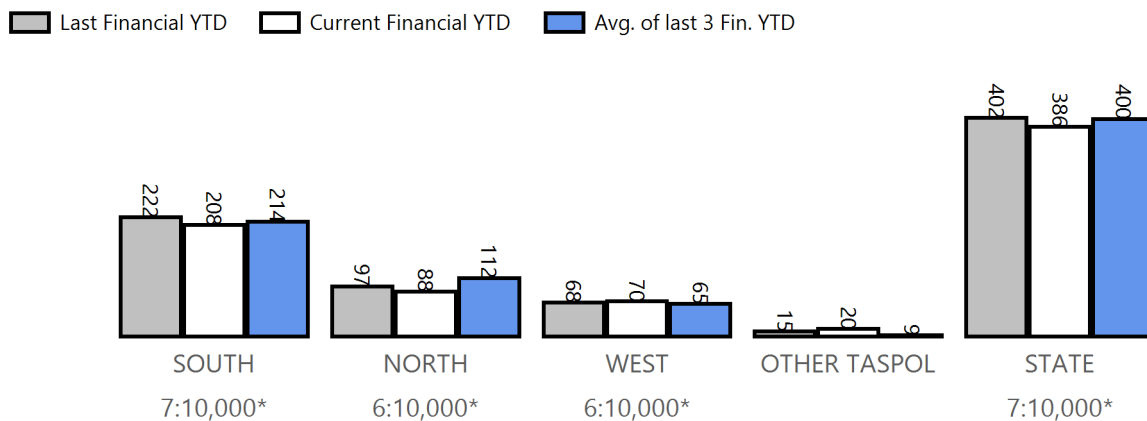
Seatbelt Compliance Offenders - September 2025

Mobile Phone Offenders - September 2025

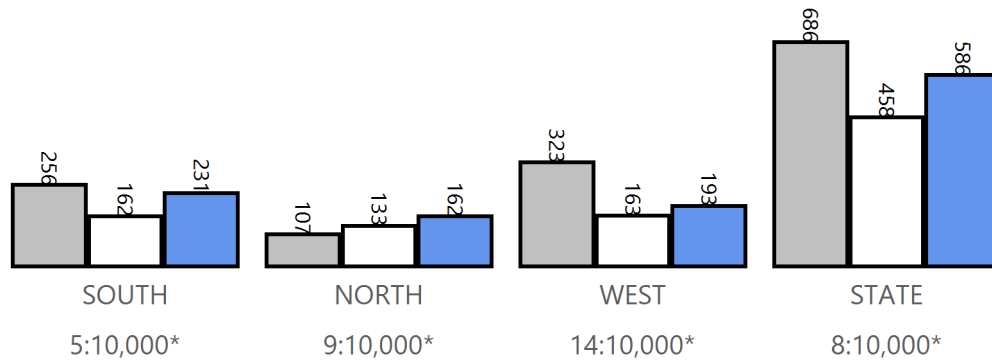

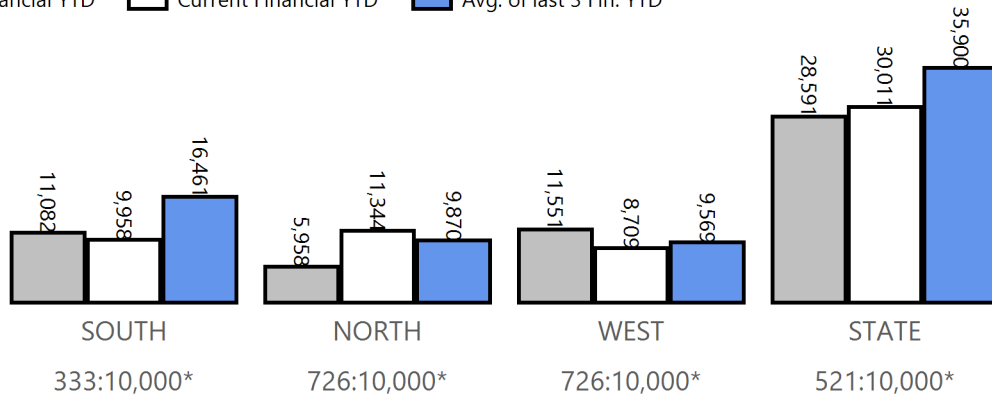

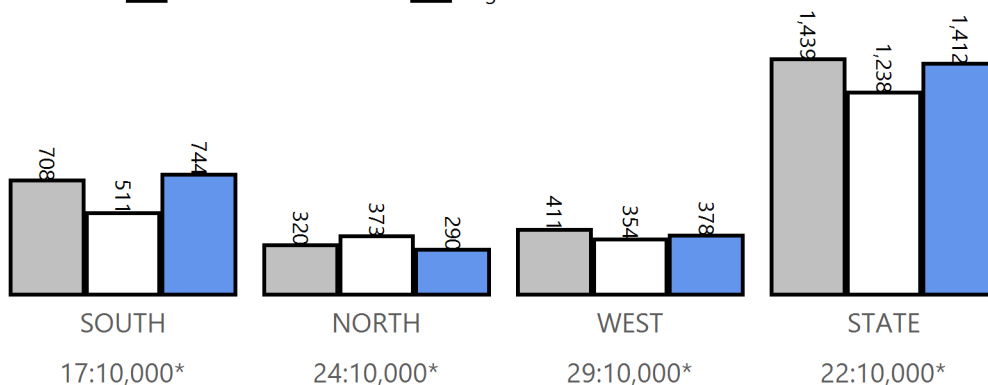

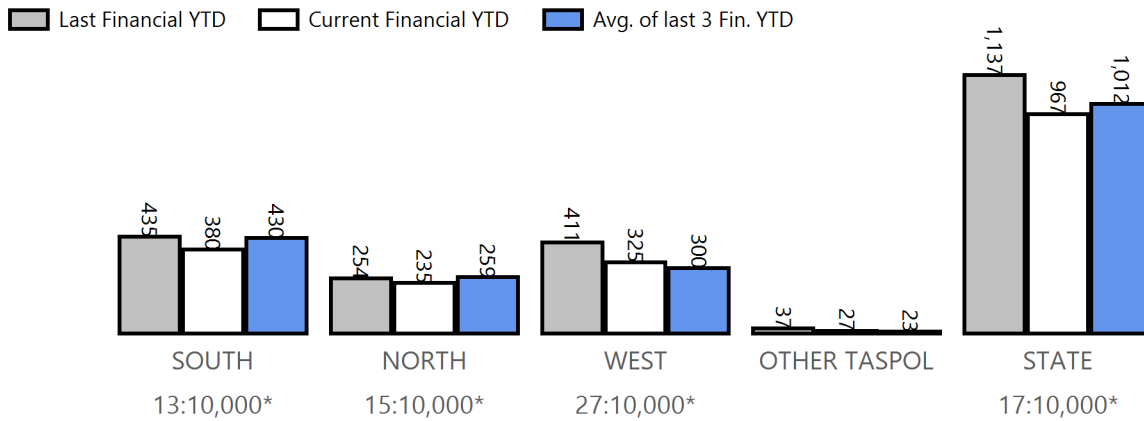

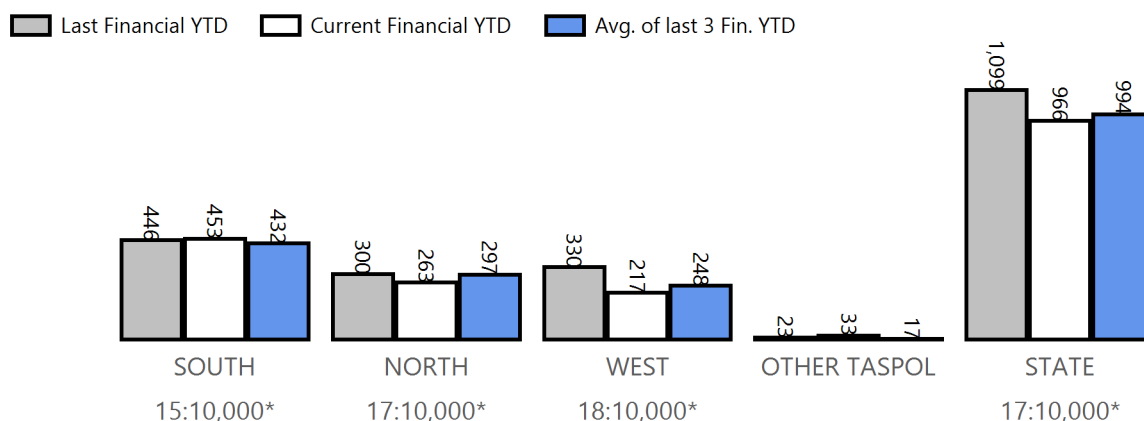
Dangerous and Reckless Driving Offenders - September 2025

Disqualified and Unlicensed Driving Offenders - September 2025



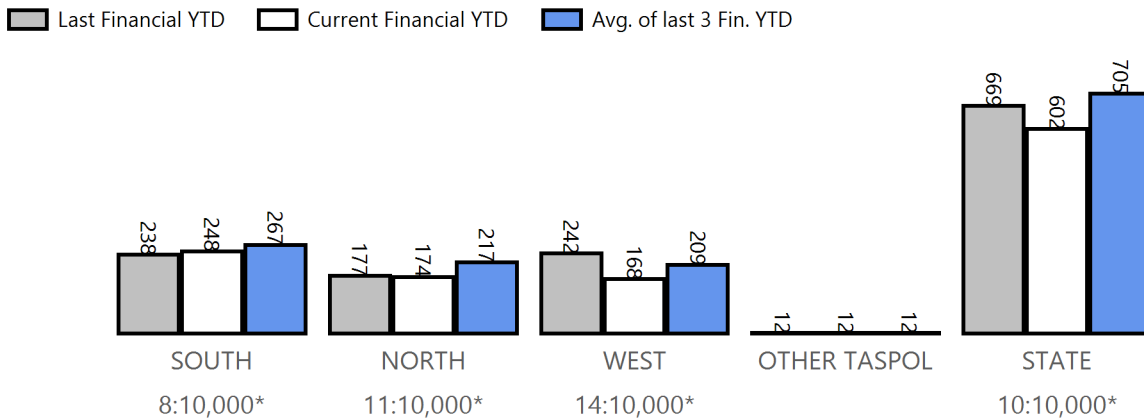

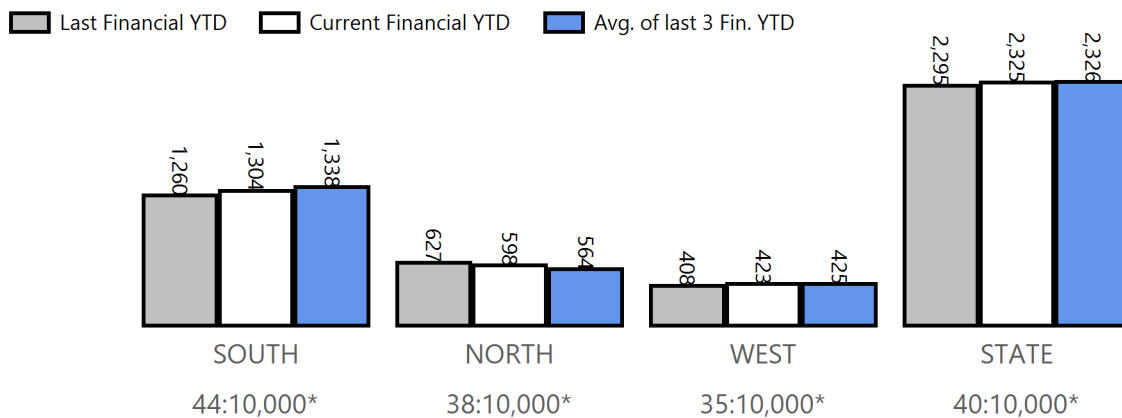
Unregistered Vehicle Offenders - September 2025

Vehicle Complaint Dispatch Incidents - September 2025

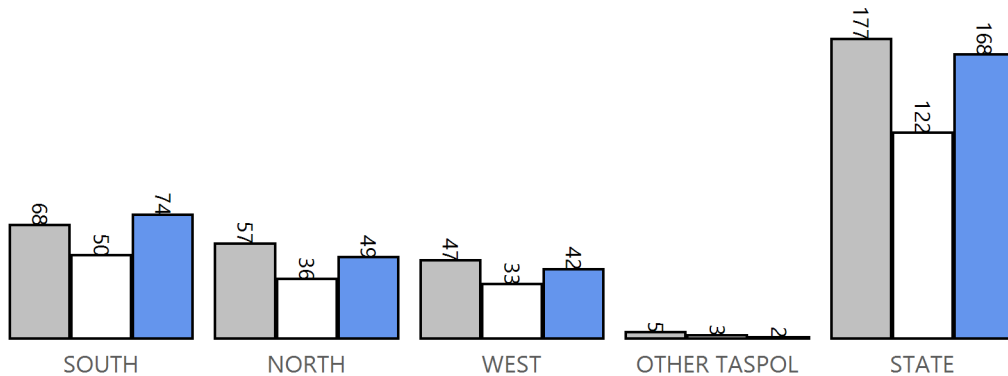

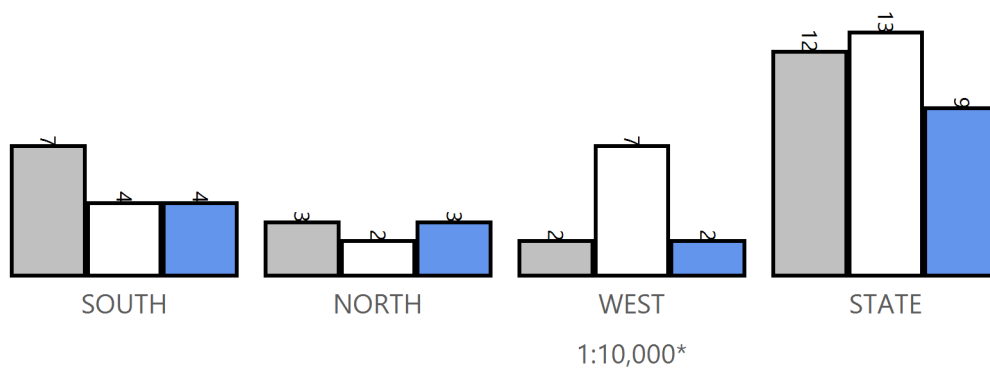

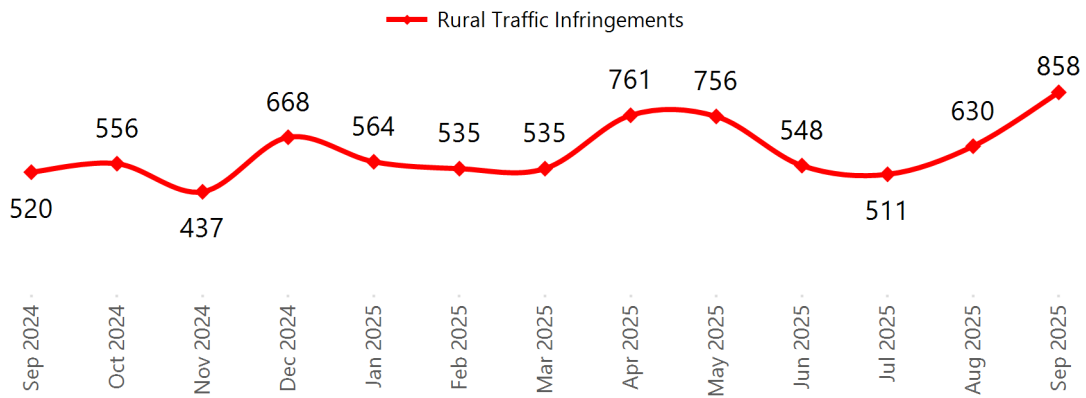

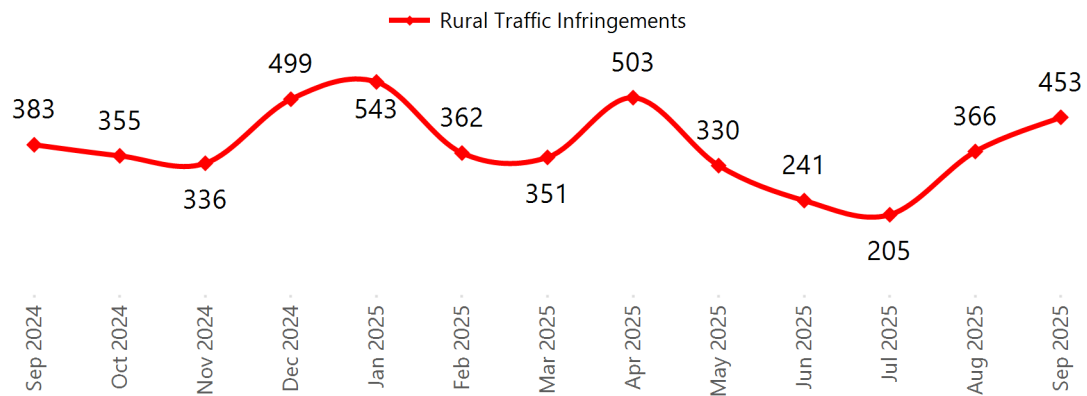

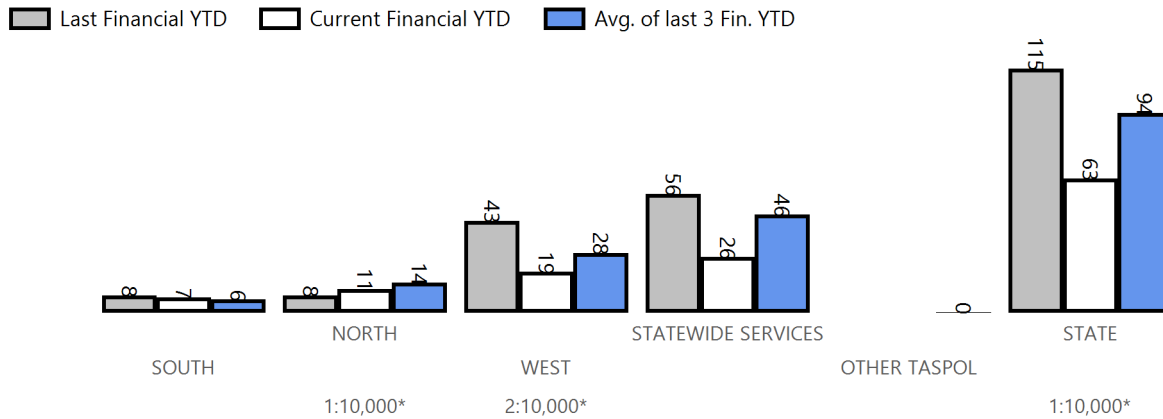

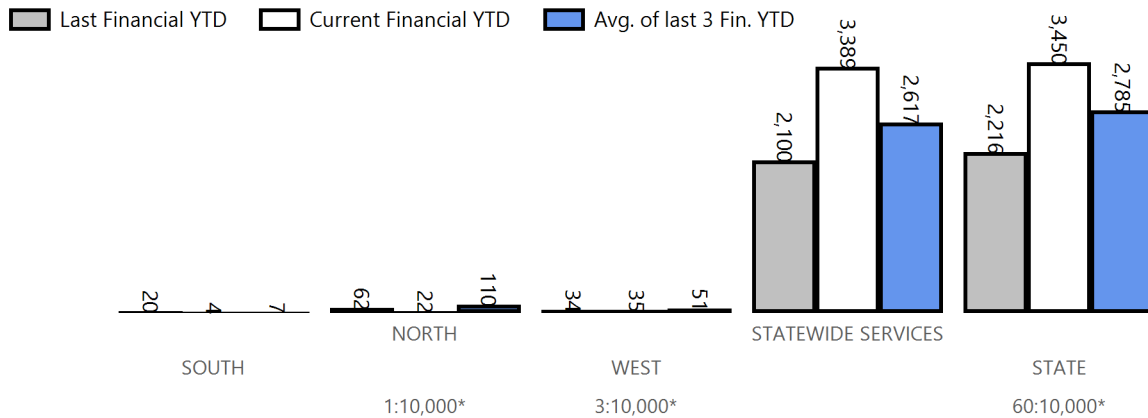

Total Marine Offenders - September 2025

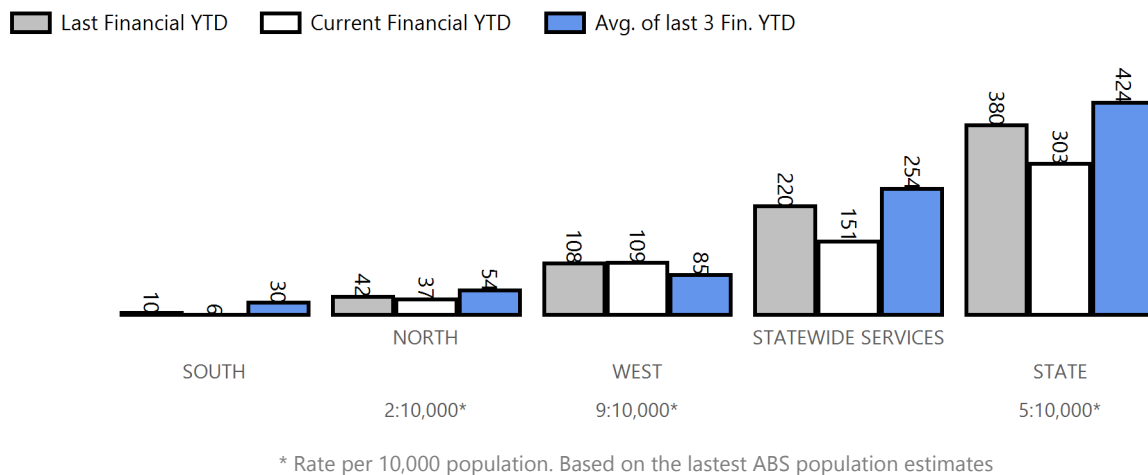


Sea Inspections (Vessel & Non-Vessel) - September 2025

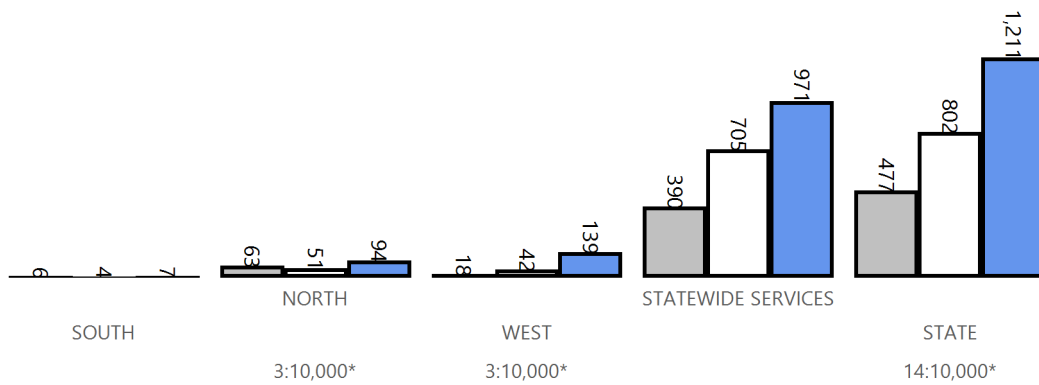
Vessel Inspections on Land - September 2025
