You must be between 23-40 years of age.

You will be paid the following rates:-170(abillinga) par wool

CONSTABLE	17s(shillings) per week
	(=85p)
SERGEANT	£1.1s per week (=£1.05)
SUPERINTENDENT	£3.10s per week (=£3.50)
CHIEF CONSTABLE	£13.19s per week (=£13.50)

Your working hours will be eight, ten, or twelve hour shifts, seven days a week. Every encouragement will be given to officers to grow beards as it is regarded as unhealthy. However, beards must not exceed two inches to join the police it is advisable to have a bath. in length.

Uniform will be worn all the time to prevent accusations of spying on public, whilst in ordinary clothes. A duty band will be worn to indicate whether you are on duty or not.

You are NOT allowed to vote in elections.

You must not gossip with the public. In particular, avoid conversation with female servants or other women on

duty. Do not walk or converse with comrades, merely exchange a word and pass on.

You will walk about 20 miles per shift.

No rest days are allowed and only one week holiday per annum, unpaid.

No meal breaks are allowed. The top hat may be used to hold a snack. You must inform the Superintendent before you associate, eat or drink with any civilians.

Before attending for medical examination and interview

You are NOT allowed to sit down in public houses at any time.

You must expect a hostile reception from all sections of the public and be prepared to be assaulted, stoned, or stabbed in the course of you duty.

#### POLICE LEGACY – TASMANIA

#### **RPAT - UPDATE FEB 2018**

Tasmania (PAT) has been pursuing the concept of registering Police Legacy - Tasmania through the Police Legacy - Tasmania, through the formation of a Australian Tax Office and Australian Charities and working group under the Chairmanship of their Vice Not-for-profits Commission as a charity. The cost of this President Gavin Cashion. Association of Tasmania (RPAT) has had a member on the working group from its beginning in 2014 and continues to work with the PAT in the formation of this important institution.

The object behind *Police Legacy - Tasmania* is to Executive who are the owner of the *Police Legacy* maintain a Public Benevolent Institution which will be a Tasmania. non-profitable charitable entity organised for services including the direct relief of poverty, sickness, suffering, distress, misfortune and helplessness among members, those eligible to be members, their partners, and family.

Police Legacy - Tasmania is intended to be a wide police family. ranging institution that not only focuses on activities for children of legatees, but also can include grief counselling support, financial support and assistance, and providing other support to the infirm and elderly members. It is about providing compassionate support to the wider police family and raising funds to support this important work.

At a Police Federation Council meeting held in September 2017 the National Police Memorial Board (NPMB) indicated that they were applying for a change of status – also becoming a police benevolent institution. Many police legacies throughout Australia have gone down this path, which means that Tasmanian funds currently held in trust with the NPMB (raised from the Wall to Wall Ride associated with Police Remembrance Day over many years) needed to be moved.

The PAT Executive decided to act in fast tracking the Police Legacy - Tasmania scheme. The concept raised in early 2017 of being involved with the Tasmania Police Charity Trust had not eventuated due to legal impediments of their constitution and governance.

The original draft constitution and rules that had been developed by the working group over many years was sent by the PAT to their solicitors Wallace Wilkinson and Webster for a formal constitution to be ratified within development of this most important scheme. corporate guidelines.

Over the past many years the Police Association of Other issues to be attended were obtaining an ABN, The Retired Police advice and work was met by the PAT.

> In late November a number of draft constitutions were circulated and amended by the working group to enable a final document to be approved. This document and the concepts contained within it were accepted by the PAT

> The scheme however will allow and encourage former Serving Police Officers to be members and also beneficiaries. It will also provide an ongoing opportunity for RPAT members to continue to support the wider

> Within the Police Legacy - Tasmania constitution the definition of a Former Serving Police Officers includes:-

Resigned Police Officers who were formerly a police officer of Tasmania Police upon resignation that had served at least 10 years of continuous or cumulative service: and

Retired Police Officers who retired from Tasmania Police due to reaching retirement age or retired on the ground of ill health.

The constitution together with other relevant documents were forwarded to the Australian Security and Investments Commission (ASIC) who advised in late January that it could not accept the name "Police Legacy - Tasmania" without the Commonwealth Treasurer's permission.

This is because the word "Police" is not allowed otherwise in a corporation. The solicitors have written to the ASIC Ministerial Consent Department seeking the Treasurers consent and once received will advise.

Upon receipt of favourable advice, all that will be left is the constitution to be signed and the company Police Legacy - Tasmania incorporated. Then it will be good to go.

## **Arthur Henry Jackson–KPM**

The devastating floods of April 1929 in the North and North-West claimed 22 lives.

Police Officer Albert Henry Jackson spent days in the icy waters searching for survivors and victims. Sadly, the legacy of his courage was paralysis of the legs, which led to his retirement from ill-health in July 1931.

For his bravery, in 1933 he was awarded the Kings Police Medal and the Bronze Medal of the Royal Humane Society.



In later years, Bert Jackson was to be seen around Hobart in his hand-powered wheelchair. With his cheerful personality and sense of humour he made light of his disability, and took up woodworking as a hobby. His souvenir serviette rings, turned from Tasmania timbers, will be remembered by many.

Bert Jackson started his police career as Constable 639 in 1916; In 1929 he was promoted to Senior Constable; He retired in 1931 from ill health. He died on July 12, 1982, aged 89.

Although his rewarding career was cut short, this brave and determined gentleman truly triumphed over adversity. By Darcy Erwin.
