Unique Band of Brothers

With all the turmoil, stress and ever-increasing numbers of reported Post Traumatic Stress Disorder victims, I just wanted to put over my thoughts about a Police Officers Life.

A Printing Company sent me an email. They were doing Military style stickers, like the Vietnam Veterans have. I then had the 'brain wave' that some Police Officers (retired or serving) might be interested in doing the

I am not often right, but I'm wrong again!!

When I put it to the Police Officer that I married, she was very adamant, that she would never put a "Police" style sticker on her car, as was a few replies from other RPAT members, who had similarly agreed. I soon realised why.

We are a Unique Band of Brothers

Generally, Police Officers are not liked. Even after nearly 19 years since I retired, I still carry the stamp. People (some) still see me for what I was, not for who I am now. I continually get remarks from friends and acquaintances that associate me as Police. It does not vanish on the day Do you remember Dr. Kevin Gilmartin talk at Launceston you finish. Do I hear an 'amen brother'?

Fire Officers and Ambulance Officers are generally liked by the public, because of their recognised purpose because they help people.

Police are not looked upon as being here to help people. We don't discriminate. We've charged kids for not wearing a bike helmet - don't think I have, but you get the picture. Police's job is to interfere with everyone's daily lives and ask intimidating questions.

We've booked people, without fear or favour, for anything

that breaches the Road Rules or Regulations. people are generally good, honest and law-biding citizens, and yet, Police can 'spoil' their reputation by one simple infringement notice.

So, at the end of the day, we are the bad ones, and people don't forget these bad incidents. What we thought was "just doing our job" becomes a lifelong battle of hatred (dislike at least) against us. Is it a new trend, that society can now challenge Police, even to the extent of assaulting them, and know there's a good chance they will get away with it?

I don't think there is another organisation like the Police Force (or 'Service' as it's now called), that 'cop' (pardon the pun) the flack of people's frustrations. I suppose this generation holds no responsibility for their actions. If anyone makes a mistake or commits an offence, it's always someone else's fault. We see the Courts taking the same view, in blaming society, or for a murderer or rapist's sad childhood being to So, why would you put a sticker on your car depicting you're a Police Officer (or Retired)??

Uni.? His concept of Police Life was very enlightening, interesting and well written. His book "EMOTIONAL SURVIVAL for Law Enforcement" - looks at the lives of Police Officers. Get vourselves a copy. Can be found online for as low as \$10.55 He talks about Police Officers becoming **negative** and **cynical** about the world. They mistrust everyone they meet and think the worst.

So, what do we end up with? We have each other. We have the Retired Police Association. We talk the talk. We understand each other.

CRIME AND OCCURRENCE BOOK ENTRIES

May 12th 1900

Temperance Hall Meeting

Supt. Peddar, Sub Inspectors Connor and Kemp with Det Sergt Franklin and Constables Ellis (2), Grainger, Ward in plain clothes, Sergt, Rainey in uniform were on duty at the Temperance Hall on Friday the 11th inst from 7 till 10.30pm up to which time all was guiet, except two or three men and a female who were inclined to be noisy. but the police acting with firmness they were got away and the public were all dispersed.

Re amended report.

Between 1 and 2 am on 12 inst. Sergt Coates with PC's Gunner and Giani arrested one Alfred G White in the act of throwing stones at and breaking the window in the Temperance Hall and remanded till the 14th inst.

May 16th 1900 **Disturbance at Temperance Hall**

Supt. Pedder, Sub Inspectors Connor and Kemp, D.S. would be broke.

Franklin, with the whole available force of police, night and day duty, were on duty at the Temperance Hall from 7.30pm on the 15th inst. On the occasion of ex priest Slattery's lecture. There was a great concourse of people outside the hall and a good number inside the building. The police were posted to the best advantage and did their best to protect property and suppress disorder and remained on duty until the hall was cleared and the public dispersed about 11pm when all was quiet.

There was a tumult arose inside the hall between 8 and 9 pm by some excited persons and who were got out of the hall by the firmness and tact of the Supt. Before much damage was done.

Further action in this matter pending.

Sir Robert Peel's Principles of Law Enforcement 1829

- 1. The basic mission for which police exist is to prevent offering of individual sacrifice in protecting and crime and disorder as an alternative to the repression of crime preserving life. and disorder by military force and severity of legal punishment.
- dependent upon public approval of police existence, actions, behaviour and the ability of the police to secure warning is found to be insufficient to achieve police and maintain public respect.
- 3. The police must secure the willing cooperation of the public in voluntary observance of the law to be able to secure and maintain public respect.
- 4. The degree of cooperation of the public that can be secured diminishes, proportionately, to the necessity for the use of physical force and compulsion in achieving police objectives.
- 5. The police seek and preserve public favour, not by catering to public opinion, but by constantly demonstrating absolutely impartial service to the law, in complete independence of policy, and without regard to the justice or injustice of the substance of individual laws; by ready offering of individual service and friendship to all members of society without regard to 9. The test of police efficiency is the absence of crime and their race or social standing, by ready exercise of disorder, not the visible evidence of police action in courtesy and friendly good humour; and by ready dealing with them.

- 6. The police should use physical force to the extent 2. The ability of the police to perform their duties is necessary to secure observance of the law or to restore order only when the exercise of persuasion, advice and objectives; and police should use only the minimum degree of physical force which is necessary on any particular occasion for achieving a police objective.
 - 7. The police at all times should maintain a relationship with the public that gives reality to the historic tradition that the police are the public and the public are the police; the police are the only members of the public who are paid to give full-time attention to duties which are incumbent on every citizen in the intent of the community welfare.
 - 8. The police should always direct their actions toward their functions and never appear to usurp the powers of the judiciary by avenging individuals or the state, or authoritatively judging guilt or punishing the guilty.

John Bird Memorial Forensic Award

The John Bird Memorial Forensic Award was established following an idea from the family of the late Inspector John Bird to create a presentation for forensic members in his memory," said Commissioner Hine.

"The late Inspector Bird was a dedicated and respected member of Tasmania Police who received many local, national and international awards for his work within Forensic Services so it was fitting that we created an Award in his honour.

"Criteria for the Award is shaped on the way the late Inspector Bird performed his duties - a Forensic Services member "who consistently sought professional development, displayed workplace initiative, personally performed to a high standard, and last but definitely not least, worked and supported others with no small measure of good humour.

Worthy recipient receives inaugural John Bird Memorial Forensic Award.

SUPERANNUATION MATTERS

At present there seems to be a lot of confusion as to the Self-funded retirees may be eligible for a Commonwealth actions that members and spouses of members should Seniors Health Card and related payments and services. take regarding superannuation and related matters. The You can find out more under the "Payments for Older Executive of the Retired Police Association of Tasmania Australians" tab on the Department of Human Services website or are currently enquiring from Government Departments as to the procedures our members should adopt.

The Office of the Superannuation Commission (OSC) is advisory and information also currently reviewing materials available to members about the surviving spouse process and information requirements (eg: marriage certificates). OSC is working on the letters sent to surviving spouses at the time of the death and is developing a checklist to assist members with the early preparation of evidentiary materials required to substantiate the status of the surviving spouse, making sure they are appropriate and not unnecessarily cumbersome.

Are you considering downsizing your home?

From 1 July 2018 people aged 65 and over will be able to make a non-concessional (post tax) contribution into their superannuation of up to \$300,000 from the proceeds of selling their home. This will apply to a principal place of residence held for a minimum of ten years. Both members of a couple will be able to take advantage of this measure for the same home, meaning up to \$600,000 per couple can be contributed. (part of the Federal Budget 2017)

It aims to encourage more effective use of housing stock by freeing up larger homes for younger, growing families.

Department of Human Services

If you receive a Partial Pension or are not eligible for a pension from Centrelink you may still qualify for other payments and supplements.

The Pension Loans Scheme can help if your capital is tied up in assets and you need more income to live on.
