Disclosed Information

In assessing the information for disclosure, I am exercising powers delegated to me by the Principal Officer of DPFEM under Section 21 and 24 of the *Right to Information Act 2009*.

I disclose nine (9) pages (attached) of relevant information in response to your application.

Further to the disclosed information/documents, I can advise that there were three (3) burns cancelled in or around the Swansea area between the 1 January 2016 and 1 January 2019. These were:

- TEZ002BU Dolphin Sand Melrose 45ha. The land owner was initially keen to have a FRB on his property but subsequently decided against it due to a perceived negative response from the greater Dolphin Sands community. This was a phone call between Bernard Plumpton (Regional Planner BRU) and the land owner. There is no written record.
- TEE202BU Bluemans Creek. This burn was split into 2 sections. Section 1 (147 ha) was burnt in autumn 2018. Section 2 (298 ha) was scheduled to be burnt in the following 12 months, however a significant landowner was concerned about the level of scorch in Section 1 and withdrew his permission to conduct the burn. See attached email chain between Dan Hoar and the land owner.
- TEE241BU Dry Creek. This burn was approximately 2255ha and located to the west of Swansea. Craig Chivers (Station Officer, Bushfire Reduction Unit) was the lead on planning this burn and spent considerable time undertaking both field visits and desk top planning. The burn was unable to be advanced as a landowner on the northern end of the burn clearly stated that he did not want any burning on his land. Whilst this was a small section of private property relative to the burn size, due to the location of the property boundaries (steep and rough) his property could not easily be excluded from the burn so nothing further was progressed. Efforts were then turned to other strategically important areas in the Southern Region. I have attached a map of the proposed burn boundary, showing the land owners property, and email that Craig Chivers sent to Dan Hoar (then Regional Planner BRU) after speaking with owner.

The Tasmania Fire Service, which forms part of DPFEM, is the custodian of the information you seek and therefore is required to comply with the Act and the *Personal Information Protection Act 2004.*




Dear Daniel

FUEL REDUCTION BURN PLANNING - DRY CREEK

The Tasmania Fire Service's Fuel Reduction Unit is working to identify areas where work is needed to lower bushfire fuel levels and lessen the chances of a large bushfire impacting on the community.

Planning for your local area by the East Coast Fire Management Area Committee has identified an area of high fuel loads that could put local residents at risk if a bushfire were to occur. This area includes property that you own (see reverse for map). For this location, the most appropriate method to reduce bushfire fuel is a prescribed burn. As well as being effective in reducing risk it is also less damaging to the environment than manual clearing.

We would like to have a site meeting with you to look more closely at your property and the possibility of including a portion of your land in a fuel reduction burn this spring and autumn. A representative of the Tasmania Fire Service will be in contact shortly to discuss this with you.


