Referrals from the Weiss Independent Review into Paul Reynolds

December 2025







In the course of the Weiss Independent Review into Paul Reynolds, people with information about grooming and/or sexual abuse committed by other former or serving Tasmania Police officers participated in private sessions with reviewer Regina Weiss. In that context, the review made seven referrals to Tasmania Police.
